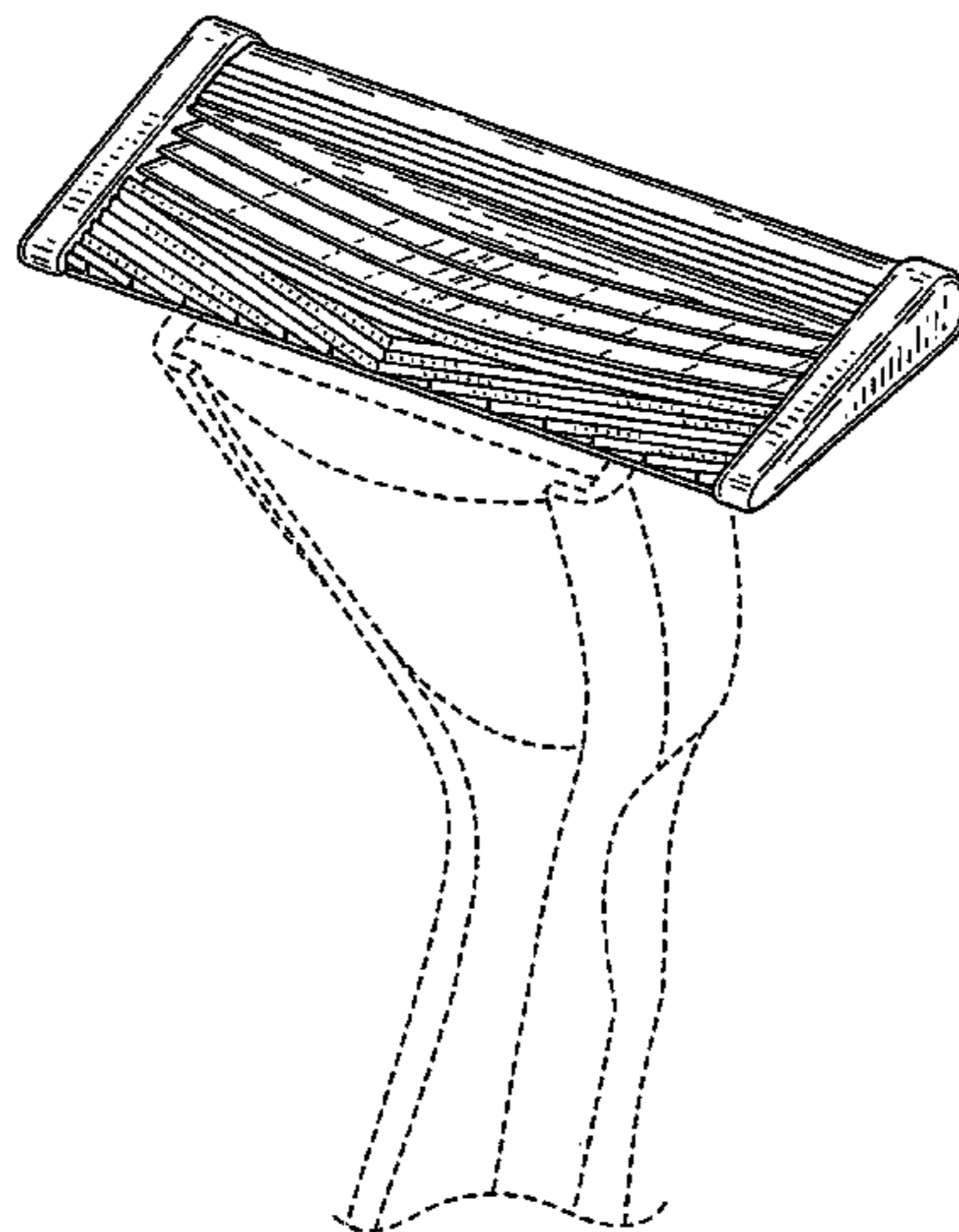

(57) **CLAIM**
The ornamental design for a razor, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a razor showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a back elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side elevational view is a mirror image thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a top plan view thereof showing where the cross sectional portion is taken to provide FIG. 8; and,
FIG. 8 is a cross sectional view taken along 8-8 of FIG. 7.
The broken lines shown in the drawings illustrate the environment of the article and form no part of the claimed design.

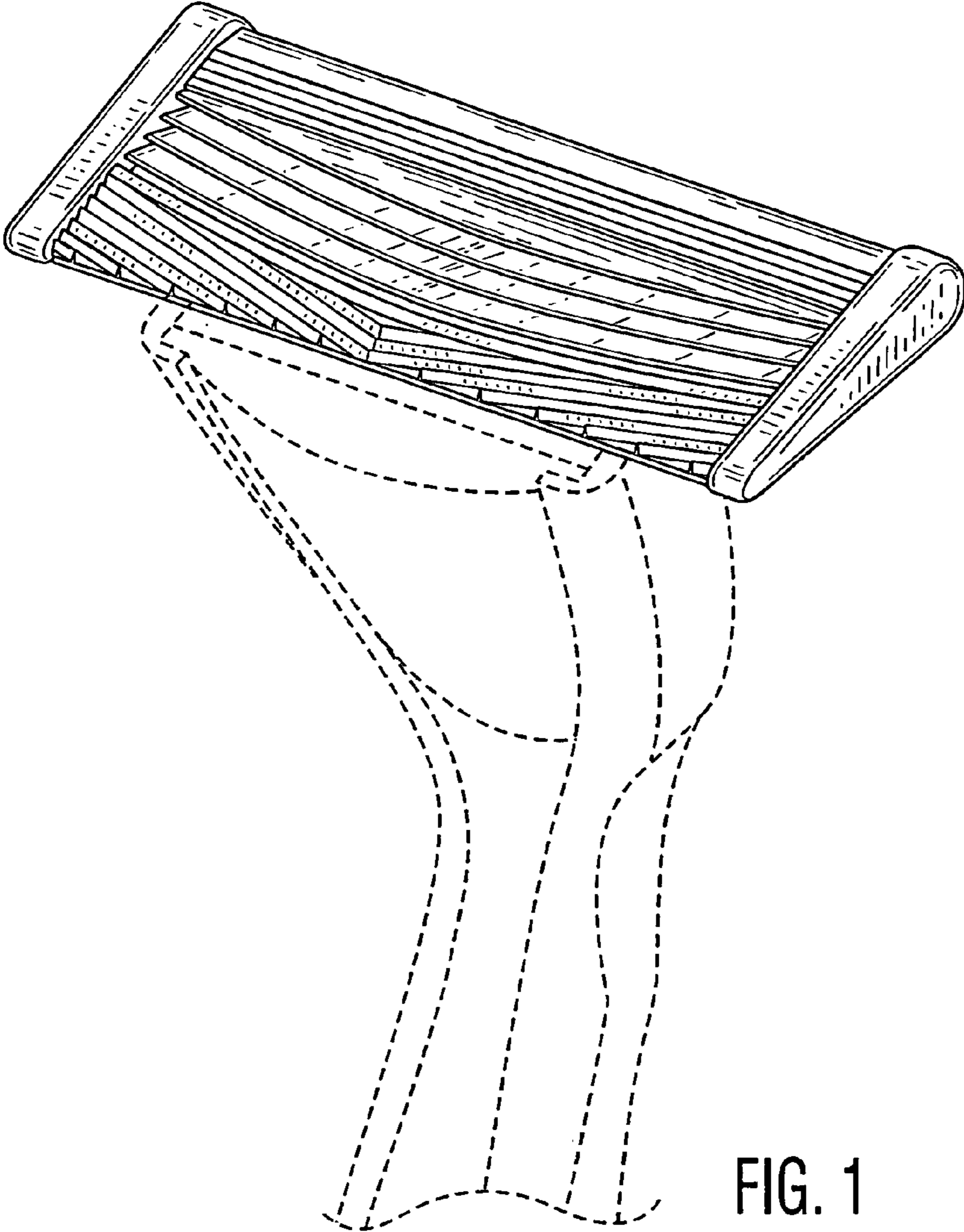

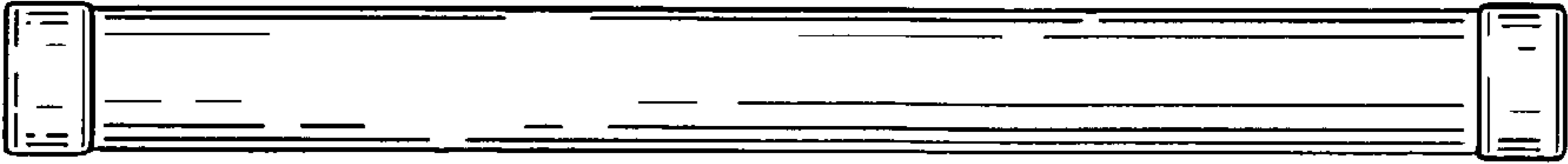

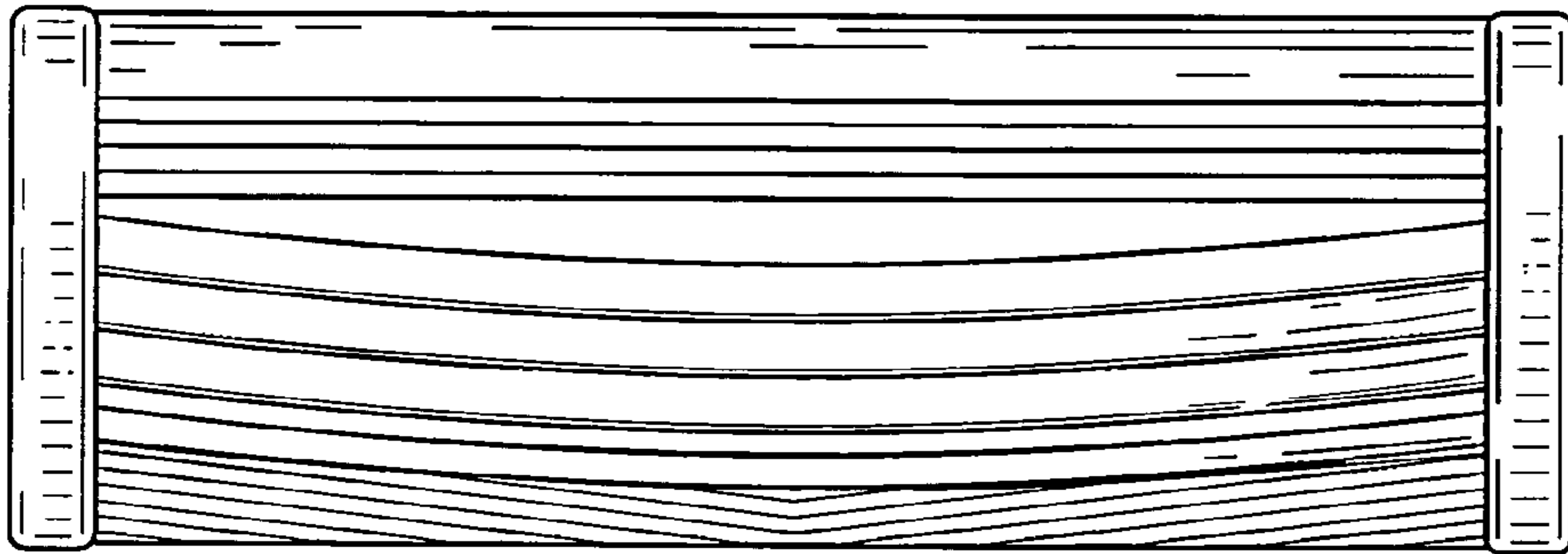

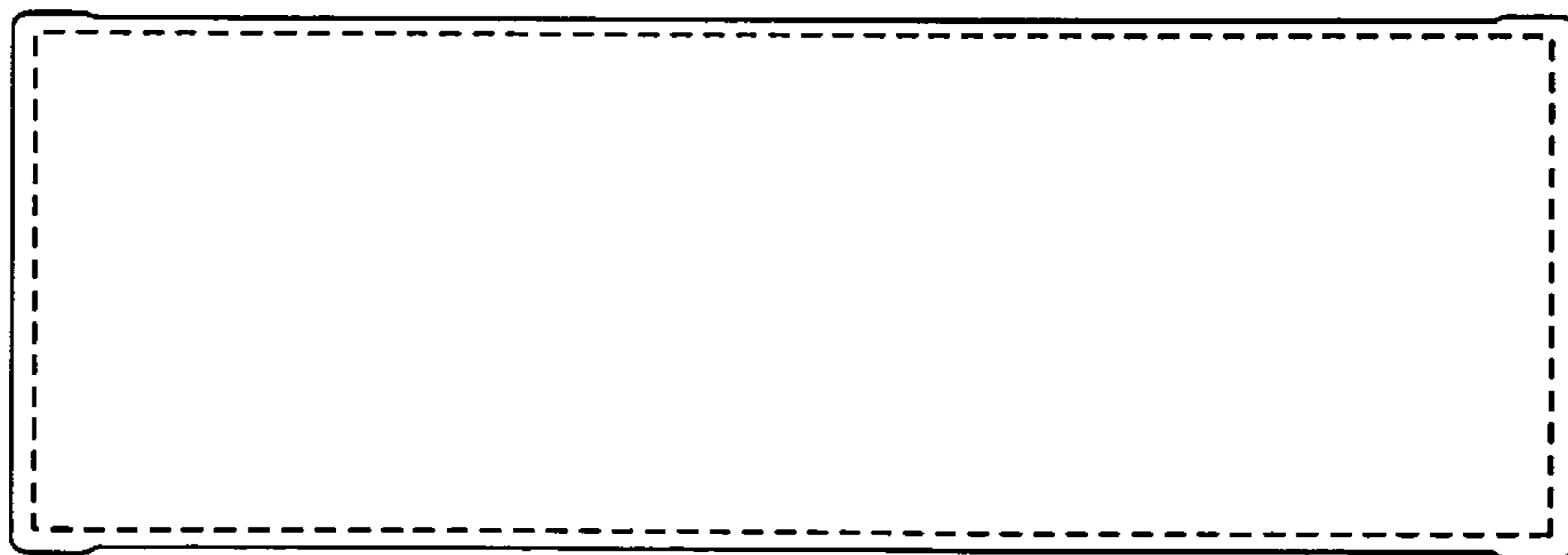

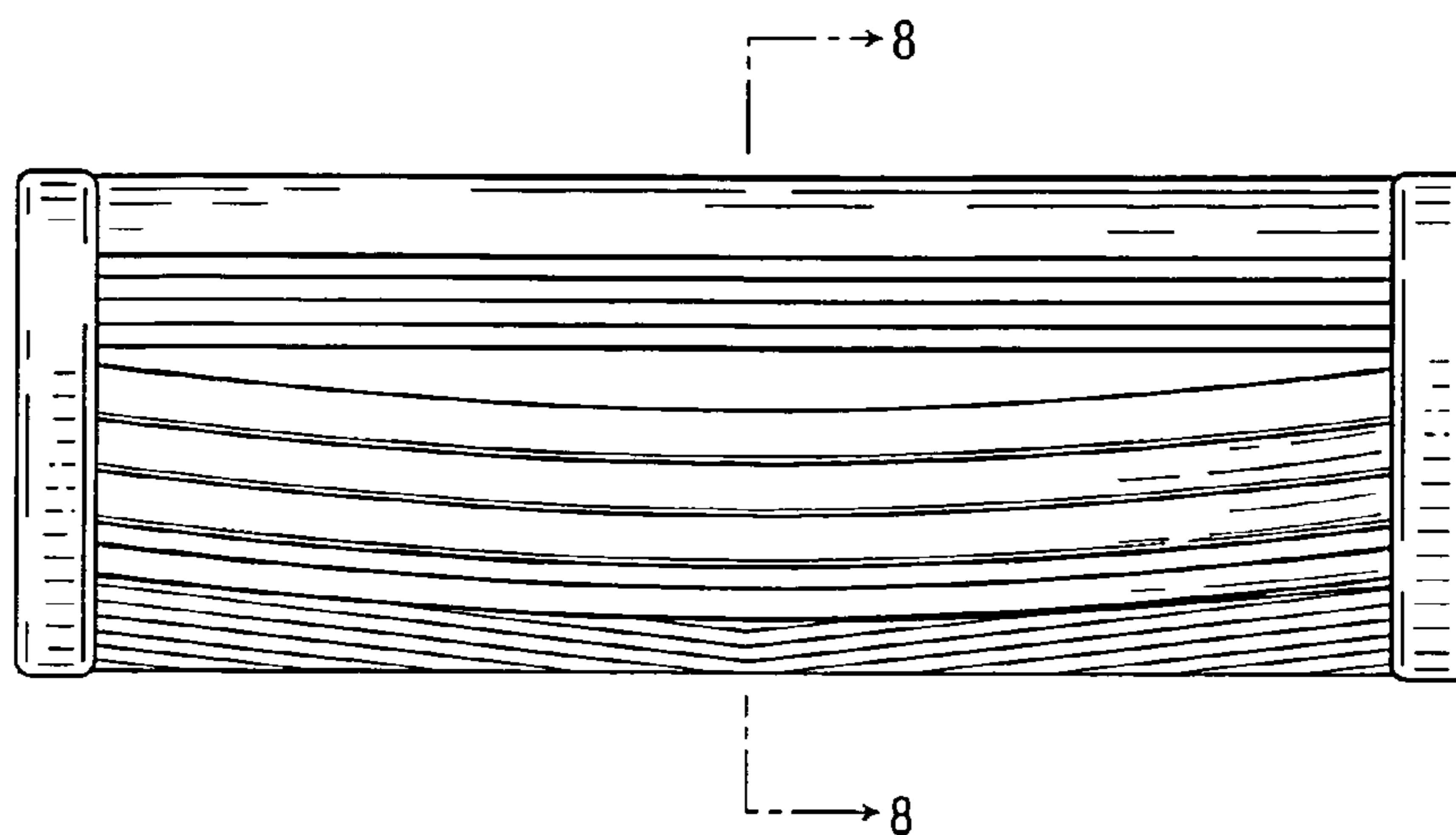

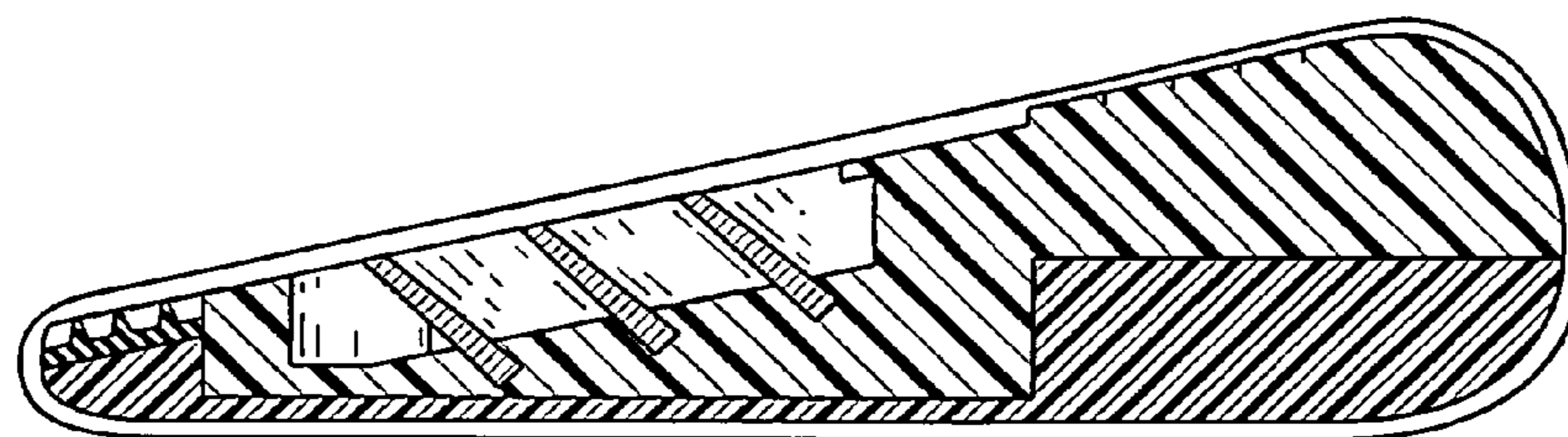
