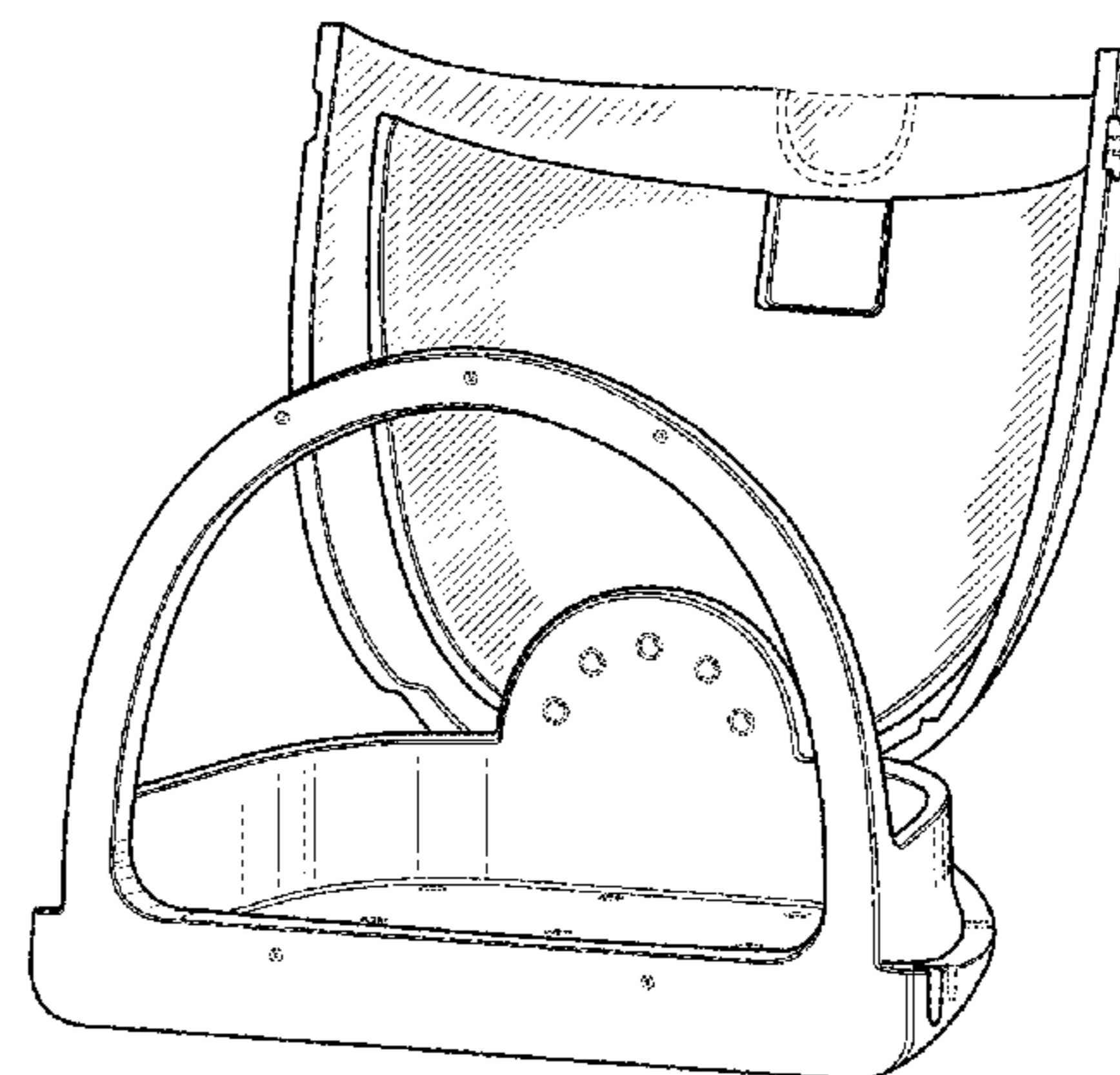
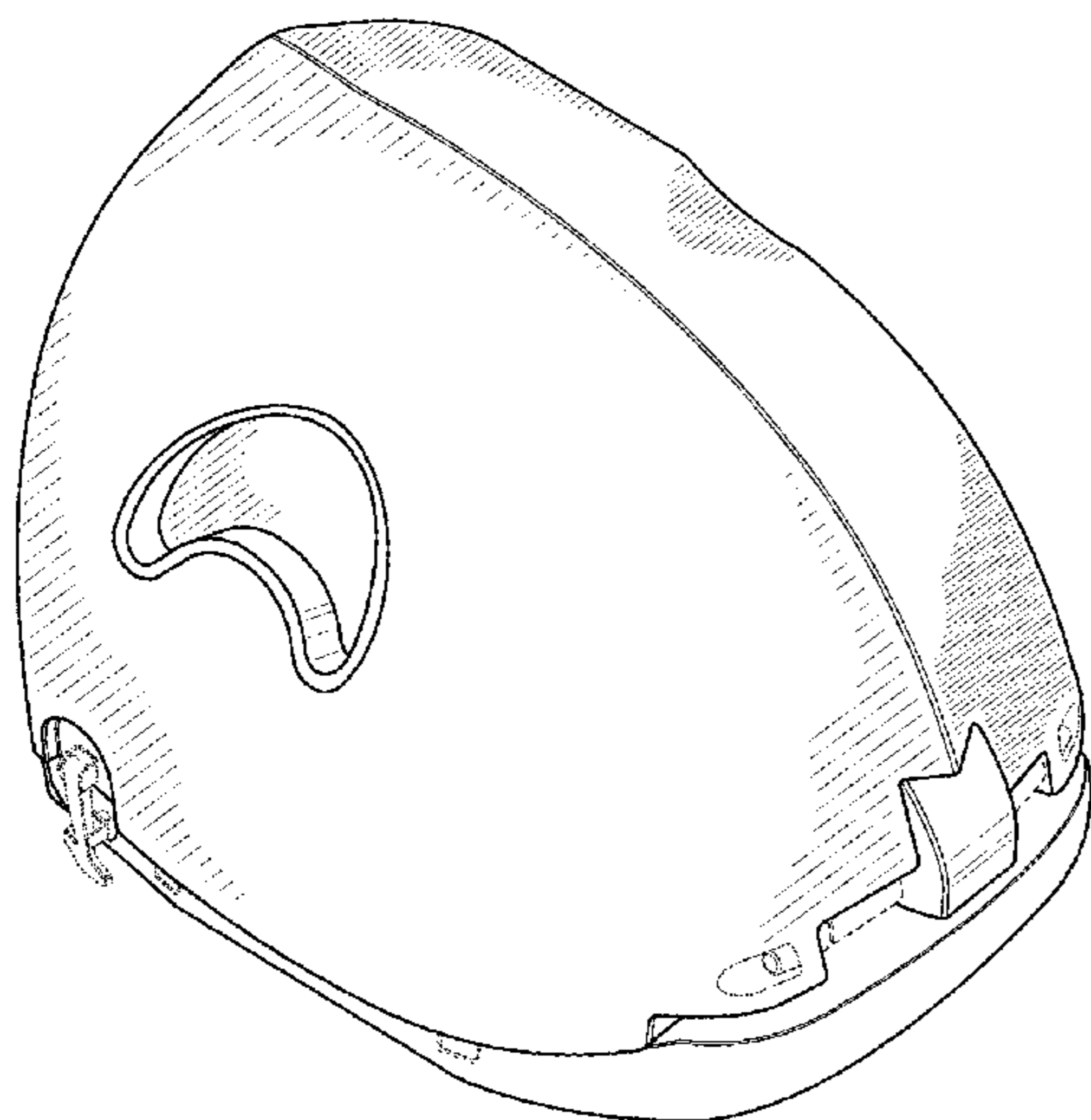
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side perspective view of one side of a shelter showing my new design,

FIG. 4 is a top, right side and rear perspective view there,

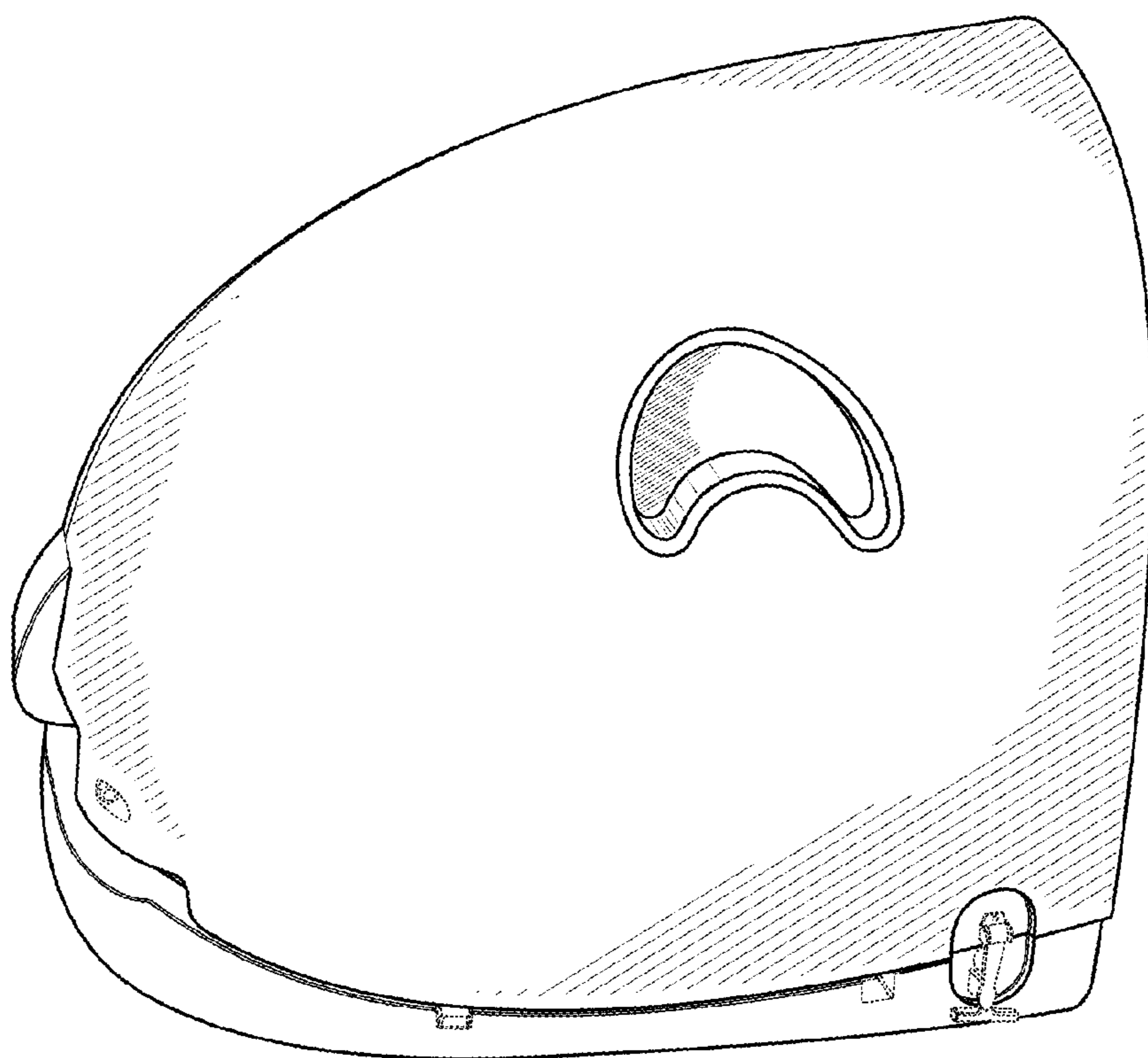

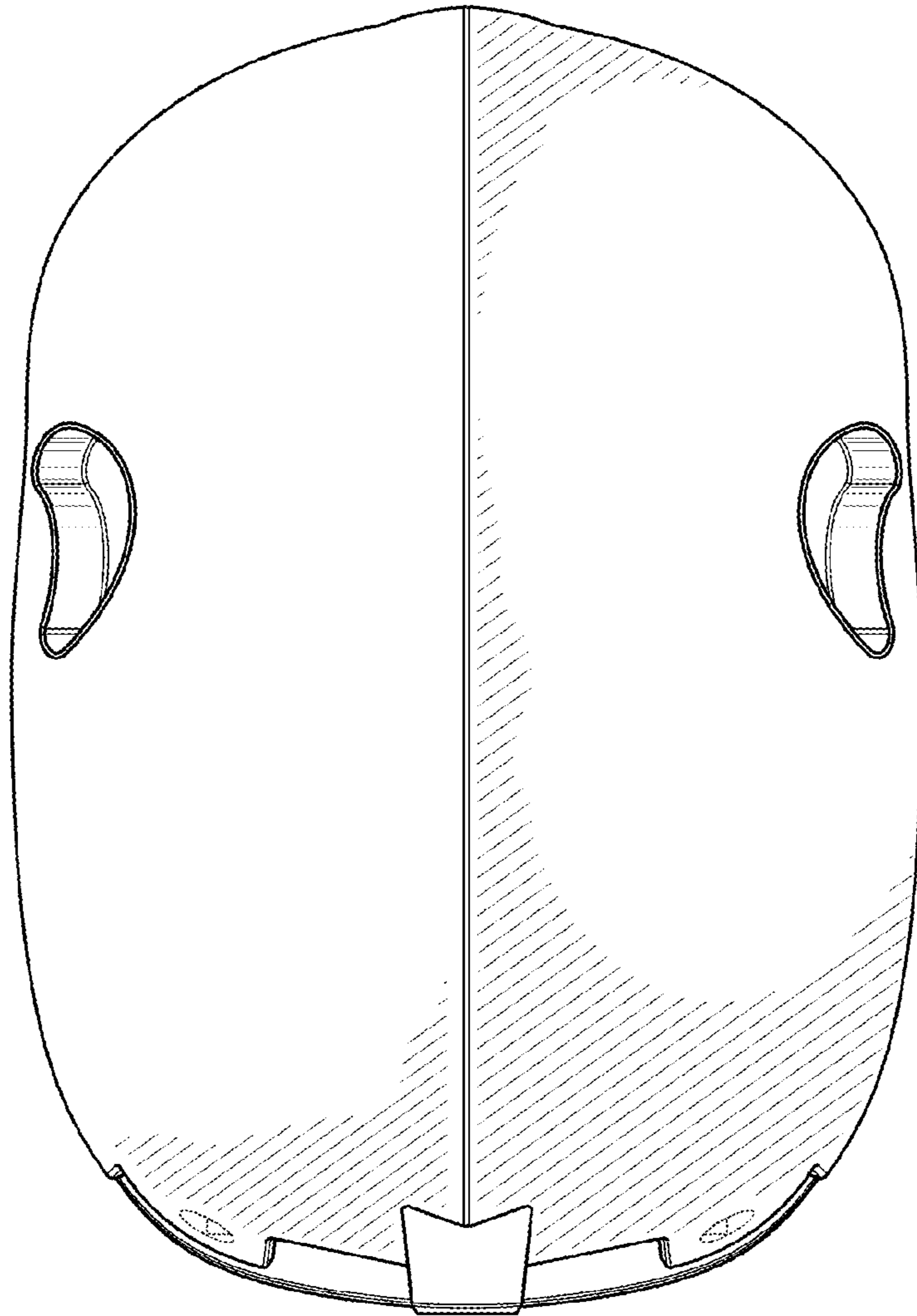

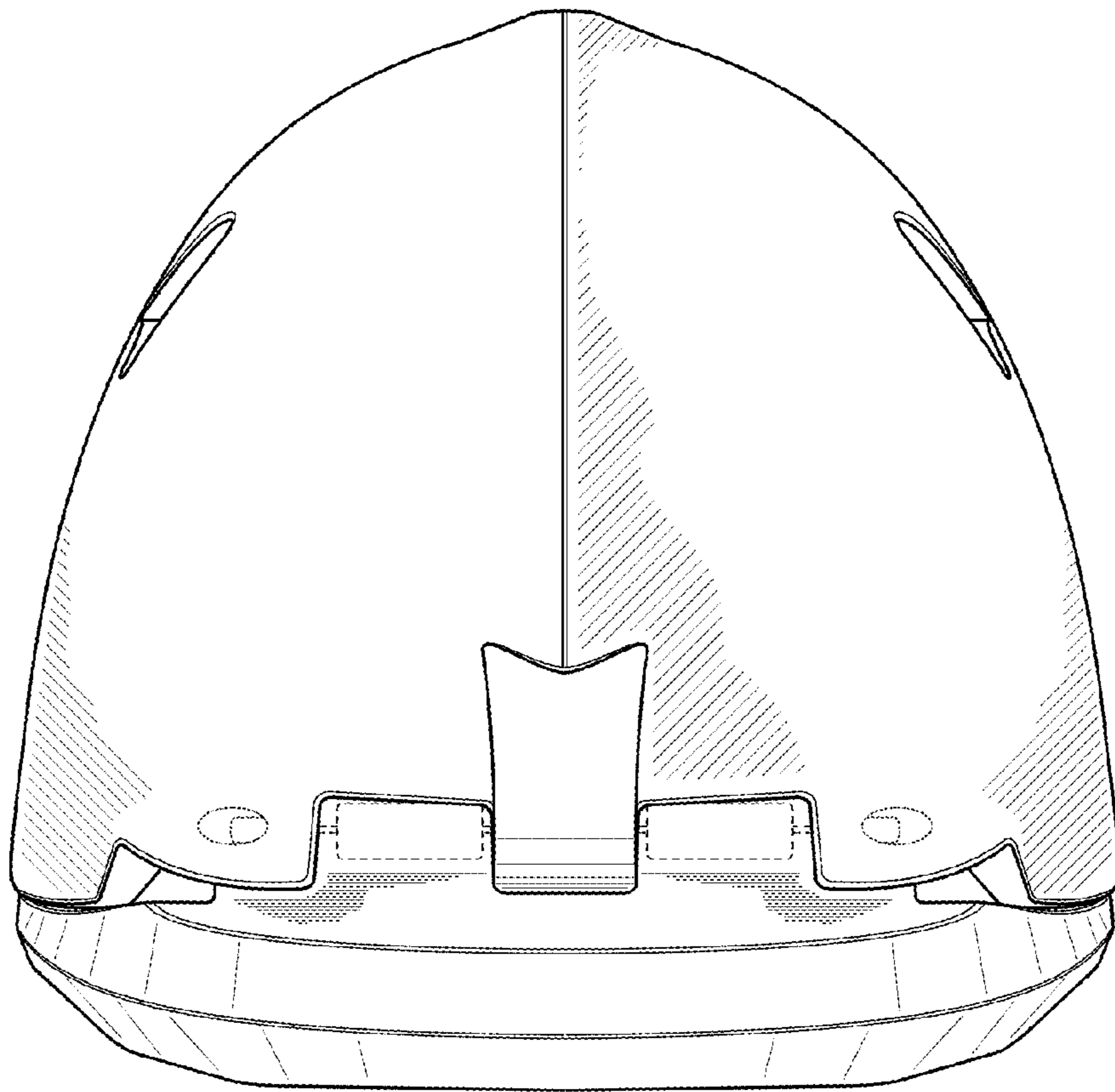

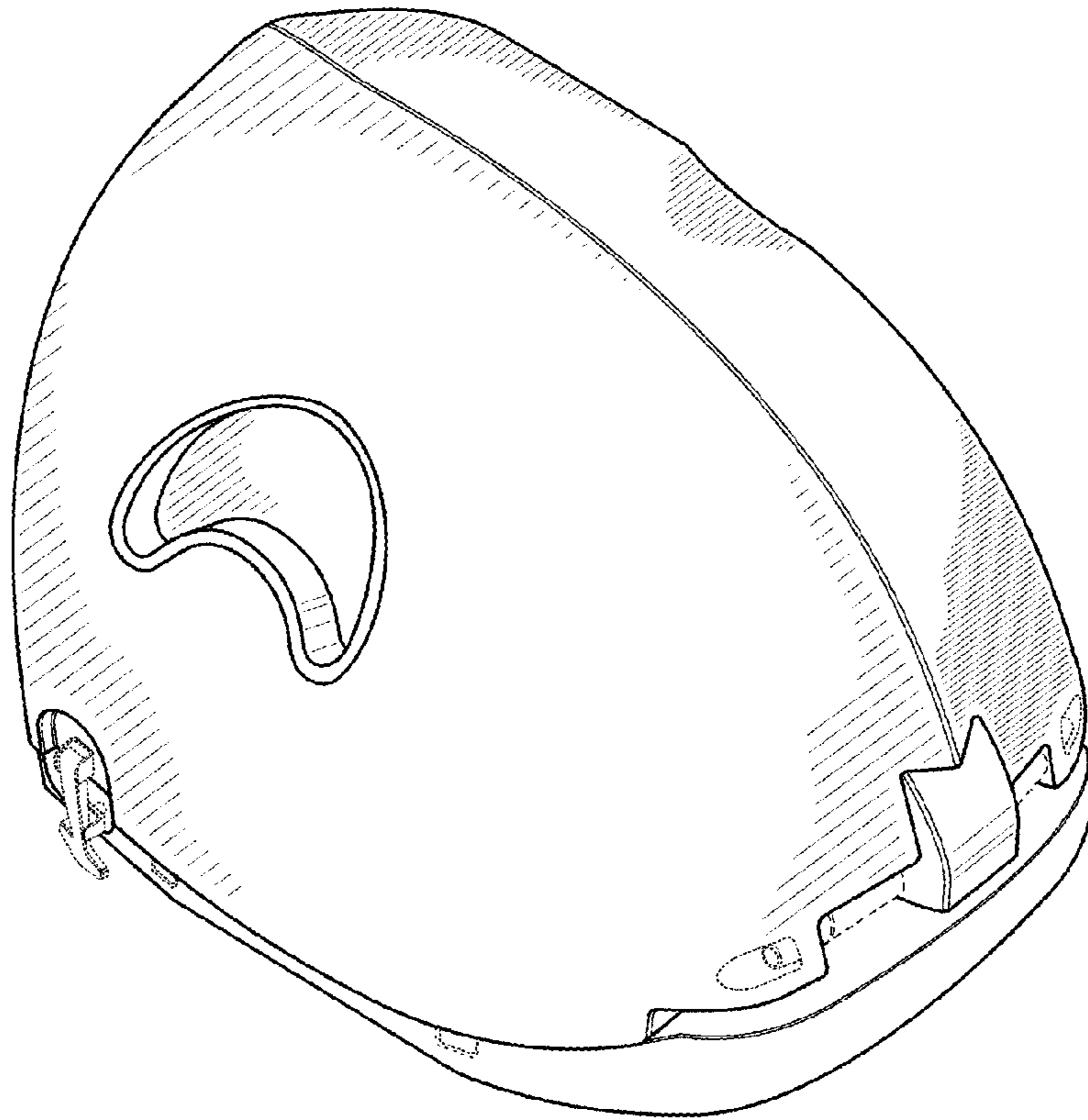

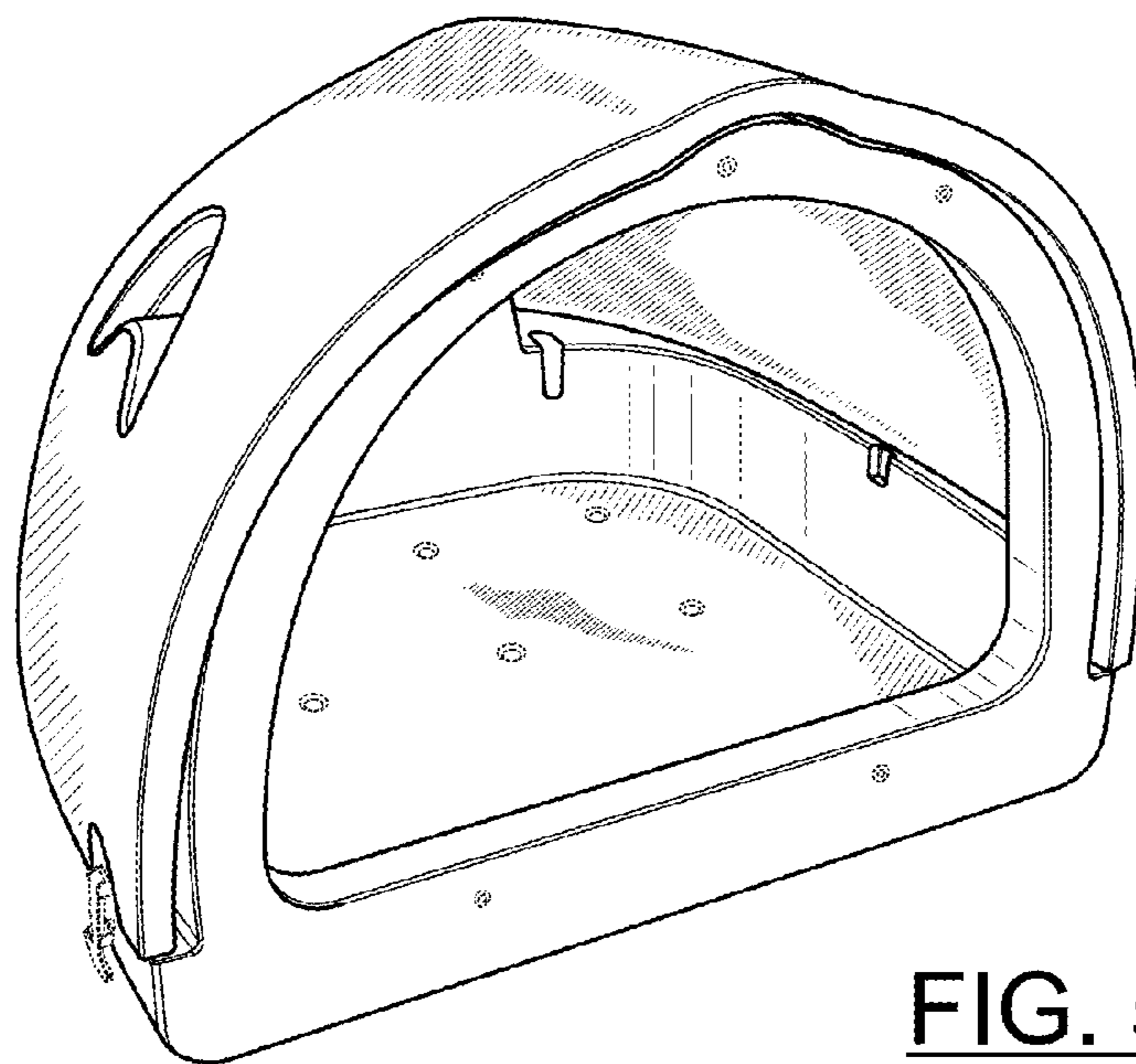

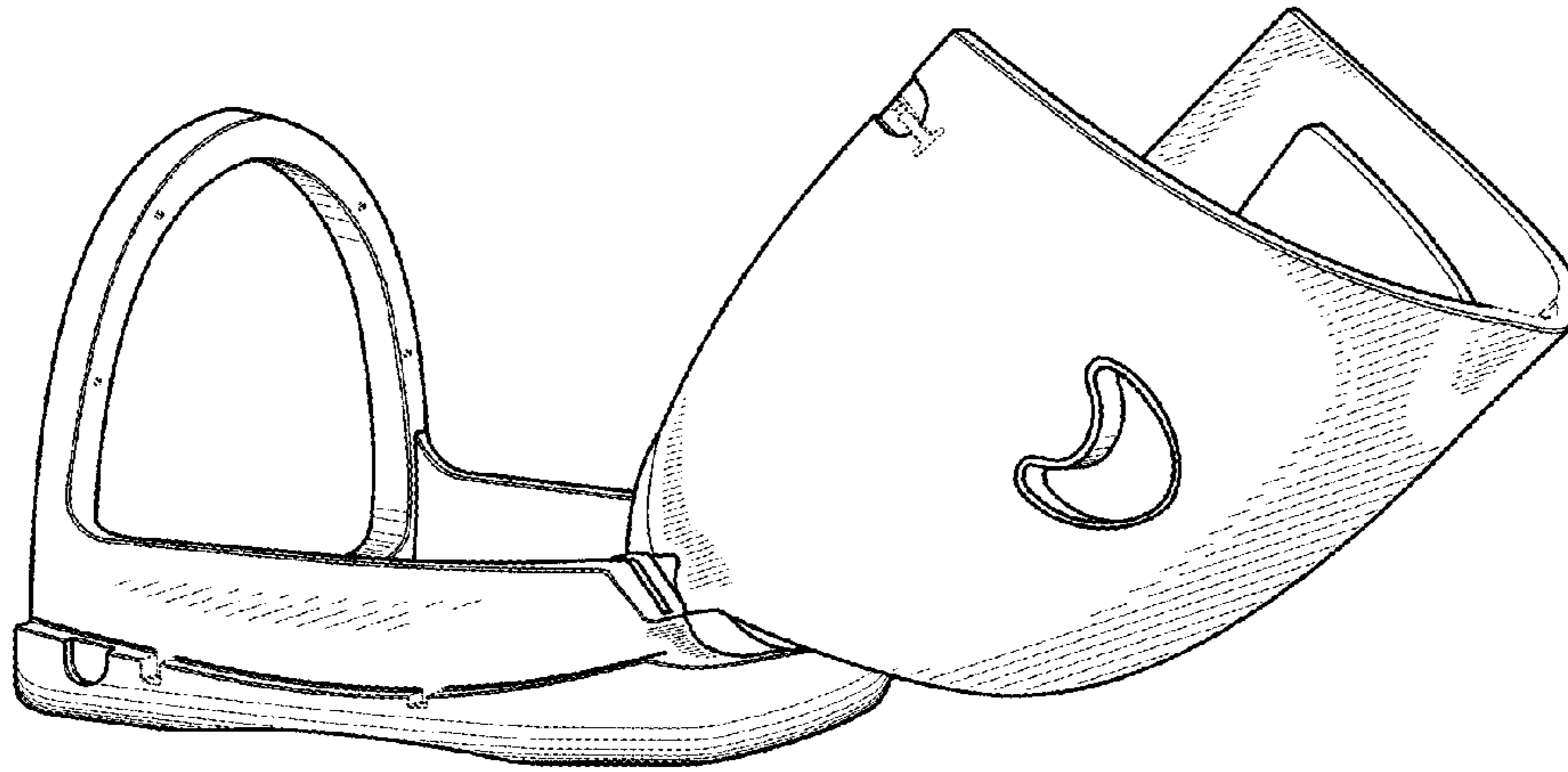

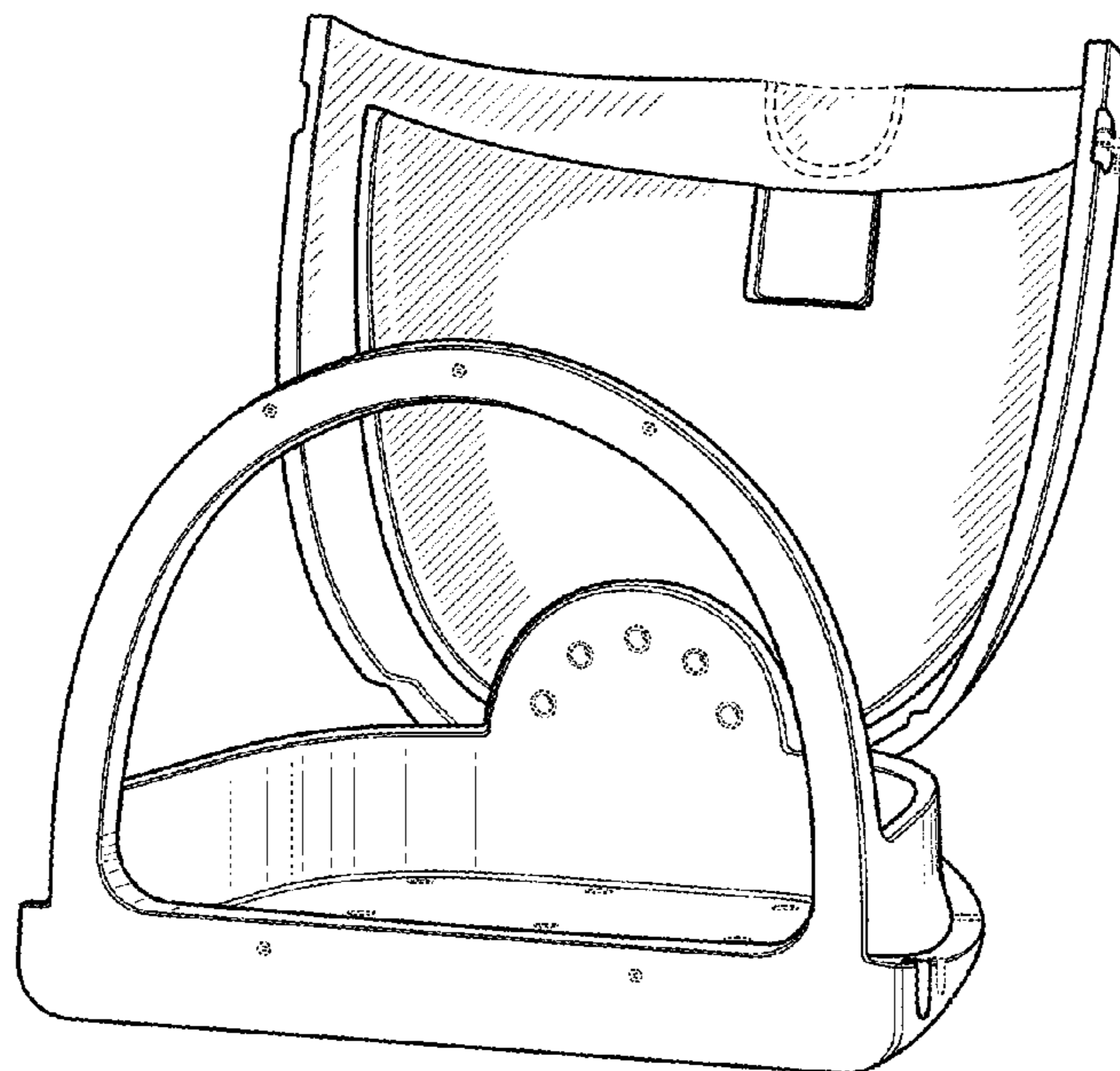
