(57) **CLAIM**

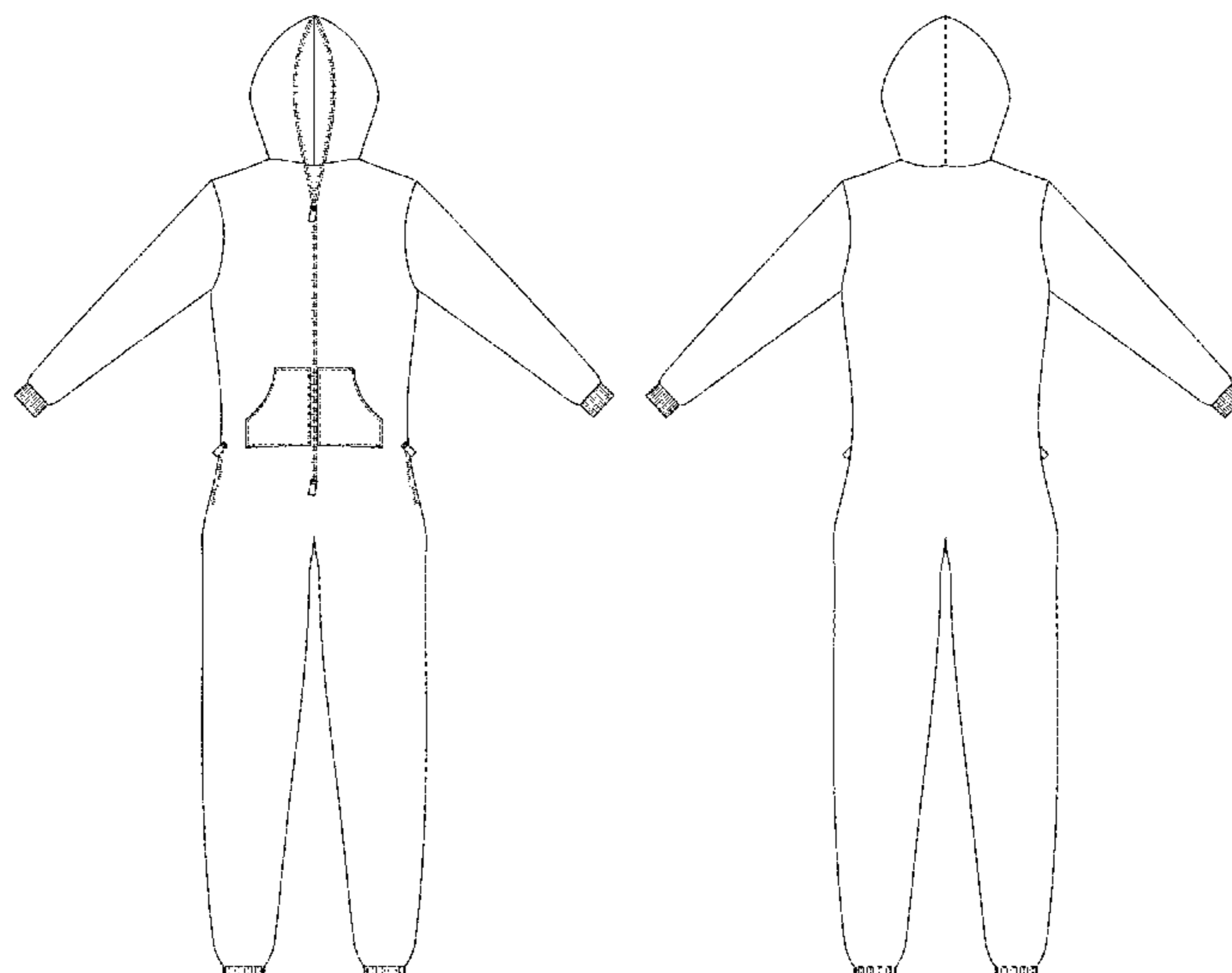
The ornamental design for a jumpsuit, as shown and described.

DESCRIPTION

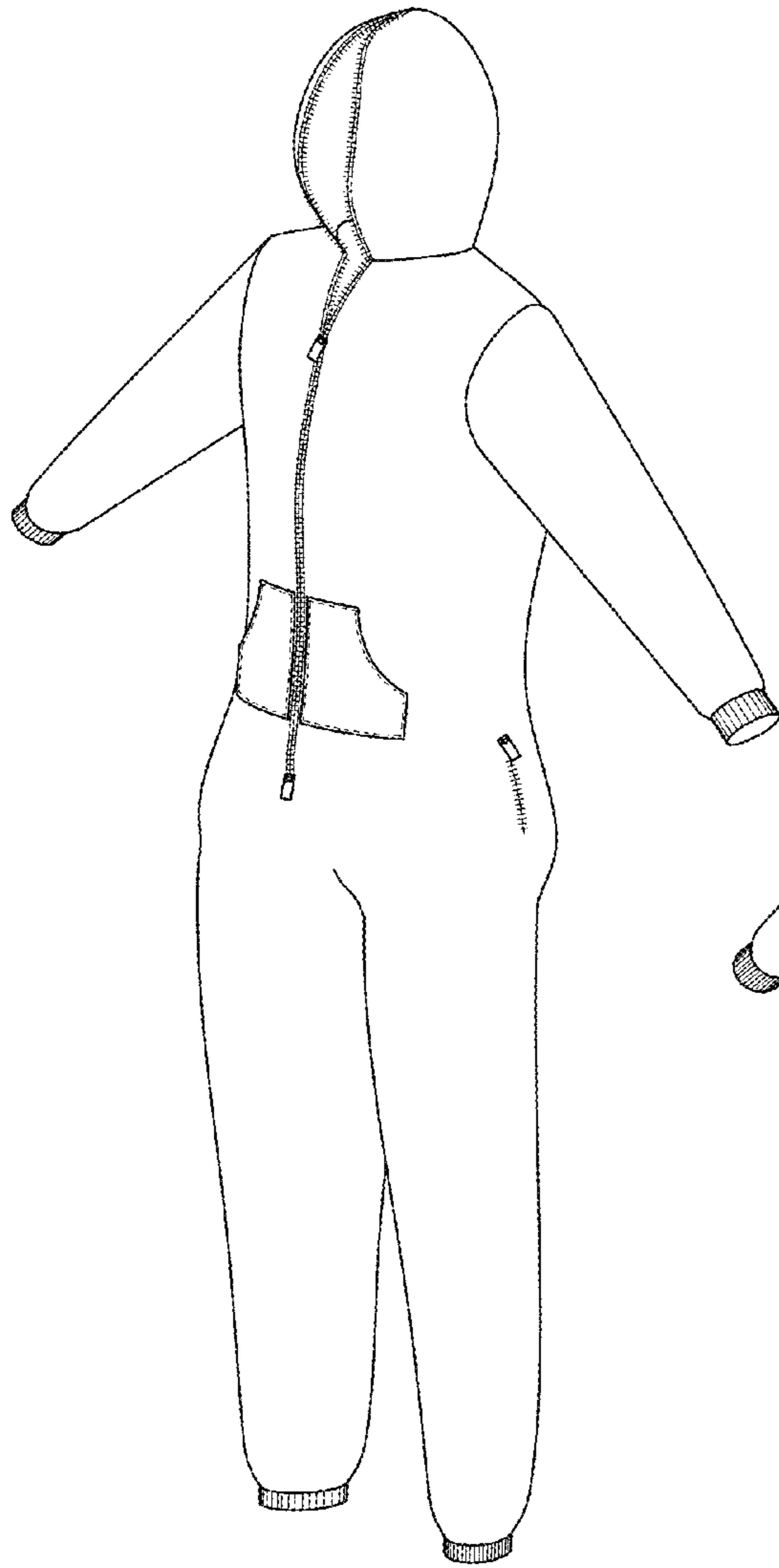

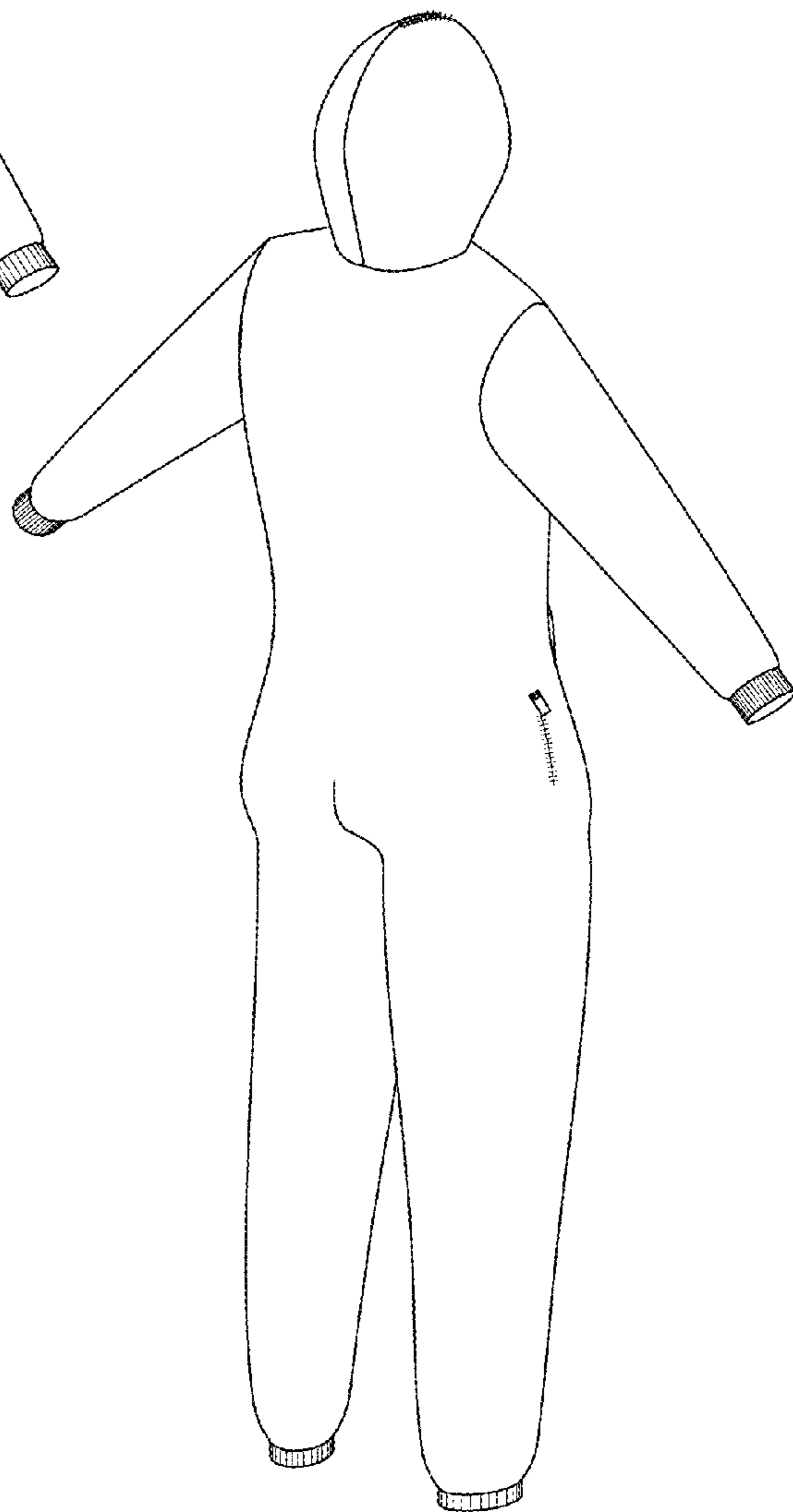

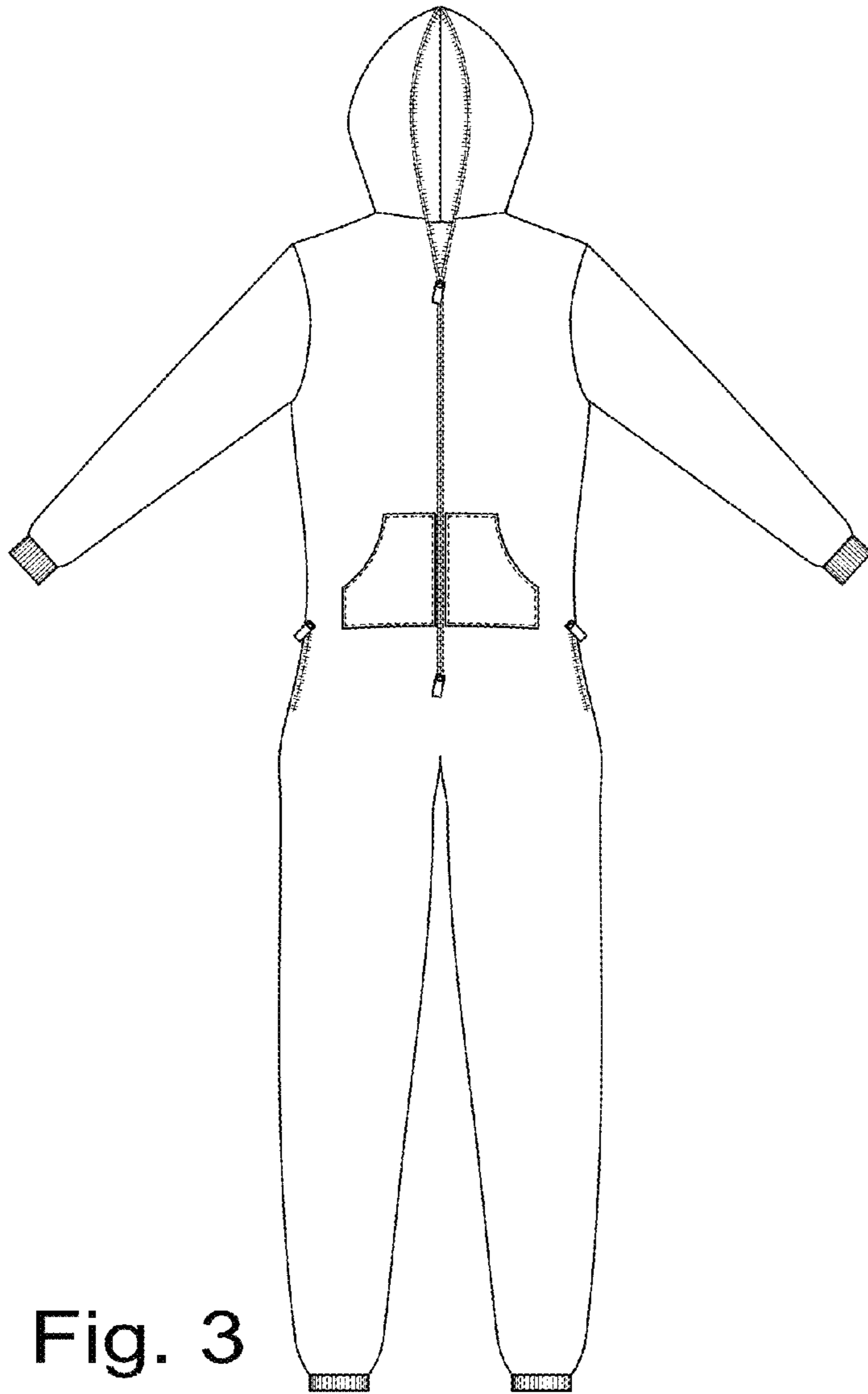

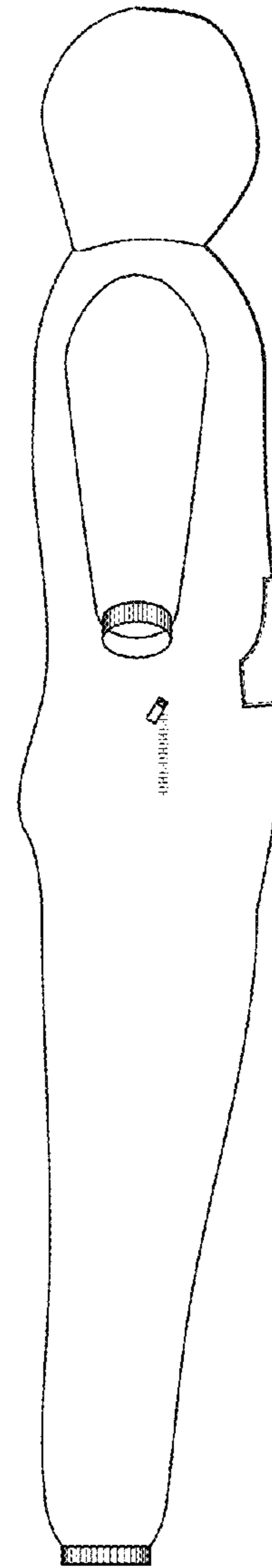

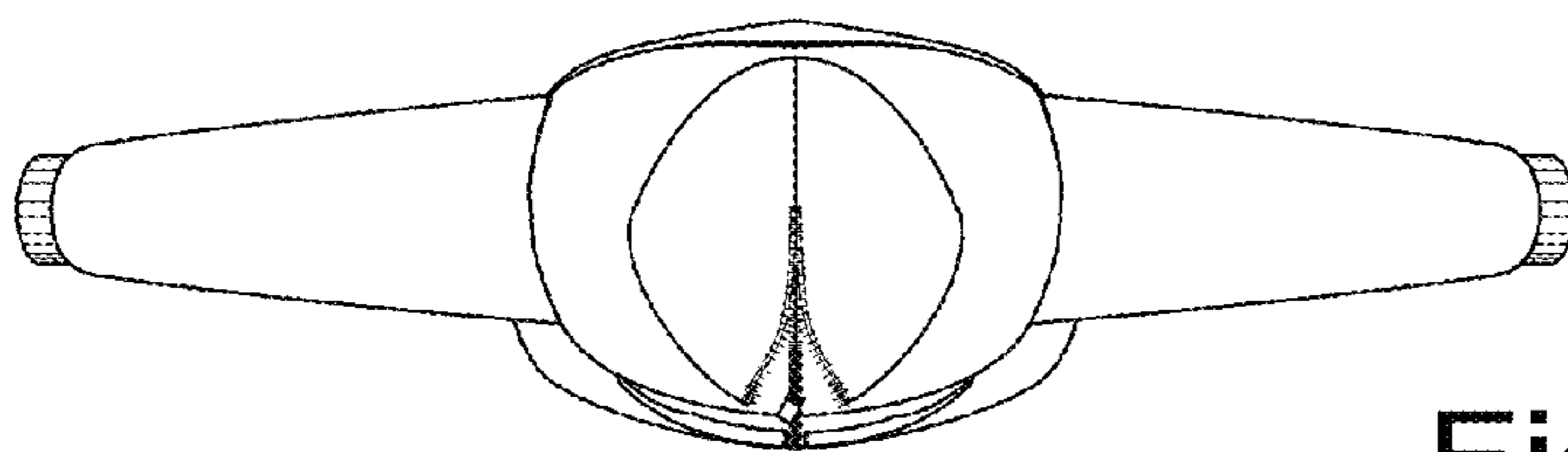

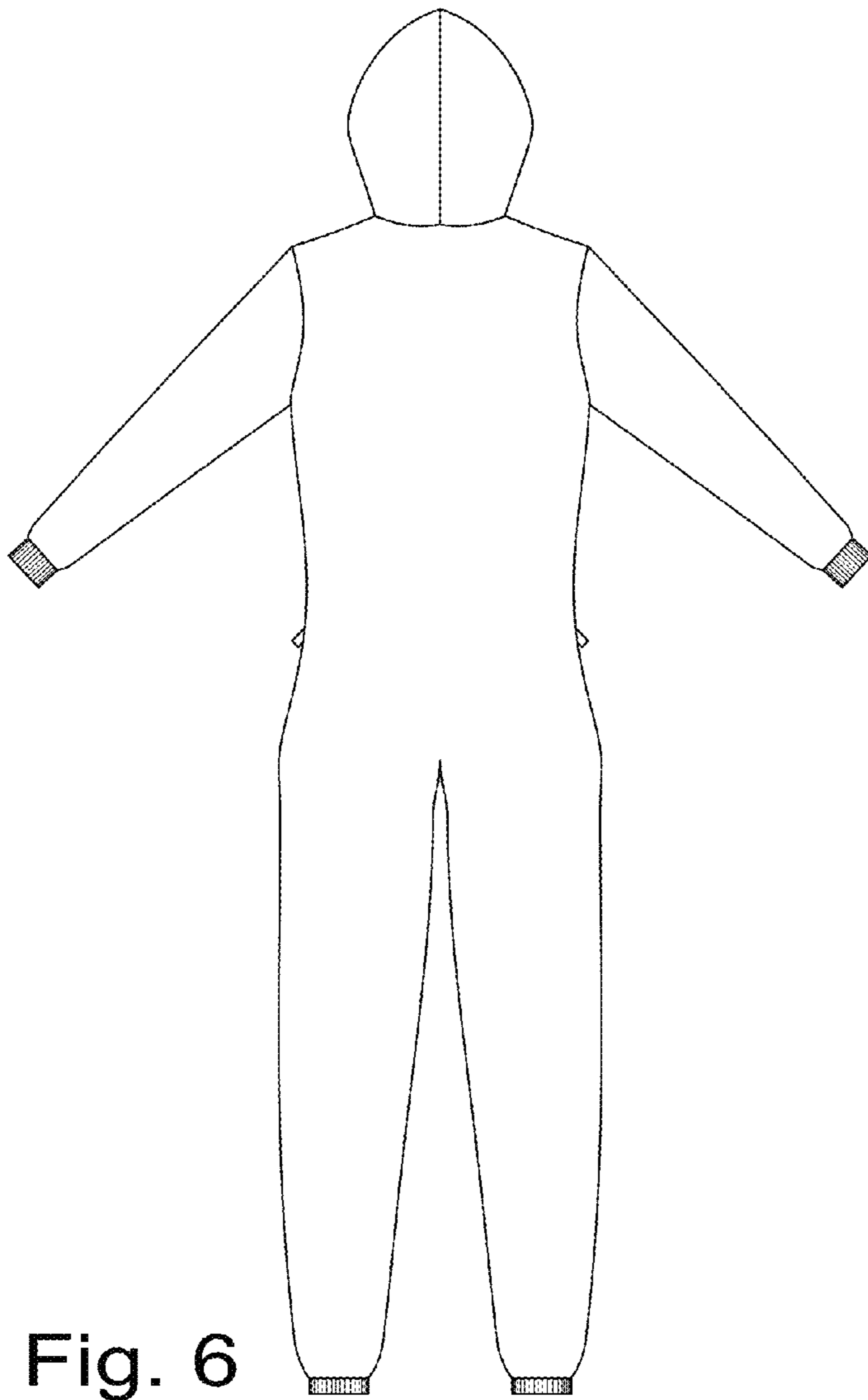

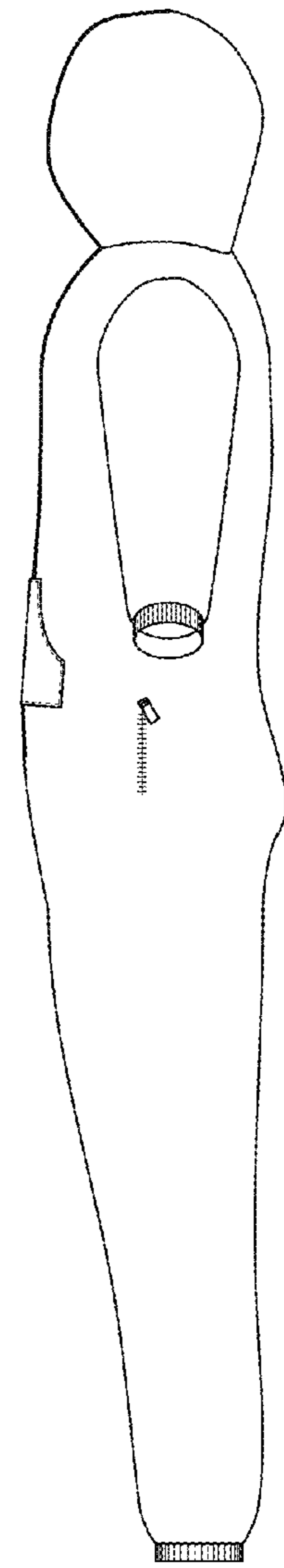

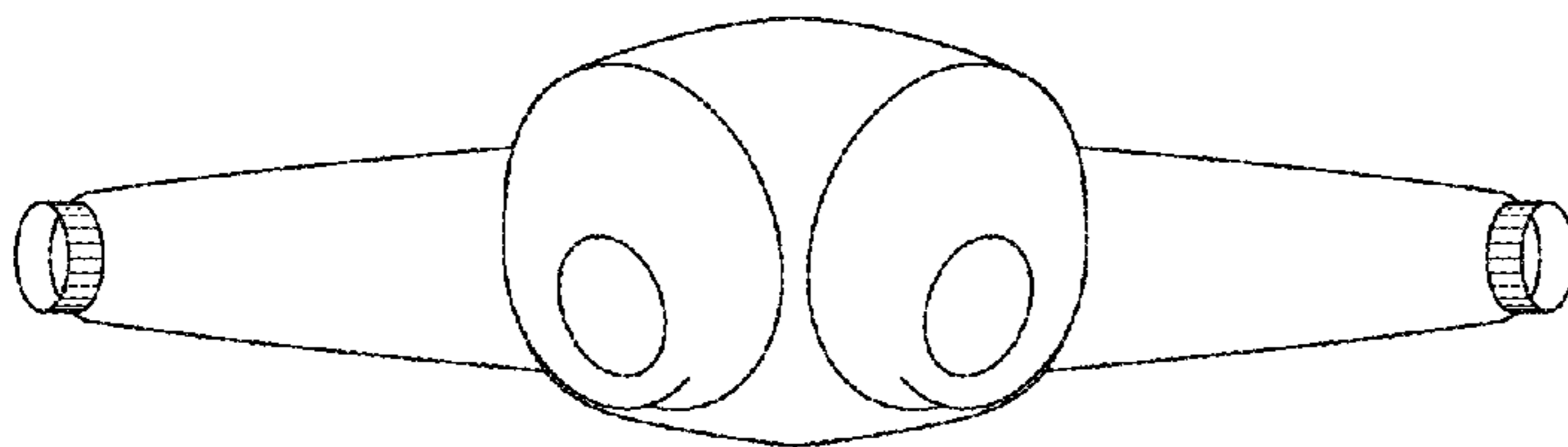
