The ornamental design for a hat, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the hat design; FIG. 2 is a rear perspective view of the hat of FIG. 1; FIG. 3 is a front elevation view of the hat of FIG. 1; FIG. 4 is a rear elevation view of the hat of FIG. 1; FIG. 5 is a left side elevation view of the hat of FIG. 1, the right side elevation view being a mirror image thereof; FIG. 6 is a top plan view of the hat of FIG. 1; and, FIG. 7 is a bottom plan view of the hat of FIG. 1.

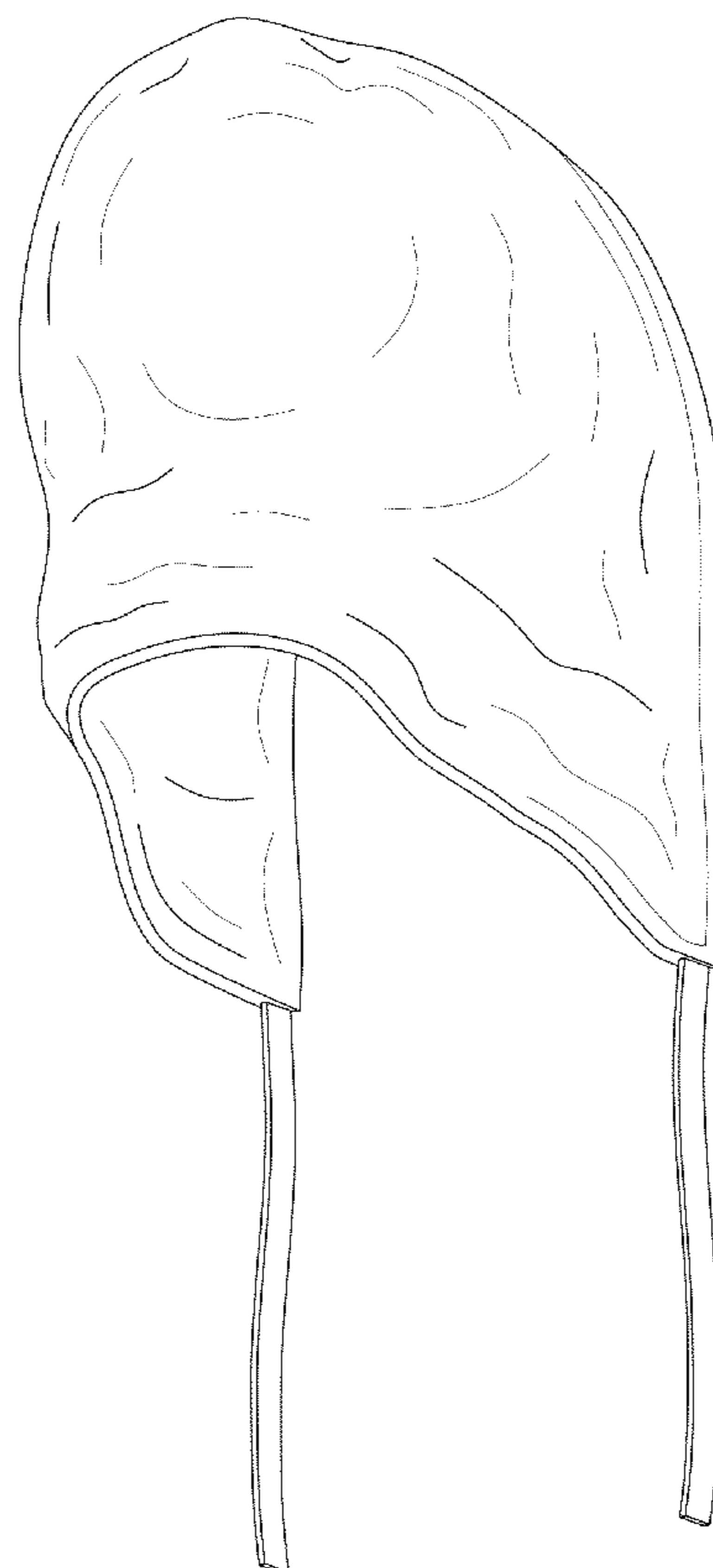
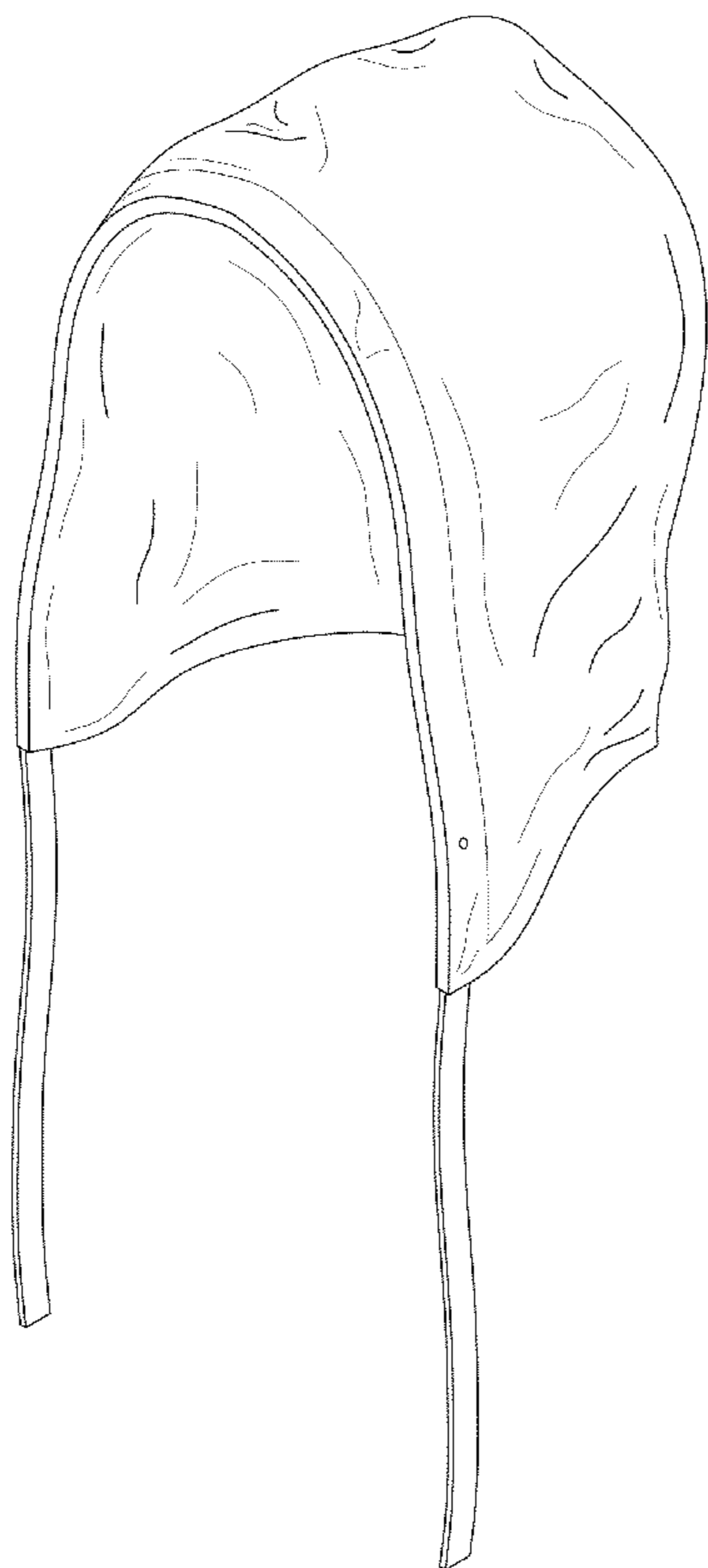

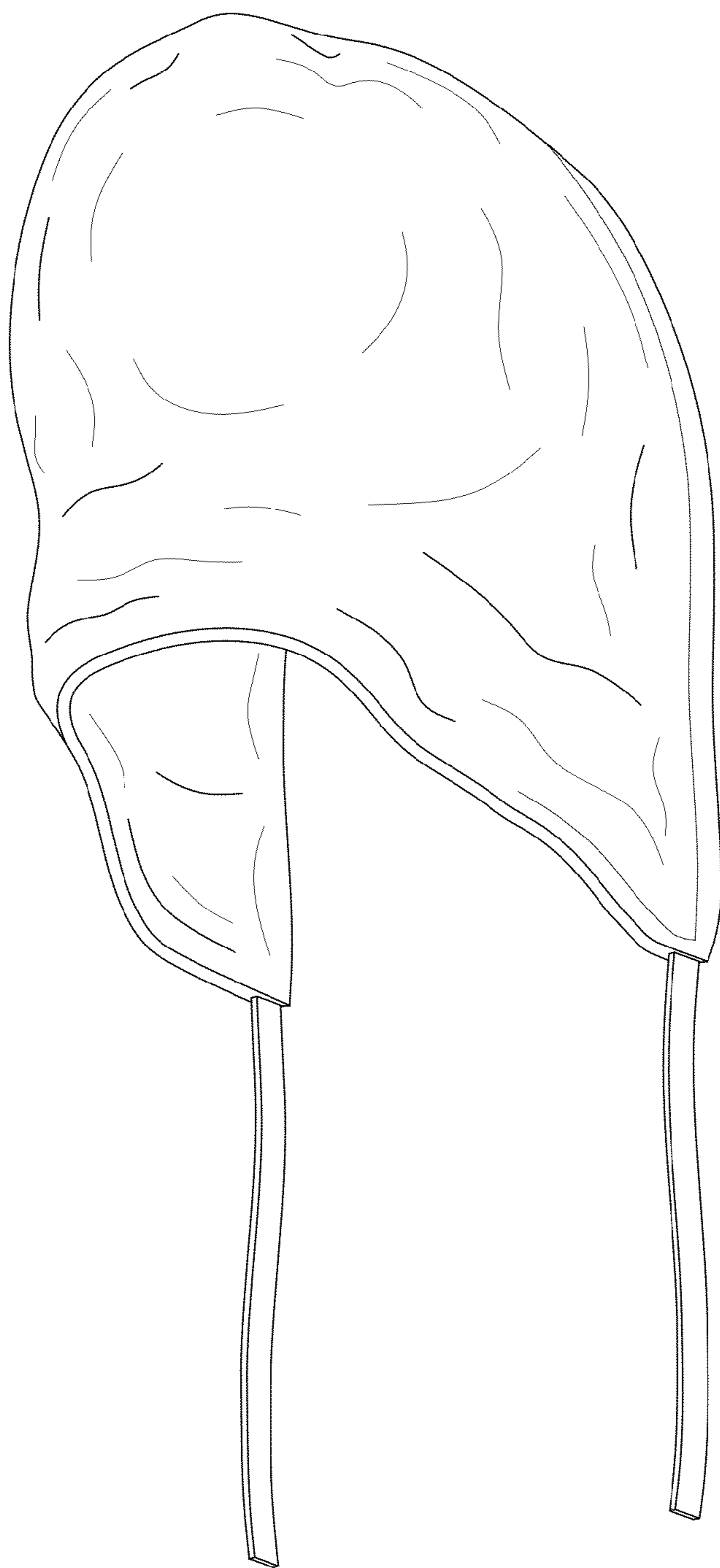

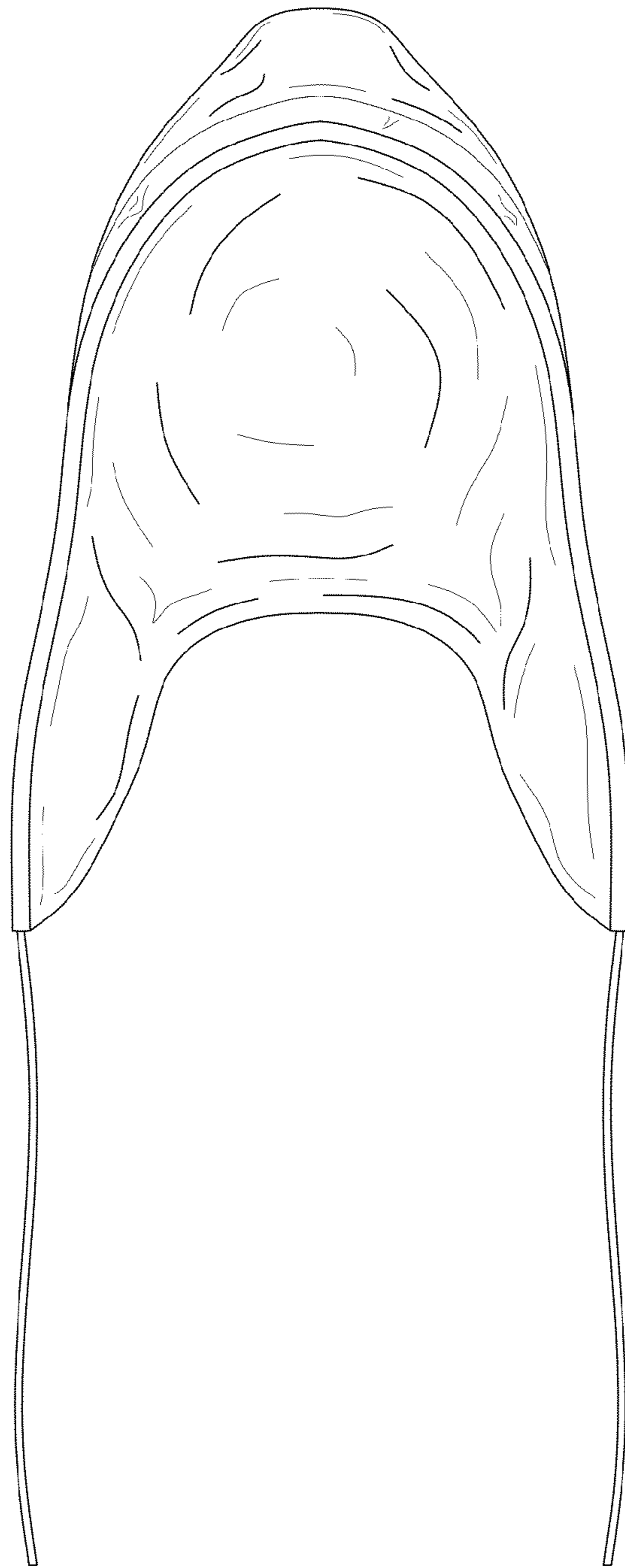

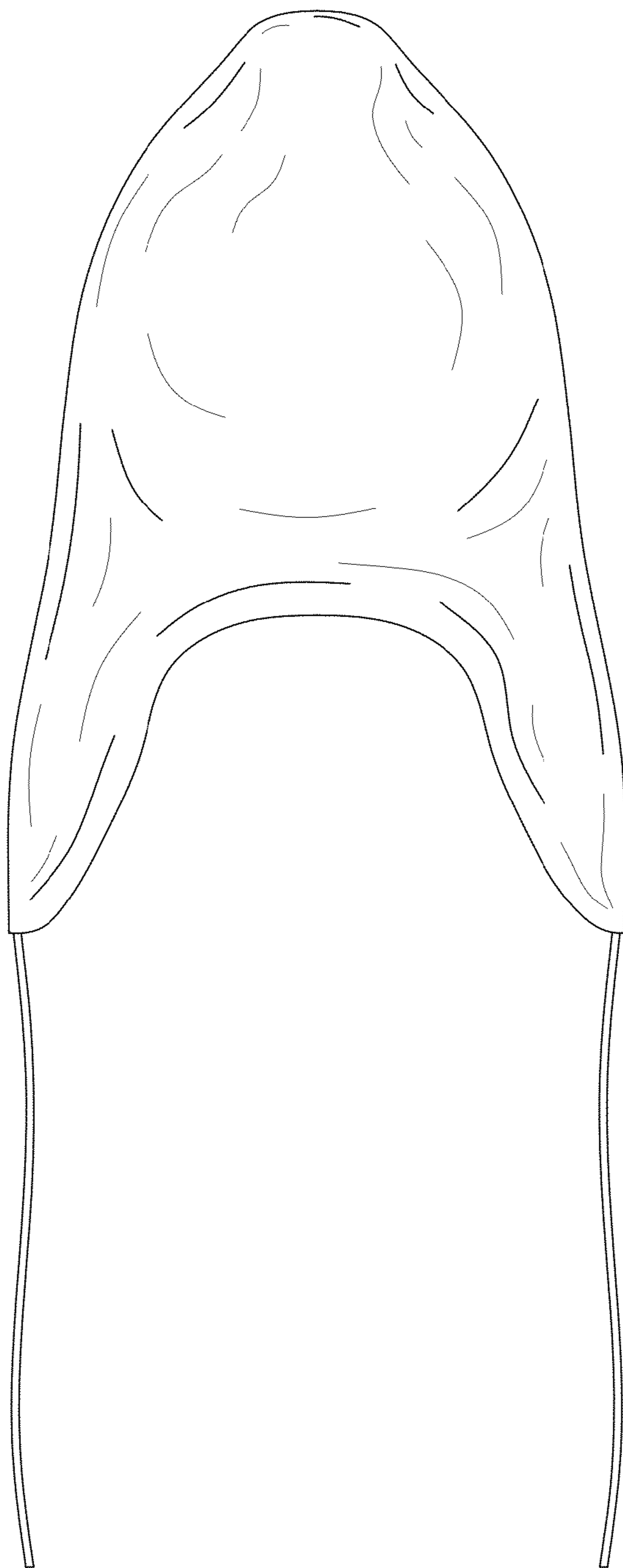

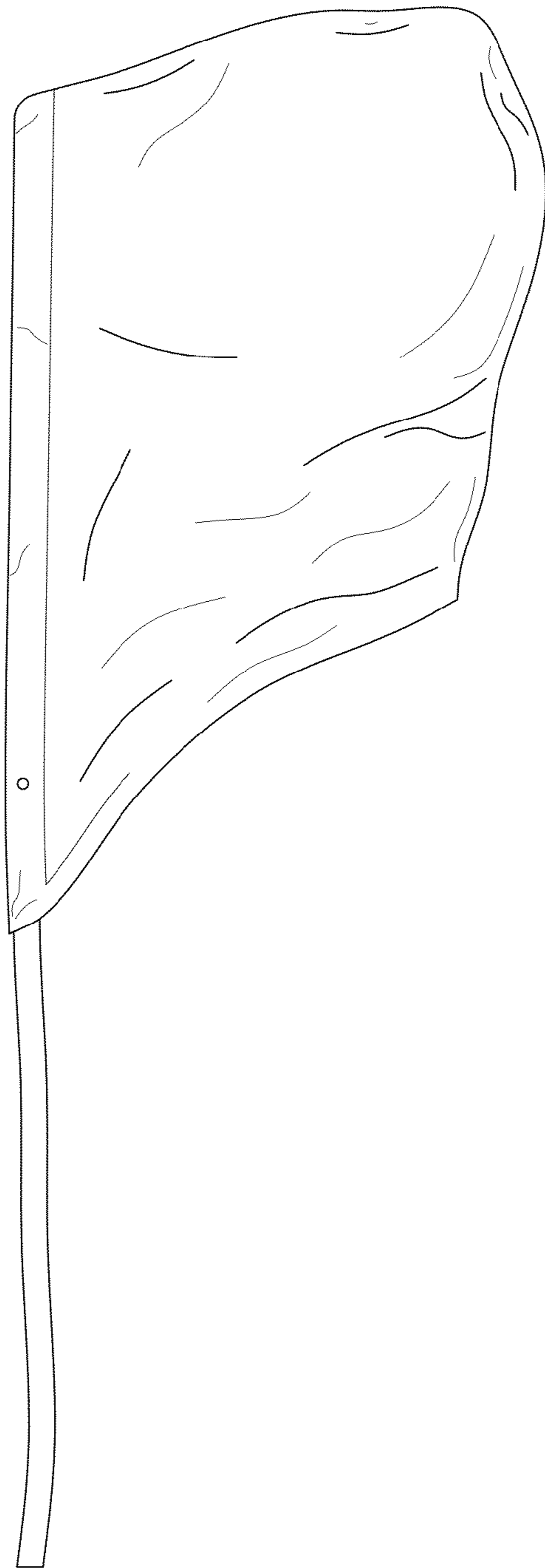

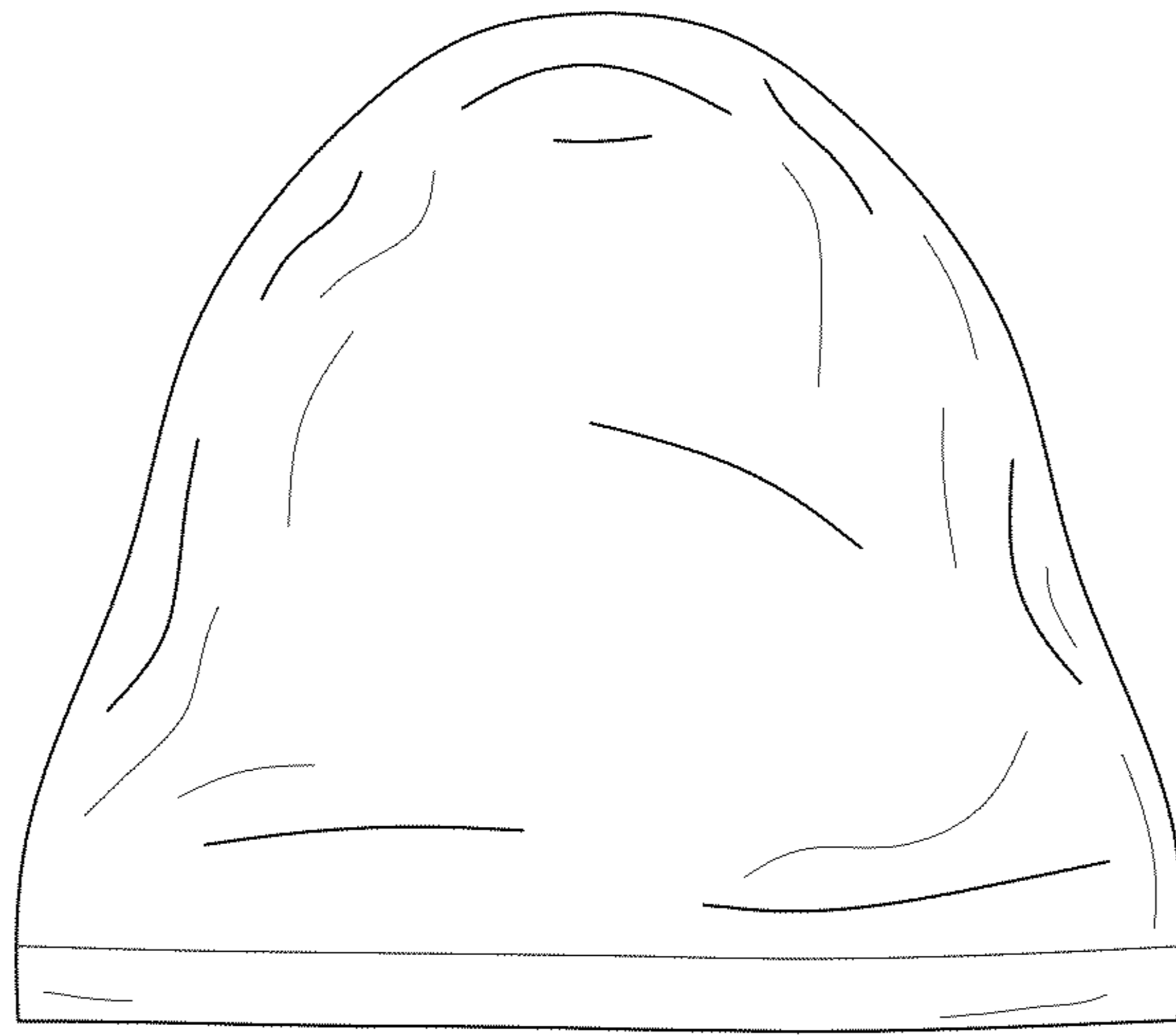
