FIG. 6 is a perspective view of the cooking appliance comprising the utensil according to the second embodiment of the invention.

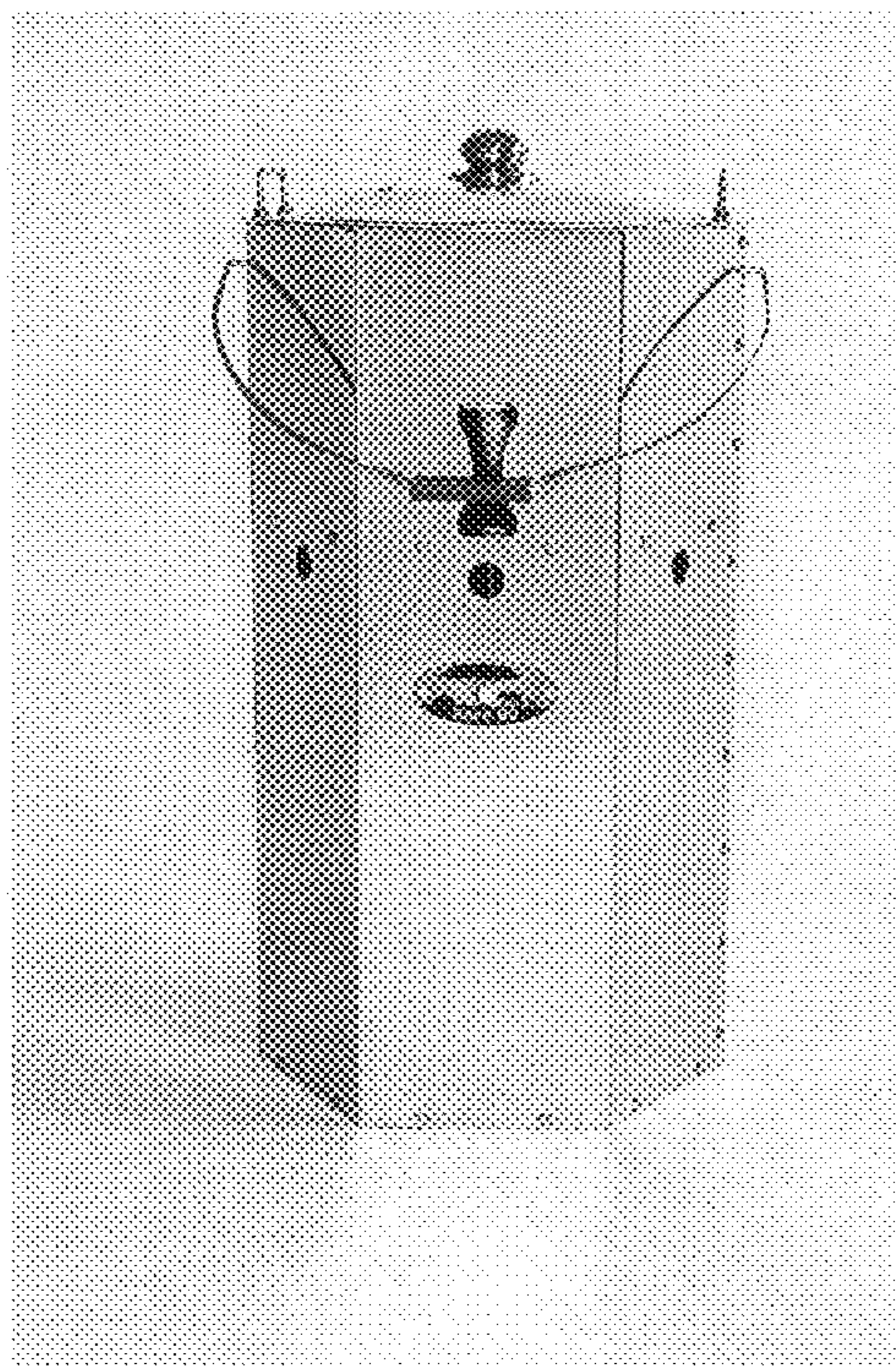

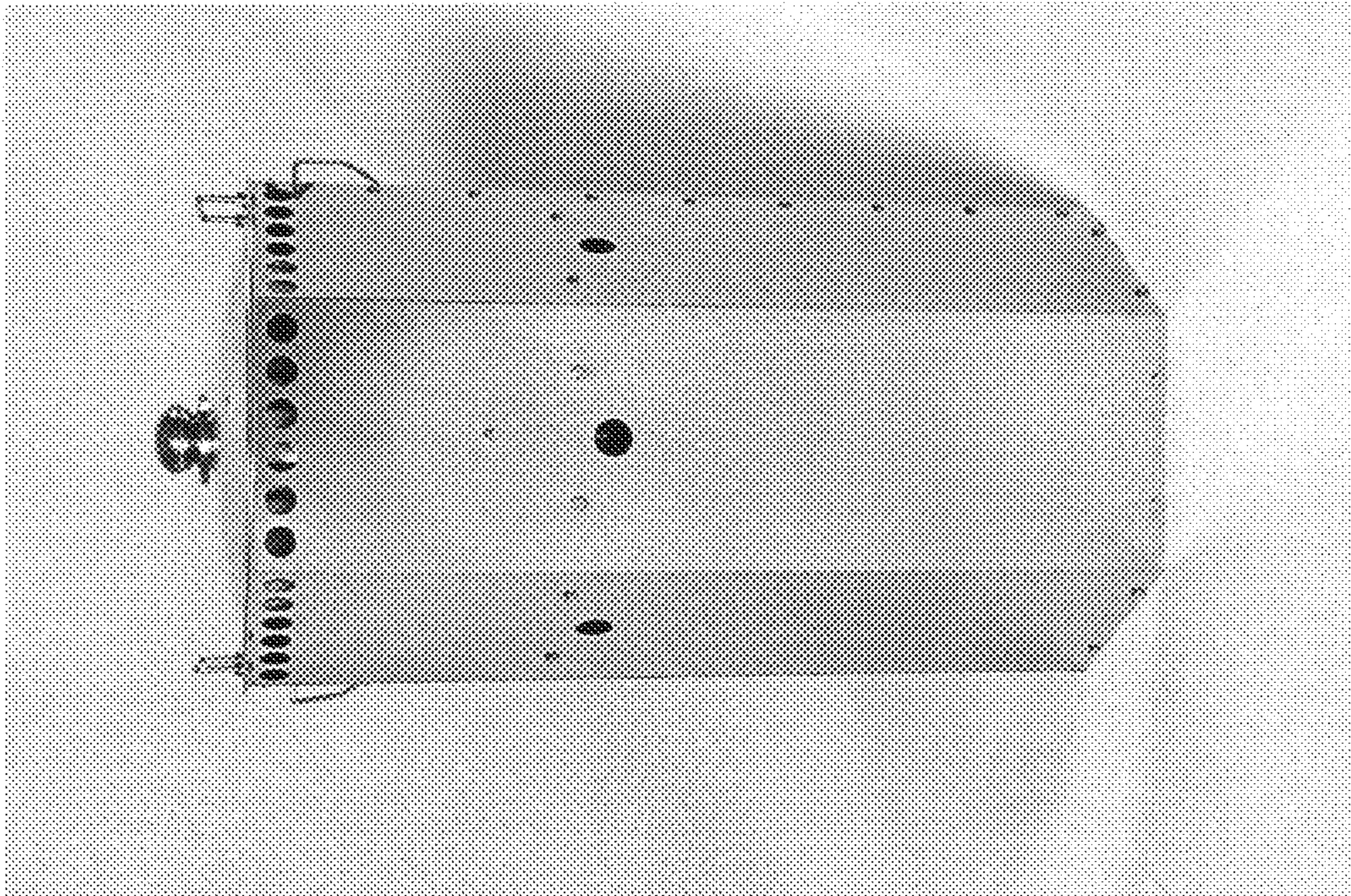

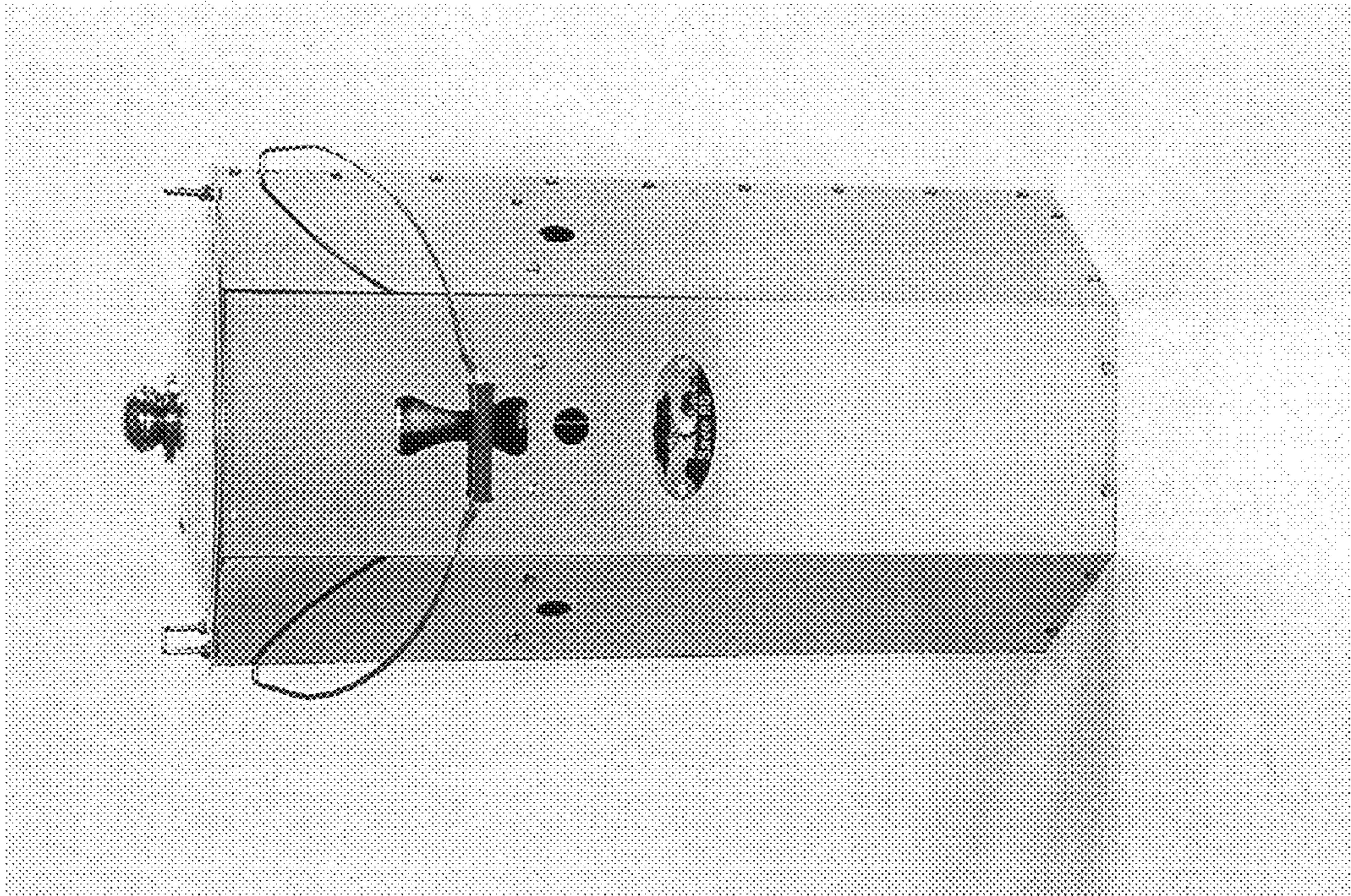

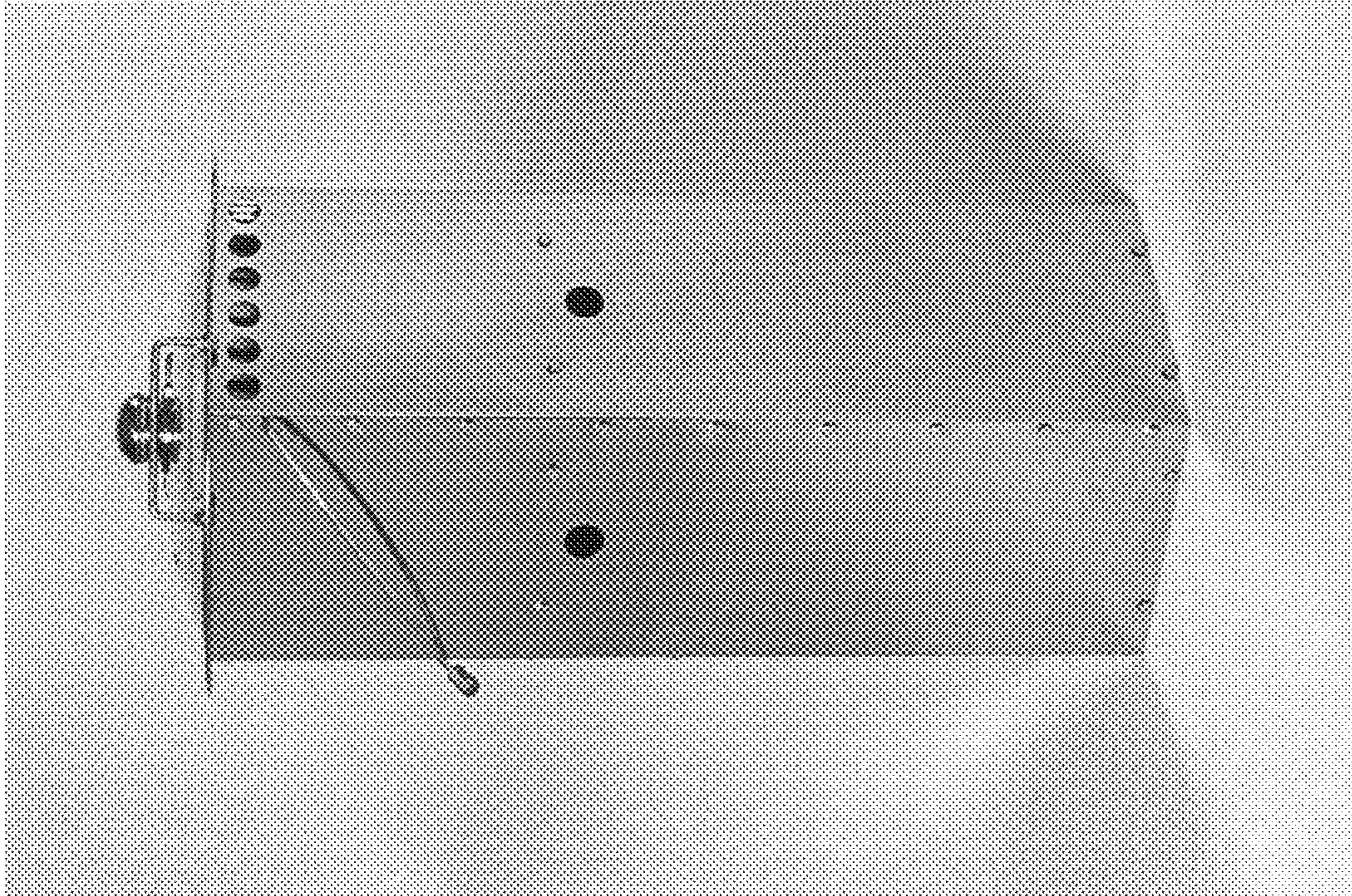

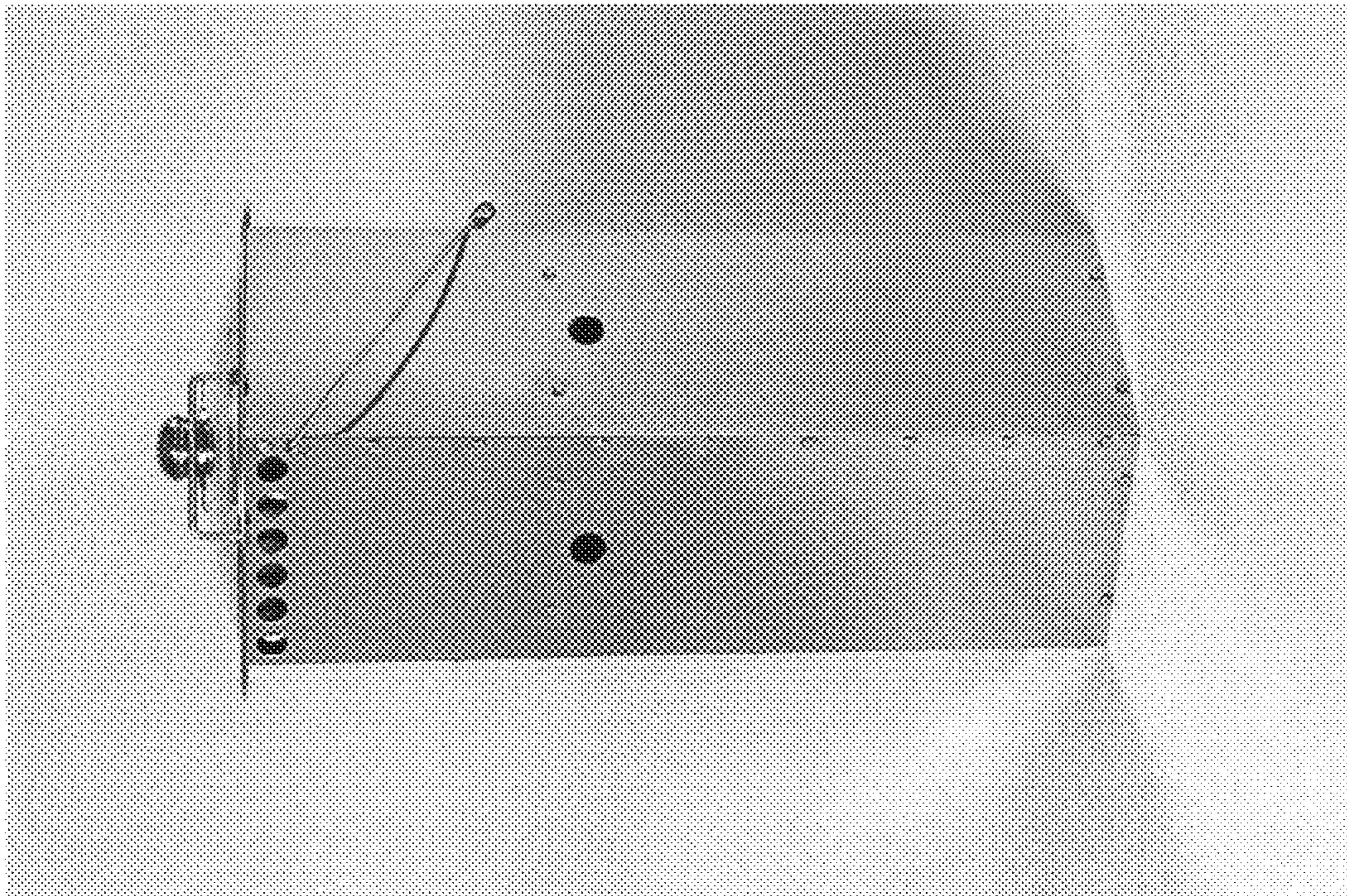

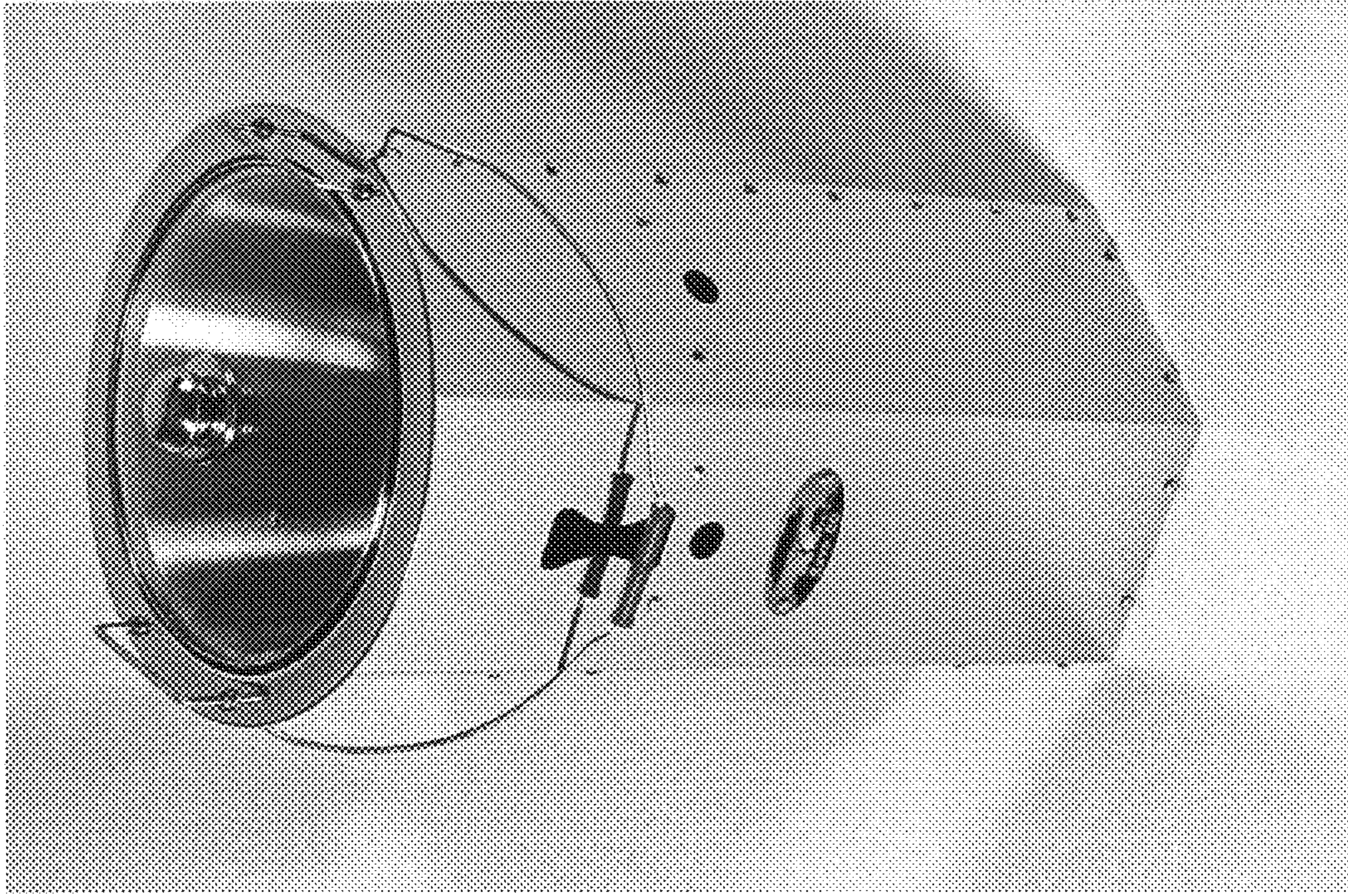

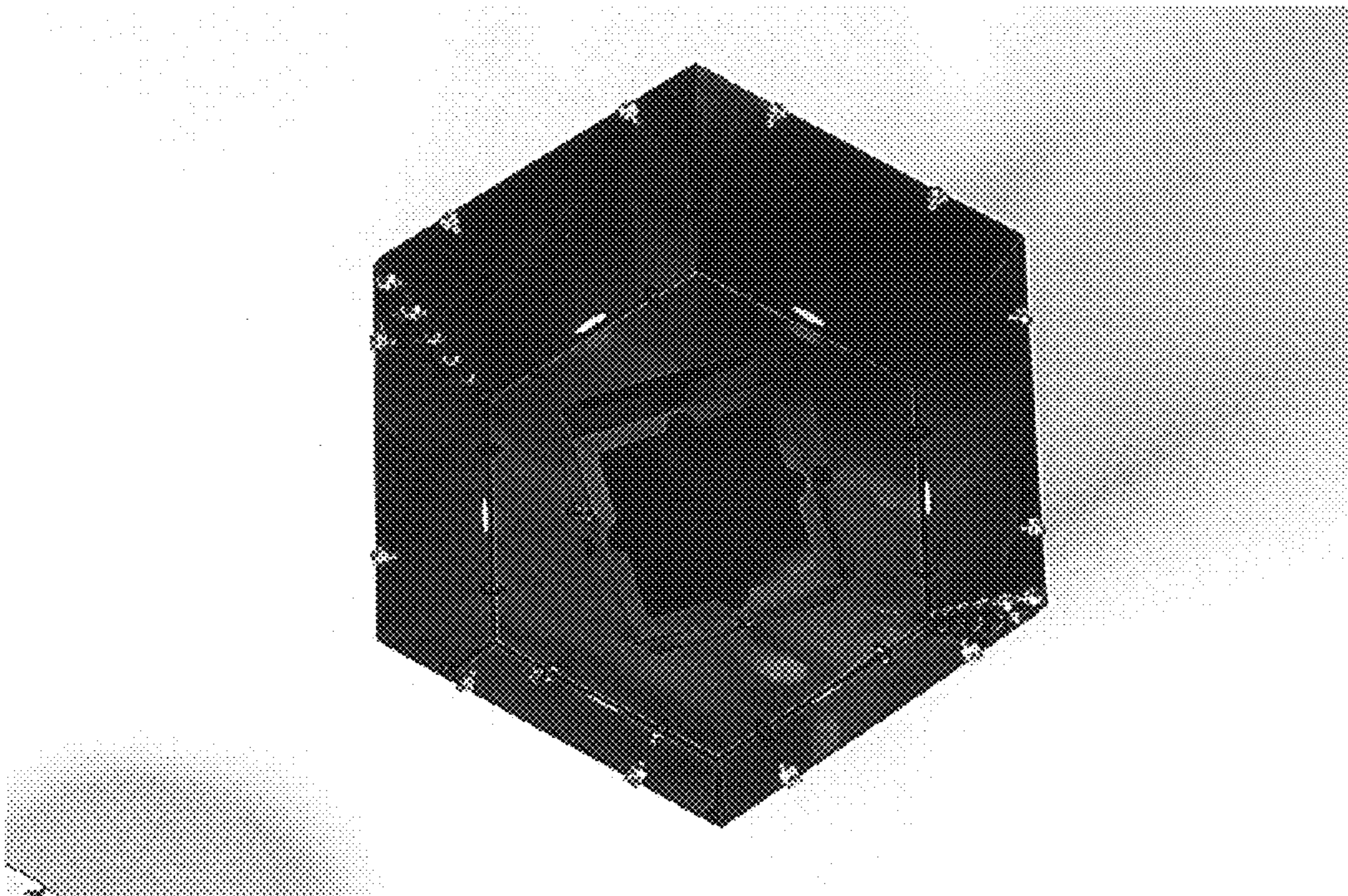
