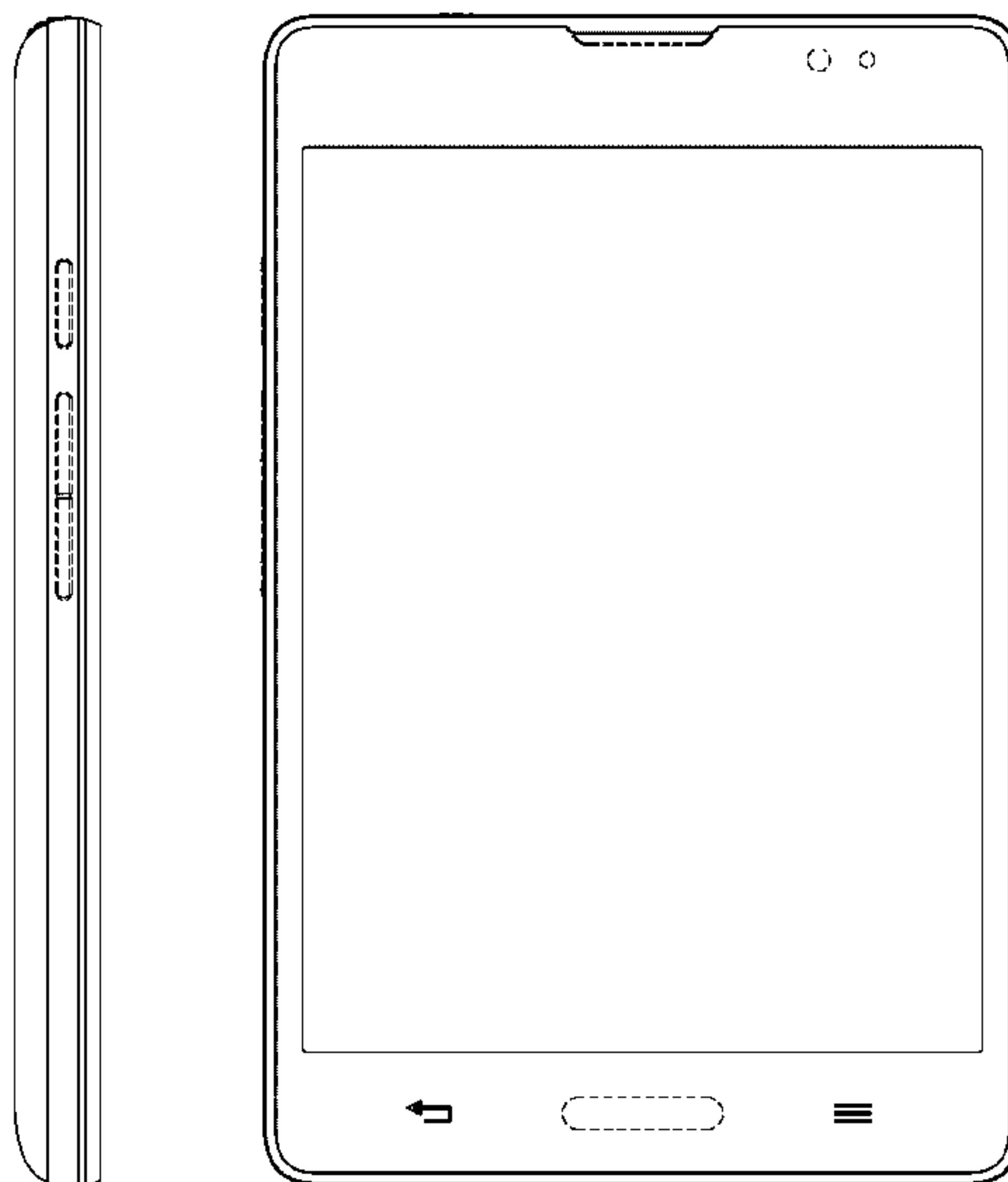
(57) **CLAIM**

The ornamental design for a cellular phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, perspective view of a cellular phone showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; and, FIG. 8 is a front view thereof in an operation state. The broken lines shown in the figures represent the bounds of the claimed design. The broken lines and the space within the broken lines form no part of the claimed design.

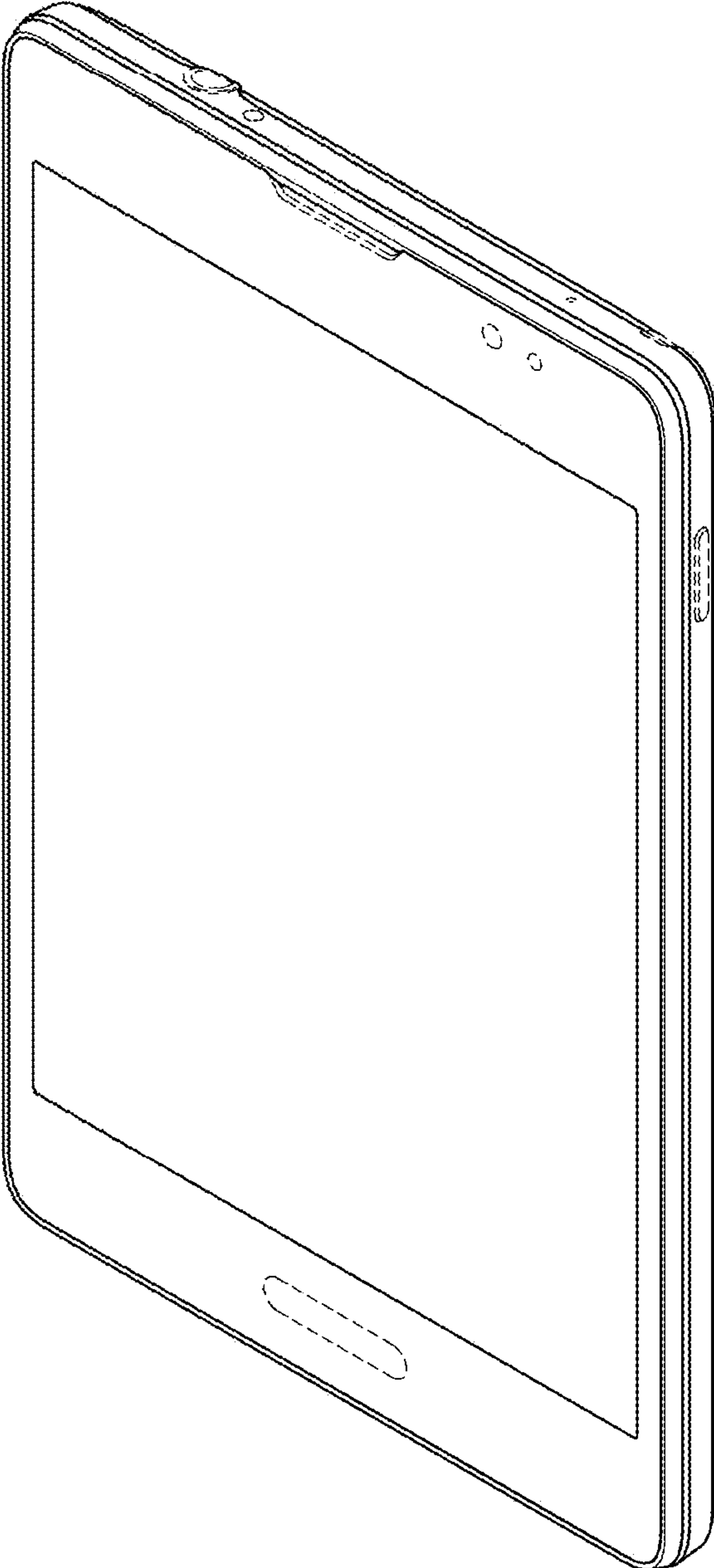

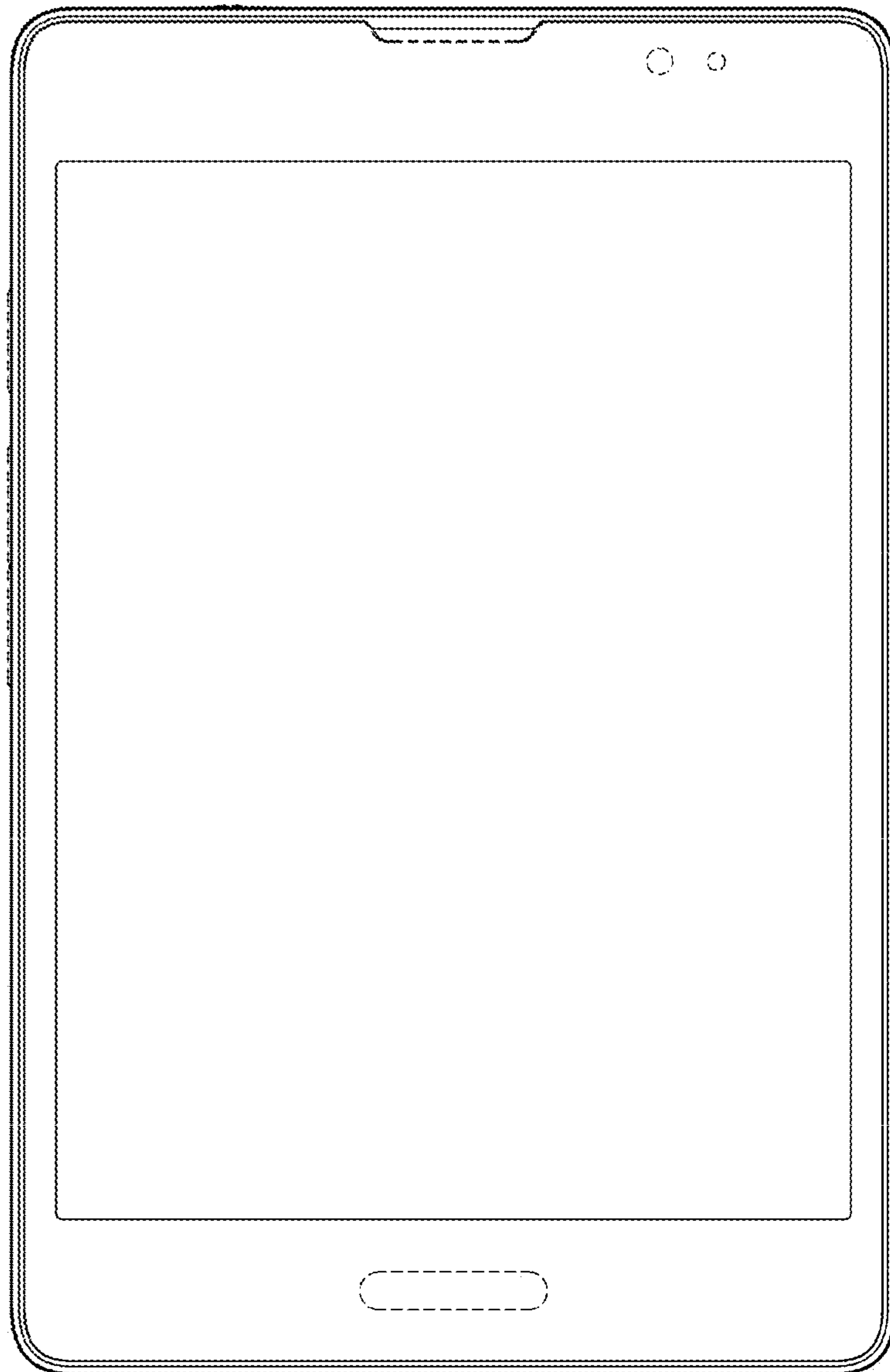

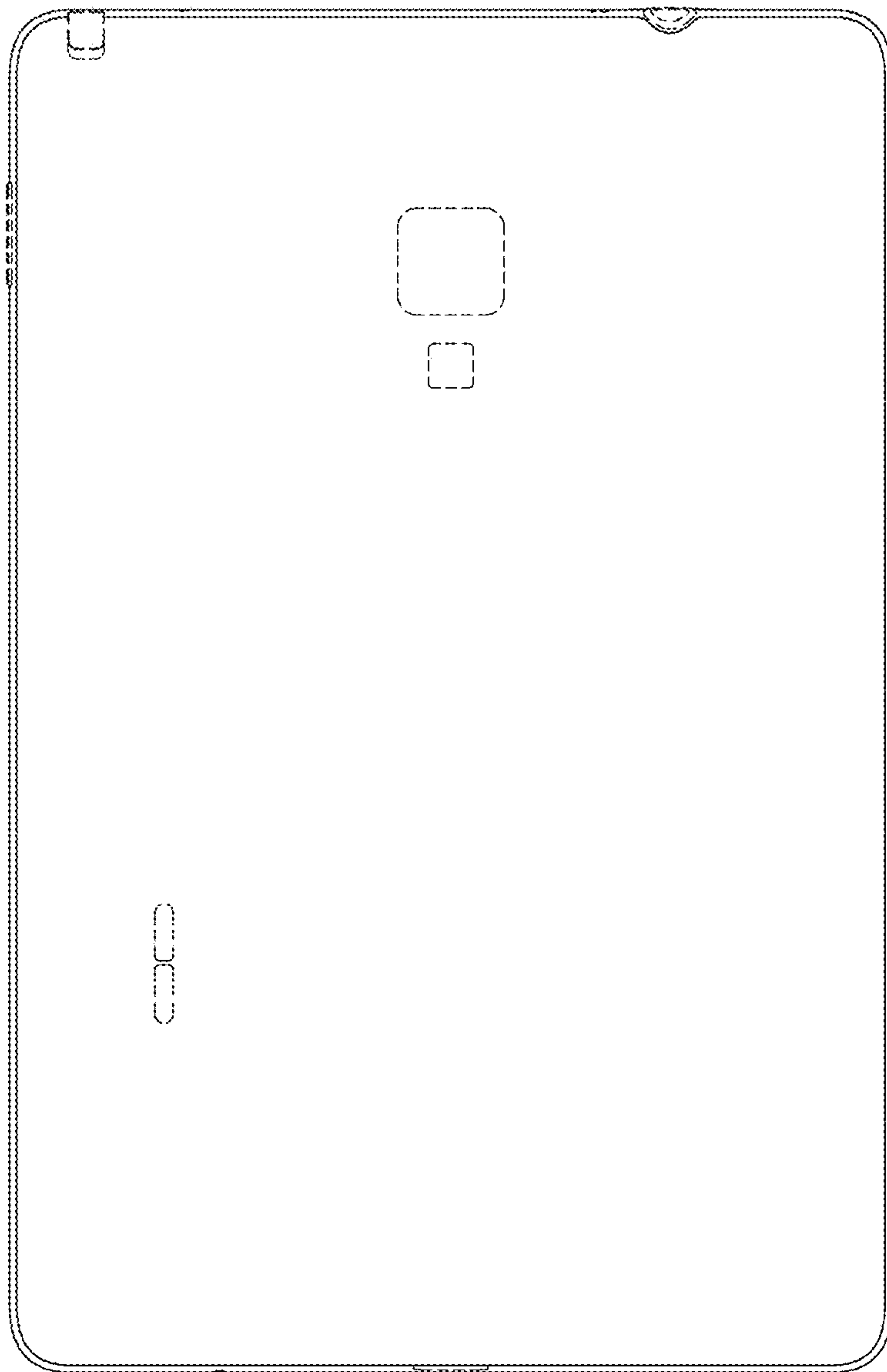

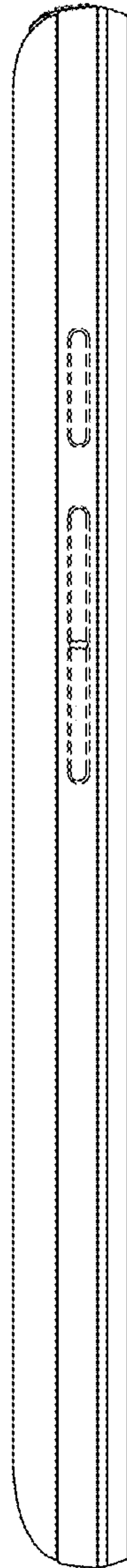

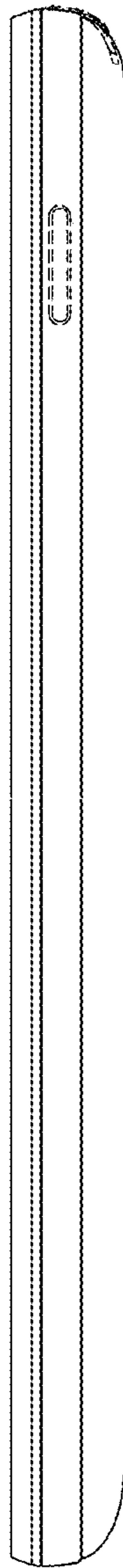

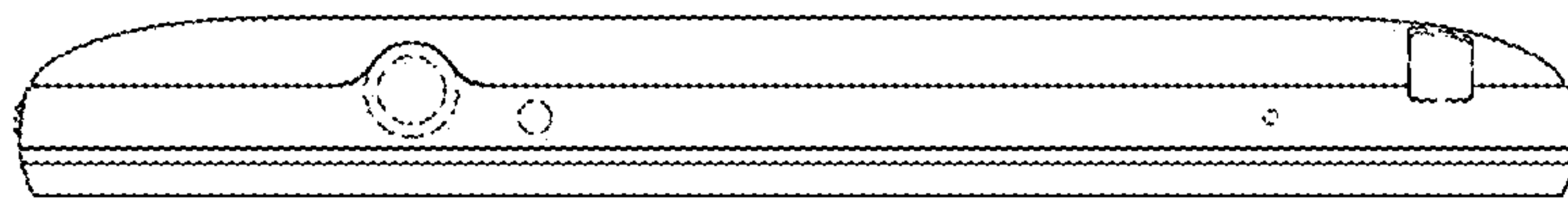

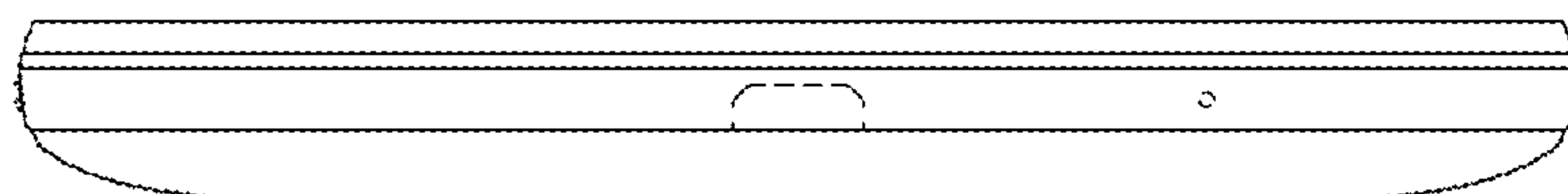
