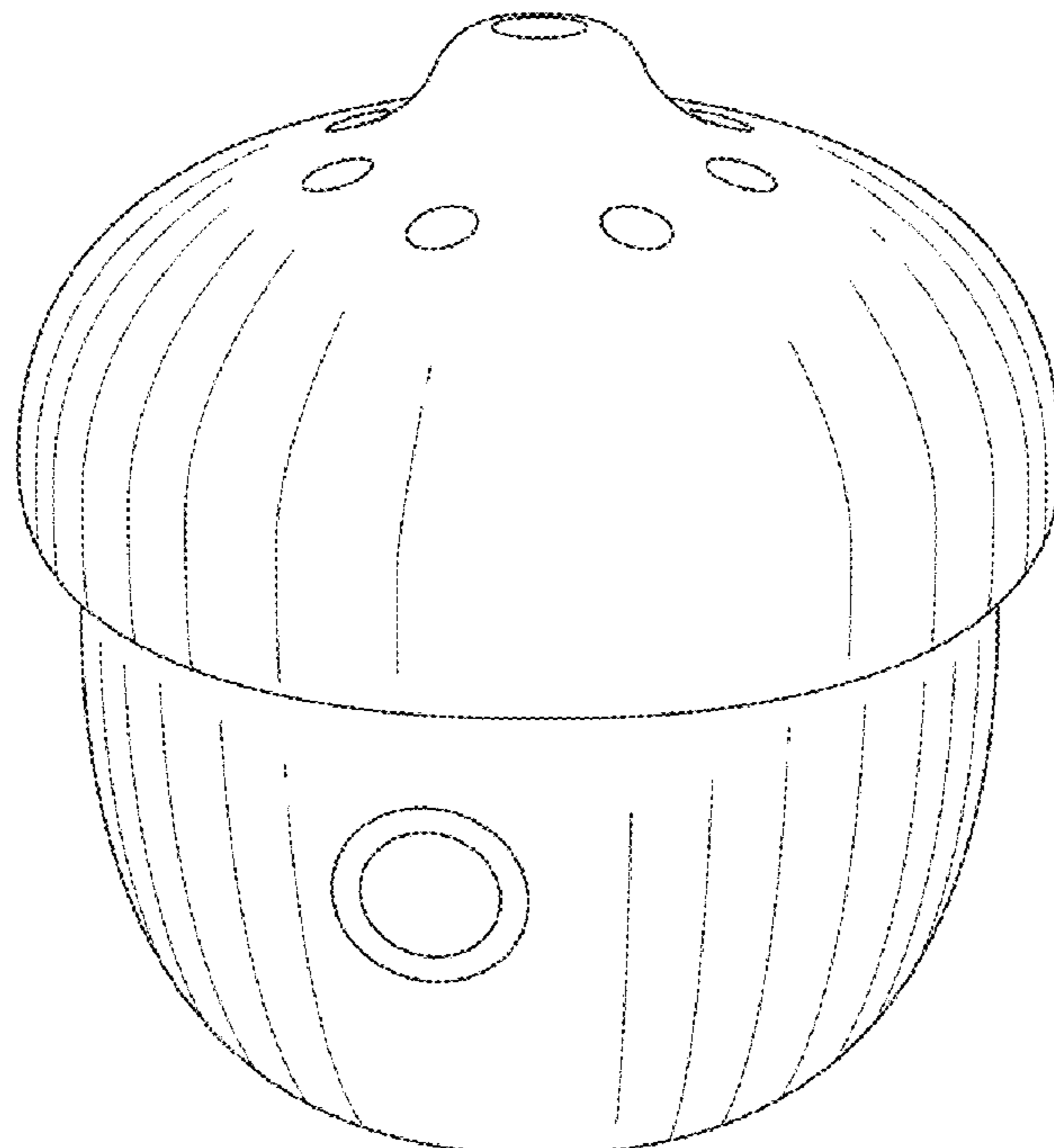
FIG. 1 is a front elevational view showing the acorn-shaped speaker and radio;

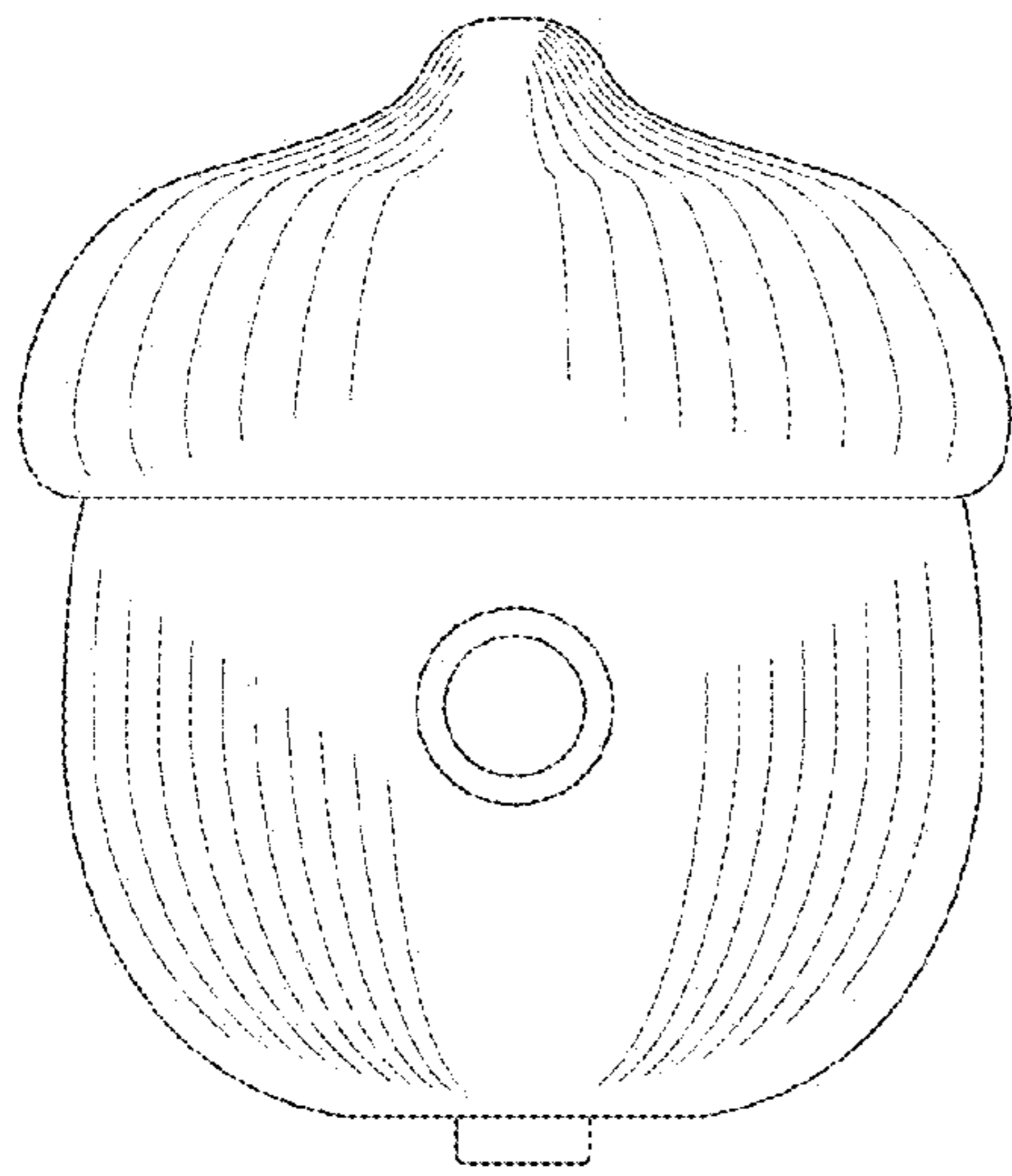

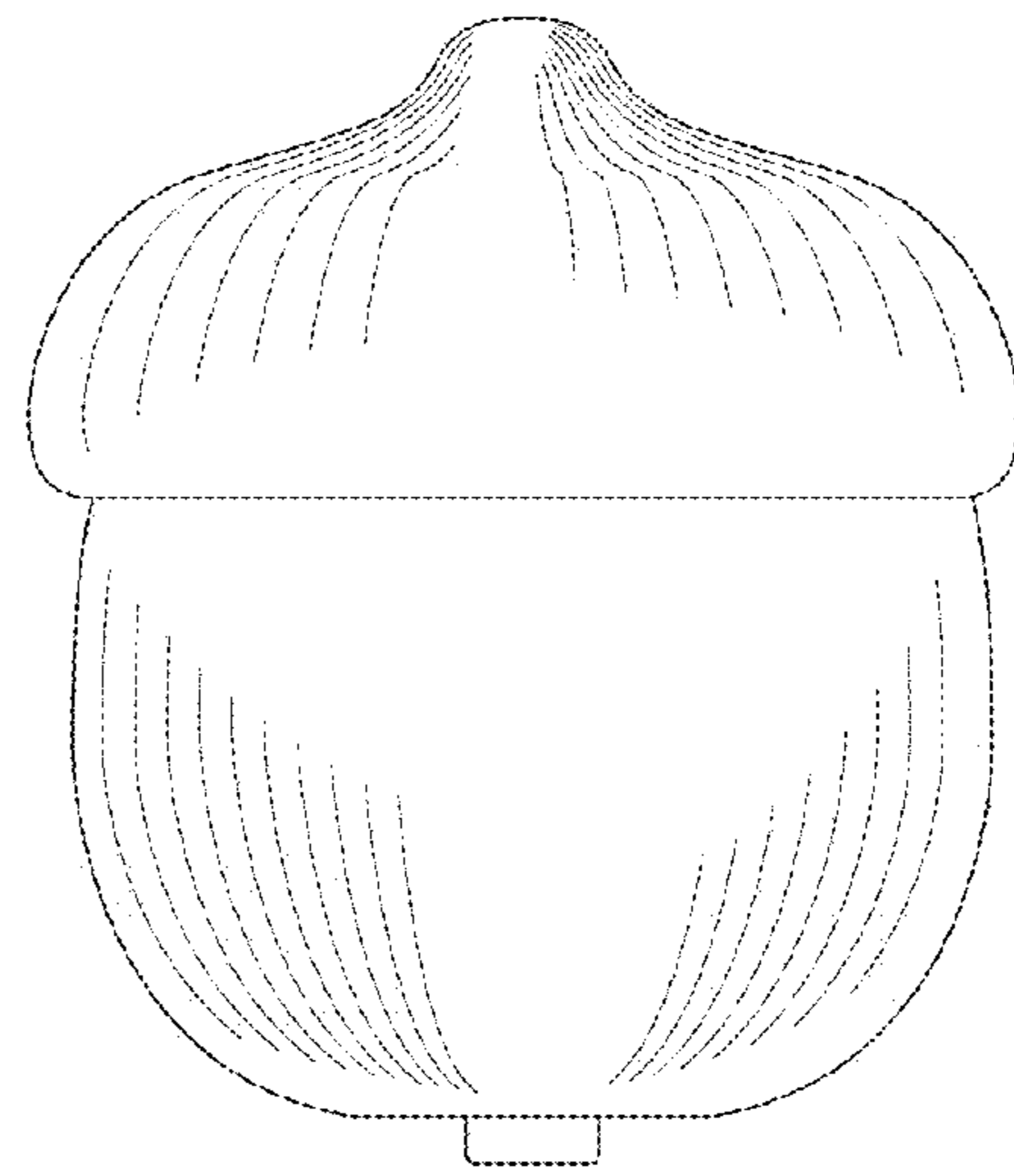

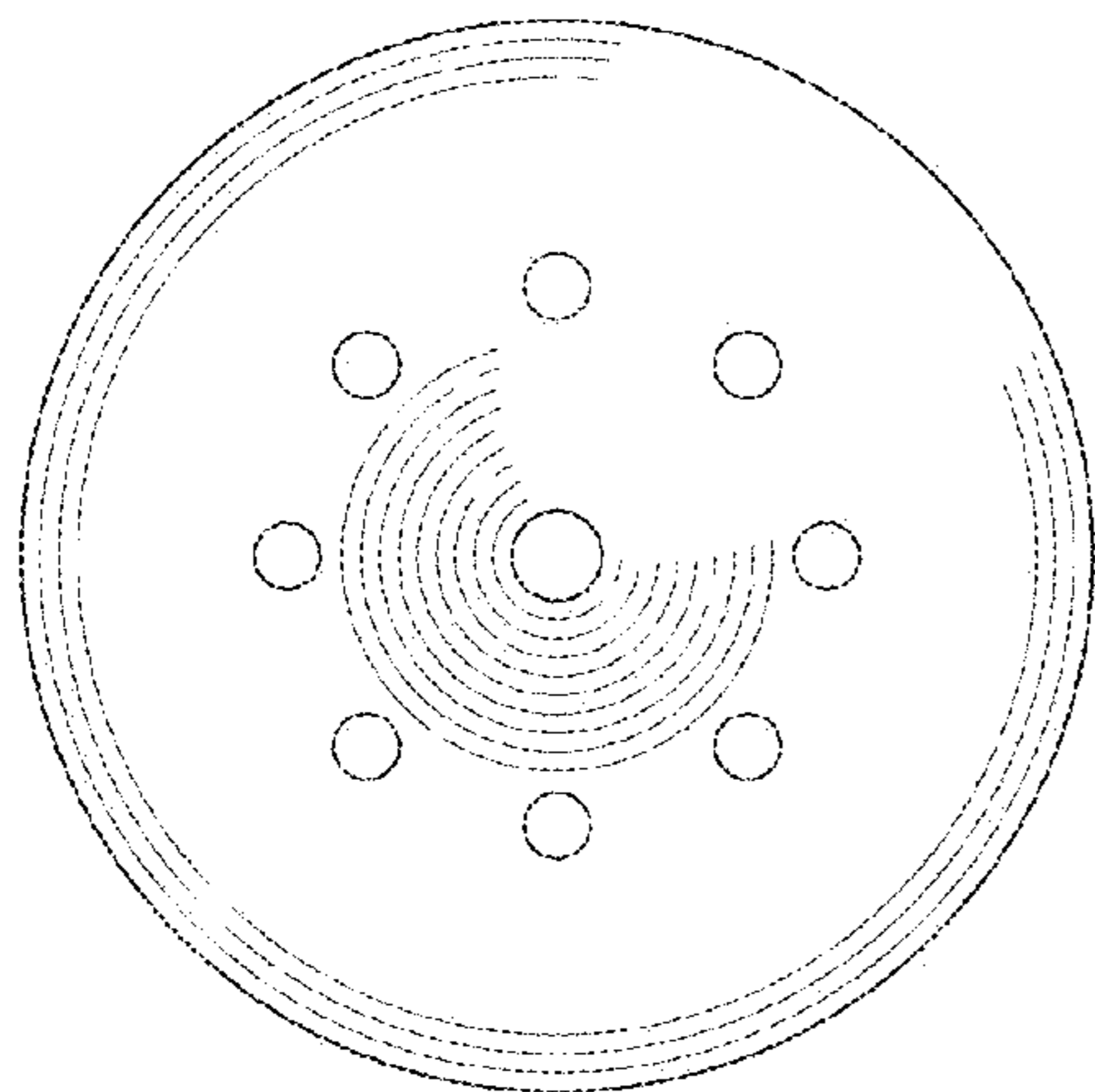

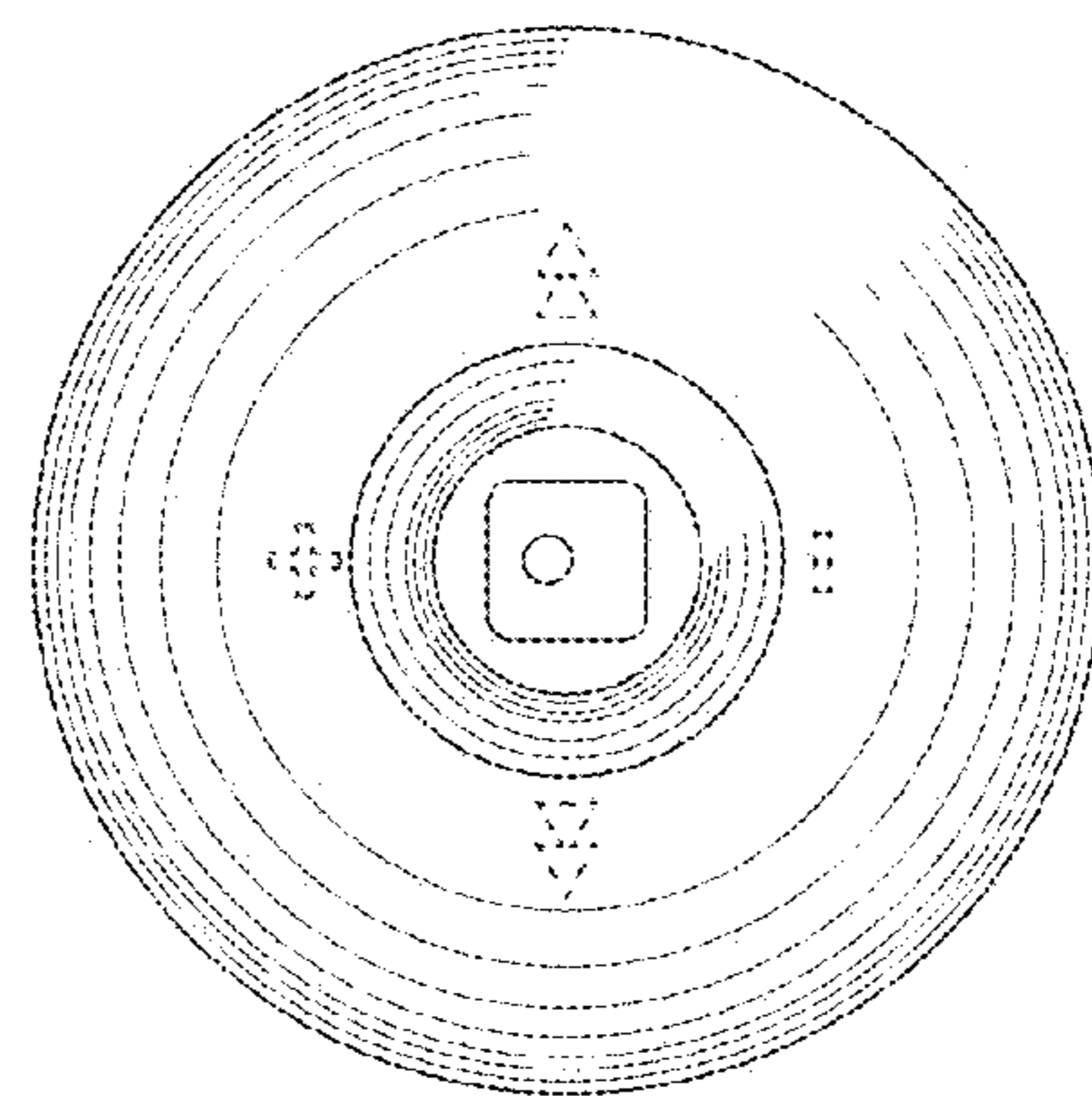

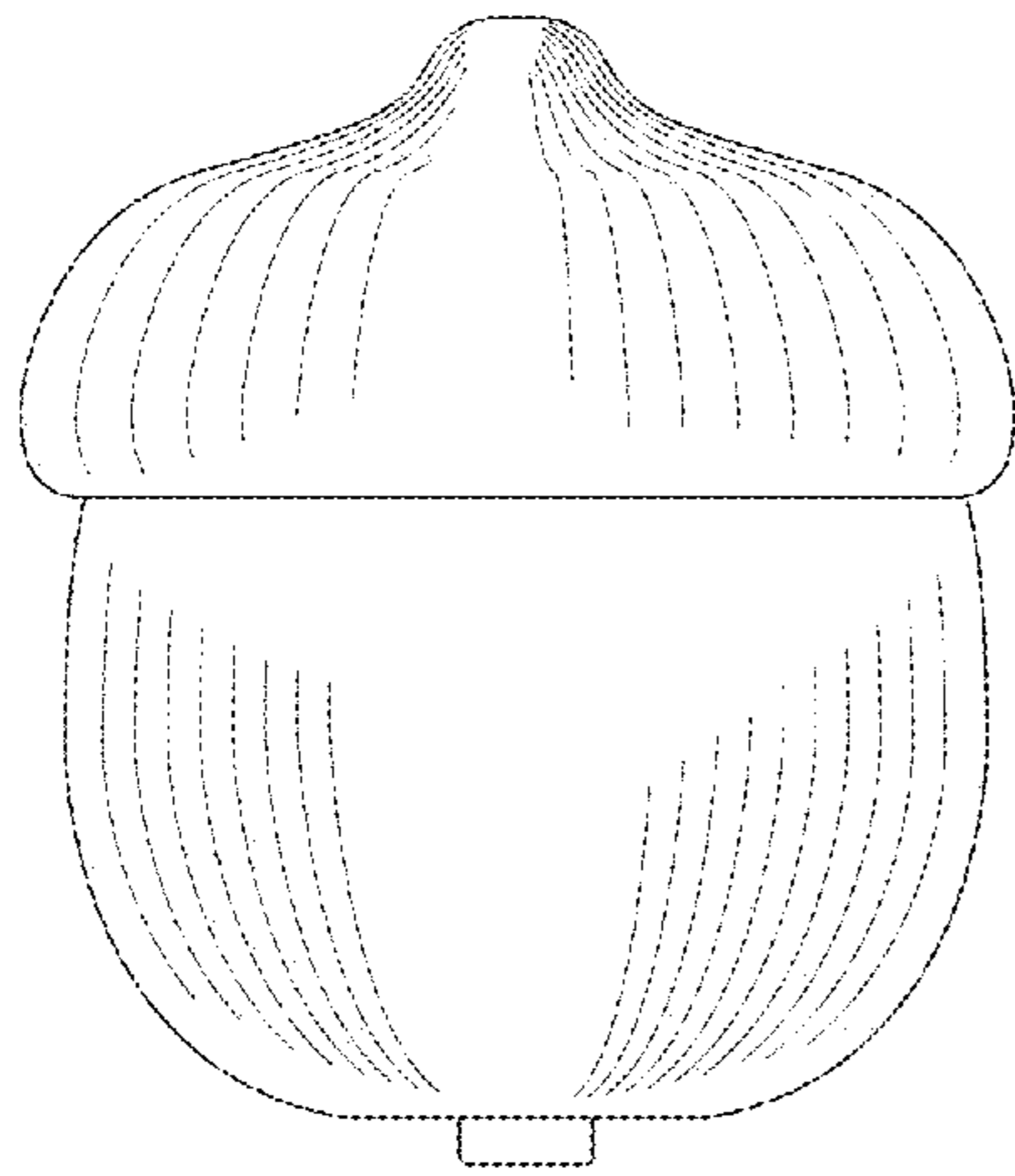

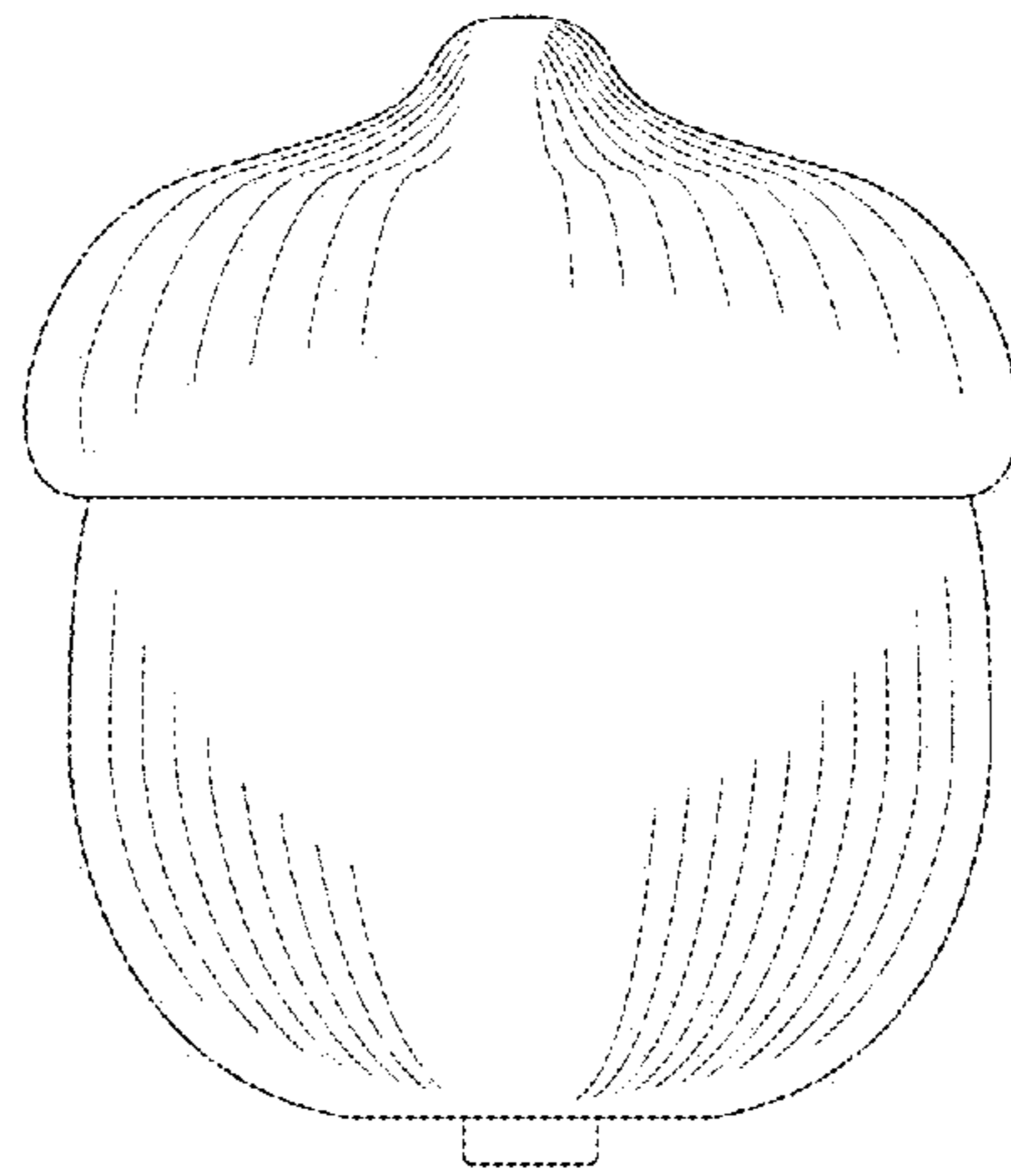

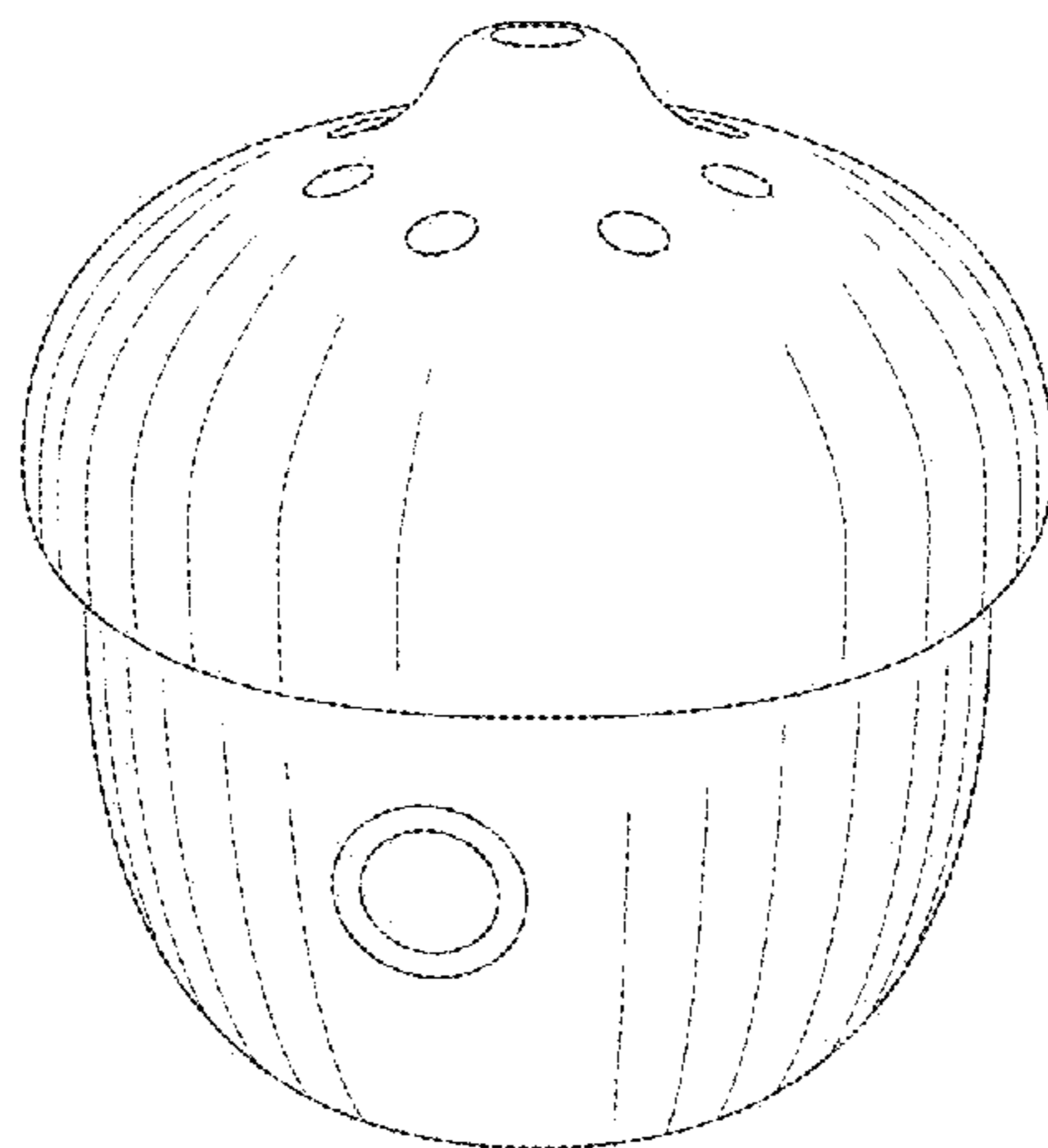
