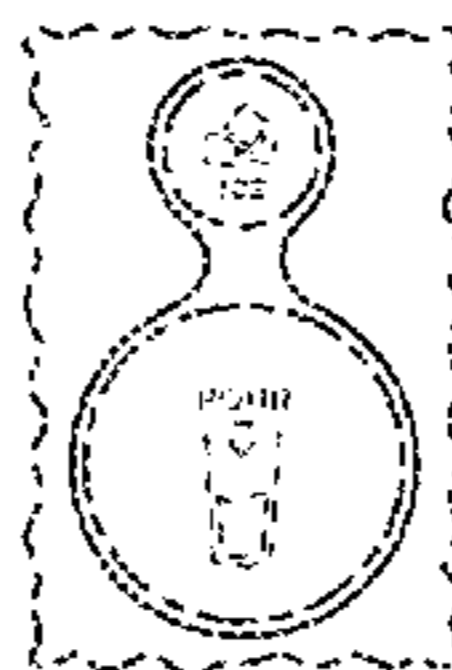
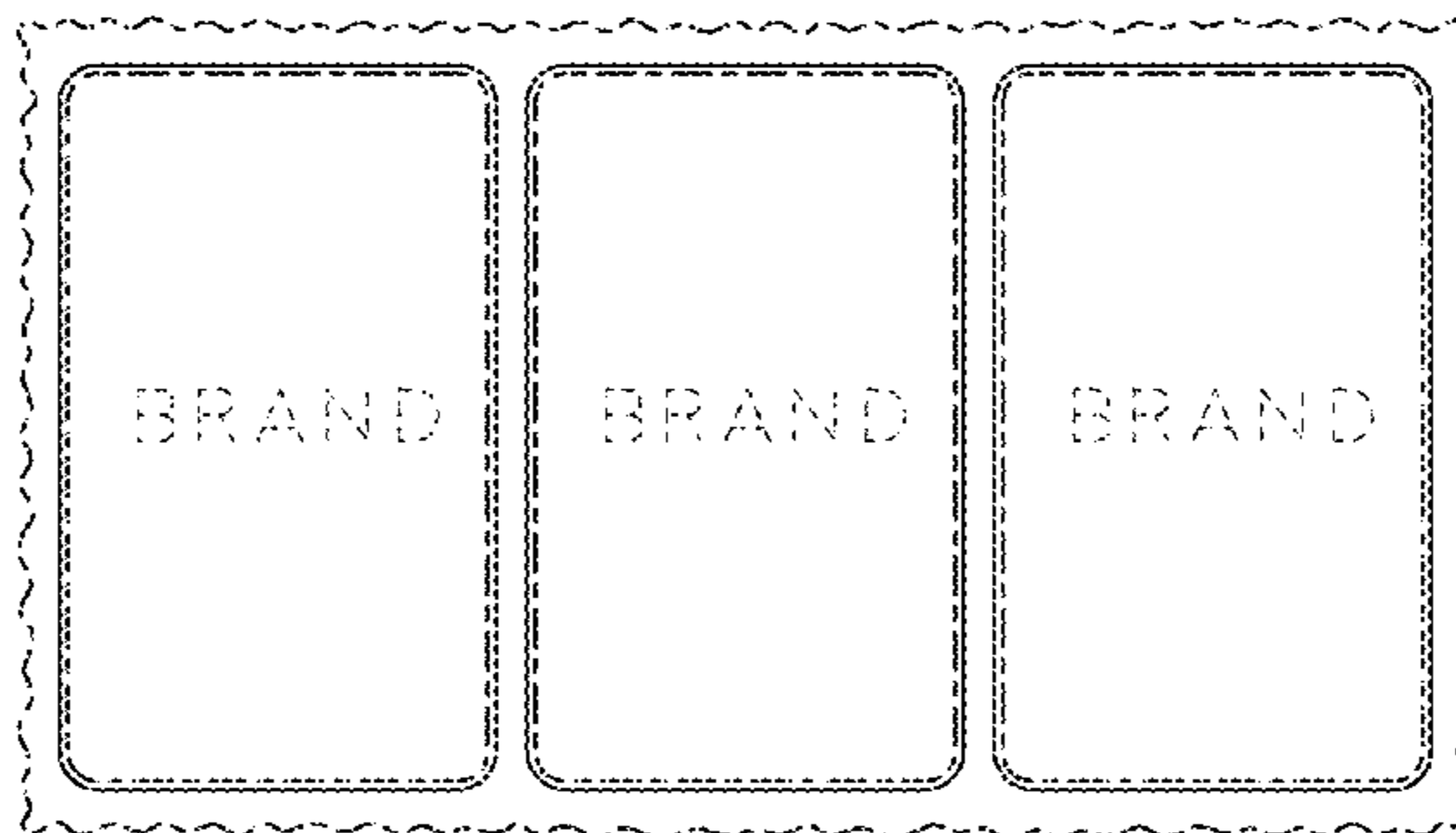
(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display screen with graphical user interface showing our new design. The uneven-length broken lines are imaginary lines not found on the display screen with graphical user interface that represent unclaimed boundaries of the claimed design.
