FIG. 7 is a bottom plan view of the mobile refrigeration cabinet shown in FIG. 1.

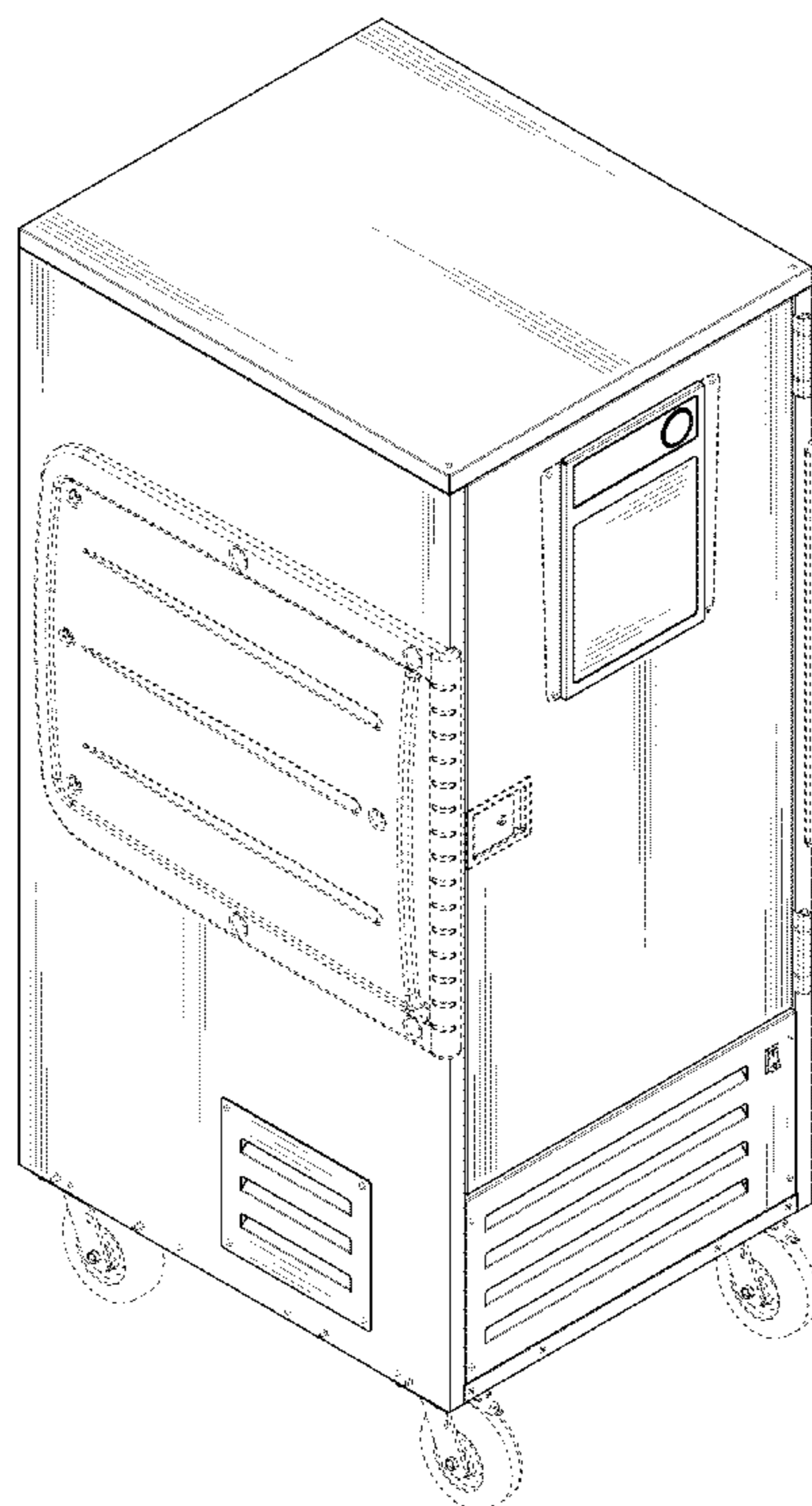

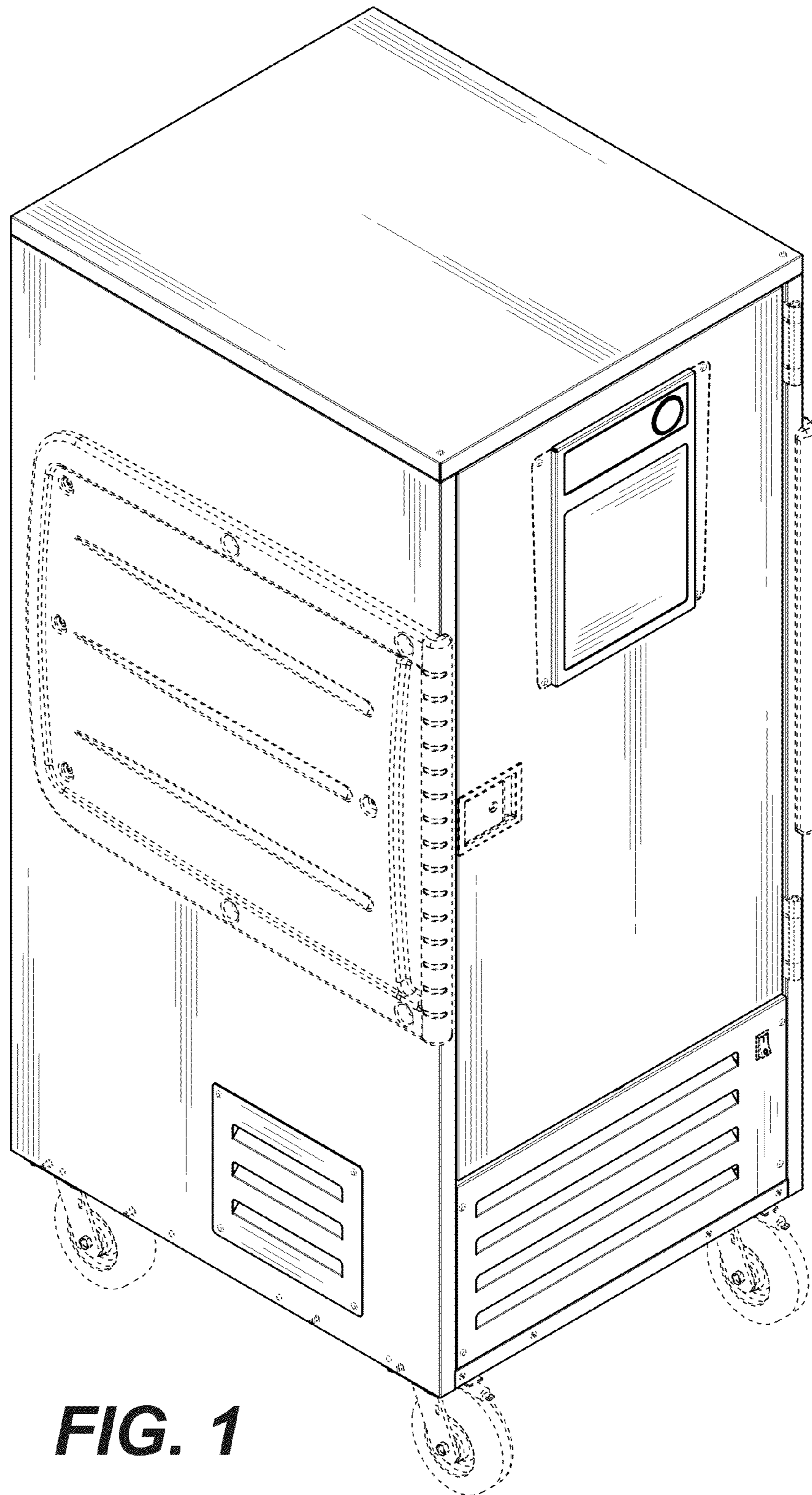

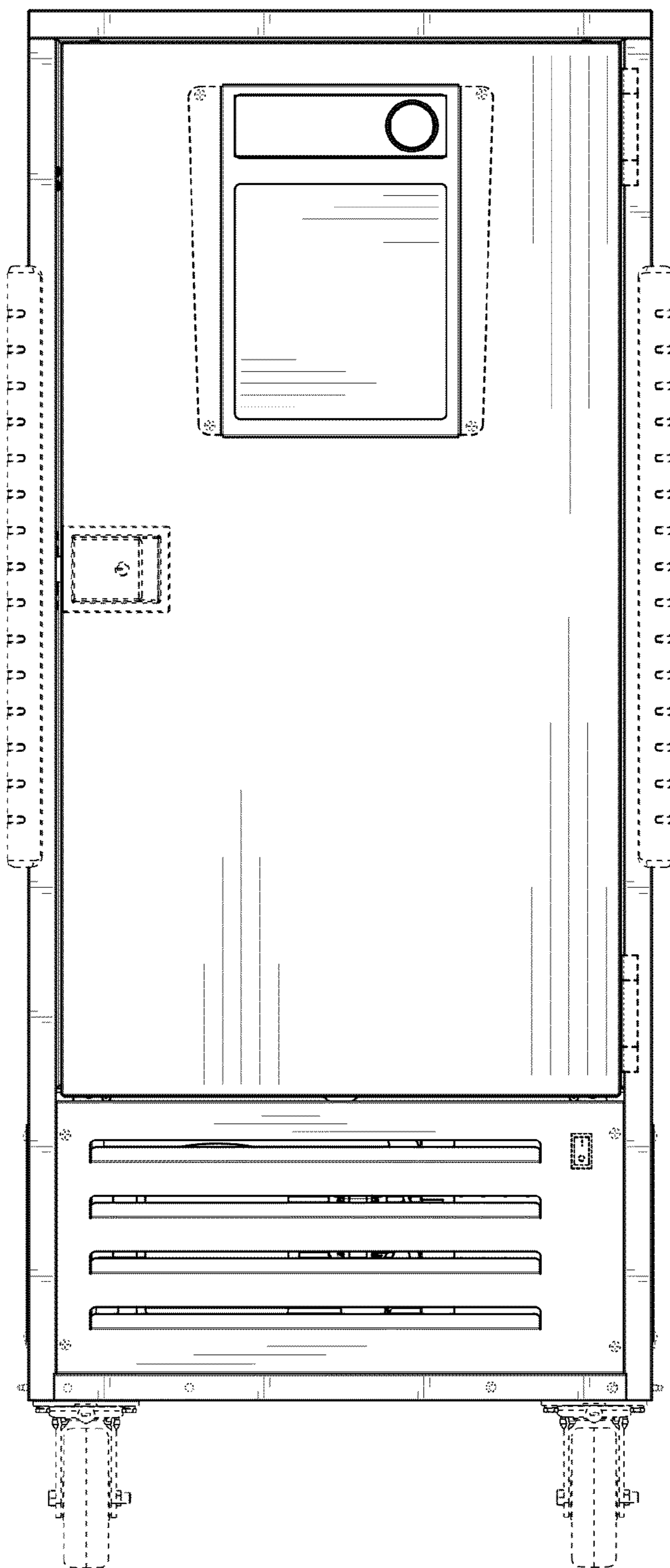

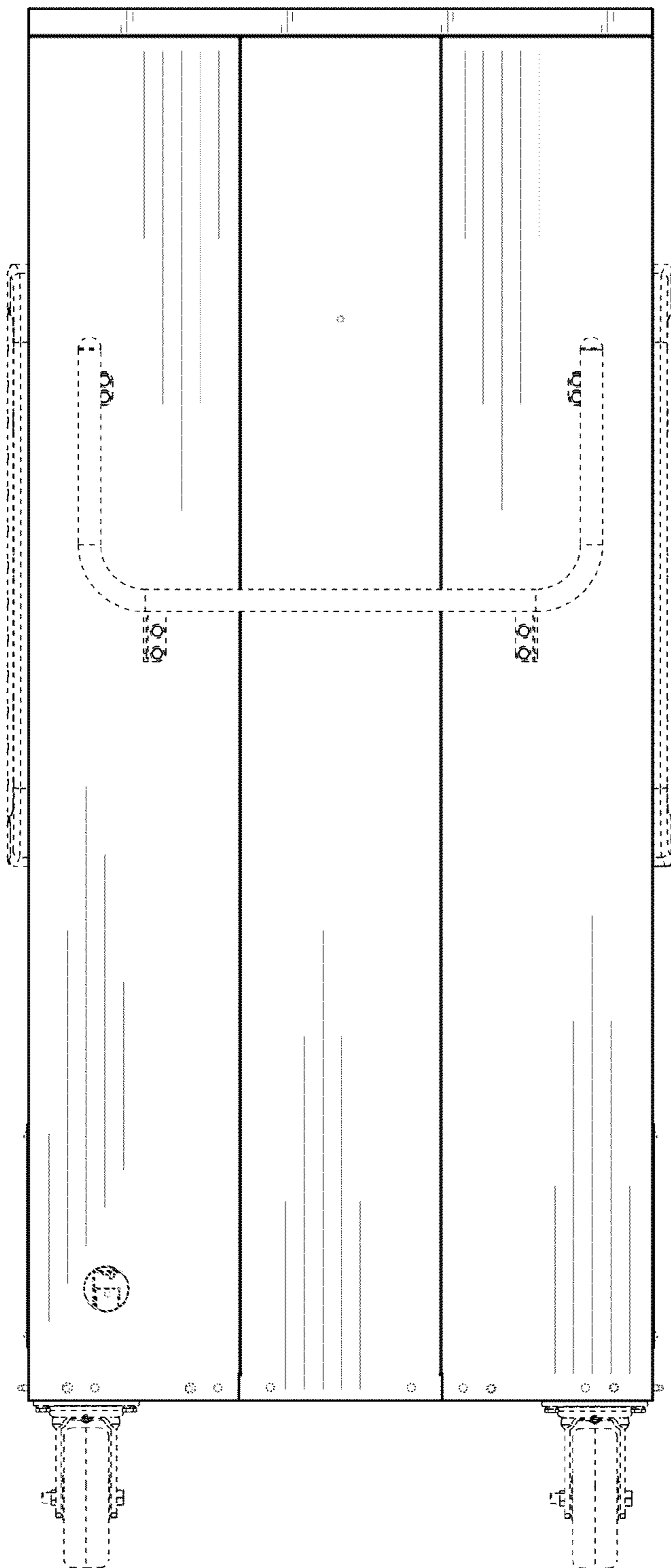

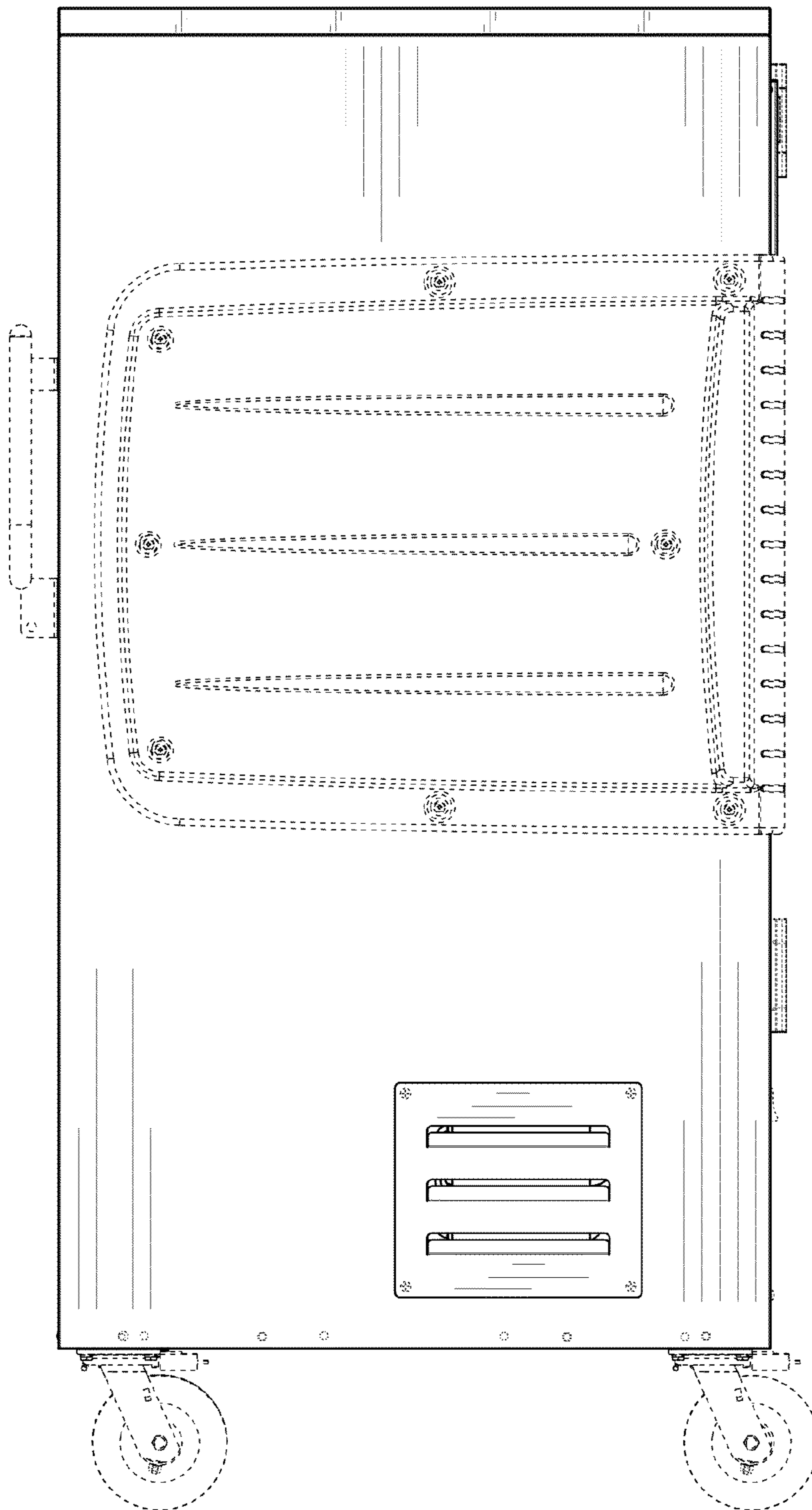

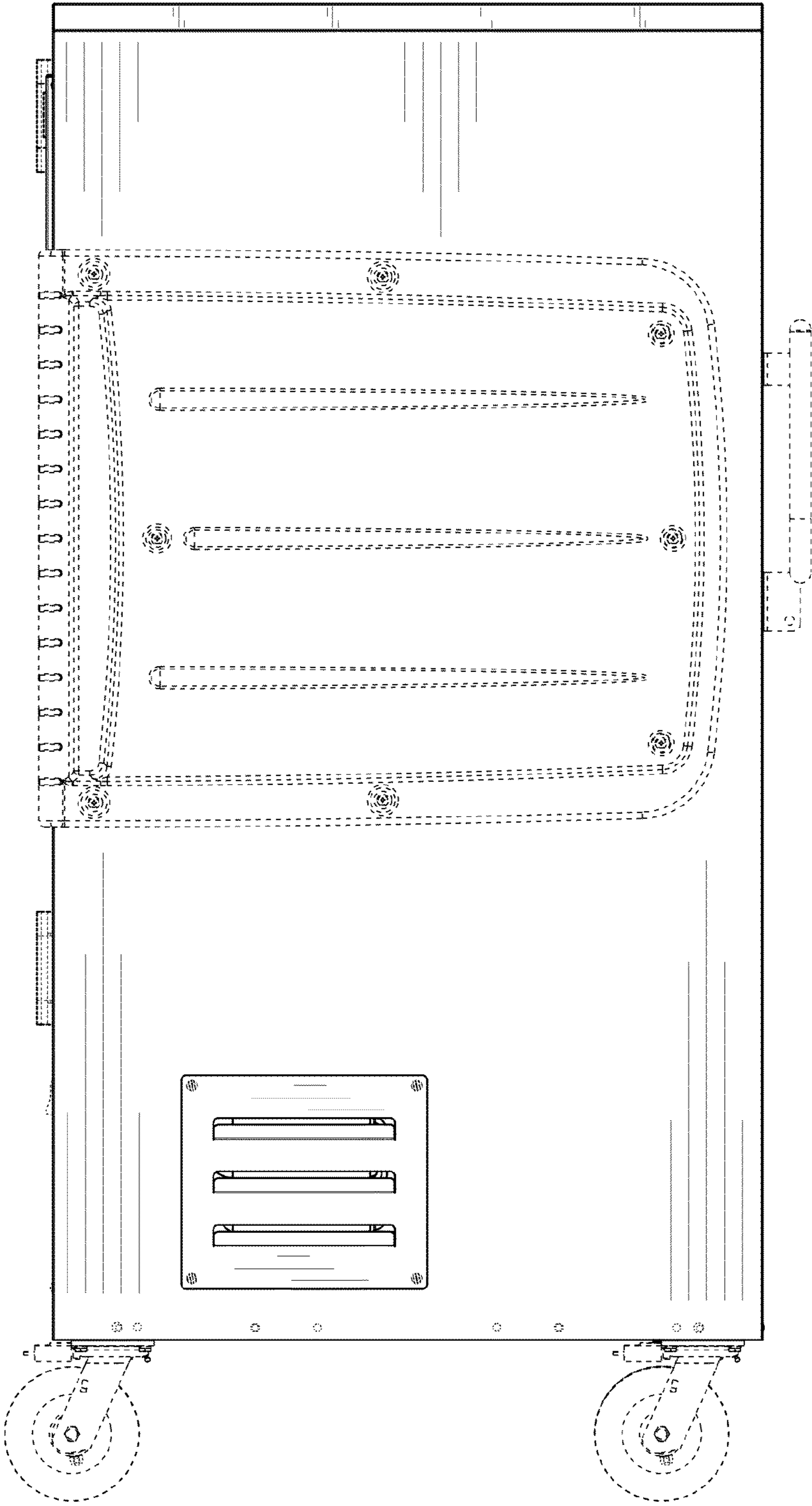

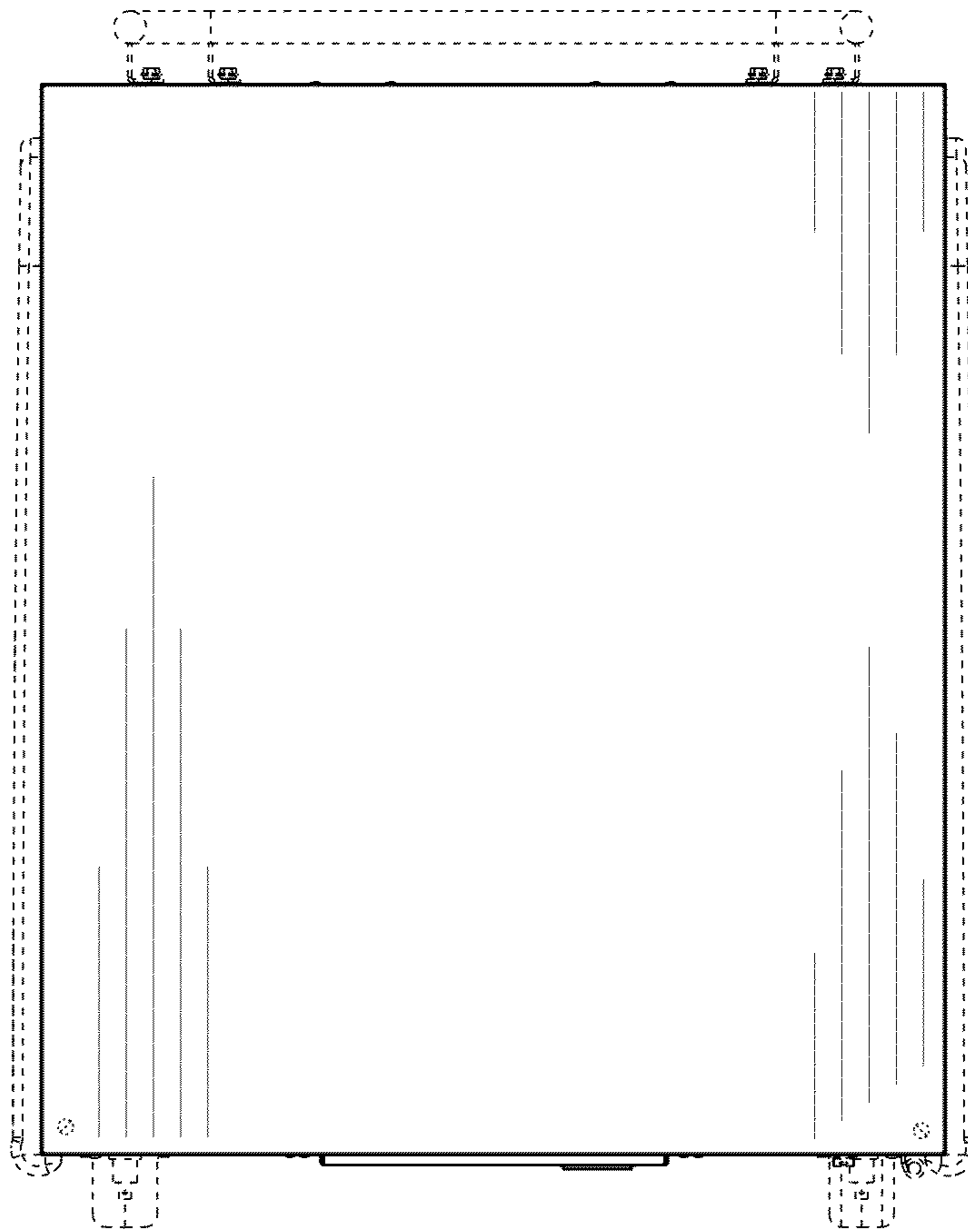

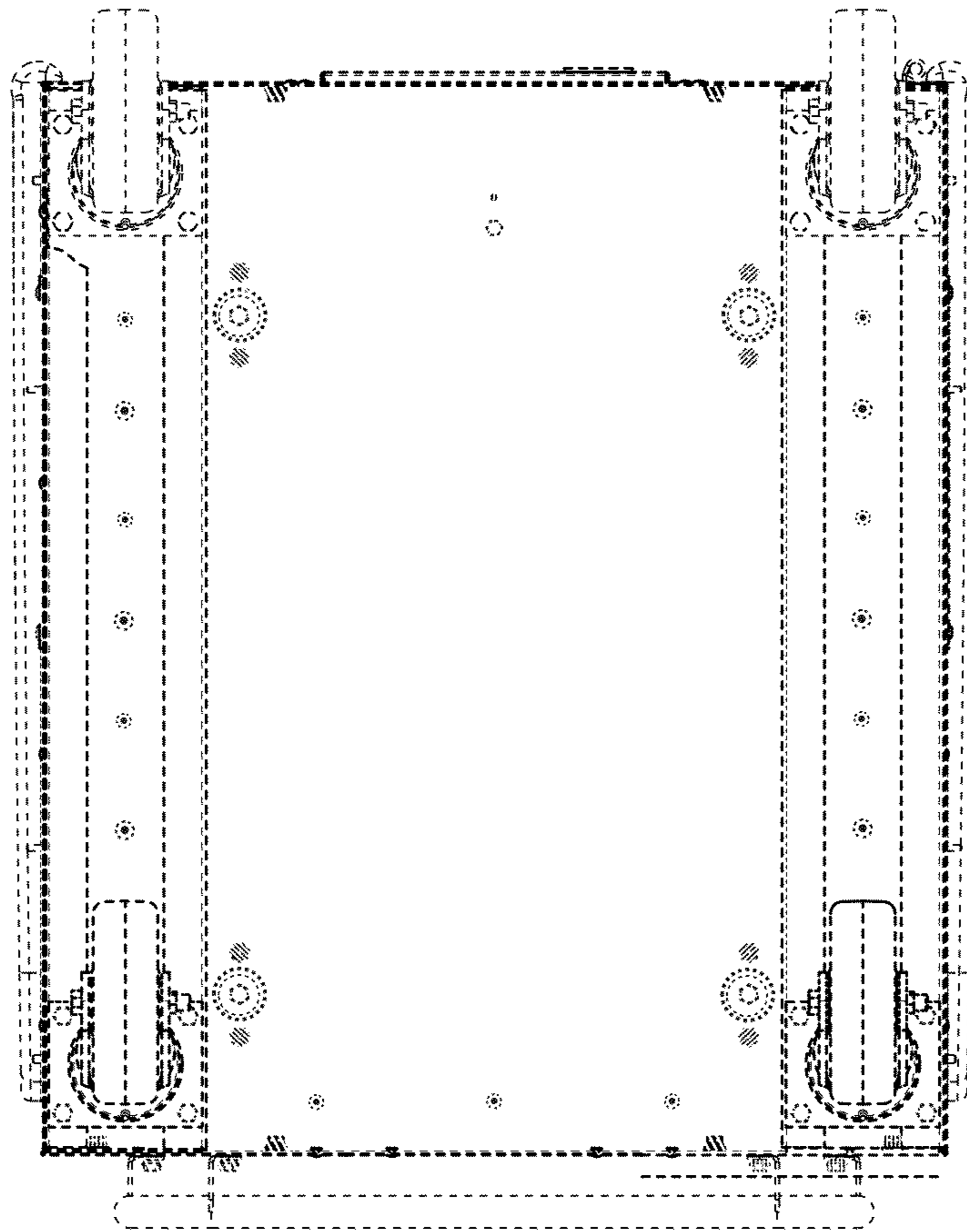
