The ornamental design for an eyeglass, as shown and described.

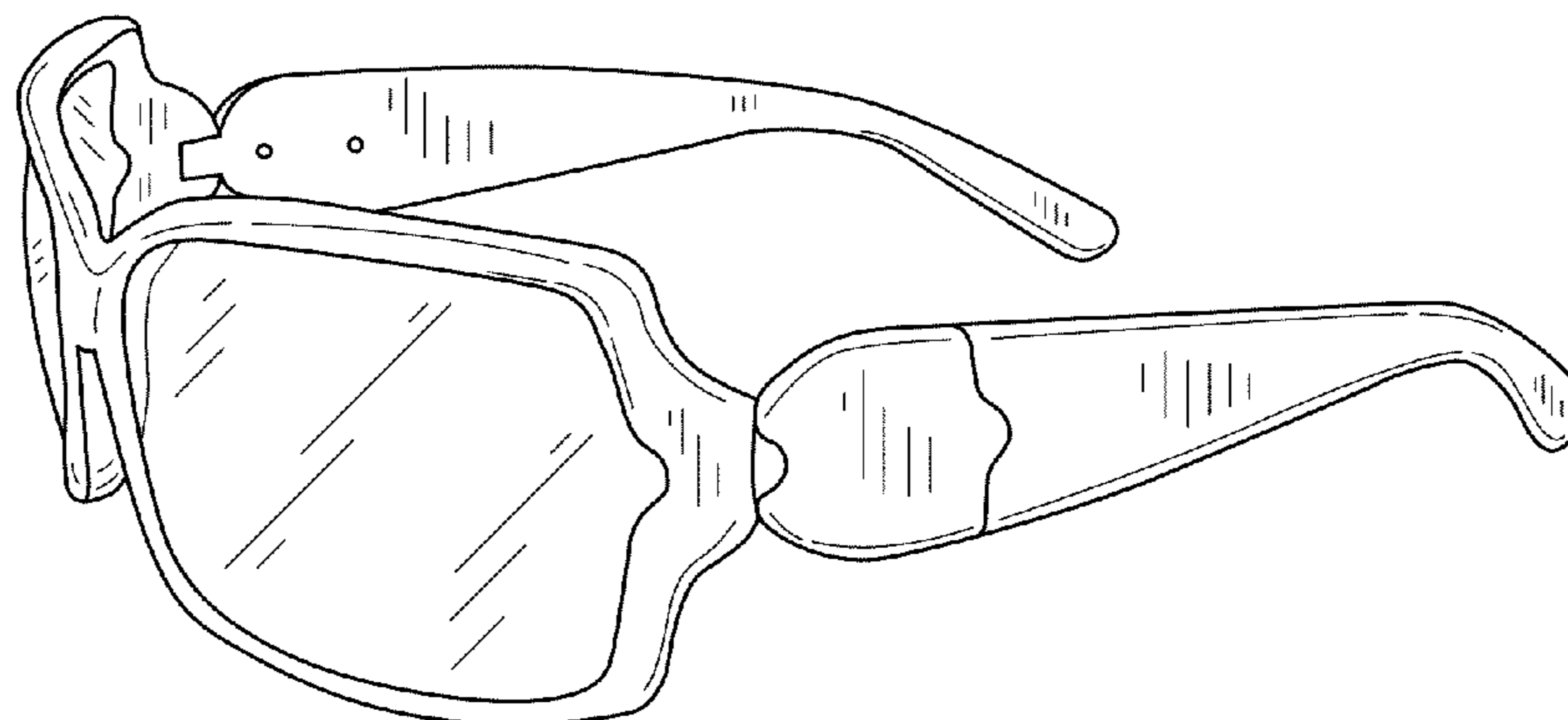
DESCRIPTION

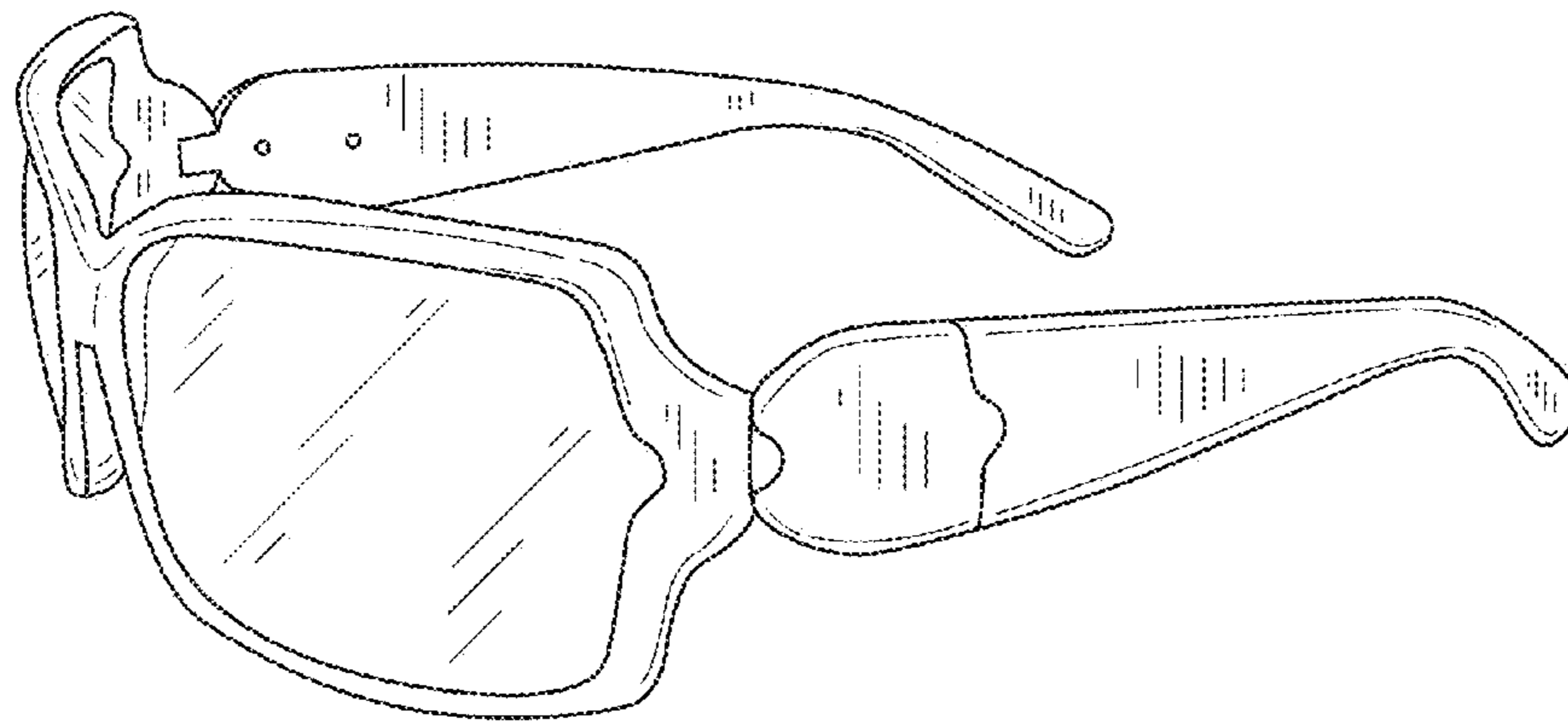

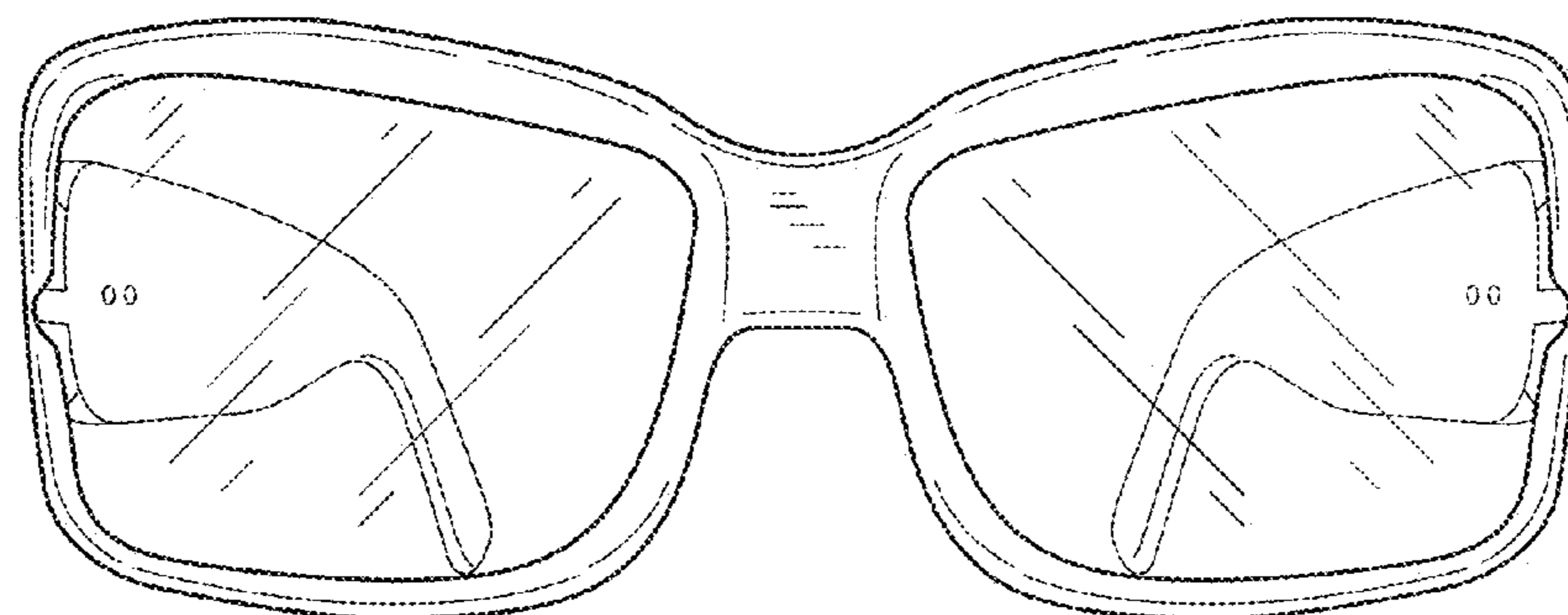

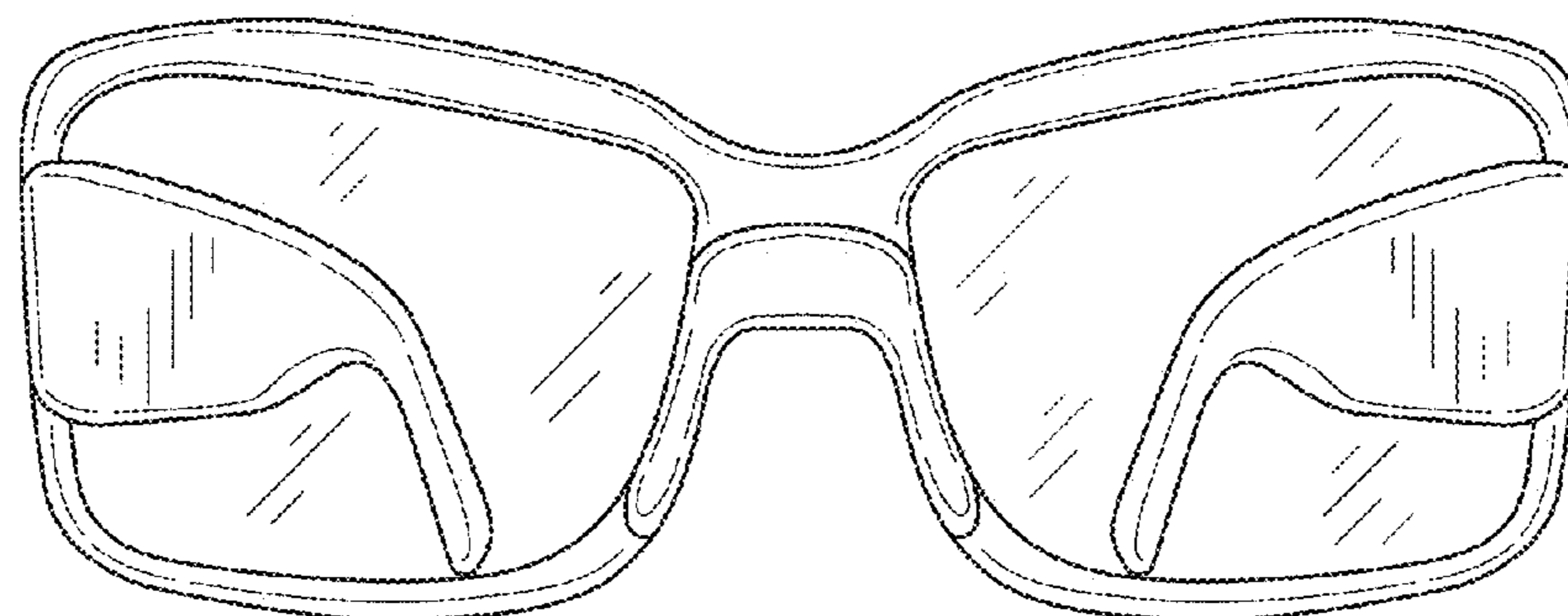

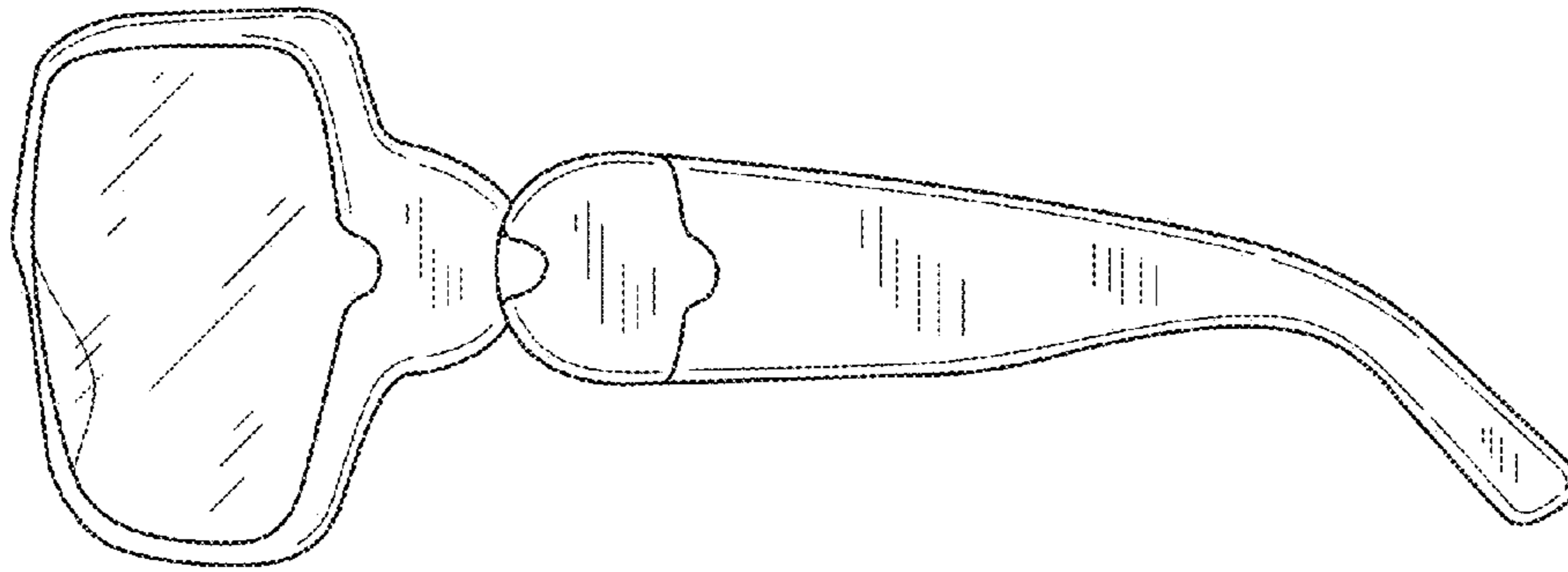

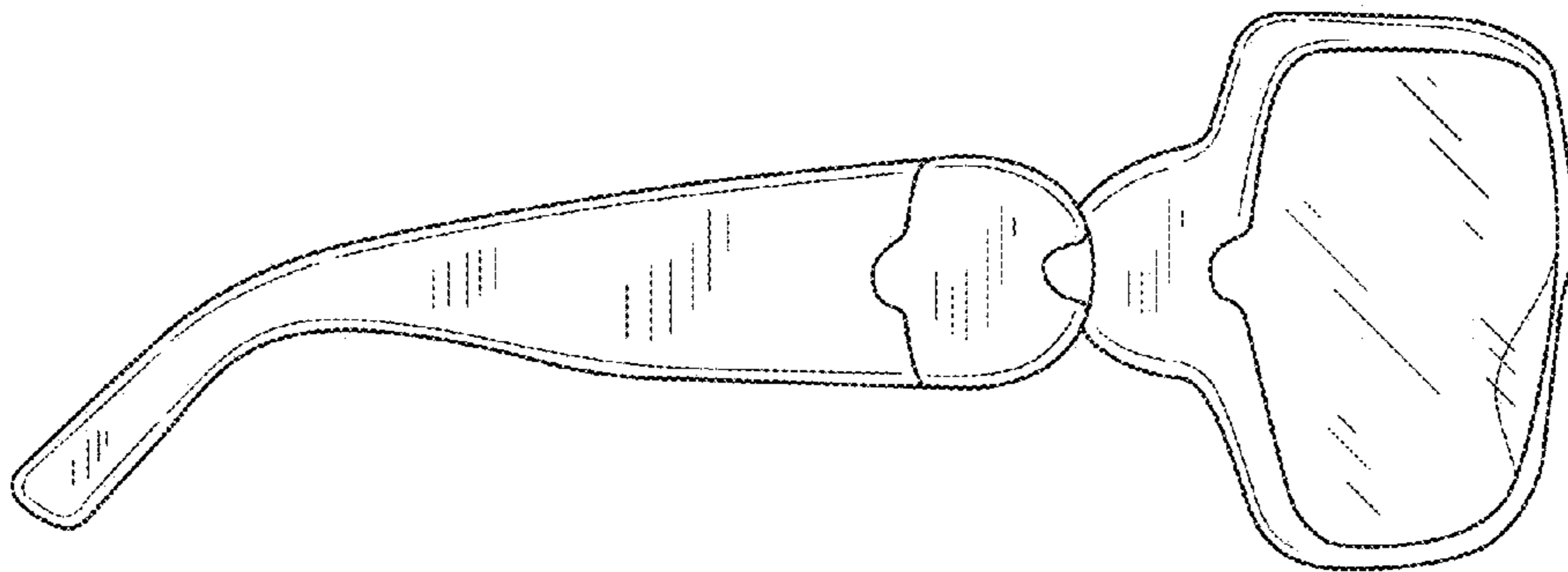

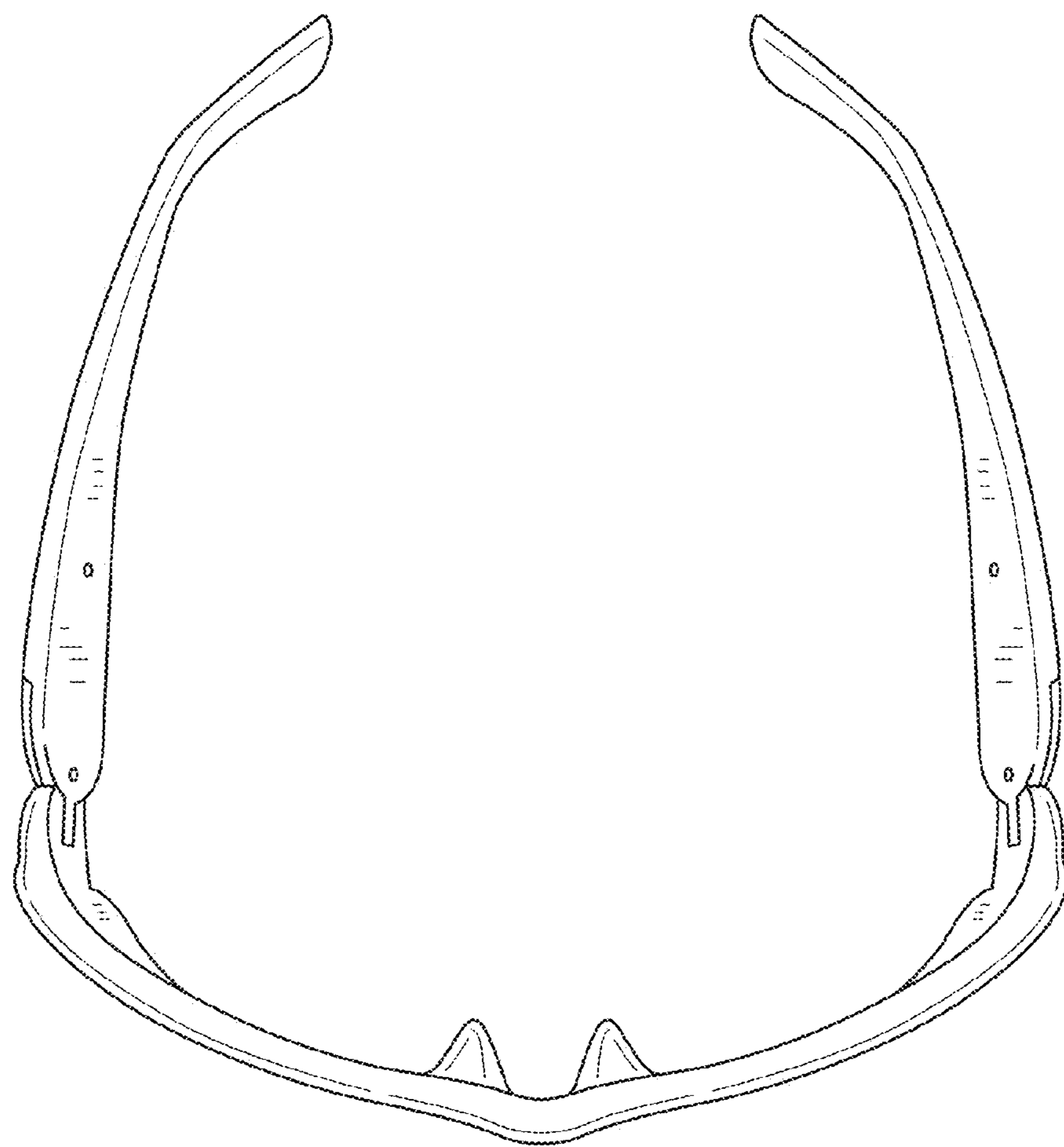

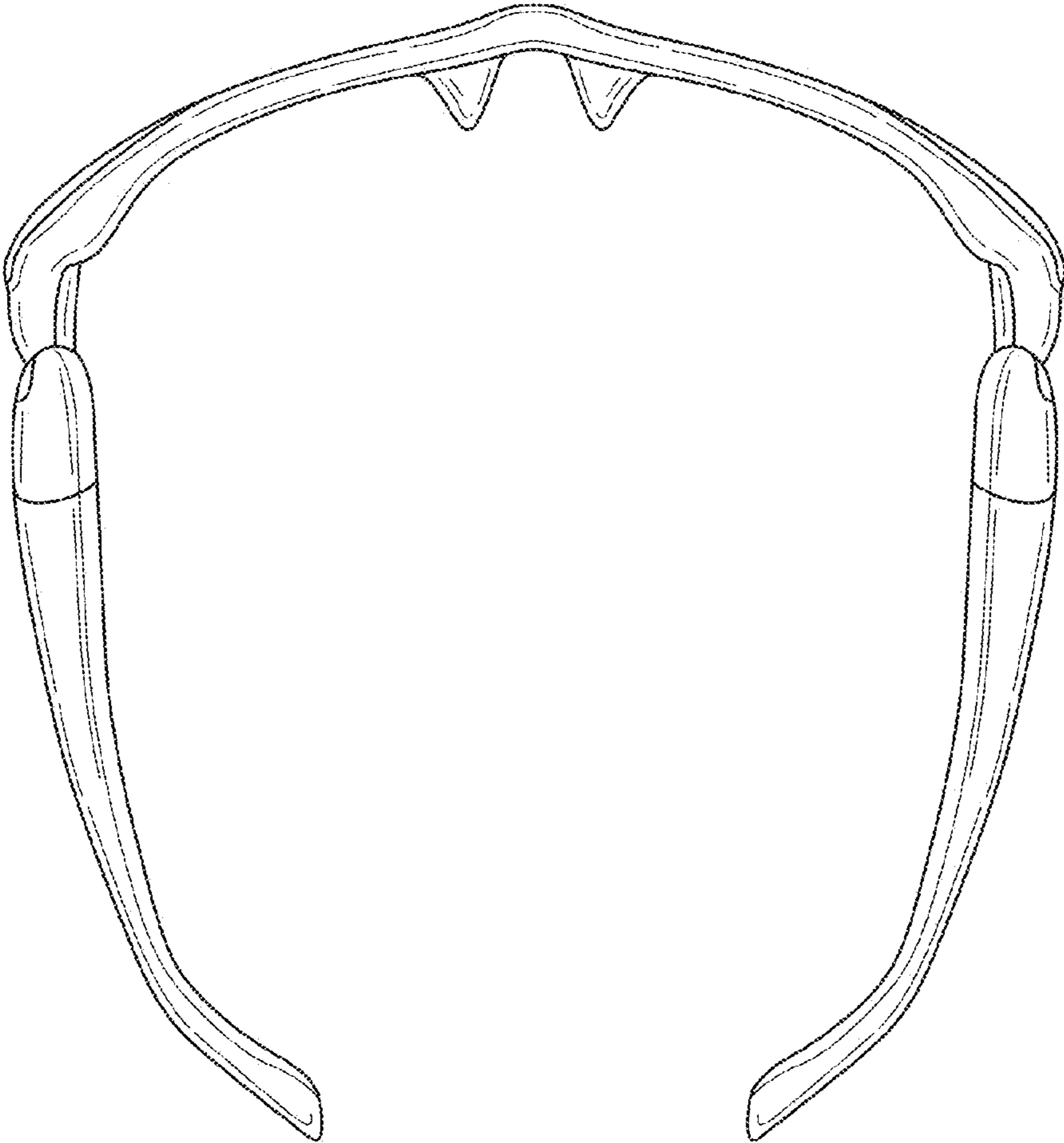
