(57) **CLAIM**

The ornamental design for an air collecting and expelling amusement device, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of an air collecting and expelling amusement device showing my new design; FIG. 2 is a left side elevation view of FIG. 1; FIG. 3 is rear elevation view of FIG. 1; FIG. 4 is a front elevation view of FIG. 1; FIG. 5 is a top plan view of FIG. 1; and, FIG. 6 is a bottom plan view of FIG. 1. The broken lines are included for the purpose of illustrating the portions of the air collecting and expelling amusement device that form no part of the claimed design.

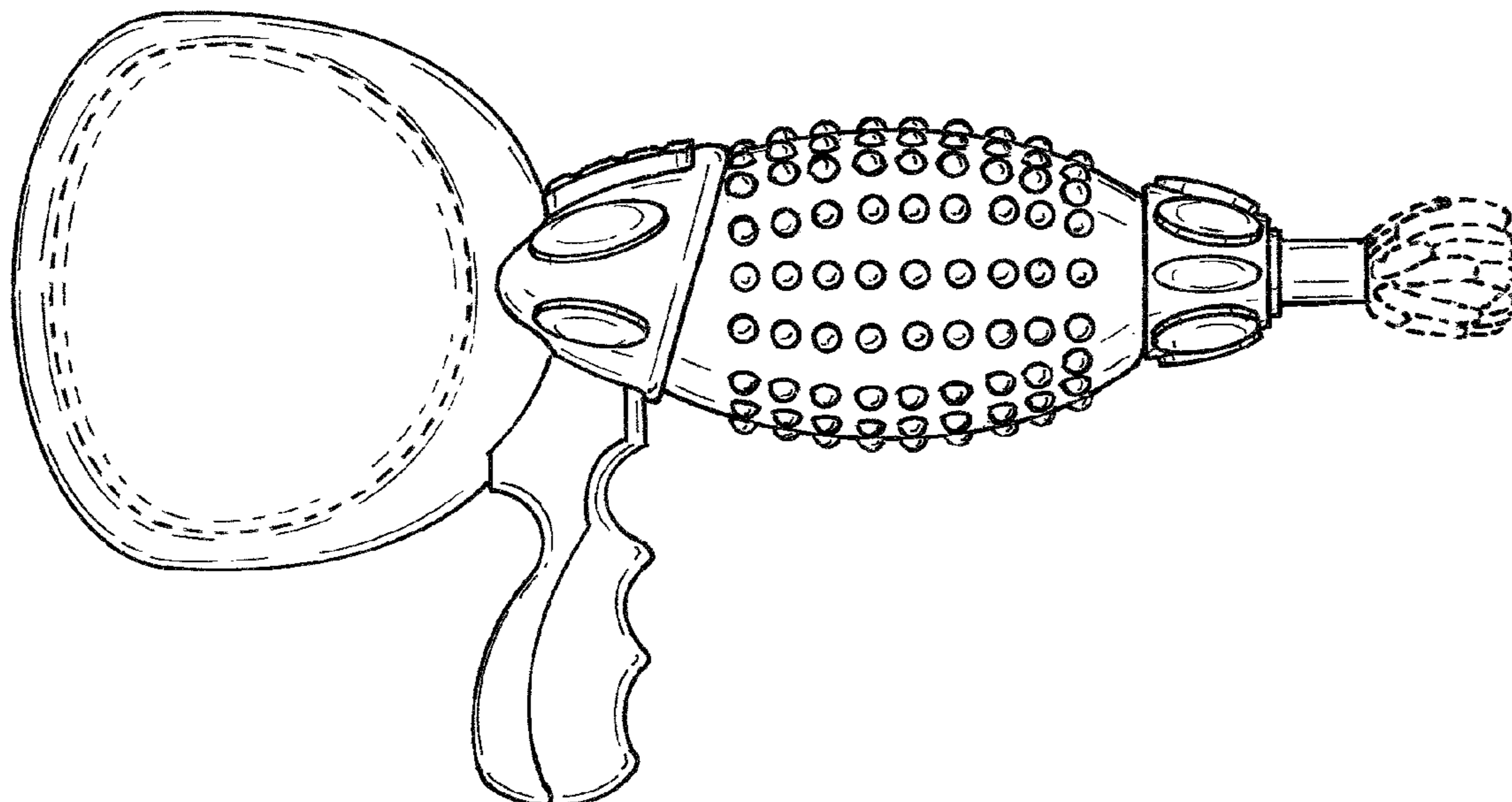

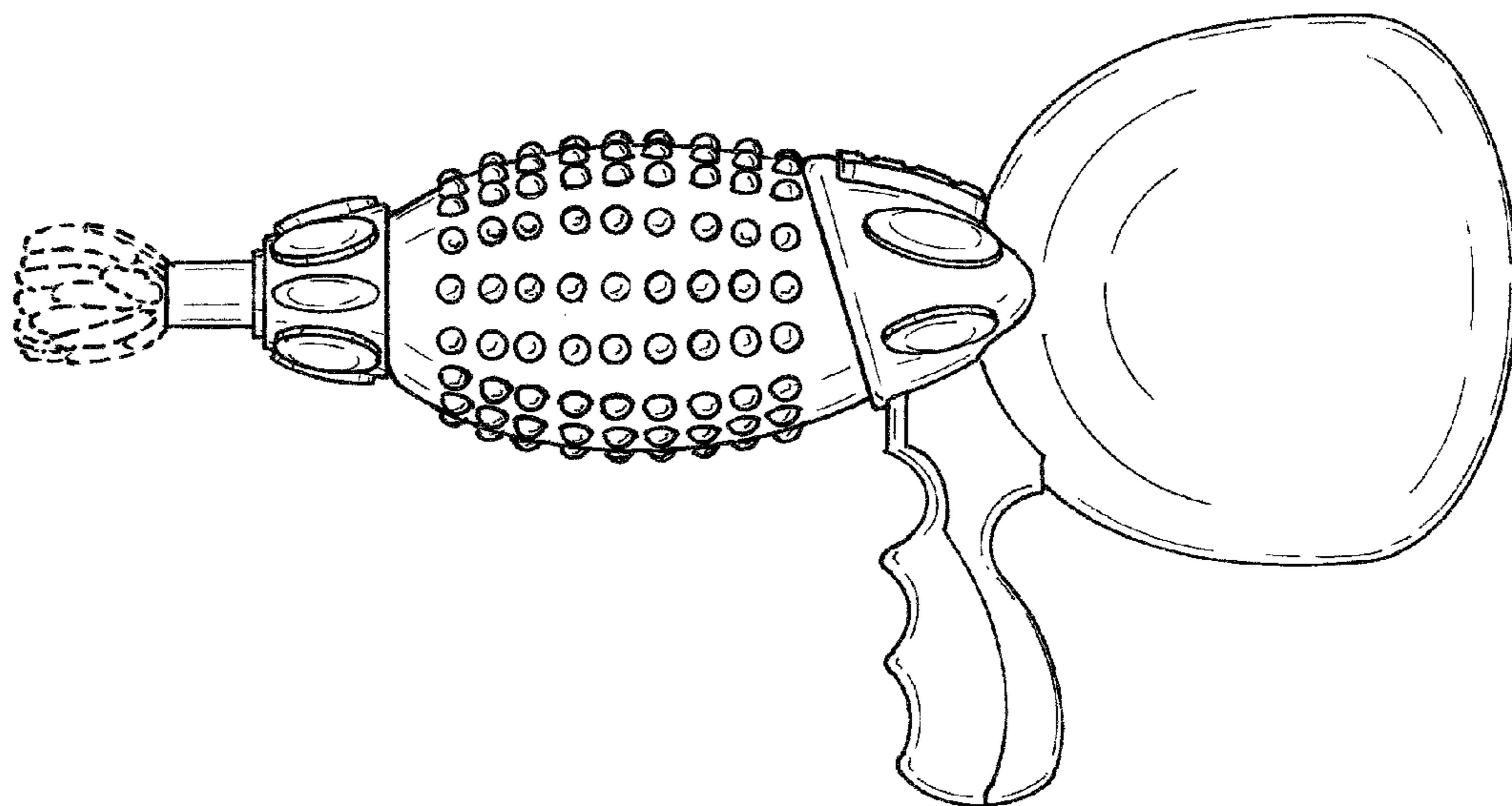
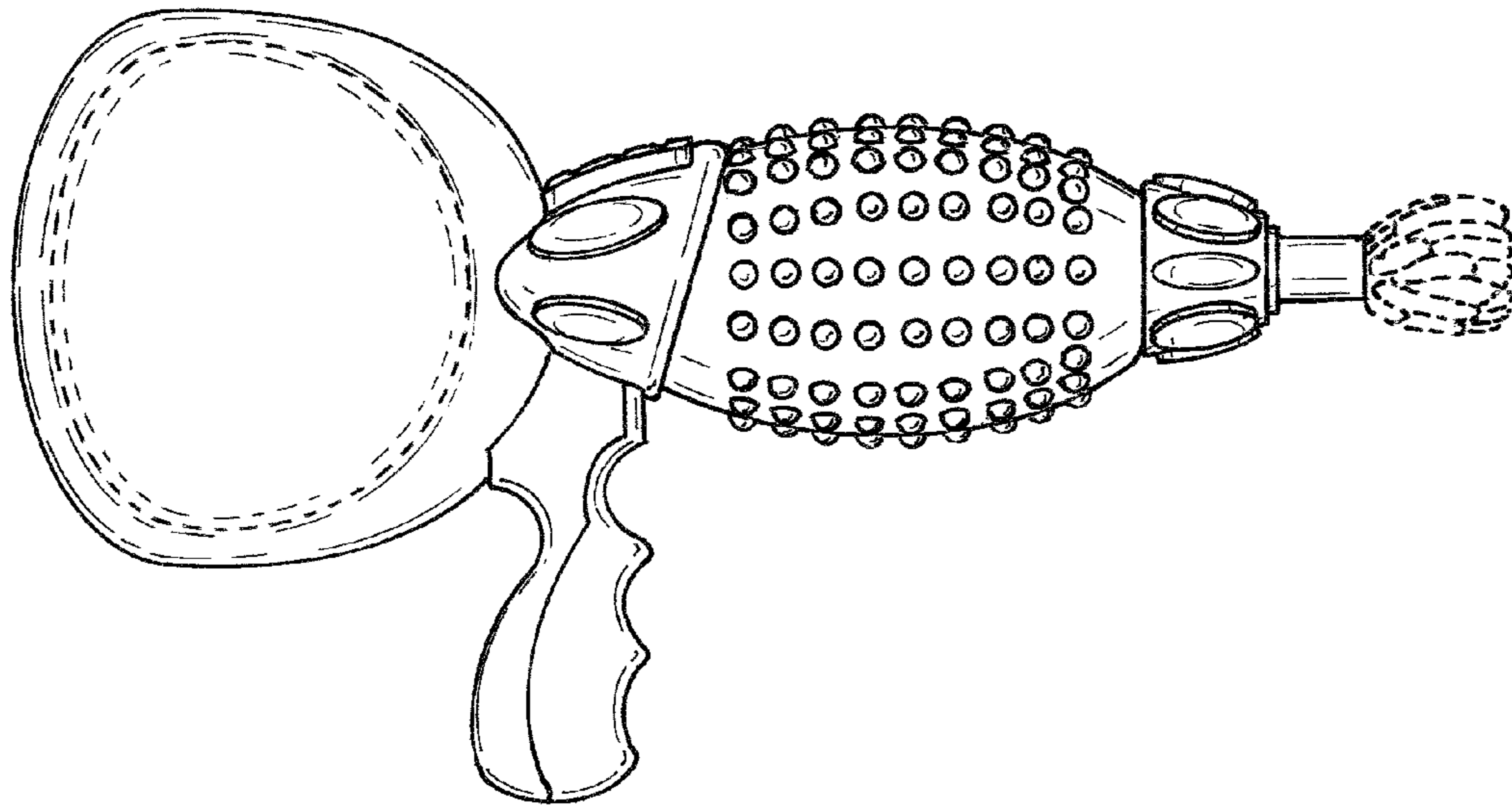

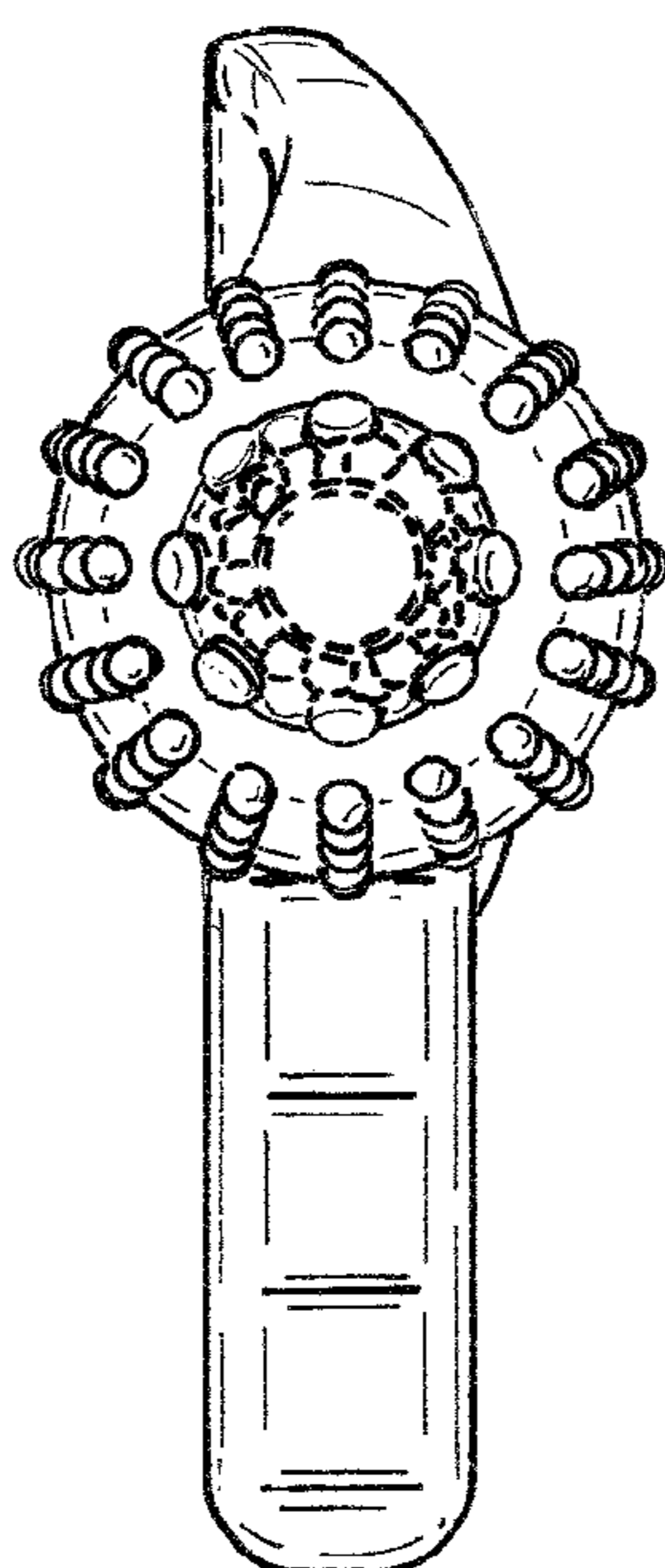
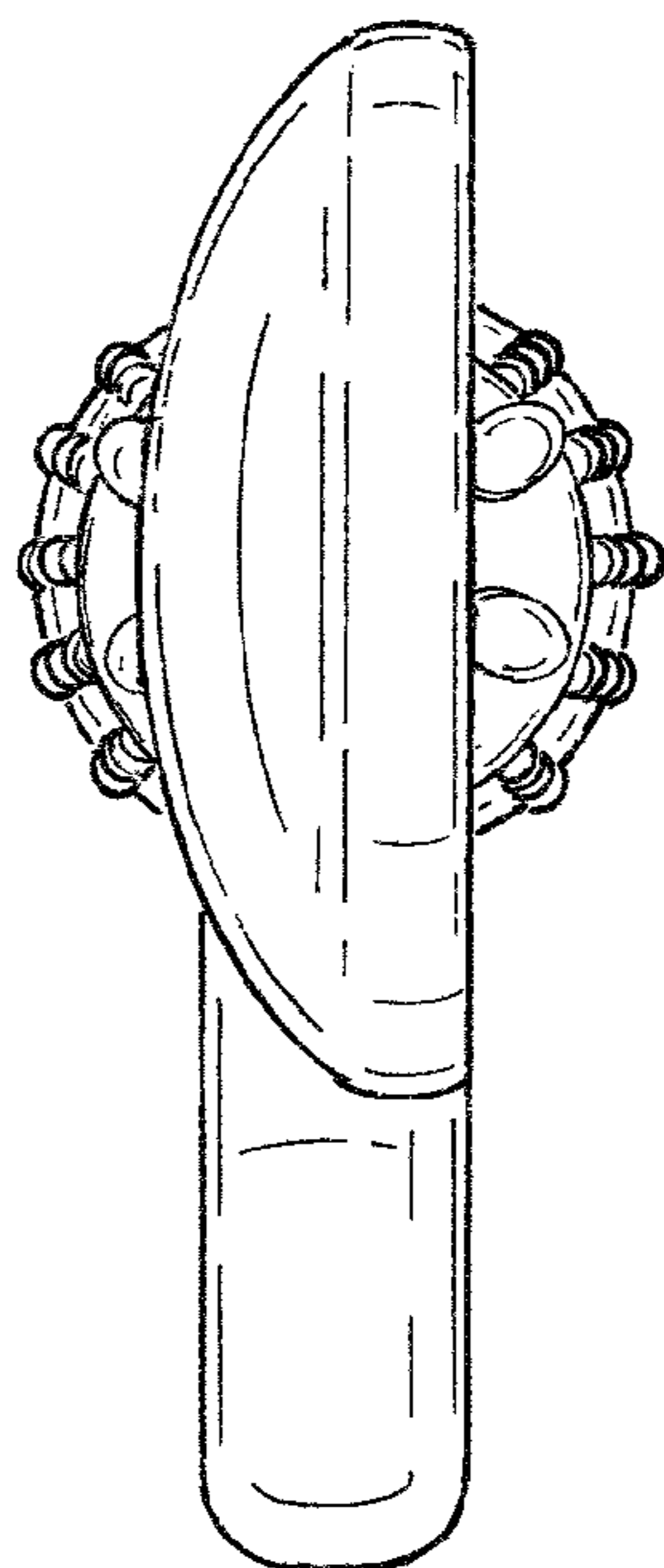

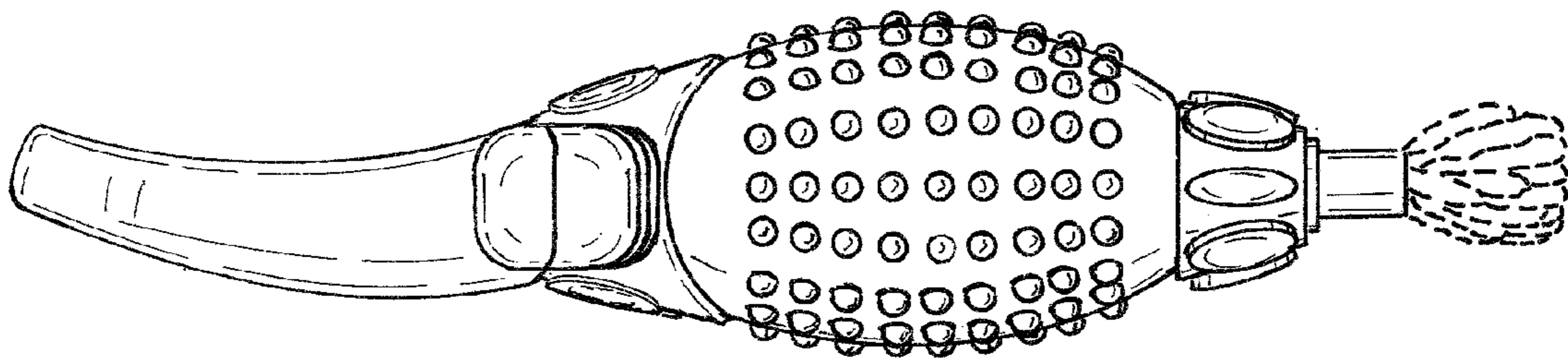
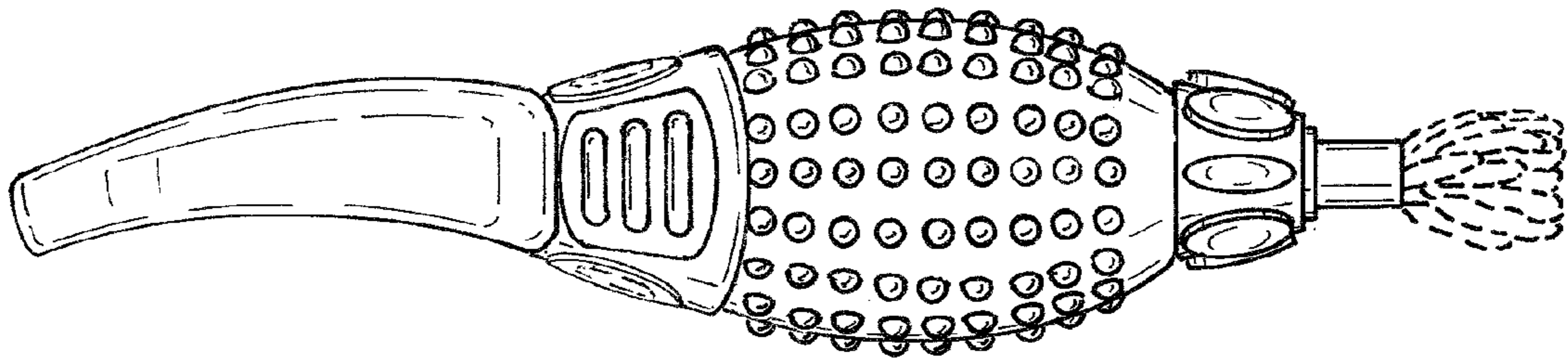
