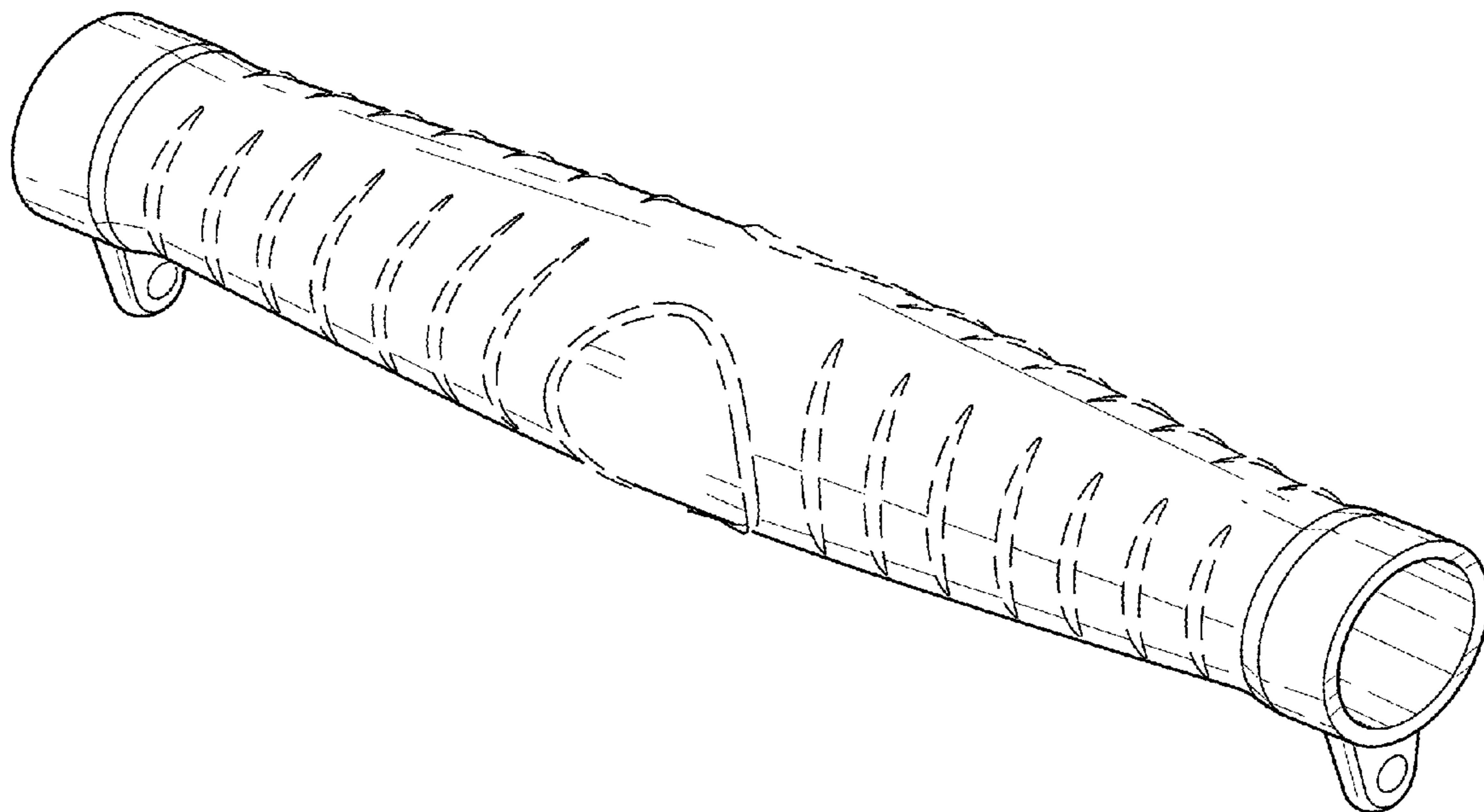
(57) **CLAIM**

We claim the ornamental design for a swing hanger, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a swing hanger according to a first embodiment of our new design; FIG. 2 is a front elevation view thereof, the back elevation view being identical to the front elevation view; FIG. 3 is a left side elevation view thereof, the right side elevation view being identical to the left side elevation view; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broke line portion of the figure drawings is included to show unclaimed subject matter only and forms no part of the claimed design.

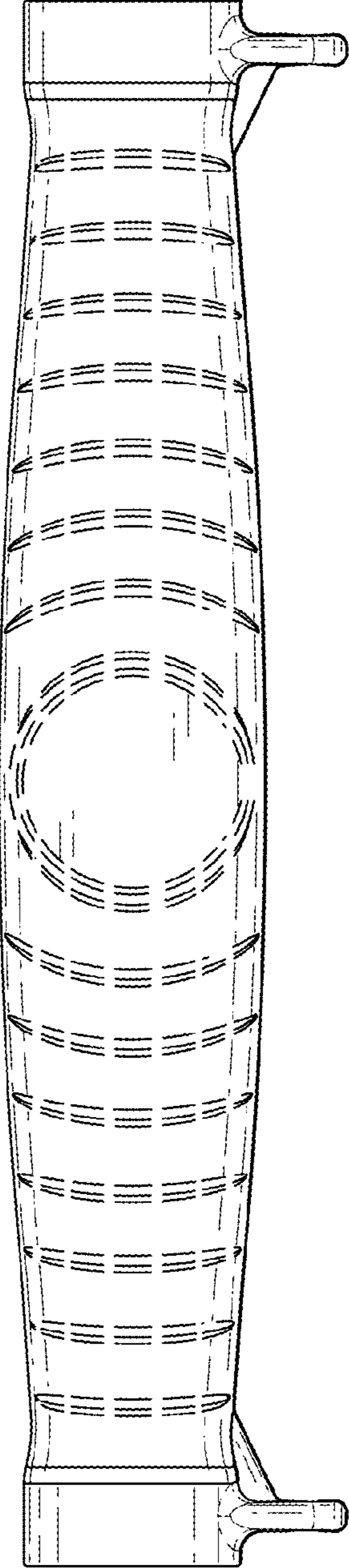
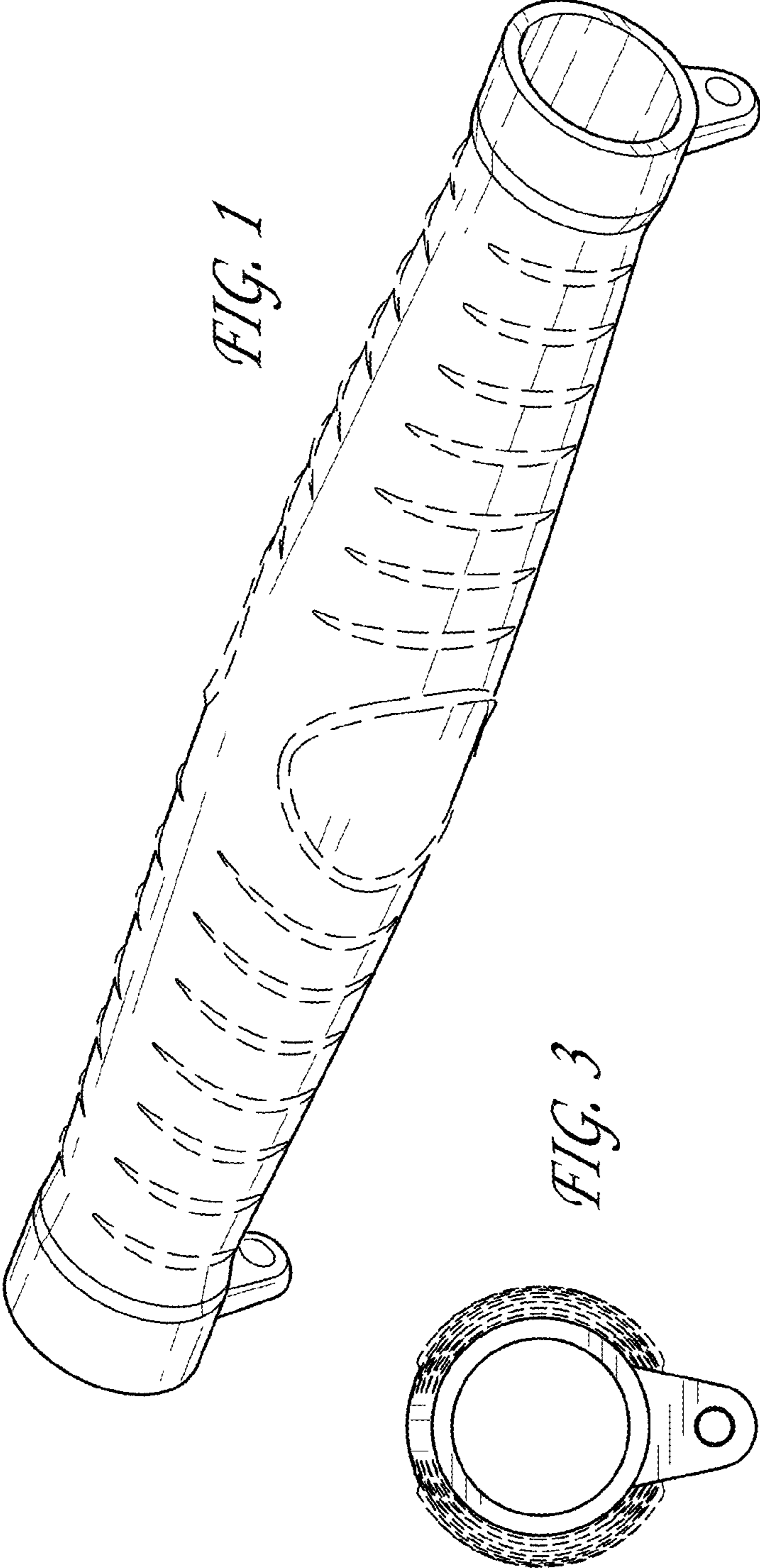

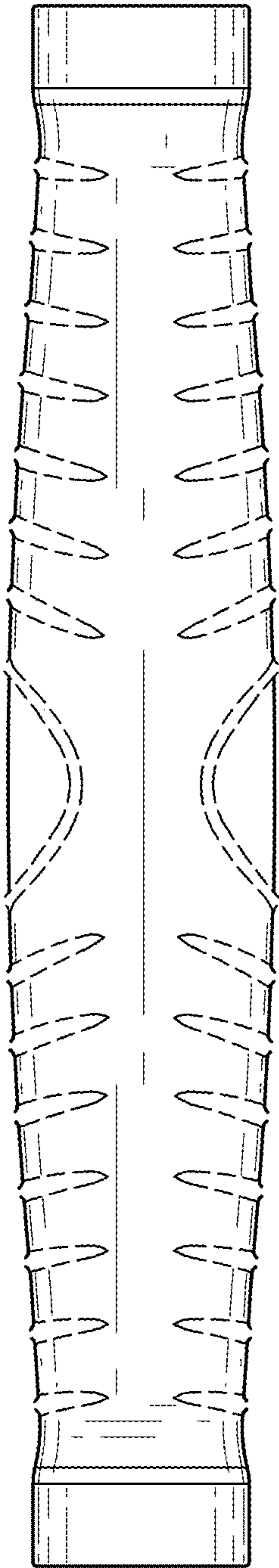

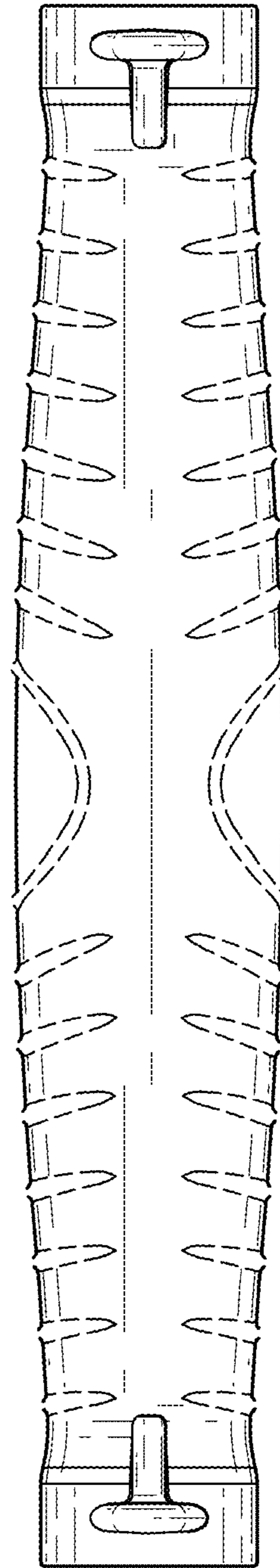
