**DESCRIPTION**

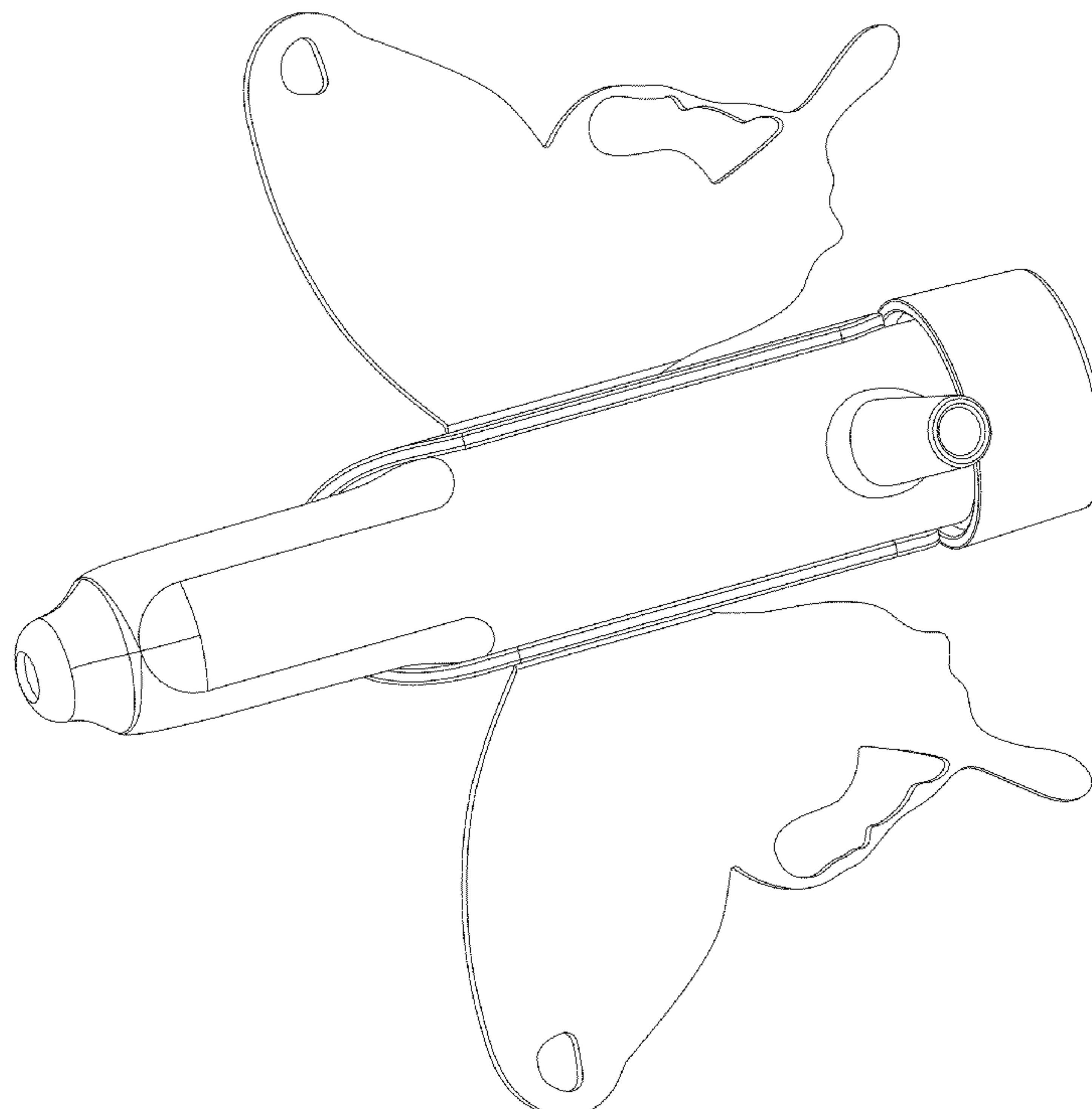
FIG. 1 is a top perspective view of the nasal device, showing our new design;

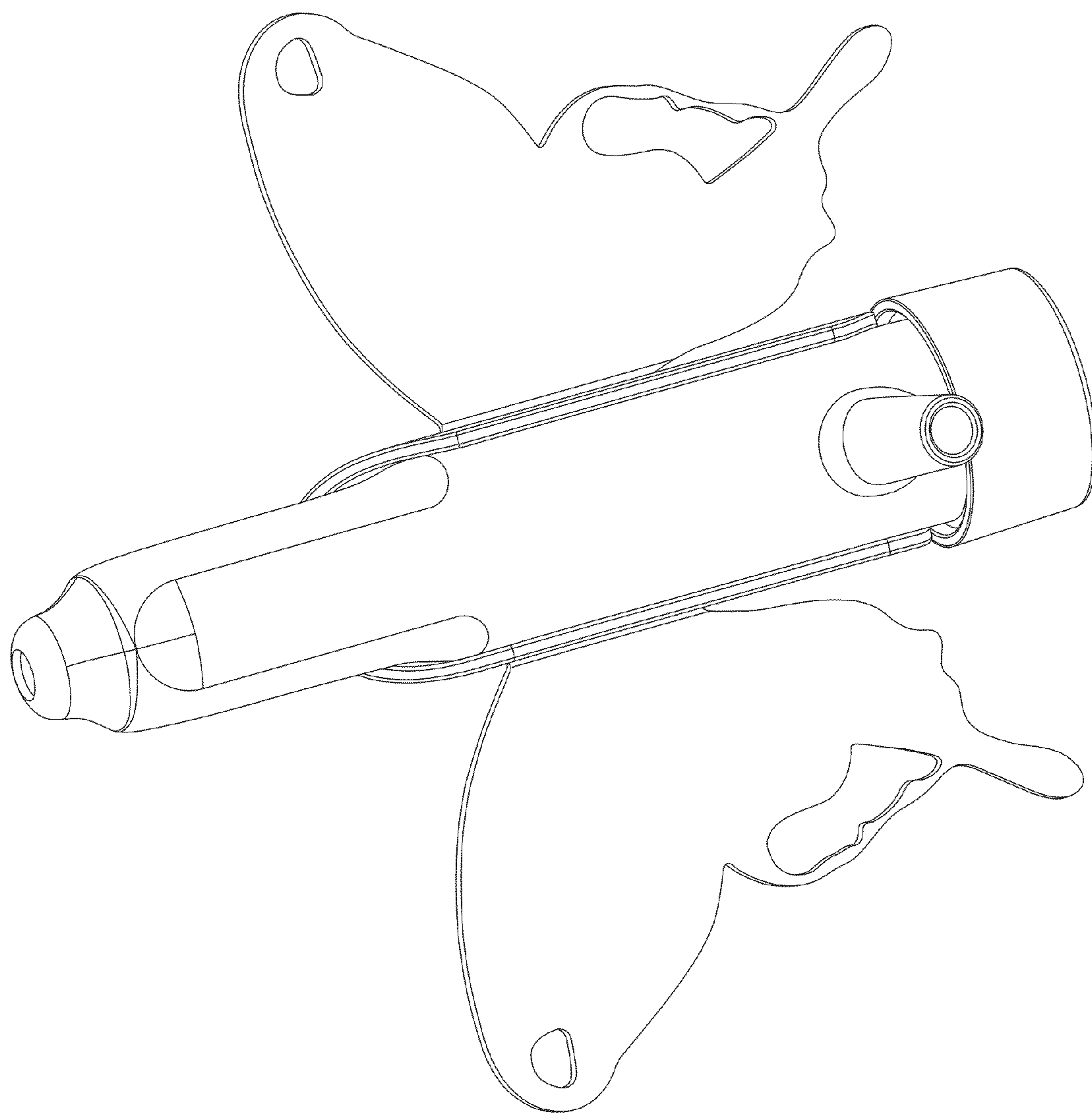

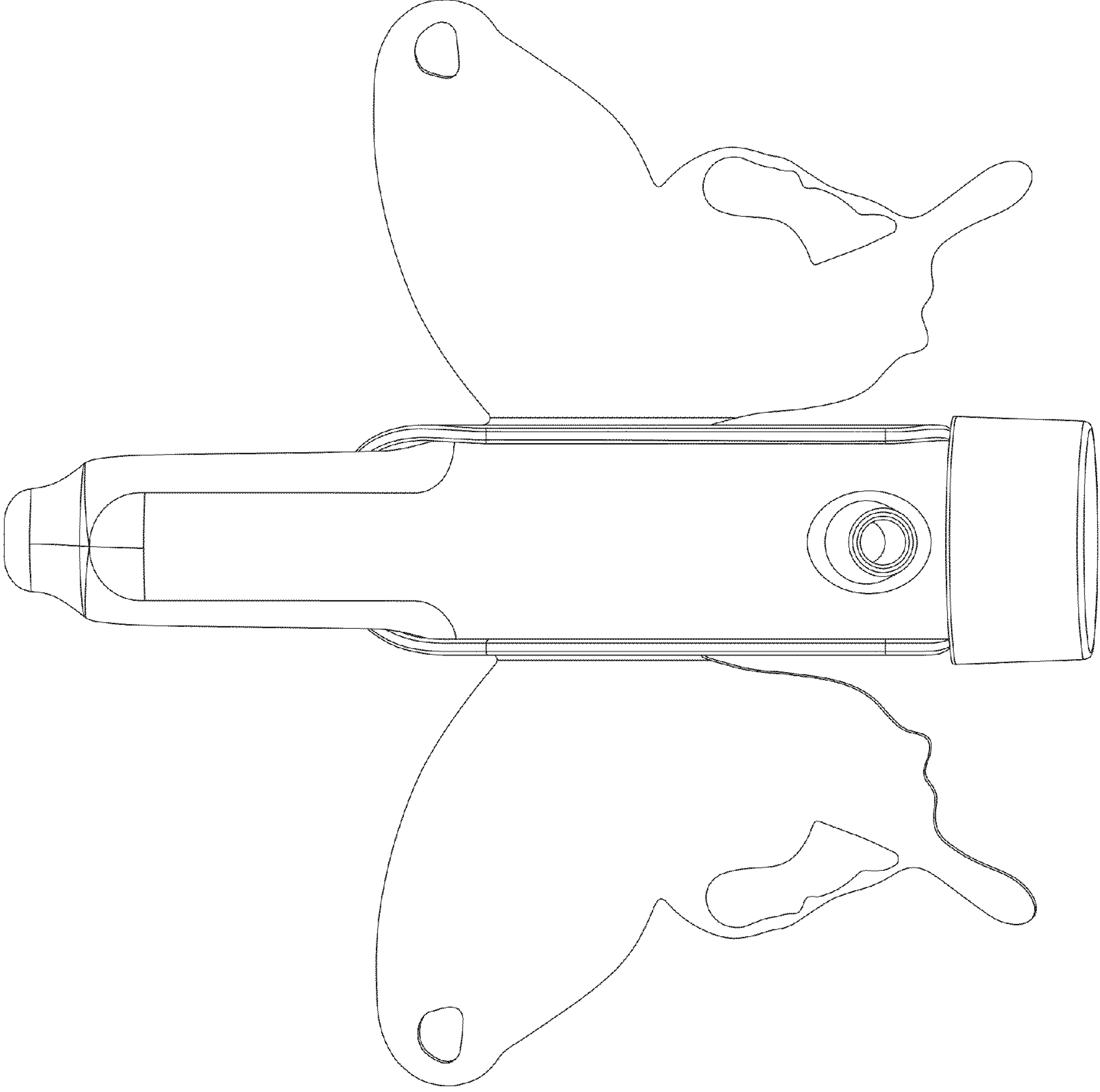

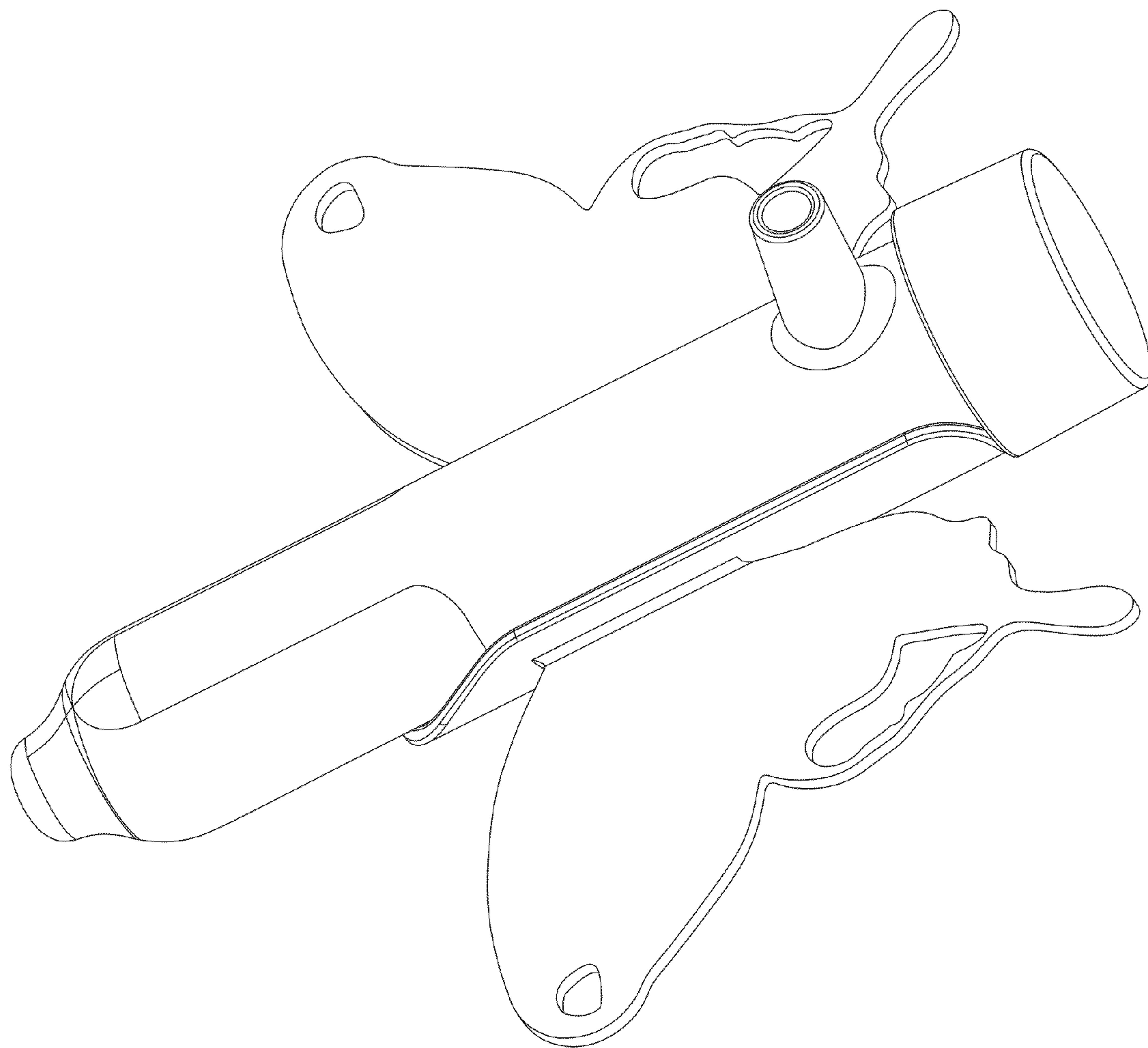

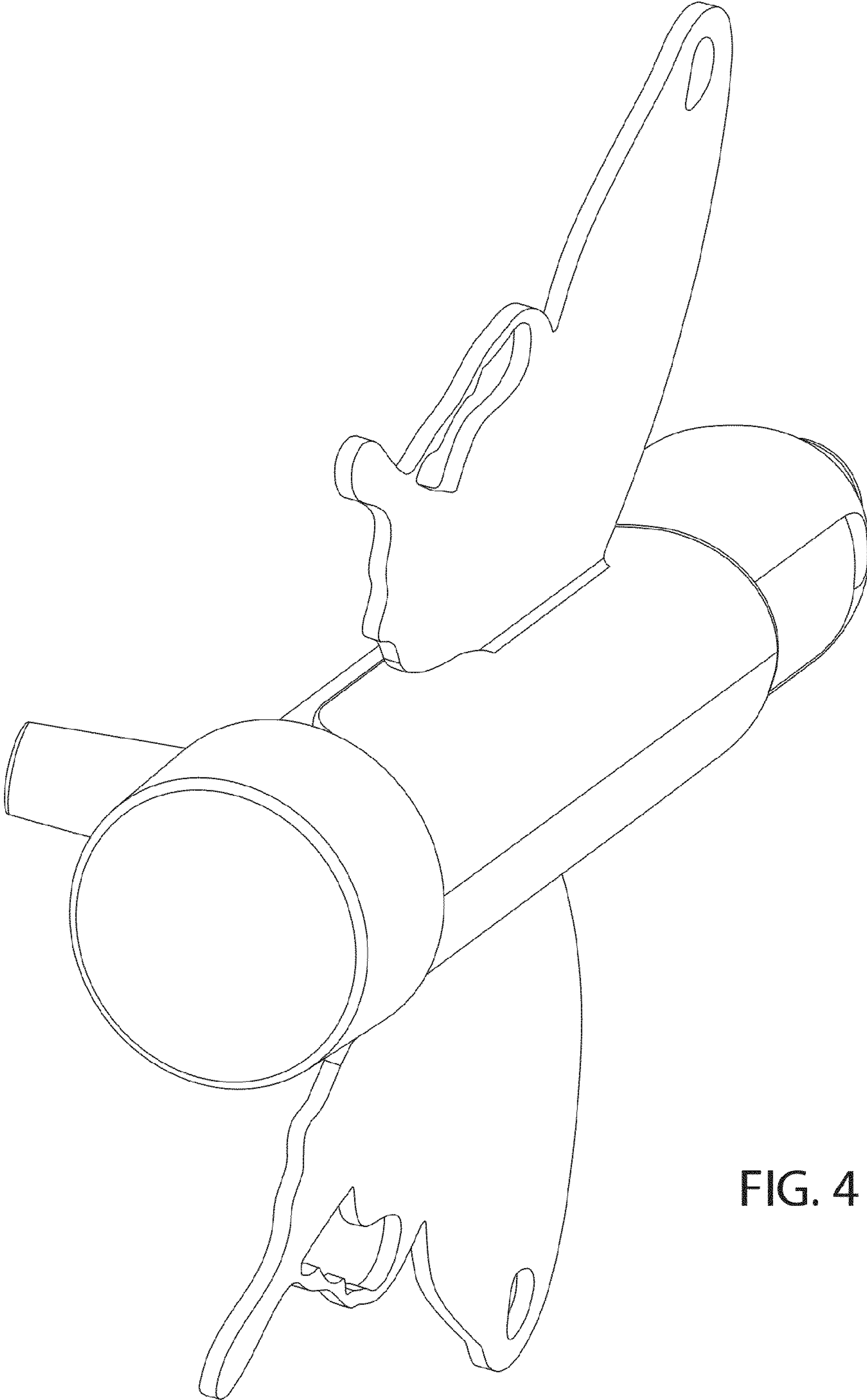

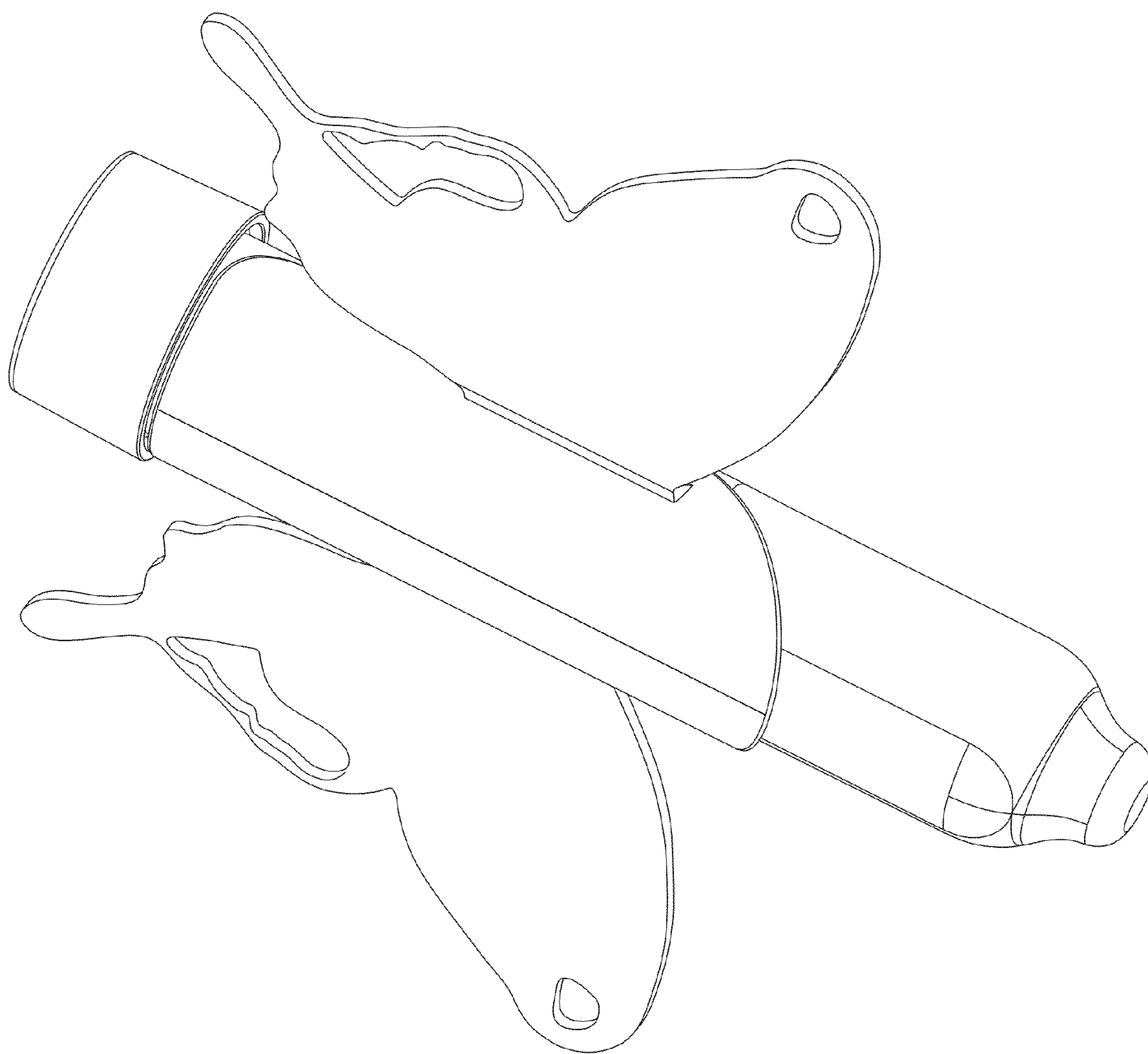

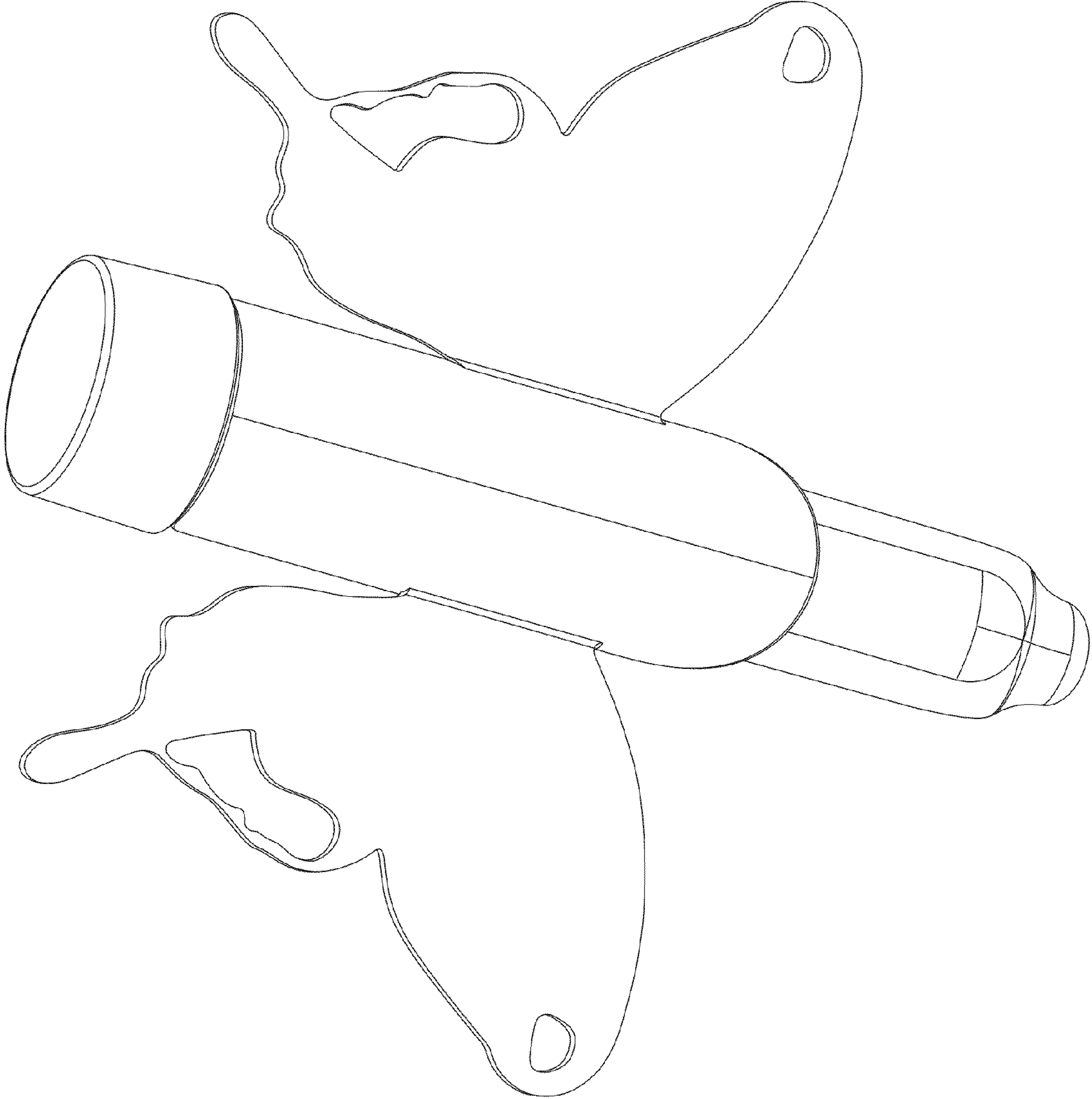
