The ornamental design for a foot spa, as shown and described.

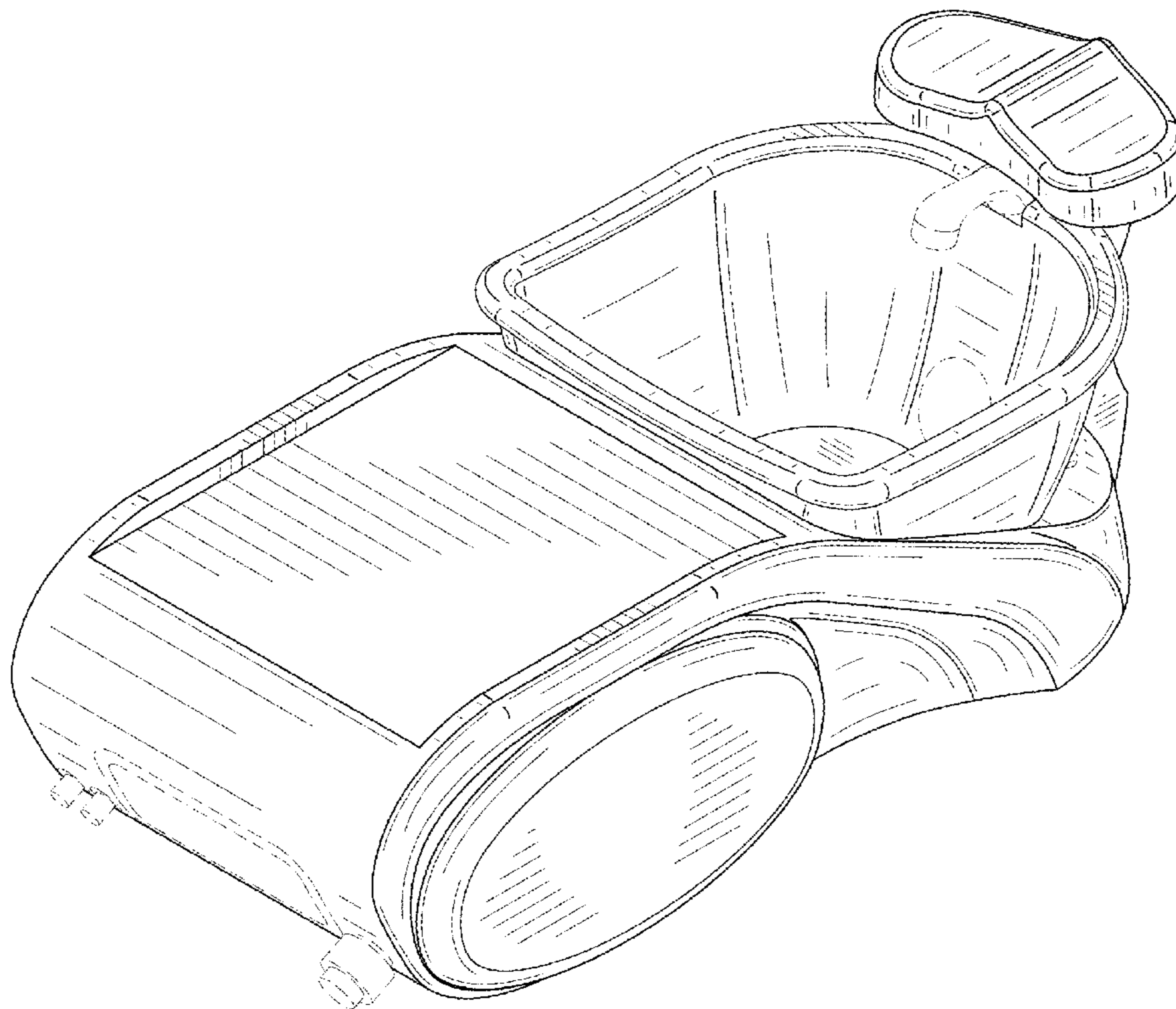
**DESCRIPTION**

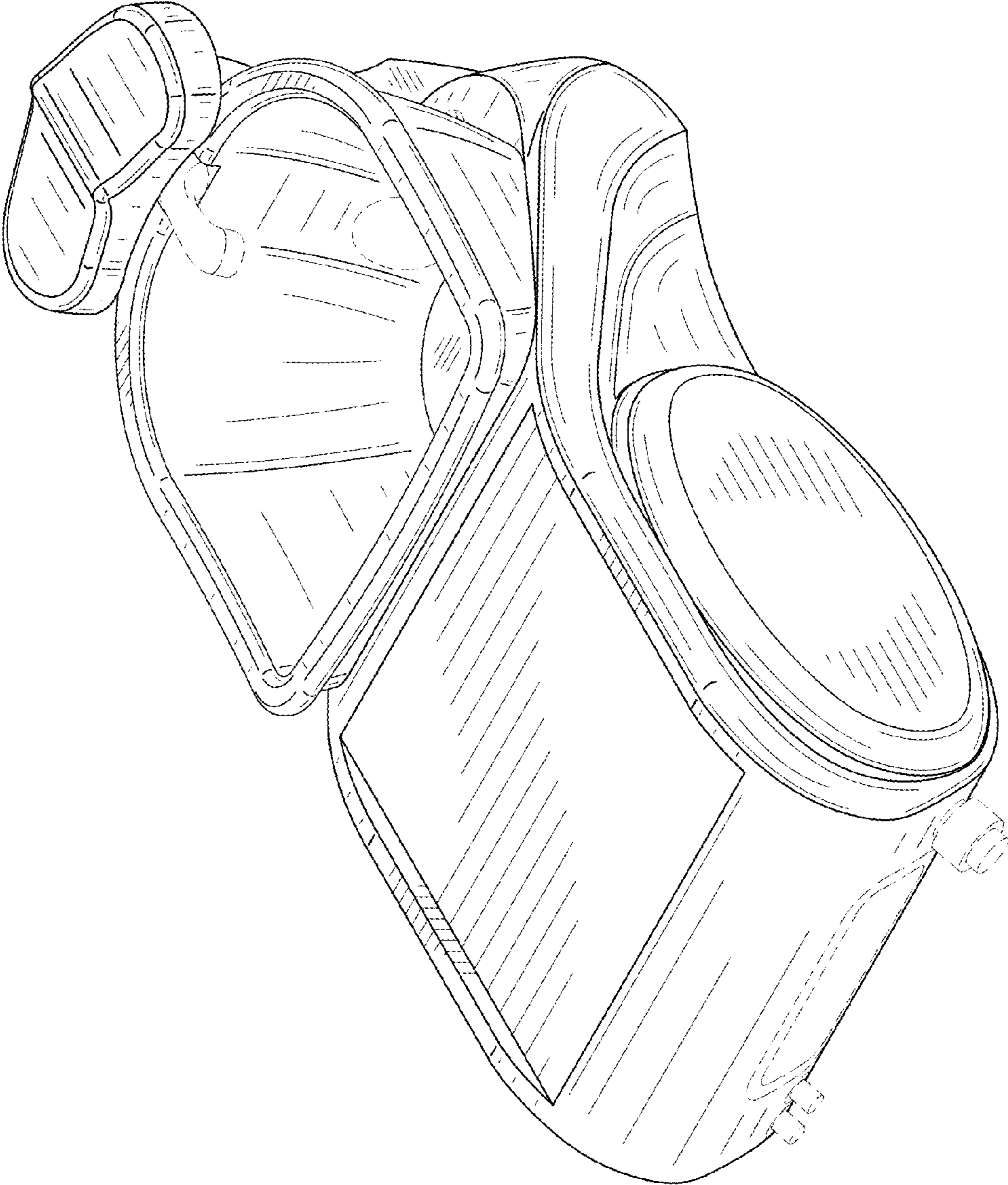

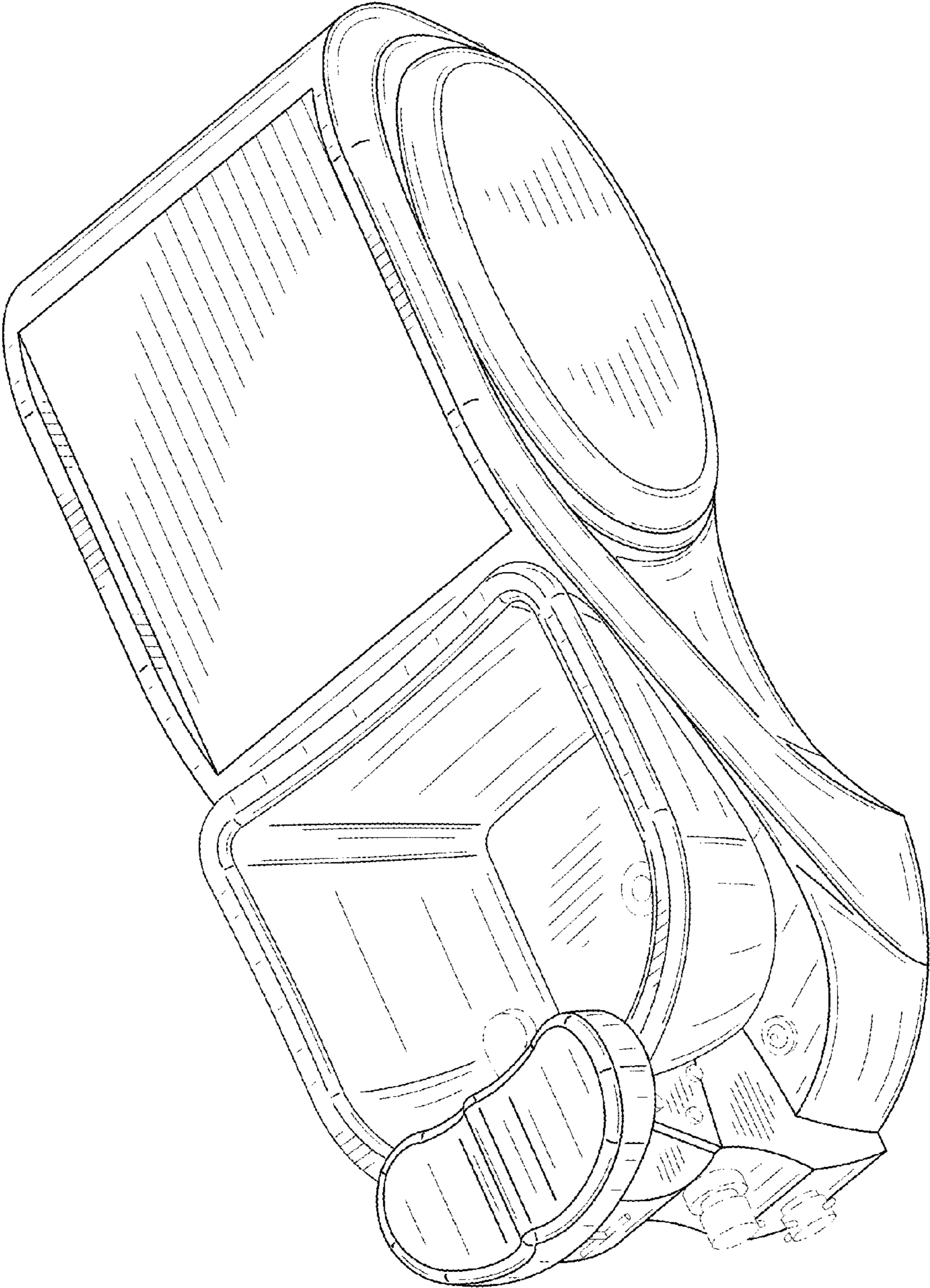

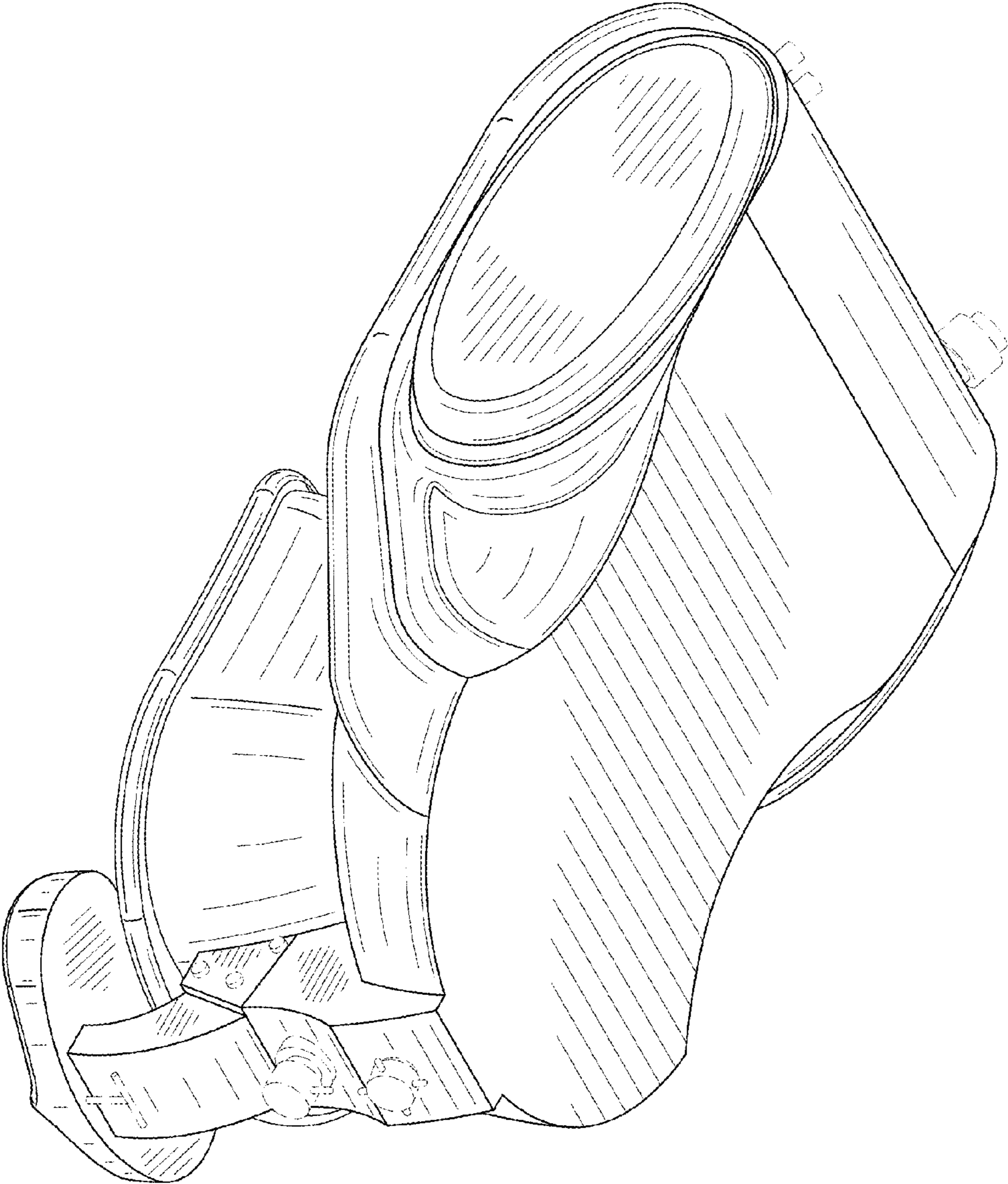

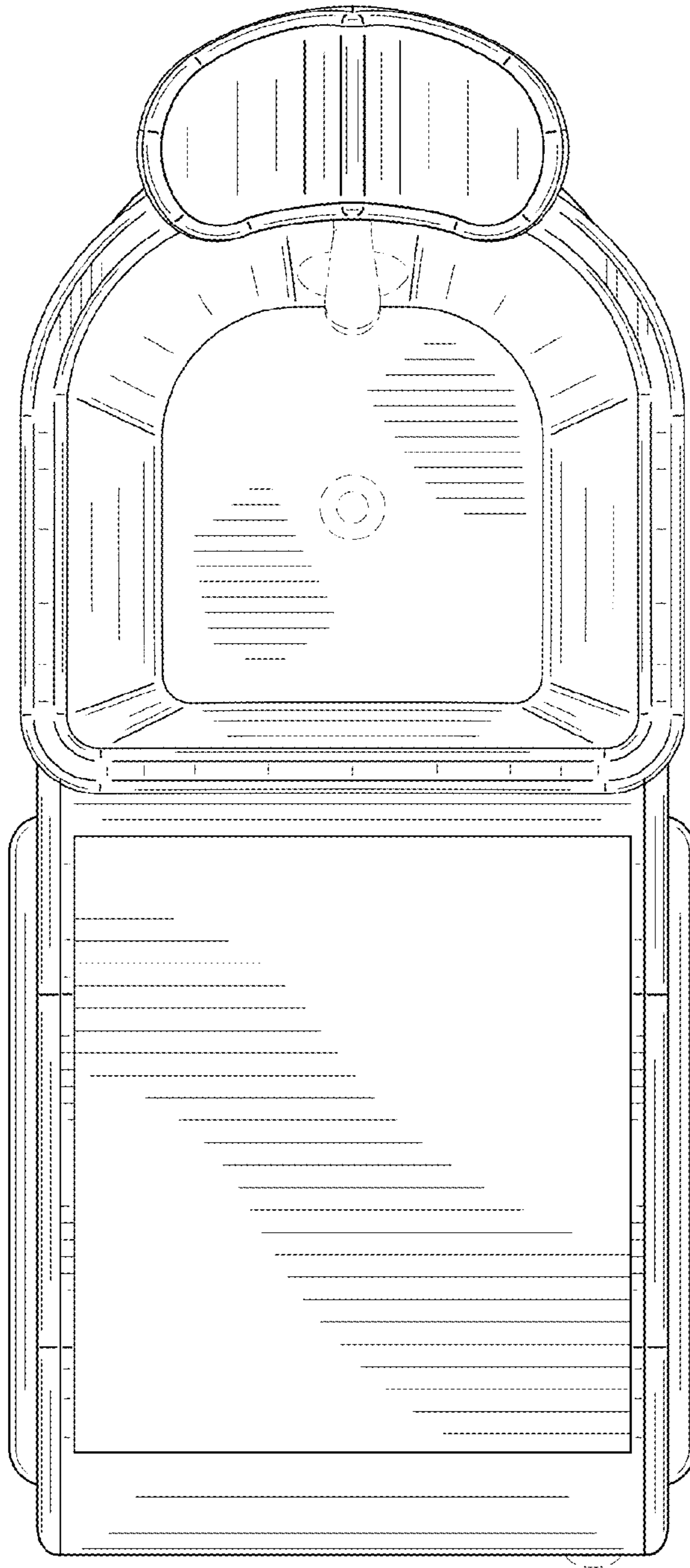

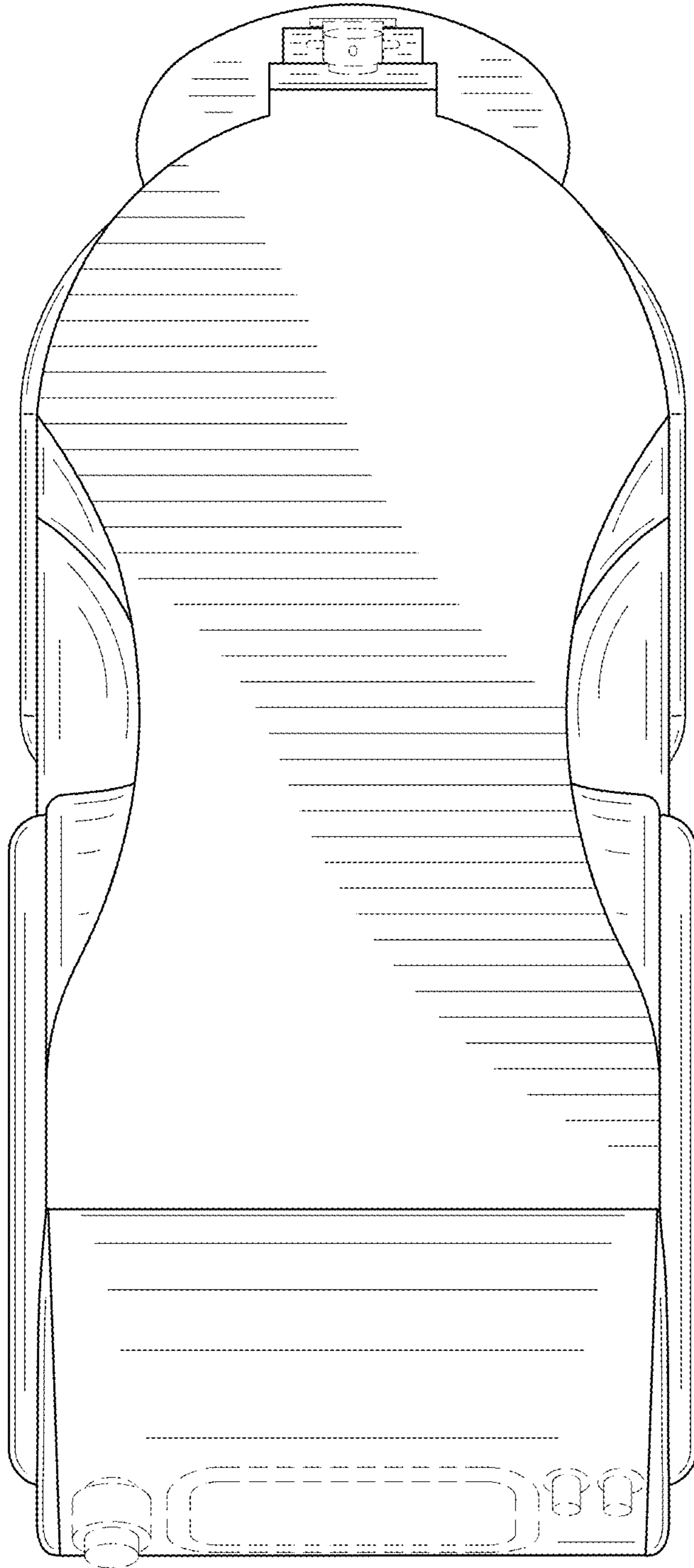

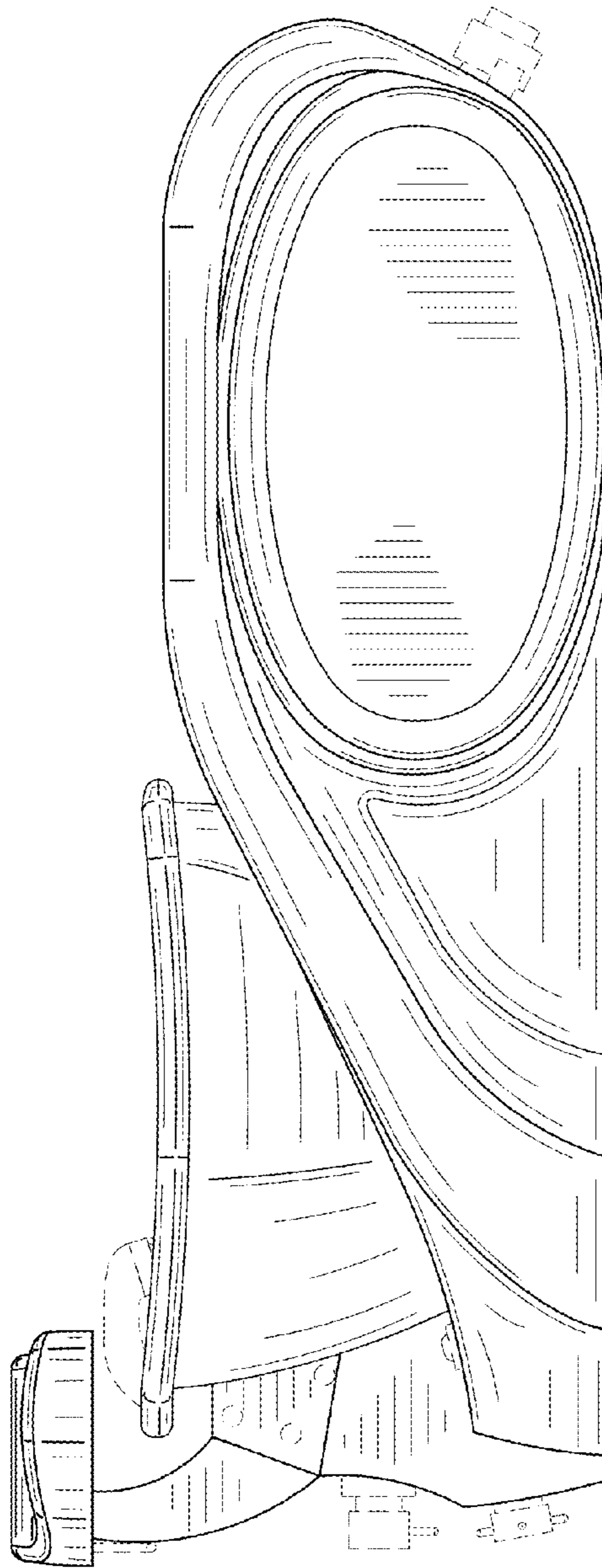

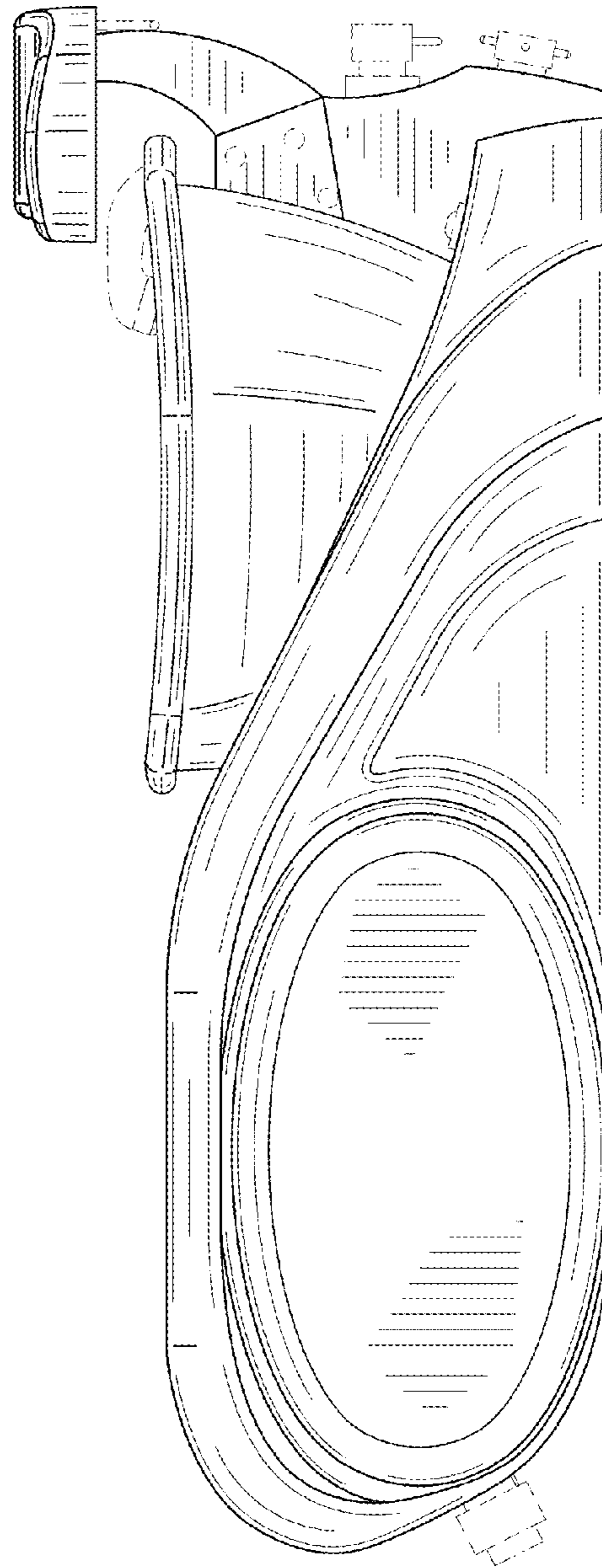

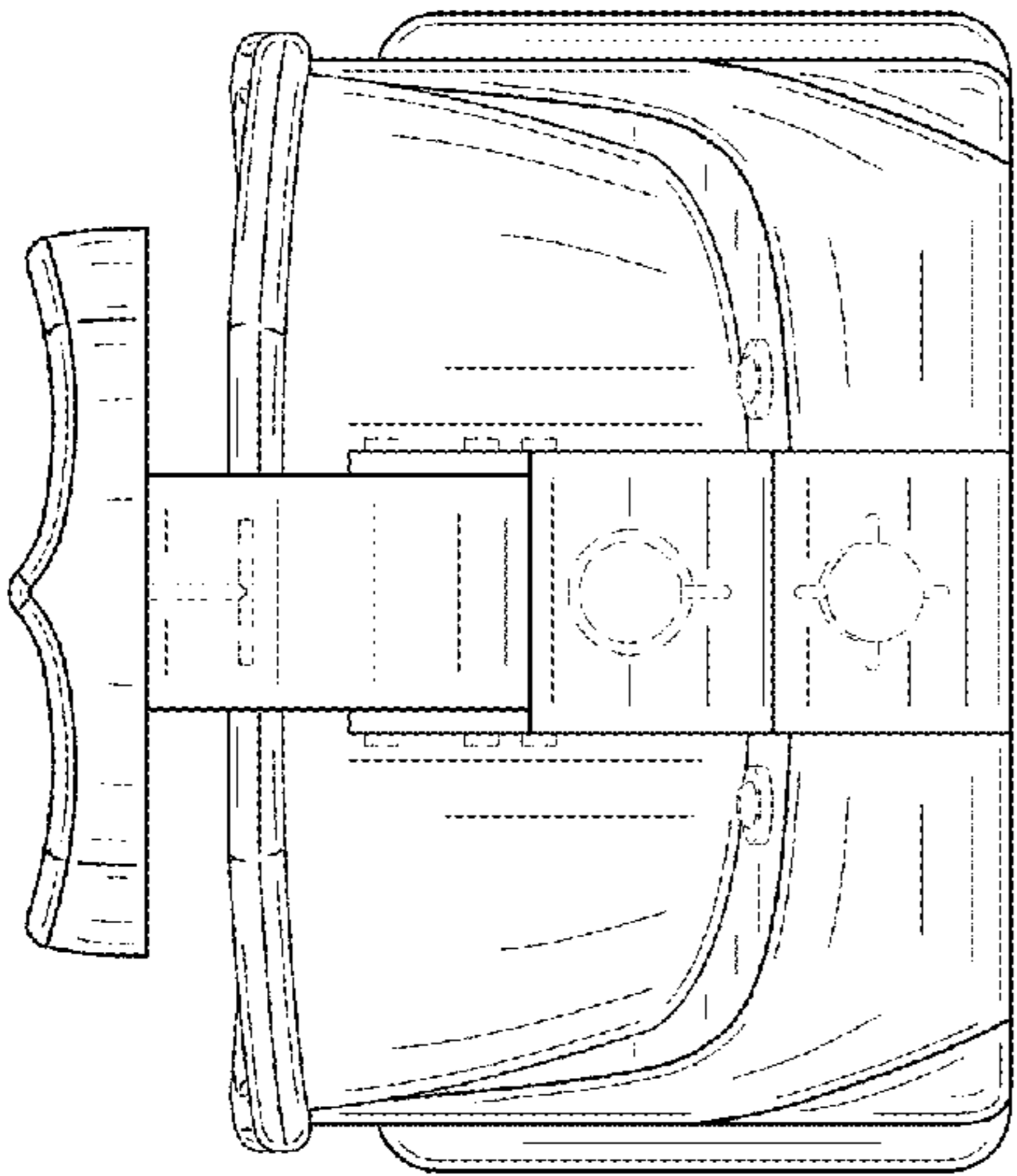

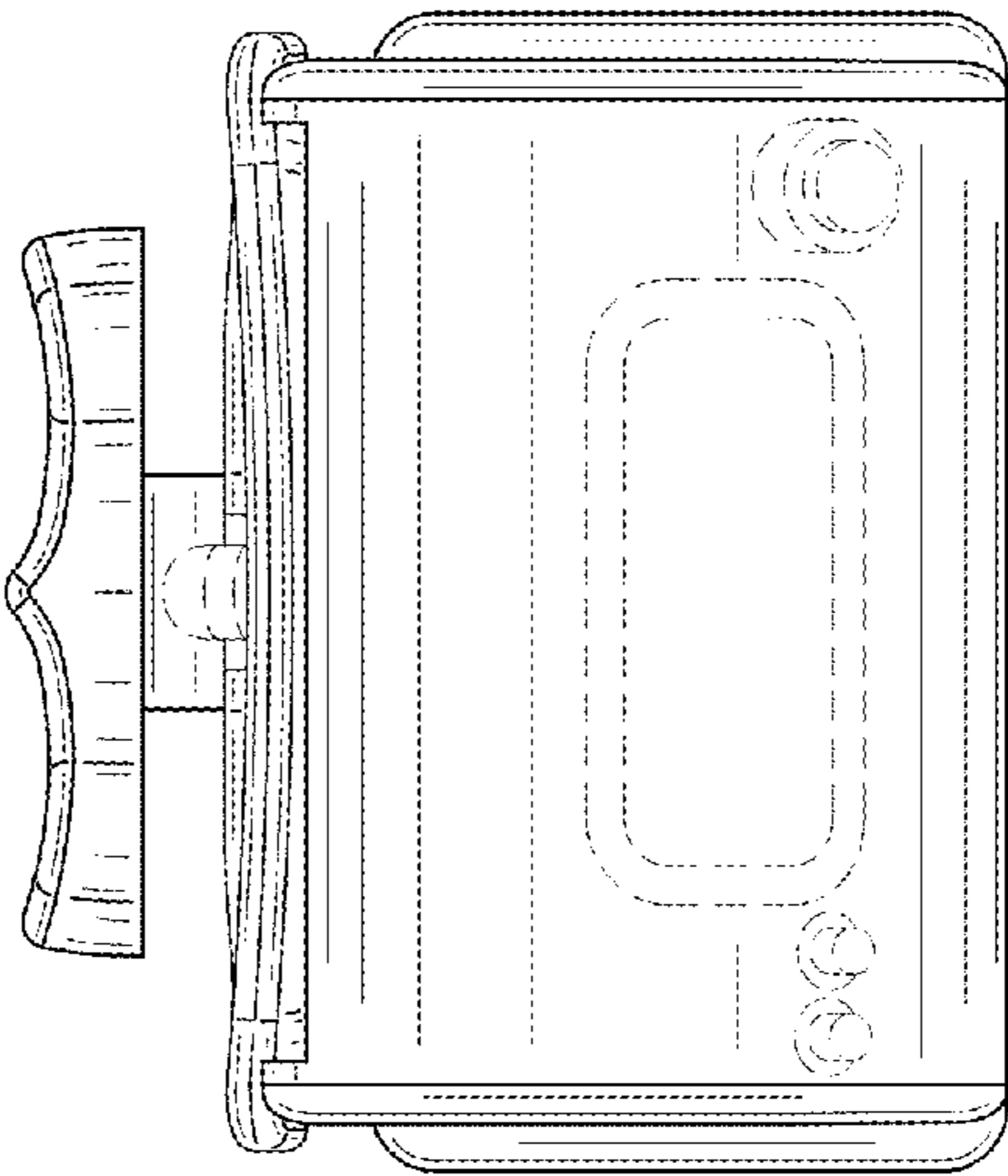
