(57) **CLAIM**

The ornamental design for an accessory for a decorative edging stone, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a decorative edging stone according to a first embodiment of the present invention;

FIG. 2 shows a front view of the decorative edging stone illustrated in FIG. 1;

FIG. 3 shows a back view of the decorative edging stone illustrated in FIG. 1;

FIG. 4 shows a right side view of the decorative edging stone illustrated in FIG. 1;

FIG. 10 shows a back view of the decorative edging stone illustrated in FIG. 8;

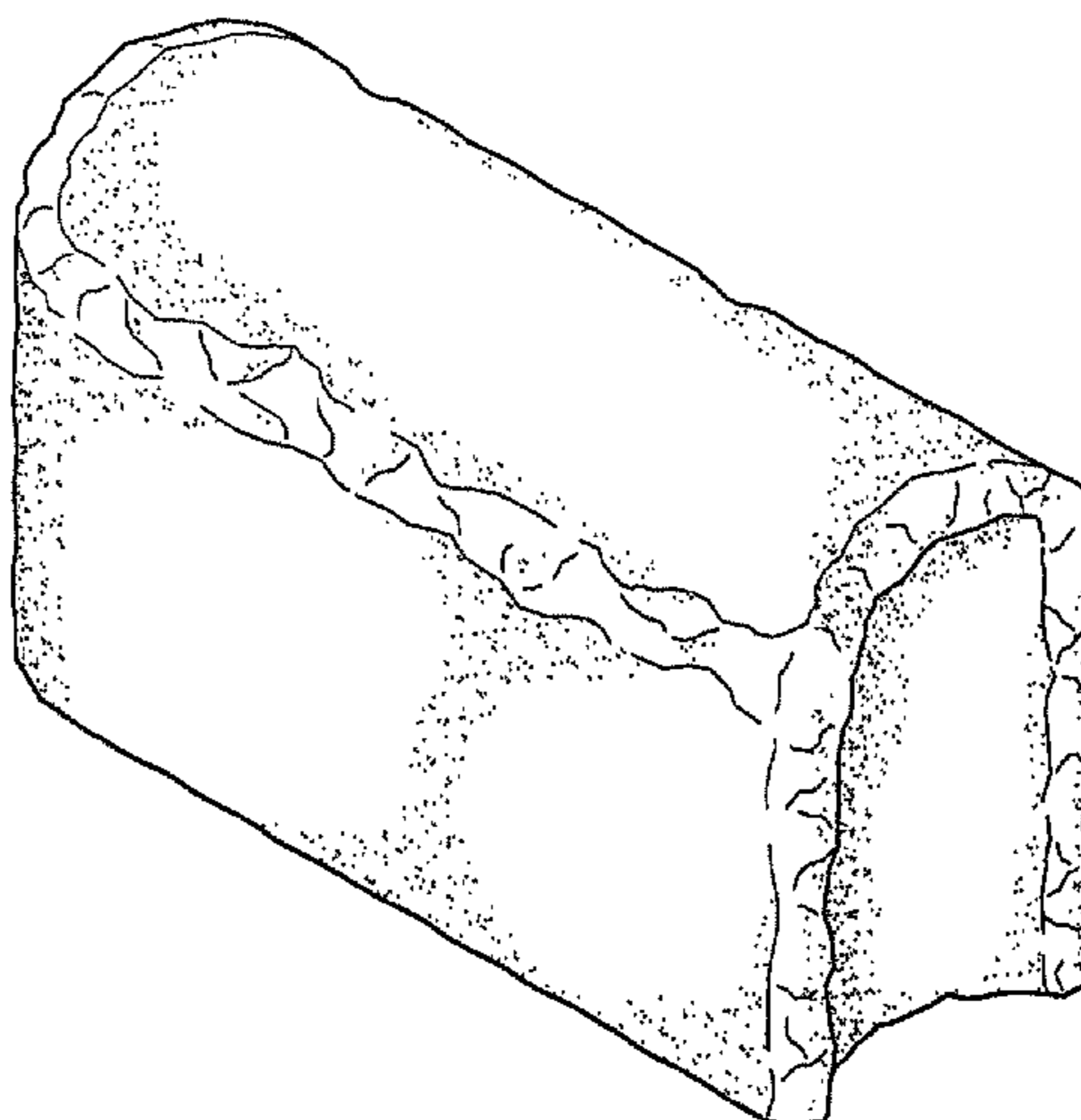
FIG. 11 shows a right side view of the decorative edging stone illustrated in FIG. 8;

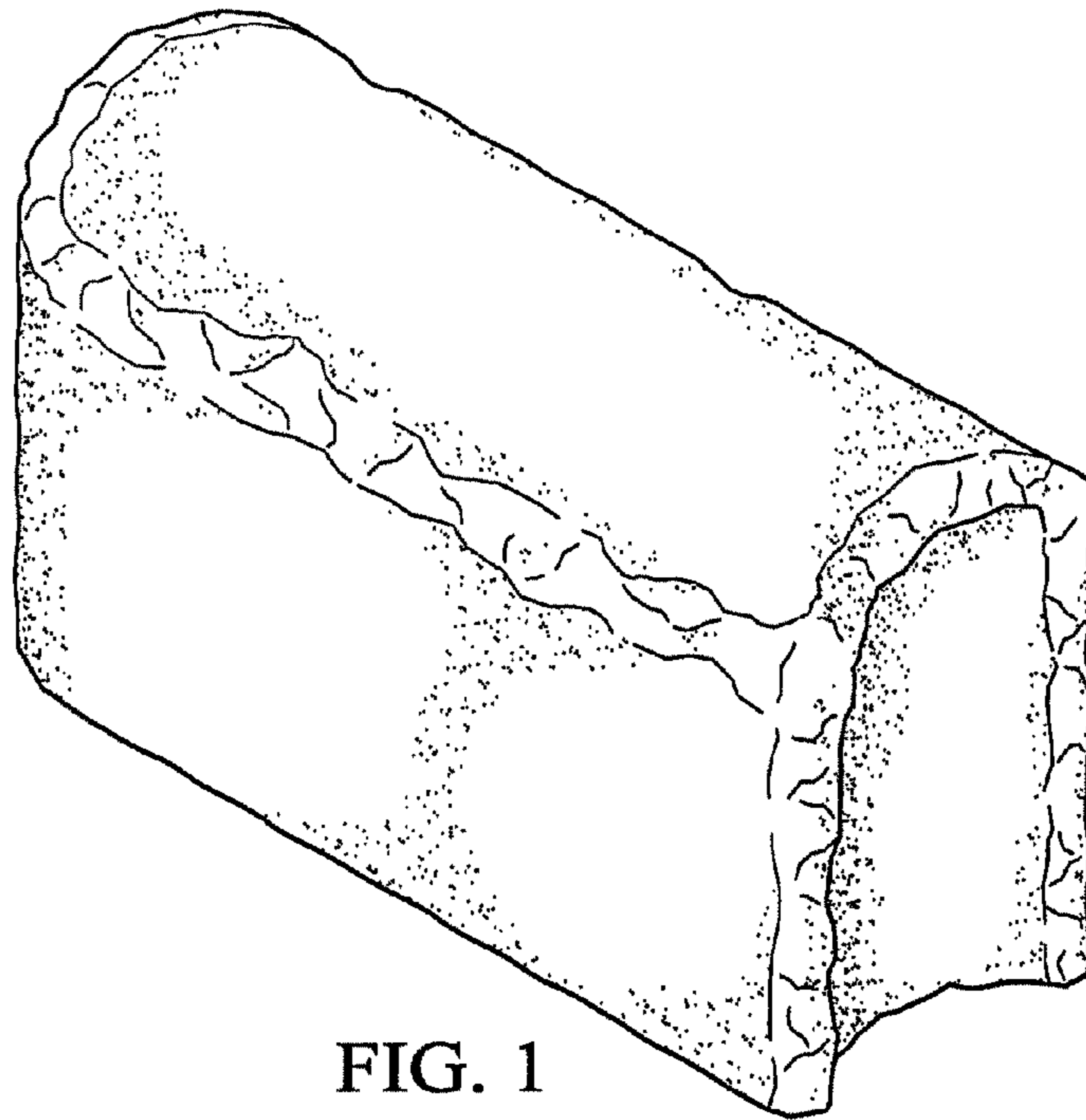

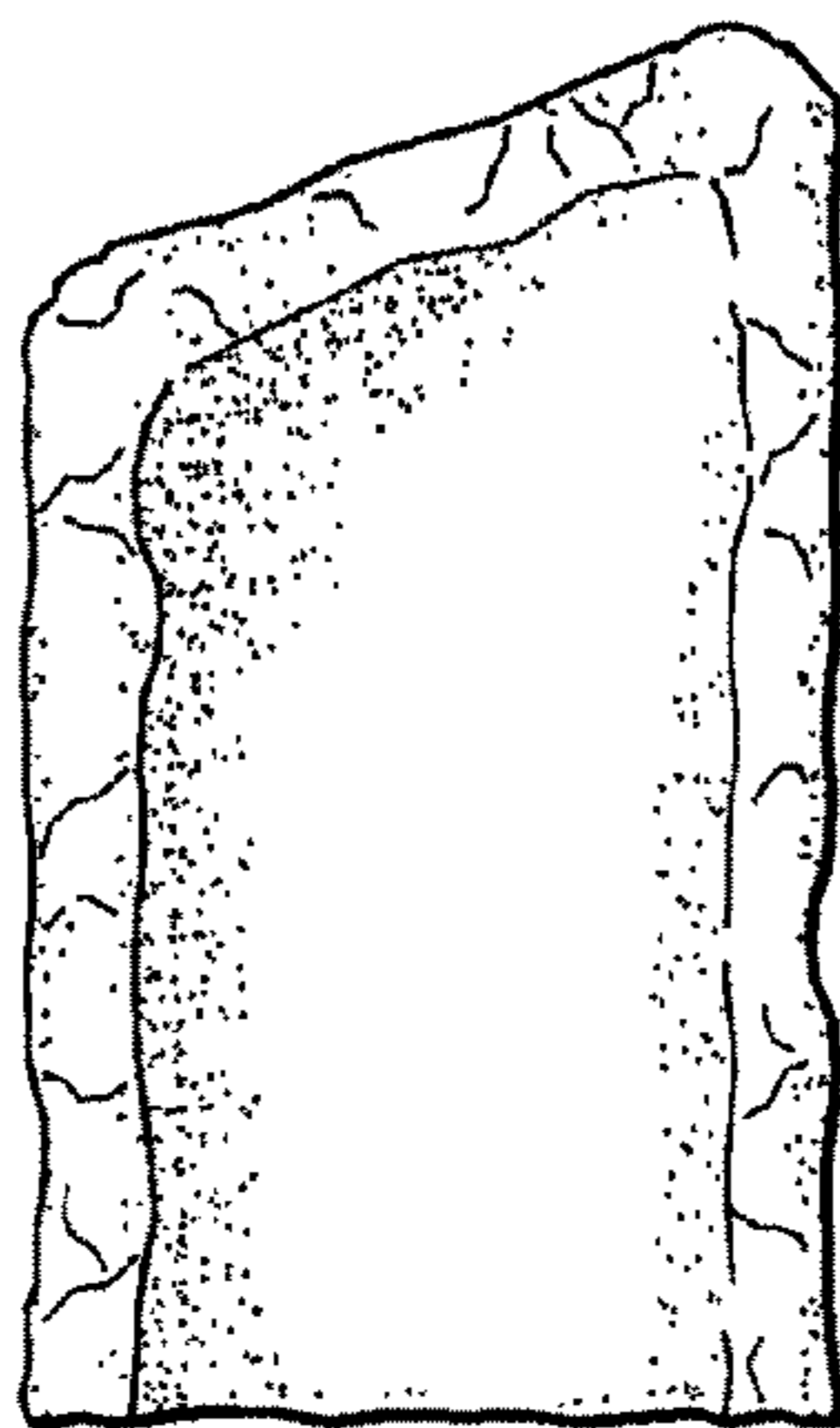

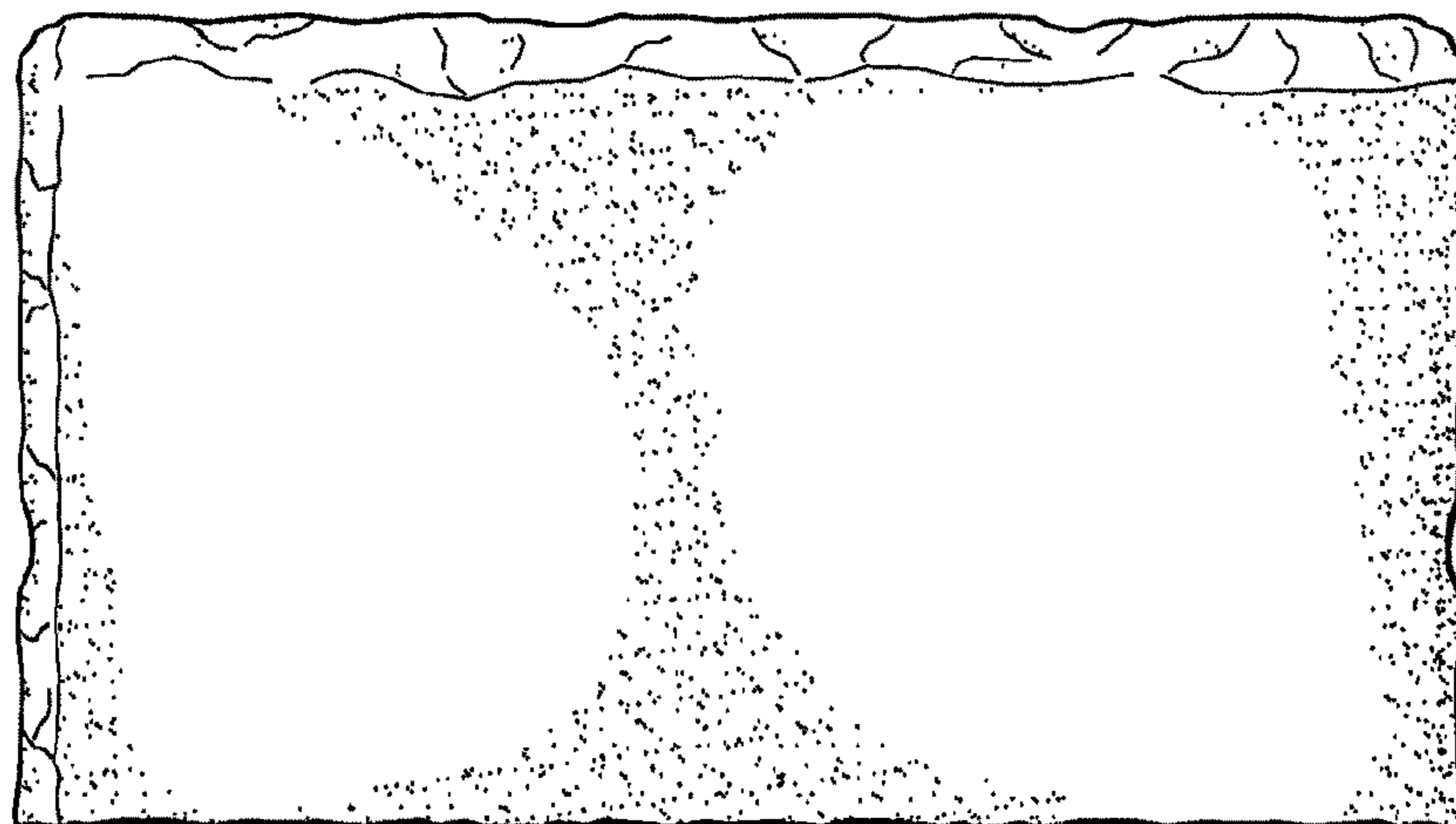

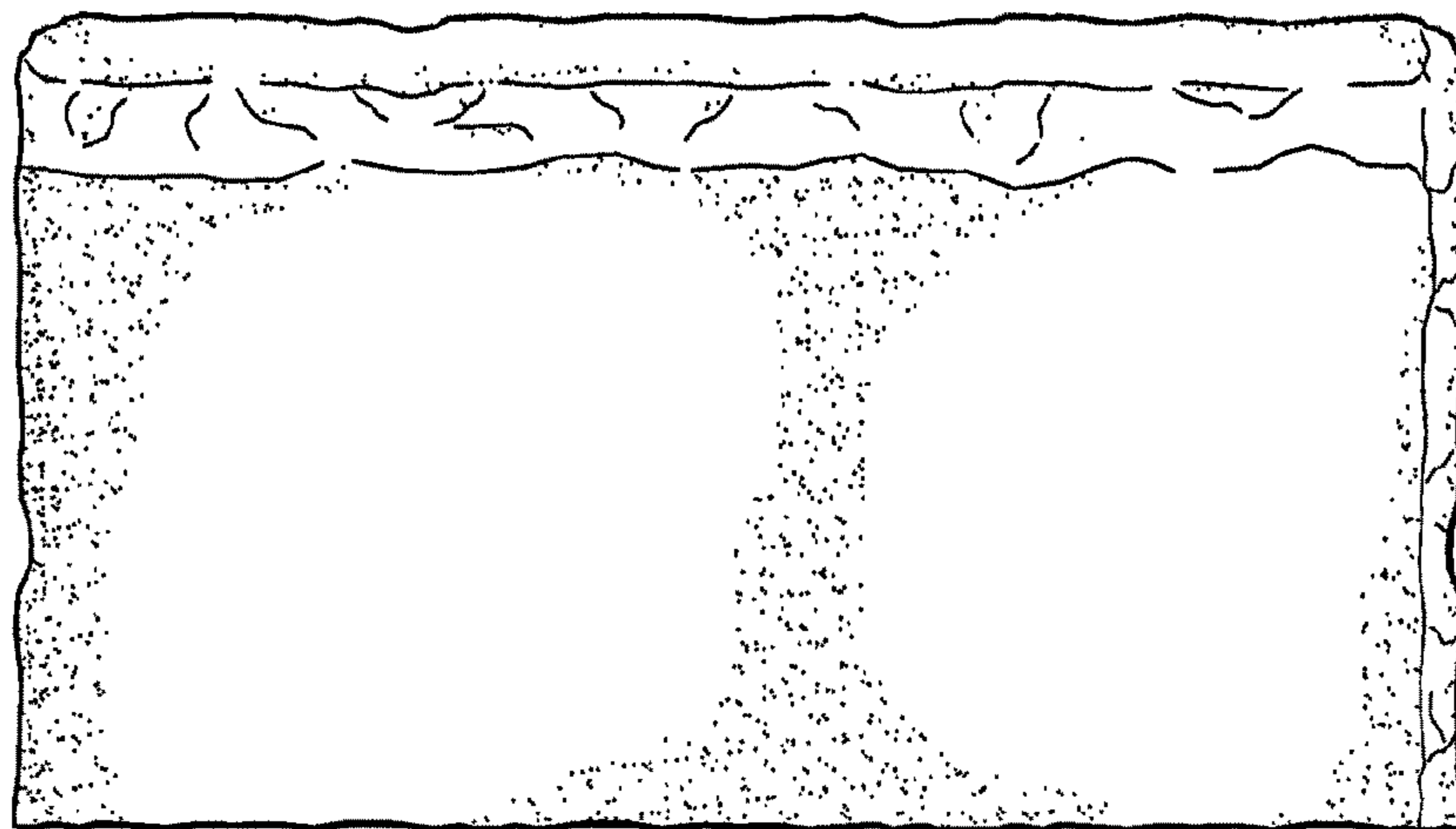

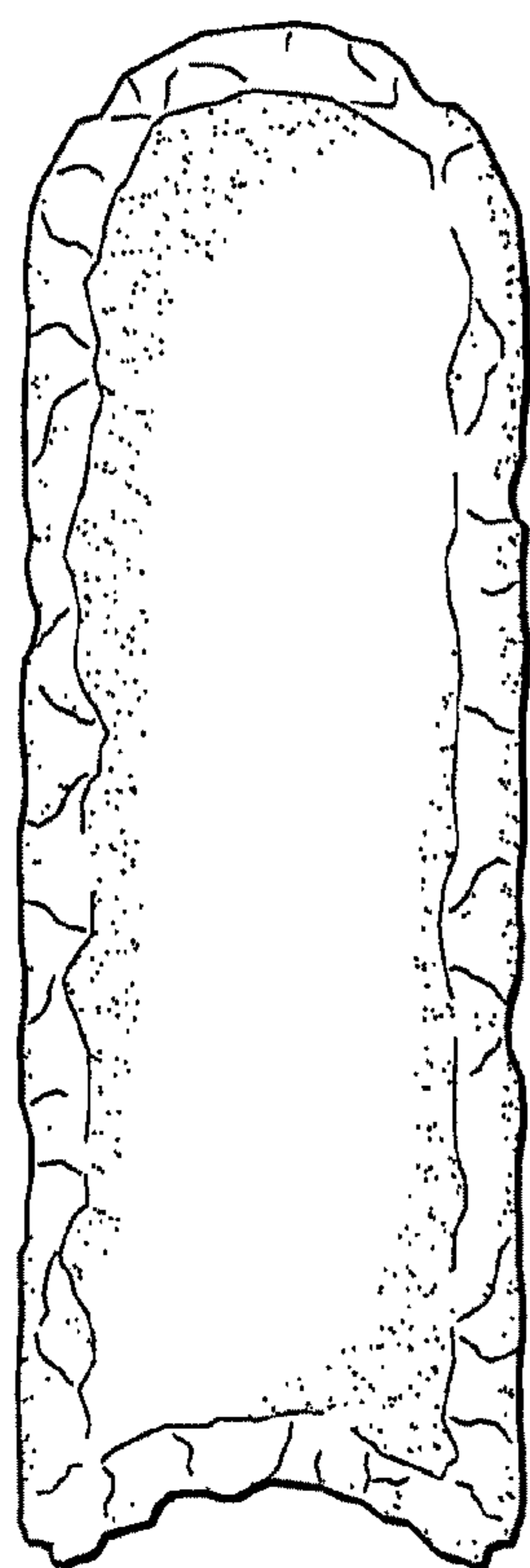

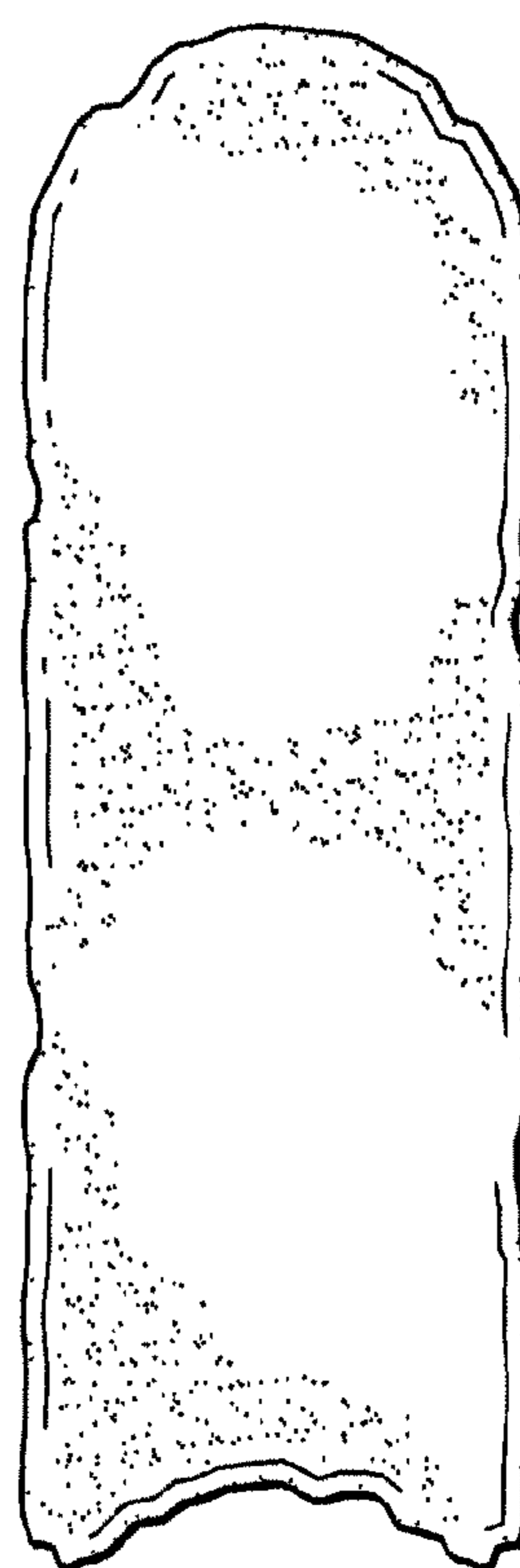

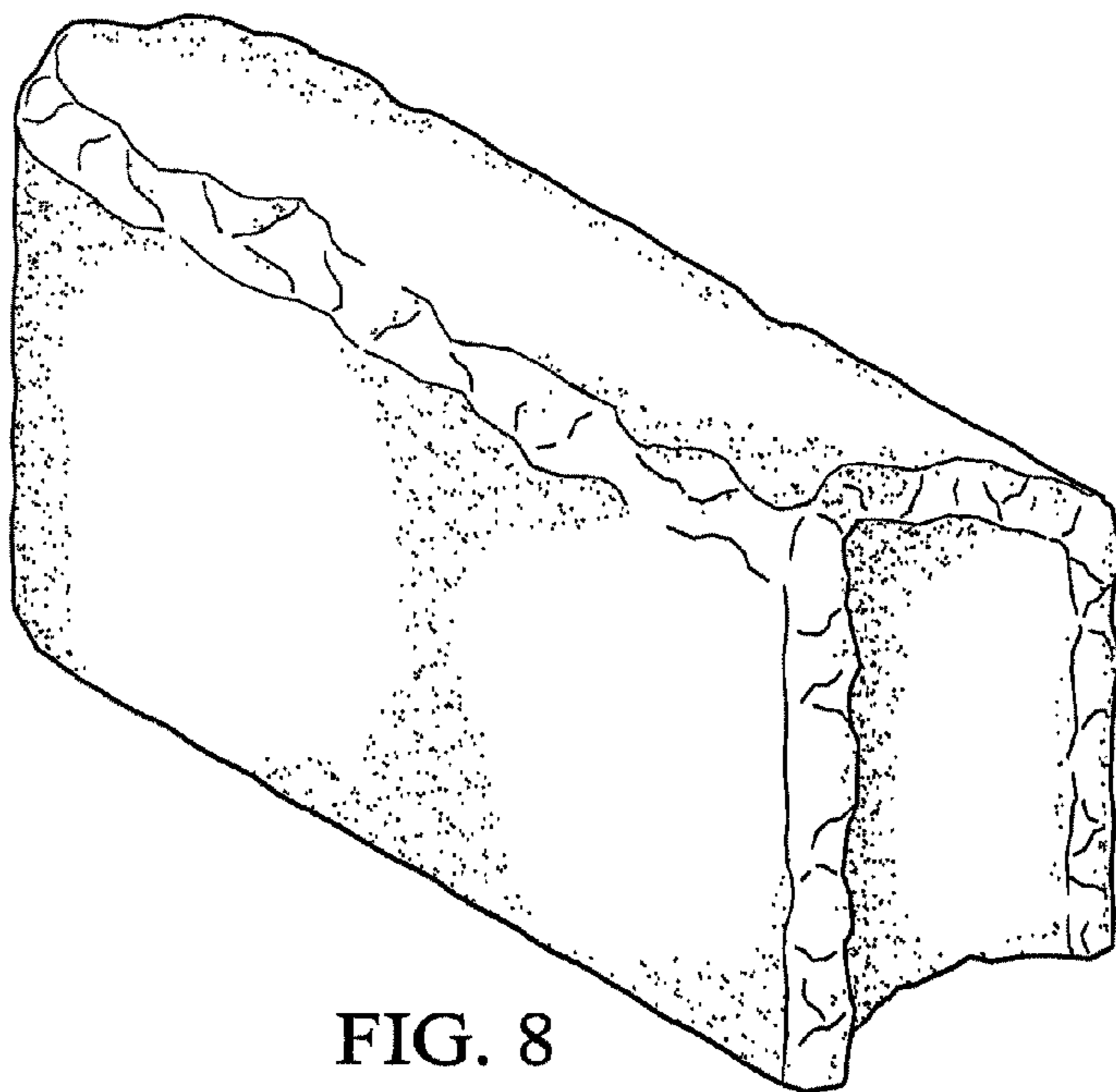

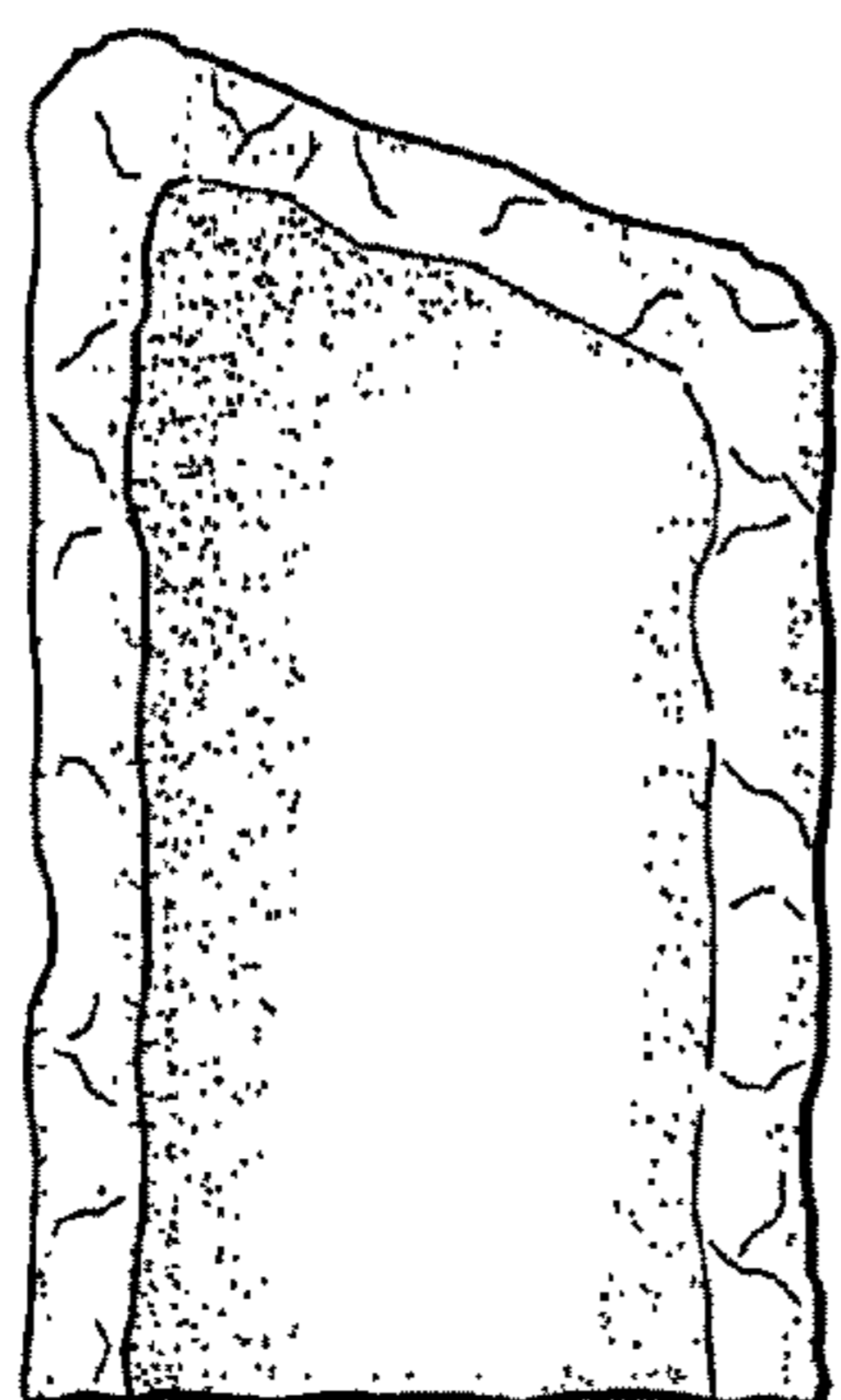

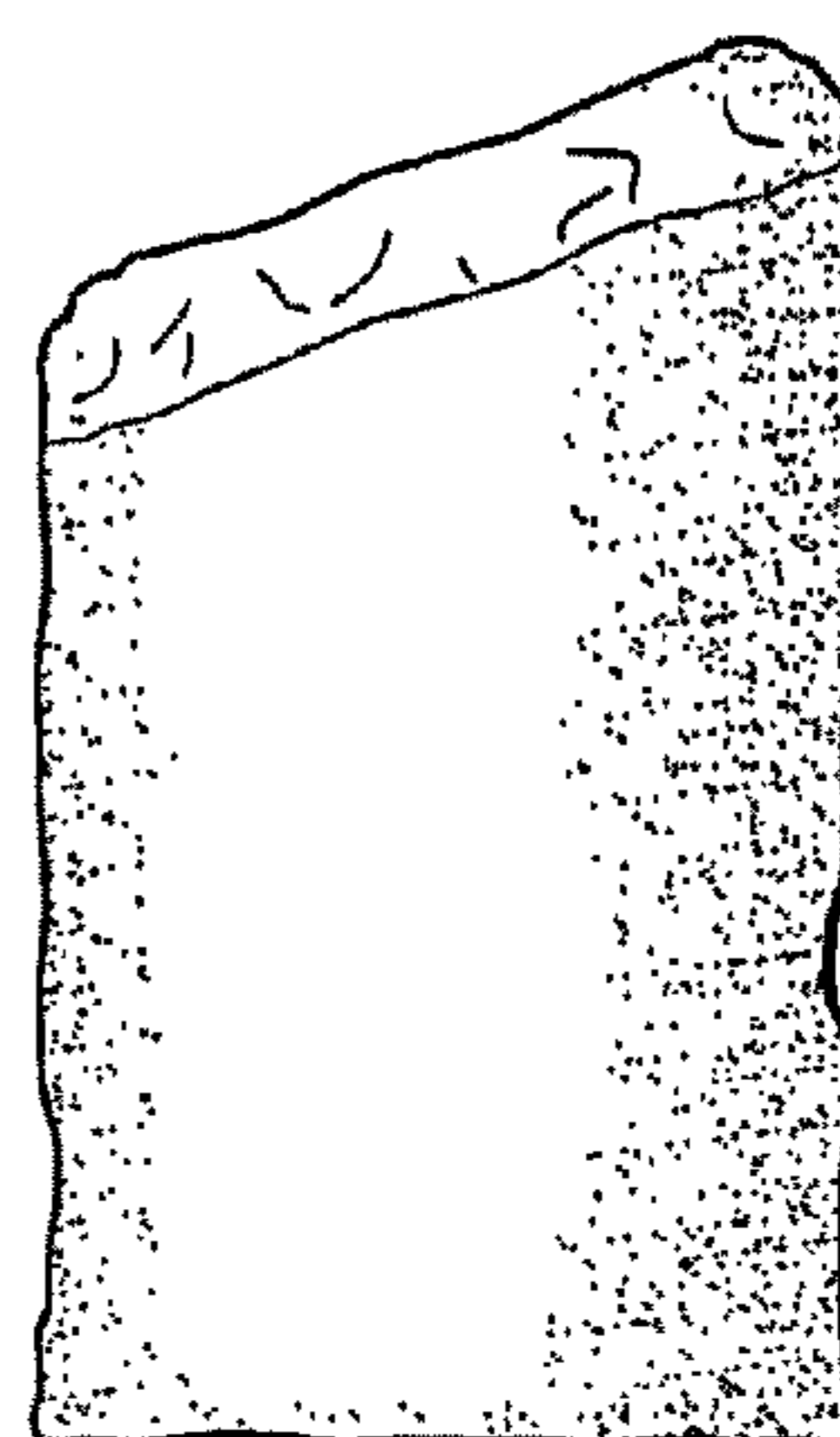

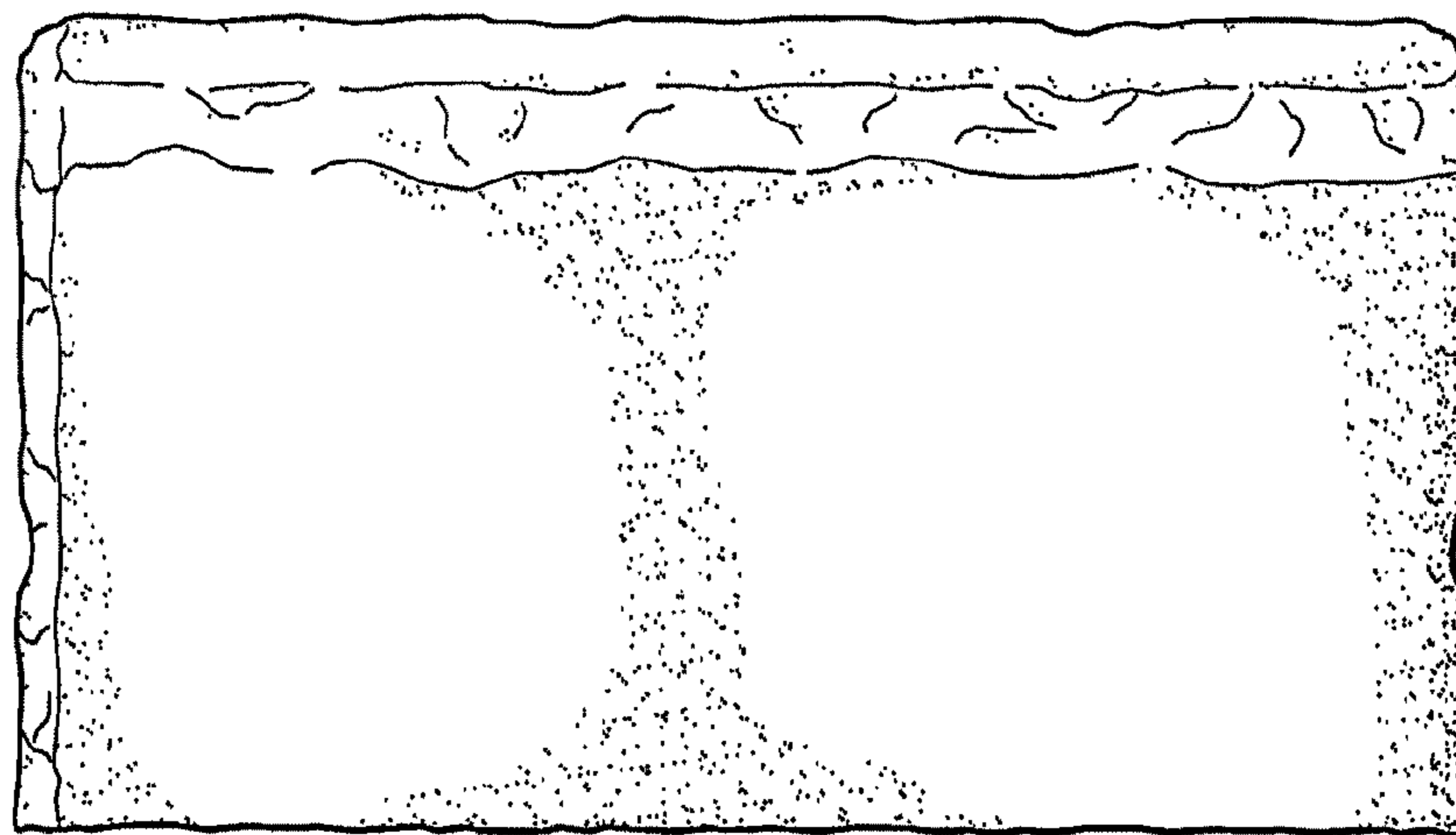

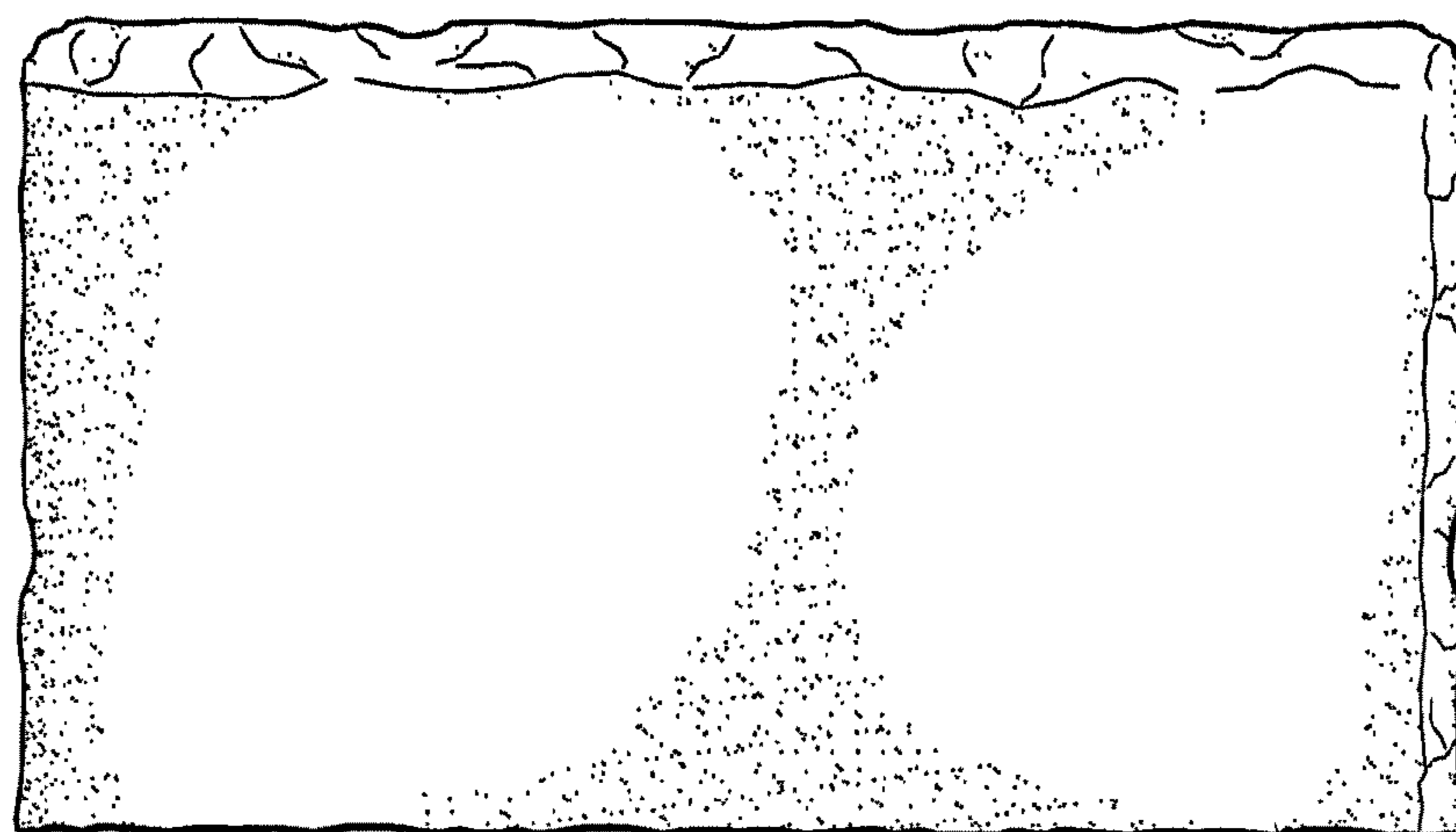

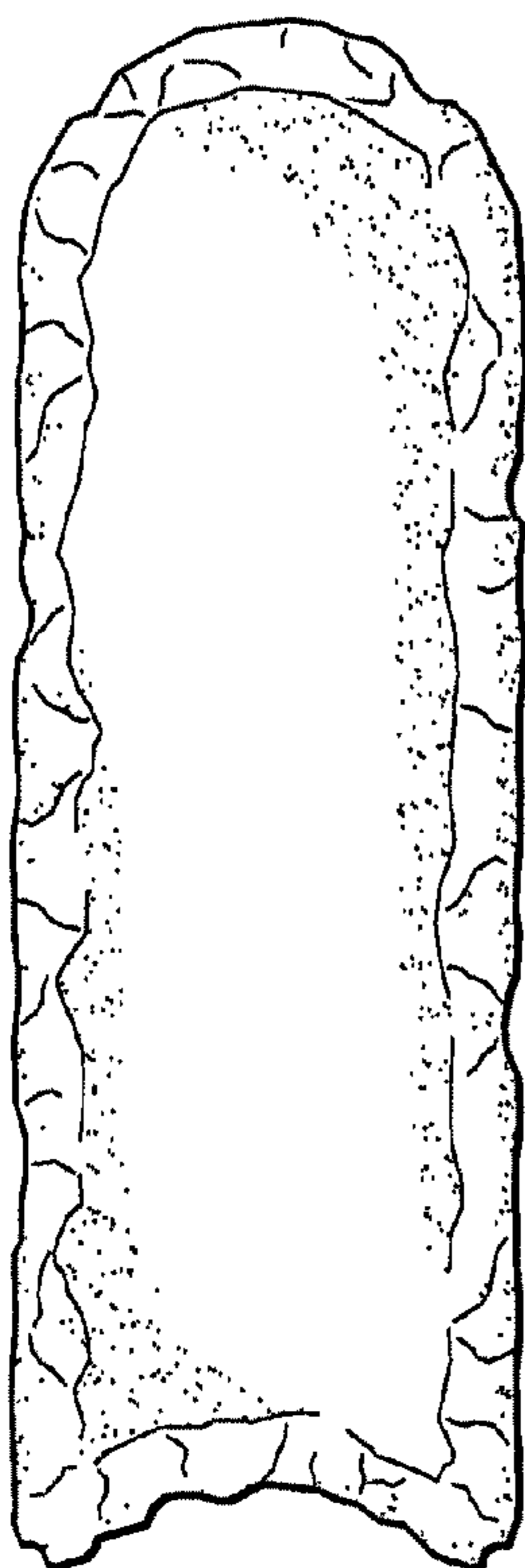

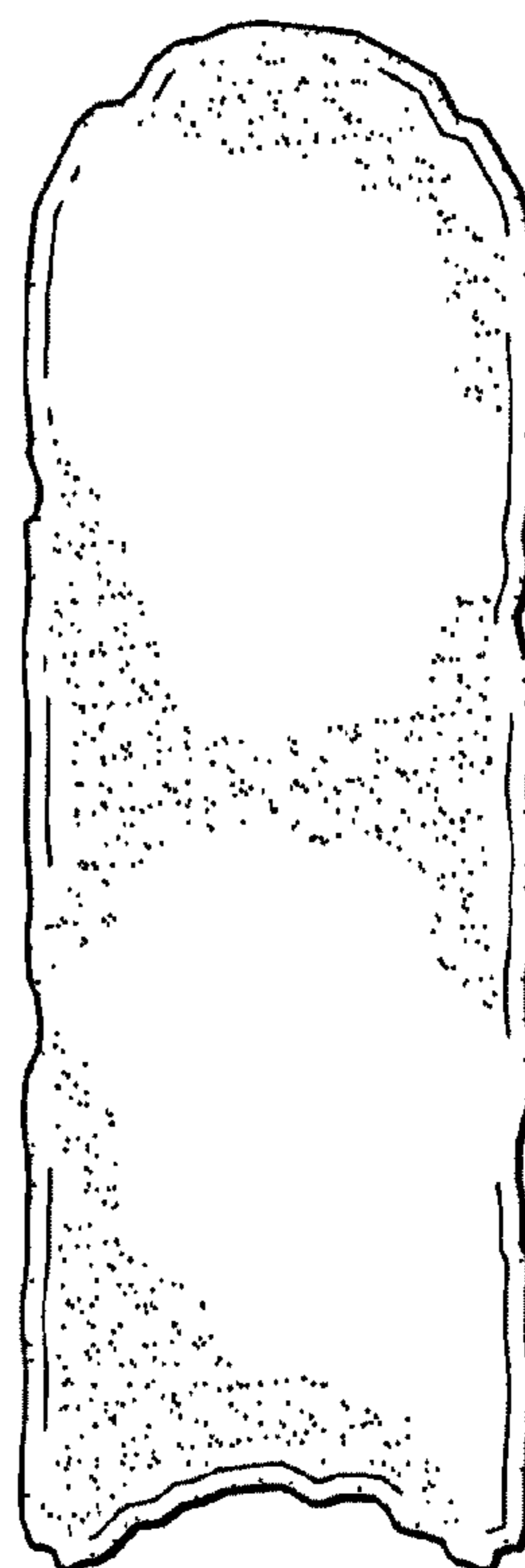
