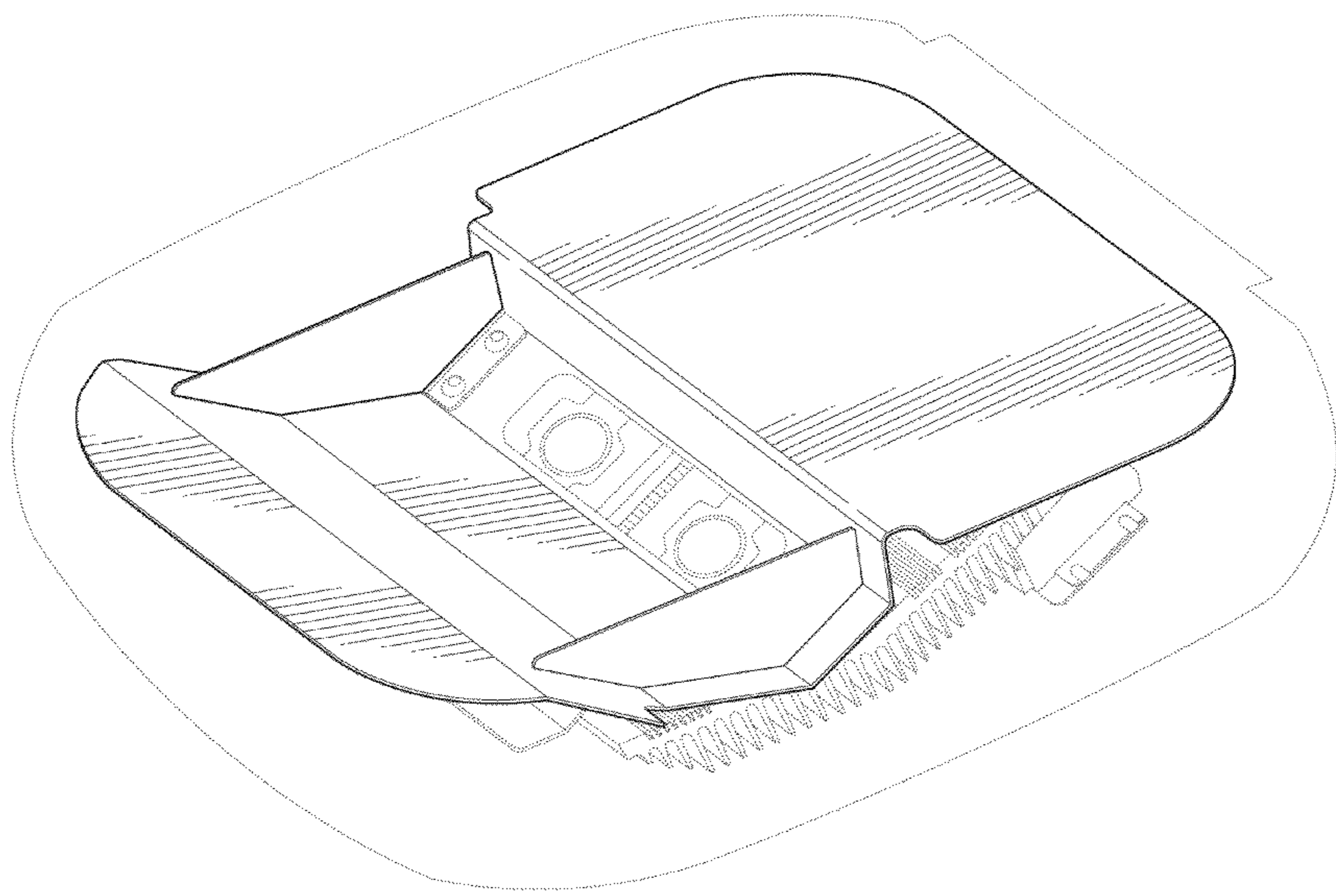

(57) **CLAIM**
I claim the ornamental design for a cover for a lighting unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cover for an overhead-type lighting unit;
FIG. 2 is another perspective view of the cover;
FIG. 3 is top view of the decorative cover;
FIG. 4 is a front view of the decorative cover, the rear view being a mirror image thereof;
FIG. 5 is a right end view as taken from FIG. 4;
FIG. 6 is a left end view as taken from FIG. 4; and,
FIG. 7 is a bottom view.

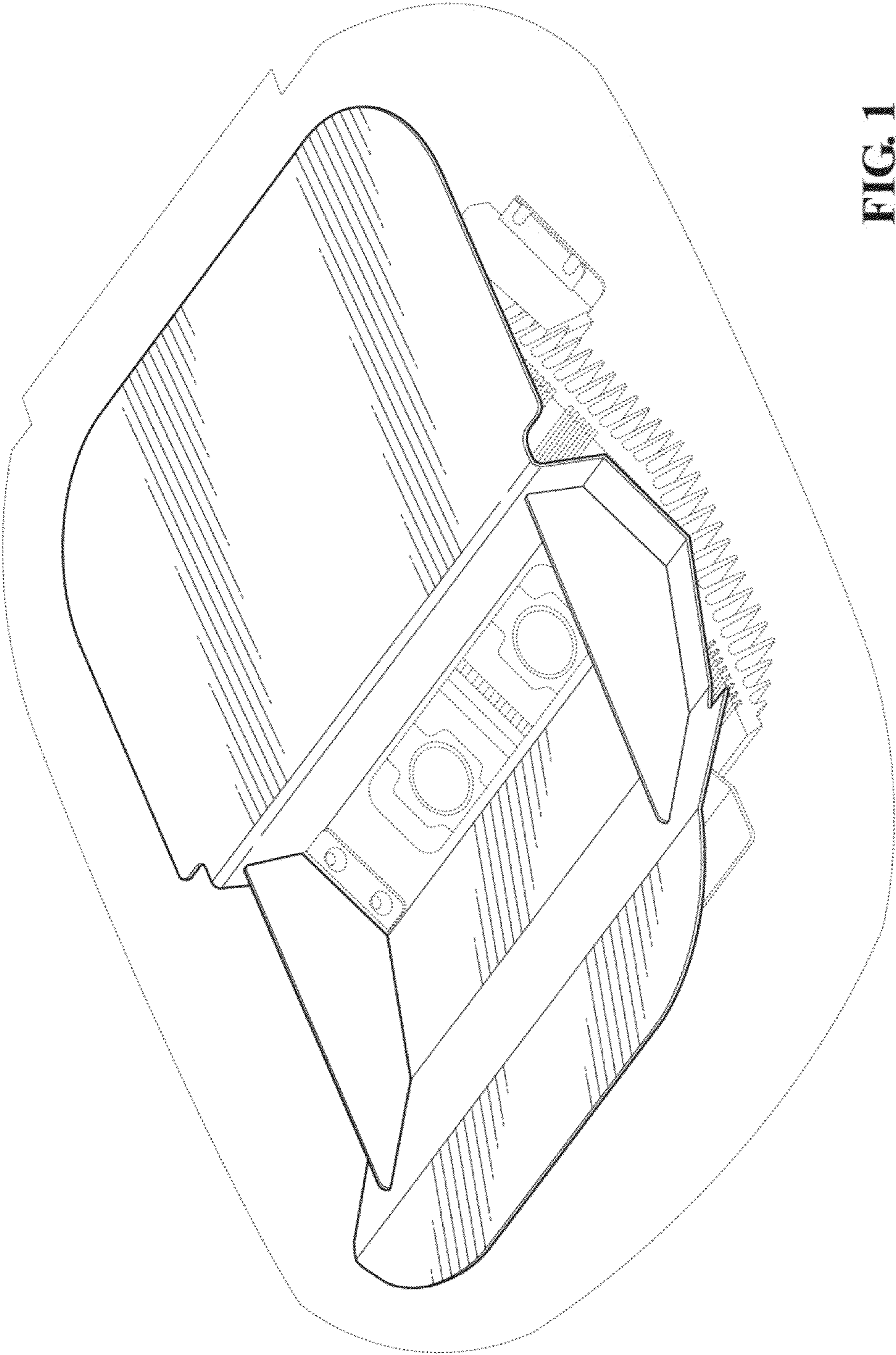

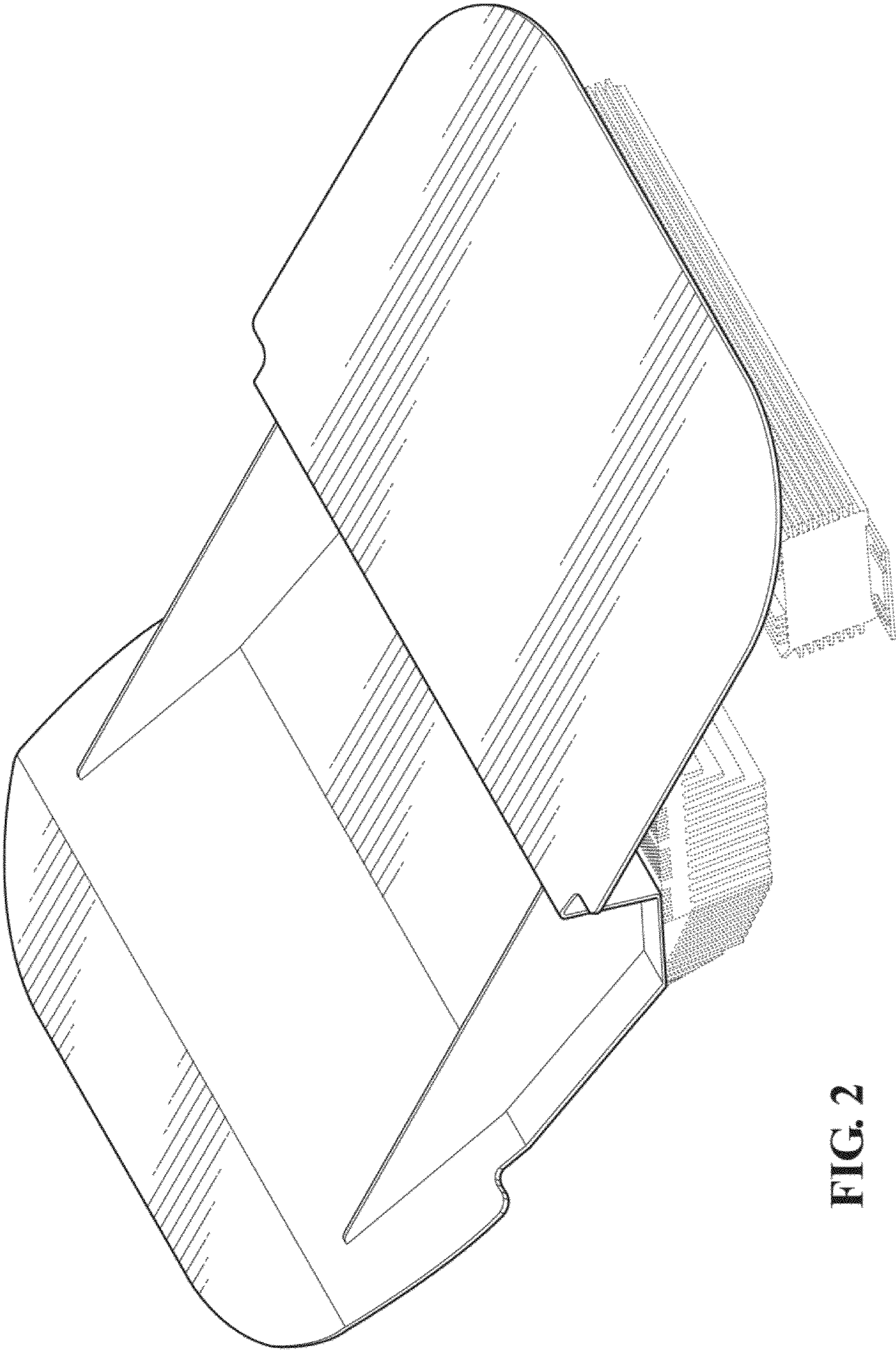

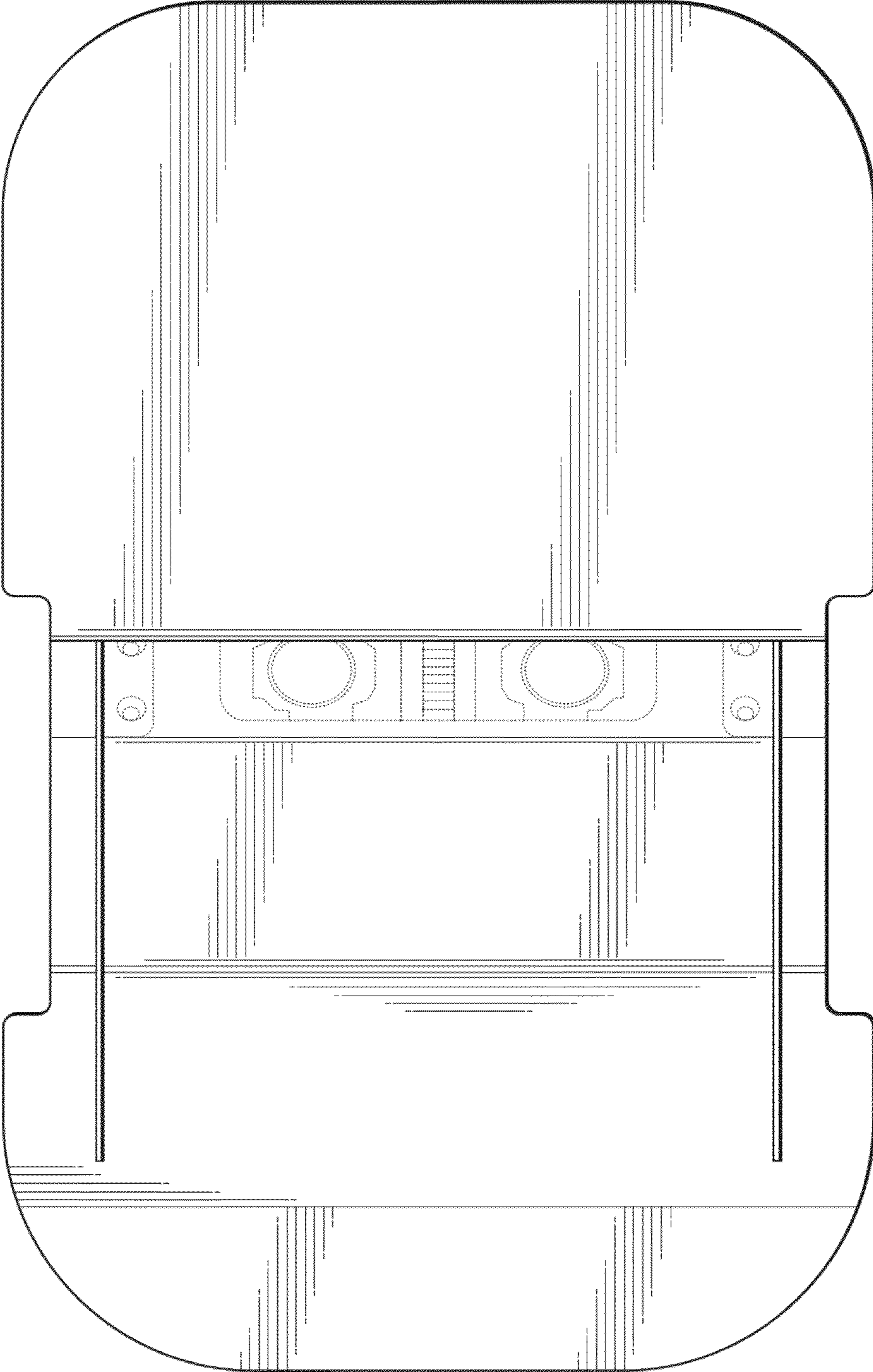

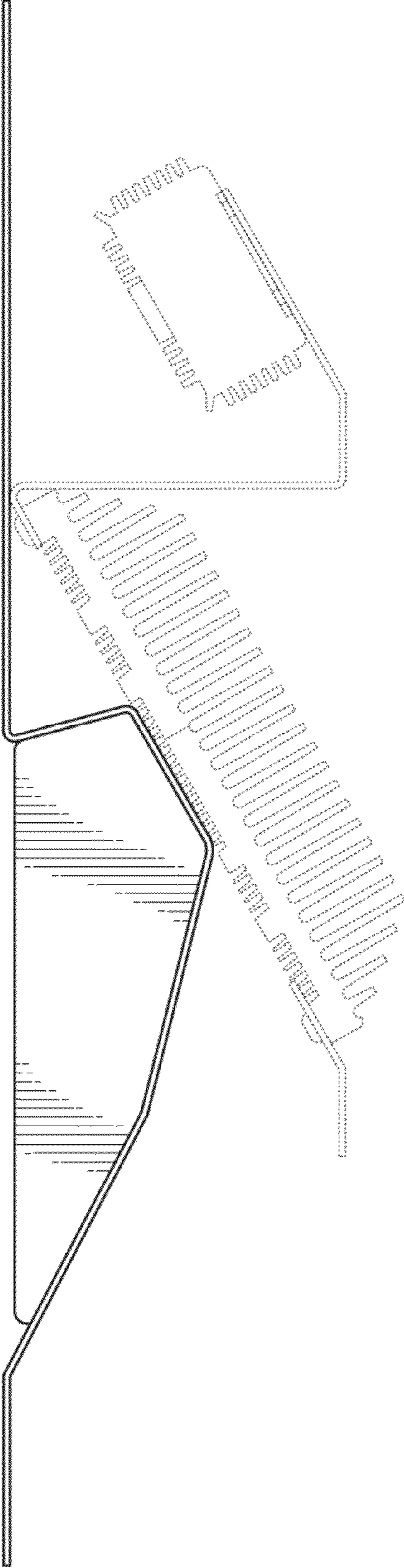

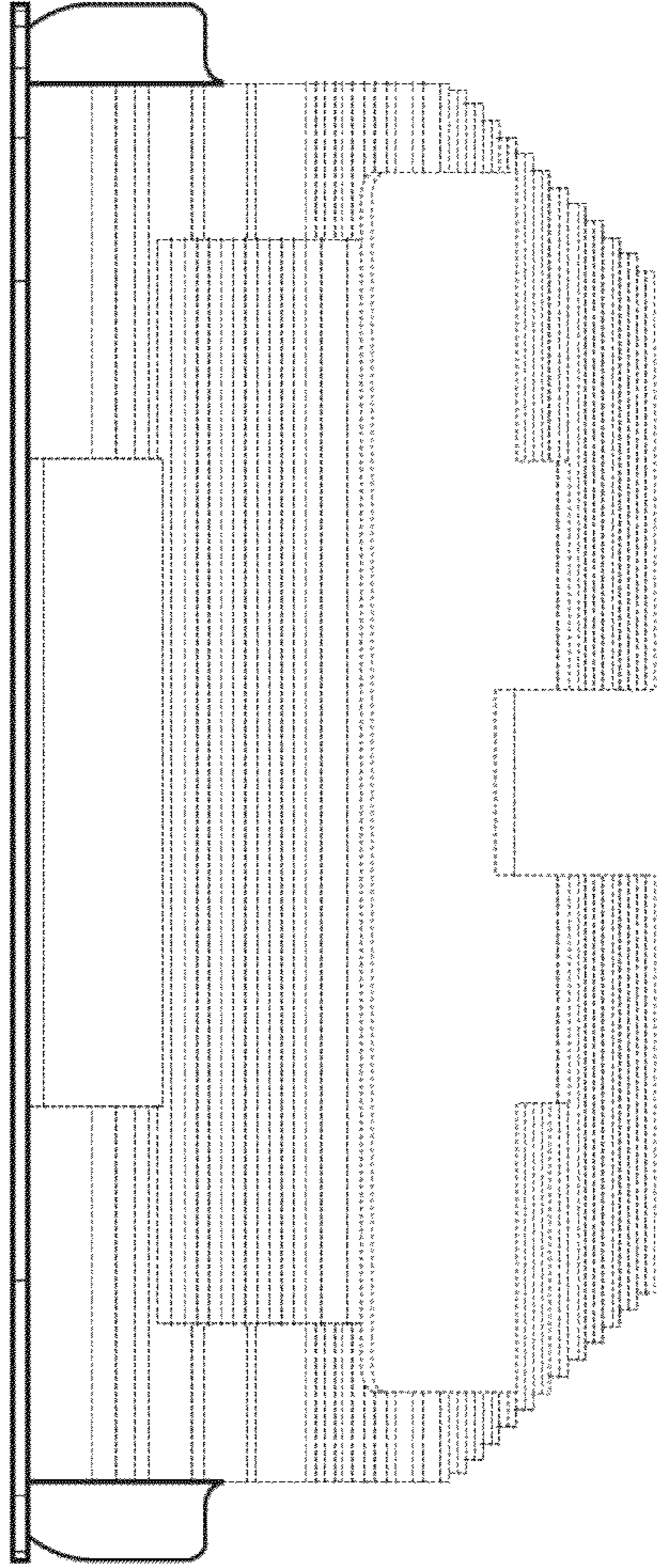

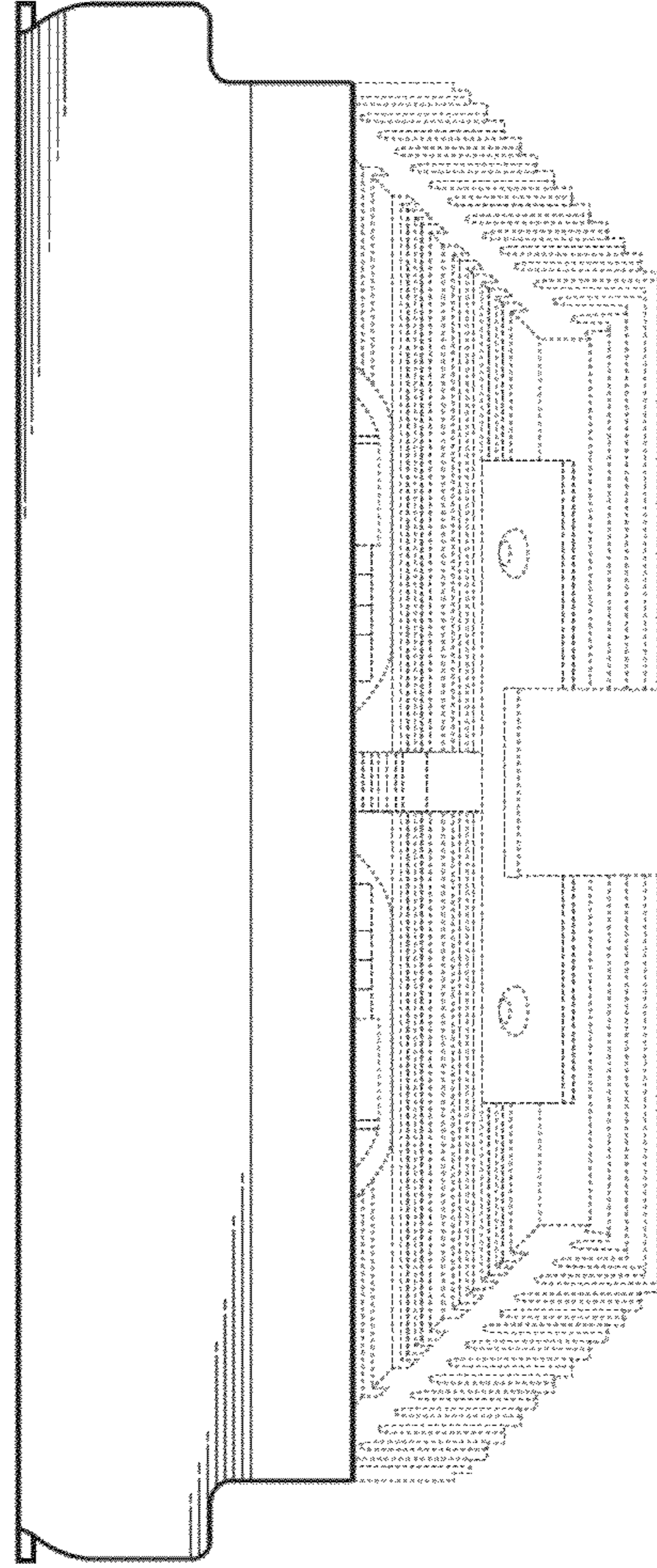

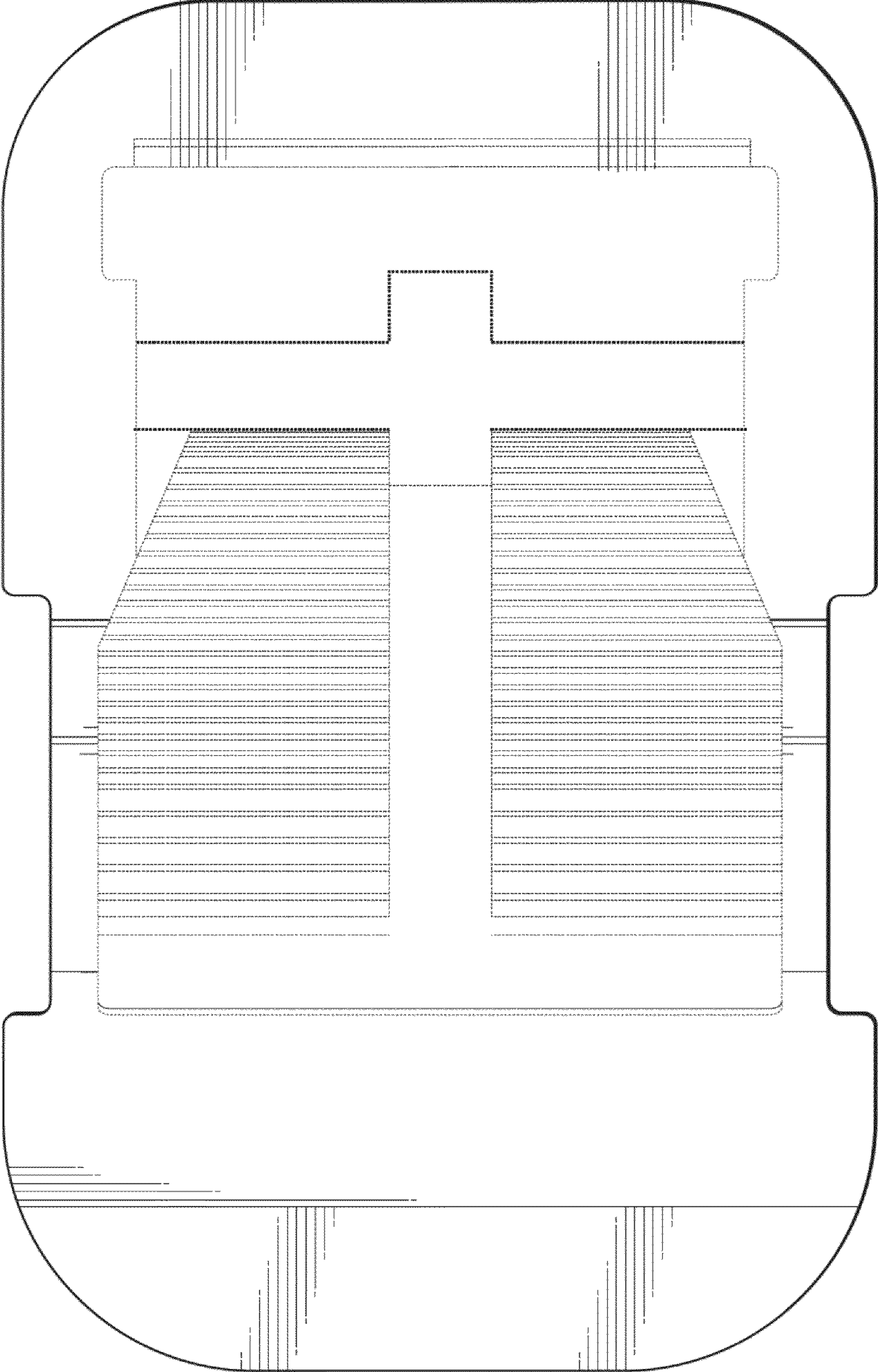
