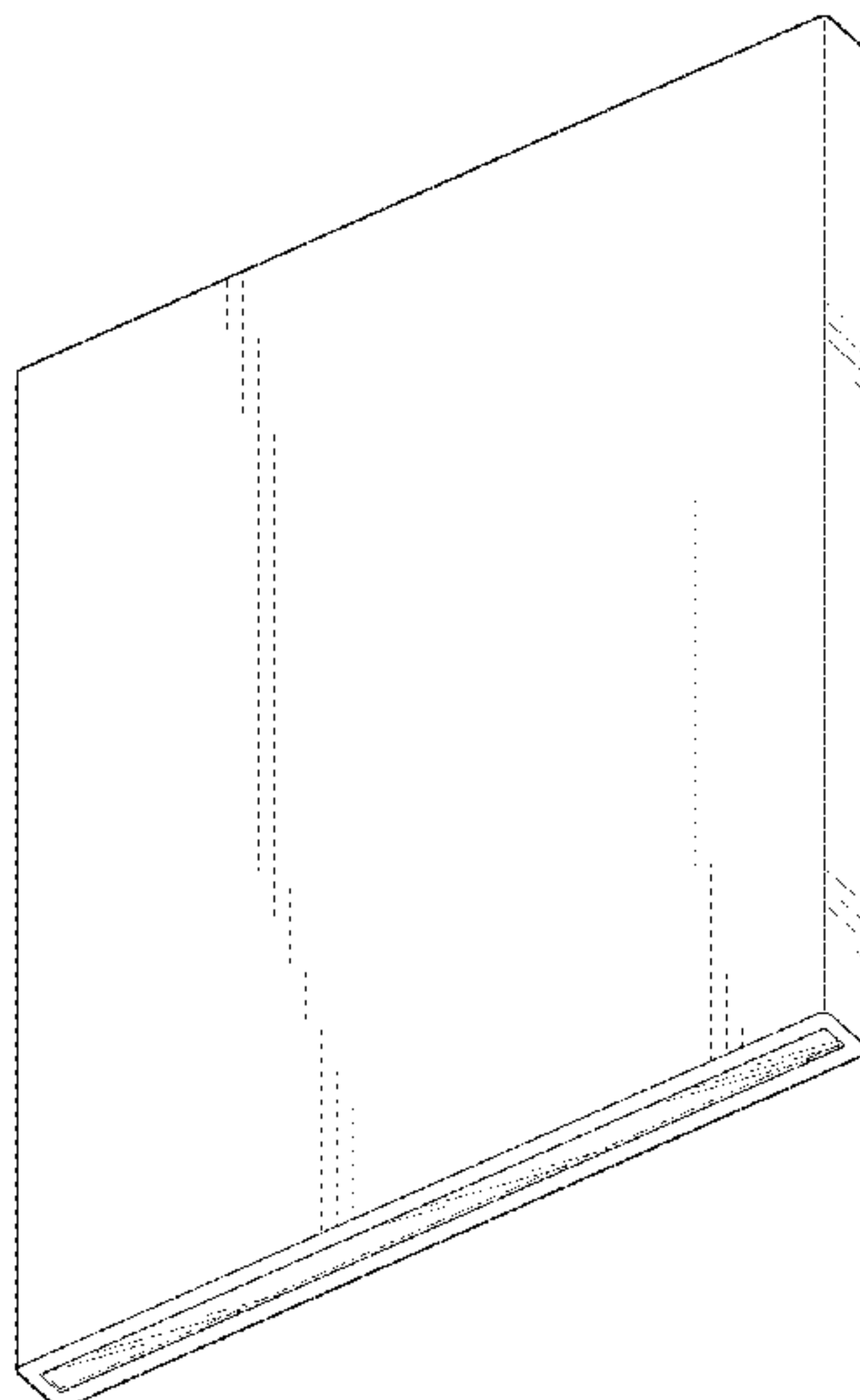
(57) **CLAIM**

The ornamental design for a lighted dishwasher door, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a lighted dishwasher door according to a first embodiment showing our new ornamental design; FIG. 2 is a front view thereof; FIG. 3 is a cross sectional view of the door shown in FIG. 2; FIG. 4 is an enlarged view of the detail shown in FIG. 3; FIG. 5 is a front view of a lighted dishwasher door and recessed kick plate according to a second embodiment showing our new ornamental design; FIG. 6 is a front view thereof; FIG. 7 is a cross sectional view of the door taken in FIG. 6; and, FIG. 8 is an enlarged view of the detail shown in FIG. 7. The broken line showing of a dishwasher compartment in FIGS. 5 and 7 is included for the purpose of showing environmental portions of the lighted dishwasher door and forms no part of the claimed design. The radiating broken lines in FIGS. 3, 4, 7 and 8 represent one or more light beams and form no part of the claimed design. The rear of the dishwasher door, and the bottom, sides, rear and/or top of the dishwasher door and compartment that are not shown are unornamented or simply not claimed and form no part of the claimed design.

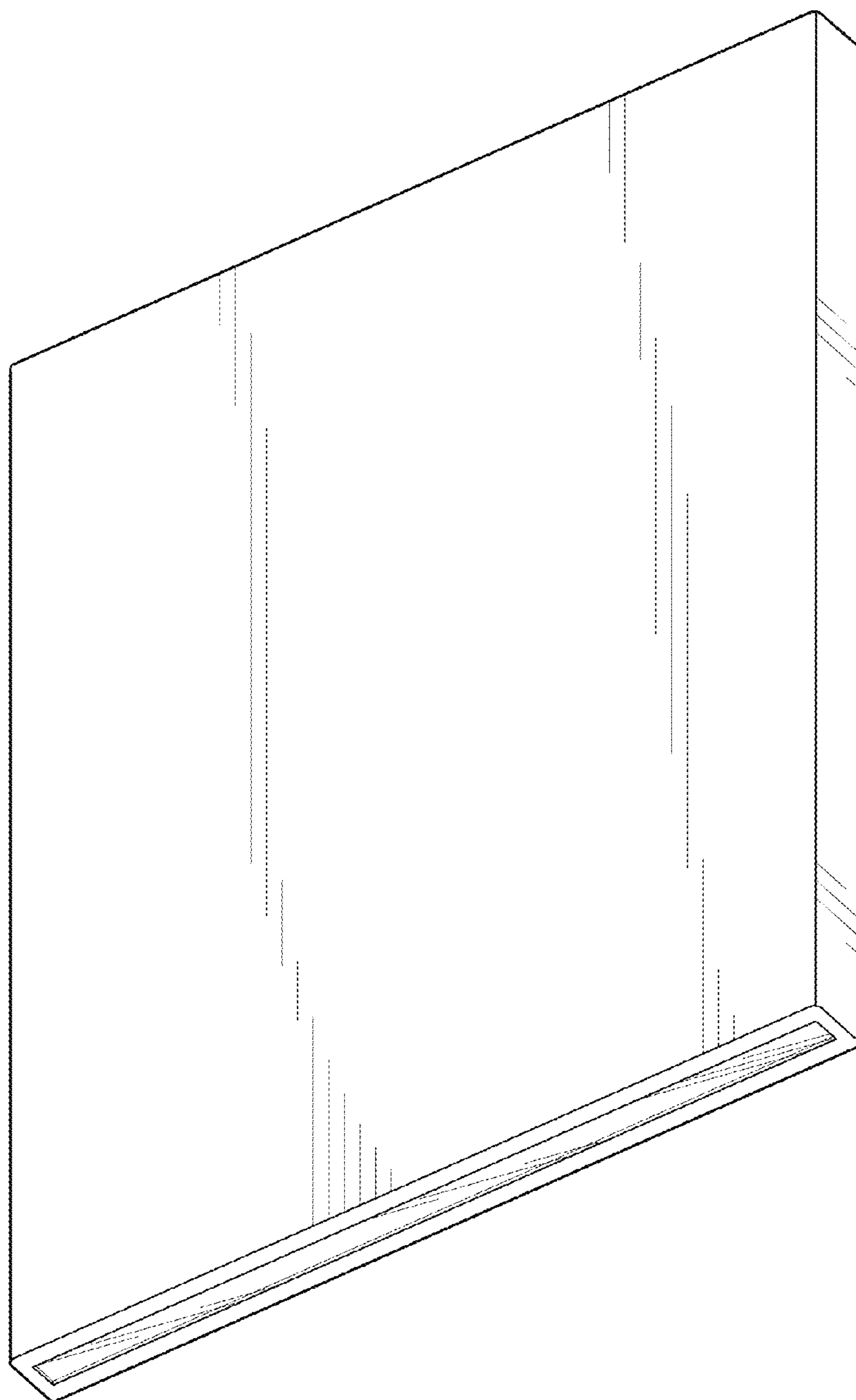

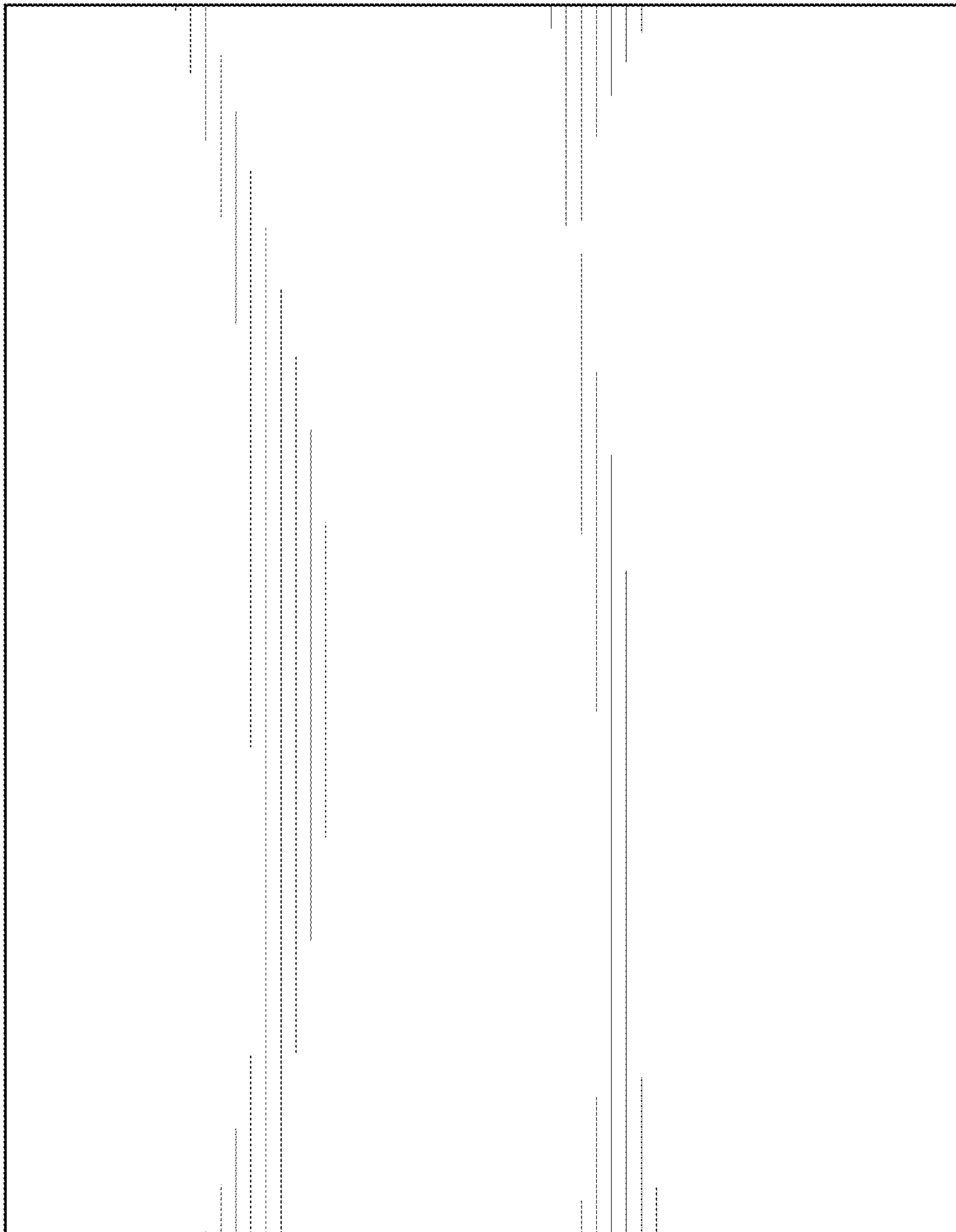

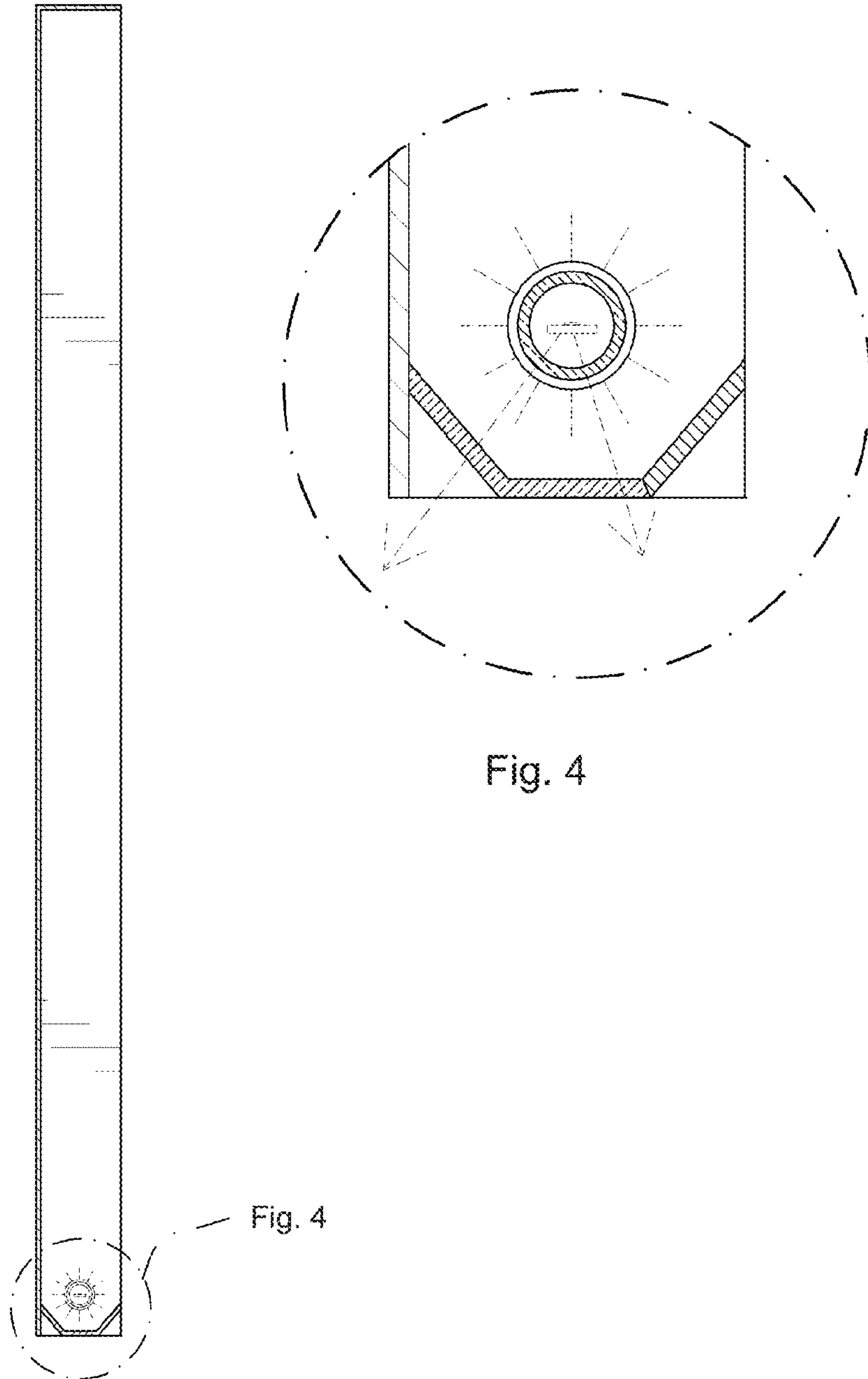

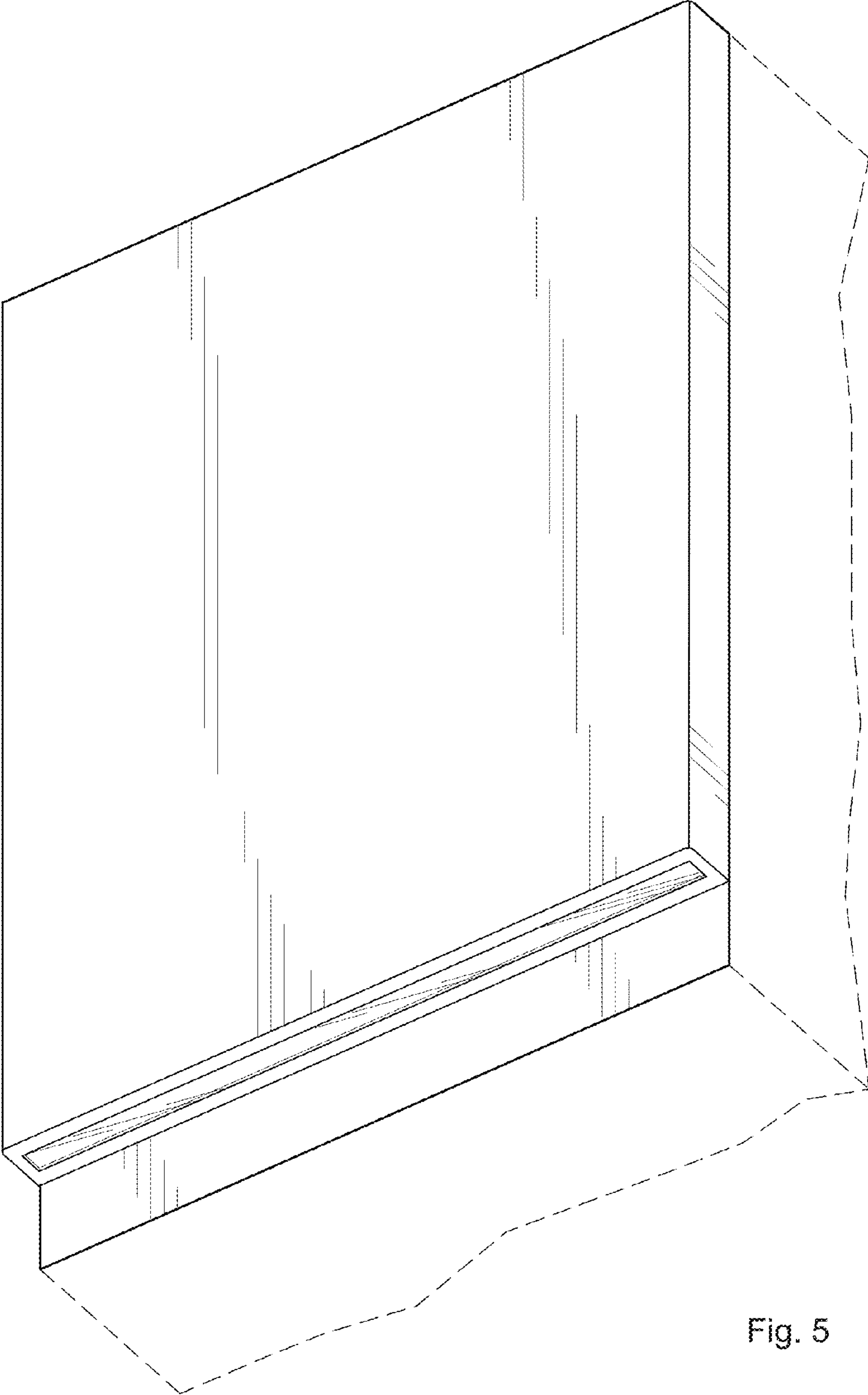

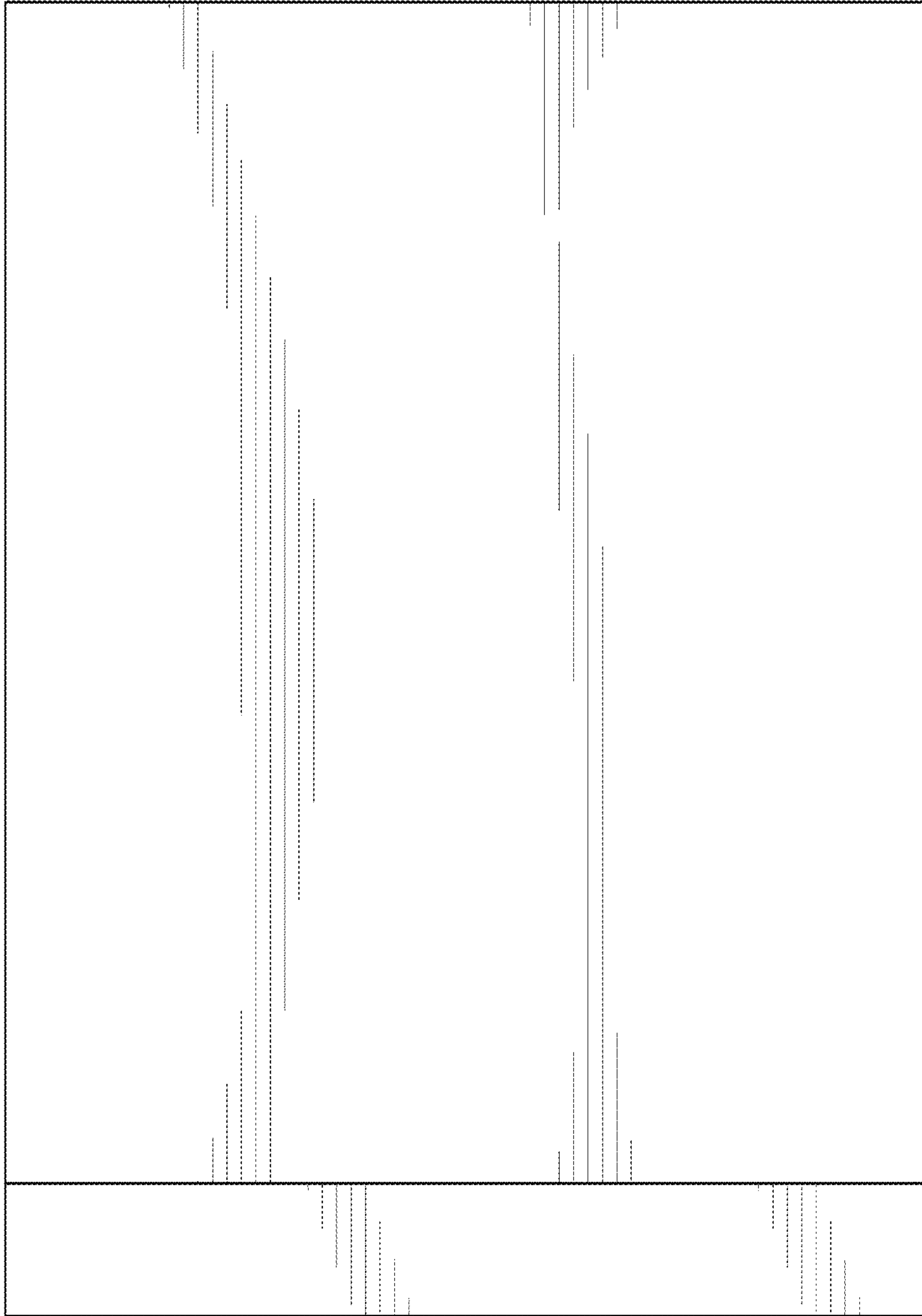

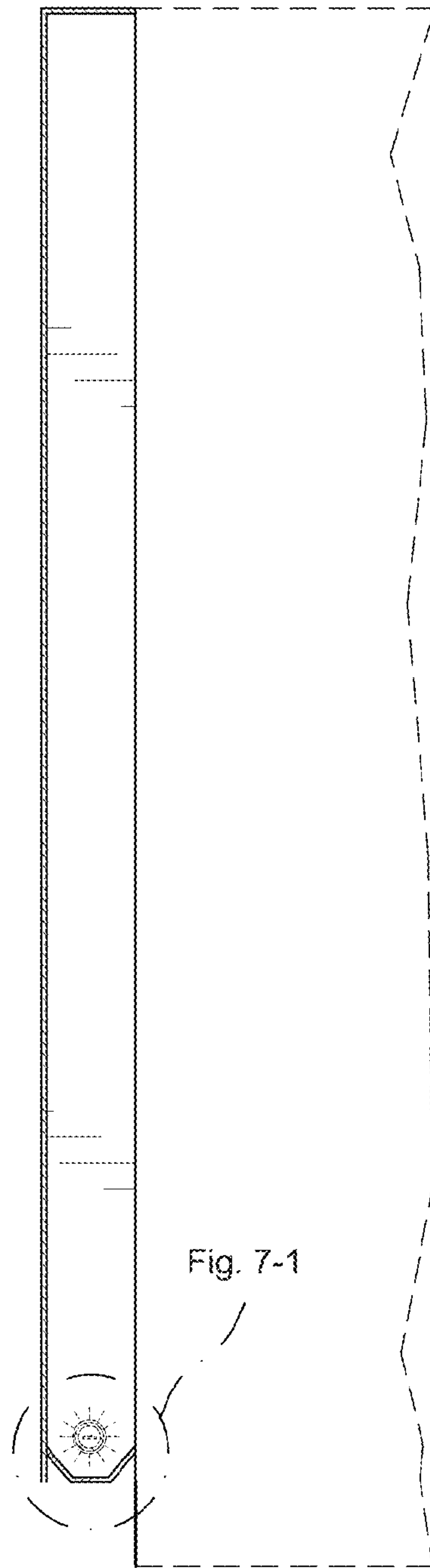
