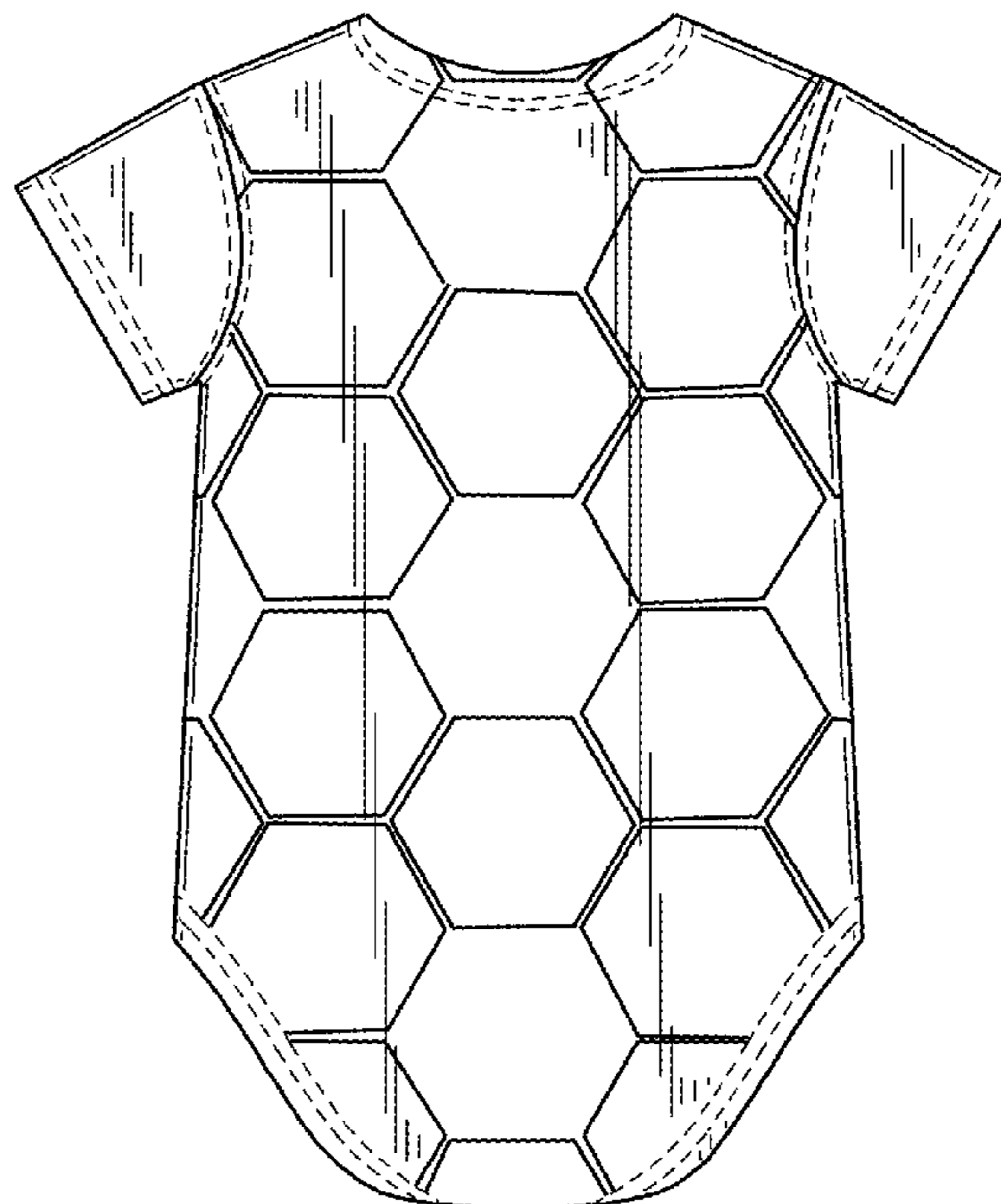
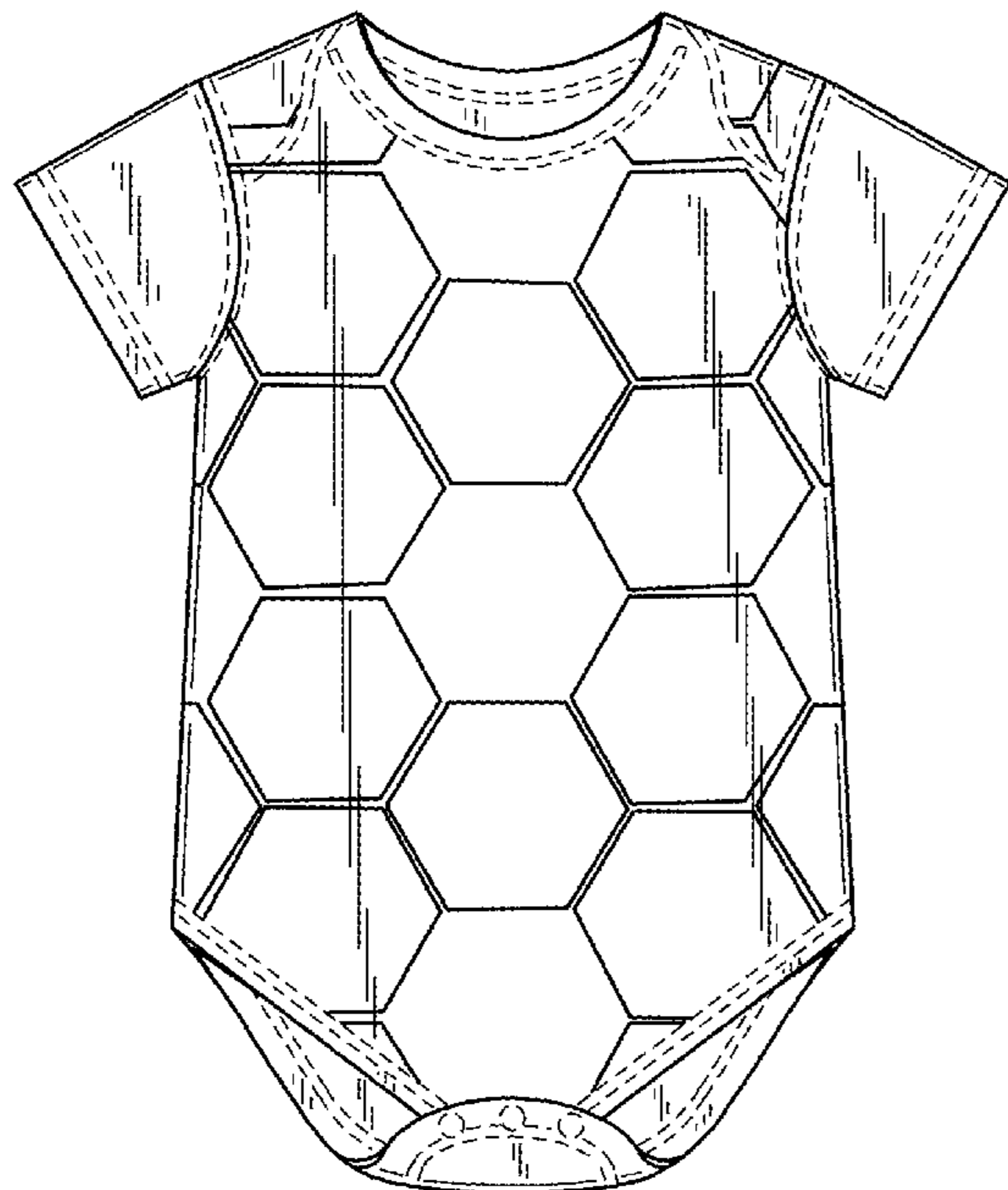
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an isometric view of an soccer ball infant bodysuit, showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof, with the opposite side view being a mirror image thereof;  
FIG. 5 is a top plan view thereof; and,

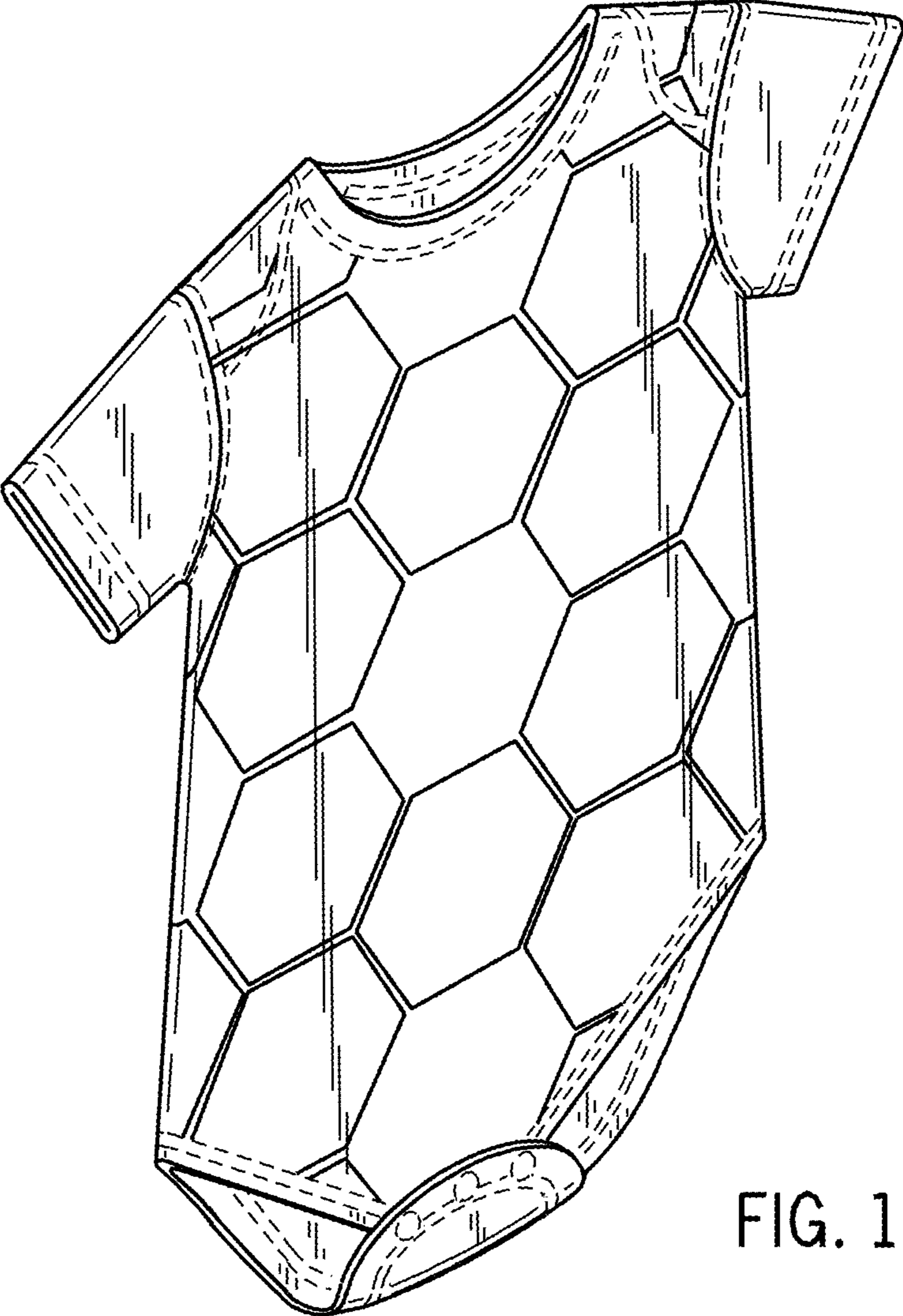

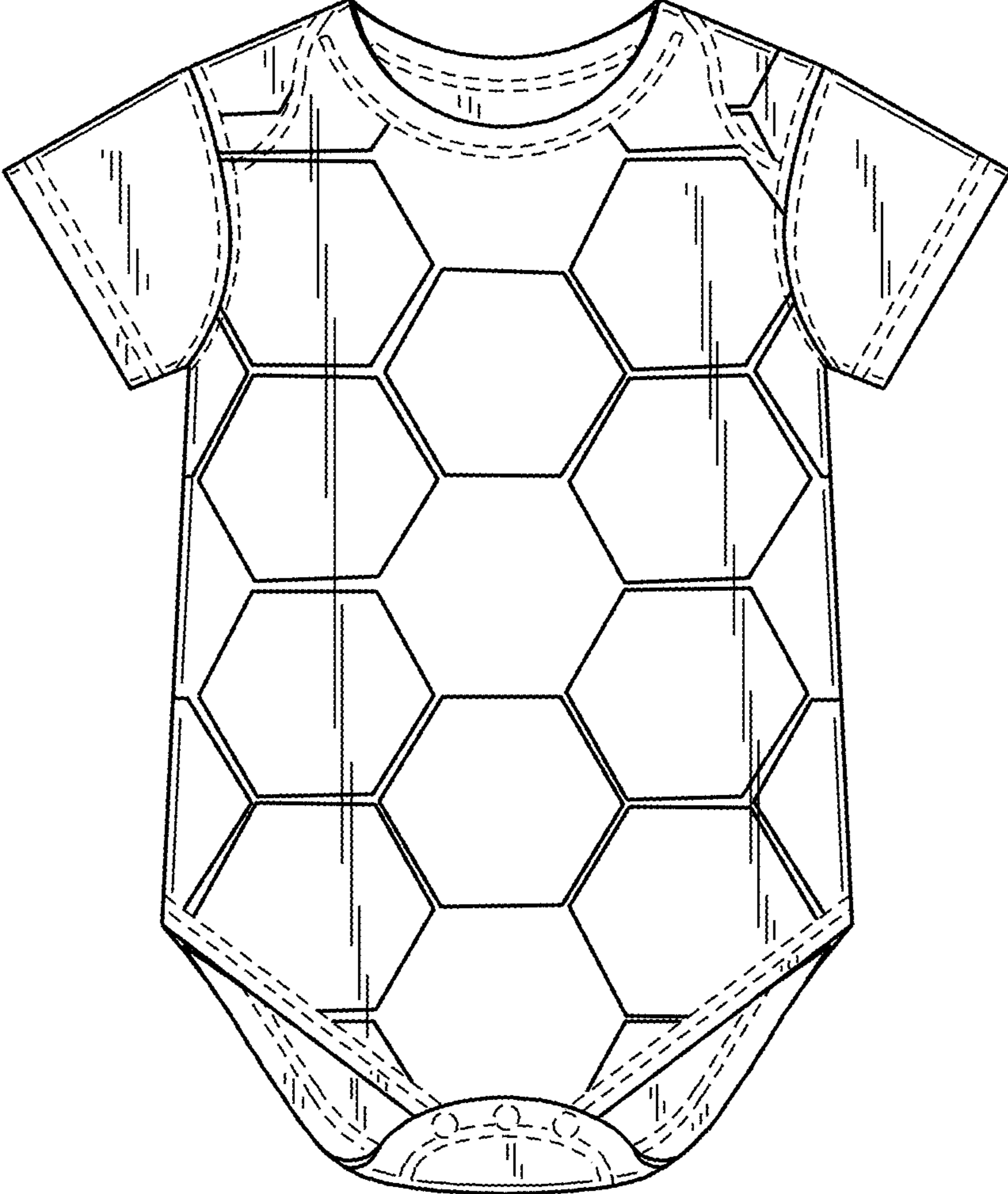

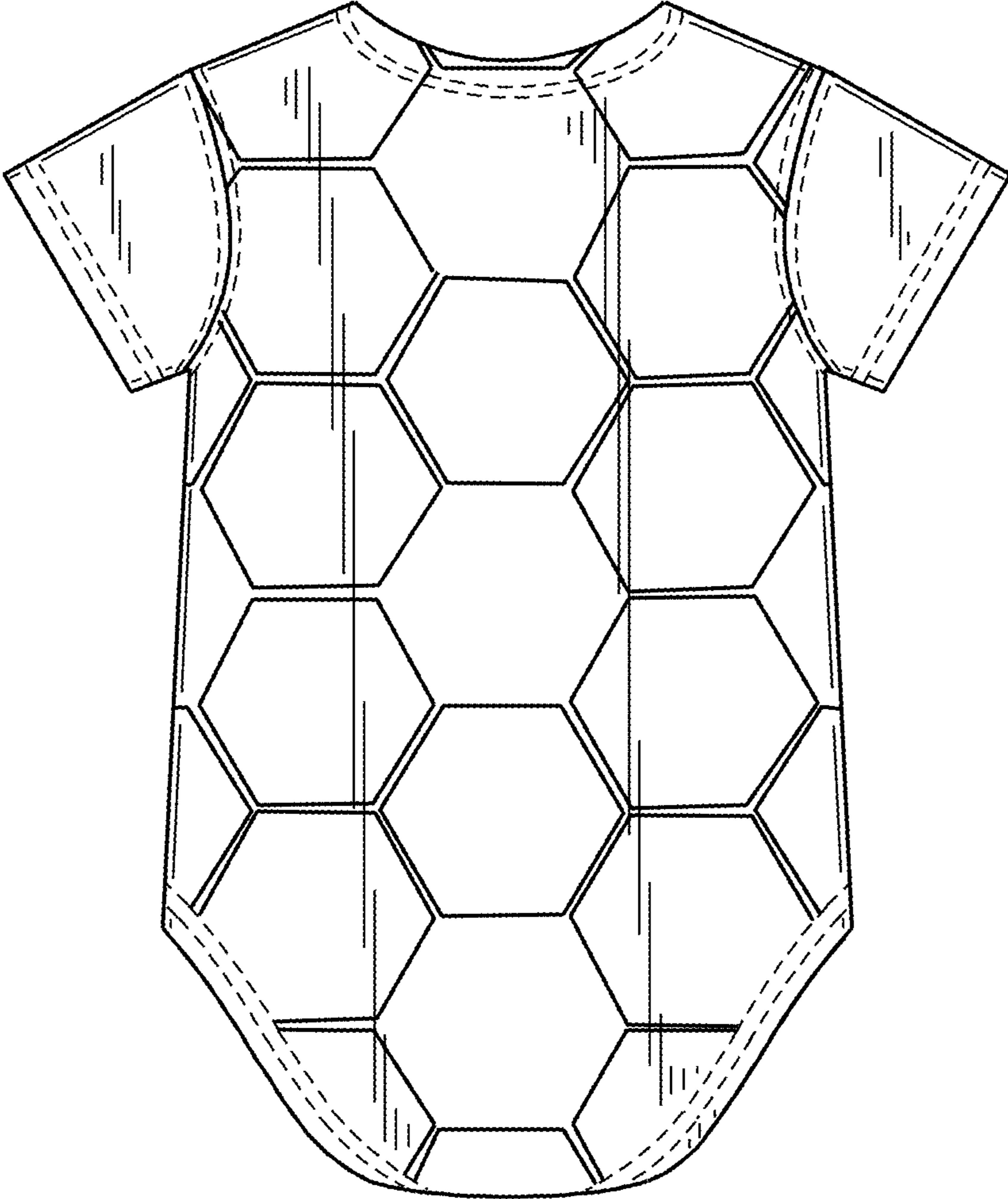

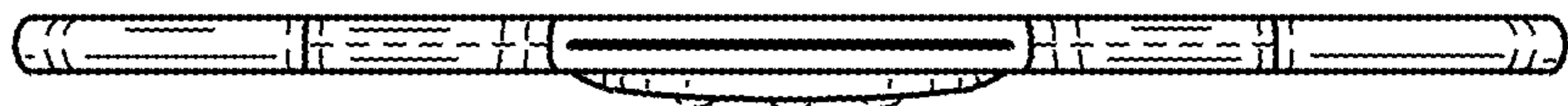

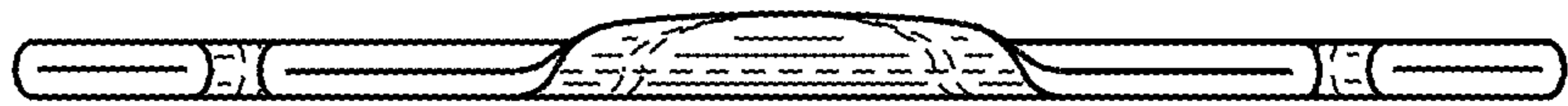
