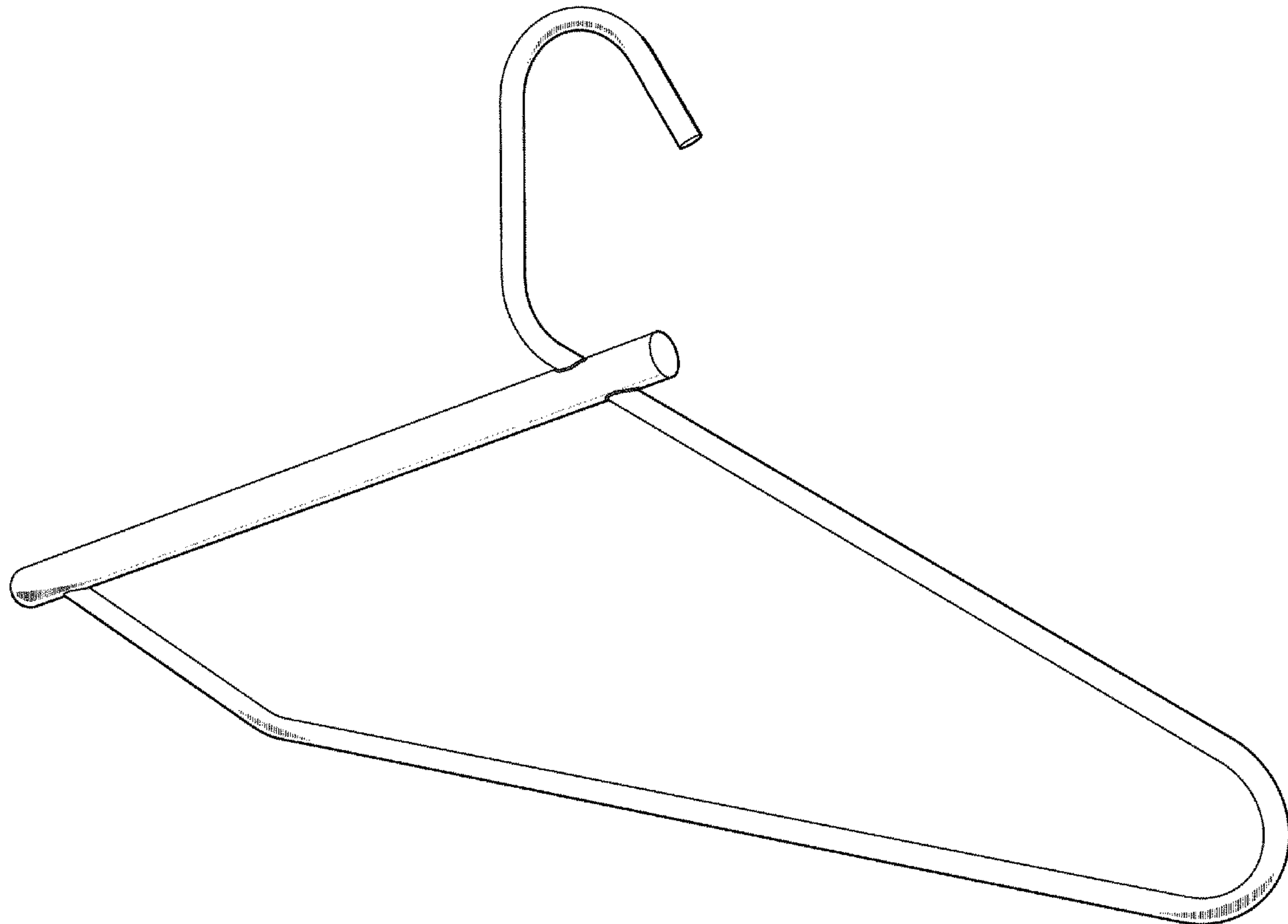
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective front quarter view of the balance clothes hanger;

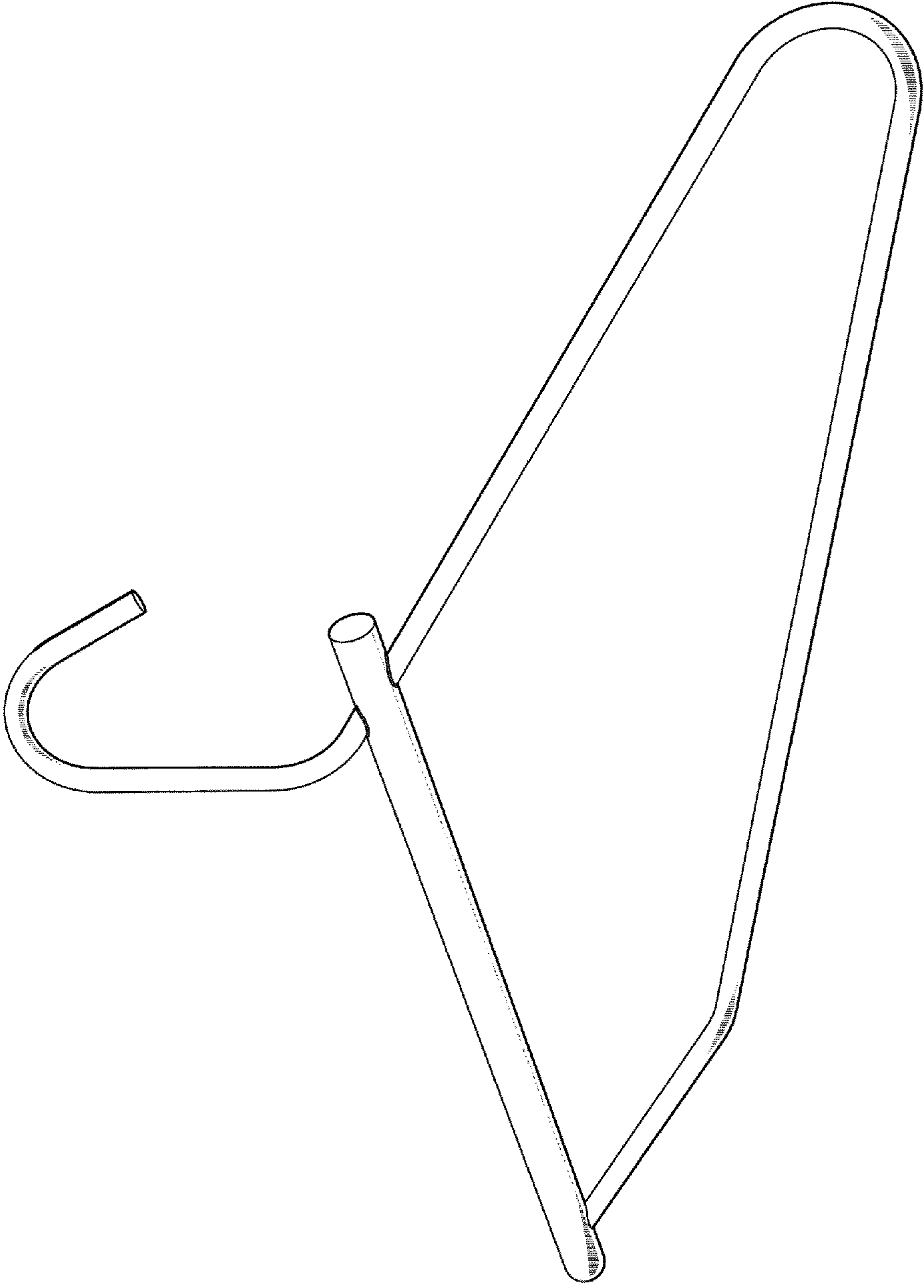

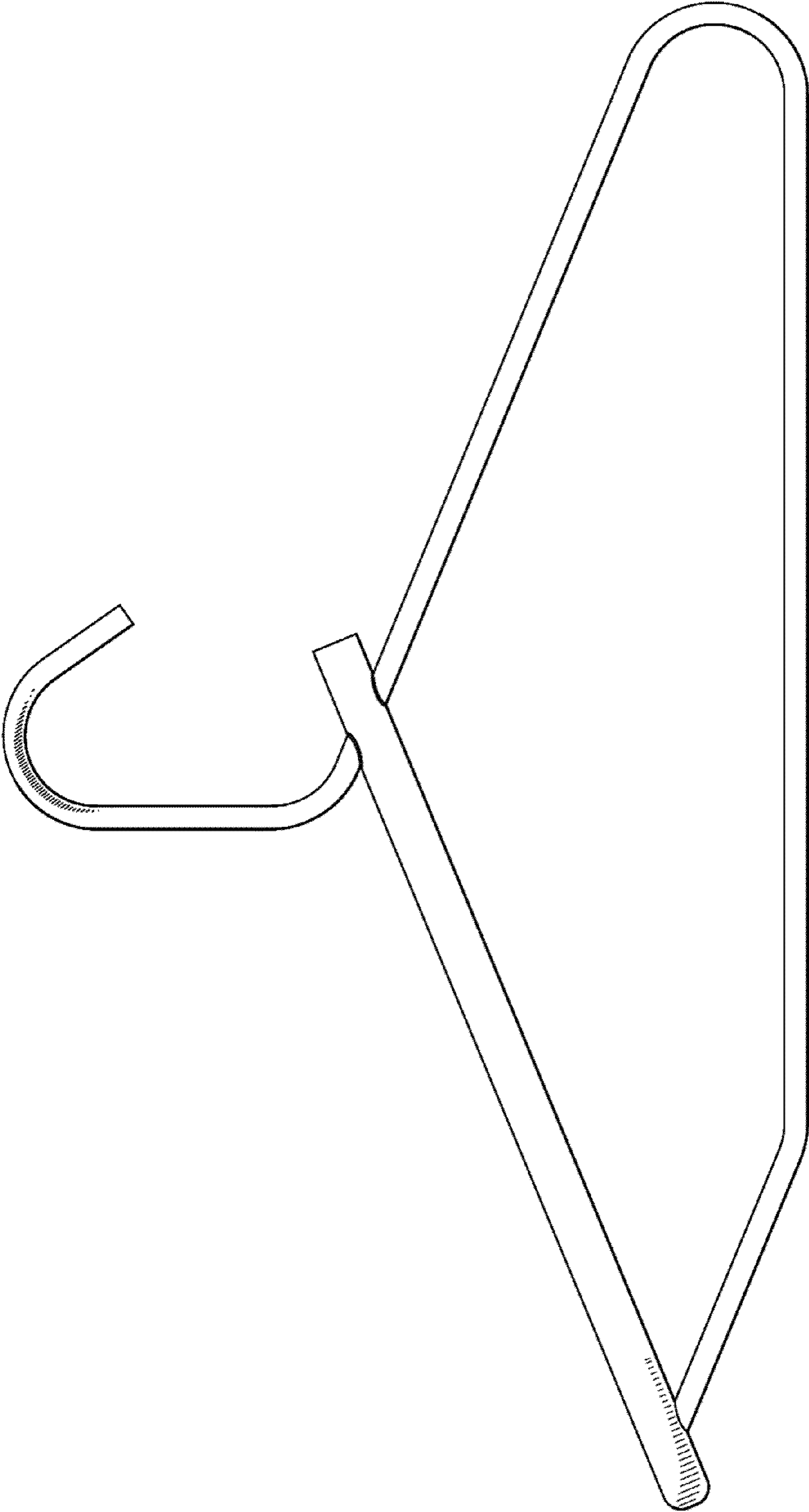

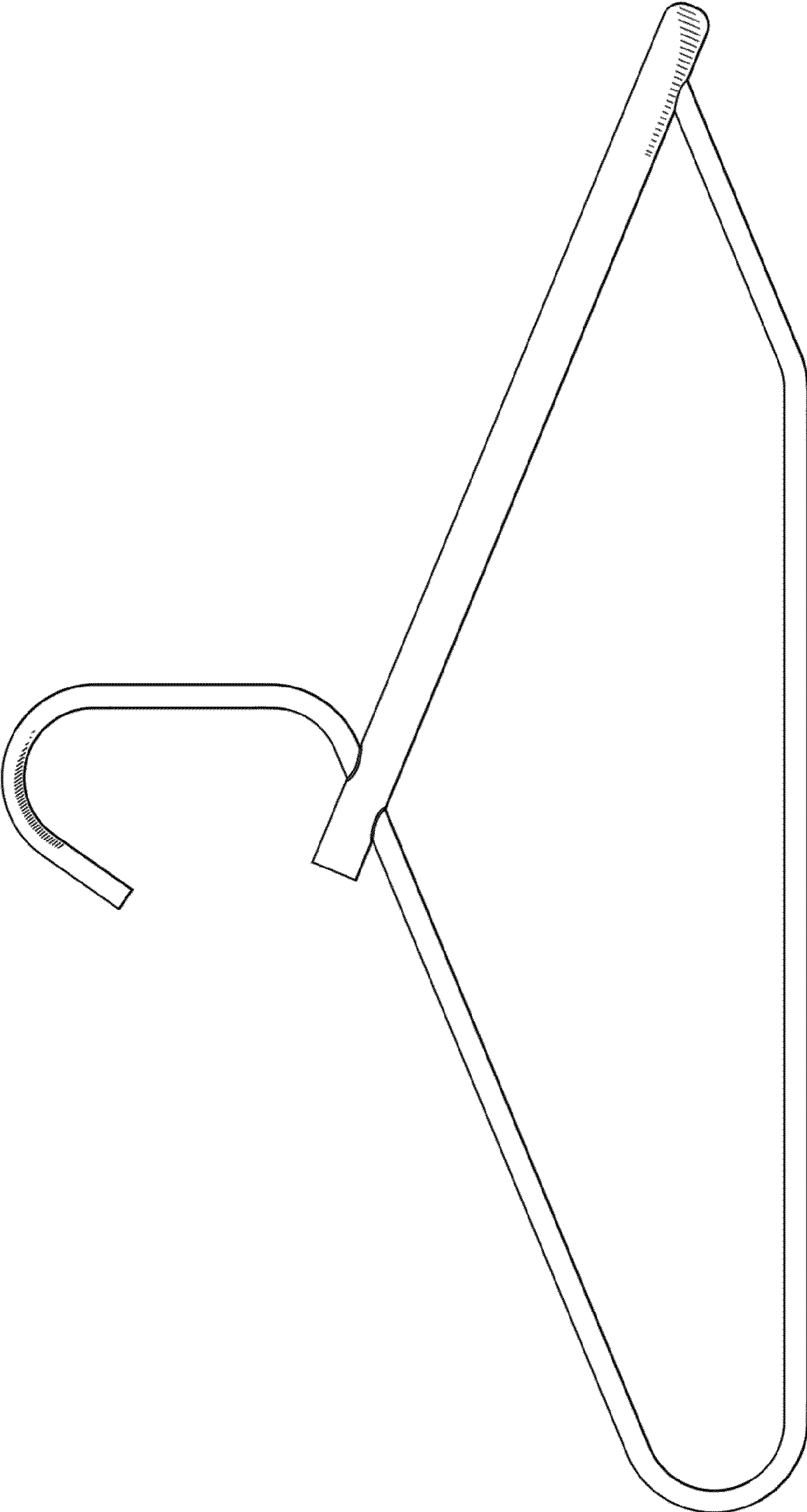
