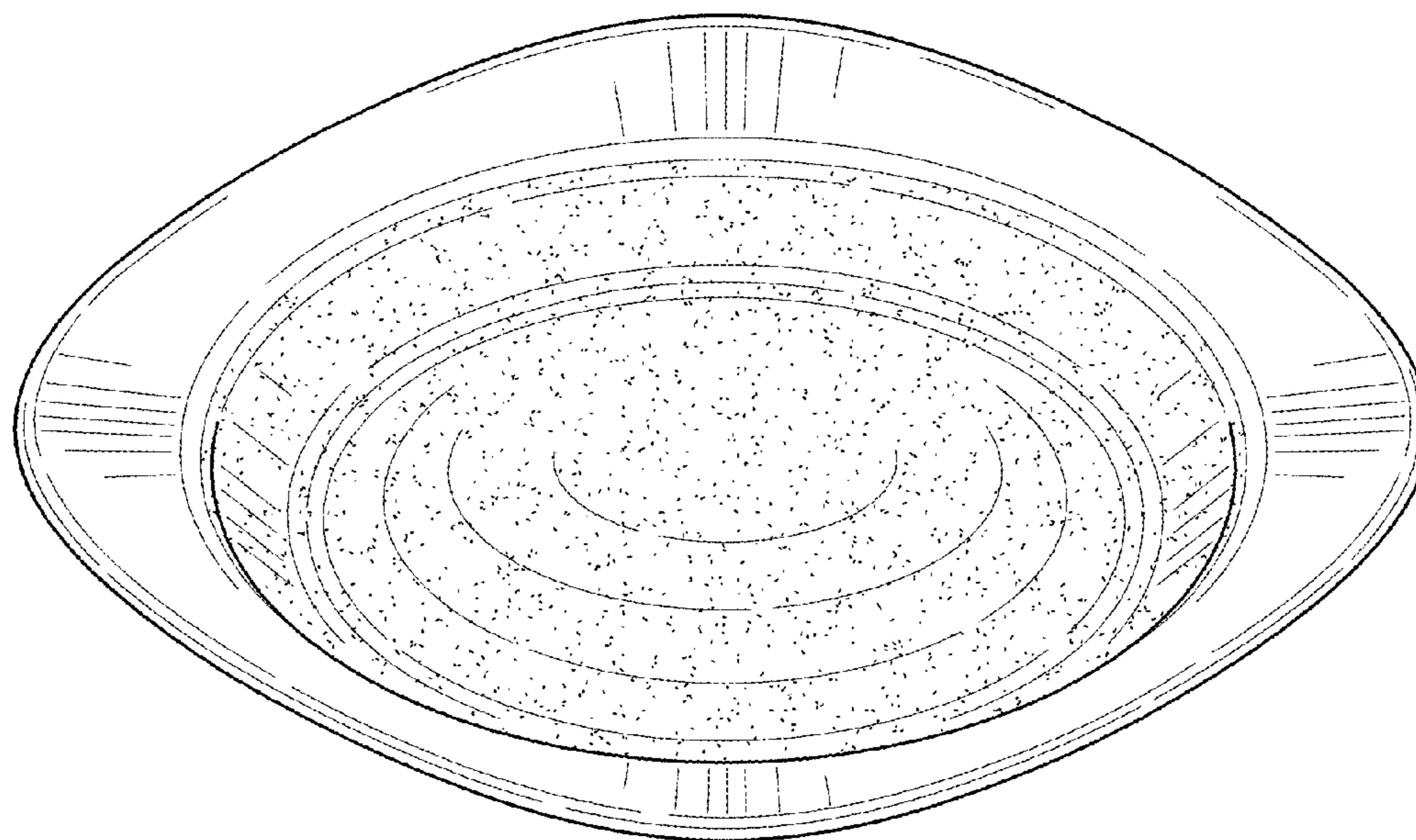
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top, front perspective view showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevation view, the rear elevation being identical thereto;  
FIG. 5 is a right side elevation view, the left side being identical thereto; and,

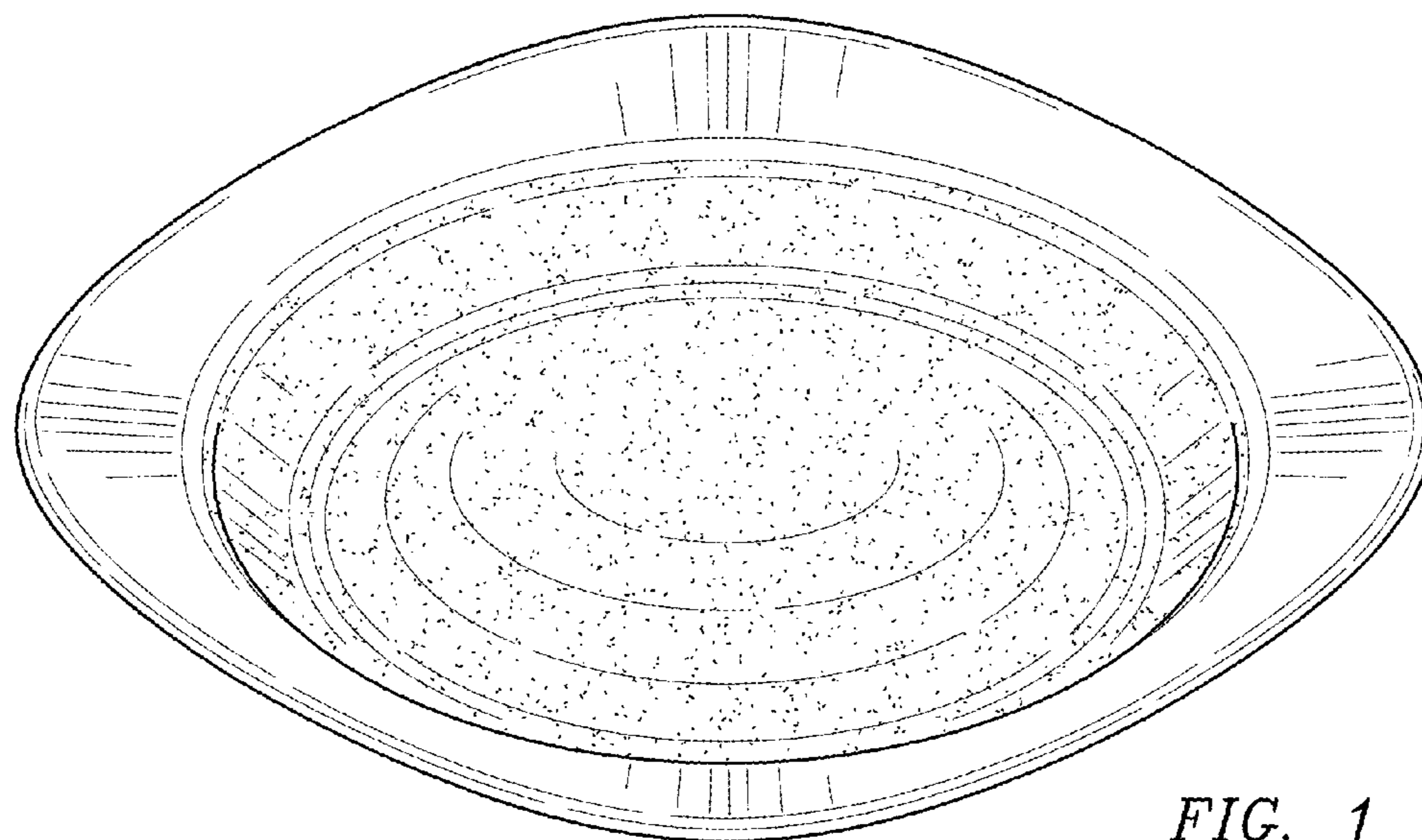

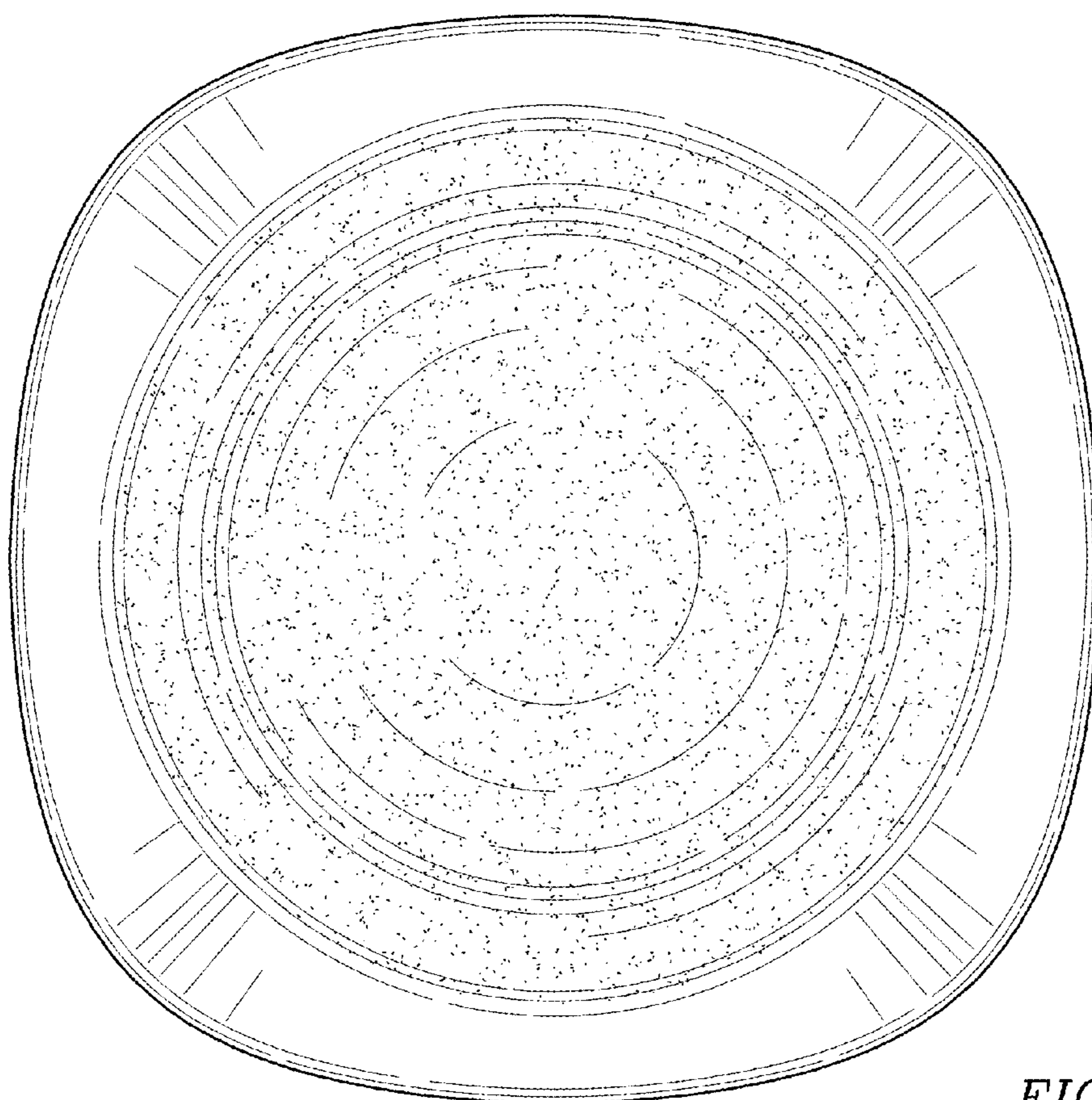
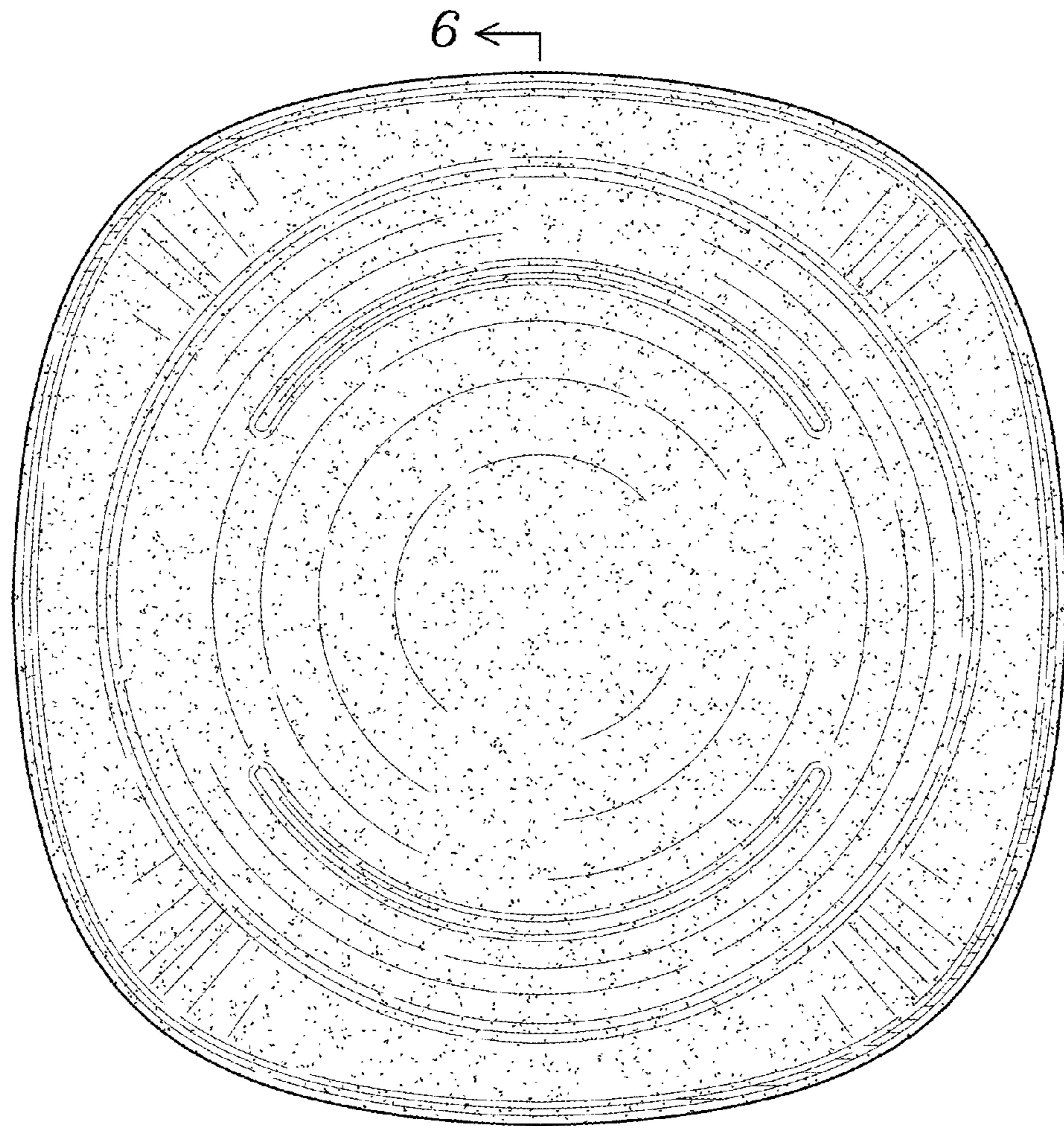

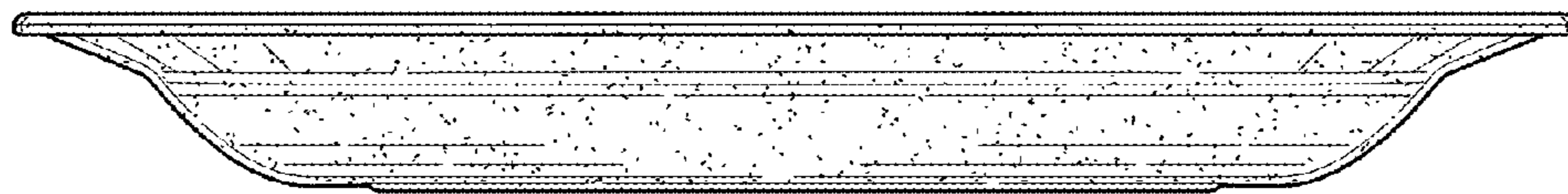

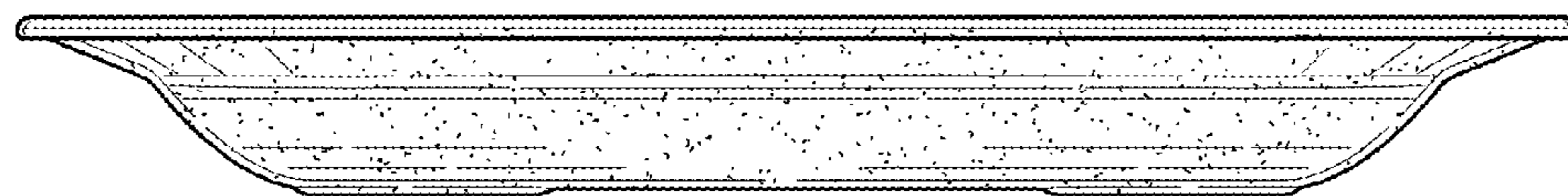
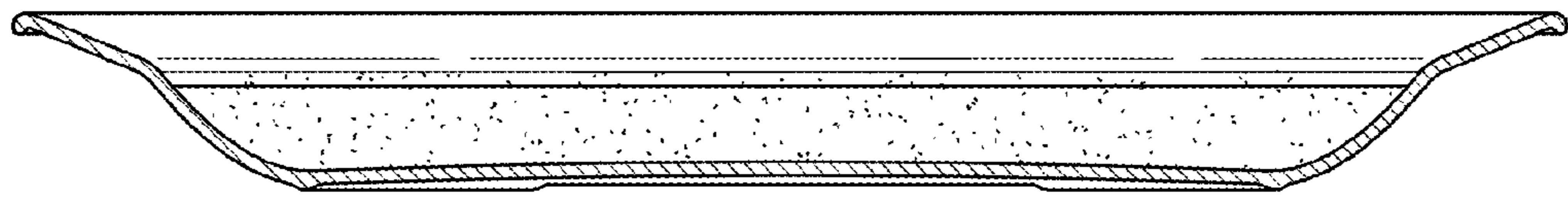
