FIG. 4 is a bottom view of the package of FIG. 1.

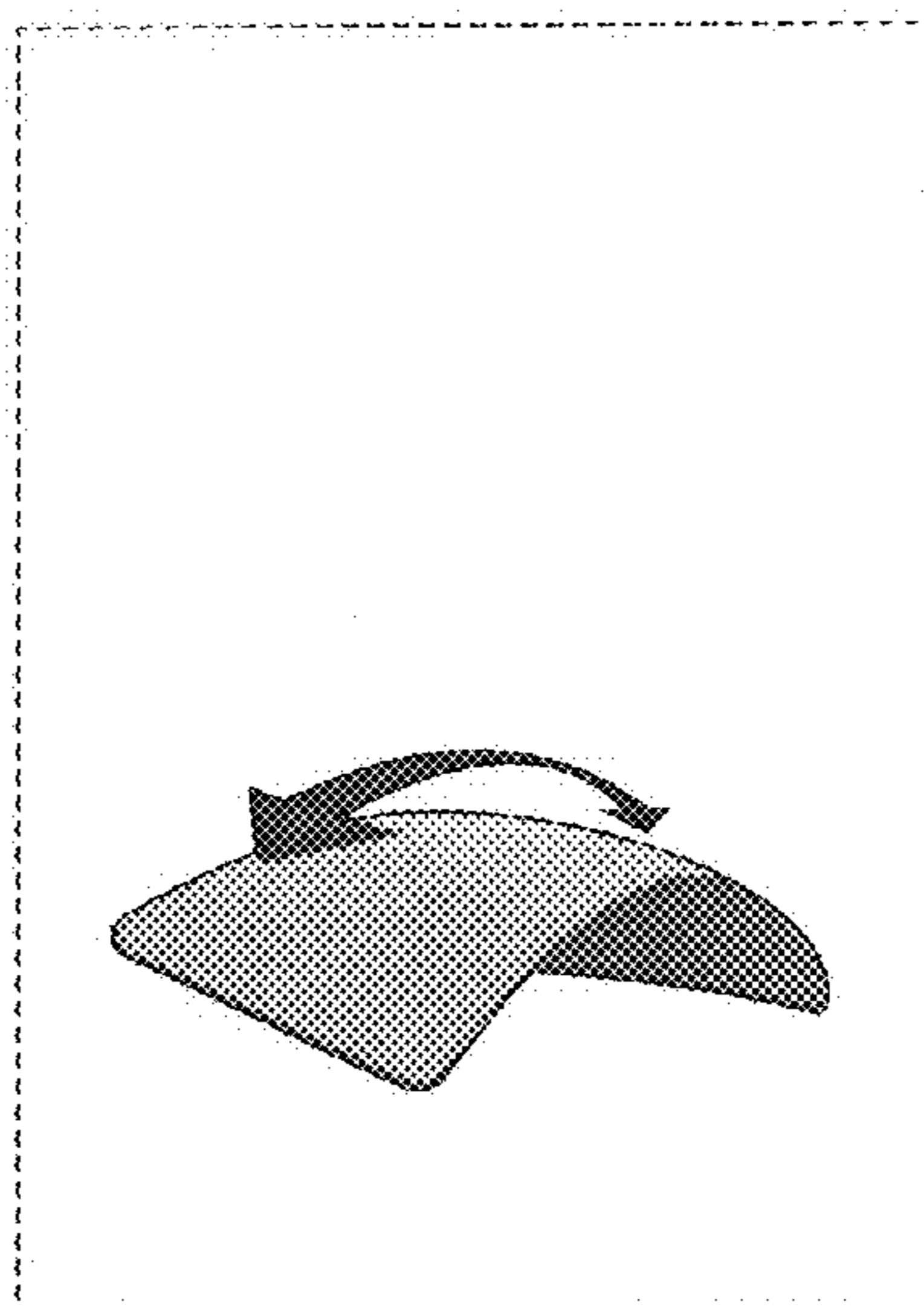
FIG. 5 is a right side view of the package of FIG. 1.

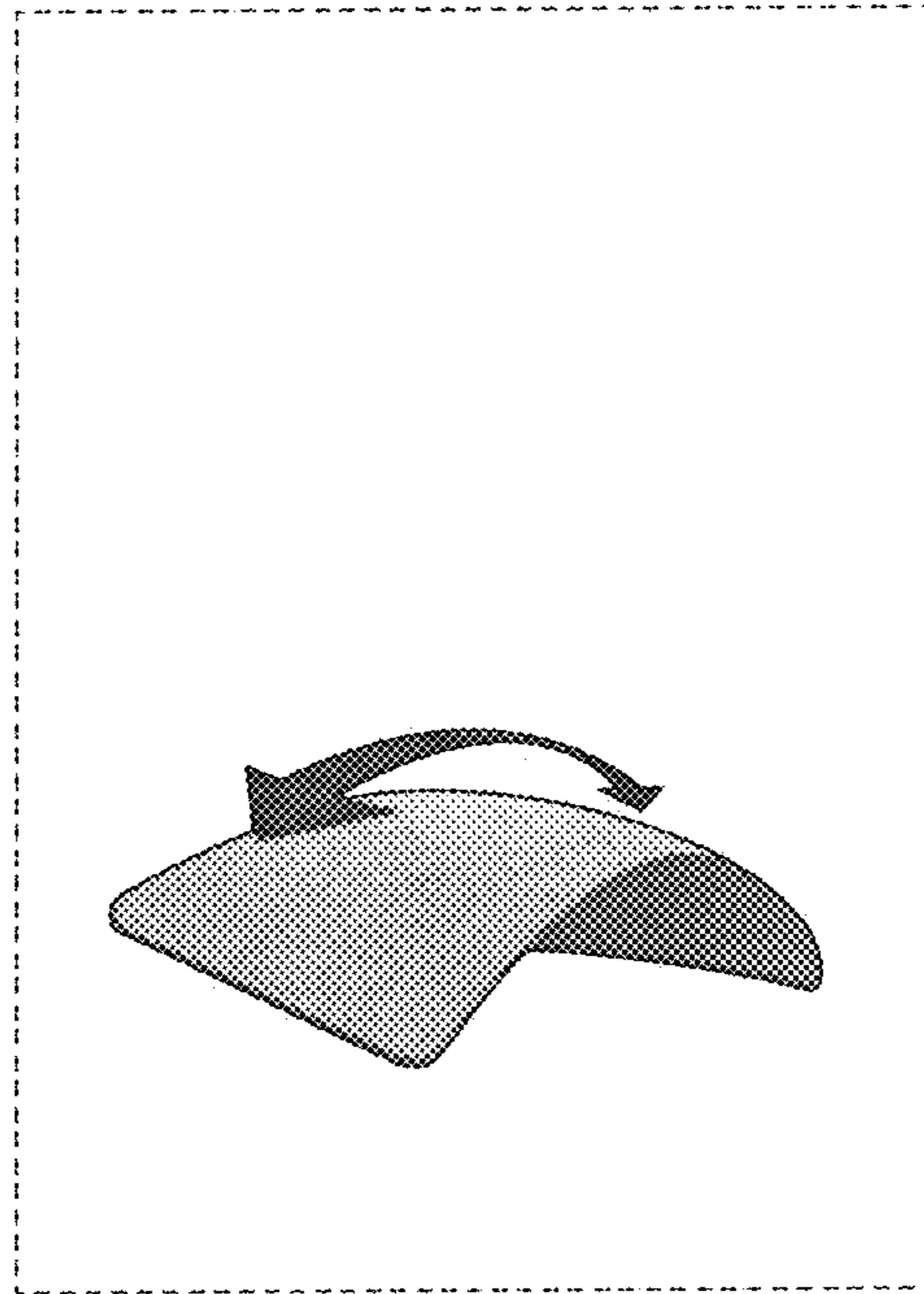

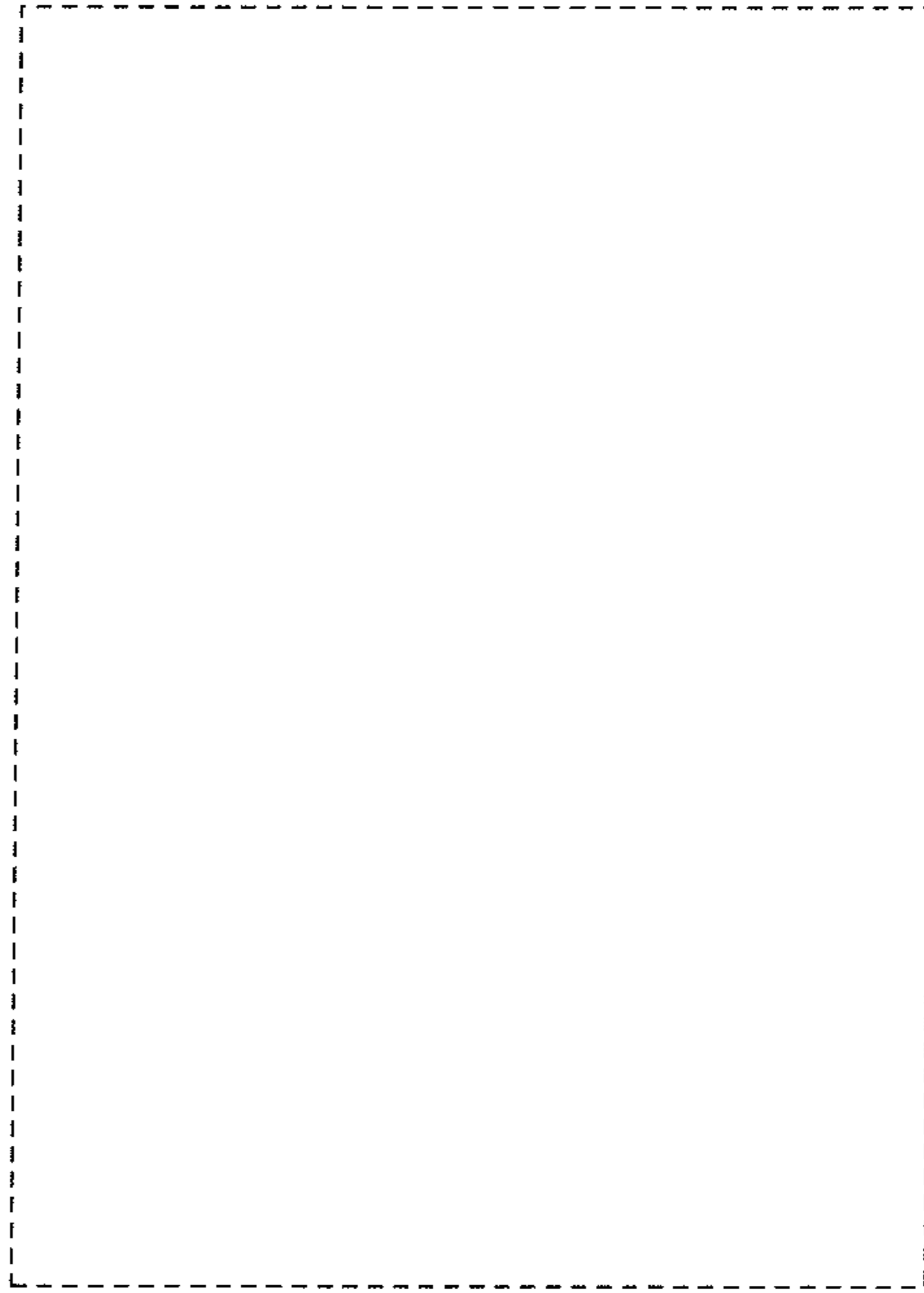

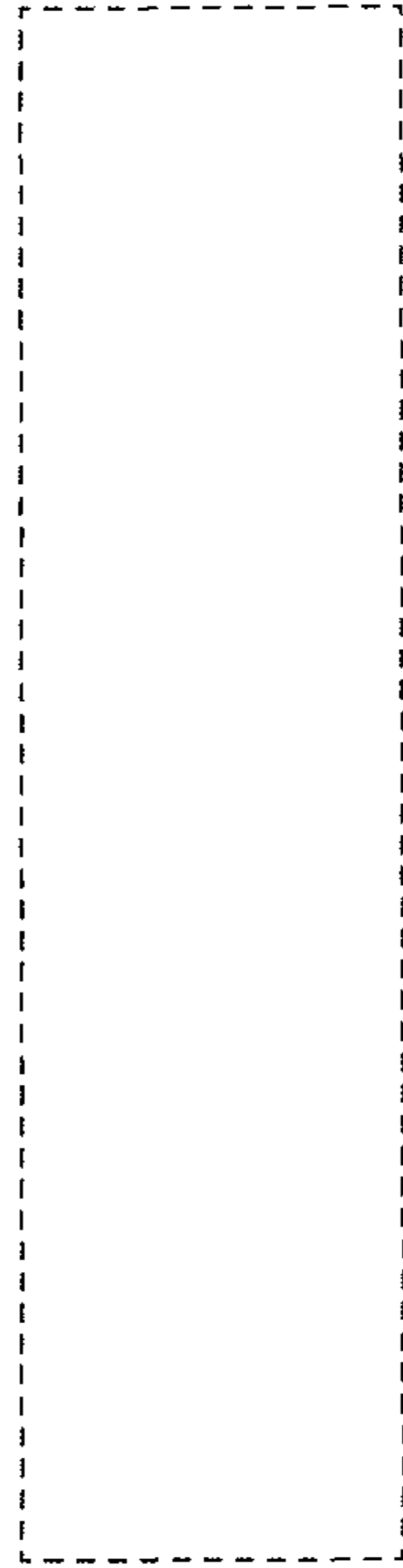

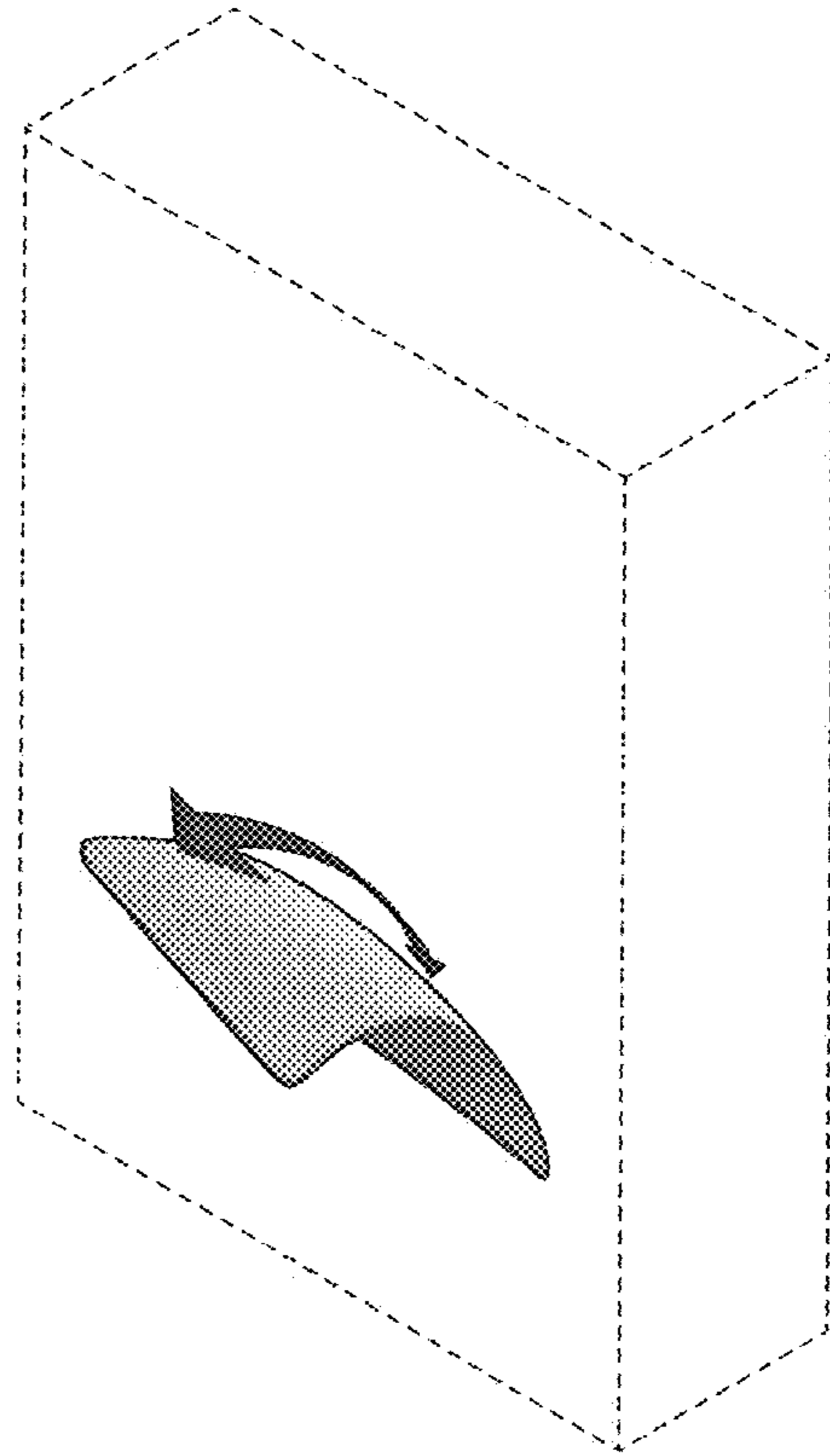
