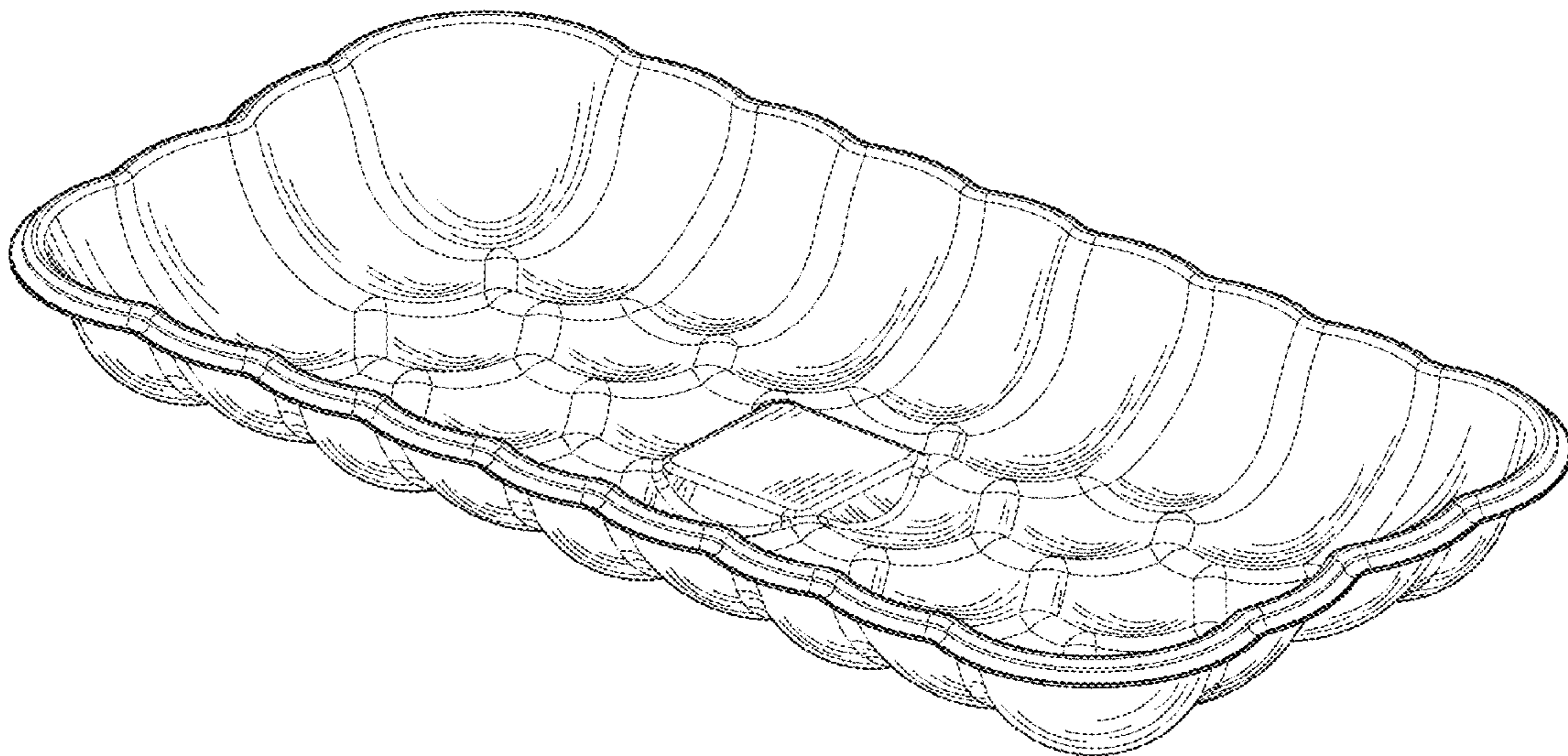
I claim the ornamental design for a container tray, as shown and described.

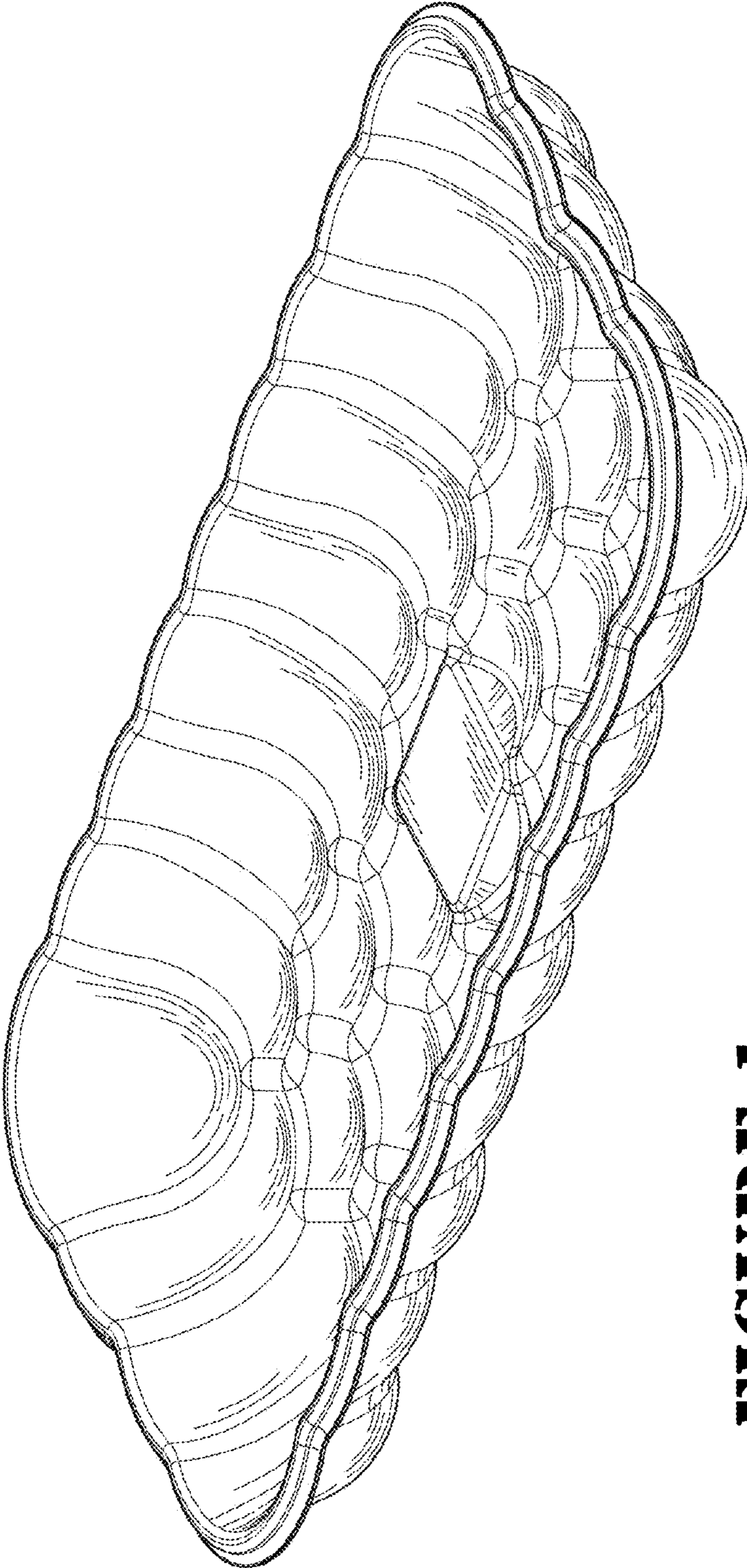
**DESCRIPTION**

FIG. 5 shows the rear view thereof.

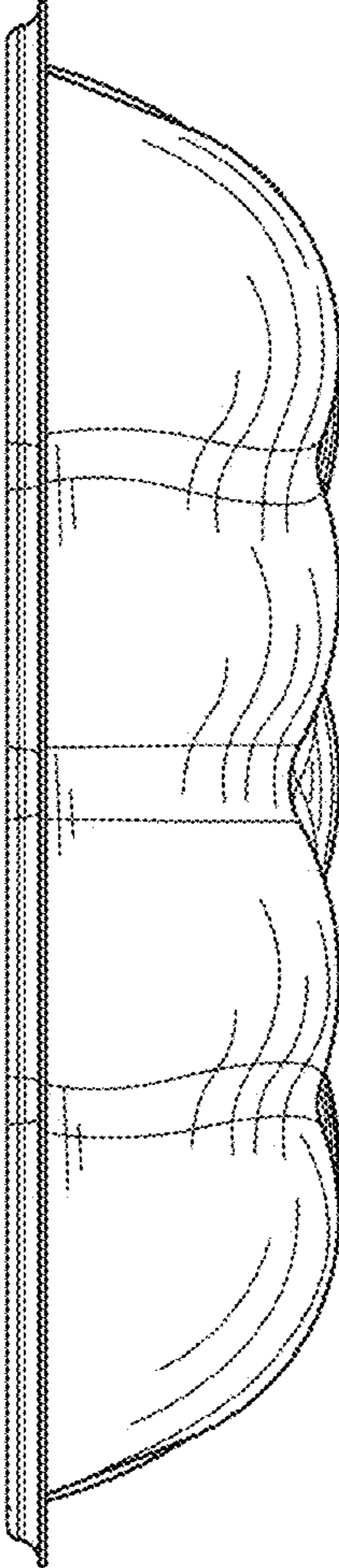

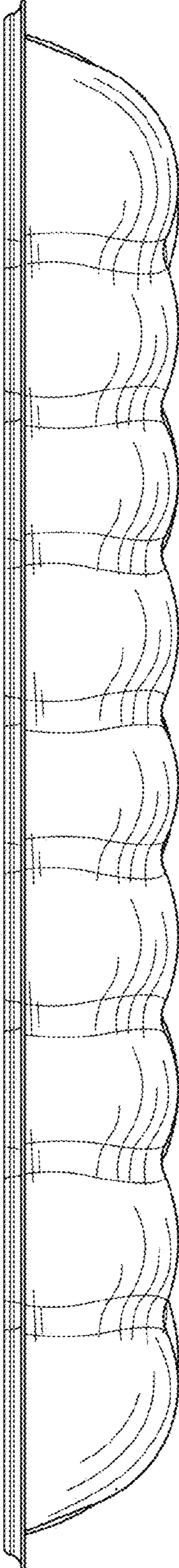




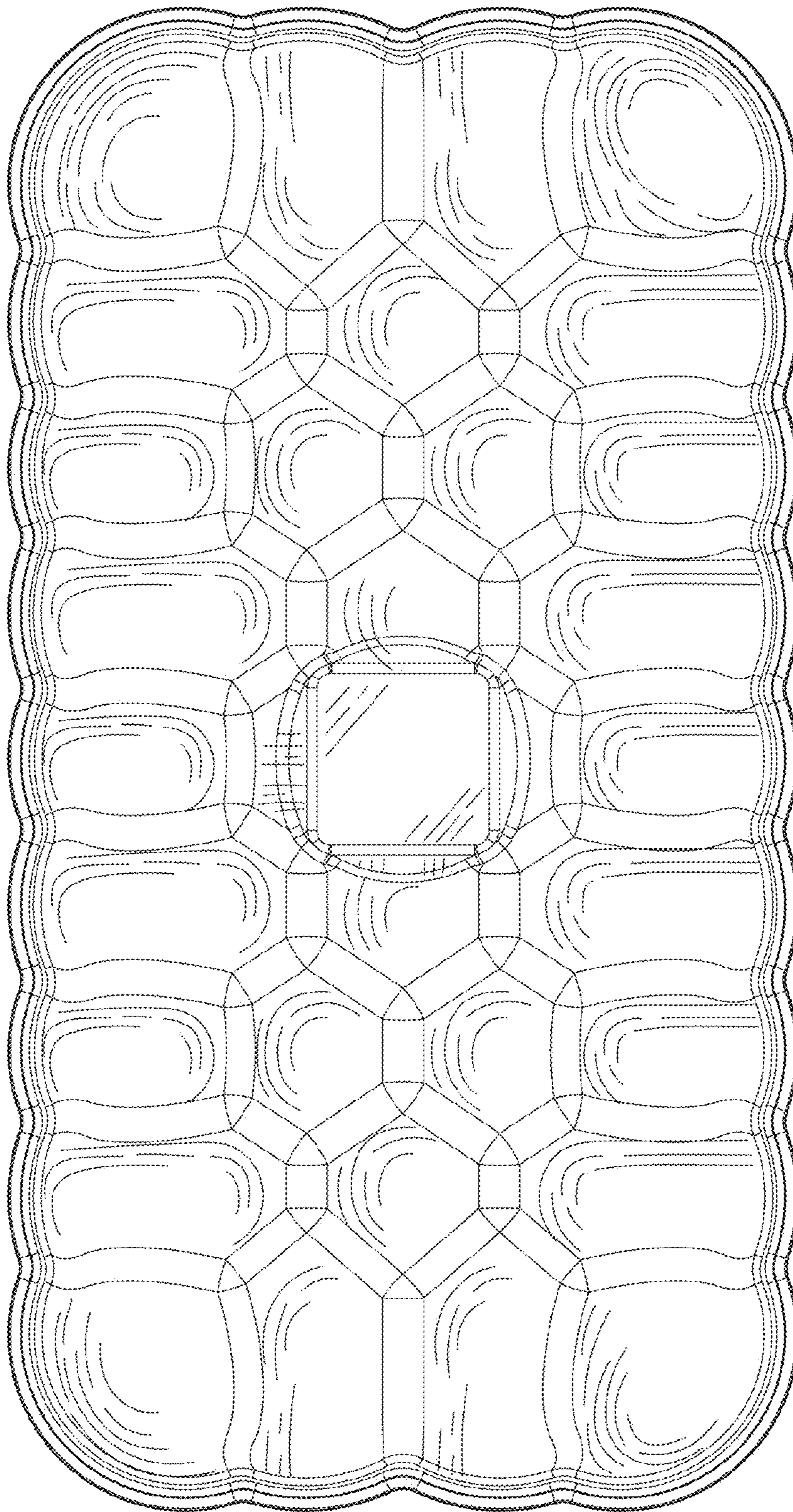

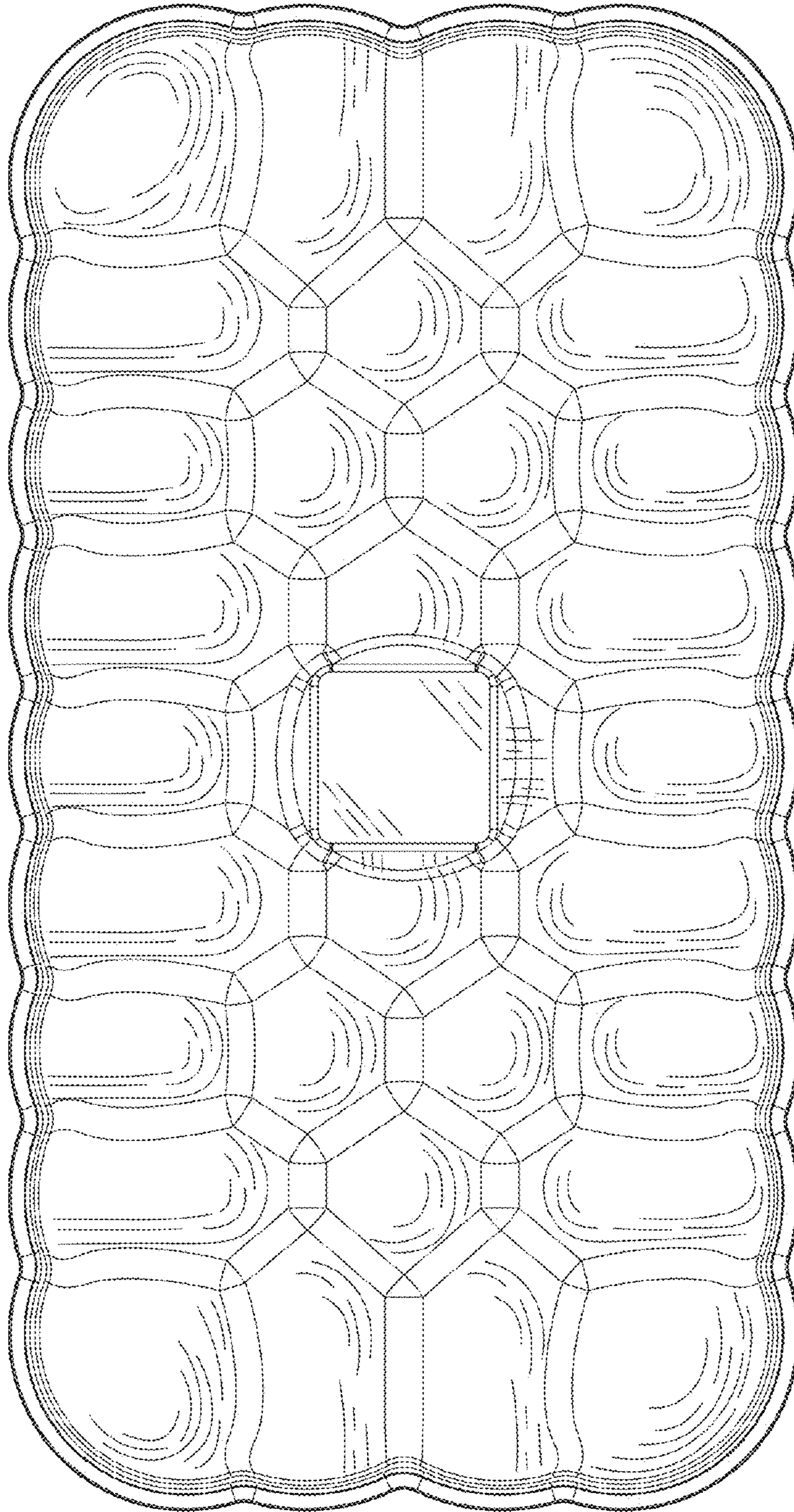
