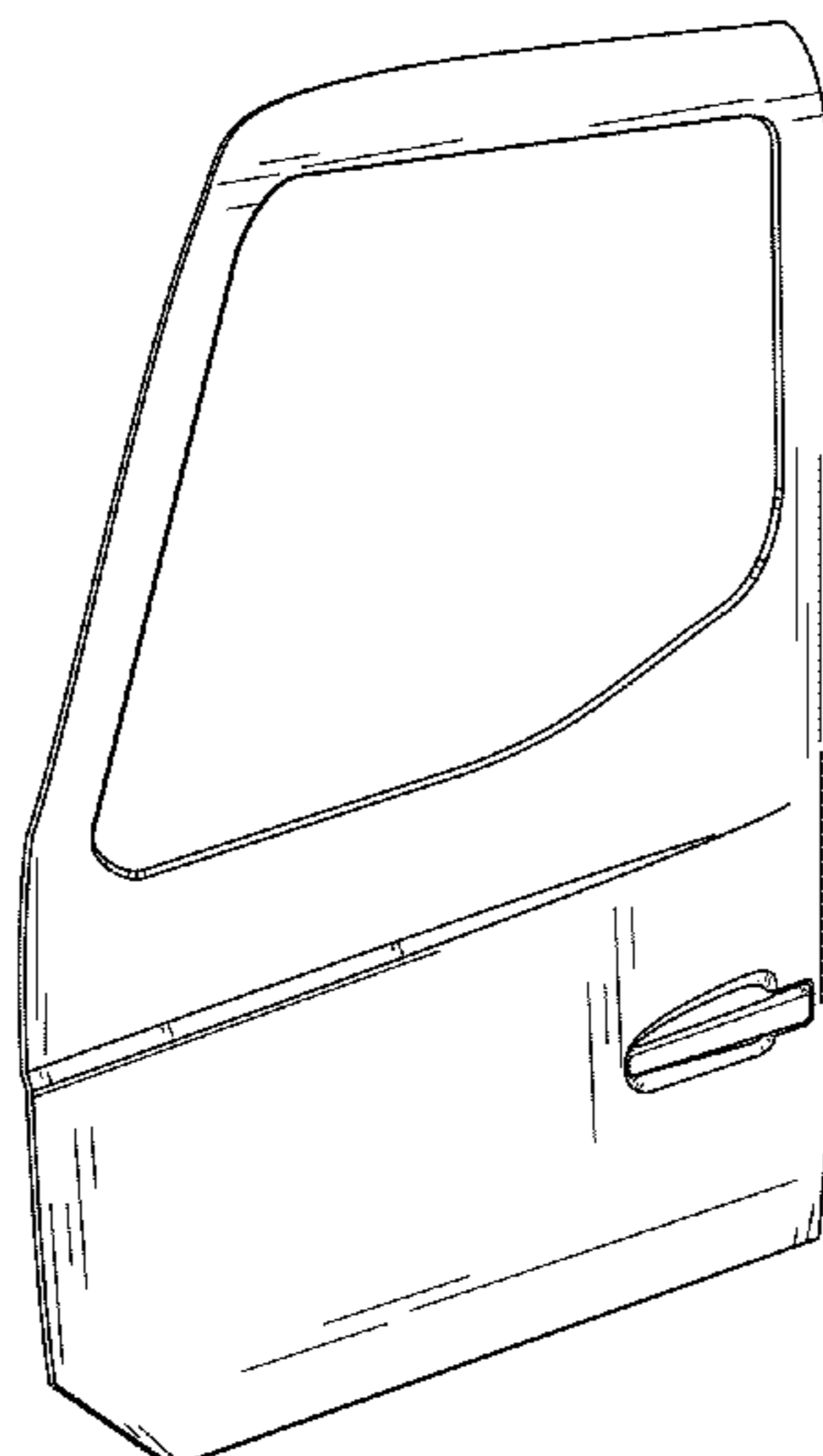
FIG. 1 is a FRONT AND LEFT SIDE PERSPECTIVE view of a left hand embodiment of a door of a truck vehicle showing our new design;

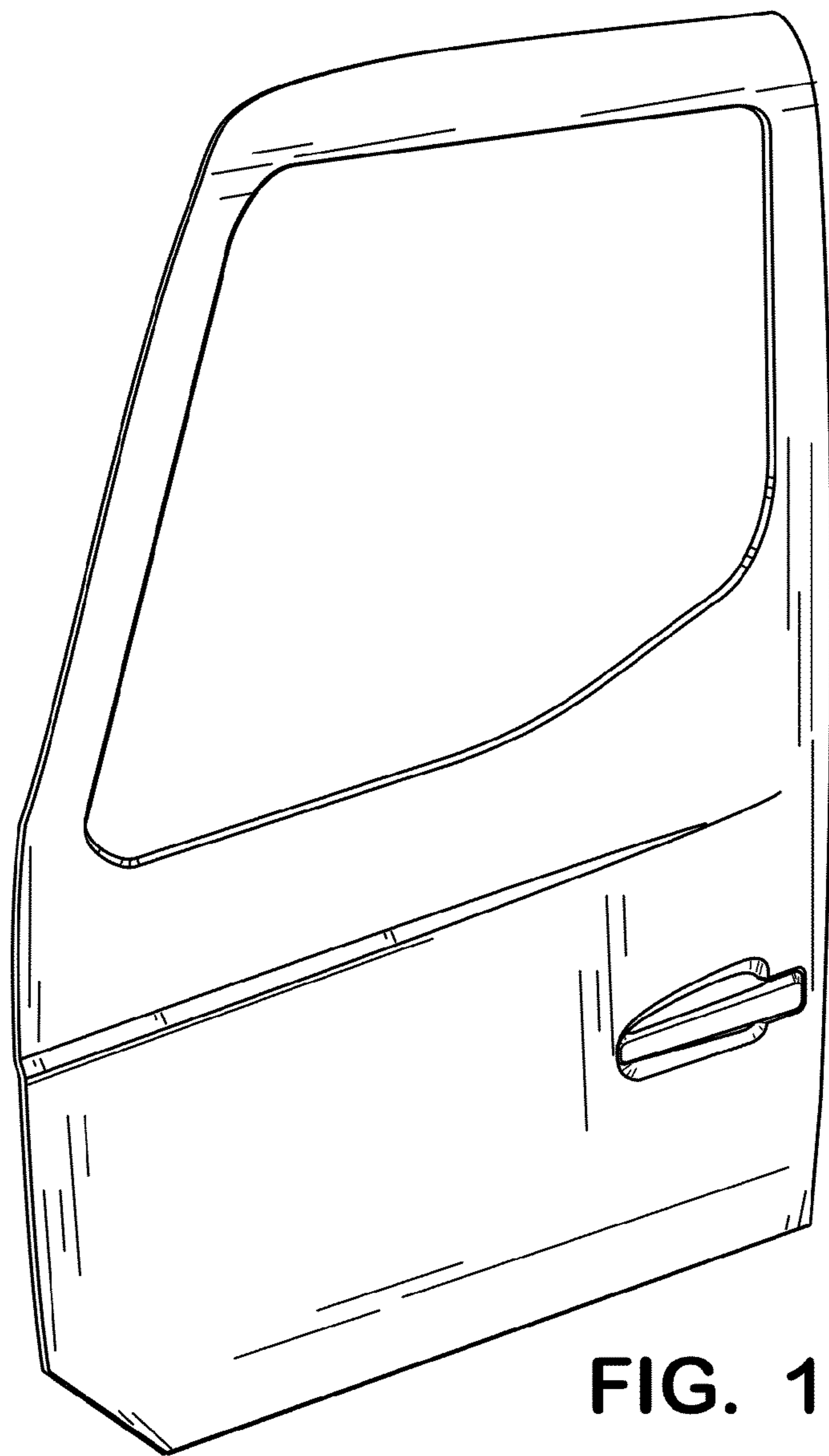

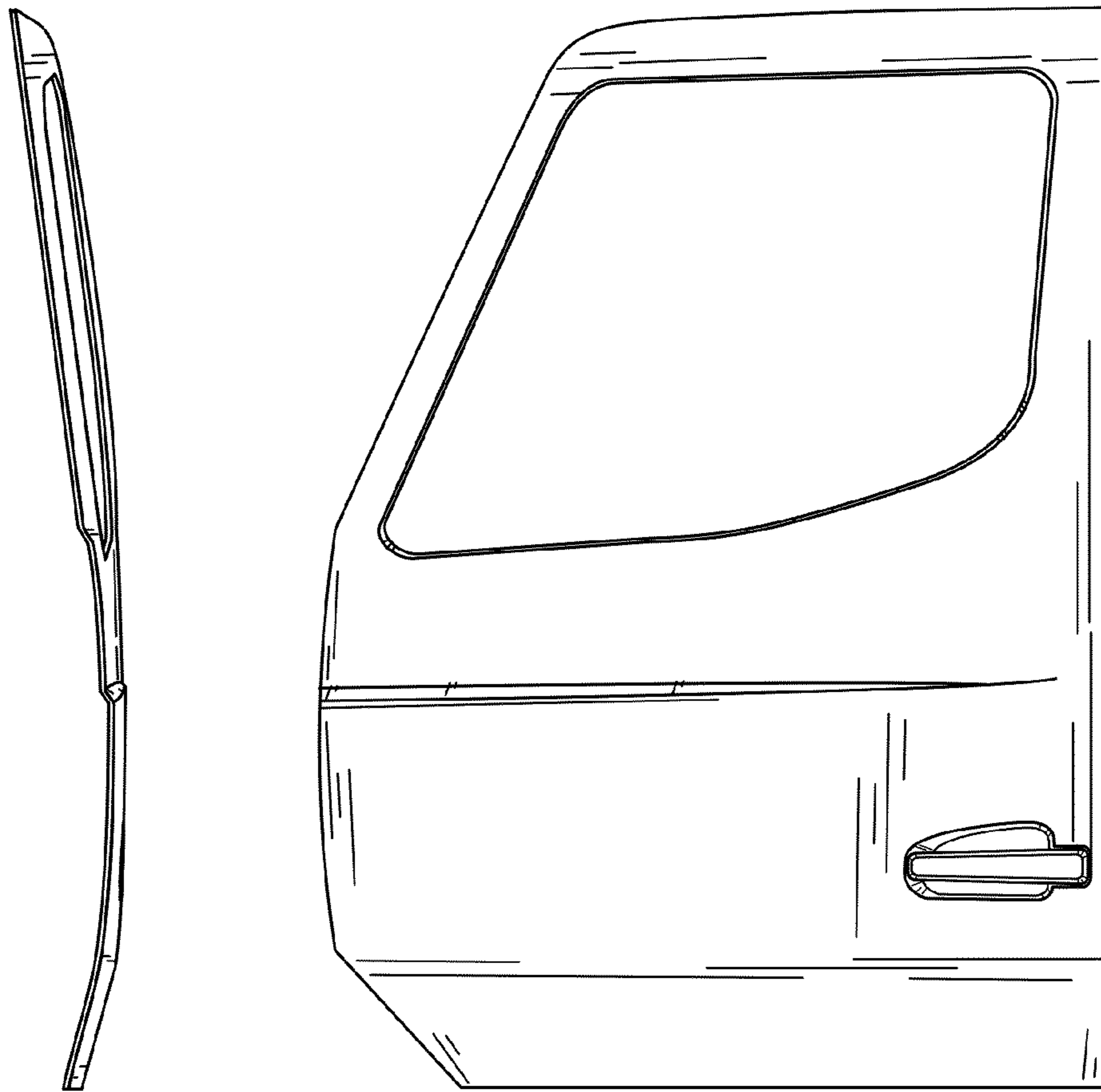
