(57) **CLAIM**

We claim the ornamental design for a decorative plug-in accessory, as shown and described.

FIG. 1 is a front end elevational view of the decorative plug-in accessory in accordance with a first embodiment of the present invention.

FIG. 2 is a rear end elevational view of the decorative plug-in accessory of FIG. 1.

FIG. 3 is a side elevational view of the decorative plug-in accessory of FIG. 1.

FIG. 4 is an opposite side elevational view of the decorative plug-in accessory of FIG. 1.

FIG. 5 is a top plan view of the decorative plug-in accessory of FIG. 1.

FIG. 6 is a bottom plan view of the decorative plug-in accessory of FIG. 1.

FIG. 7 is a front end elevational view of the decorative plug-in accessory in accordance with a second embodiment of the present invention.

FIG. 8 is a rear end elevational view of the decorative plug-in accessory of FIG. 7.

FIG. 9 is a side elevational view of the decorative plug-in accessory of FIG. 7.

FIG. 10 is an opposite side elevational view of the decorative plug-in accessory of FIG. 7.

FIG. 11 is a top plan view of the decorative plug-in accessory of FIG. 7.

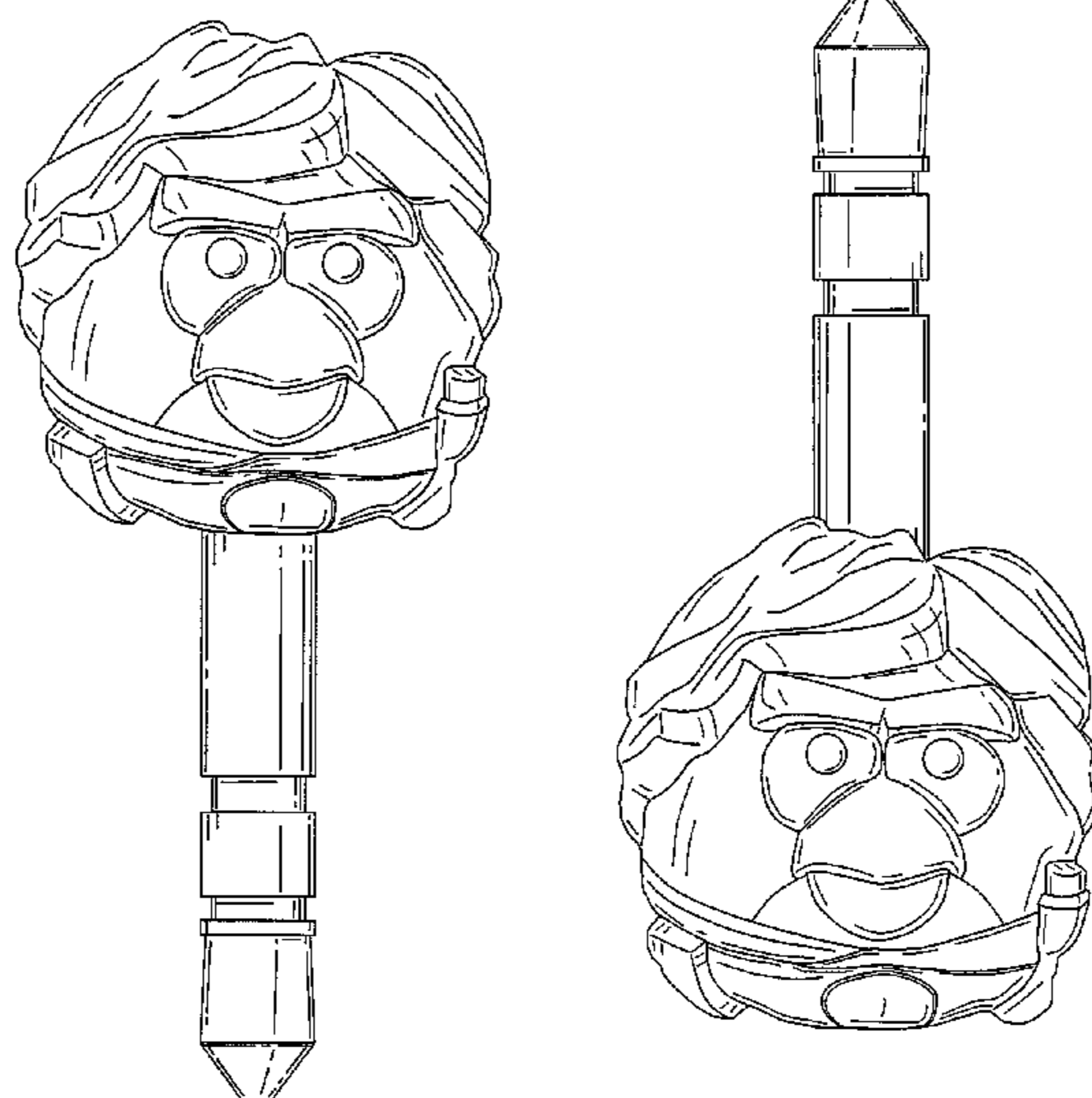
FIG. 12 is a bottom plan view of the decorative plug-in accessory of FIG. 7.

FIG. 13 is a front end elevation view, shown at a reduced scale, of the decorative plug-in accessory of FIG. 1 mounted on an i-Phone® mobile phone; and,

FIG. 14 is a front end elevation view, also shown at a reduced scale, of the decorative plug-in accessory of FIG. 7 mounted on an i-Phone® mobile phone.

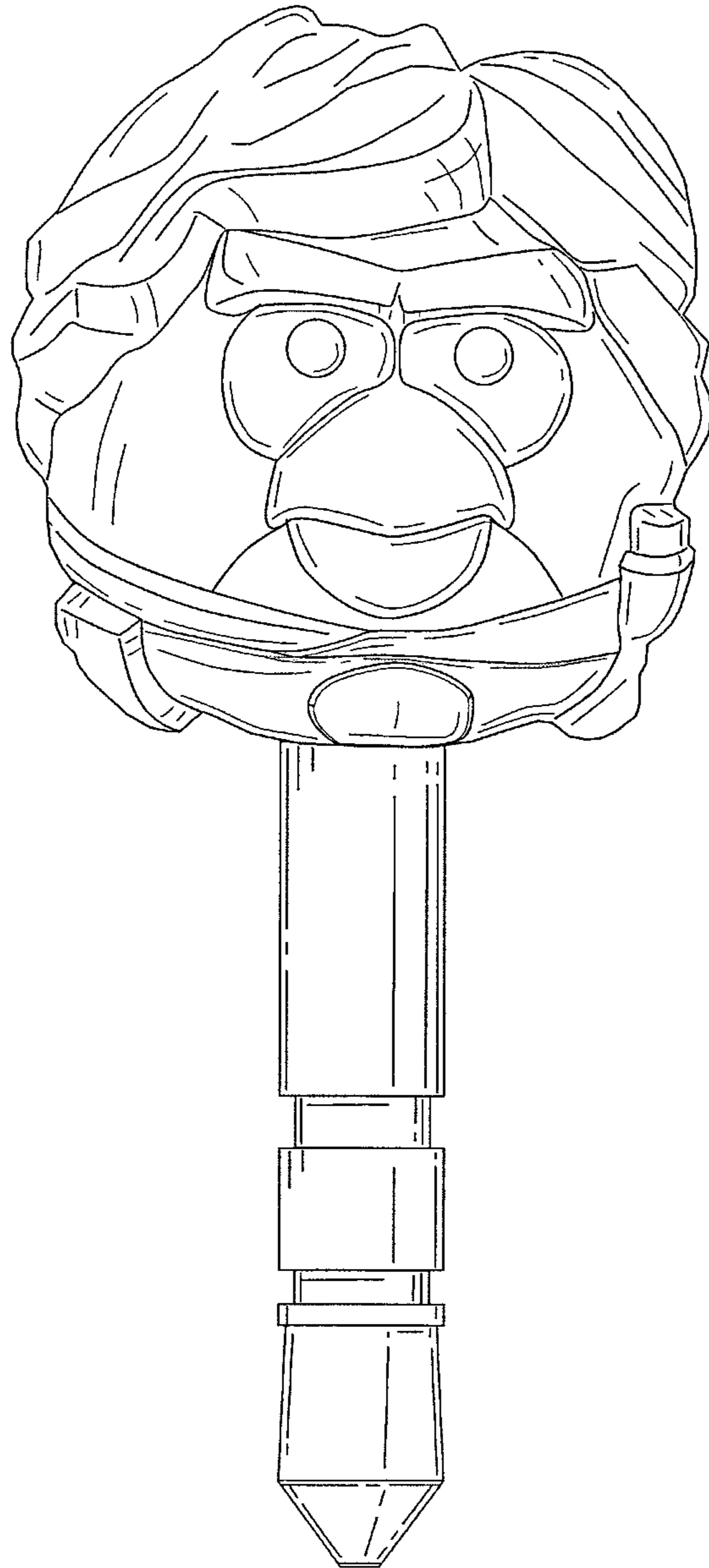
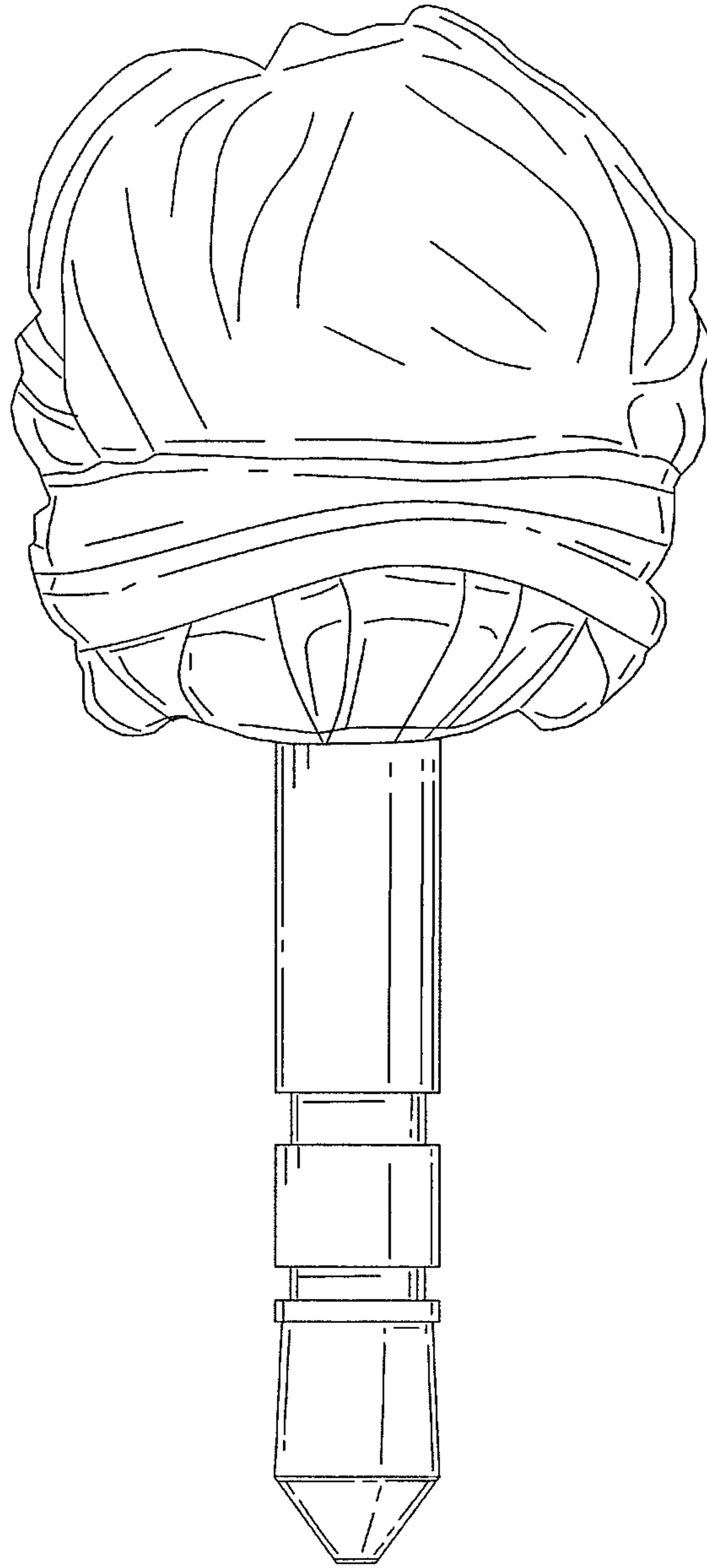
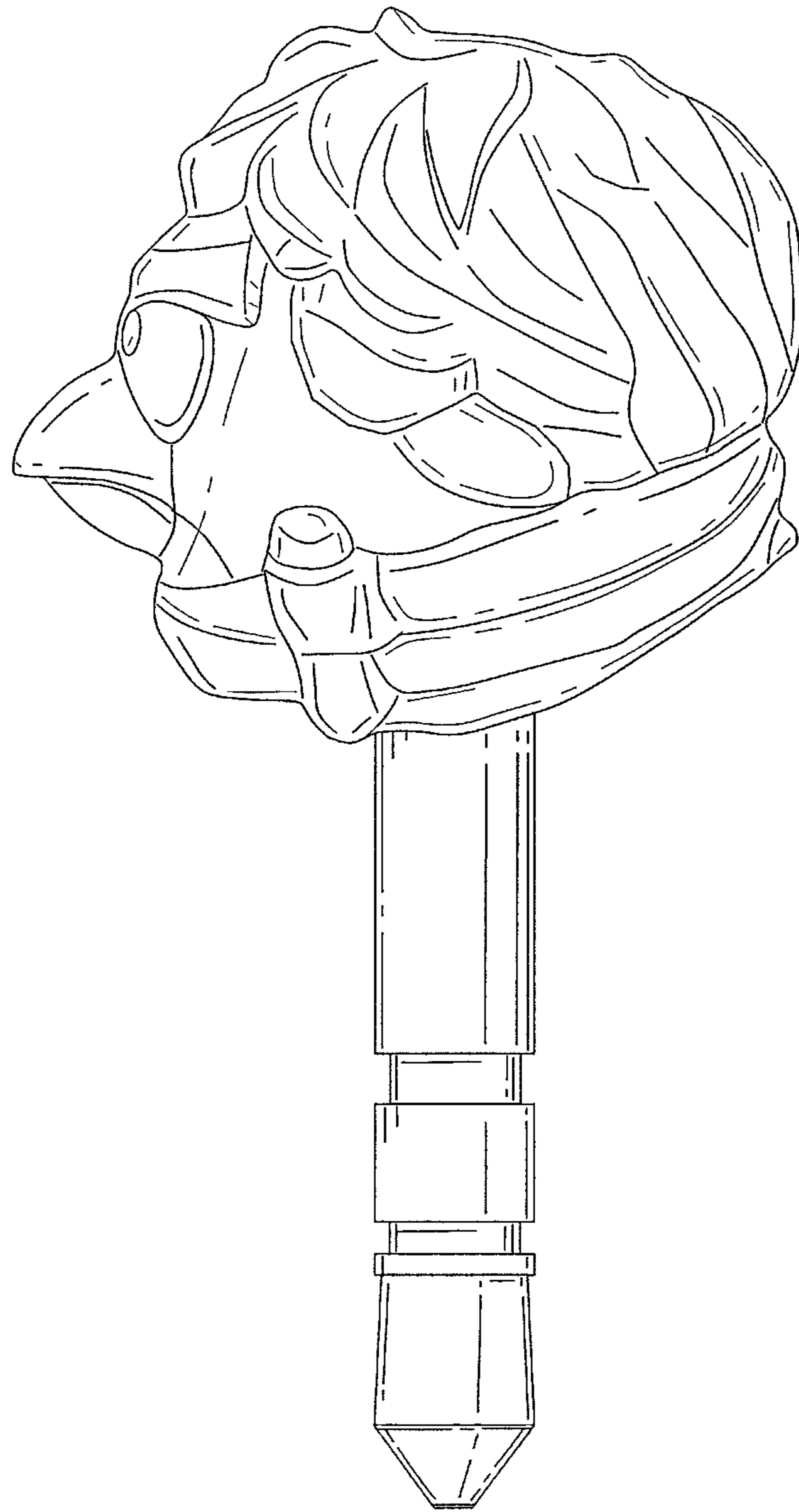


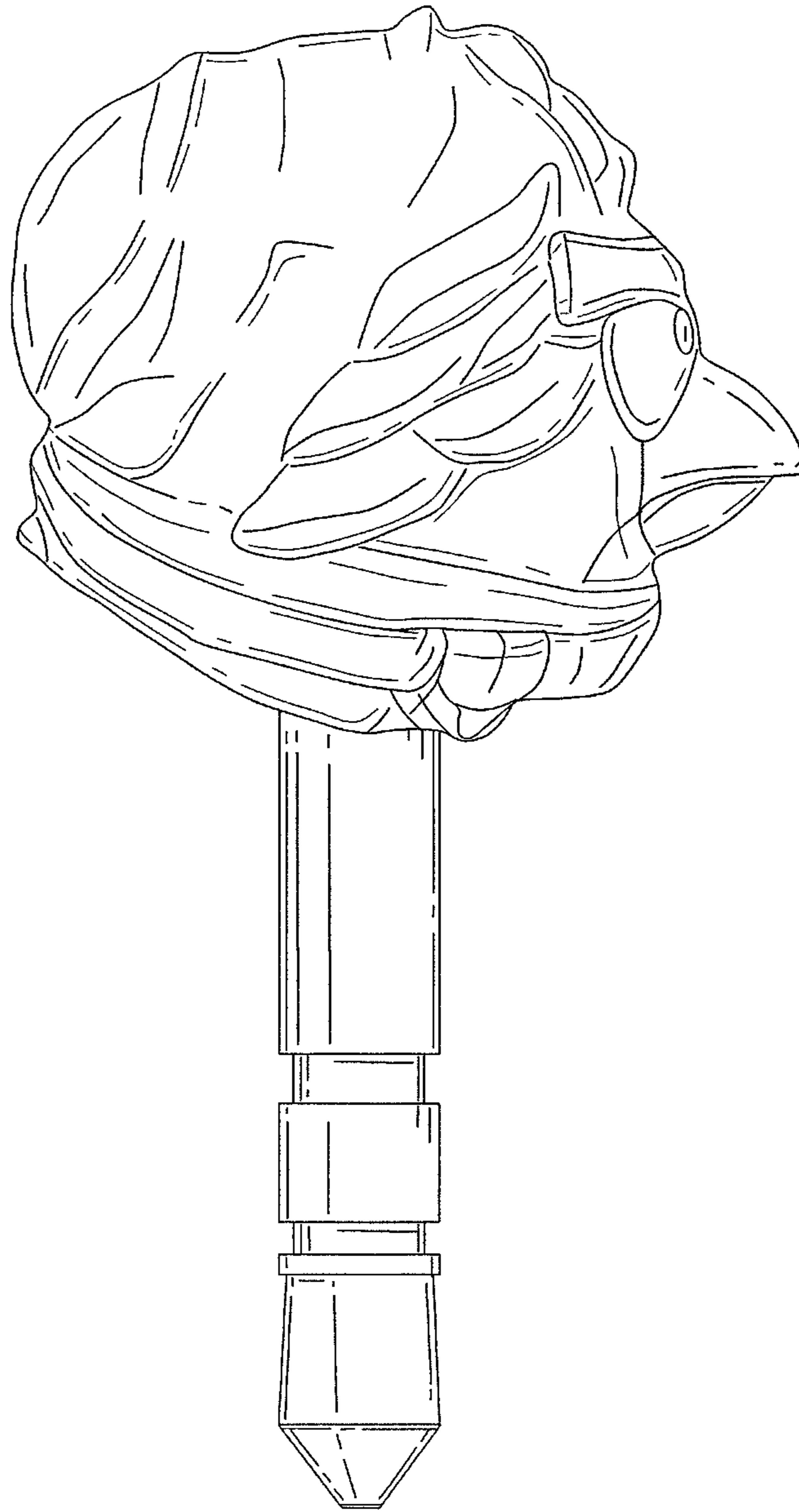

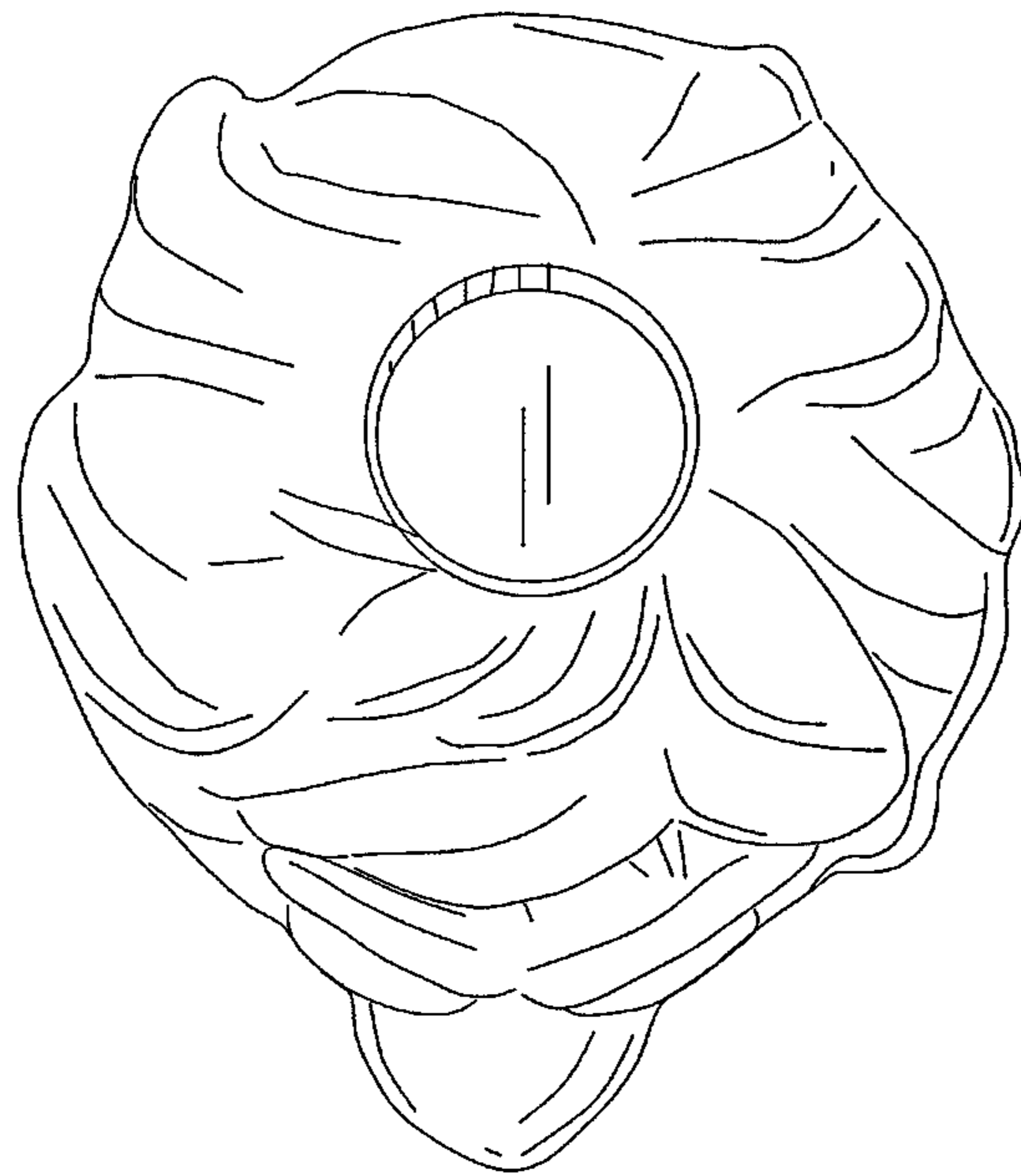

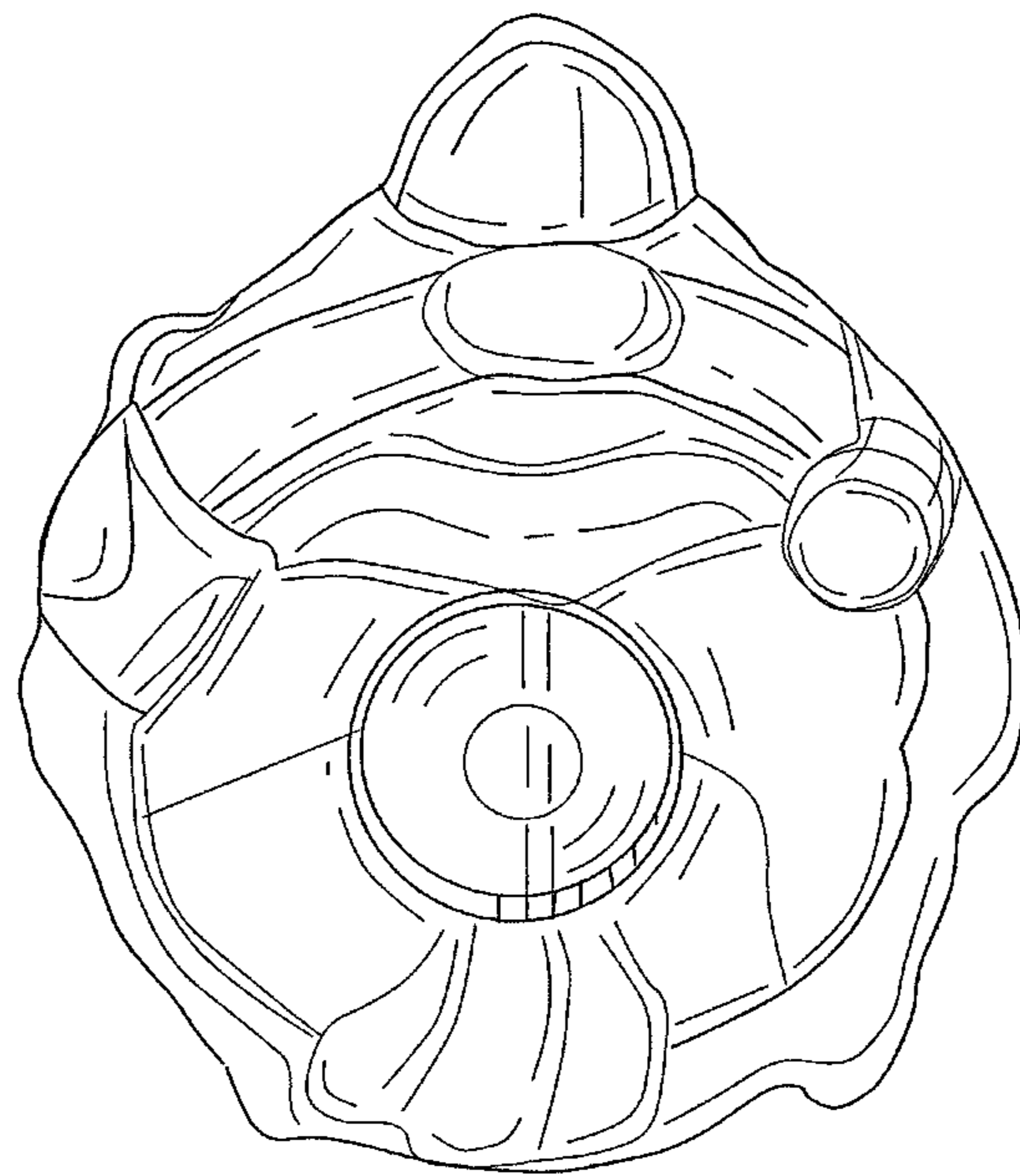

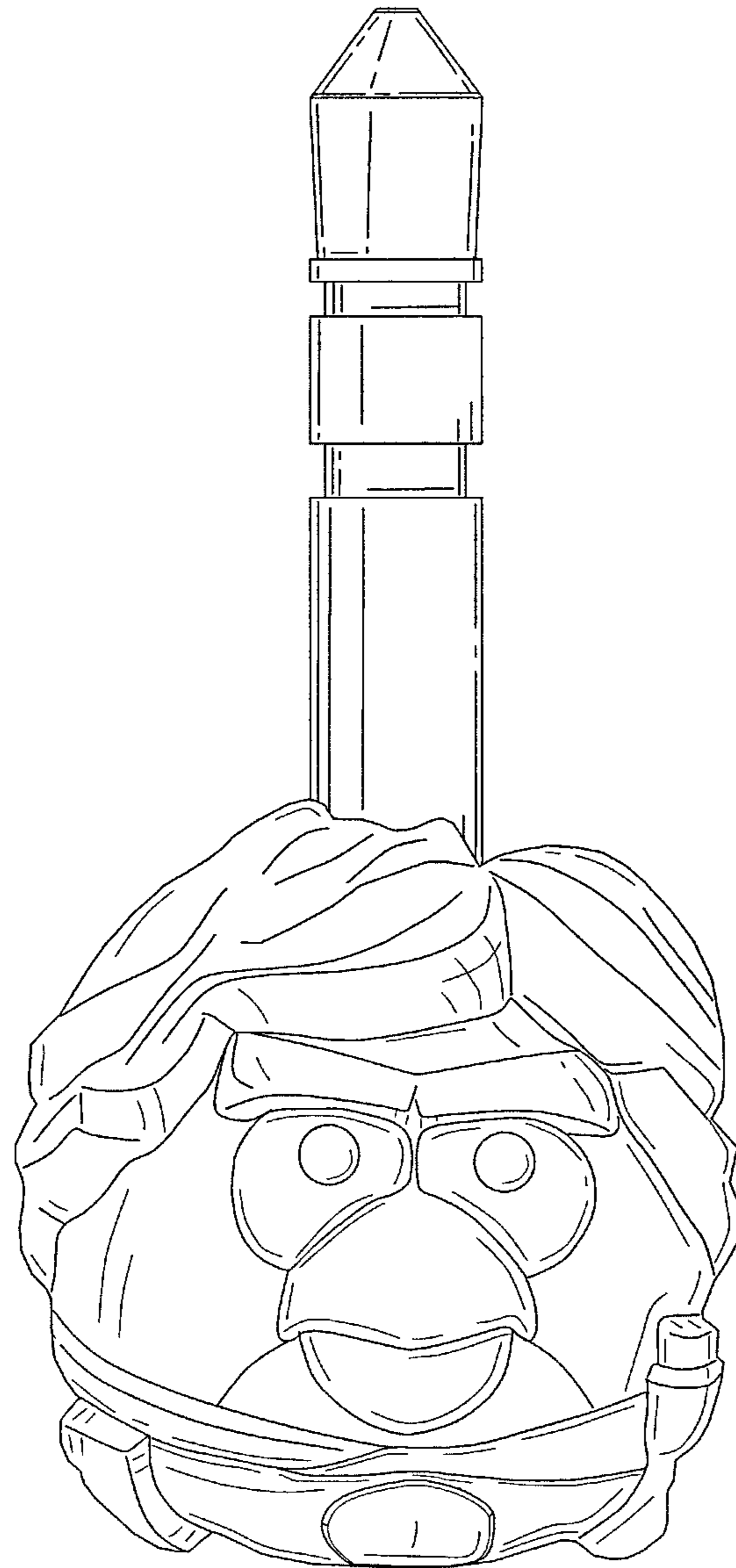
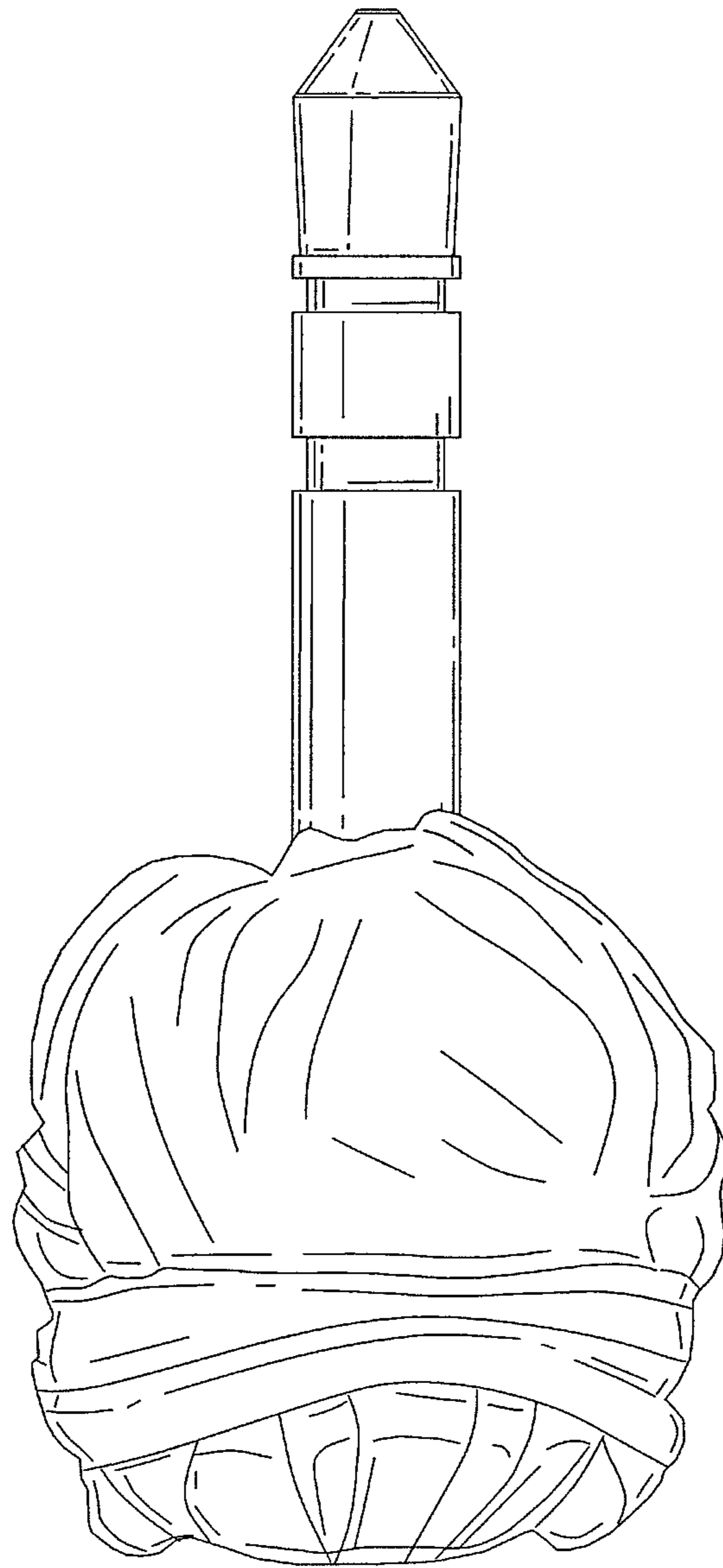
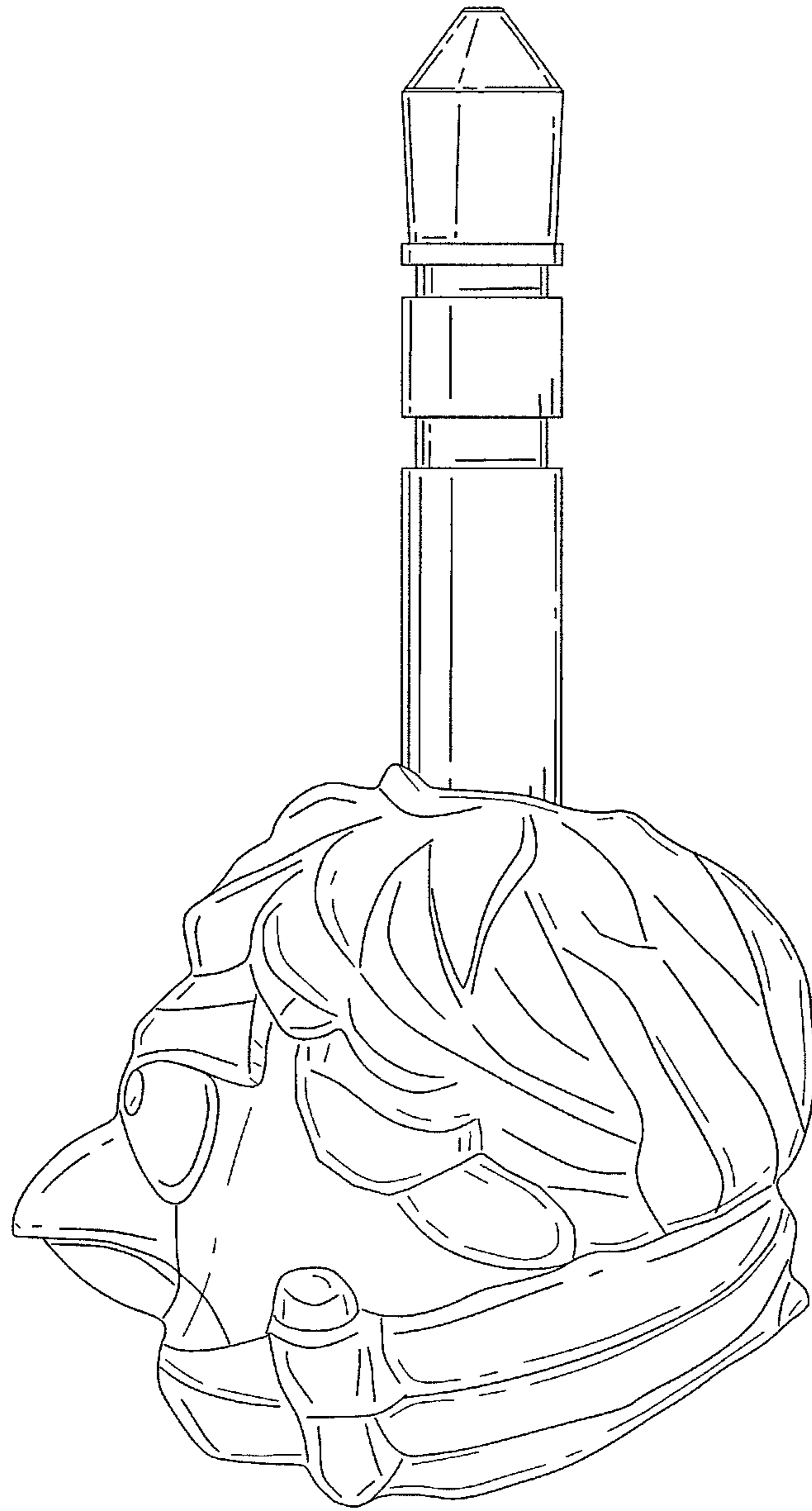

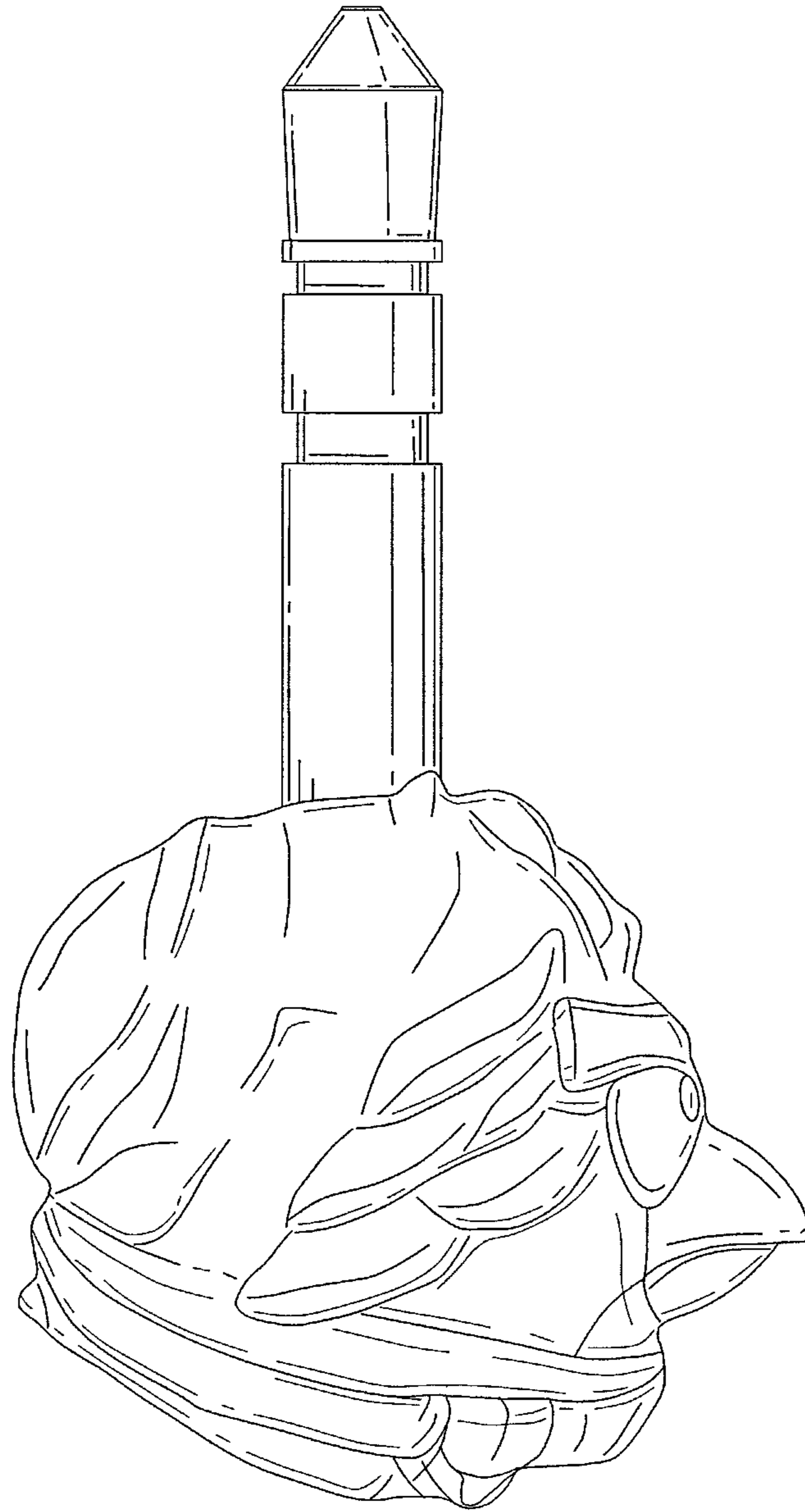




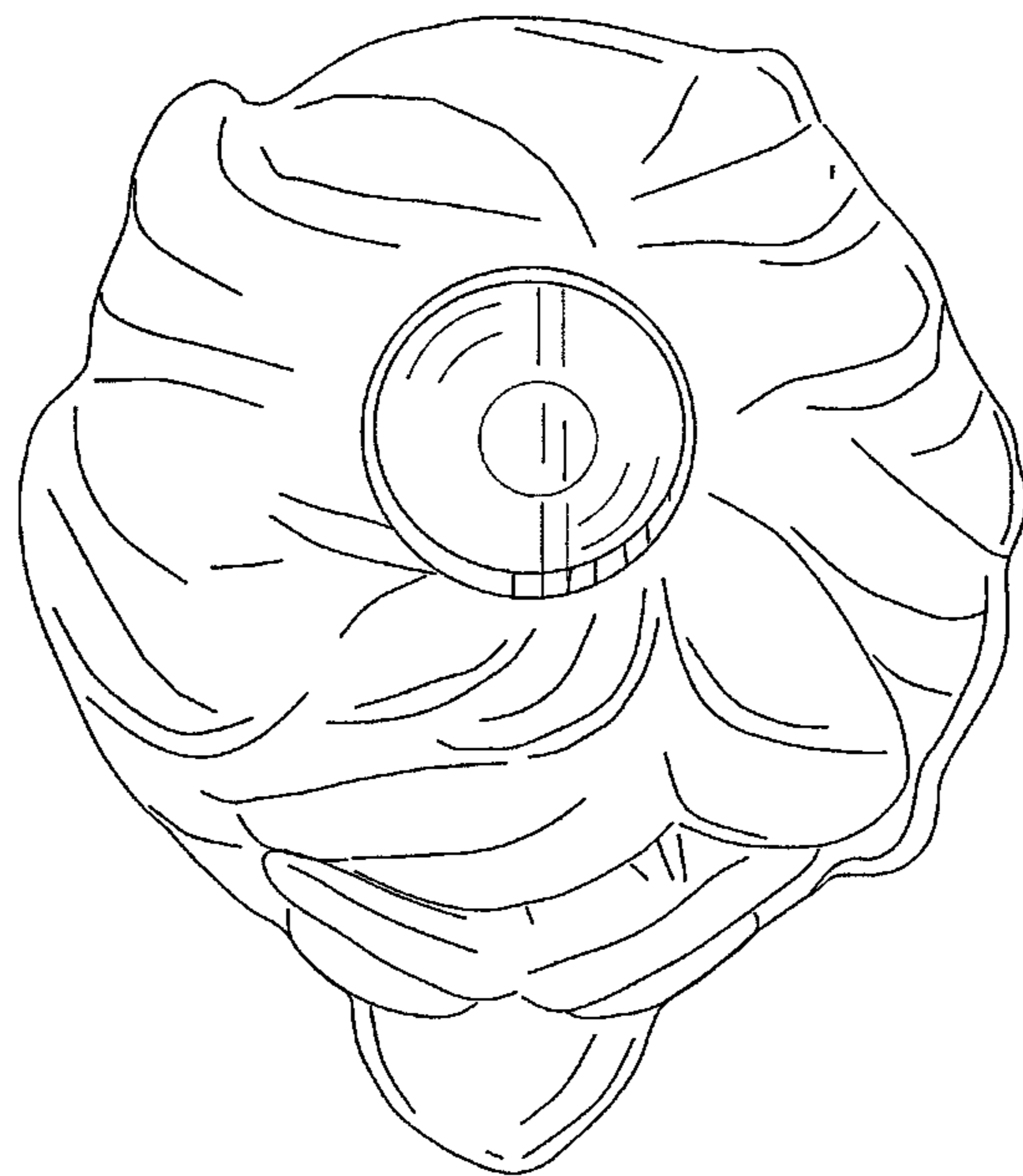

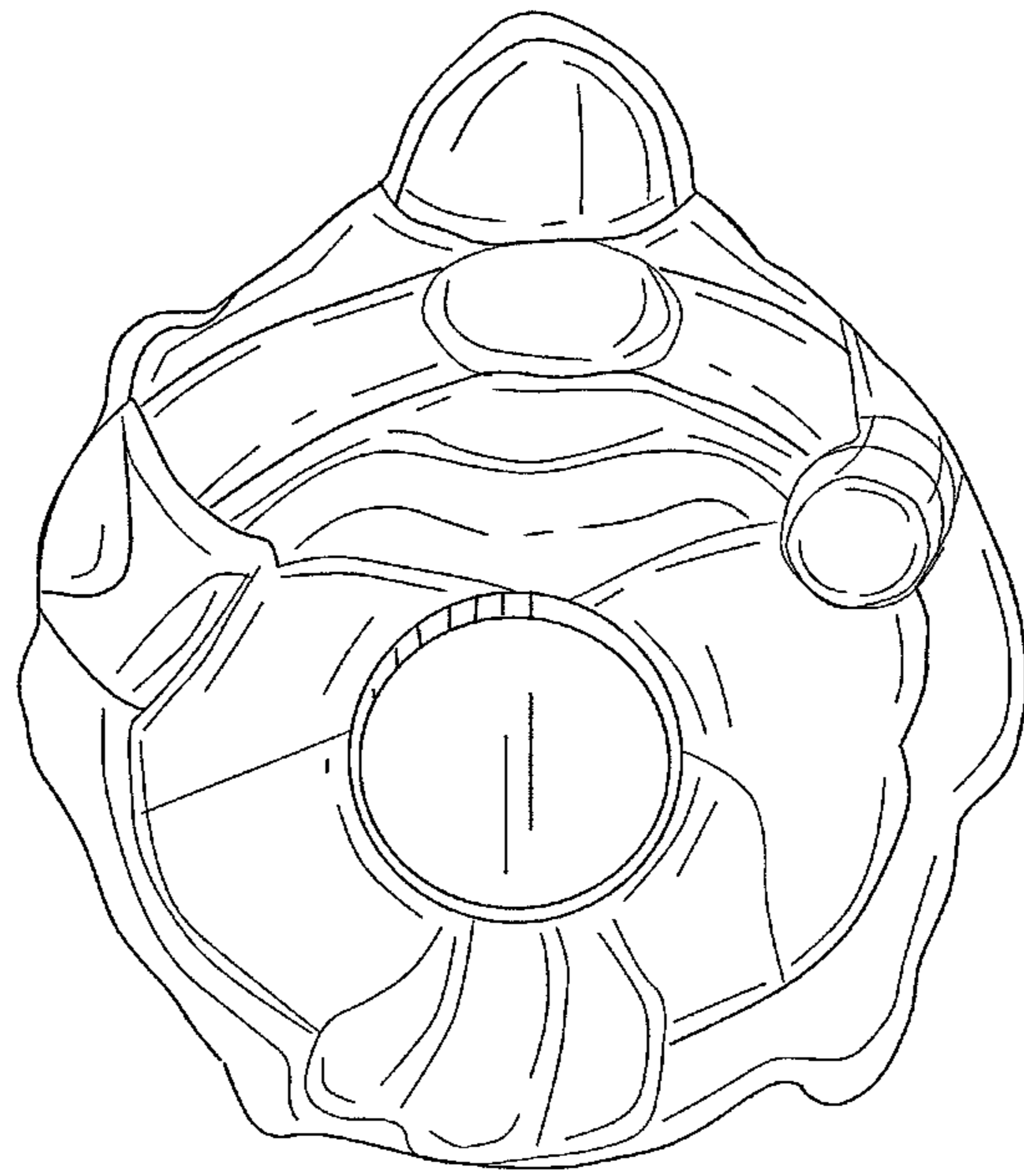

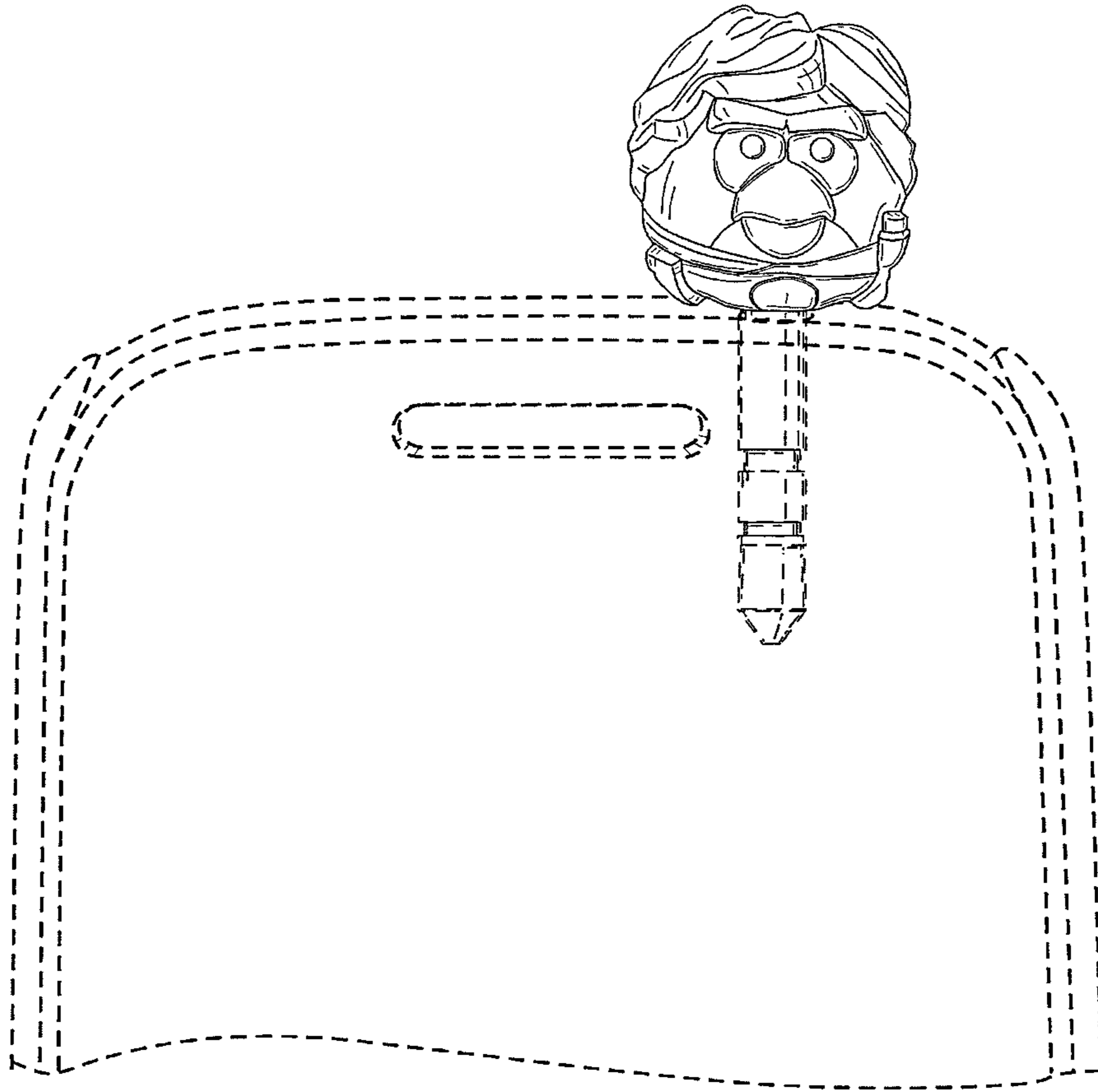

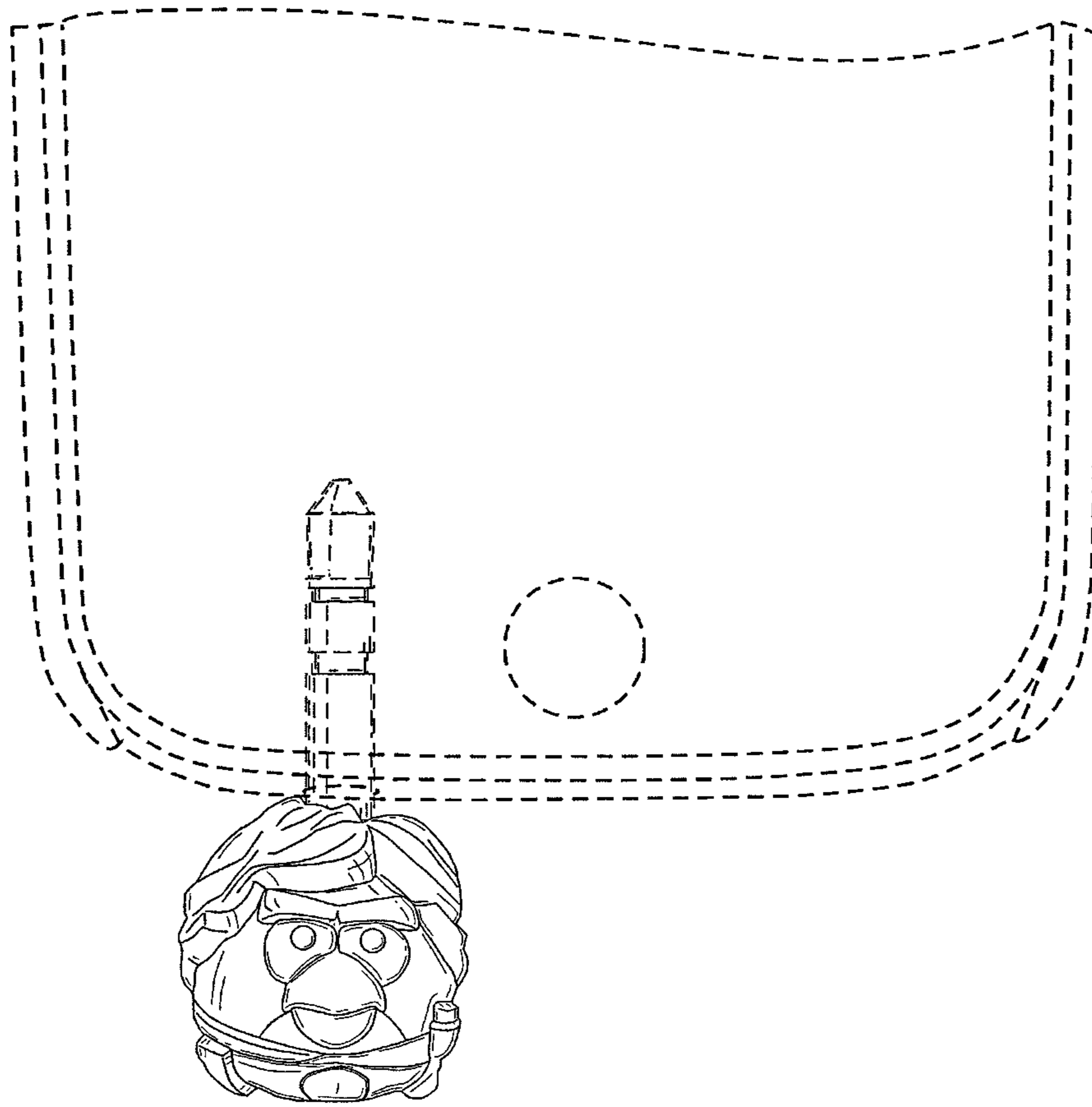
