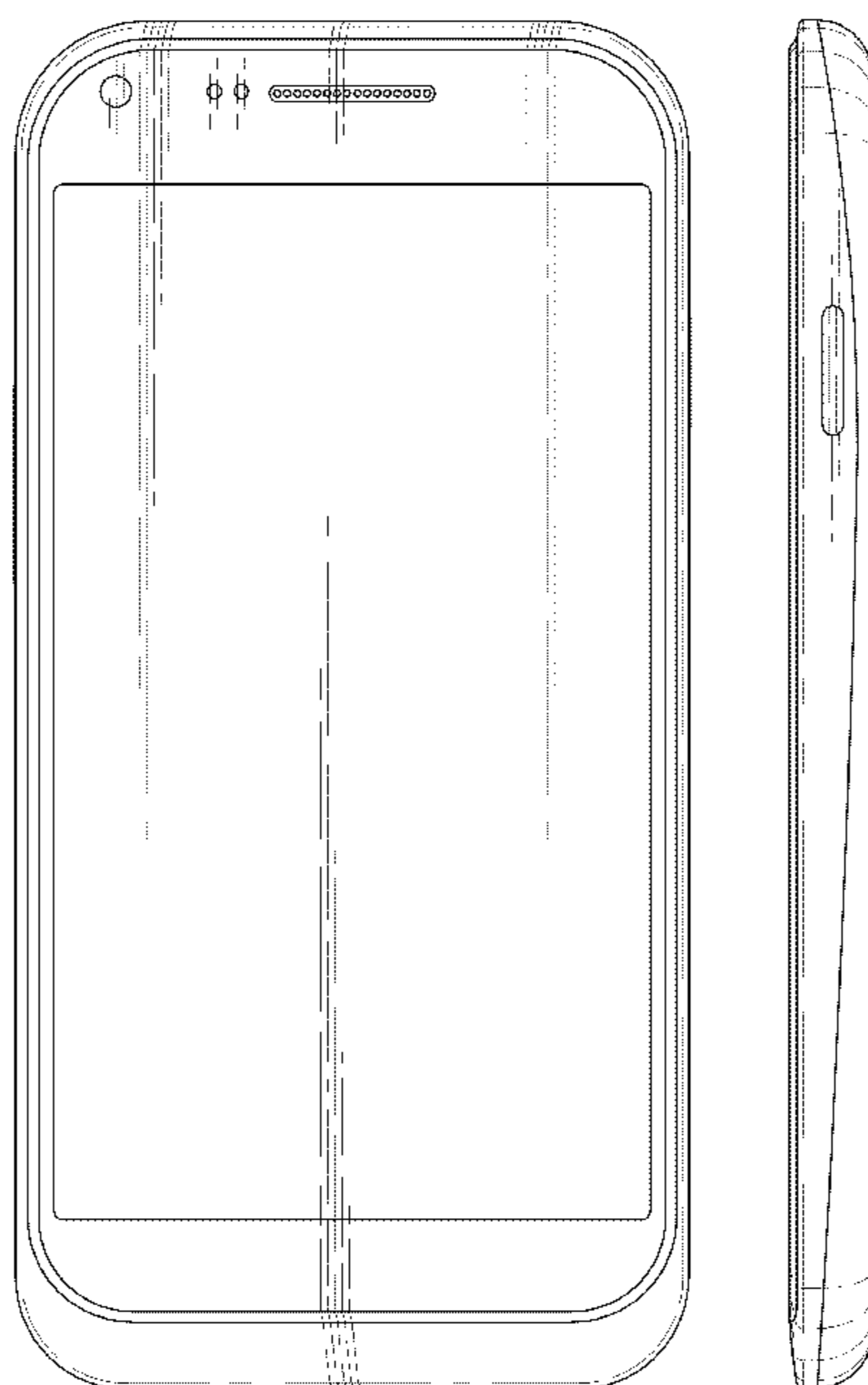
(57) **CLAIM**

The ornamental design for a mobile terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a mobile terminal; FIG. 2 is a front view of the mobile terminal of FIG. 1; FIG. 3 is a rear view of the mobile terminal of FIG. 1; FIG. 4 is a left-side view of the mobile terminal of FIG. 1; FIG. 5 is a right-side view of the mobile terminal of FIG. 1; FIG. 6 is a top plan view of the mobile terminal of FIG. 1; and, FIG. 7 is a bottom plan view of the mobile terminal of FIG. 1. The broken line immediately adjacent the shade lines represents unclaimed boundaries of the claimed design while all other broken lines are directed to environment; the broken lines form no part of the claimed design.

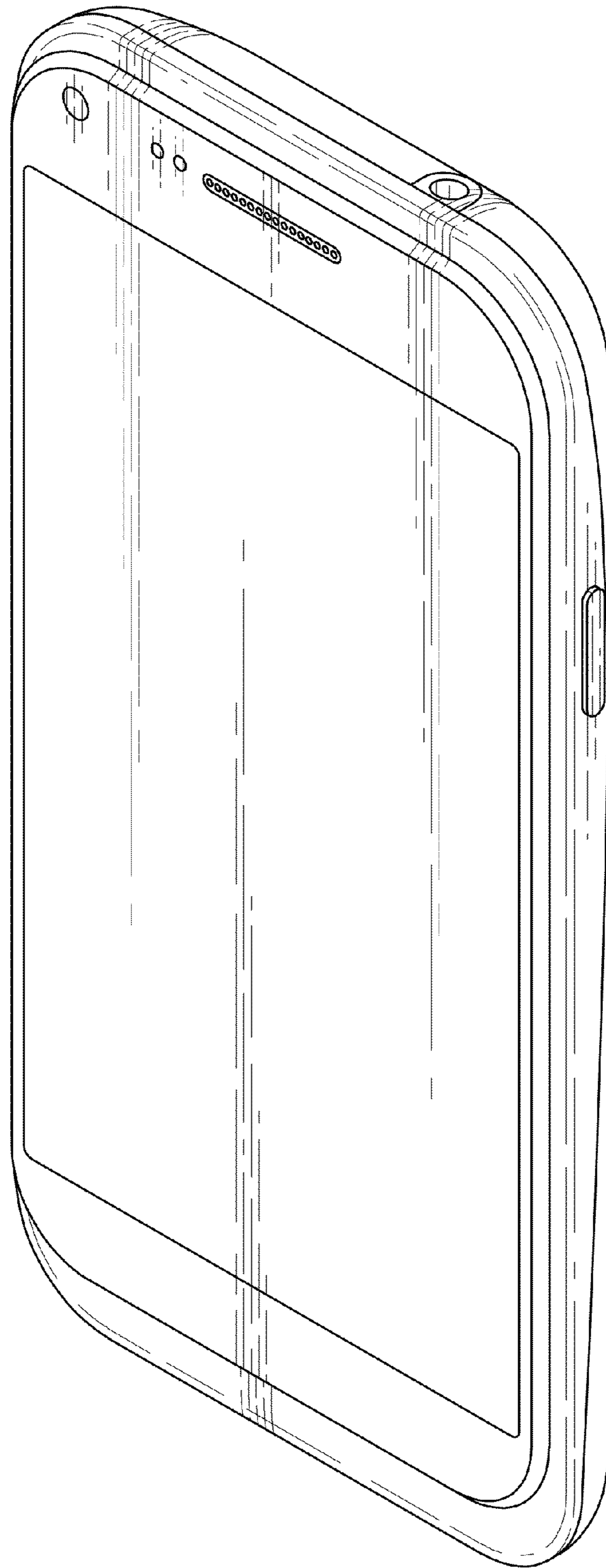

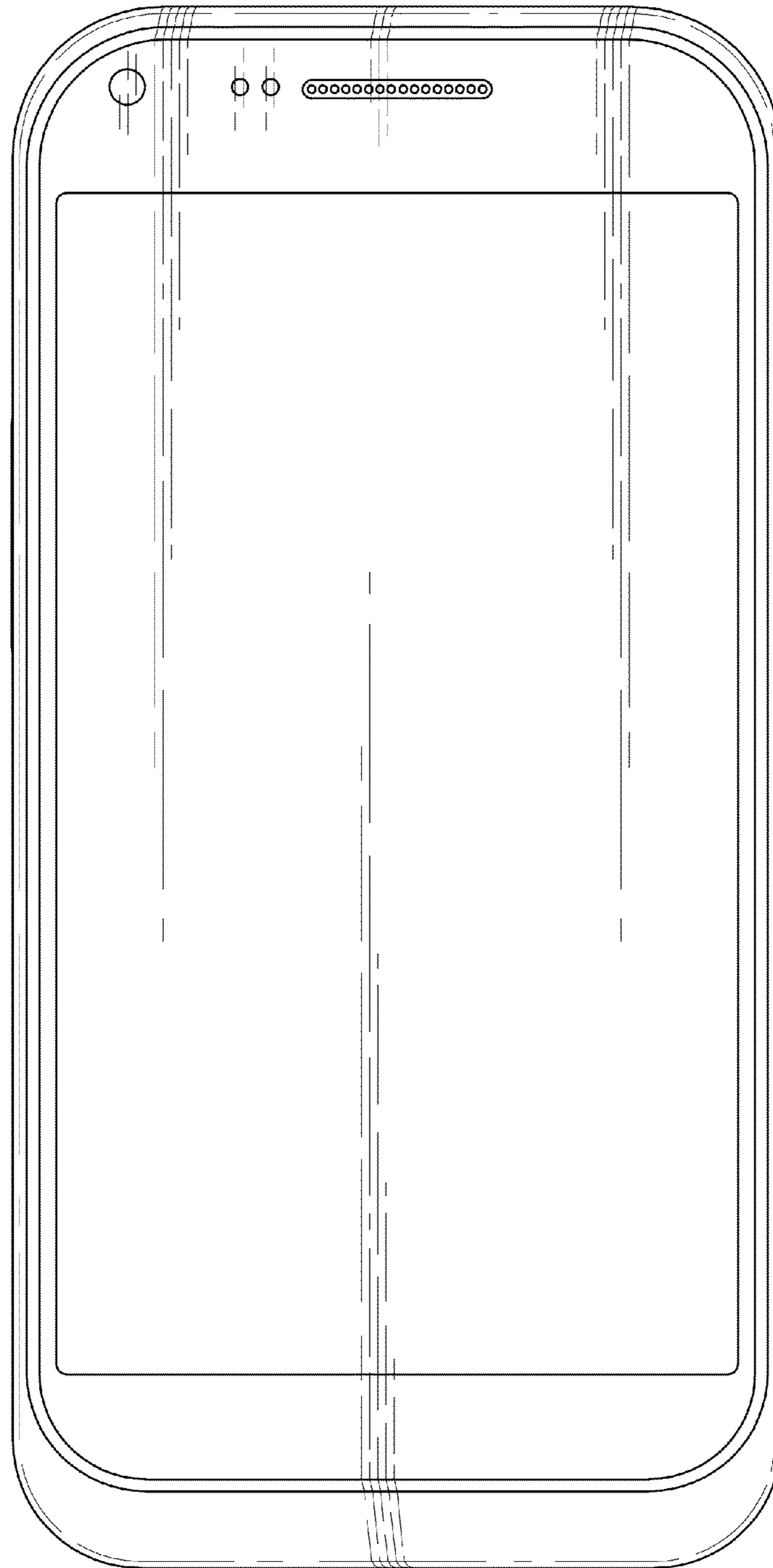

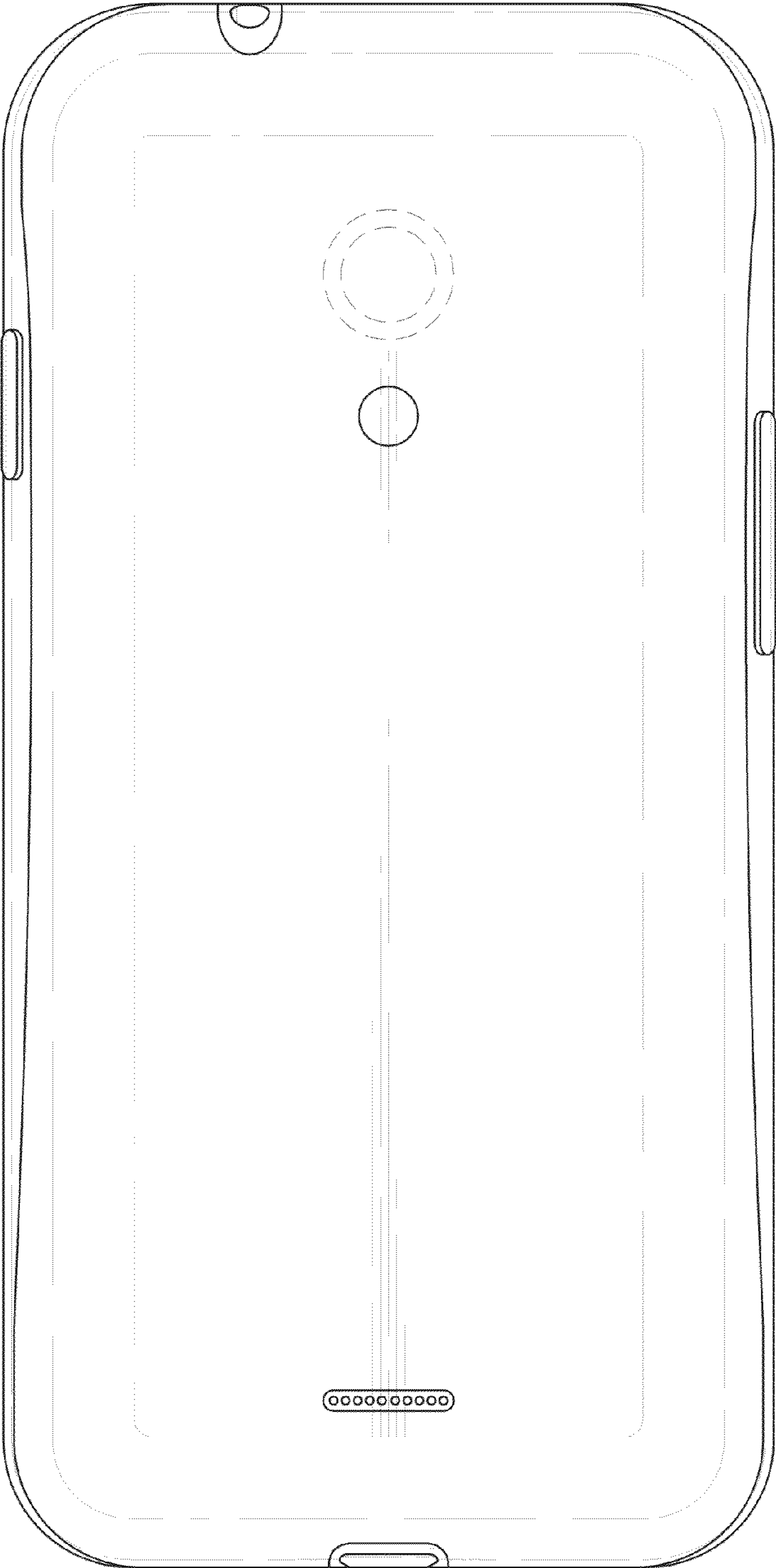

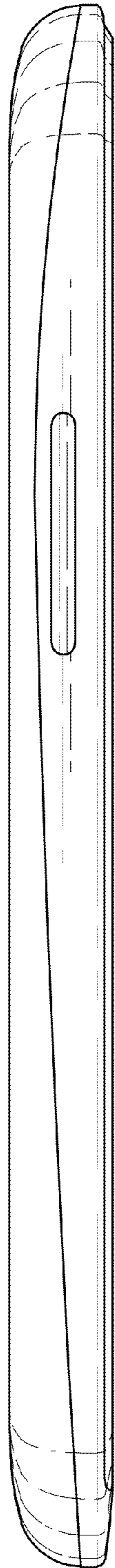

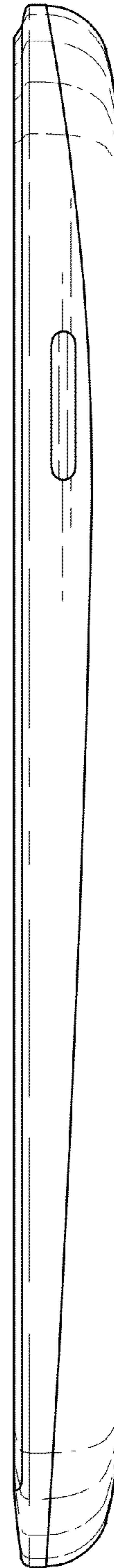

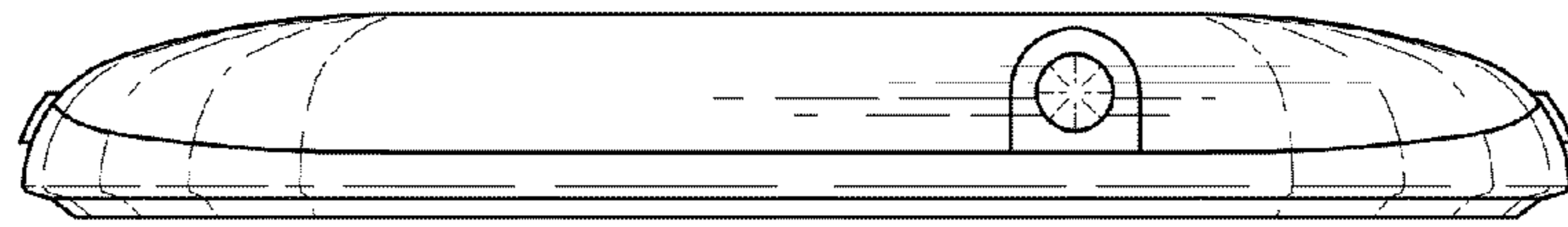
