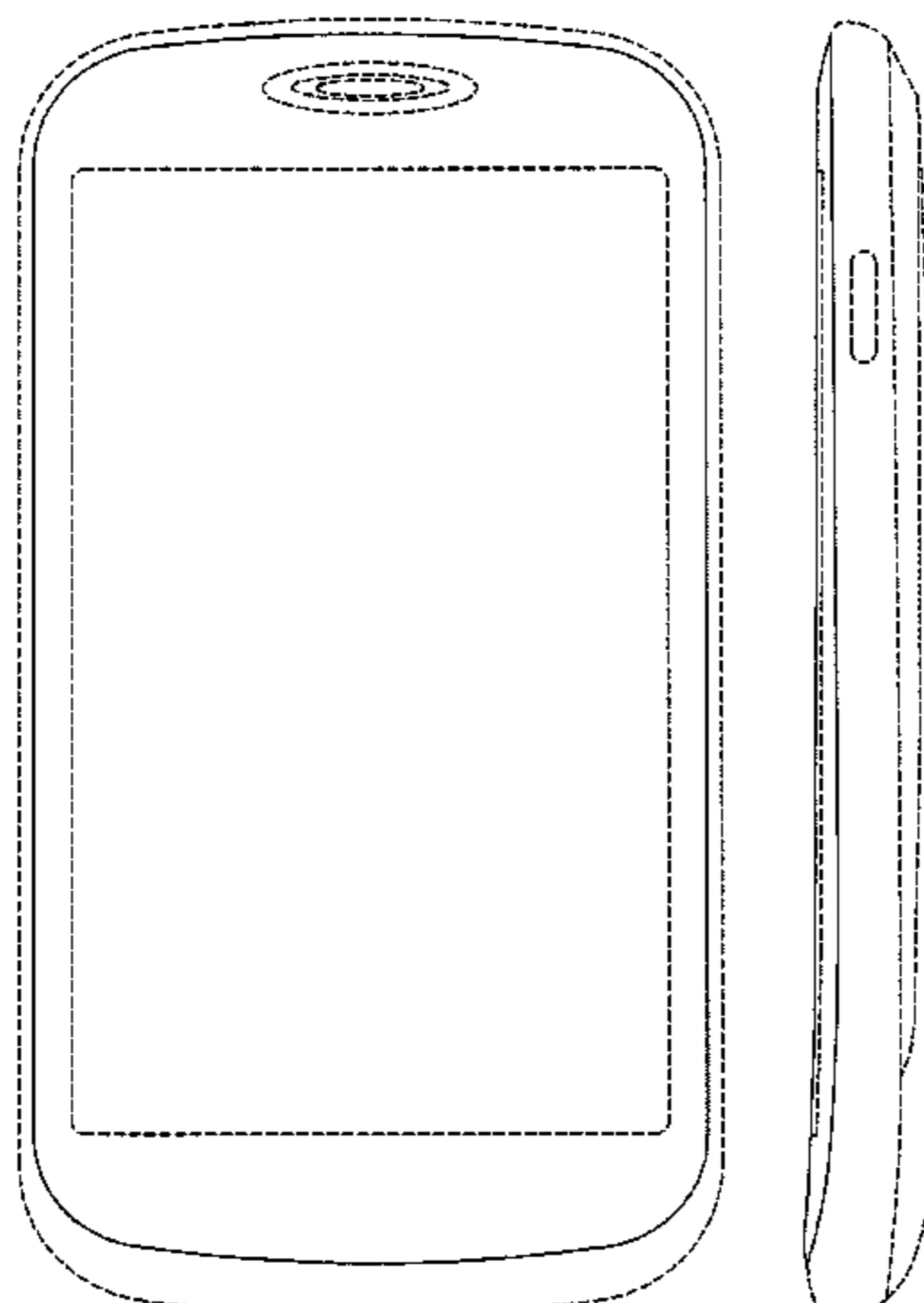
(57) **CLAIM**

I claim the ornamental design for a portable electronic device, as shown and described.

DESCRIPTION

FIG. 1 is a front/right-side/top perspective view of a portable electronic device showing our new design; FIG. 2 is a front-side elevational view thereof; FIG. 3 is a rear-side elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a top-side elevational view thereof; and, FIG. 7 is a bottom-side elevational view thereof. The broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

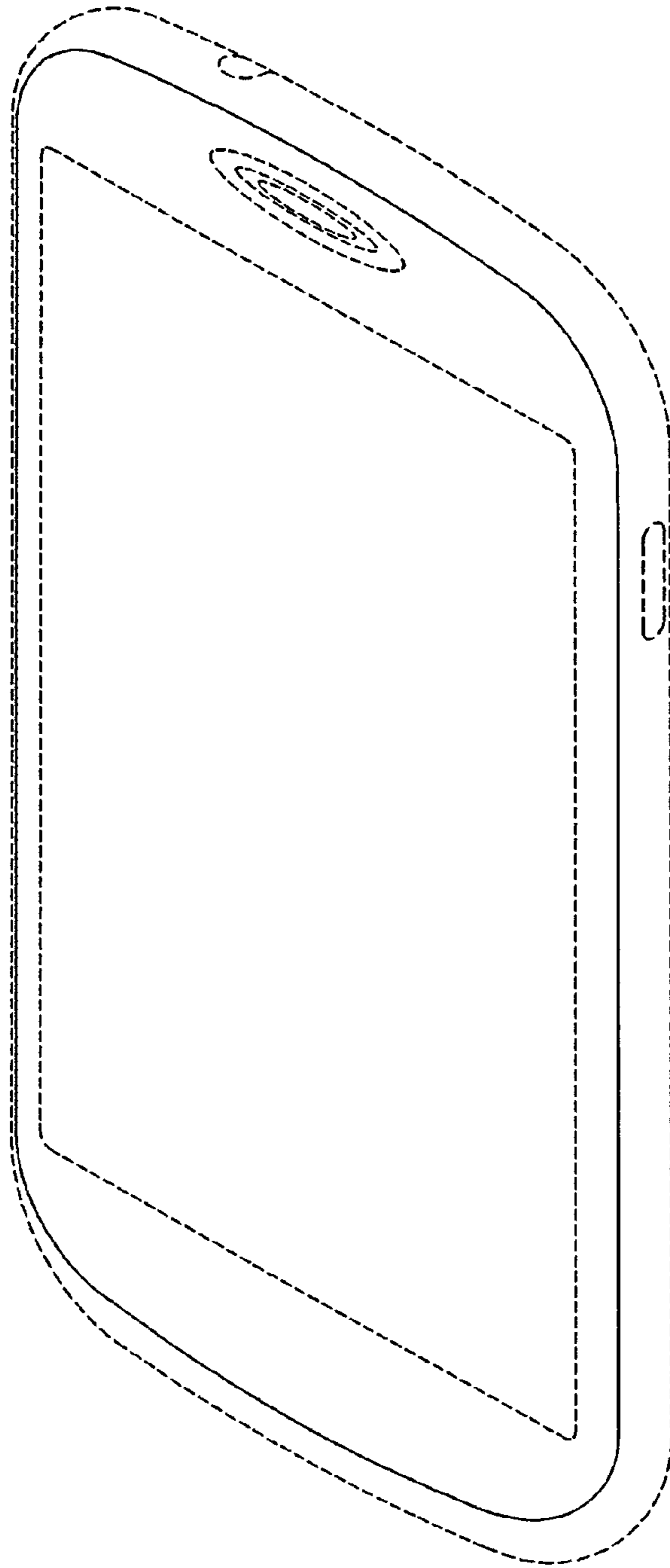

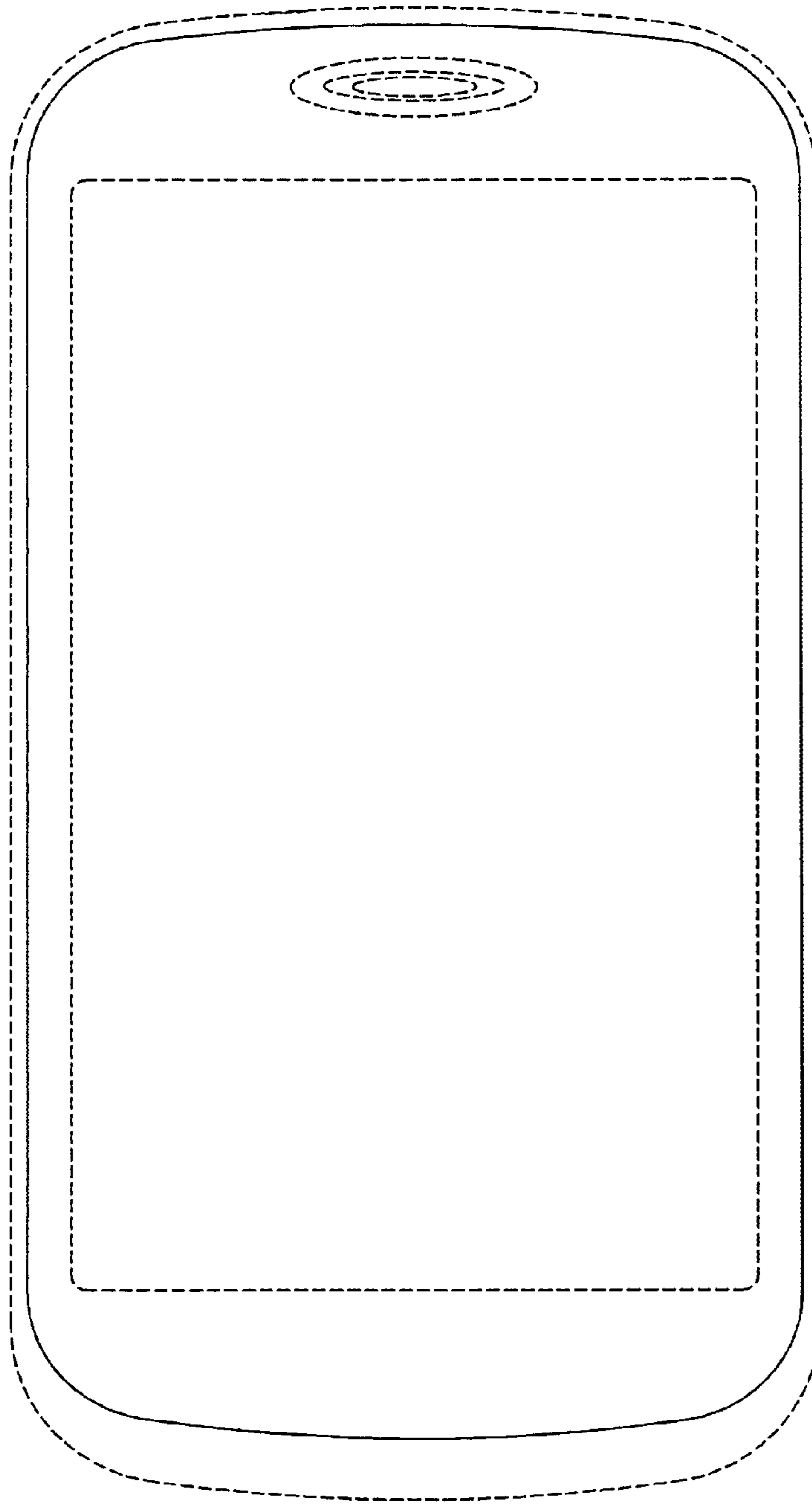

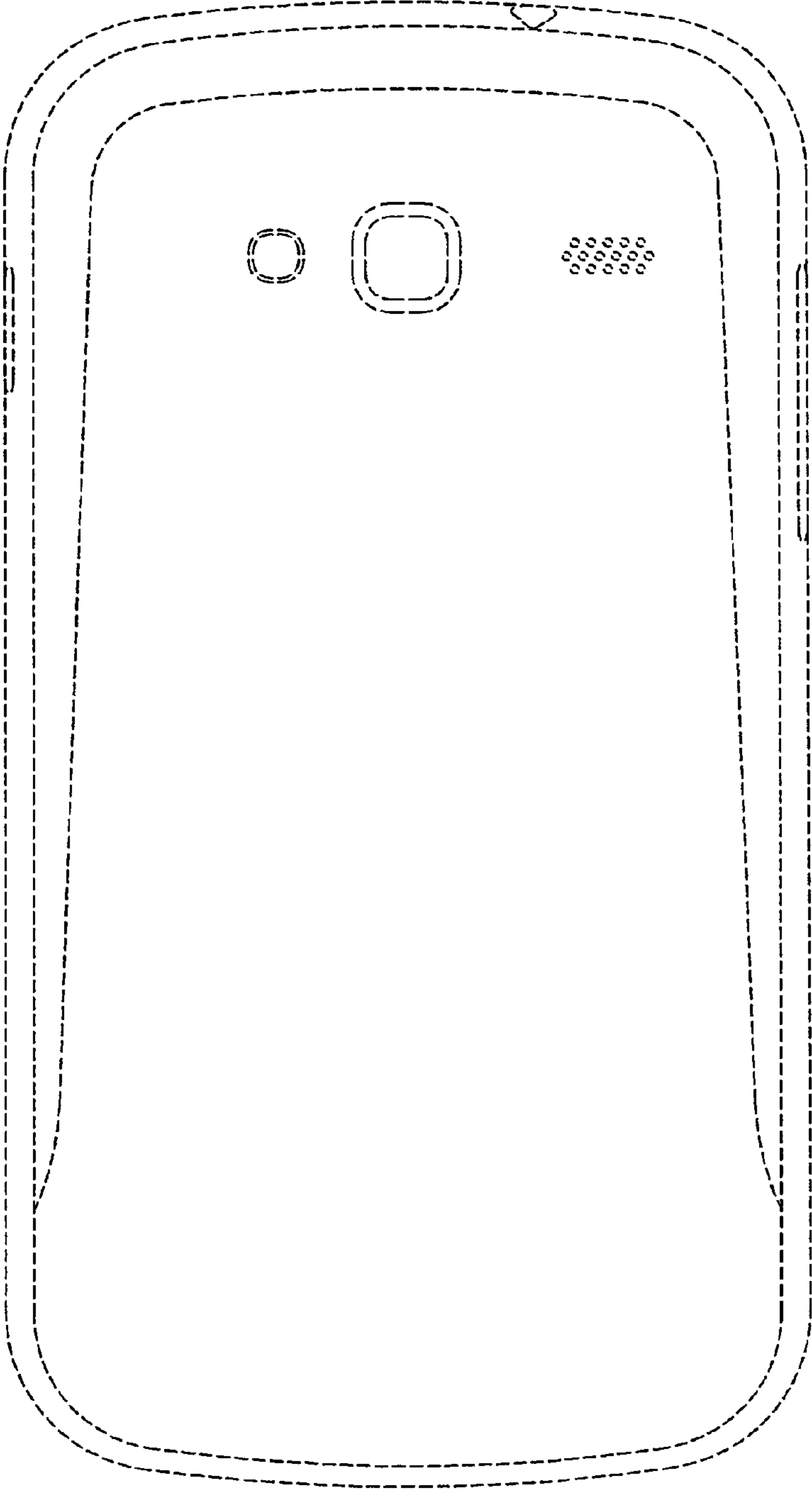

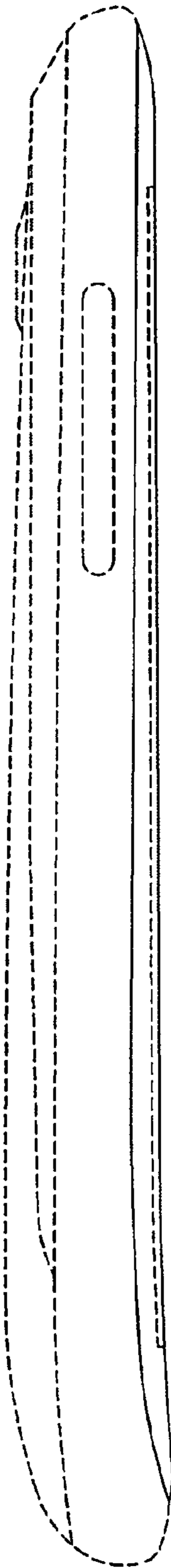

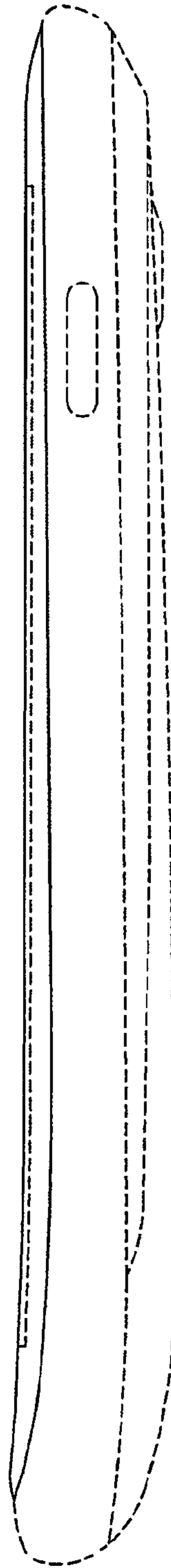

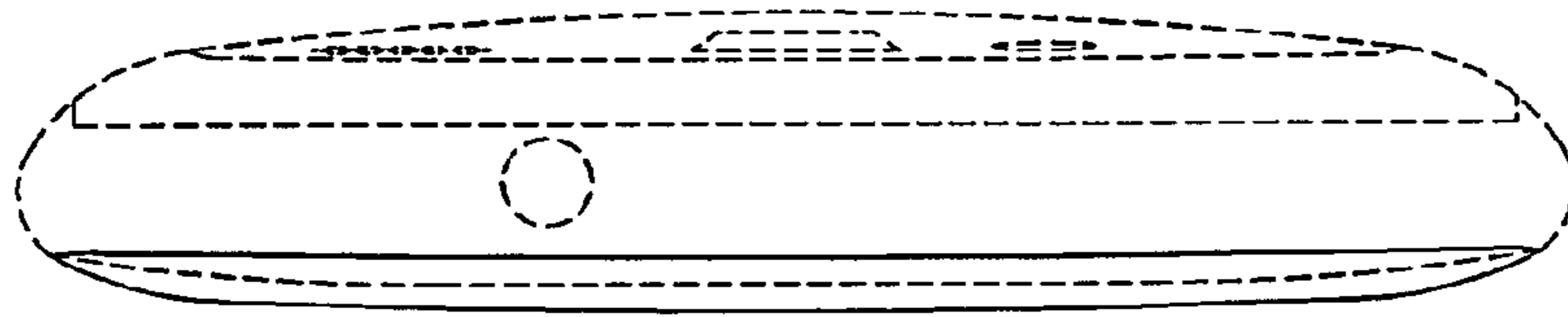
