(57) **CLAIM**

The ornamental design for a screen for projectors, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a screen for projectors showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof where the right side view is a mirror image;
FIG. 5 is a top plan view thereof where the bottom plan view is a mirror image; and,
FIG. 6 is an enlarged view of the area enclosed in dashed lines in FIG. 4.

The broken lines shown in the drawings depict environmental features that form no part of the claimed design.

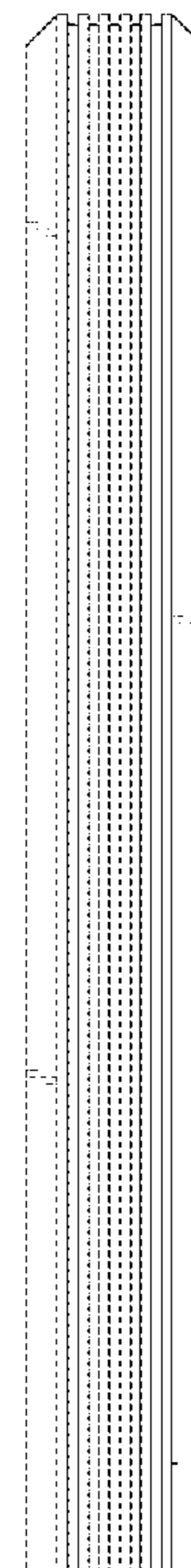
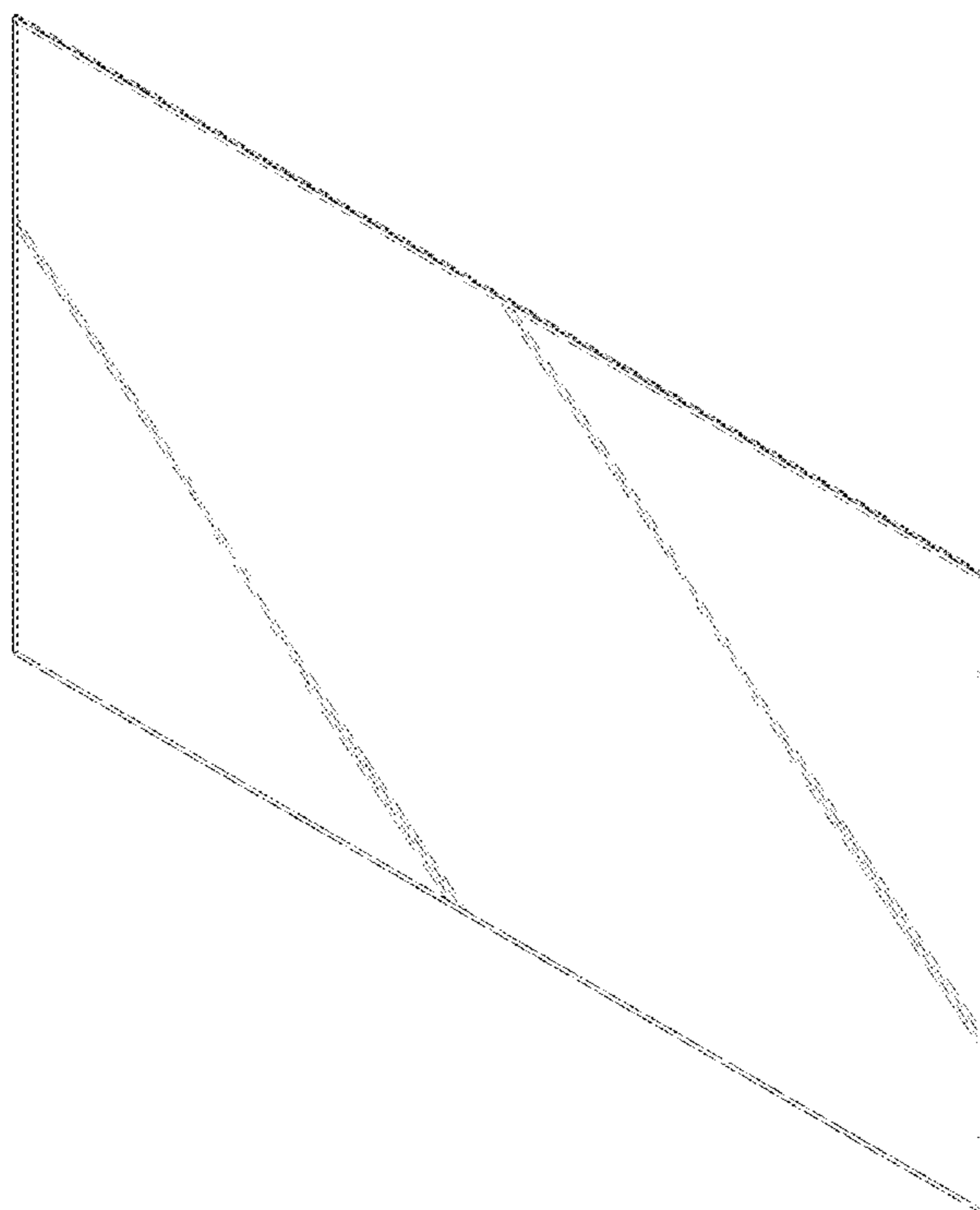

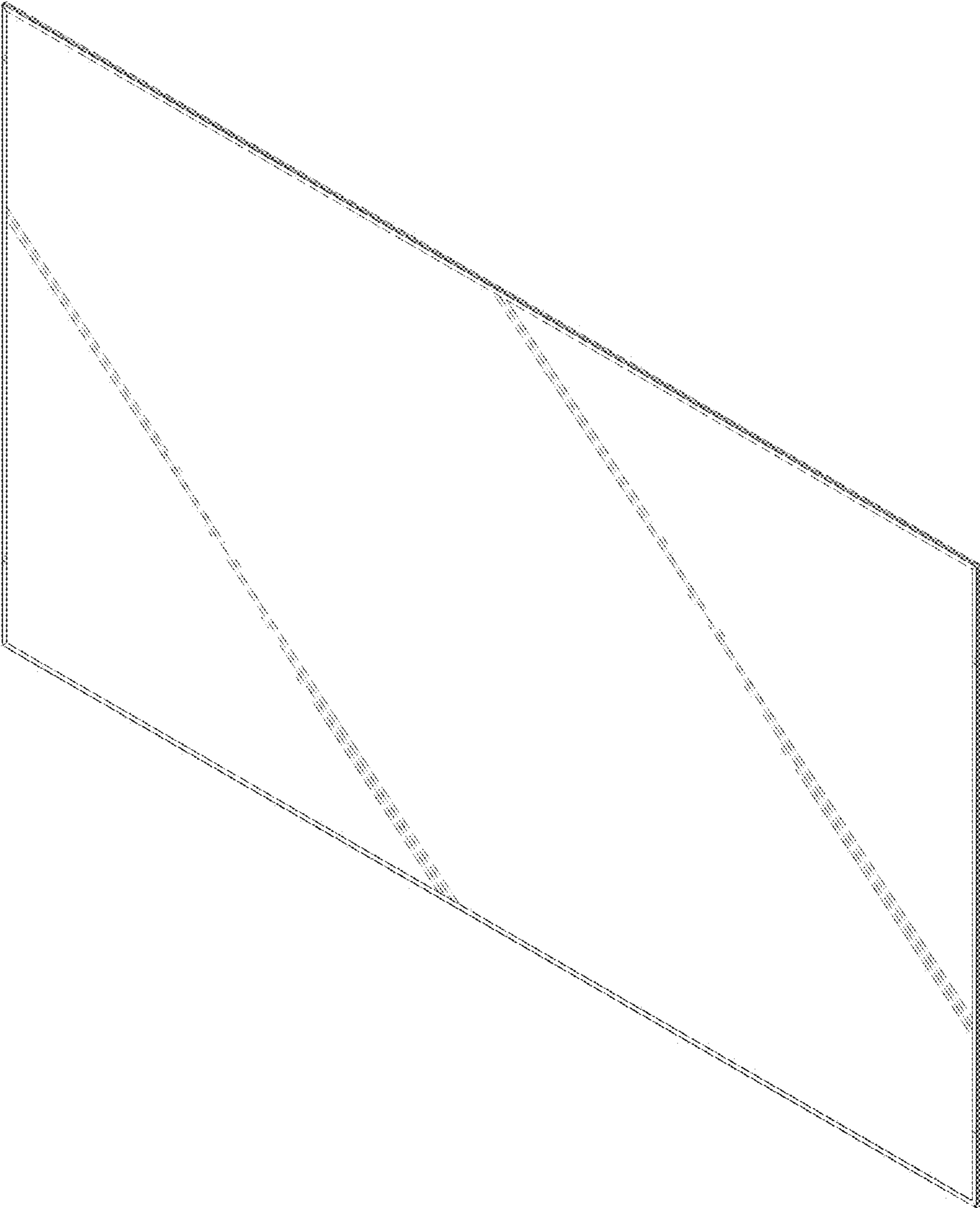

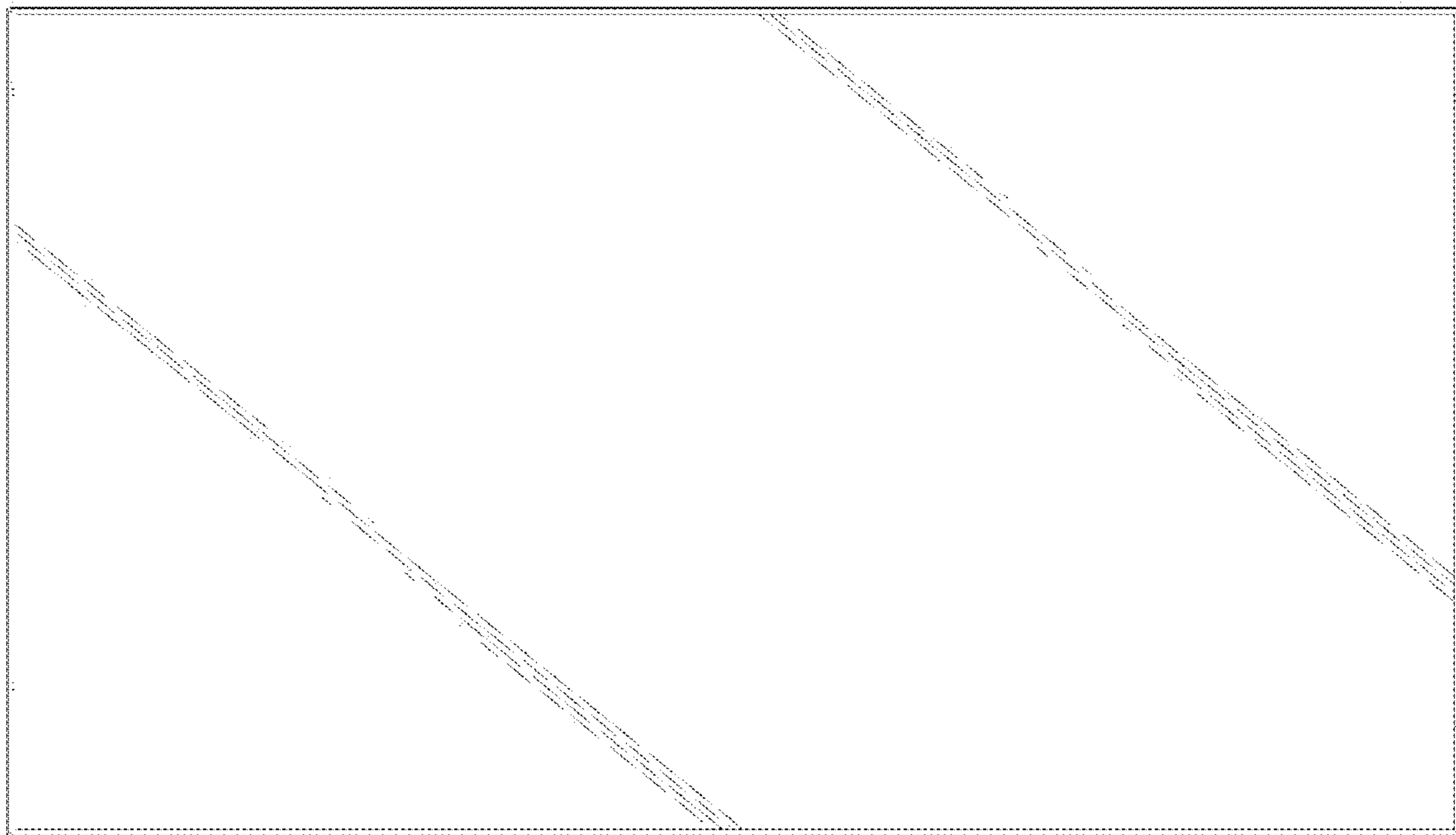

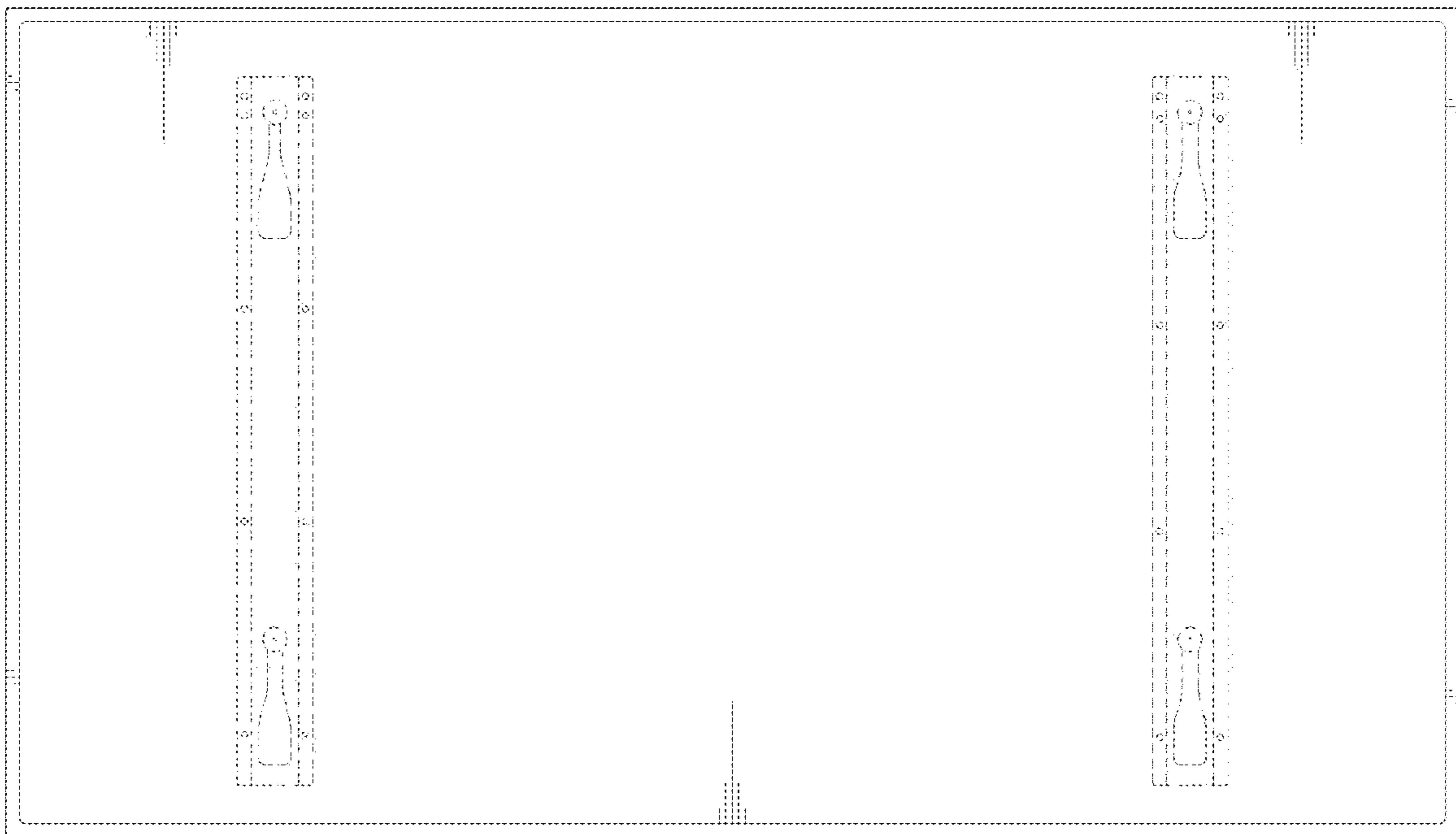

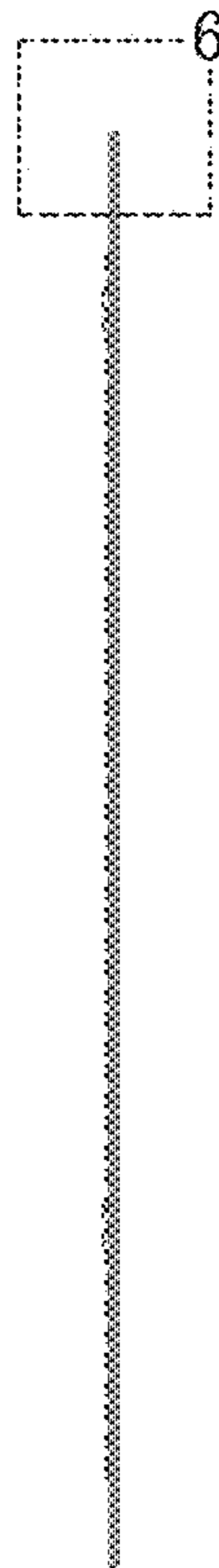
