**DESCRIPTION**

FIG. 1 is a perspective view of an HVAC cover of the present  
invention in its relaxed position.

FIG. 2 is a perspective view of the HVAC cover of the present  
invention, in its extended position;

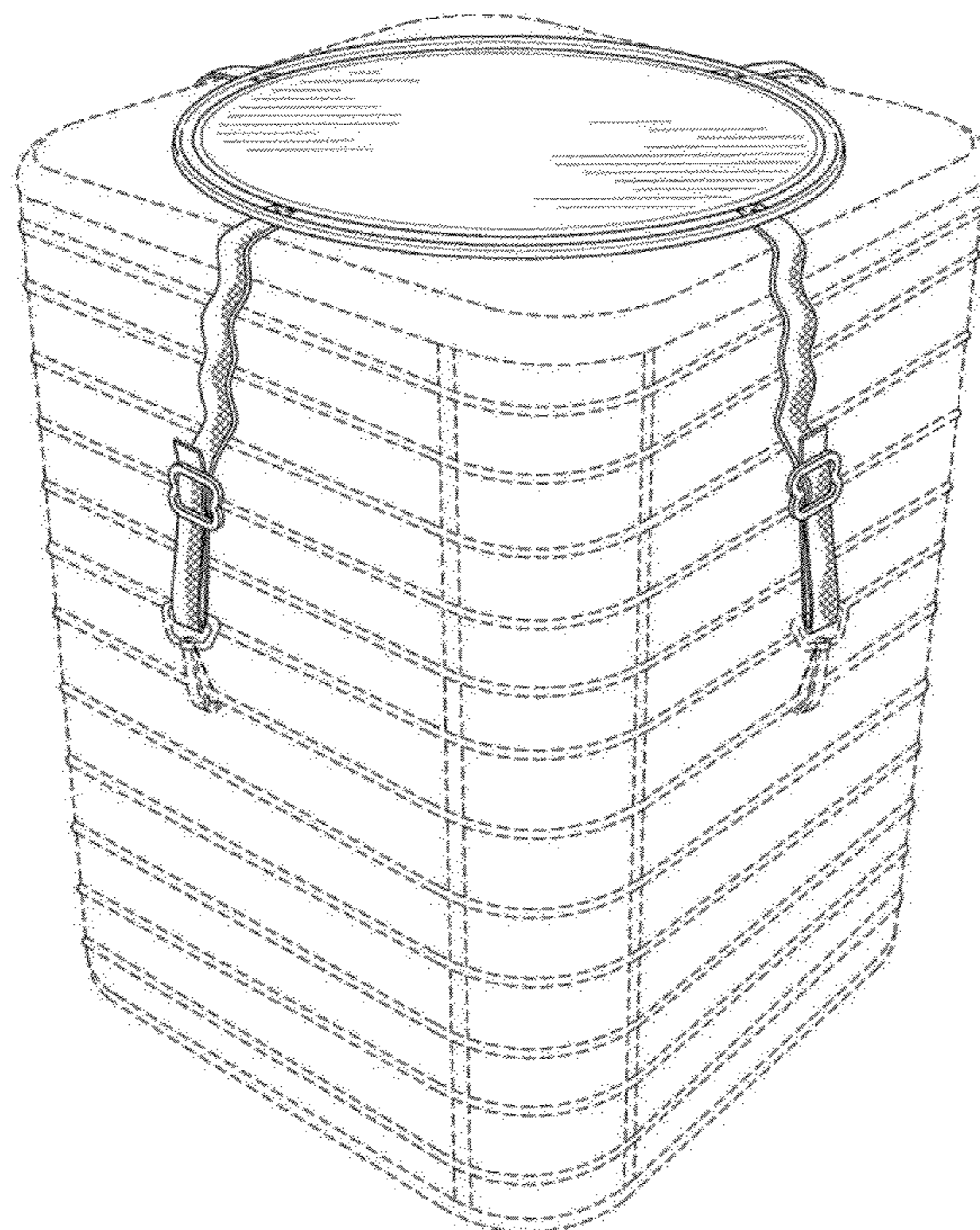
FIG. 3 is a top plan view of the HVAC cover of FIG. 1

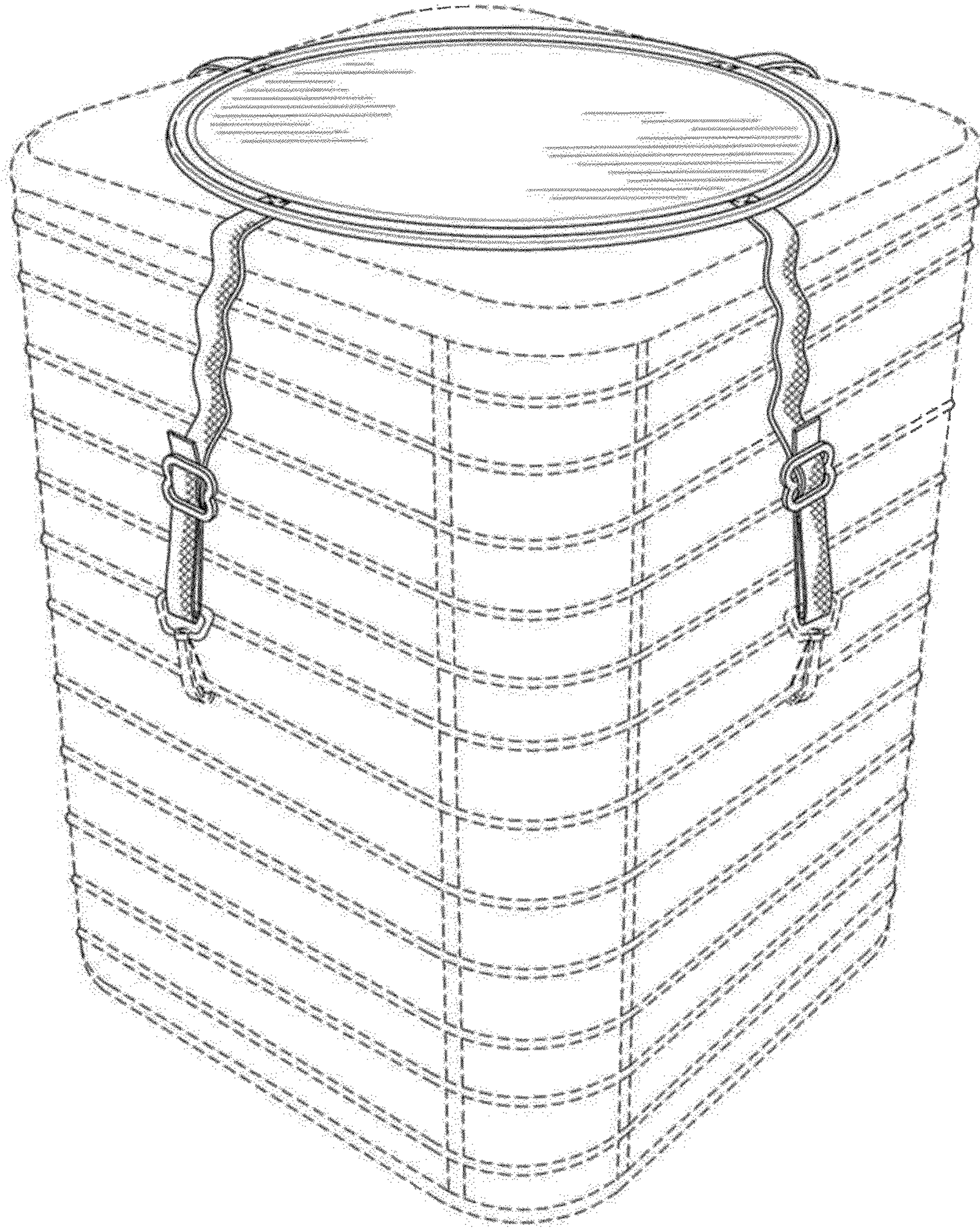

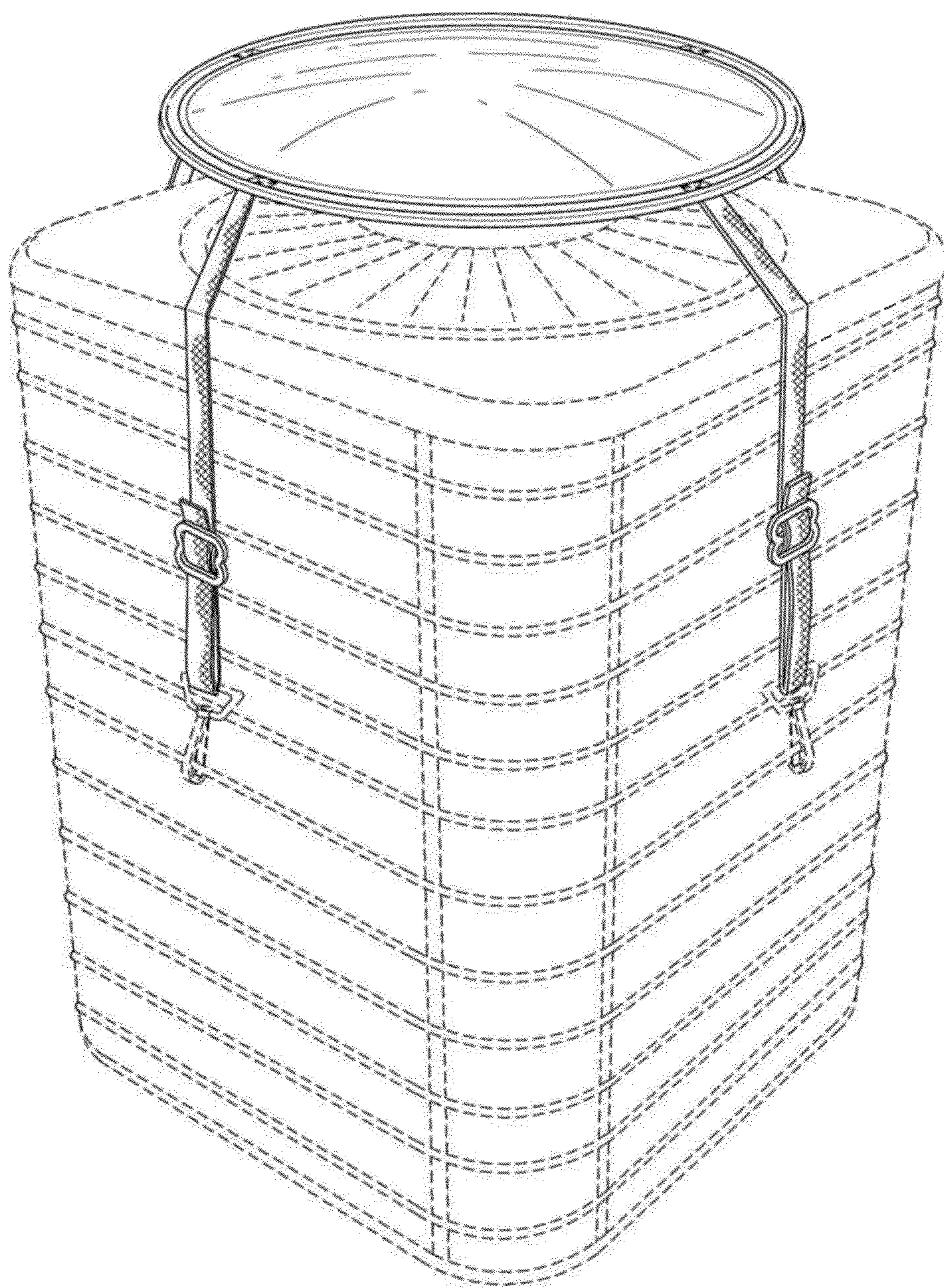

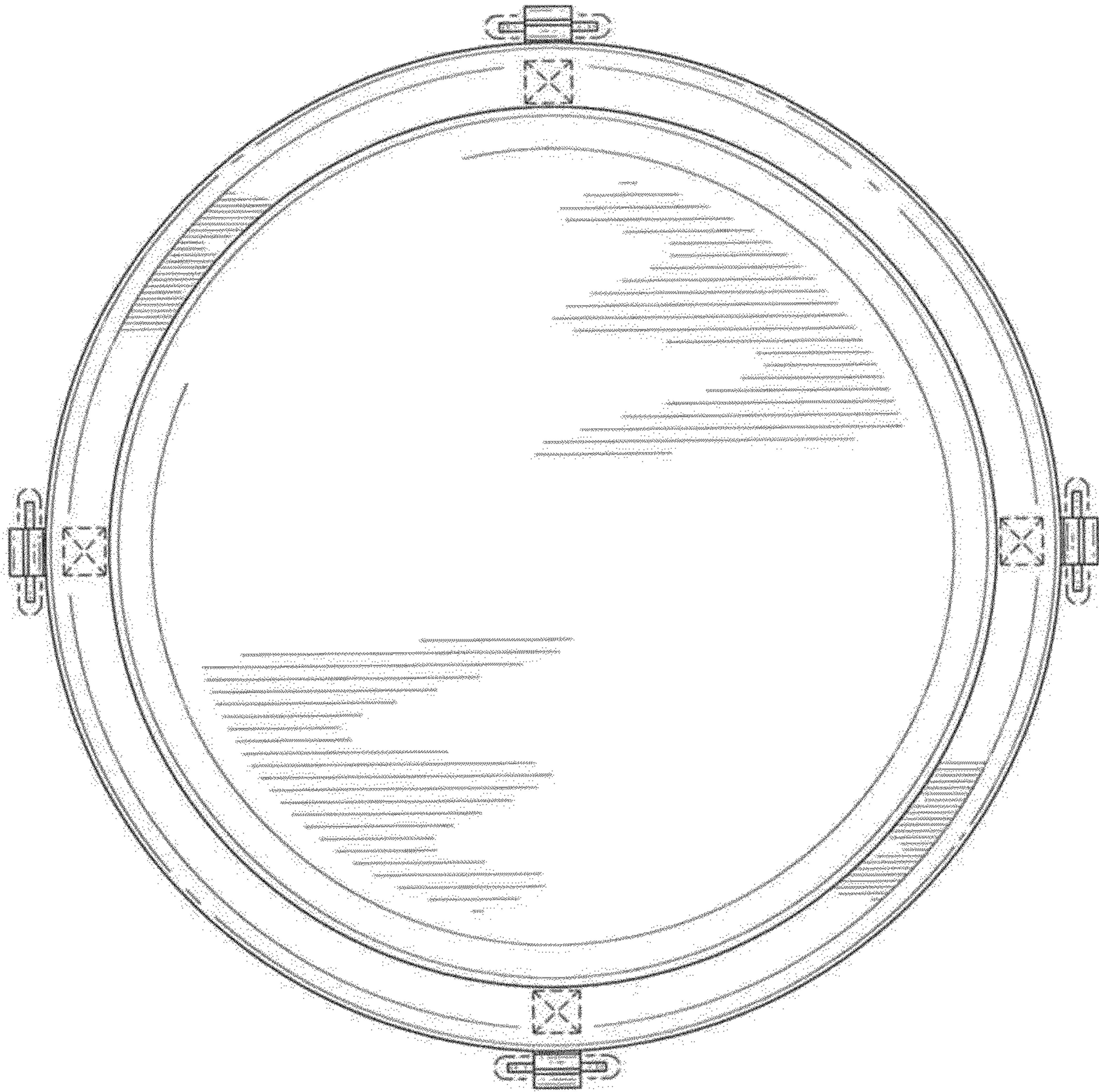

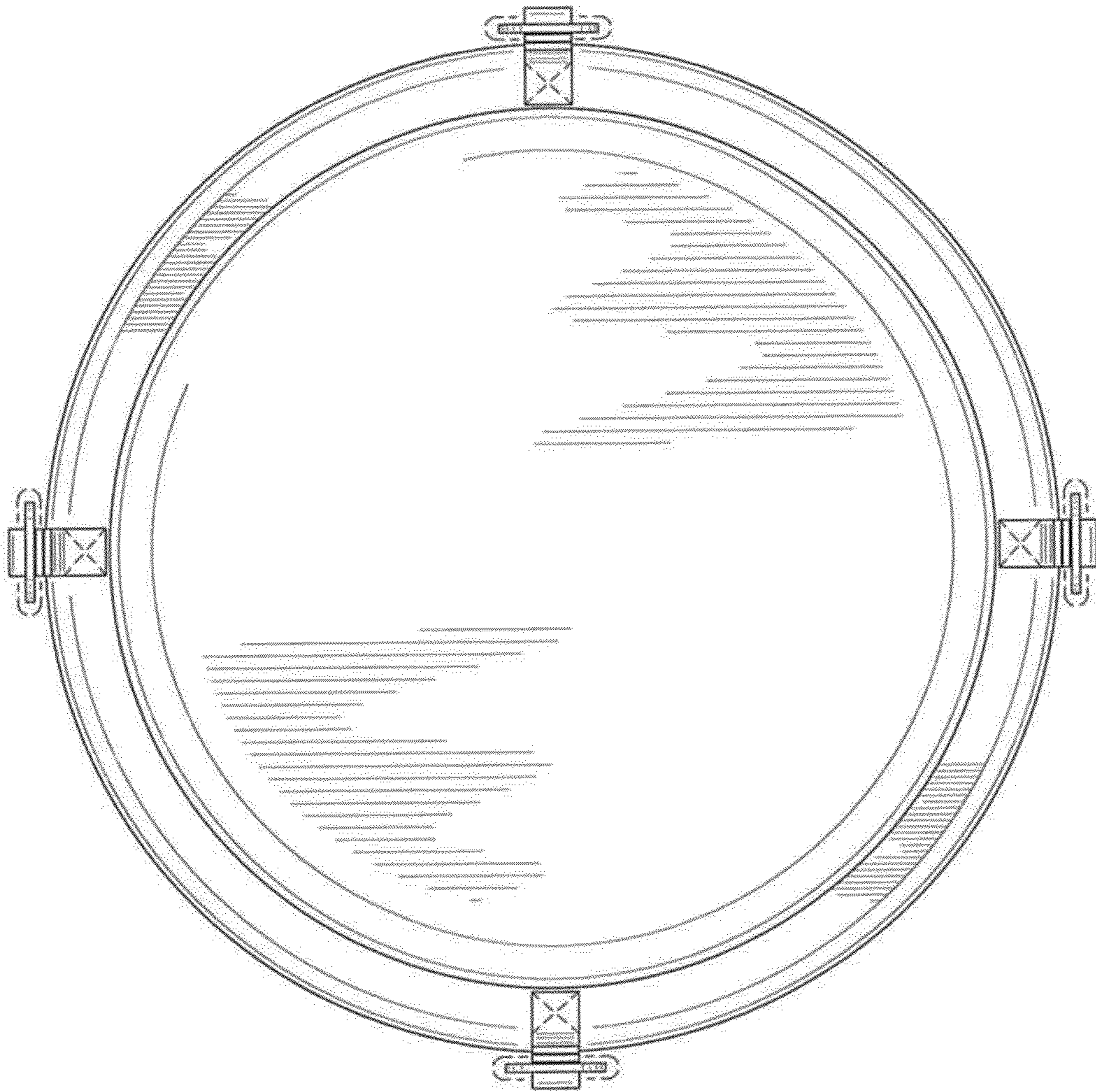

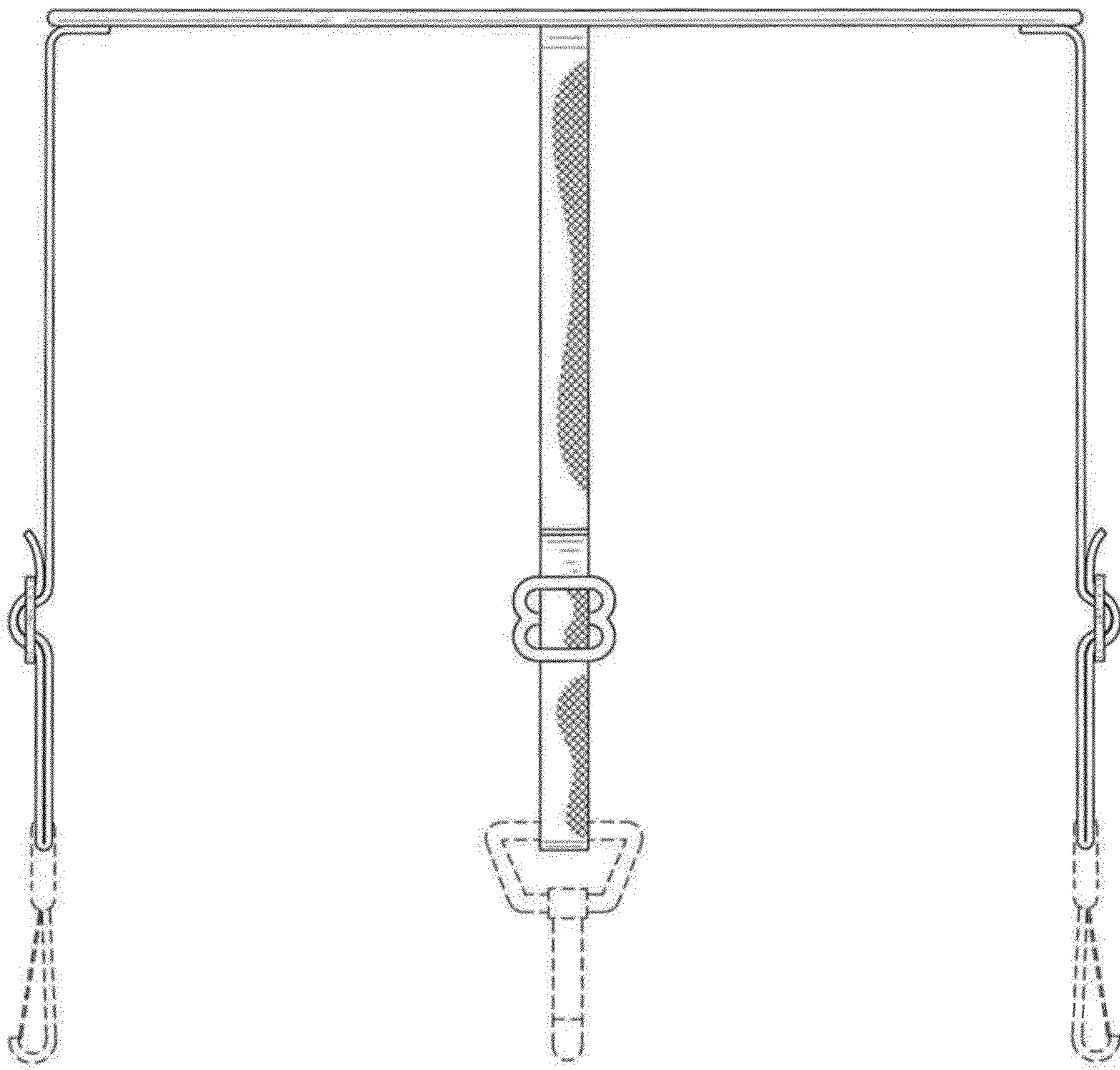
