(57) **CLAIM**

The ornamental design for a massage roller, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a massage roller;

FIG. 2 is a front view of the massage roller shown in FIG. 1;

FIG. 3 is a top view of the massage roller shown in FIG. 1;

FIG. 4 is a right end view thereof, the left end view being identical to the right end view;

FIG. 5 is a front view of a second embodiment, the end view being the same as those of FIG. 4;

FIG. 6 is a front view of a third embodiment, the end view being the same as those of FIG. 4;

FIG. 7 is a front view of a fourth embodiment, the end view being the same as those of FIG. 4;

FIG. 8 is a front view of a fifth embodiment, the left end view being the same as that of FIG. 4;

FIG. 9 is a right side view of the roller massager shown in FIG. 8;

FIG. 10 is a front view of a sixth embodiment, both end views being the same as that shown in FIG. 9;

FIG. 11 is a front view of a seventh embodiment, both end views being the same as that of FIG. 9;

FIG. 12 is a front view of an eighth embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9;

FIG. 13 is a front view of a ninth embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9;

FIG. 14 is a front view of a tenth embodiment, both end views being the same as that shown in FIG. 9;

FIG. 15 is a front view of an eleventh embodiment, both end views being the same as that shown in FIG. 9;

FIG. 16 is a front view of a twelfth embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9;

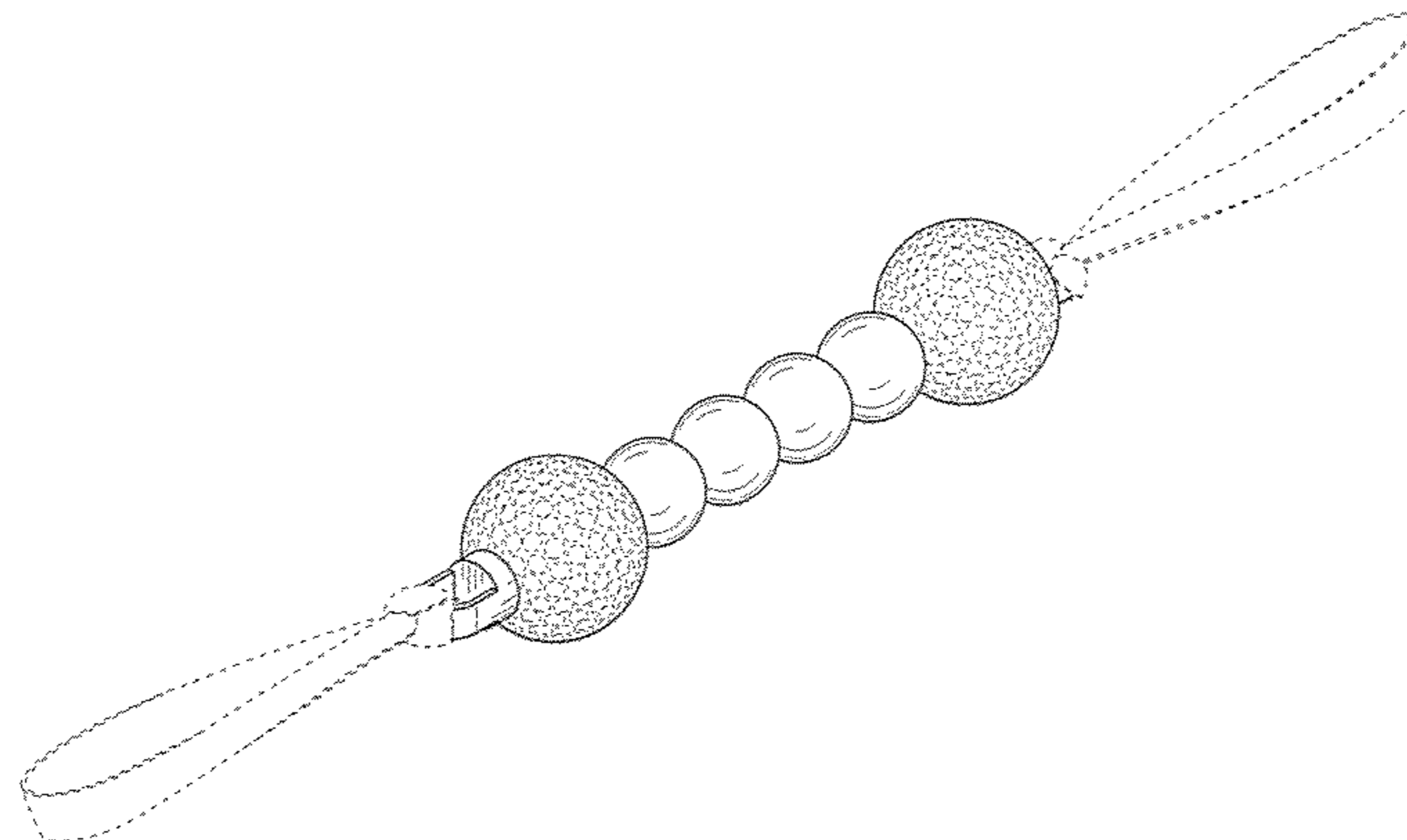


FIG. 17 is a front view of a thirteenth embodiment, both end views being the same as that of FIG. 9;

FIG. 26 is a front view of a twenty second embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9;

FIG. 27 is a front view of a twenty third embodiment, both end views being the same as that shown in FIG. 9;

FIG. 28 is a front view of a twenty fourth embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9;

FIG. 42 is a front view of a thirty eighth embodiment, both end views being the same as that shown in FIG. 9;

FIG. 43 is a front view of a thirty ninth embodiment, the left end view being the same as that shown in FIG. 4 and the right end view being the same as that shown in FIG. 9; and,

FIG. 44 is a front view of a fortieth embodiment, both end views being the same as that shown in FIG. 9.

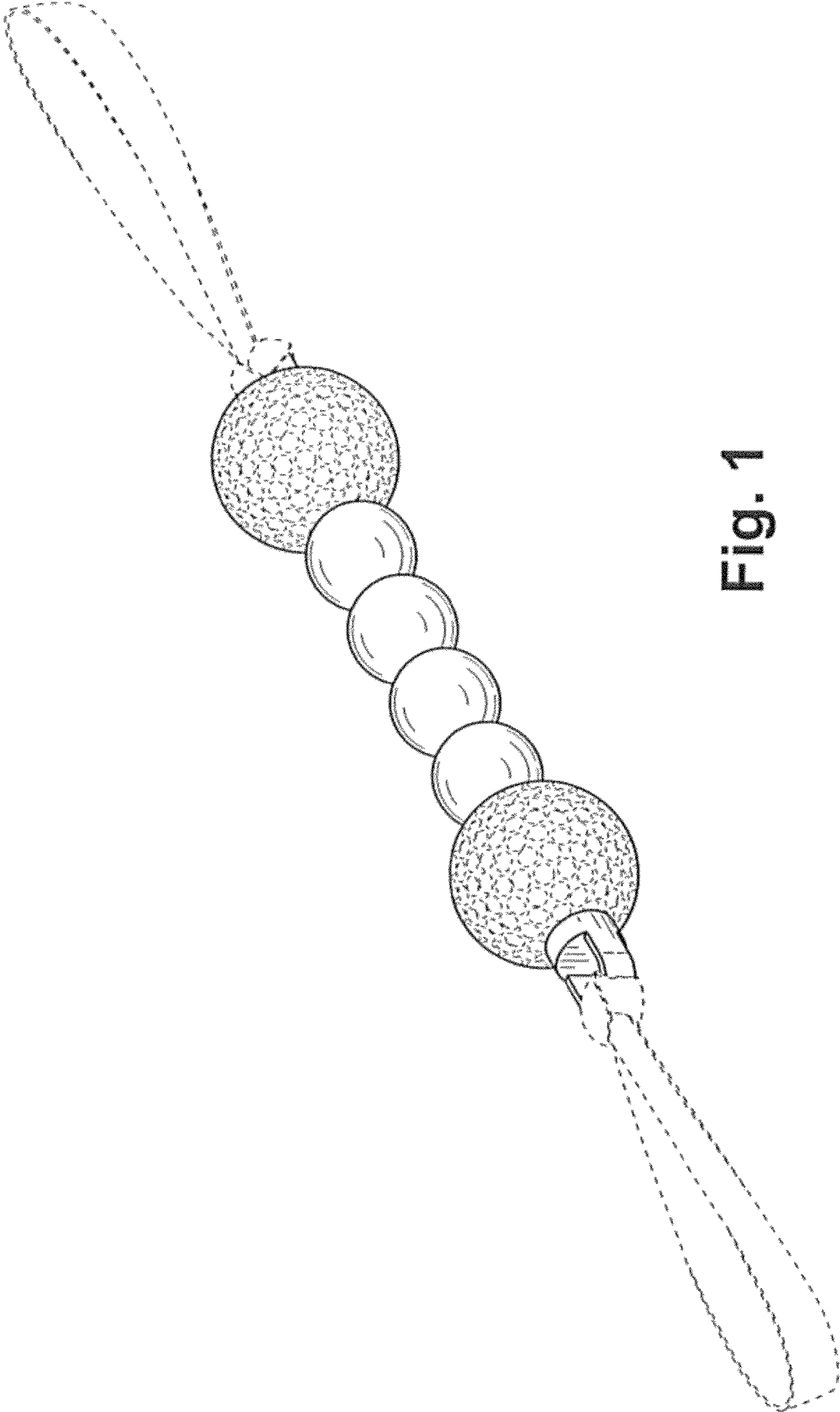

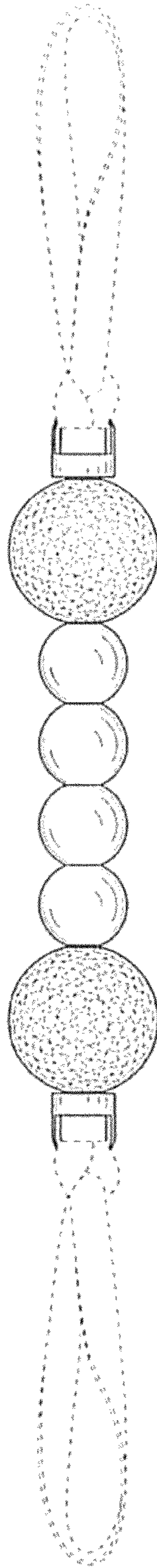

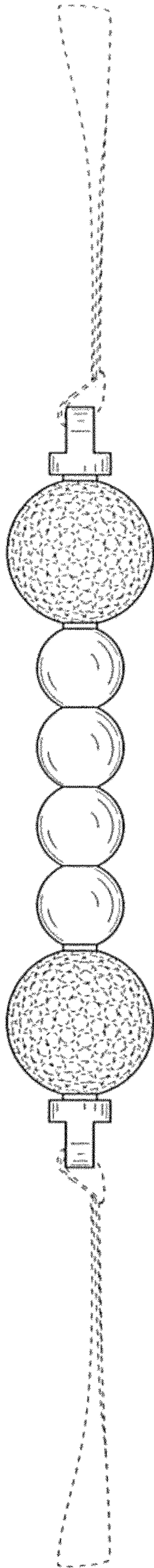

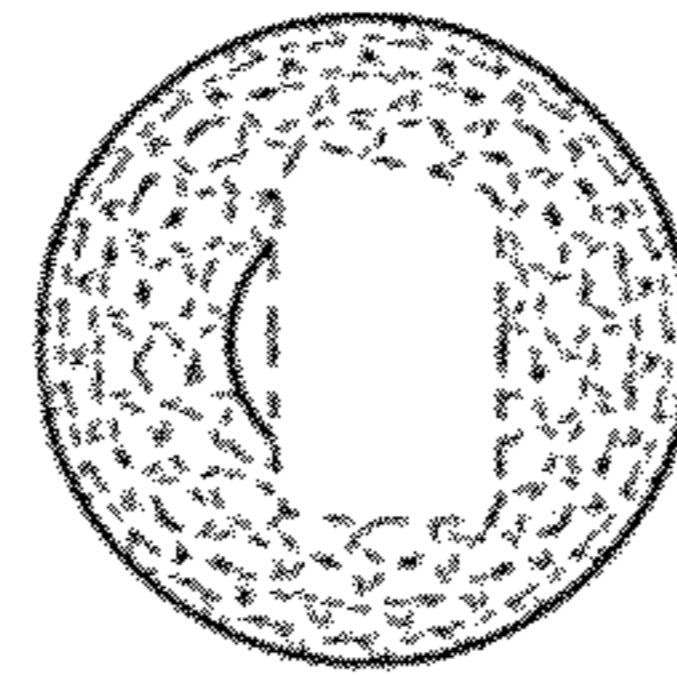

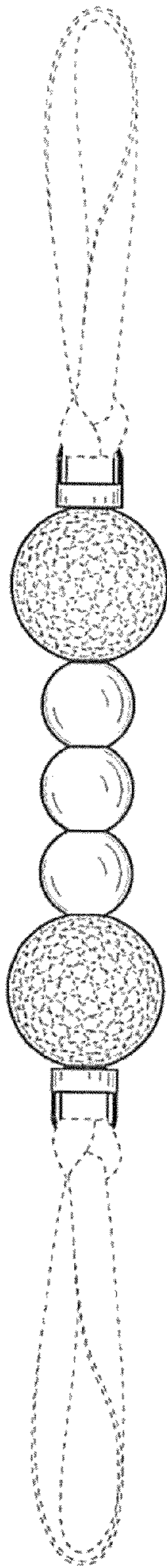

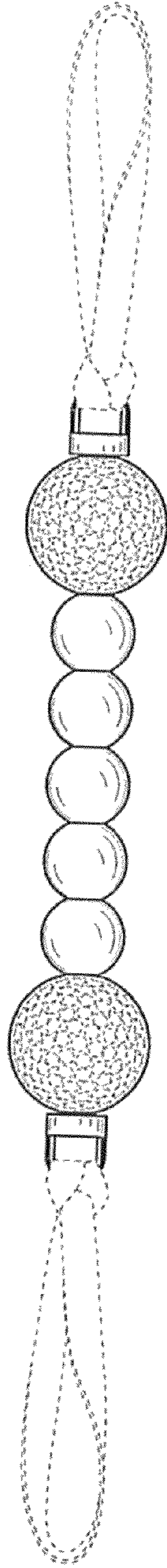

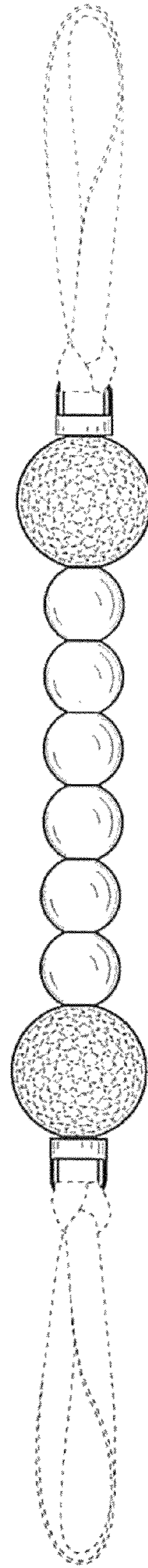

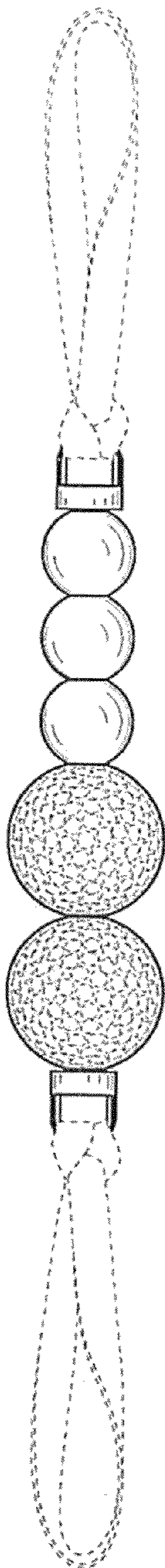

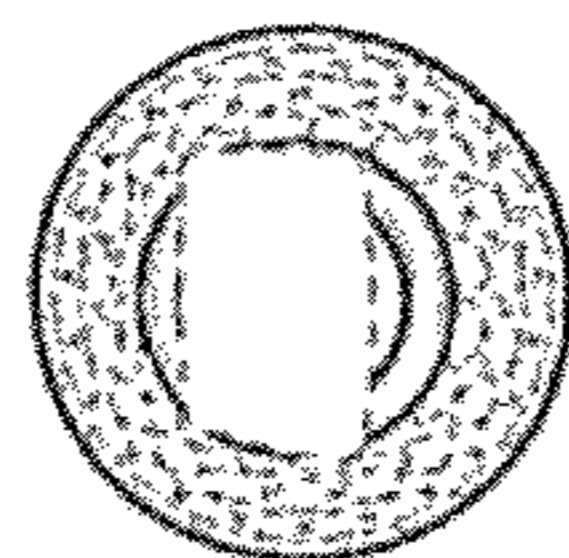

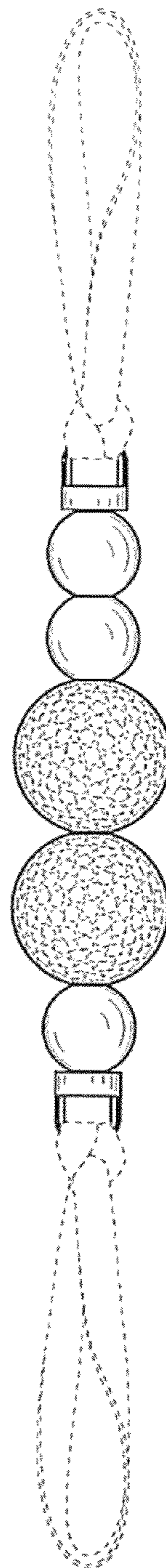

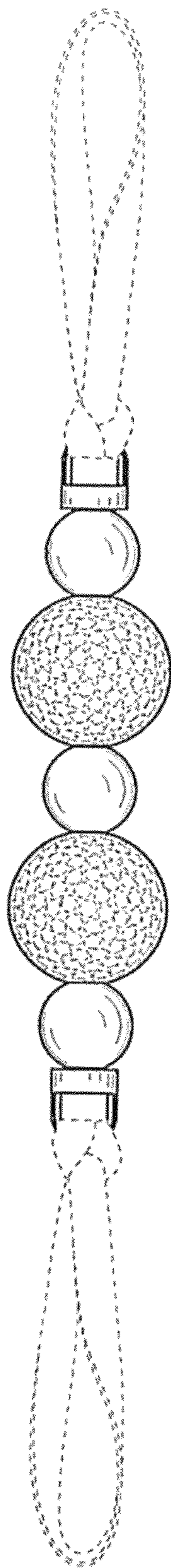

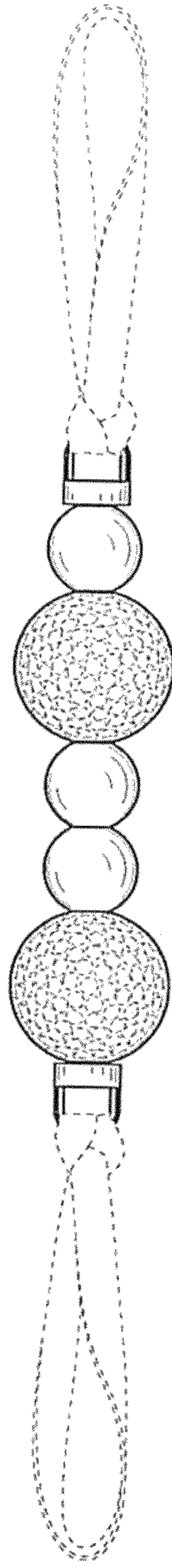

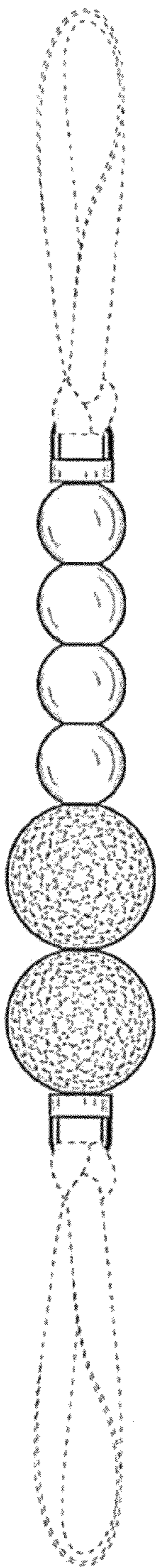

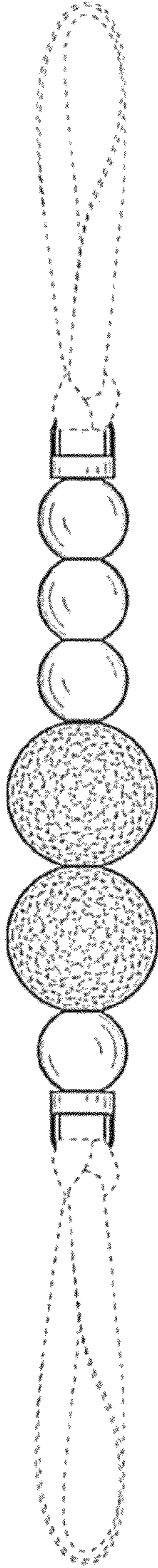

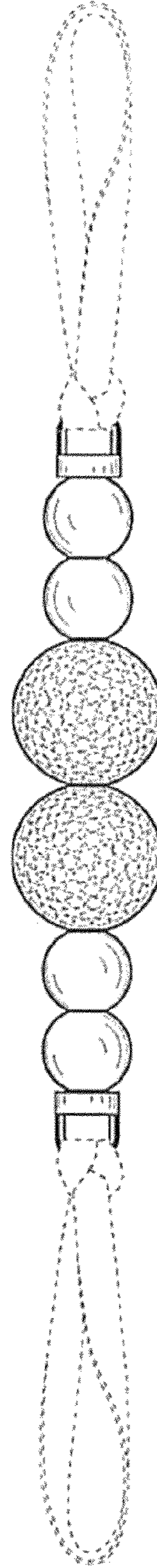

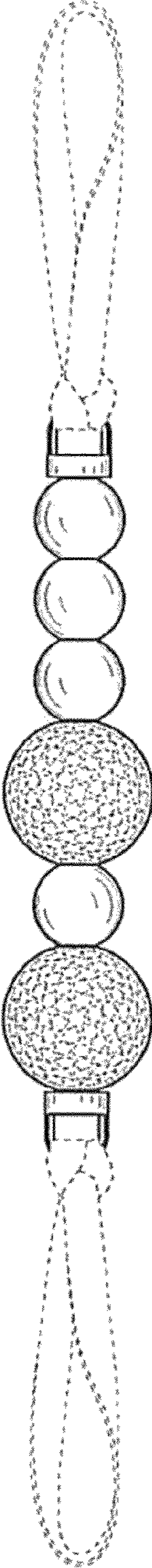

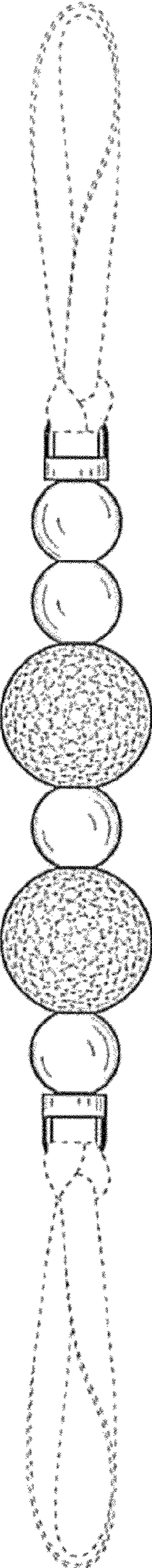

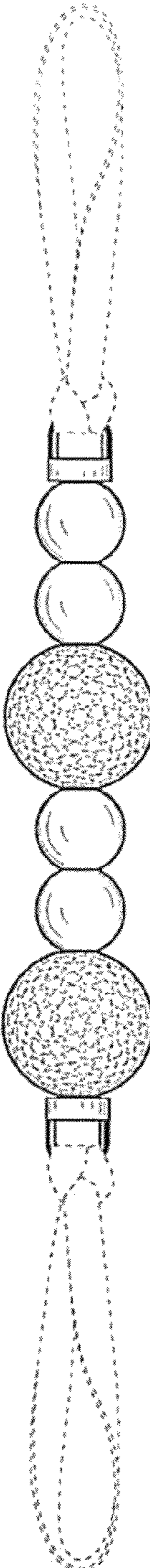

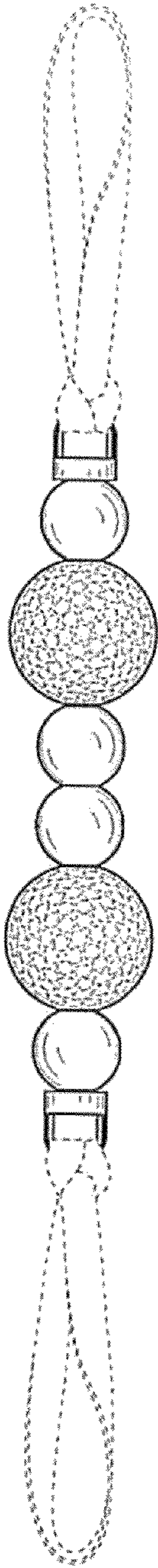

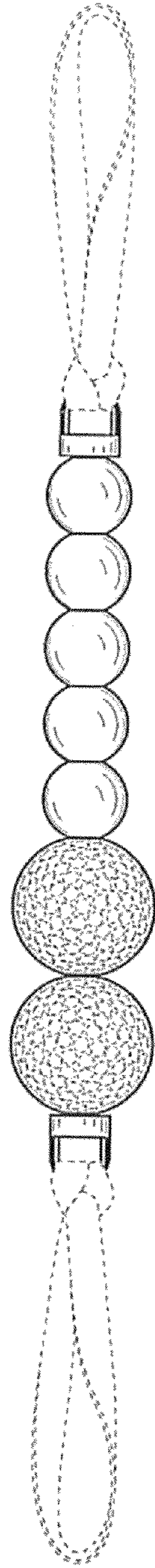

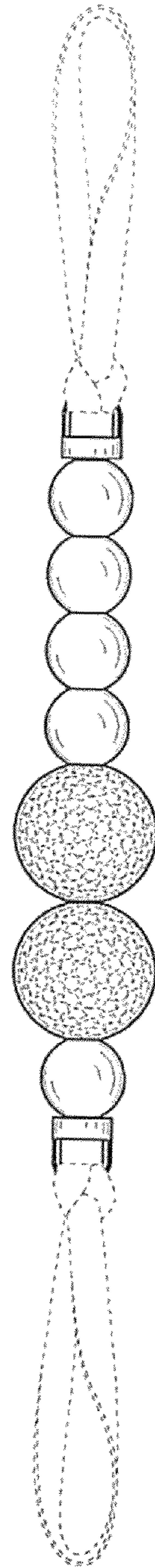

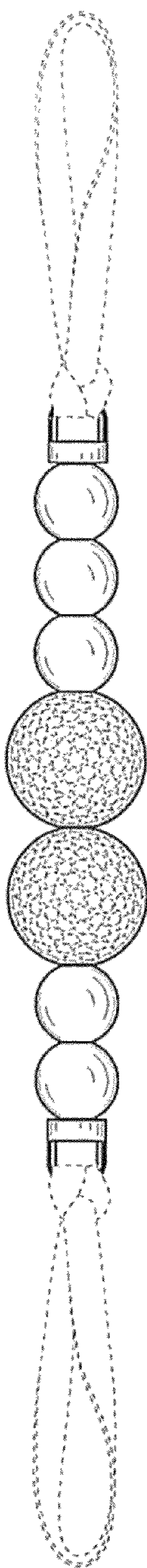

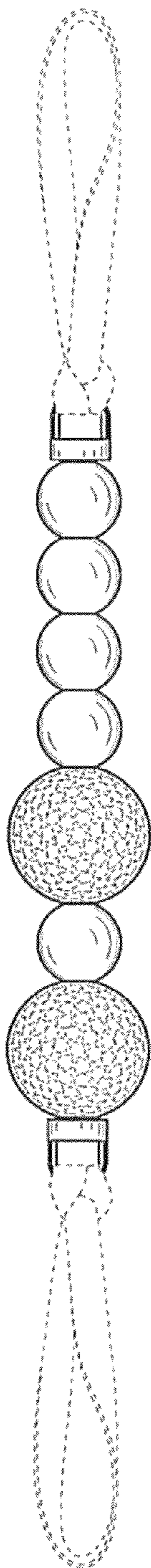

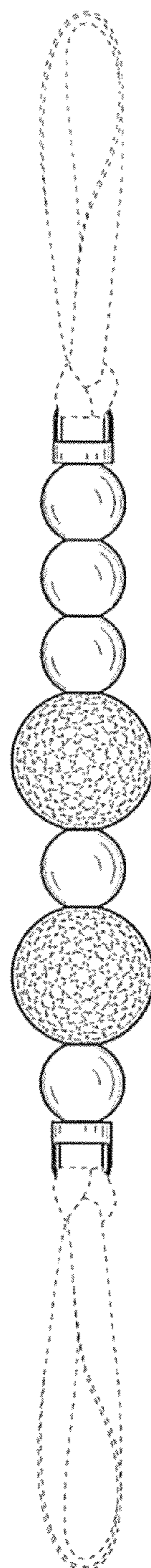

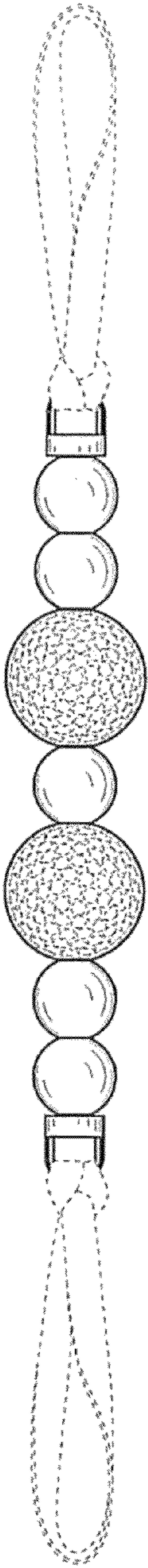

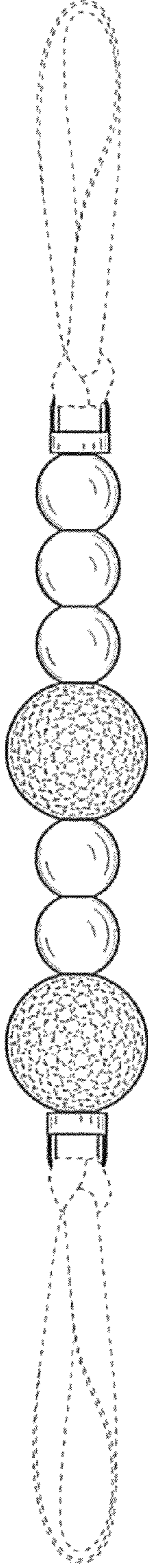

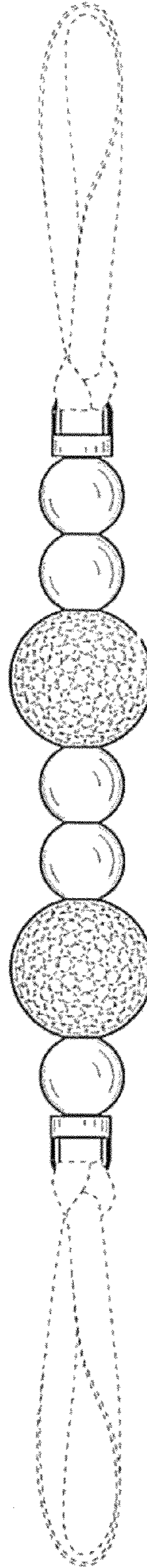

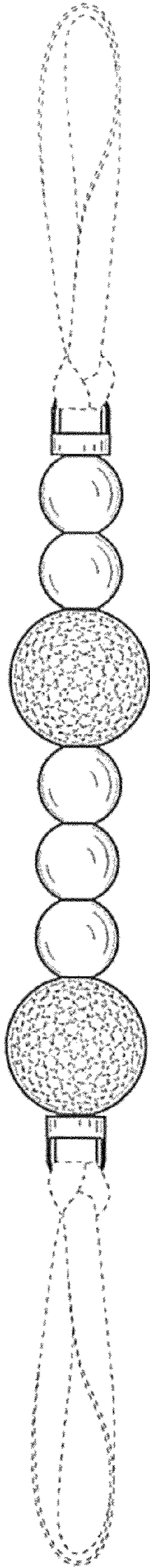

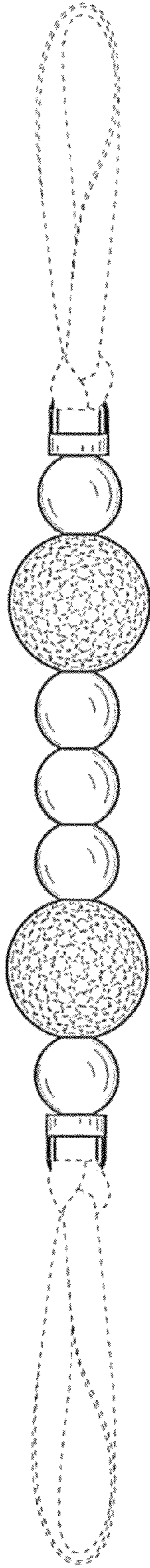

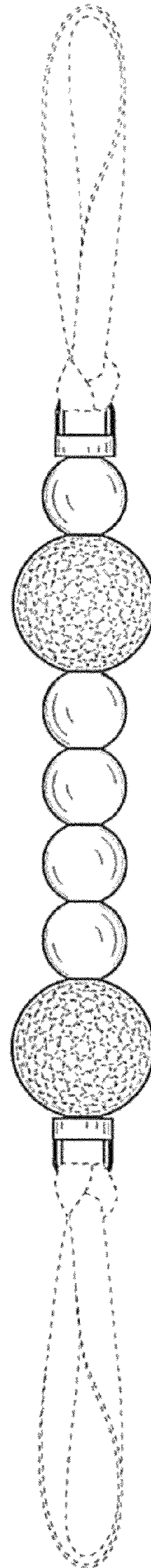

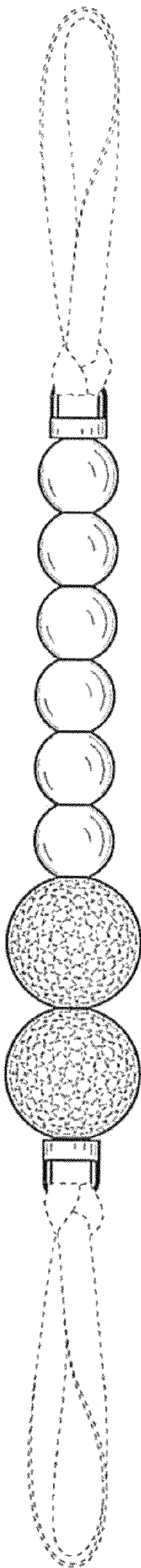

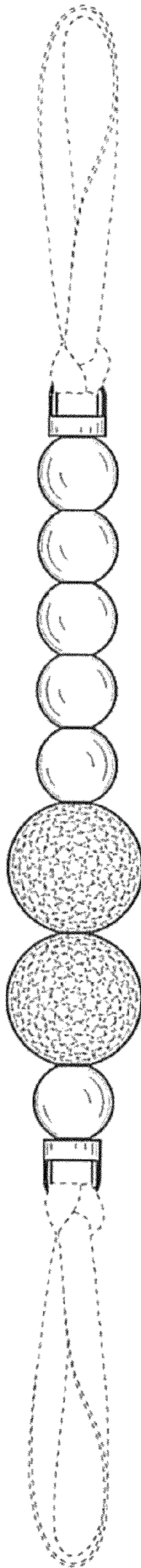

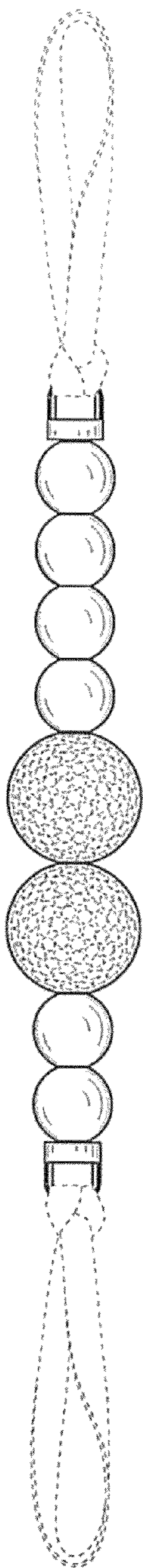

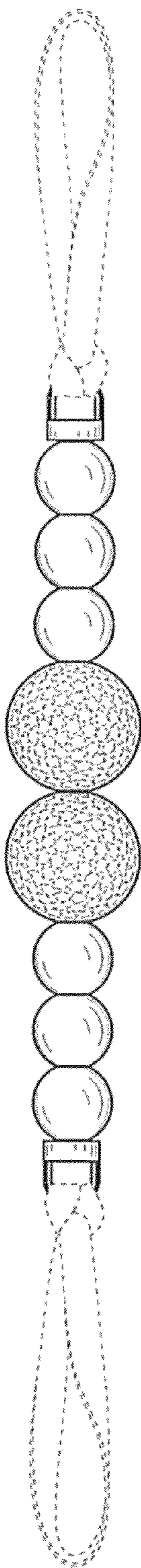

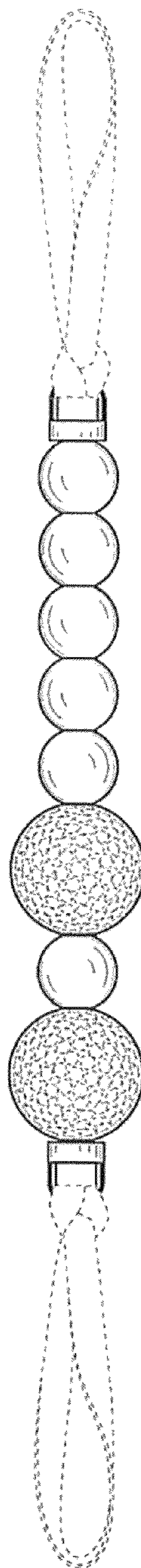

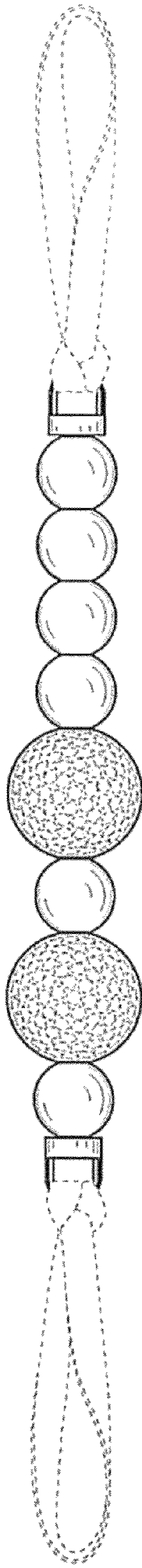

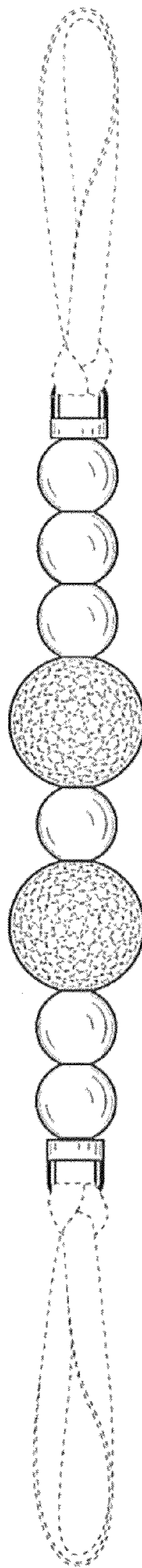

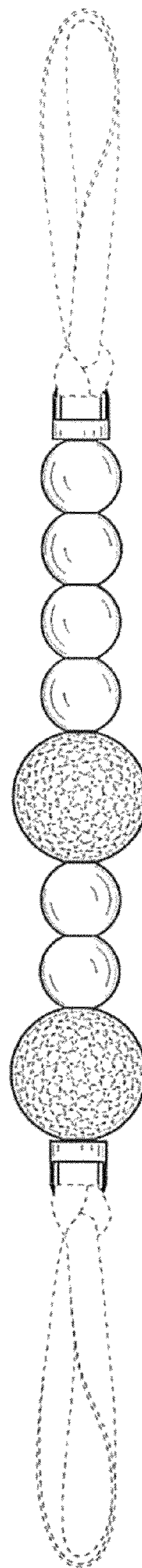

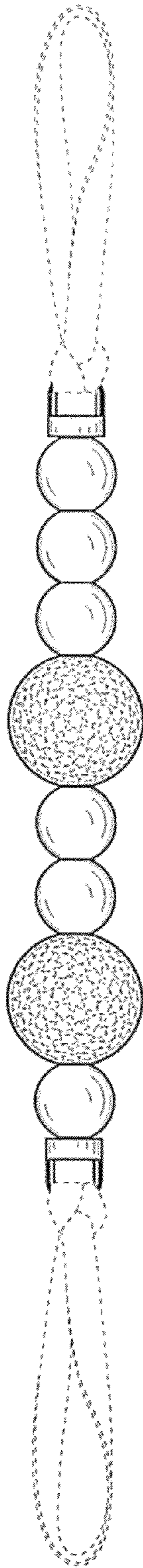

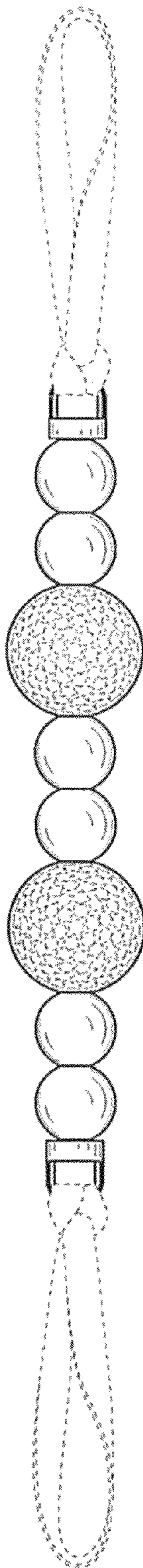

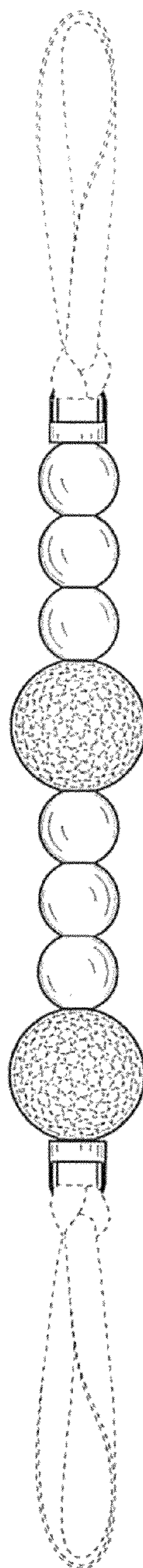
