FIG. 11 is a front view of the double antiroll pillow shown in FIG. 7; and,

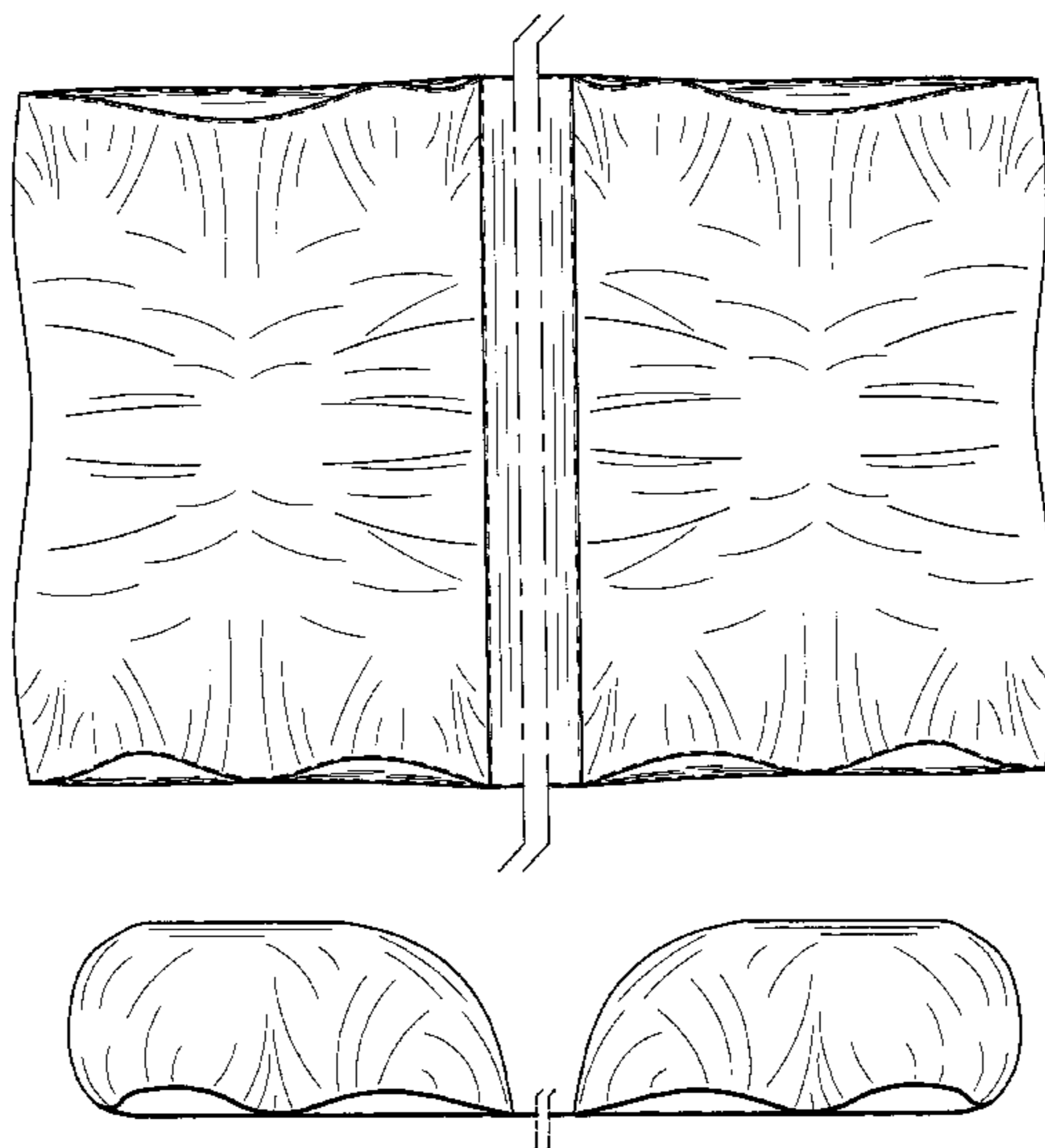
FIG. 12 is a rear view of the double antiroll pillow shown in FIG. 7.

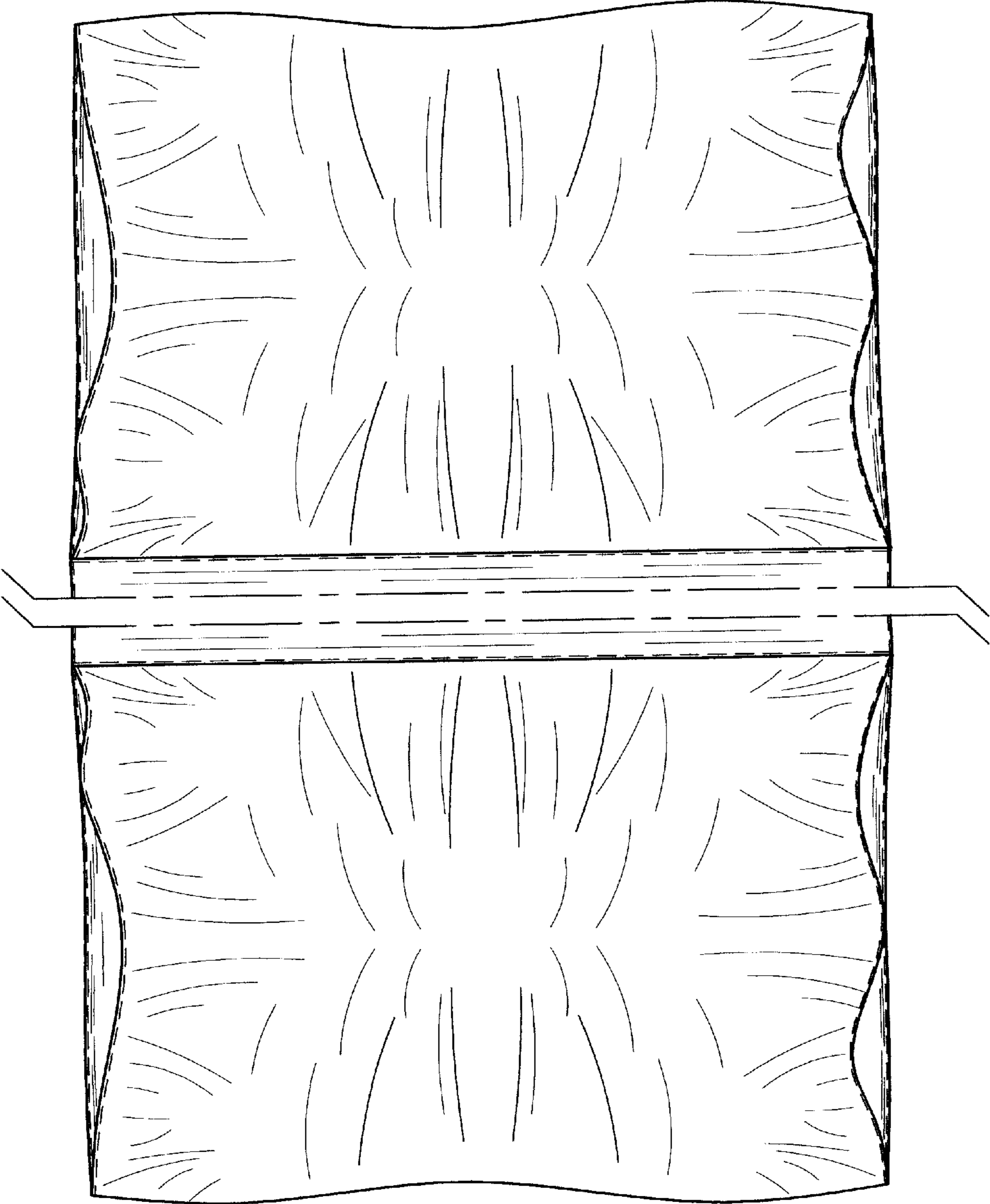
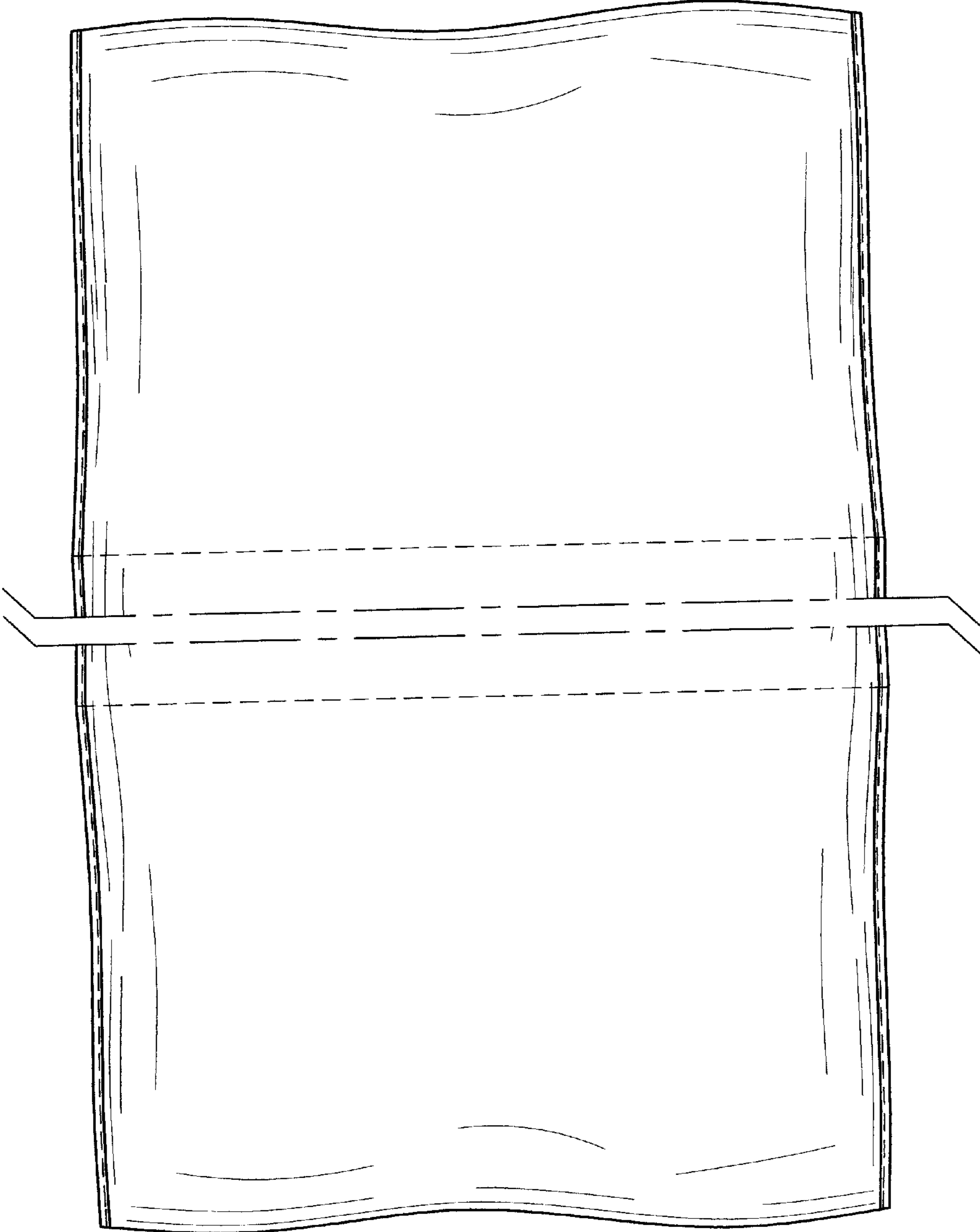

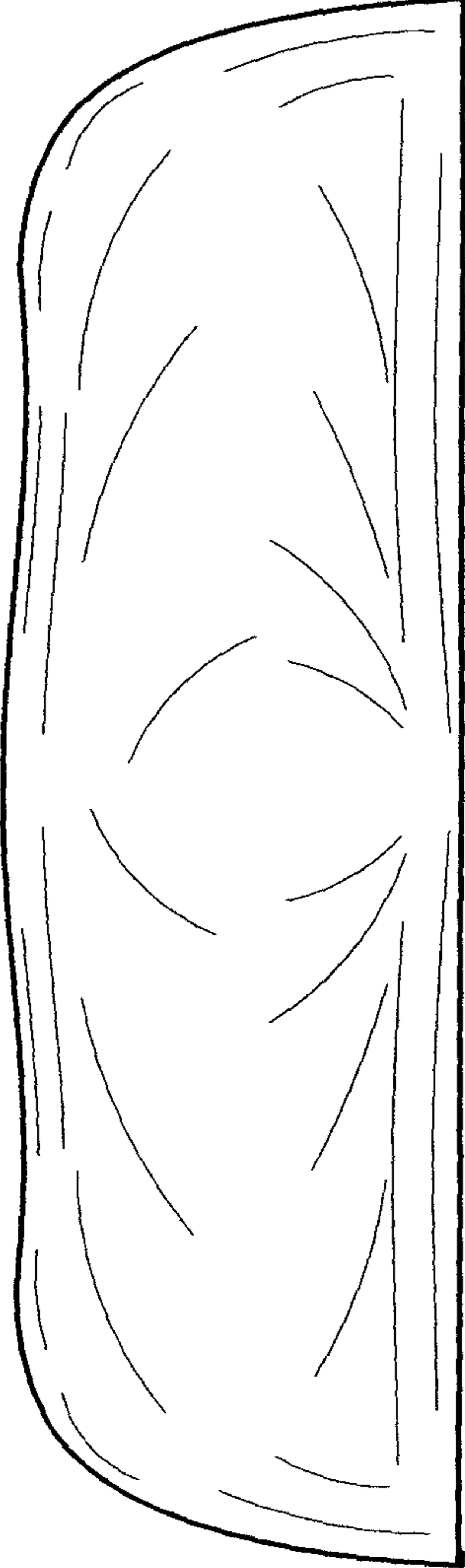

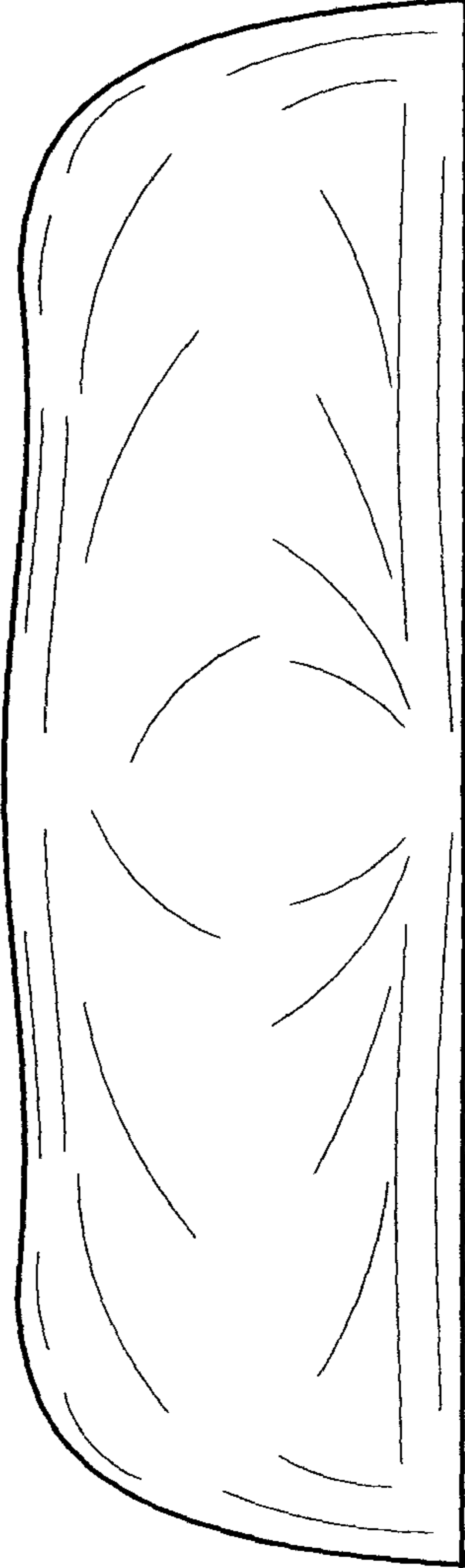

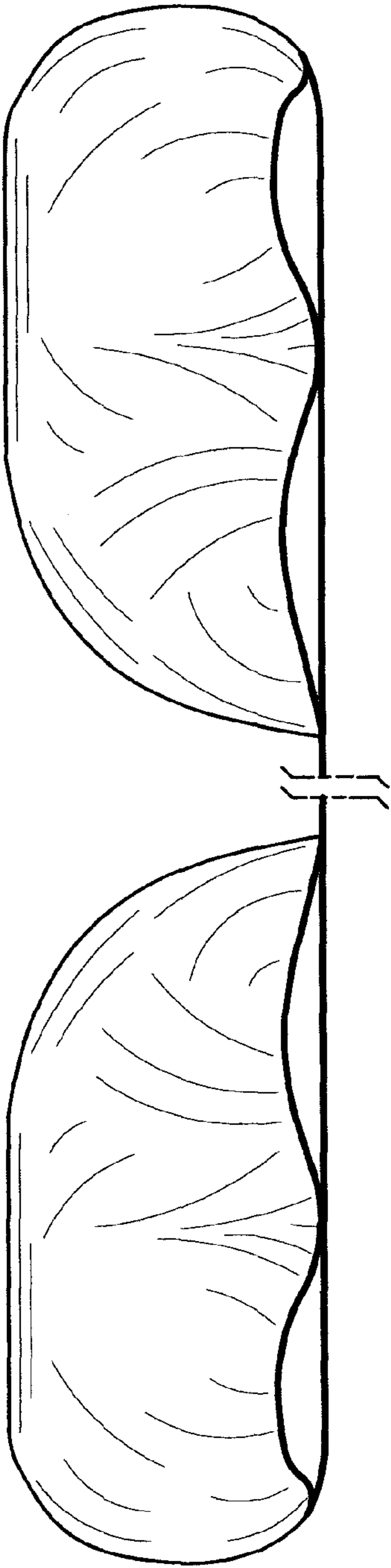

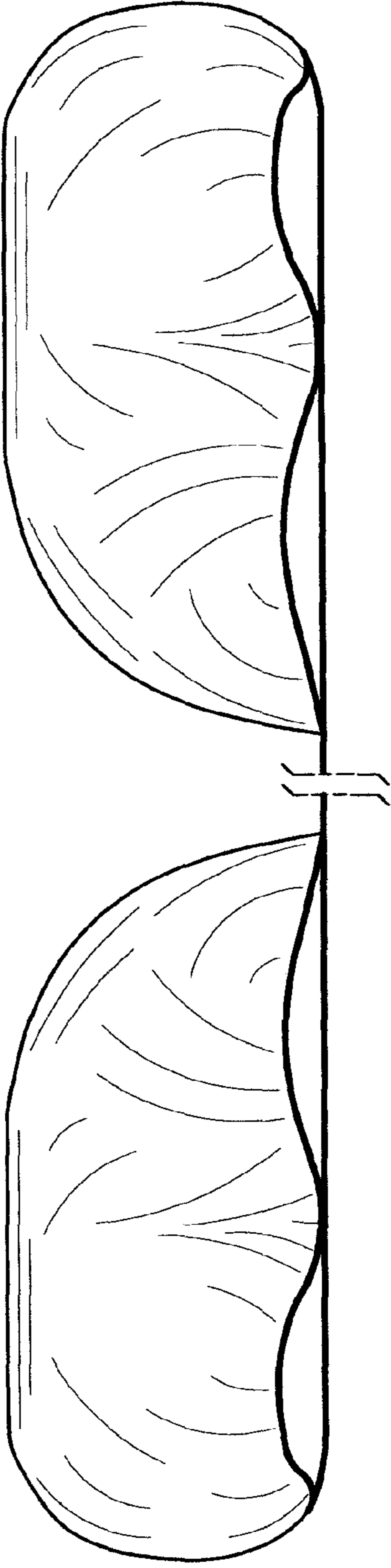

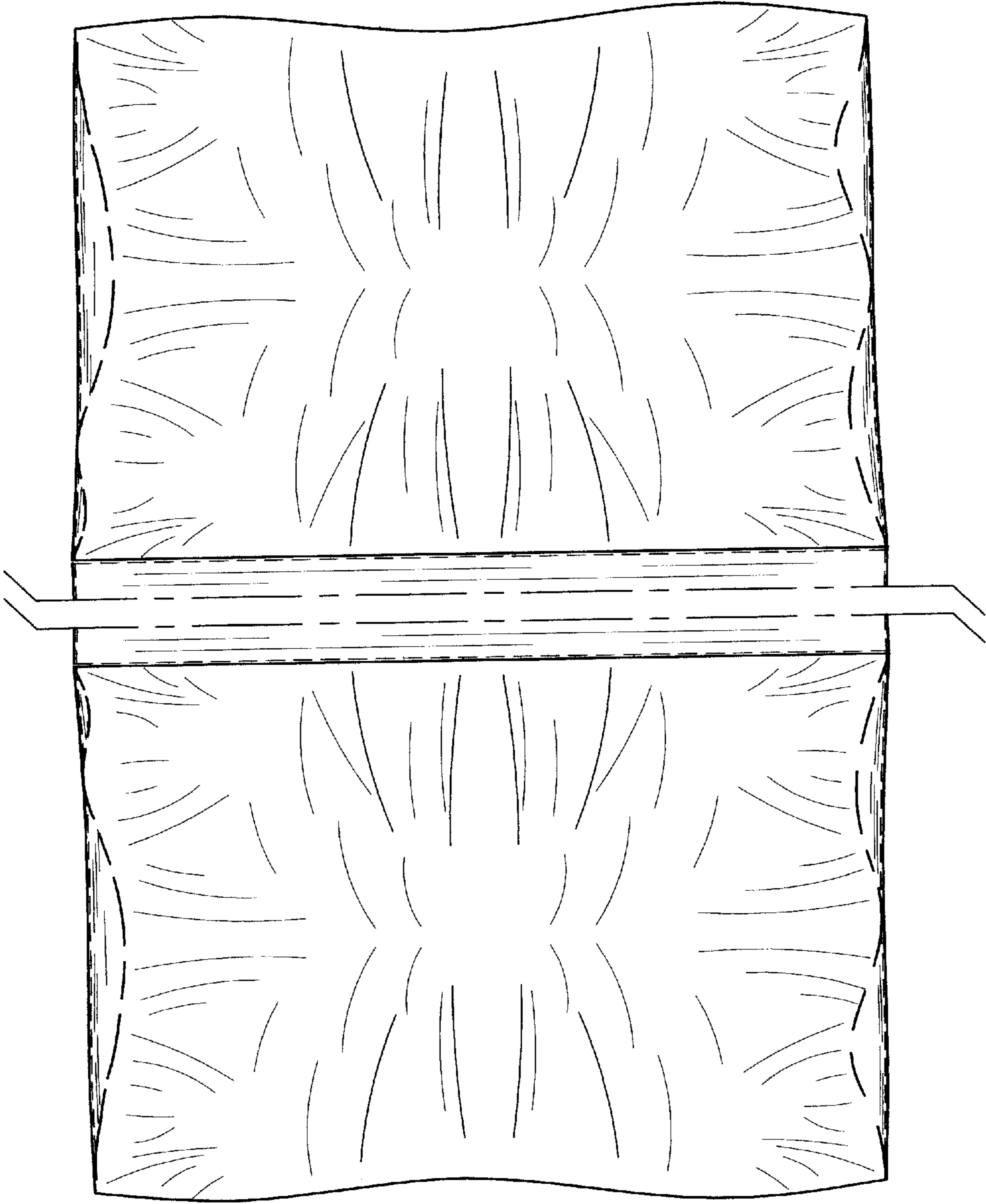
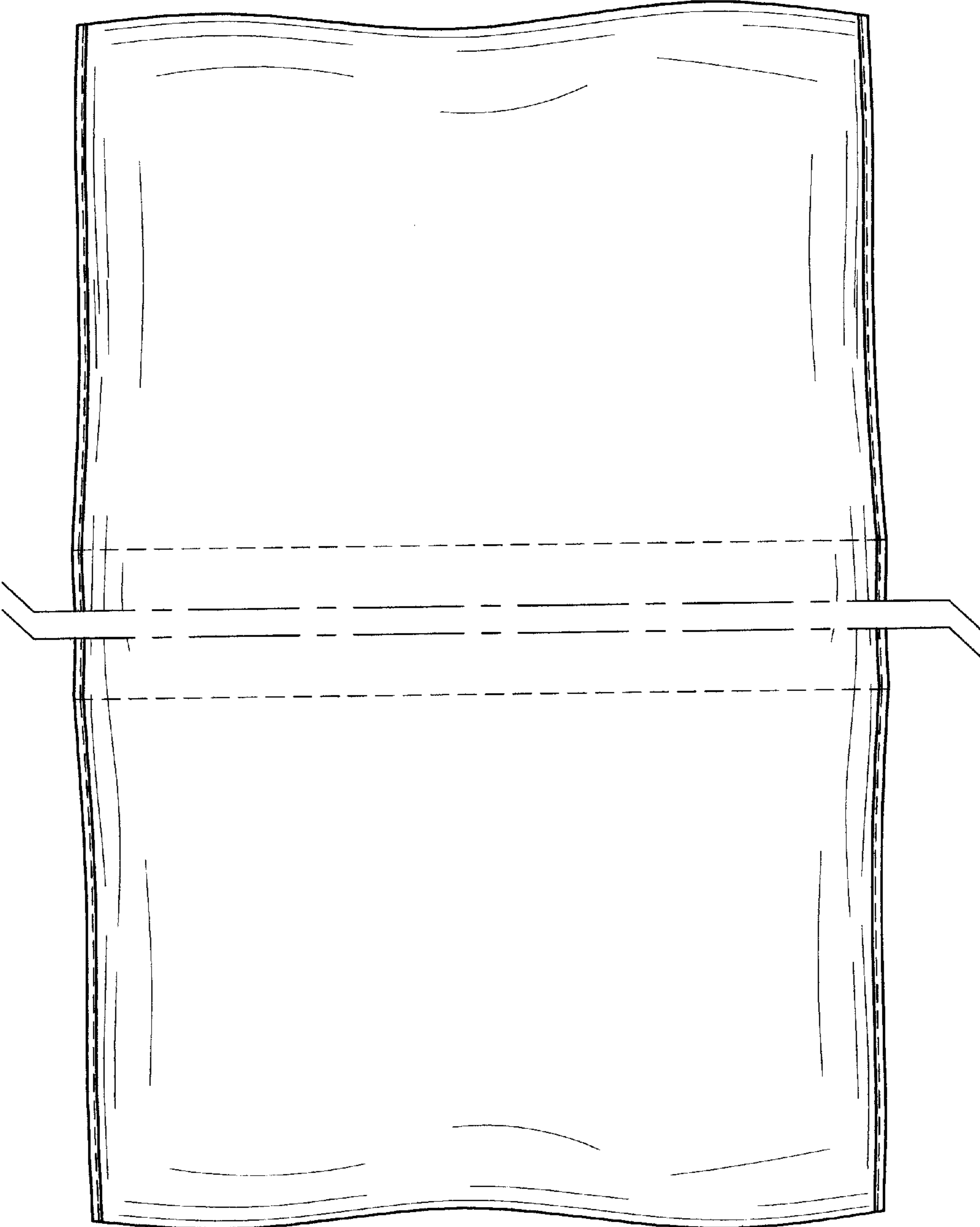

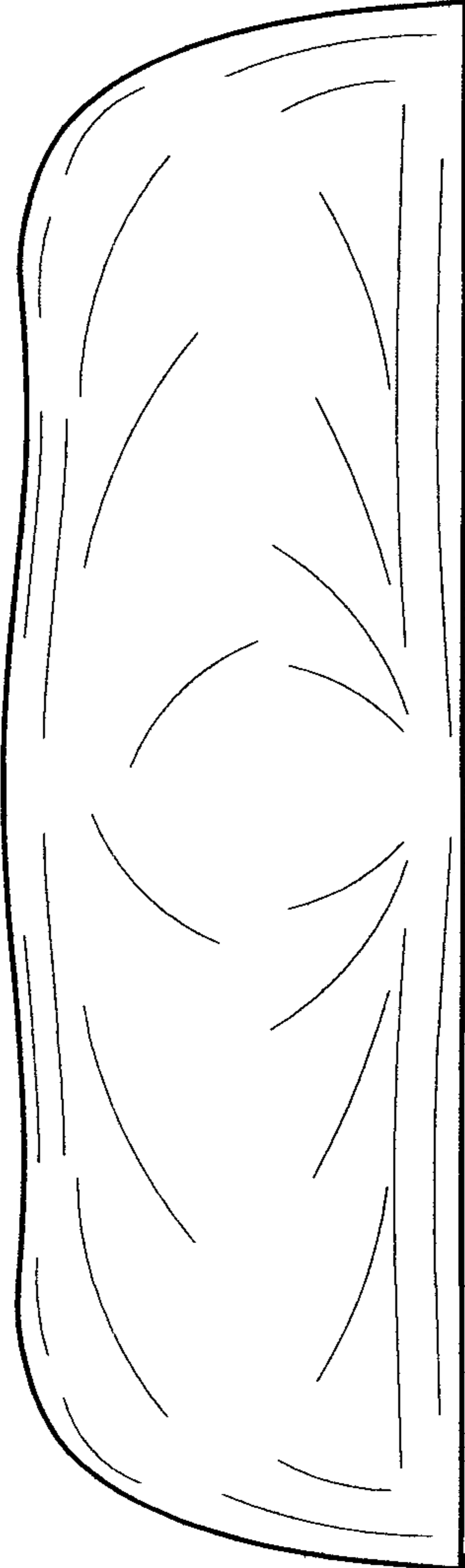

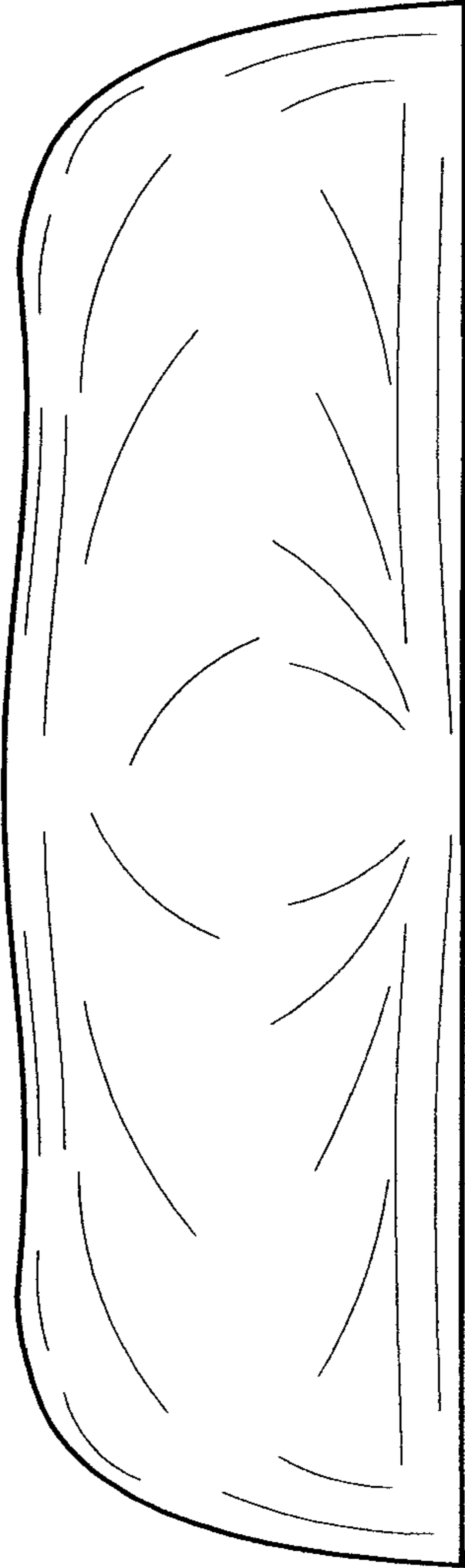

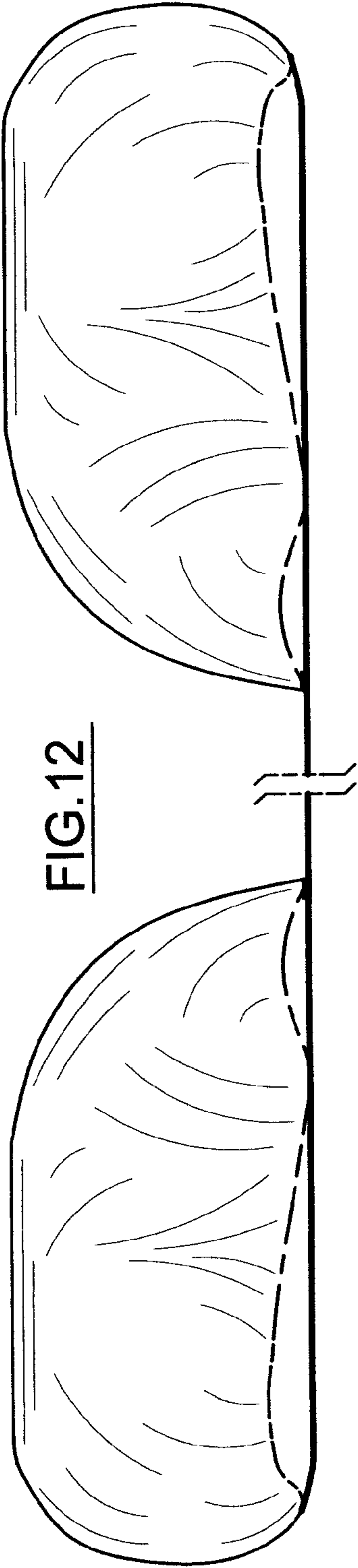

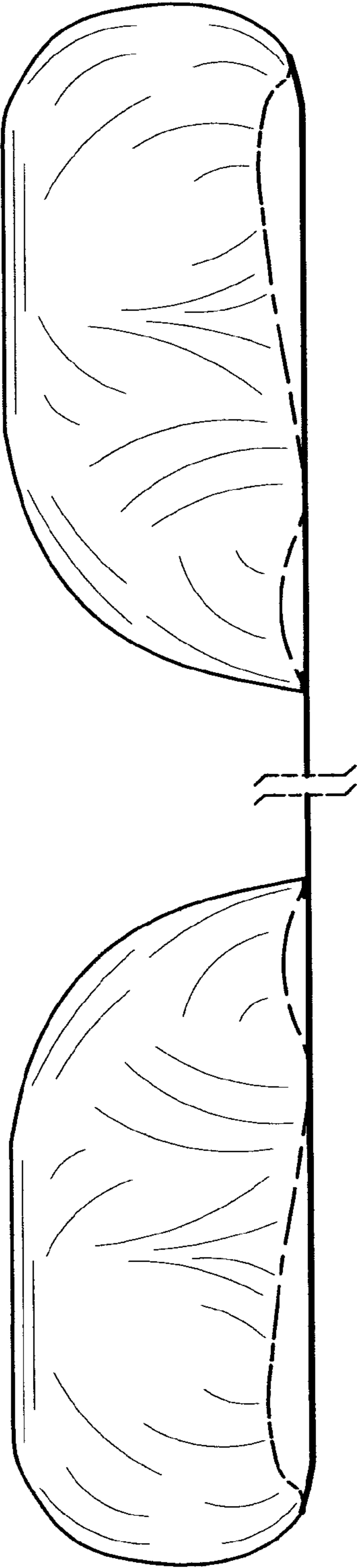
