DESCRIPTION

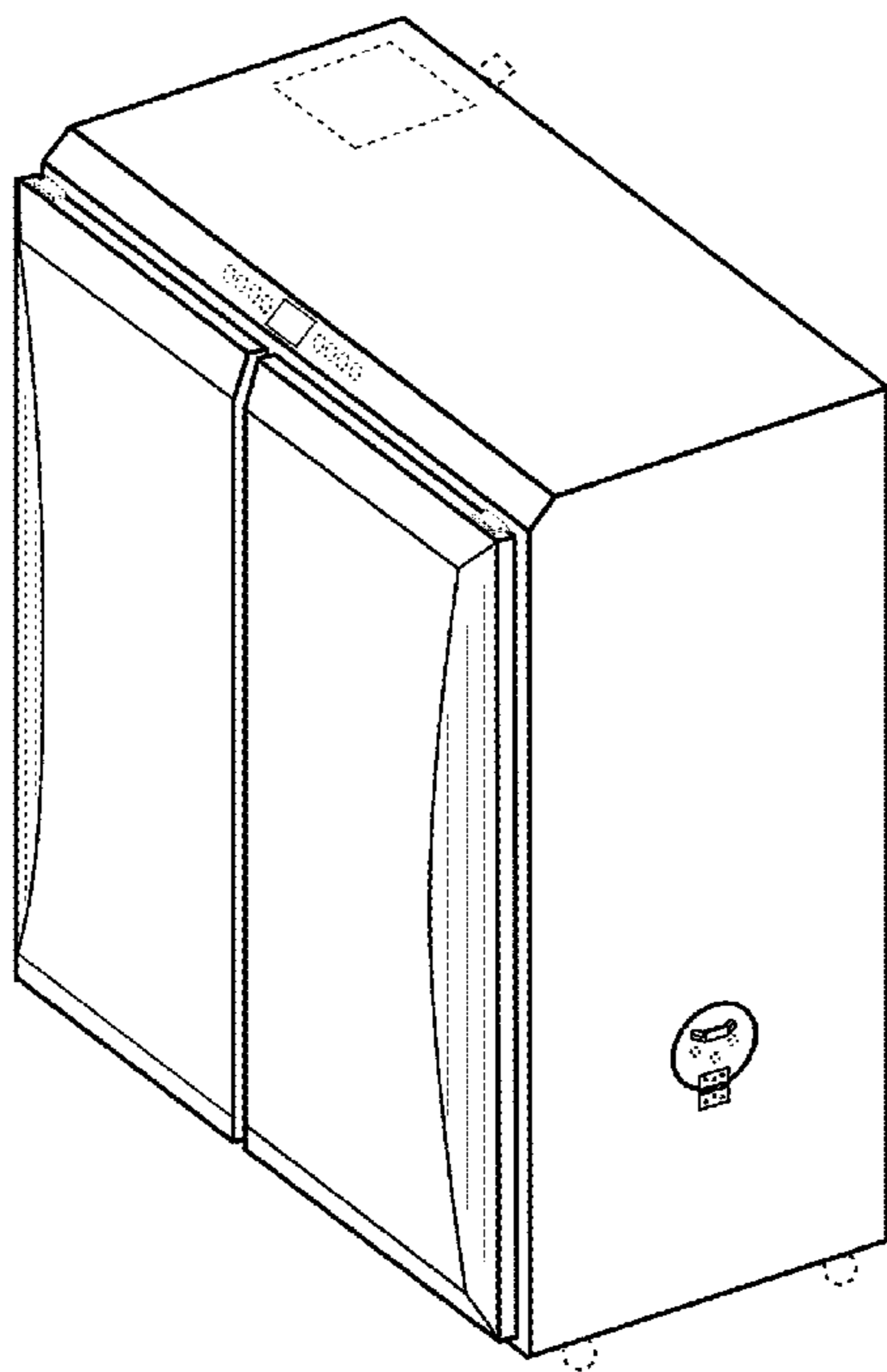
FIG. 1 is a top, right front perspective view of a double door smoker showing my new design;

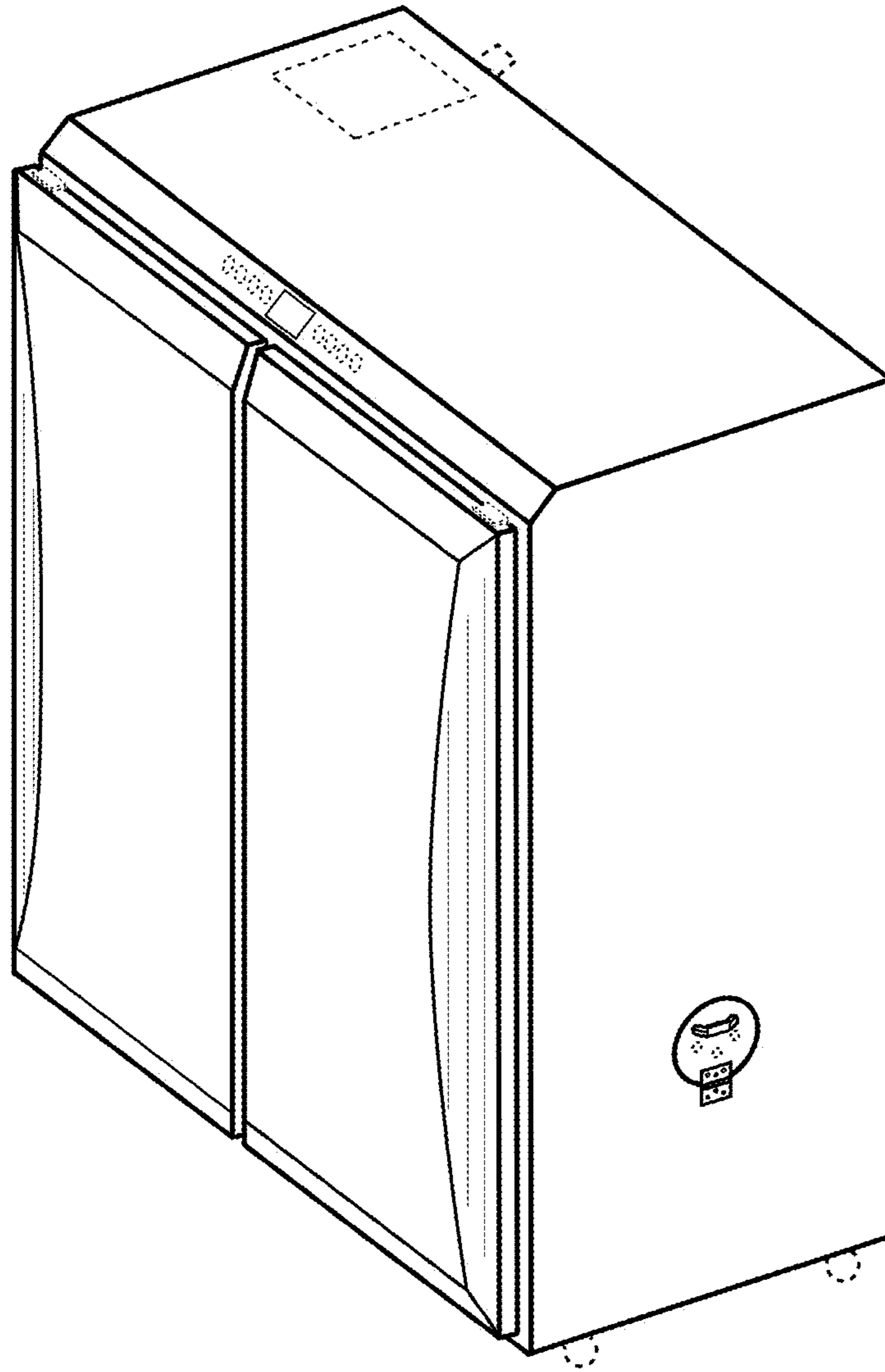

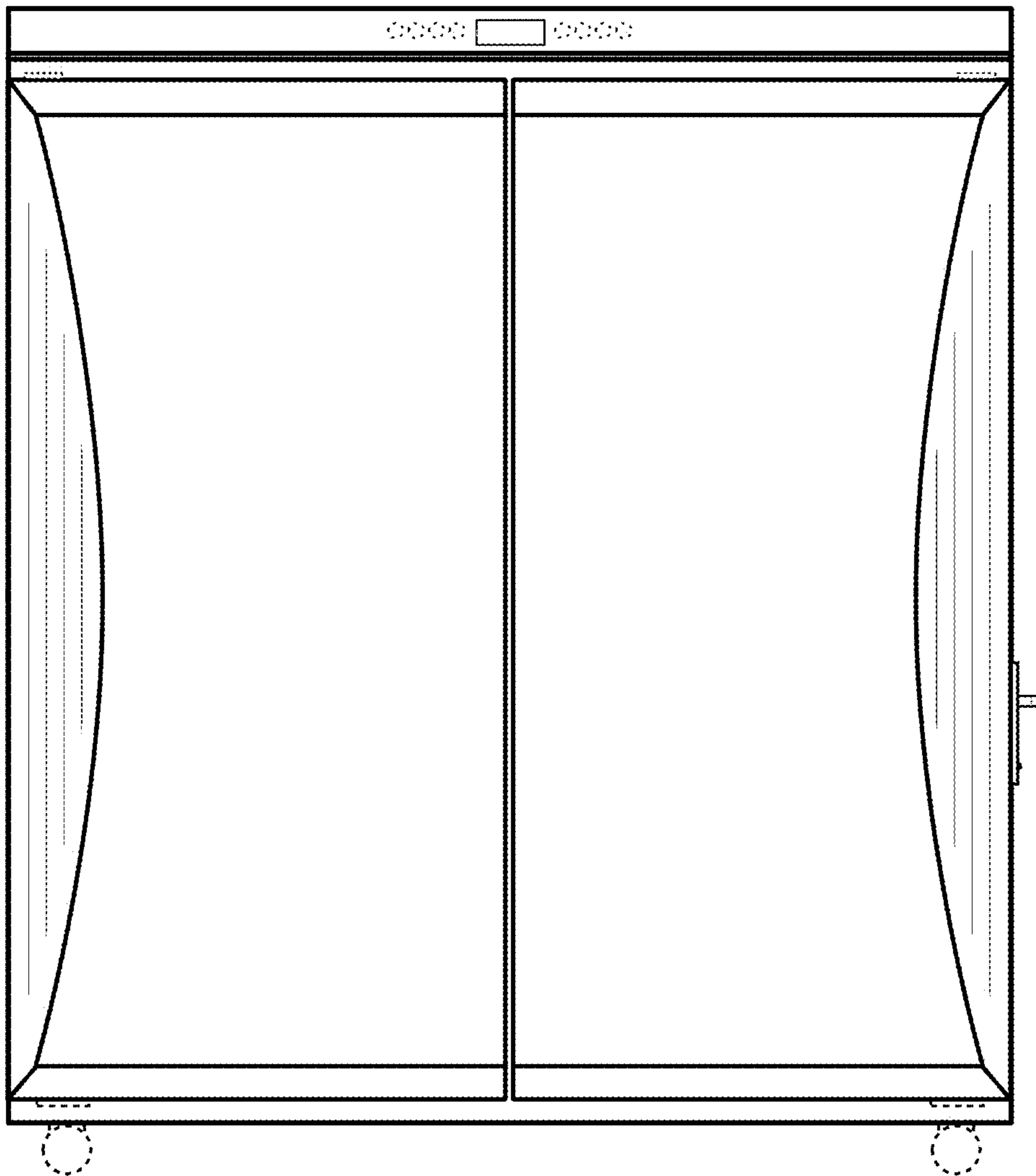

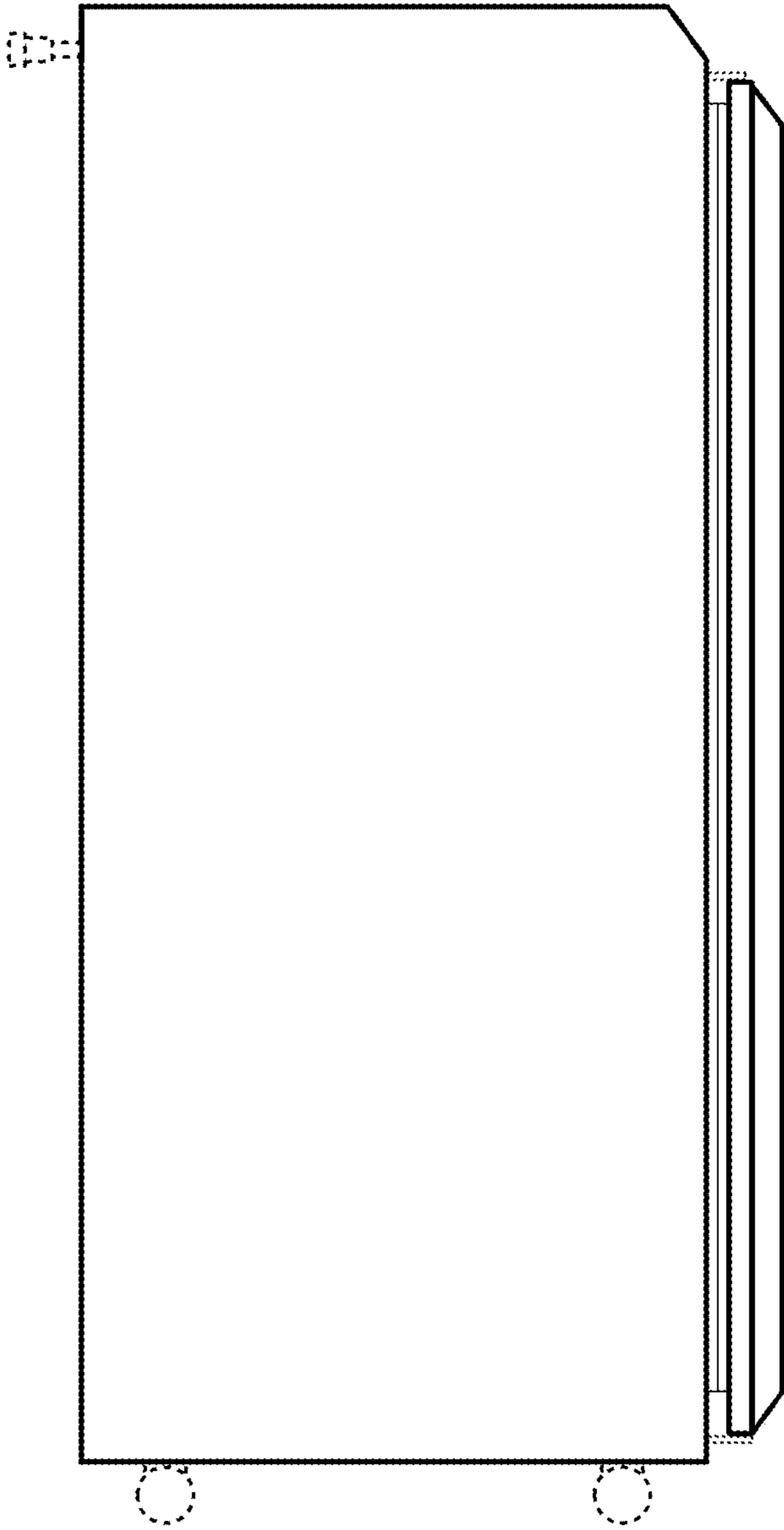

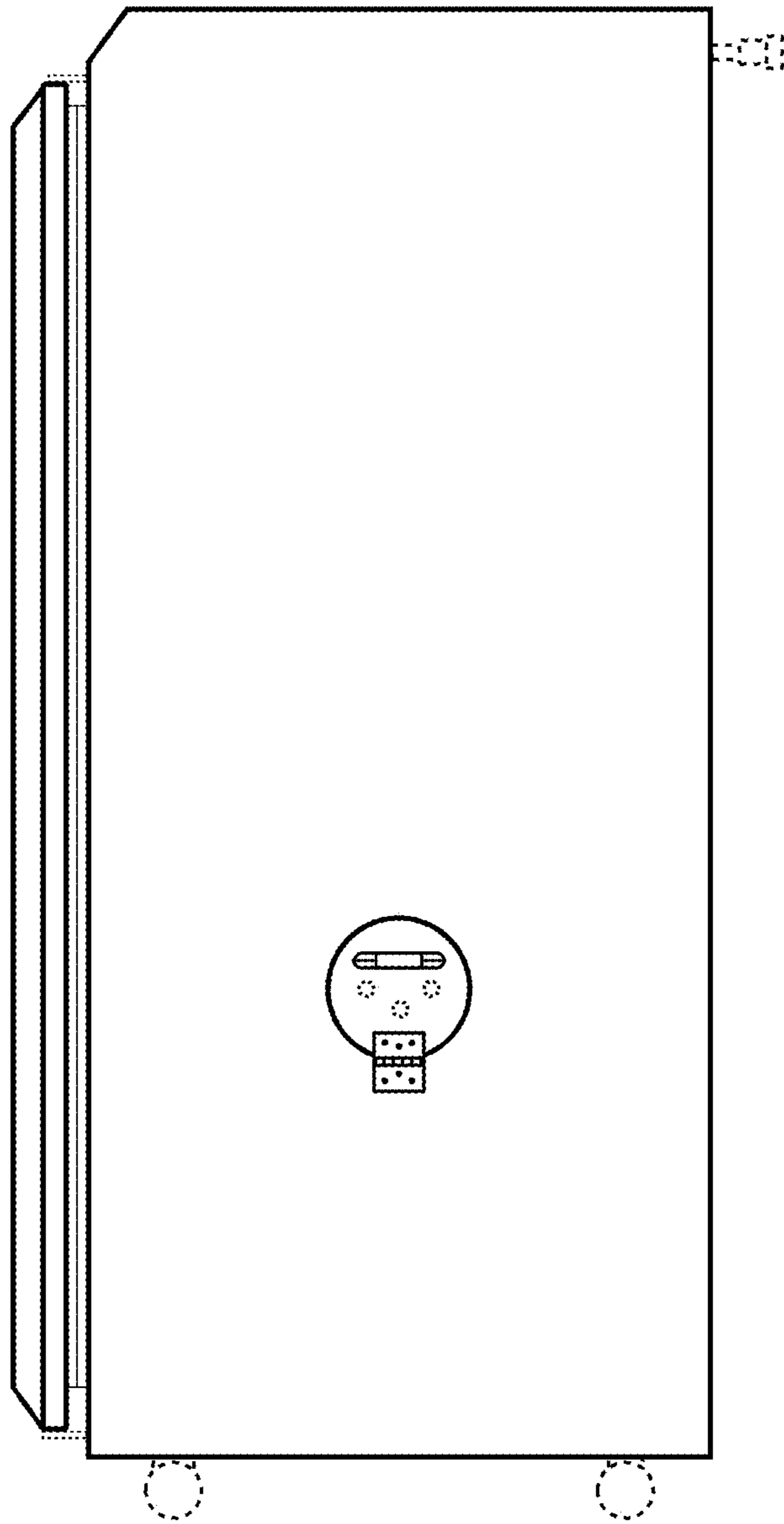

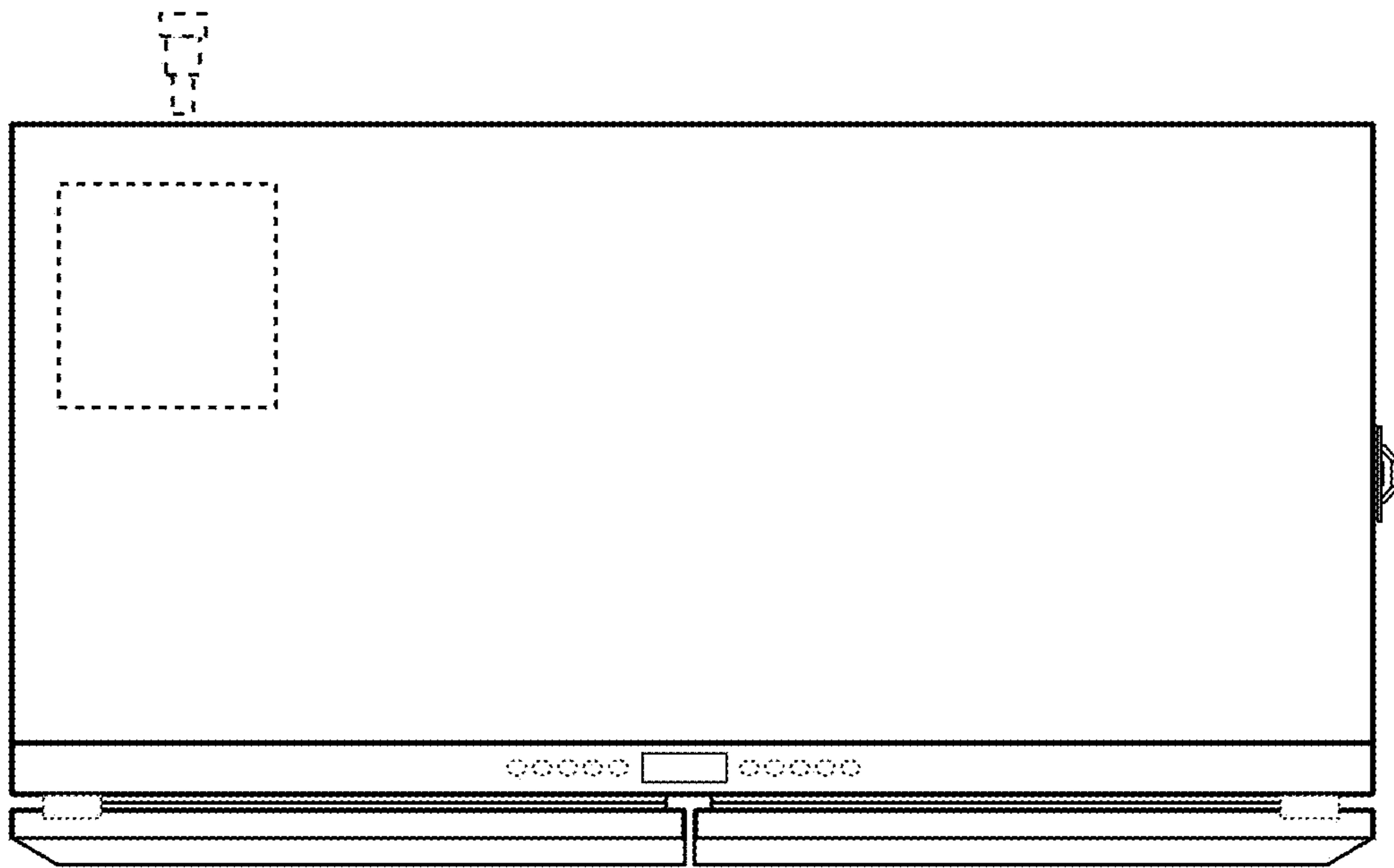
