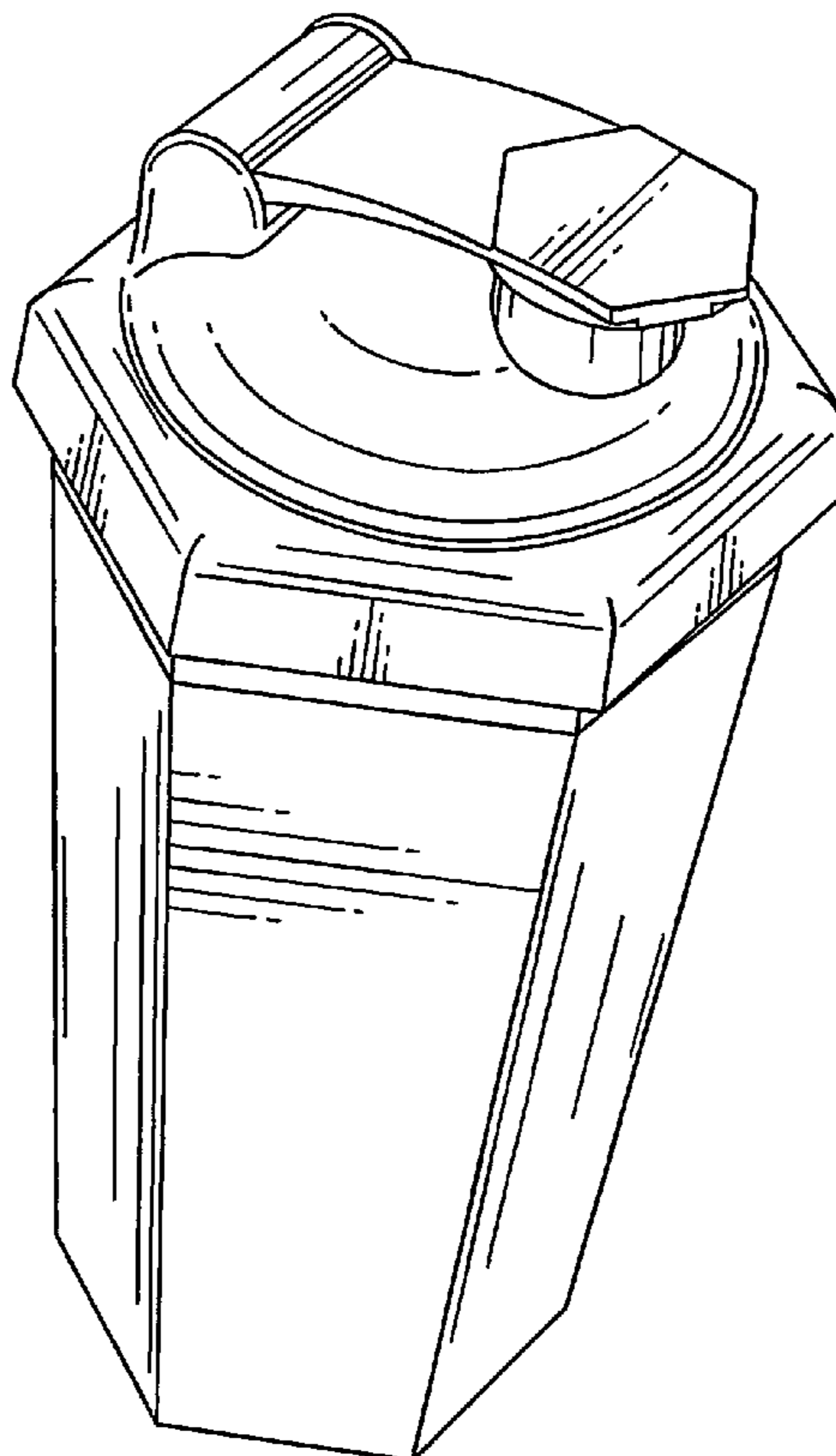

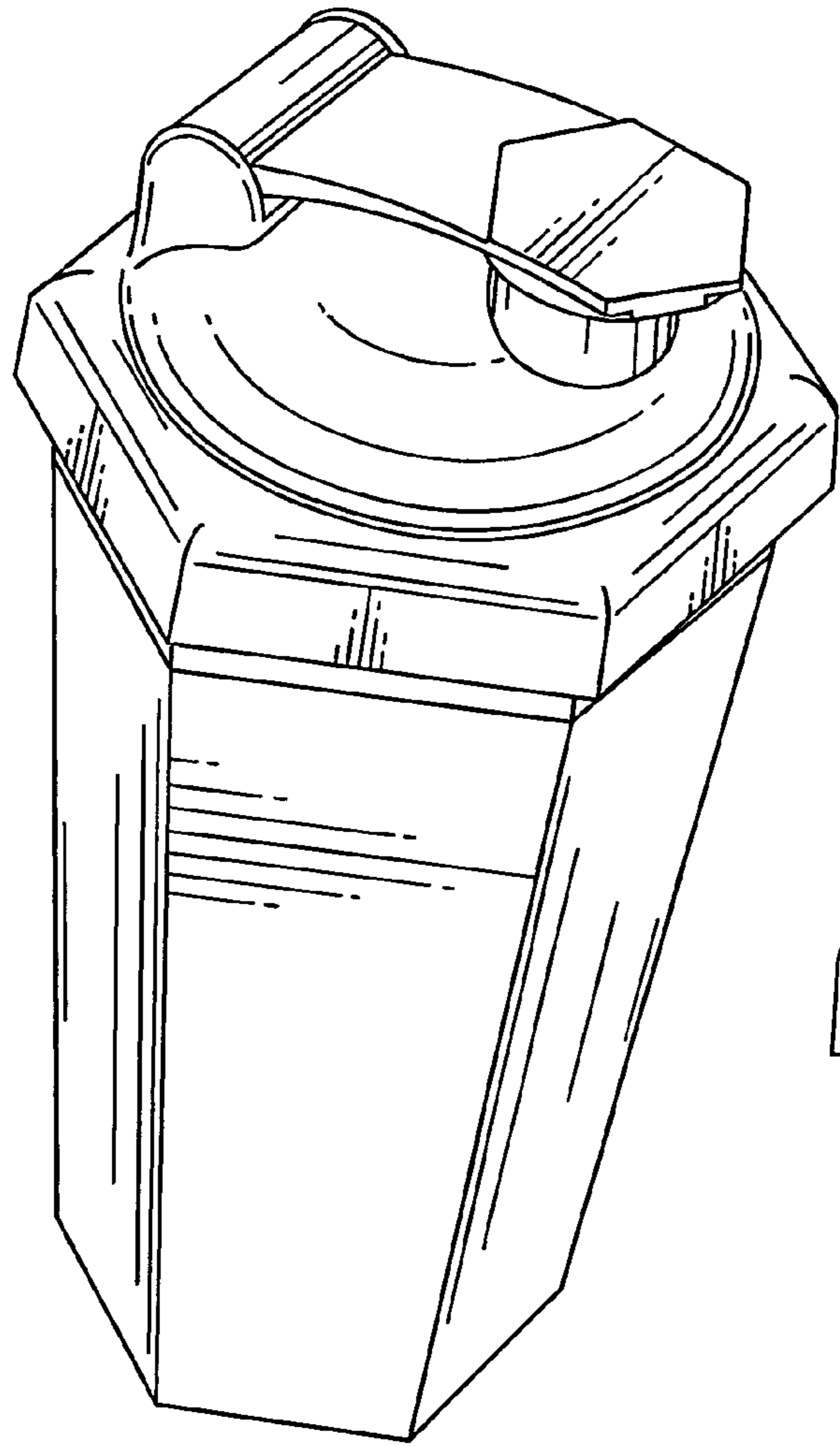
The ornamental design for a shaker mug, as shown and described.

**DESCRIPTION**

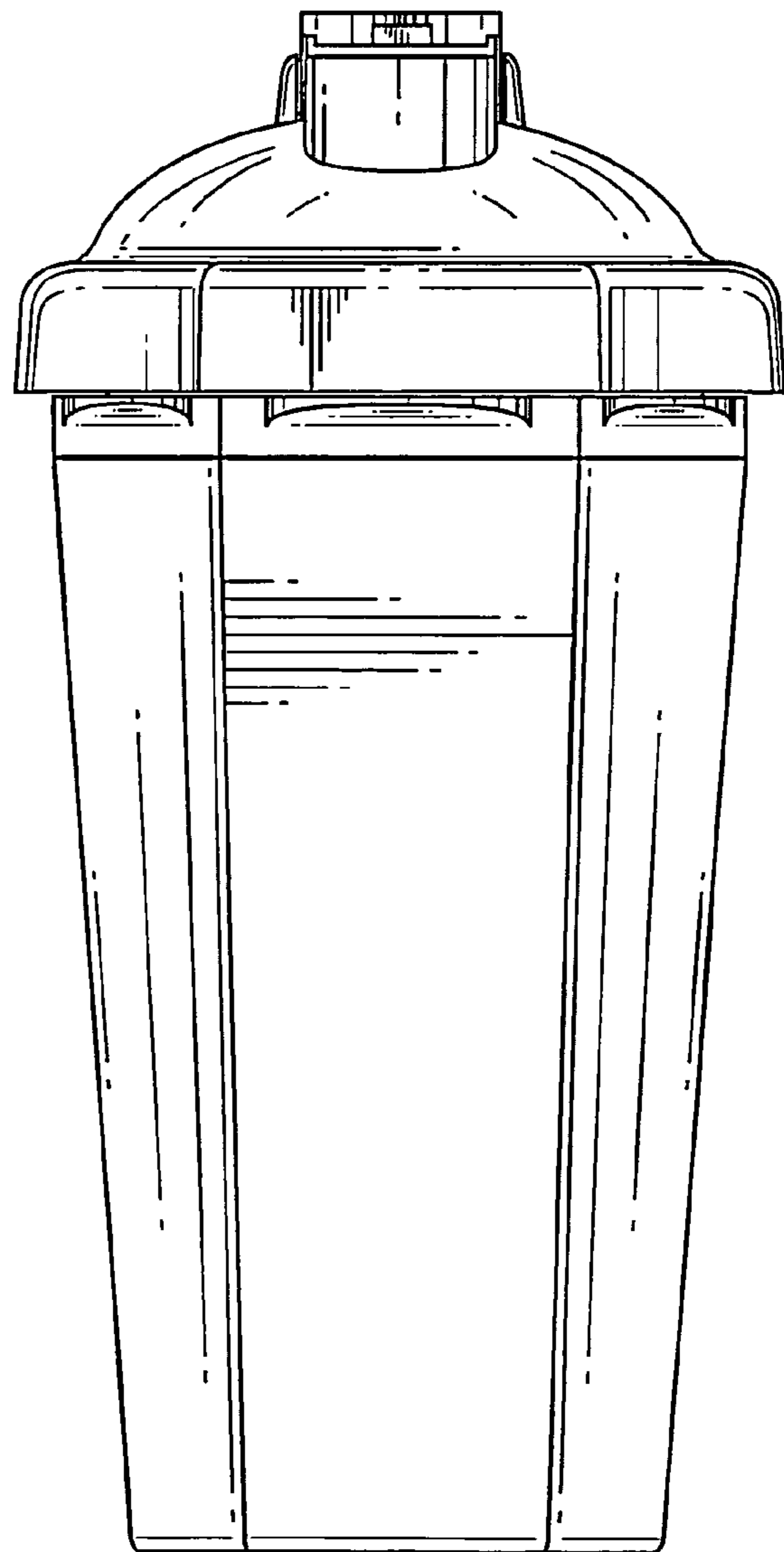
FIG. 1 is a top perspective view of a shaker mug;

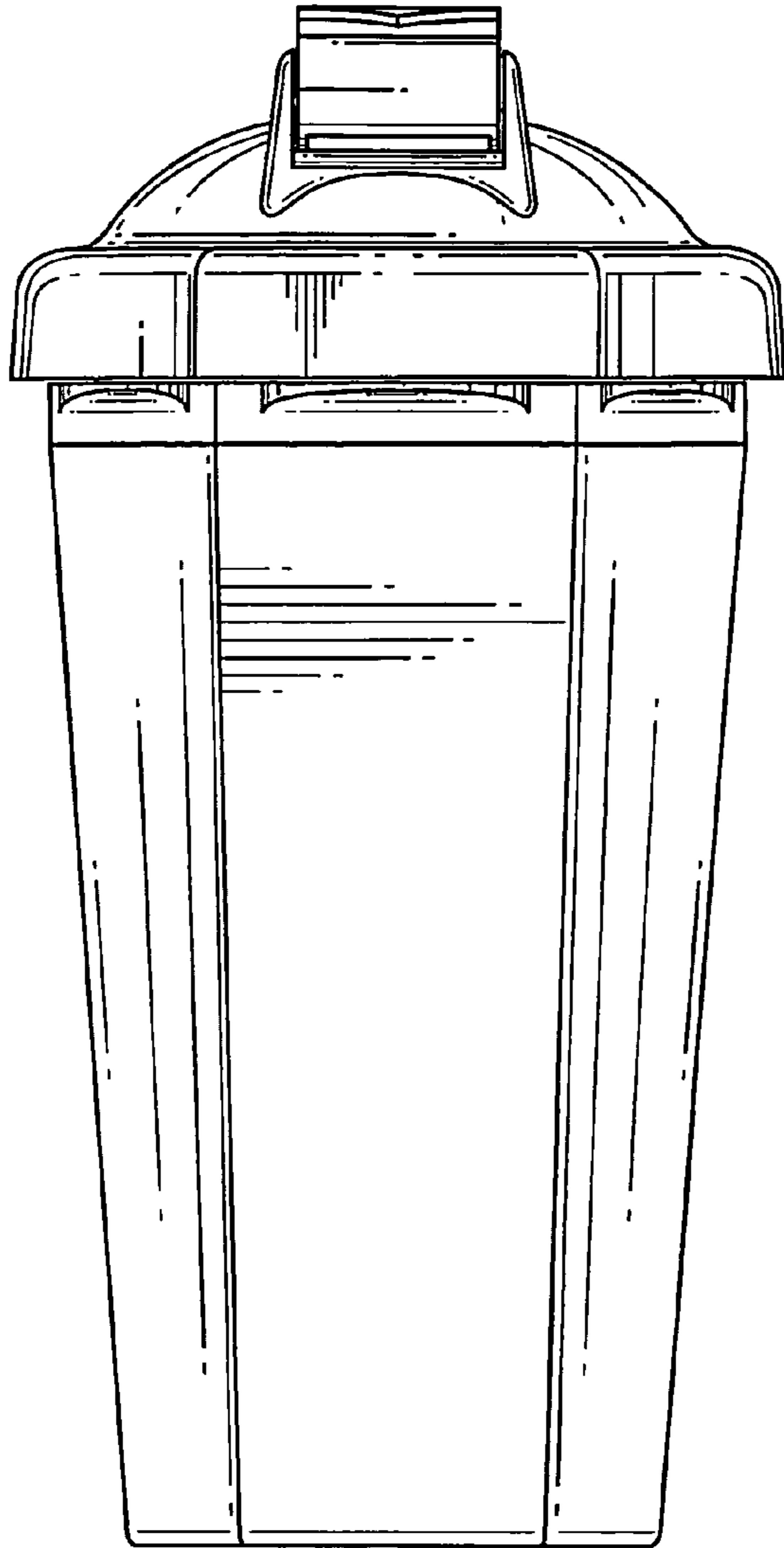




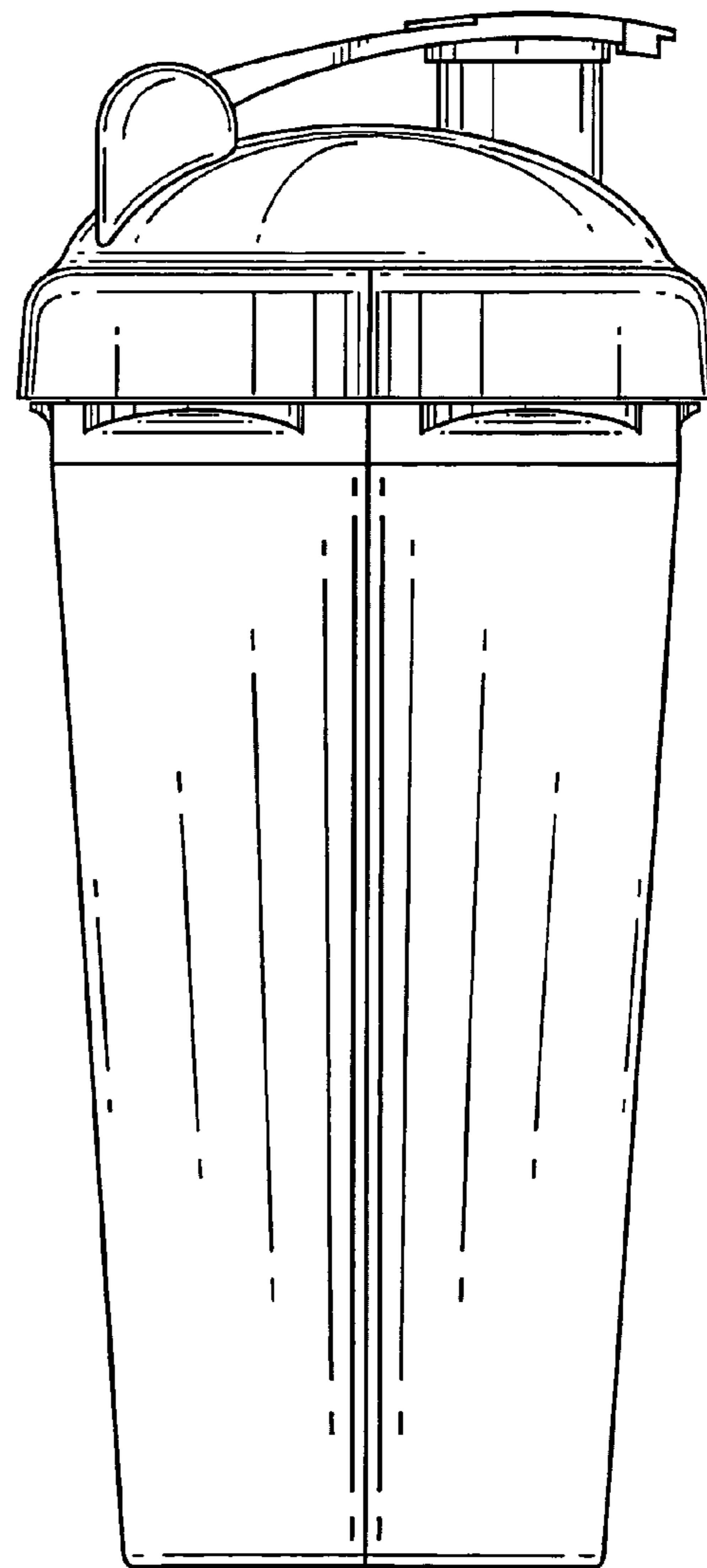

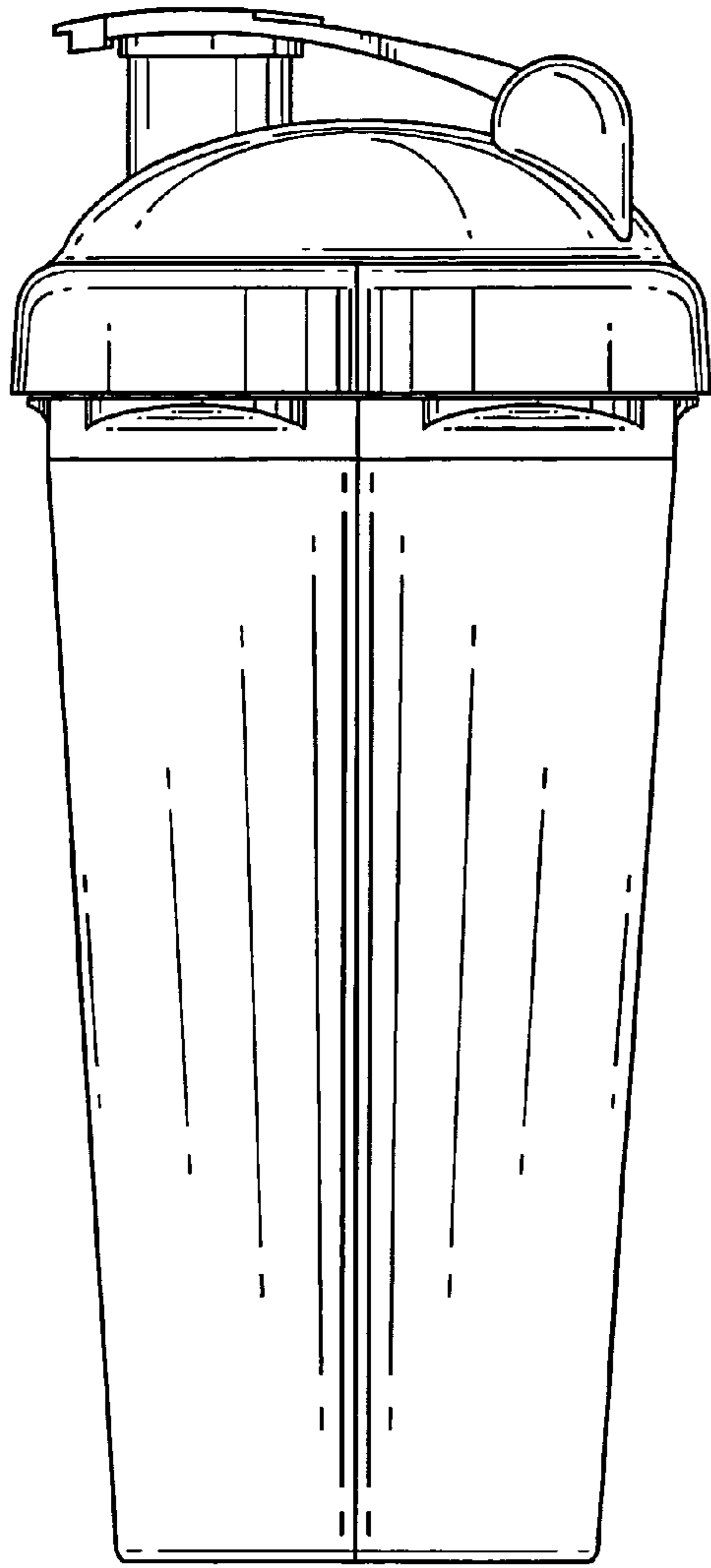

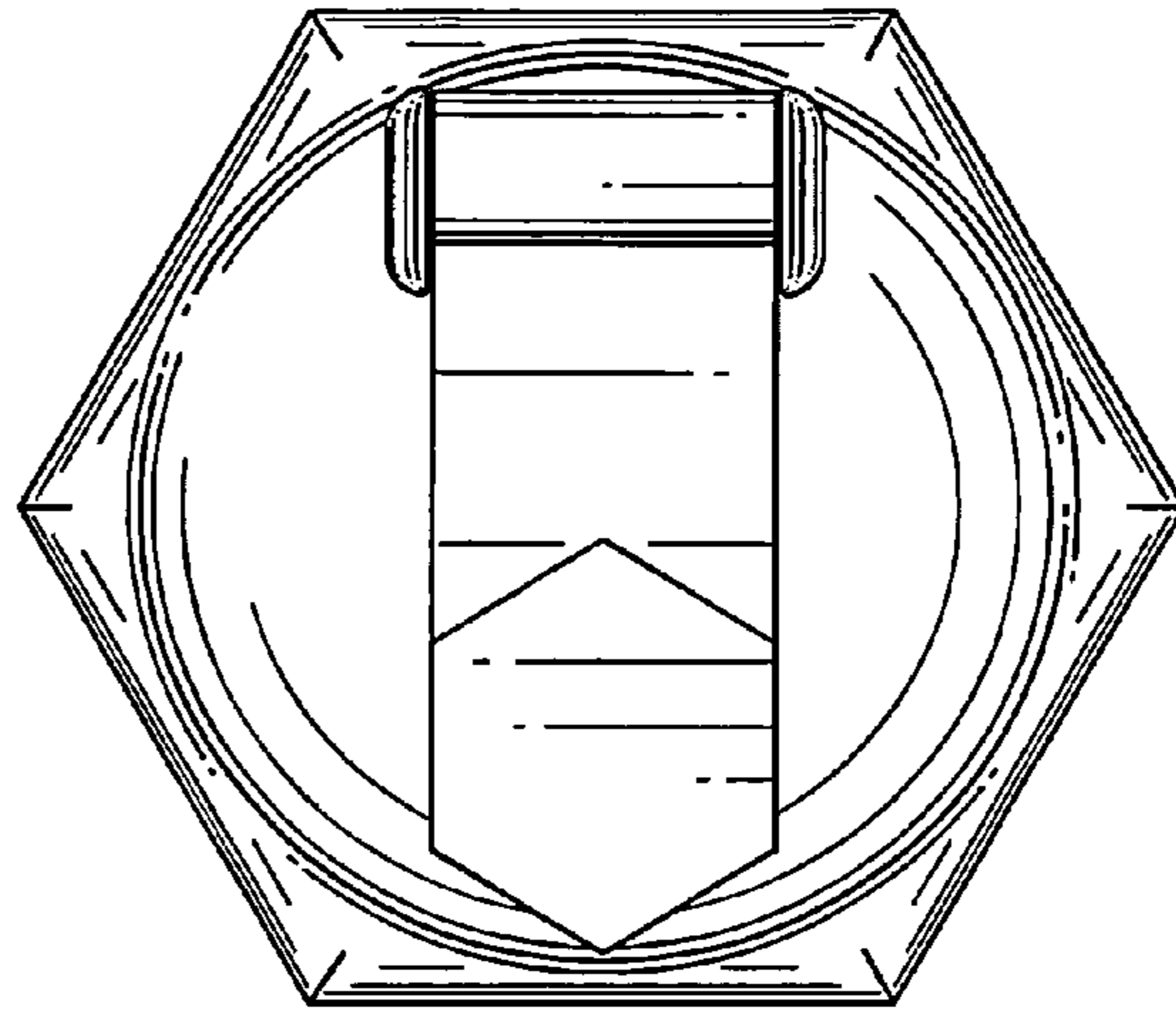

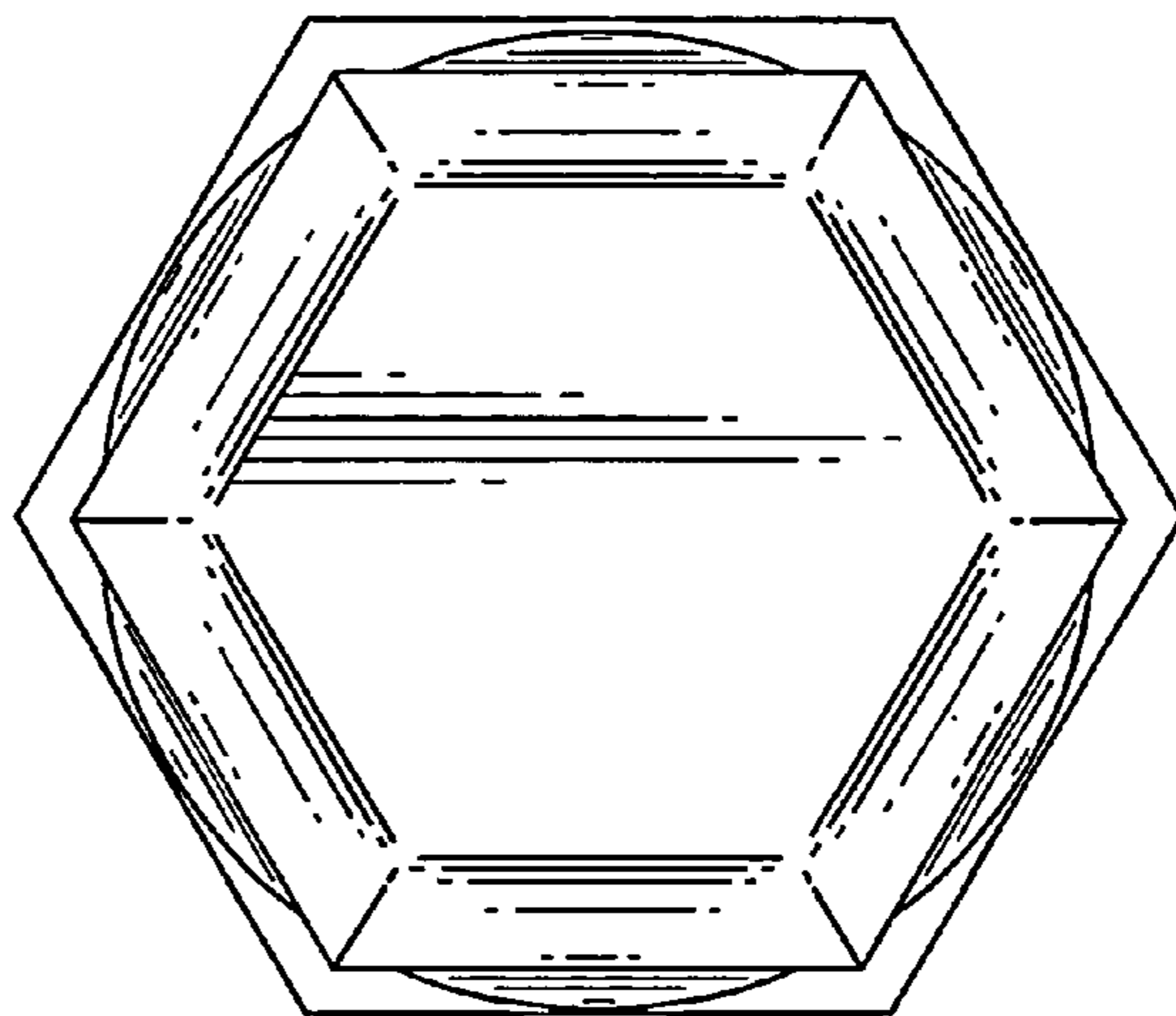
