DESCRIPTION

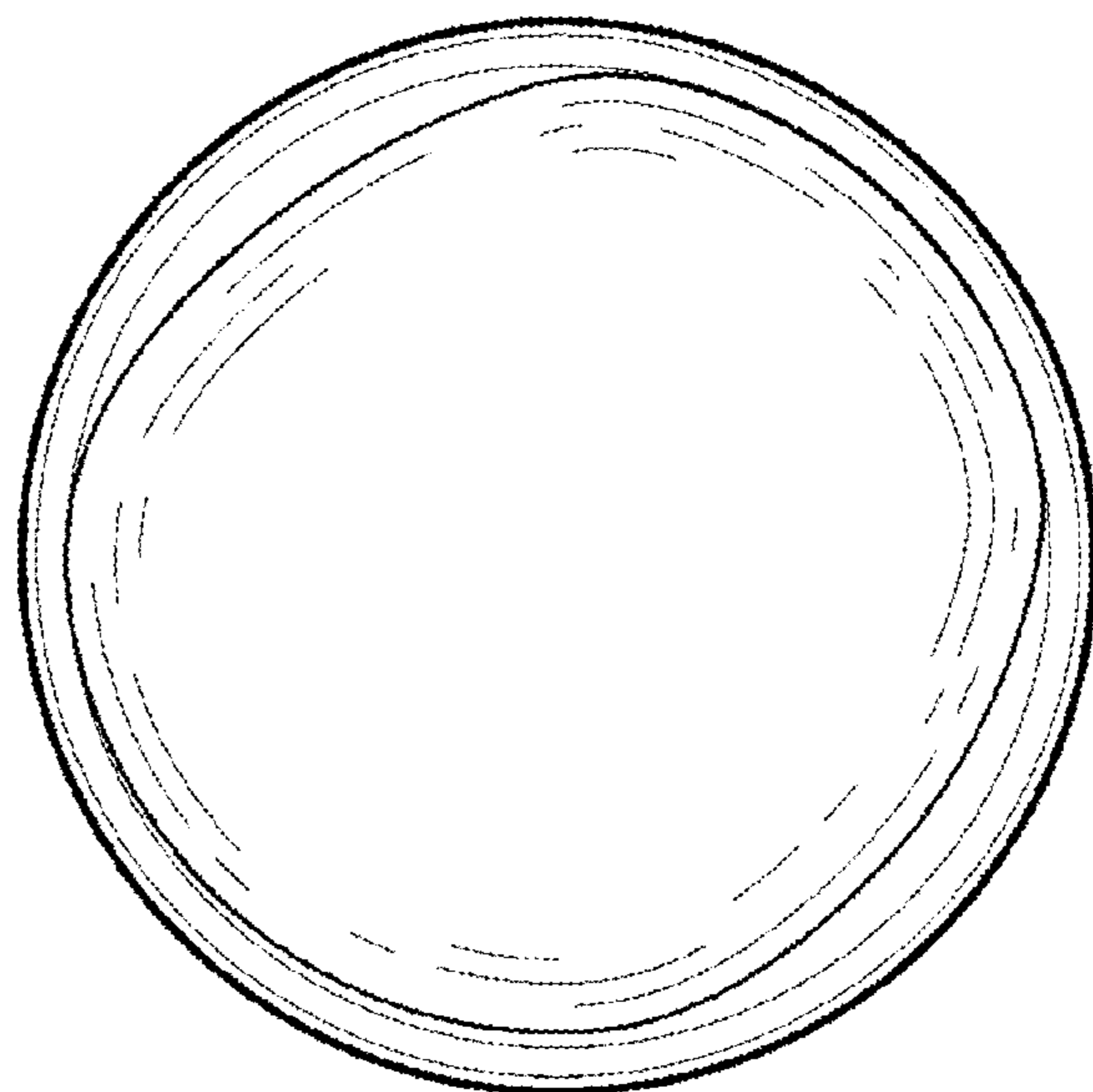
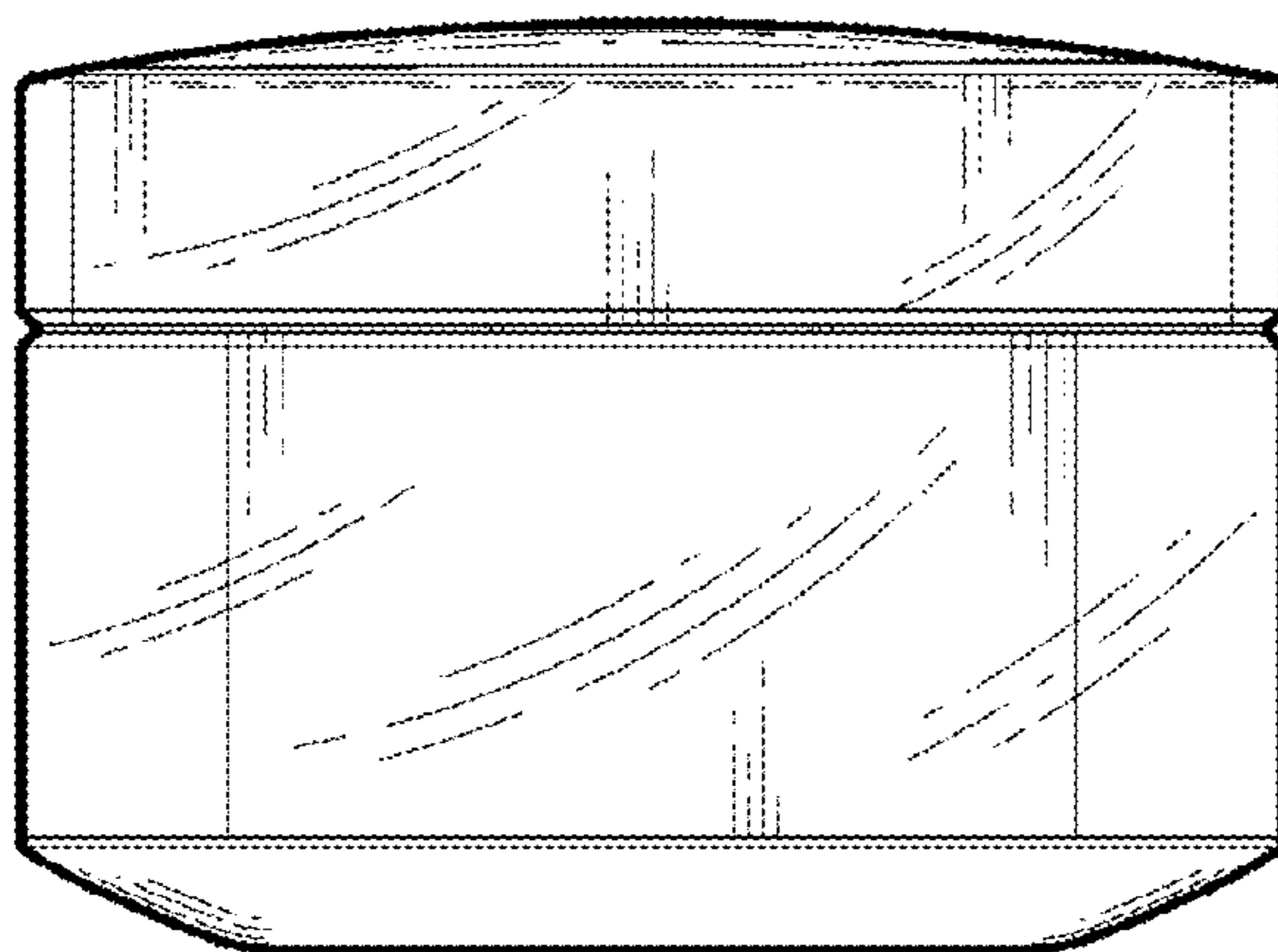

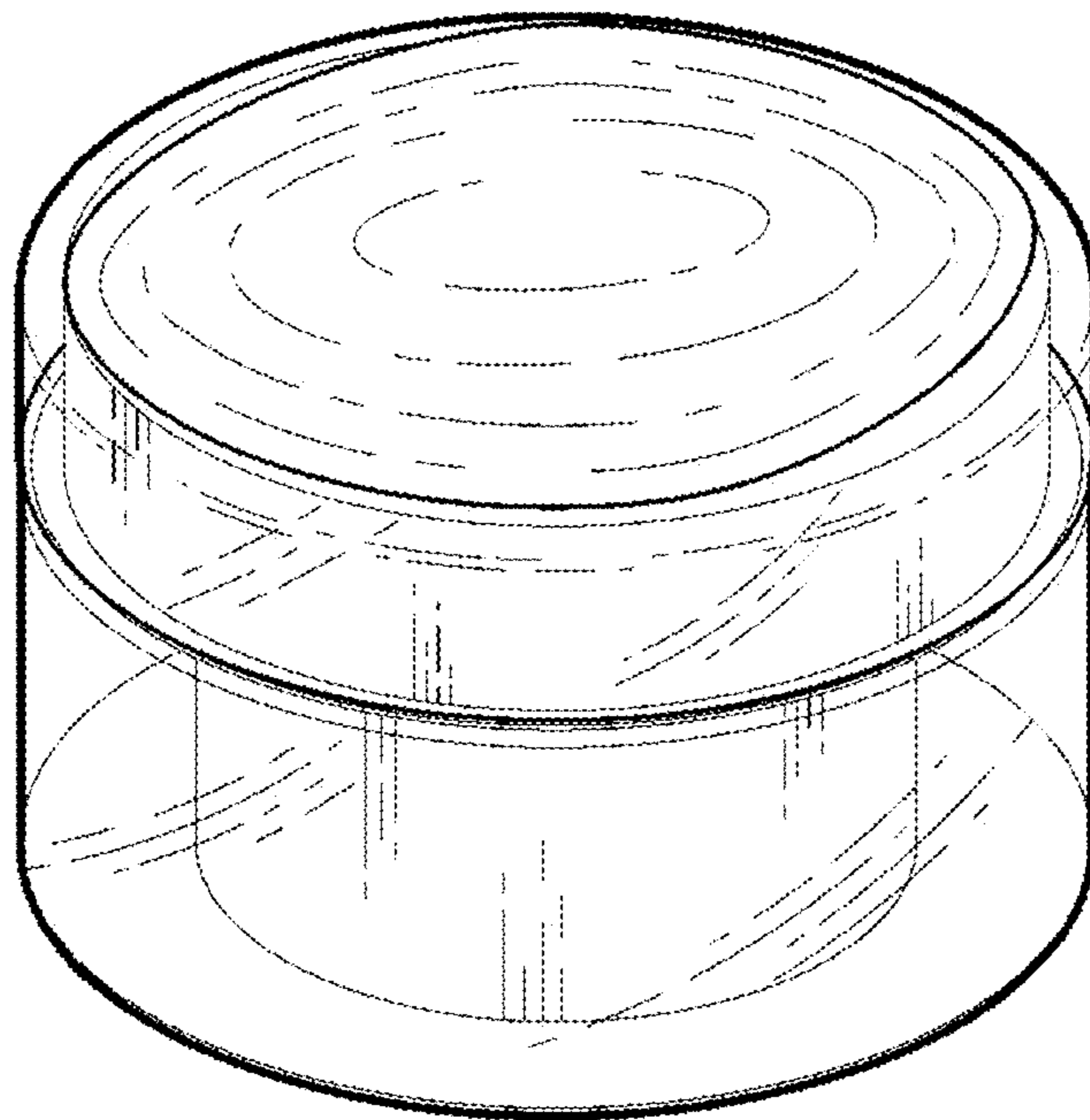

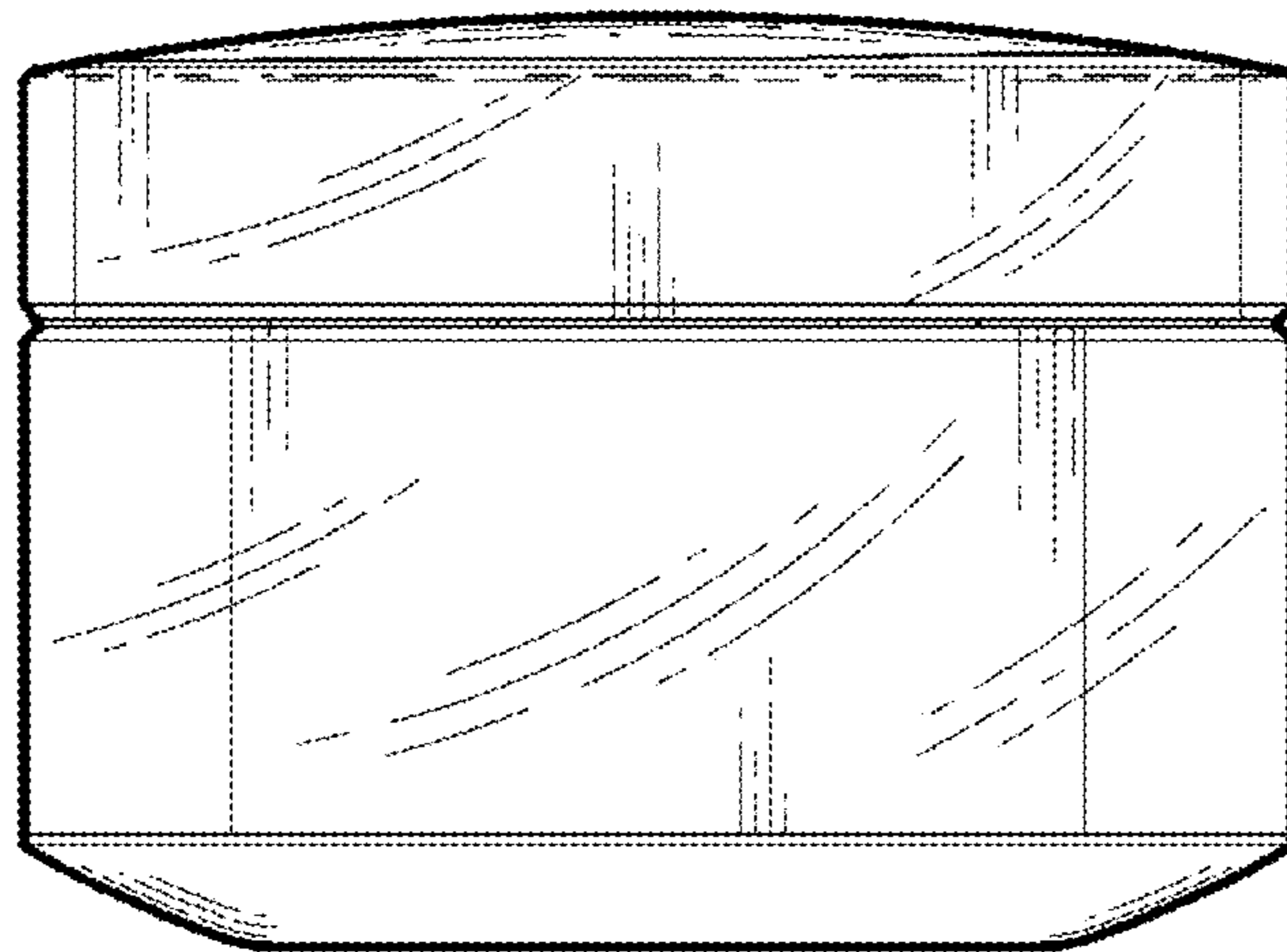

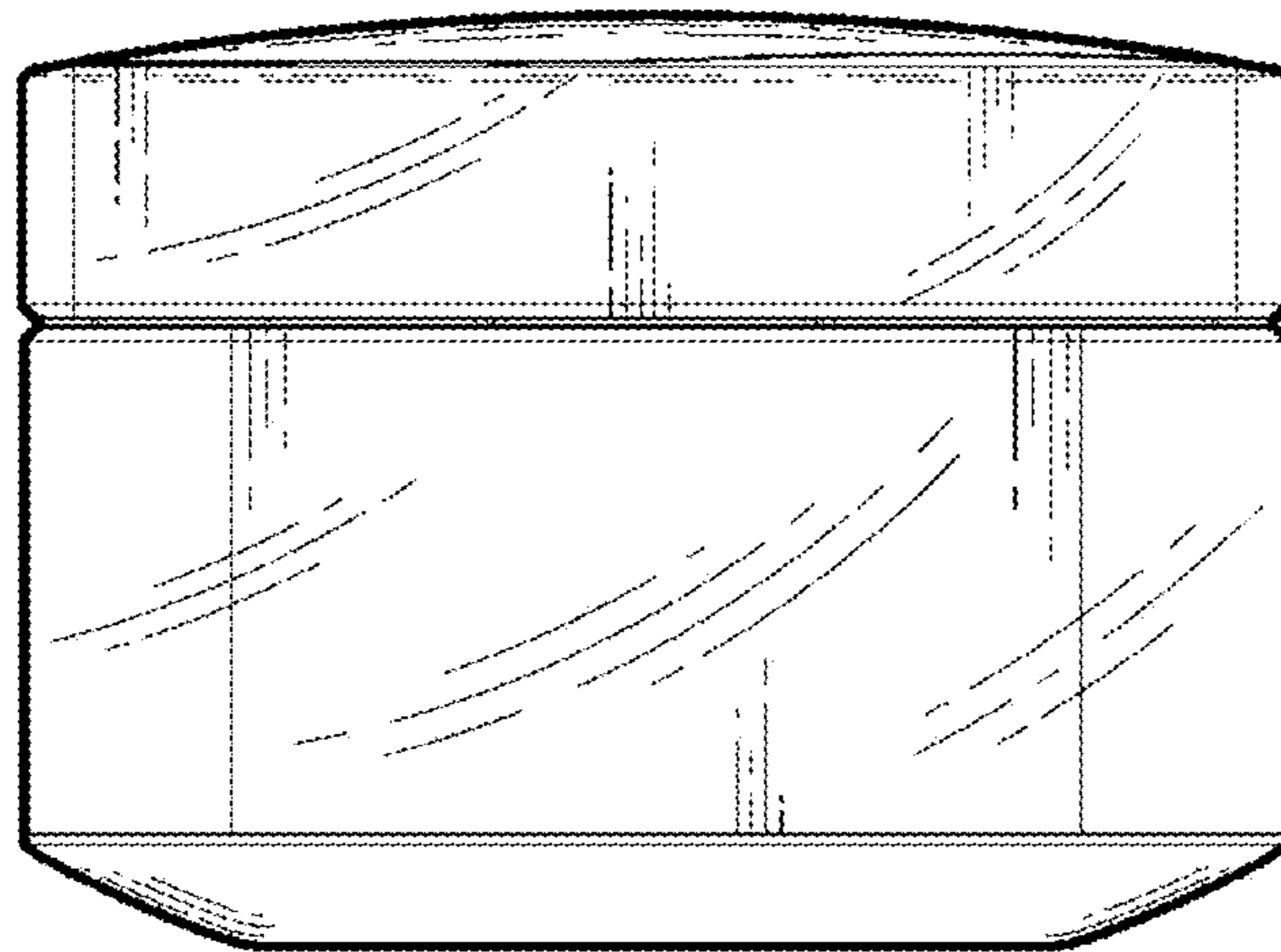

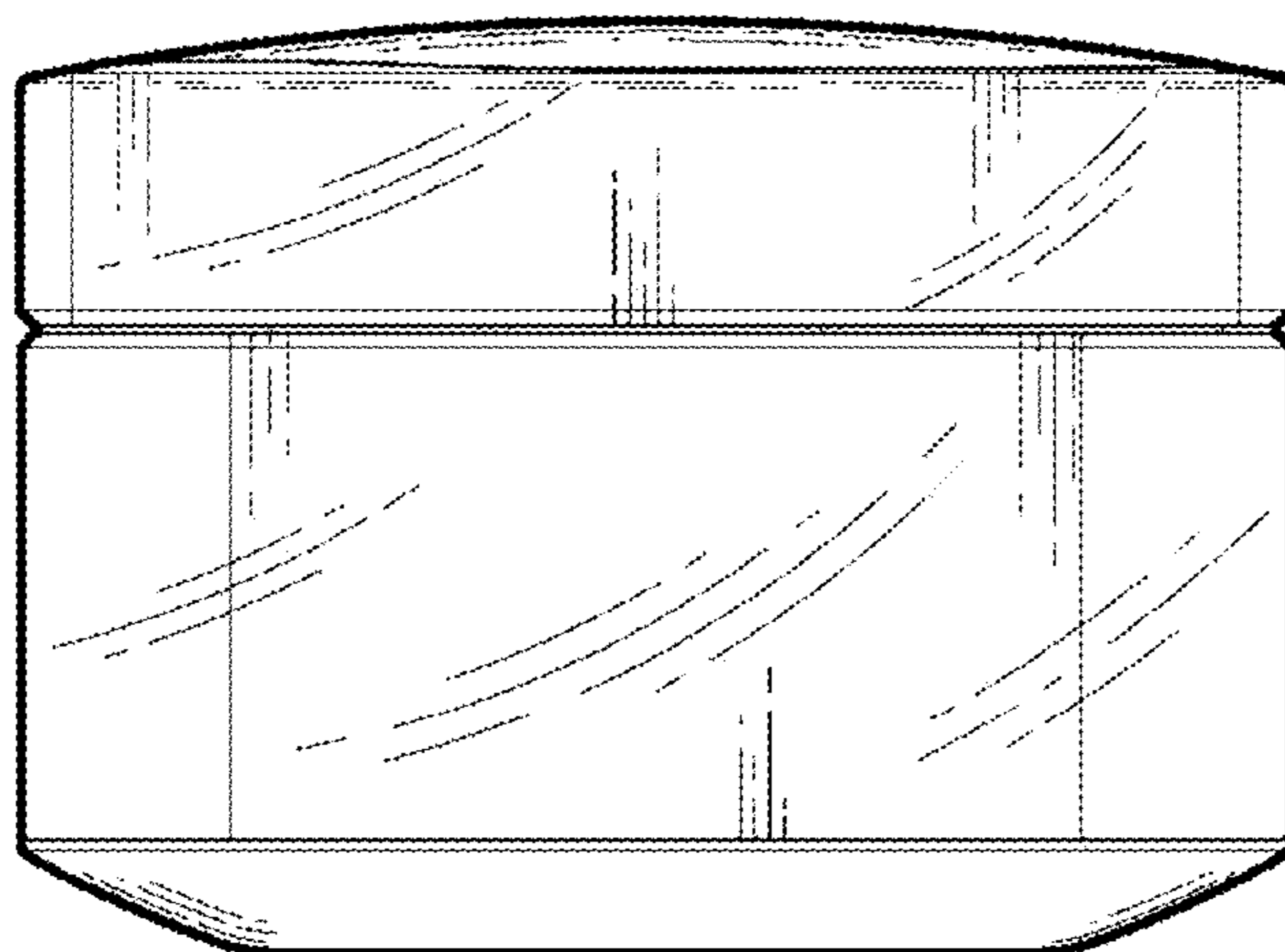

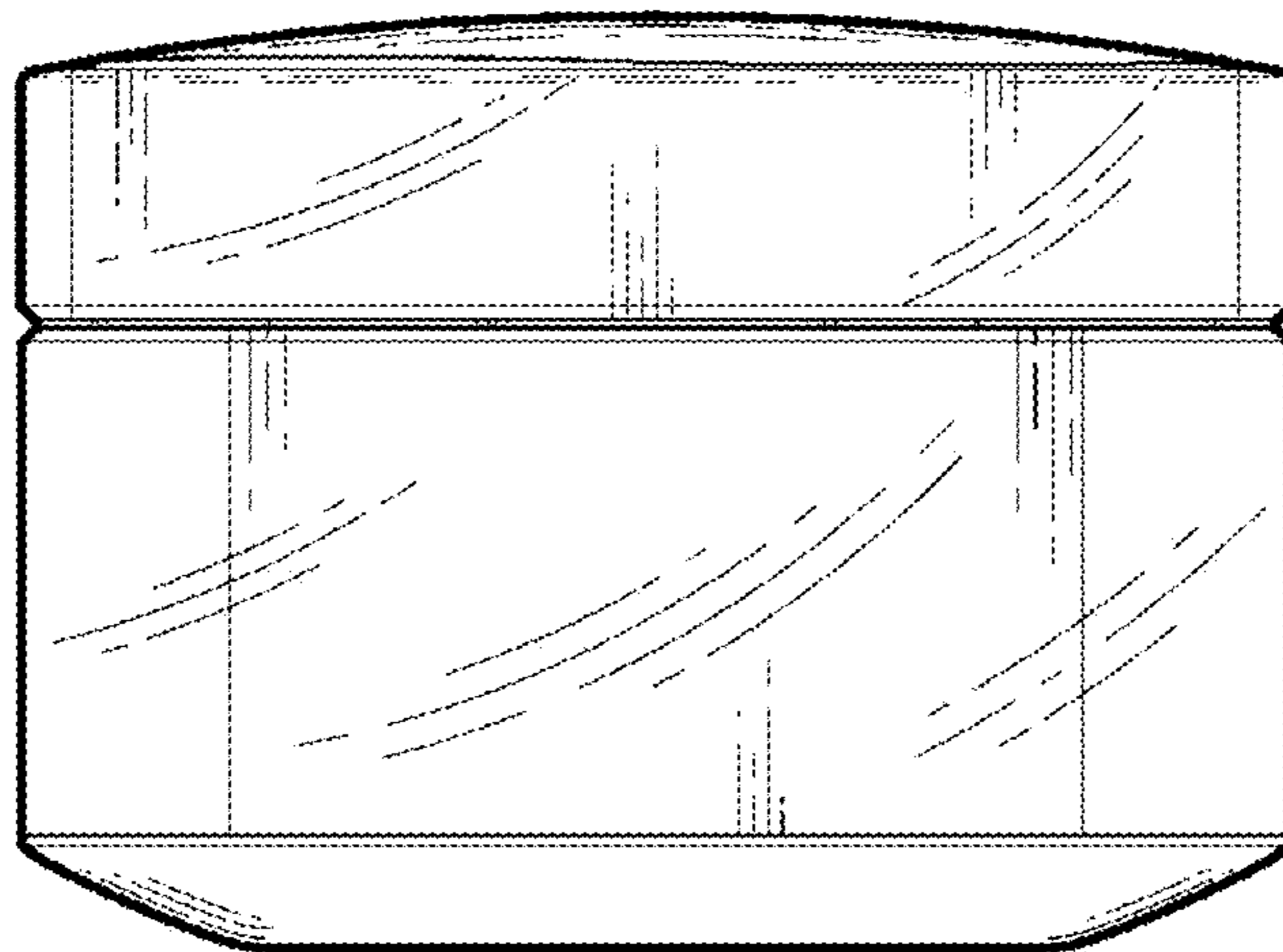

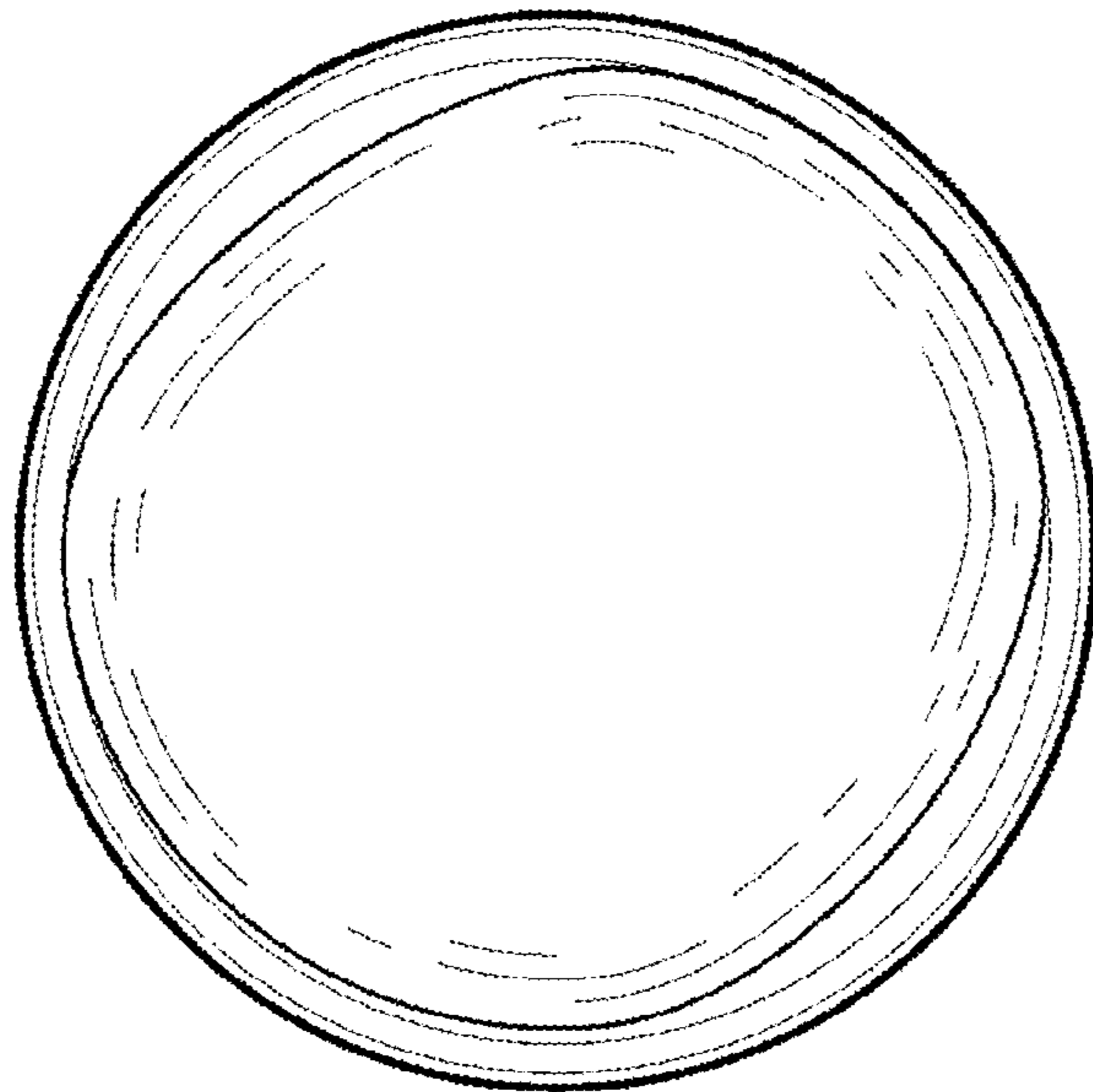
