(57) **CLAIM**

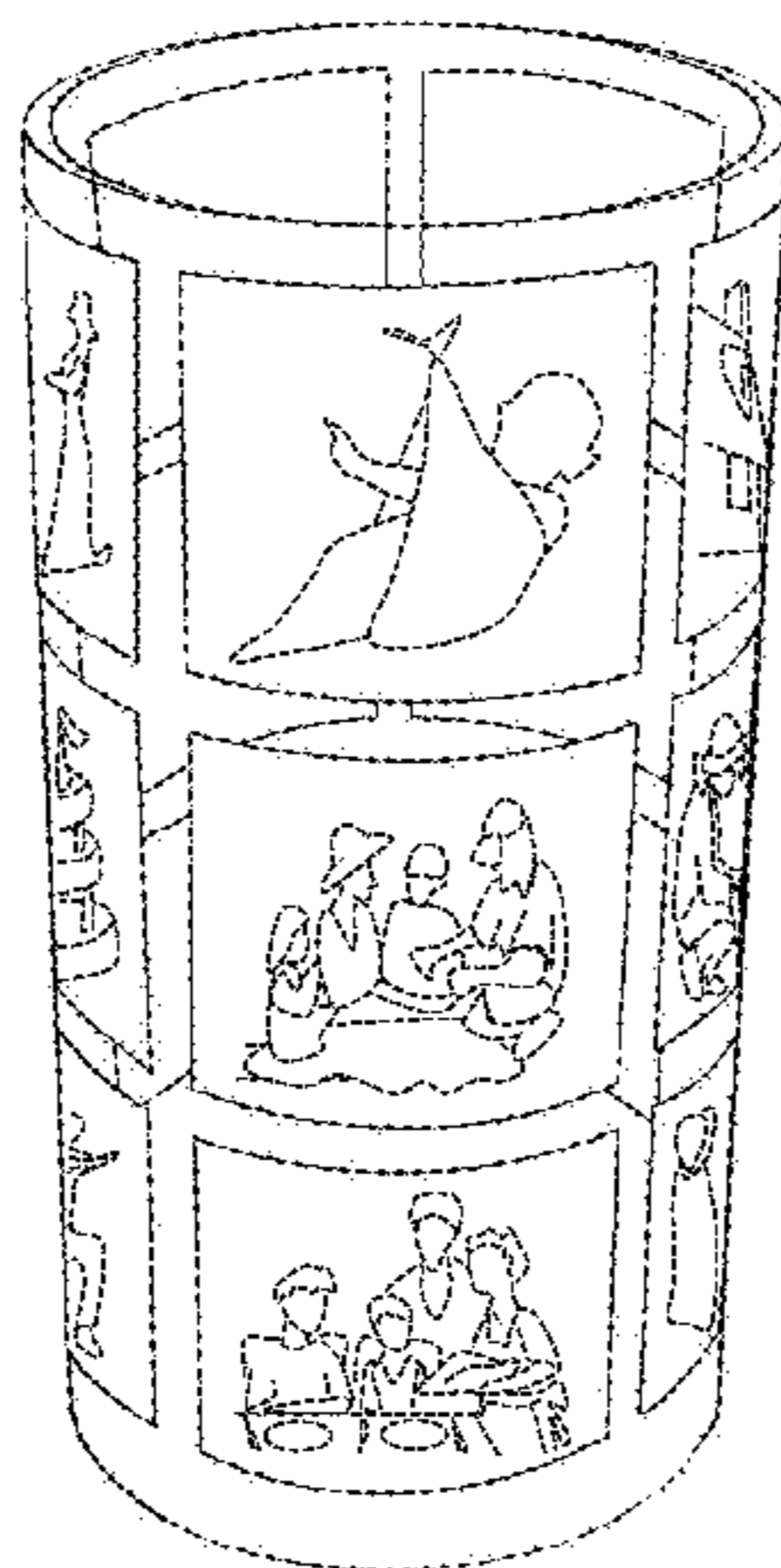
The ornamental design for a vase, as shown and described.

DESCRIPTION

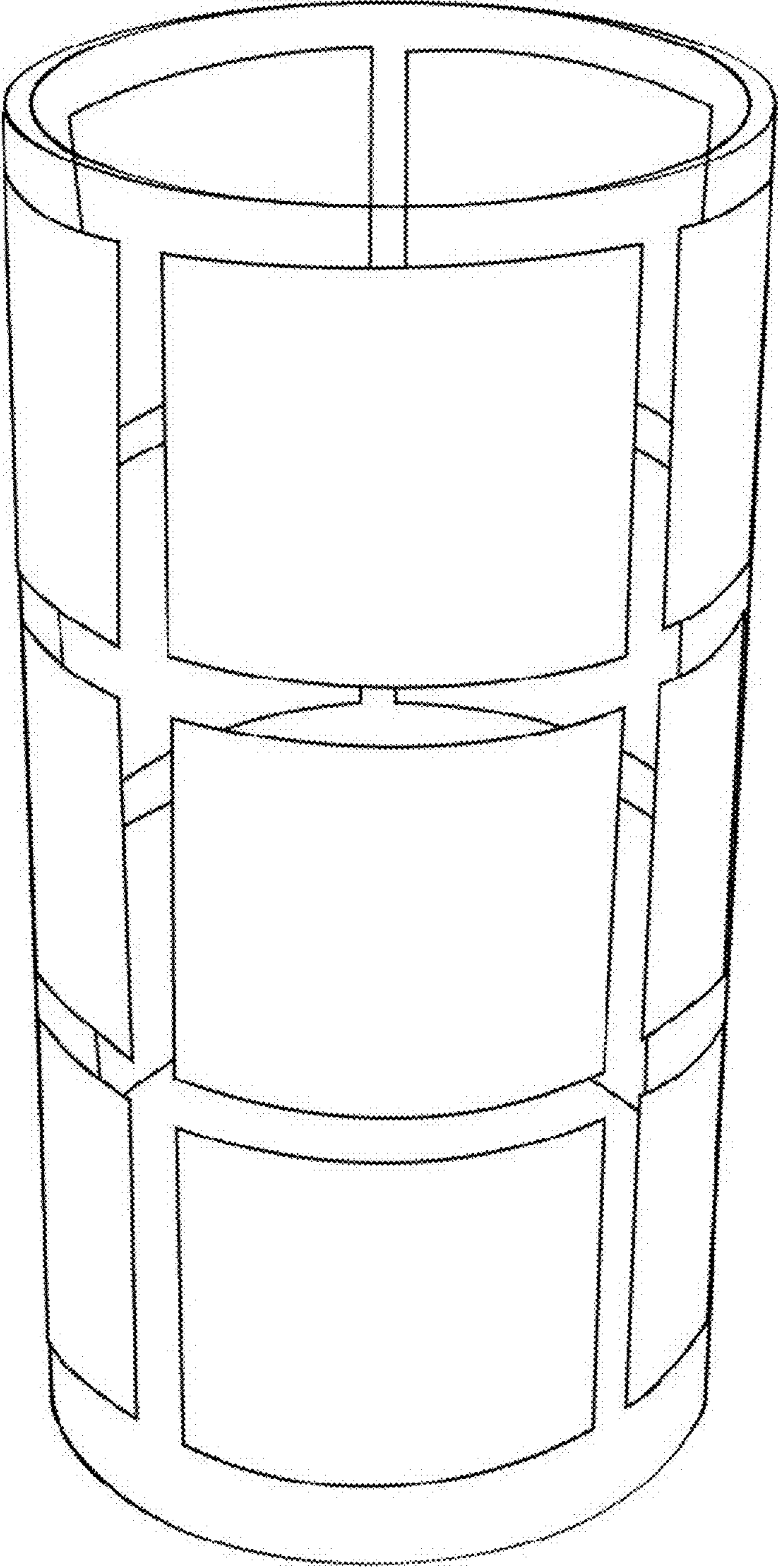

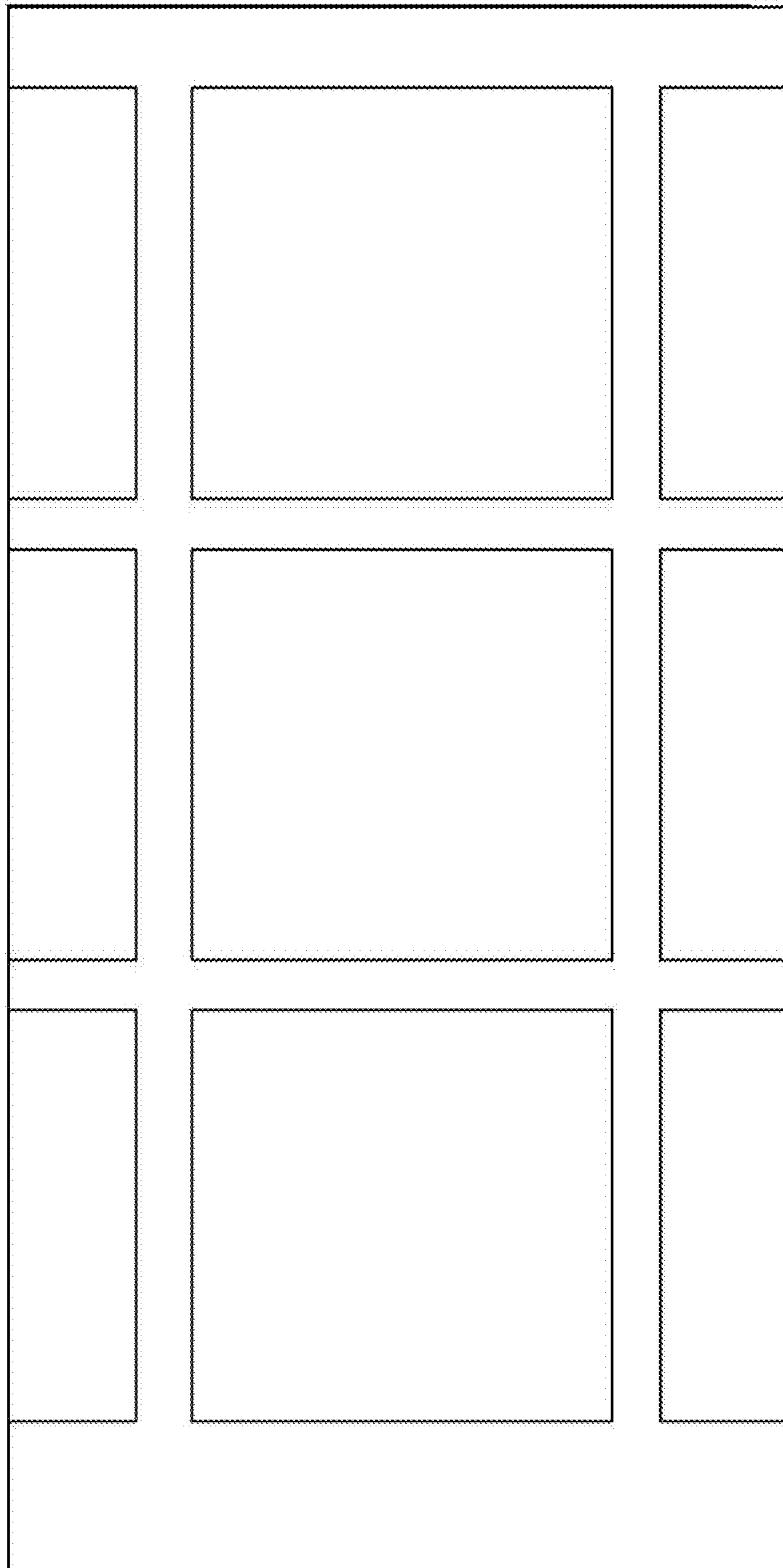

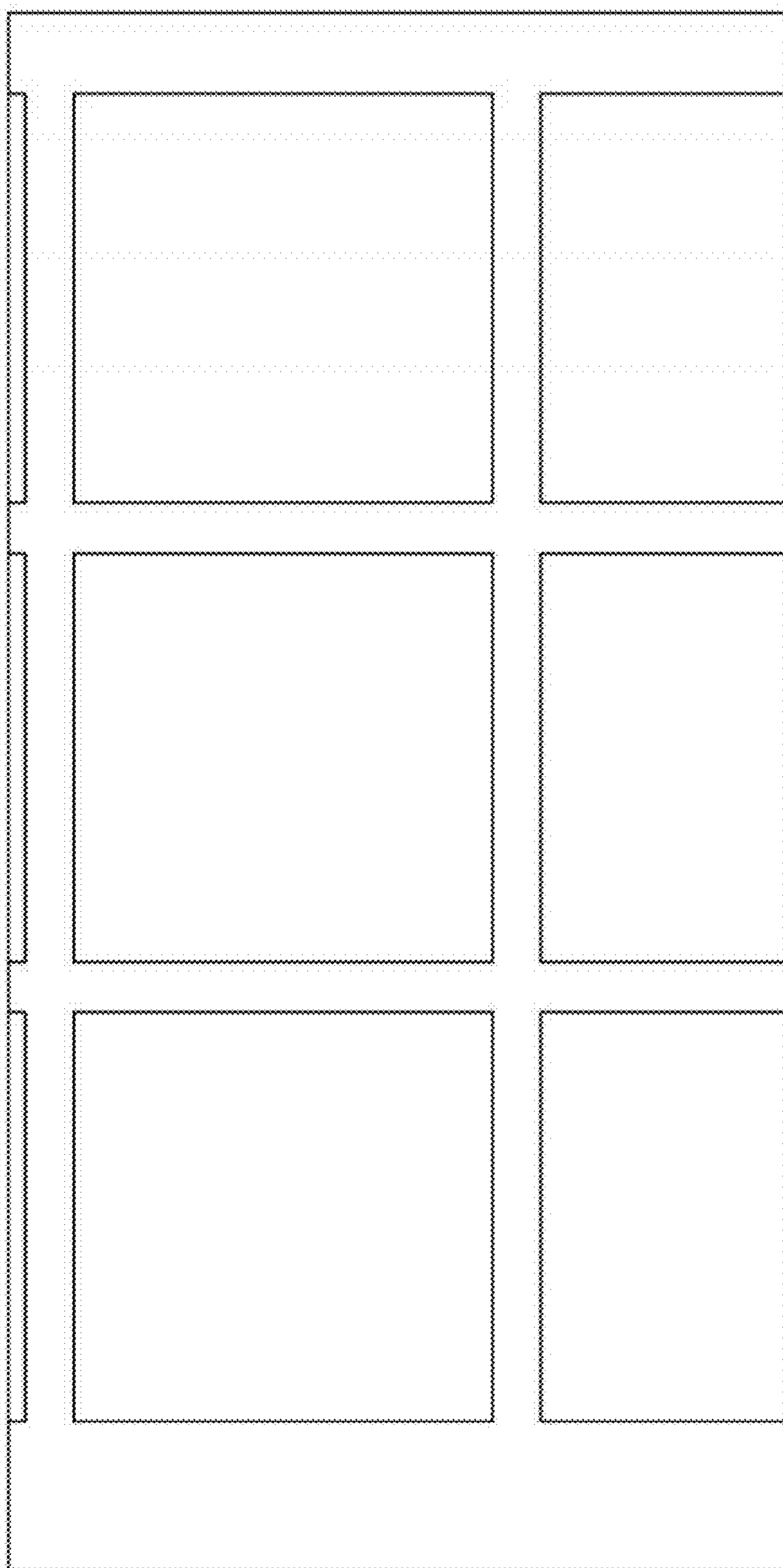

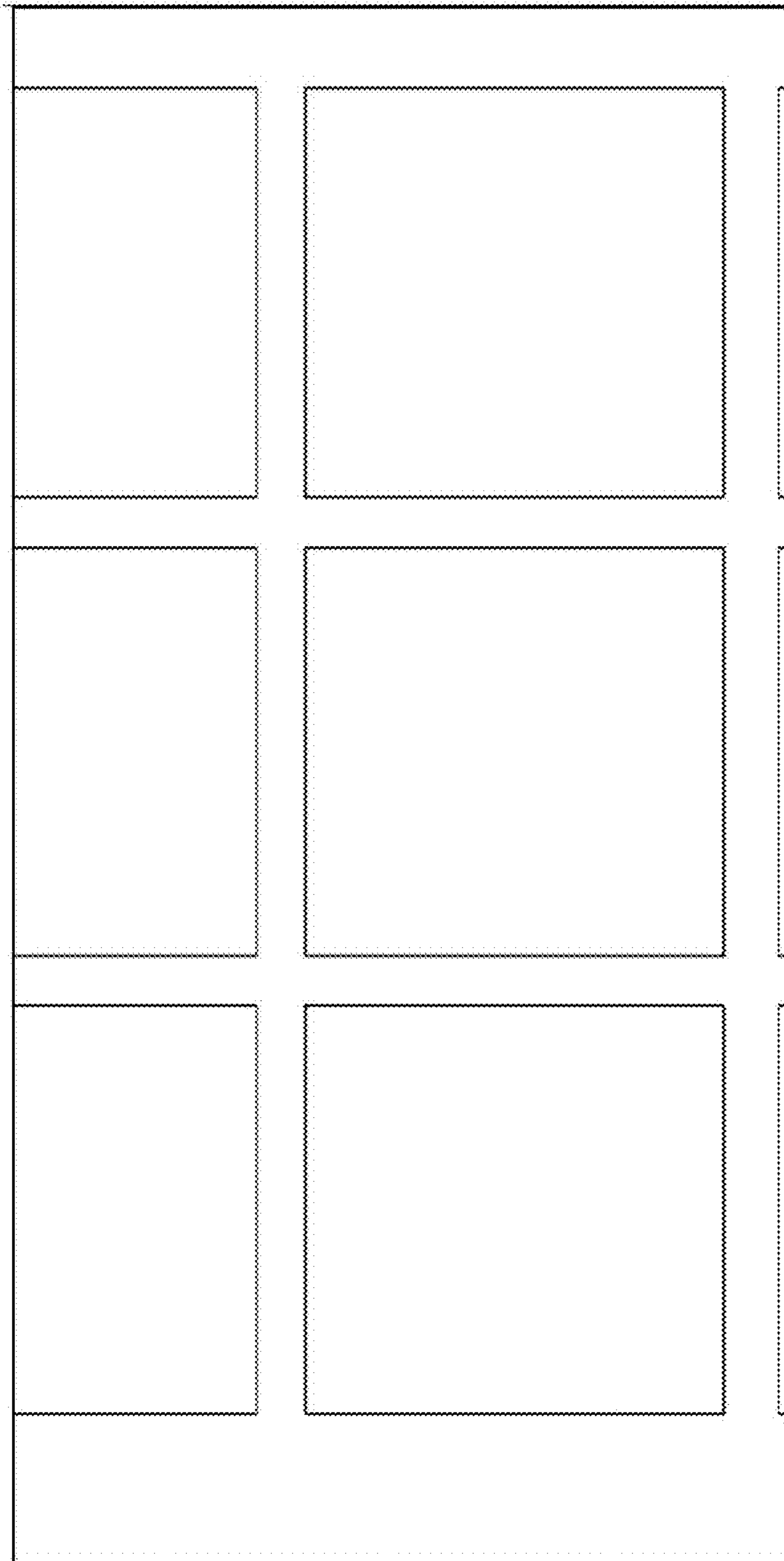

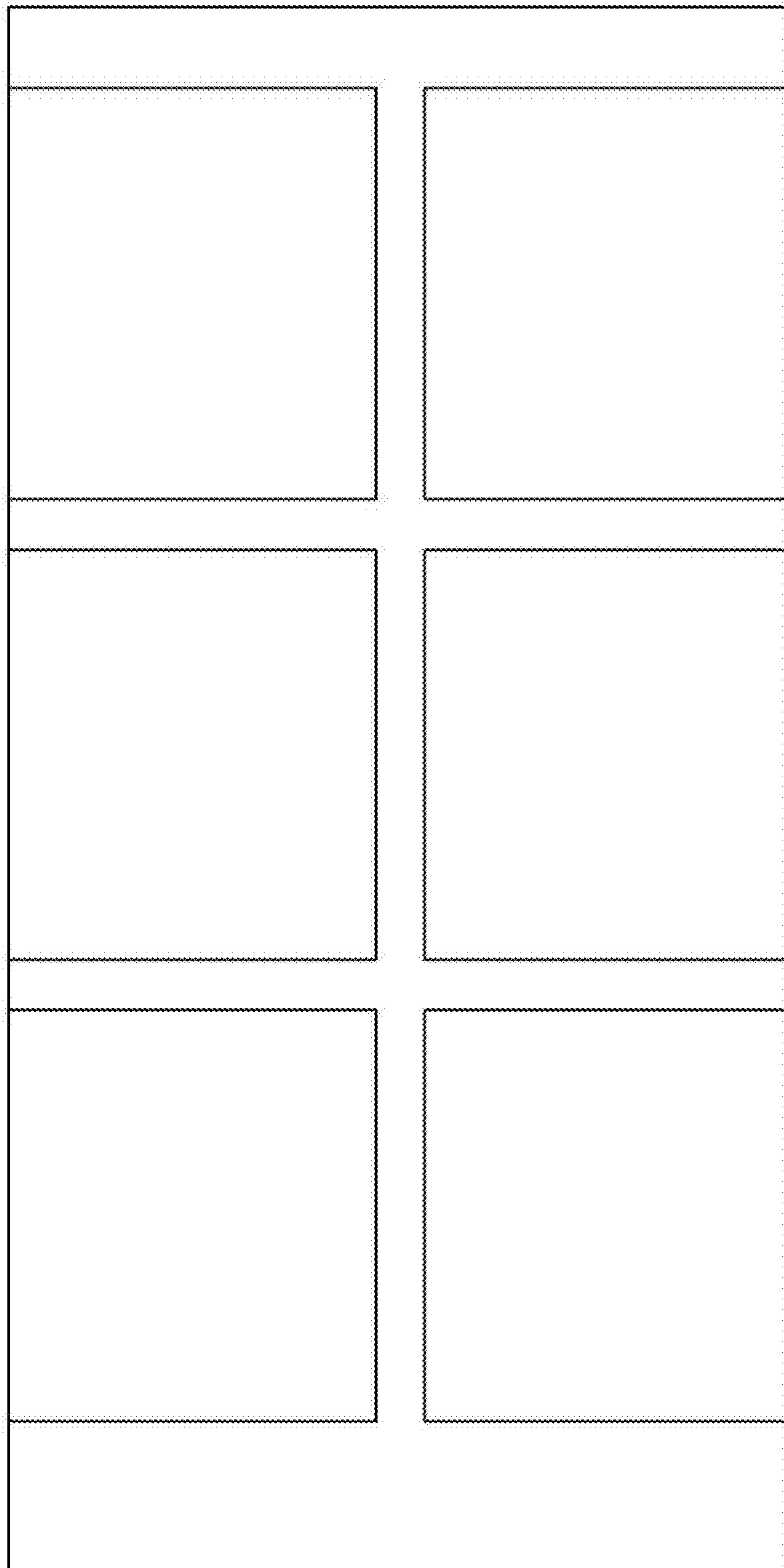

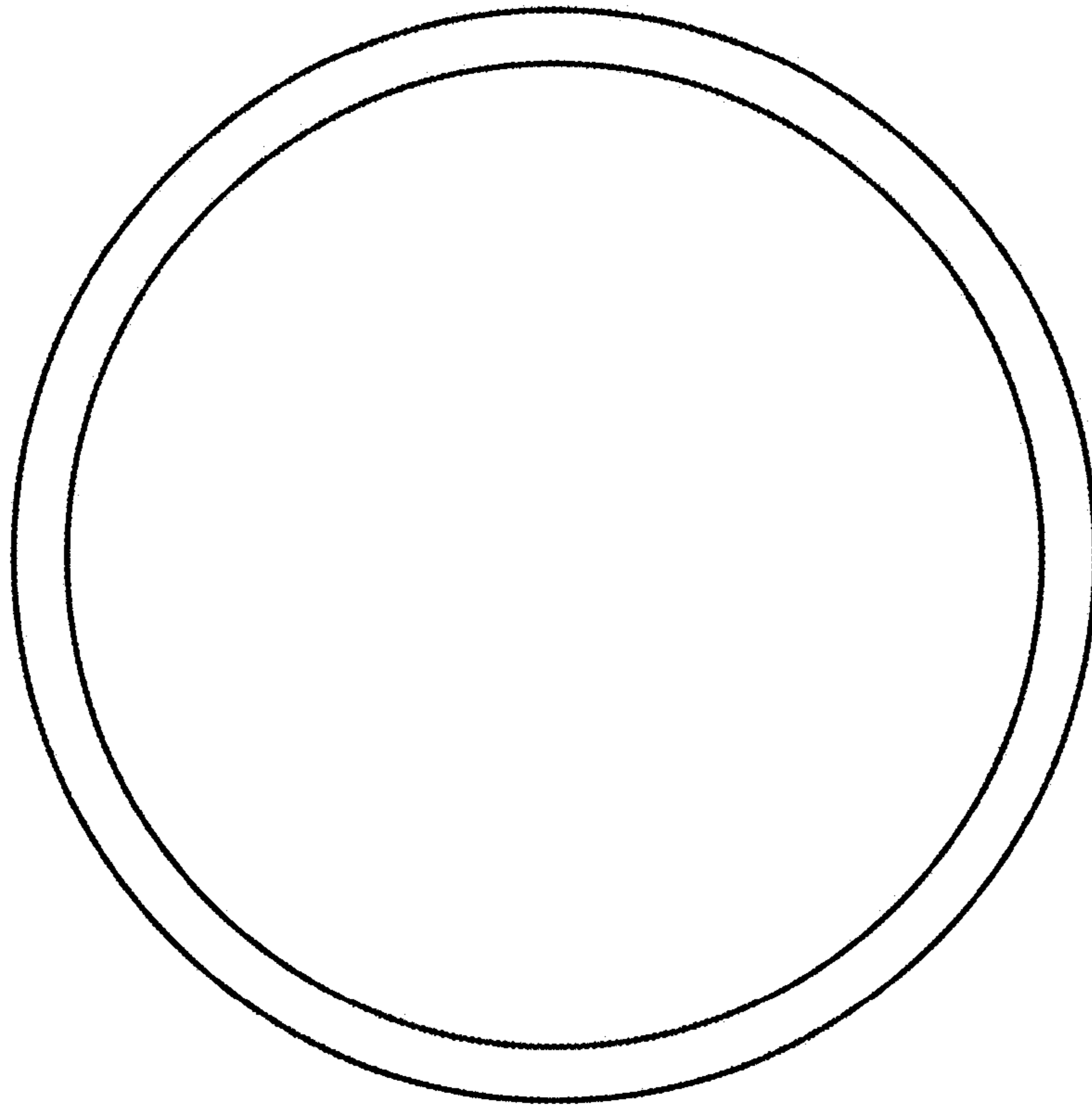

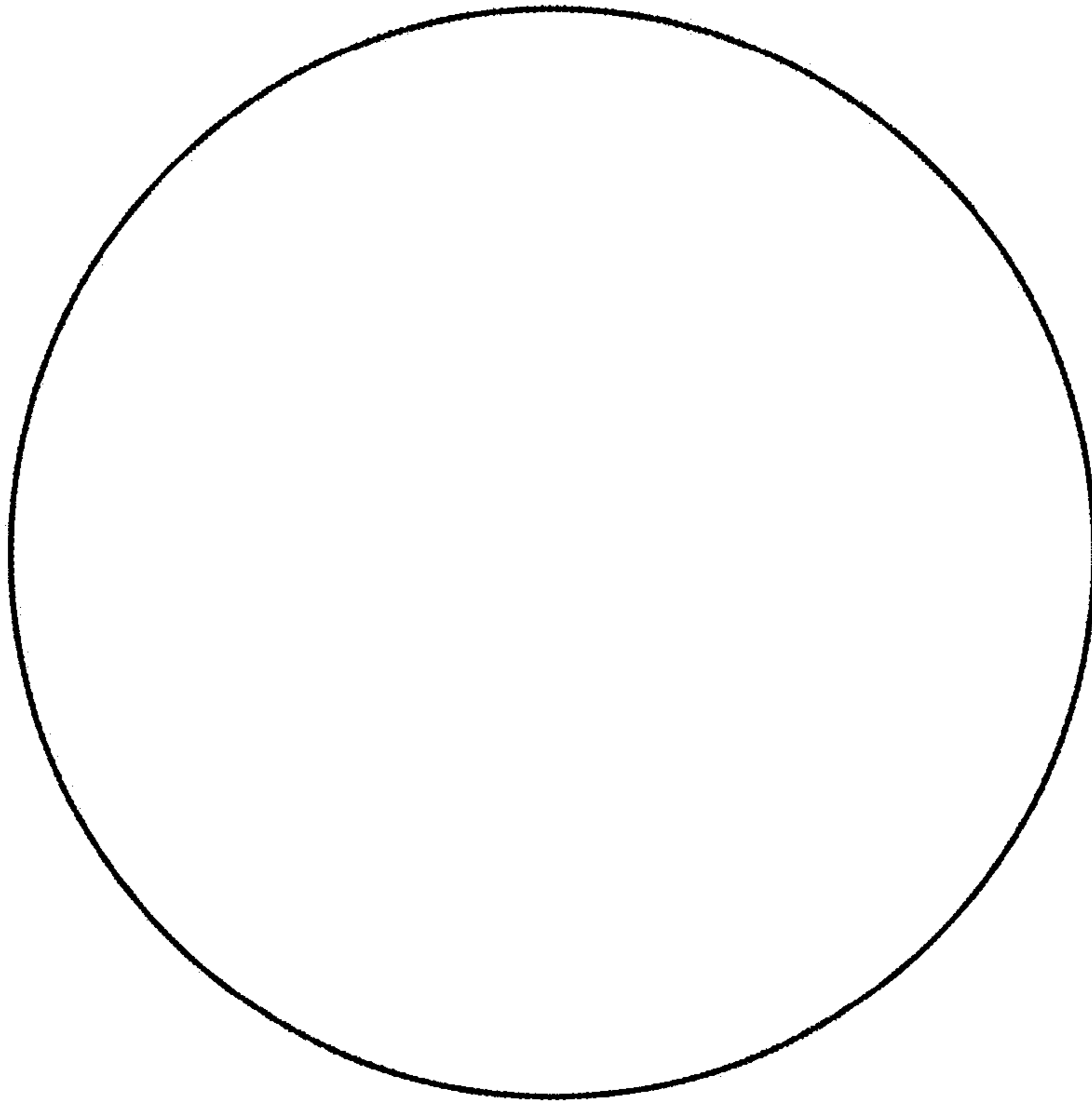

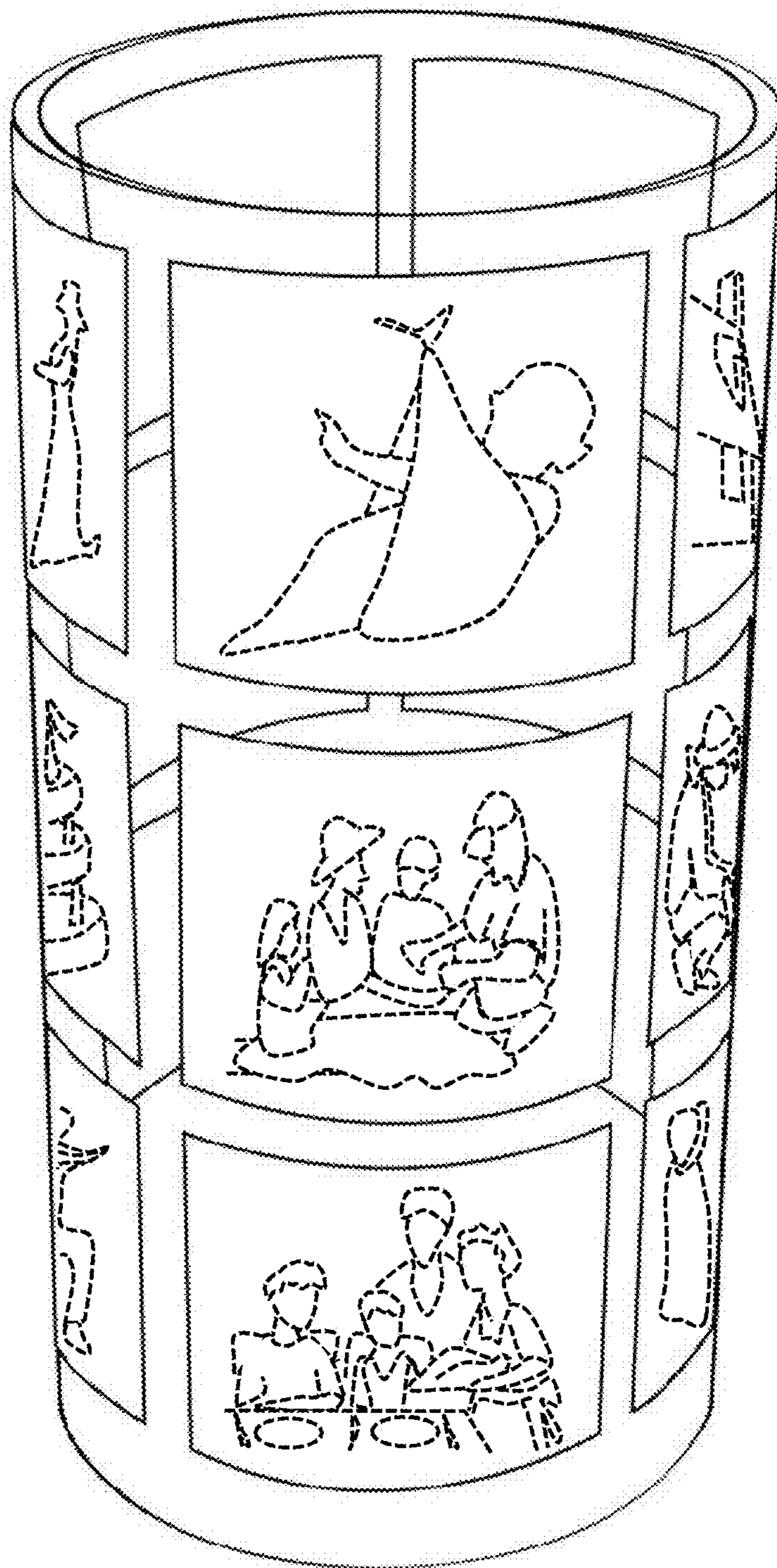

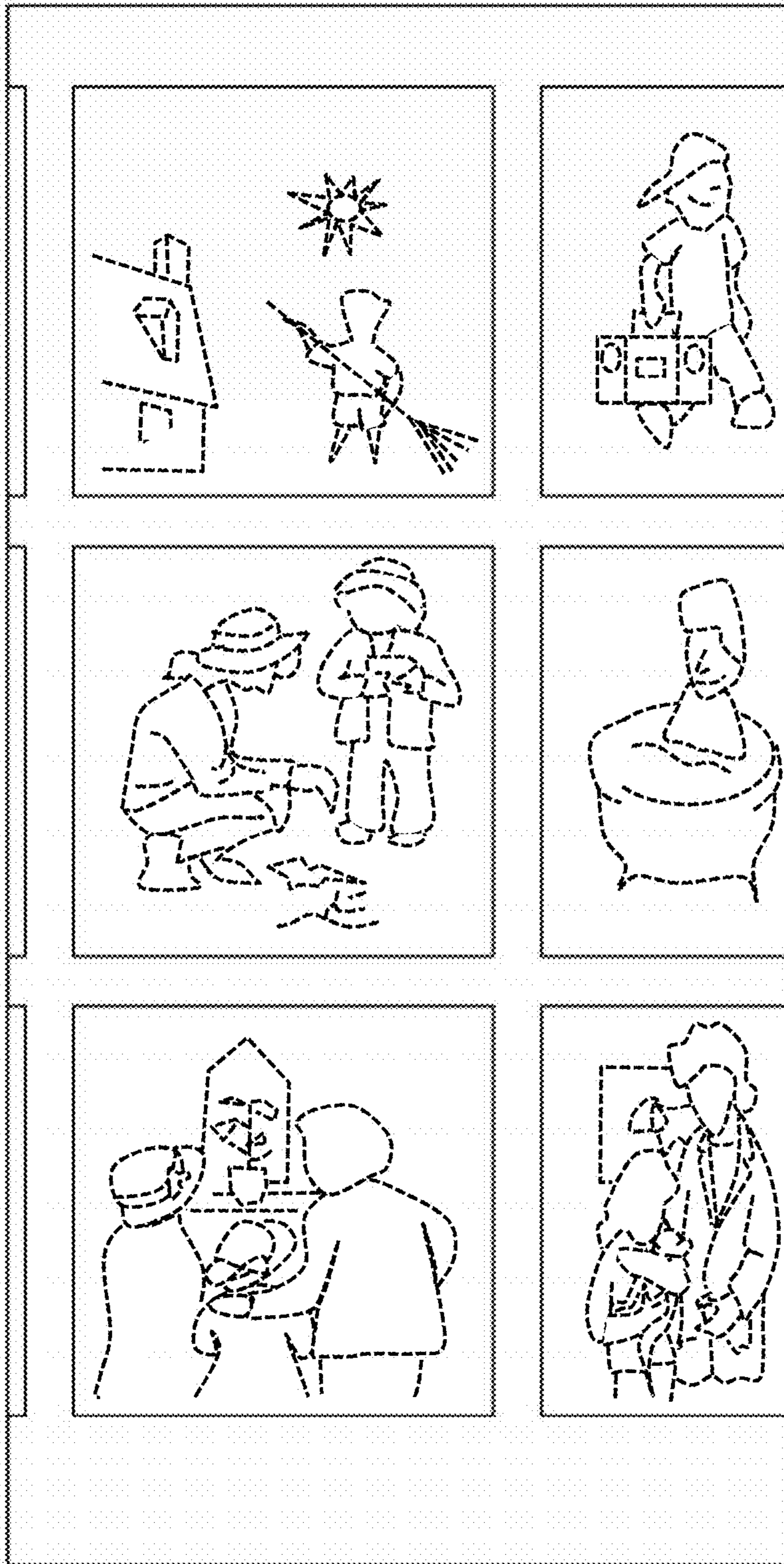

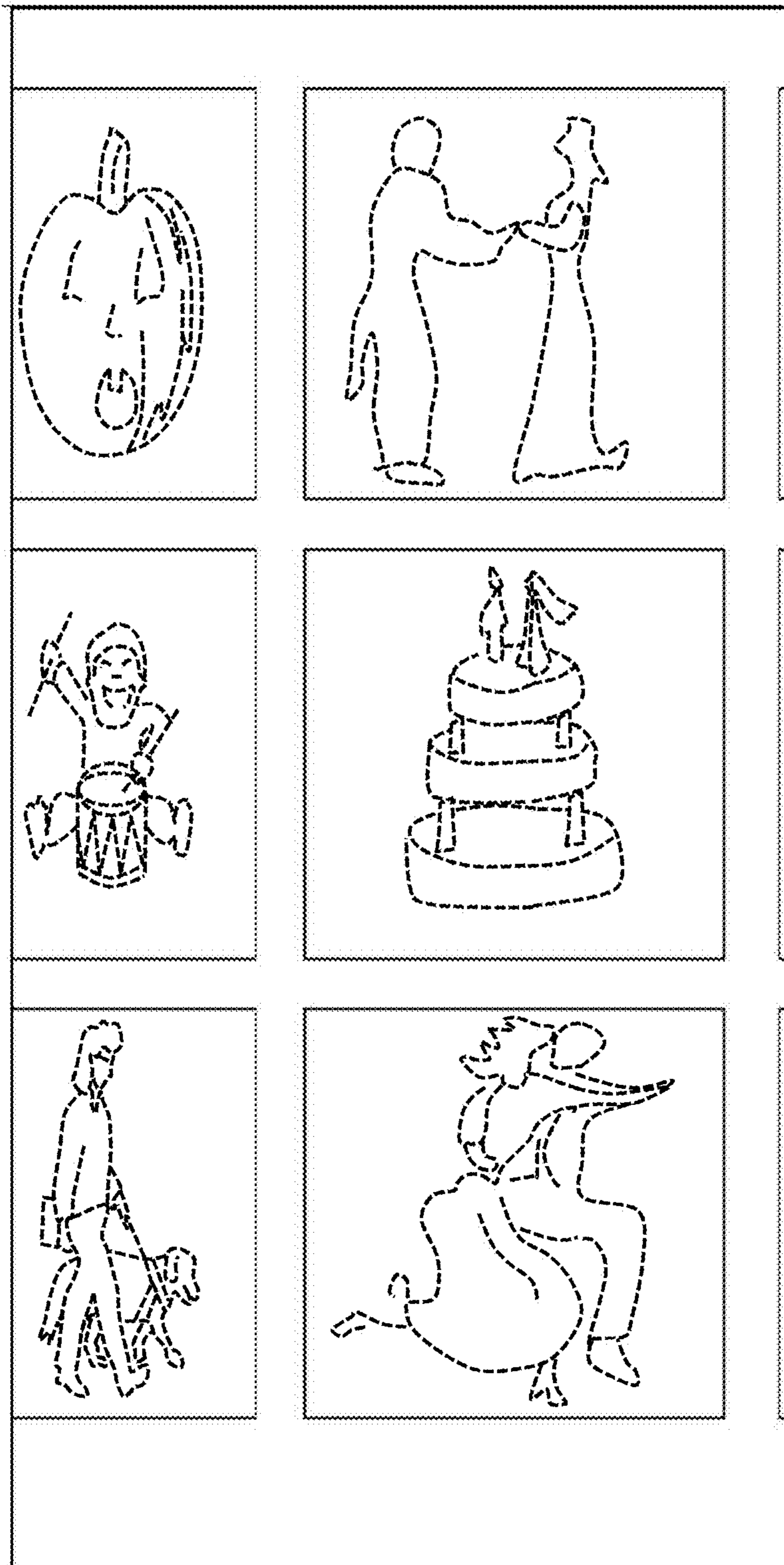

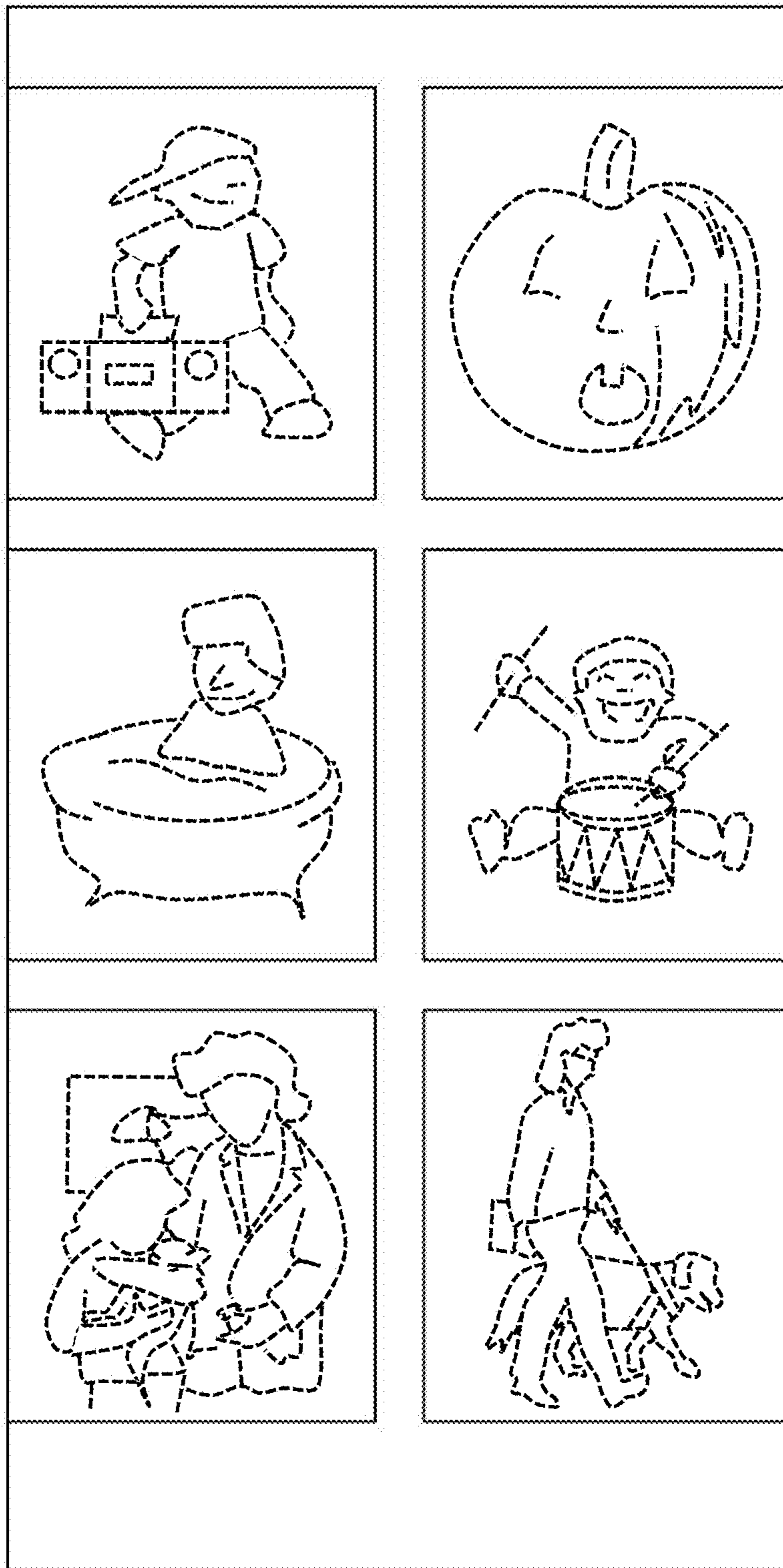
