(57) **CLAIM**

The ornamental design for a module for programmable logic controller (PLC), as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a module for a programmable logic controller (PLC) showing our new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right-side elevation view thereof; FIG. 6 is left-side elevation view thereof; FIG. 7 is a front perspective view thereof; and, FIG. 8 is a right side perspective view thereof. The broken line portion of the figure drawings is included to show unclaimed subject matter only and forms no part of the claimed design.

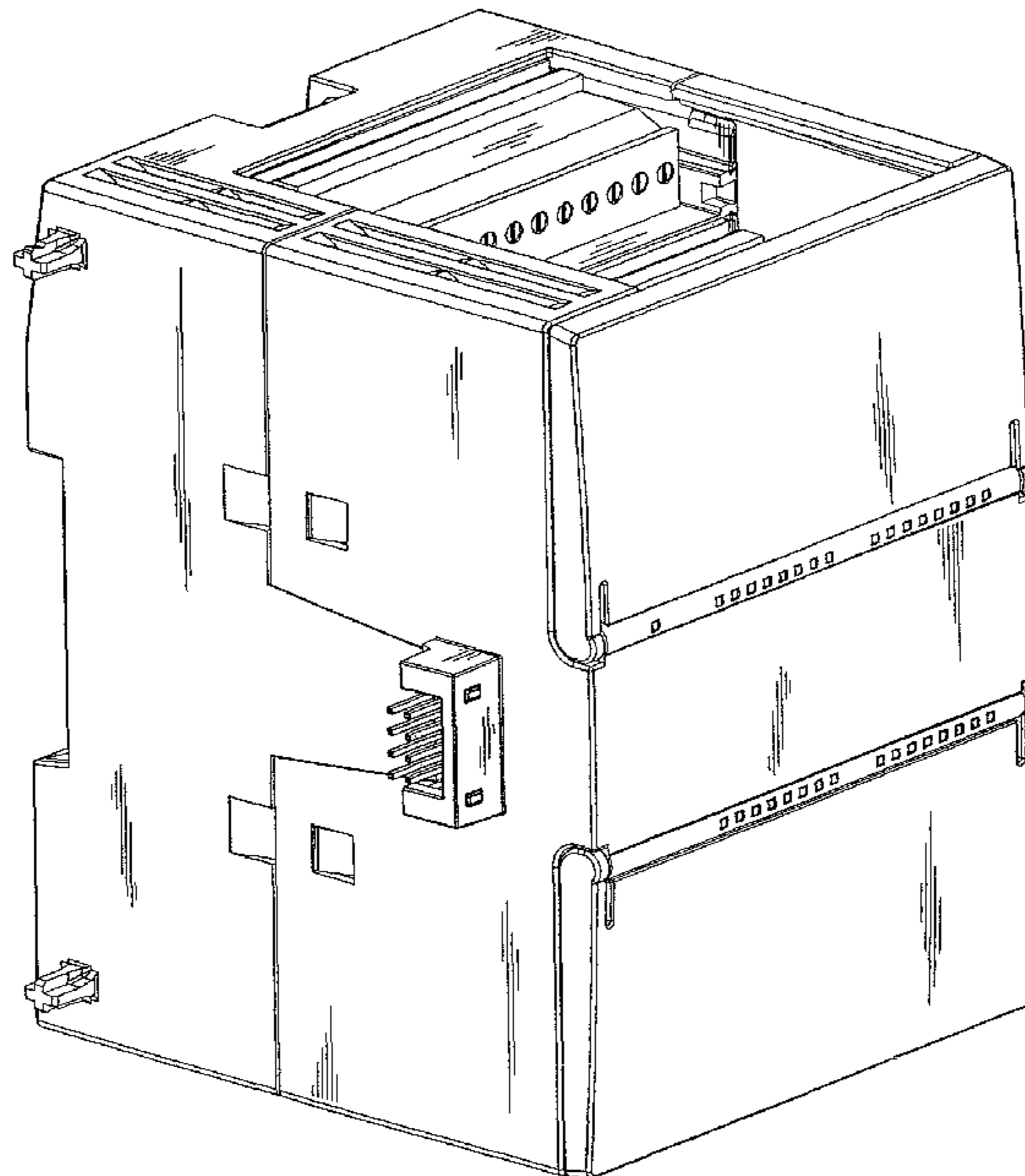

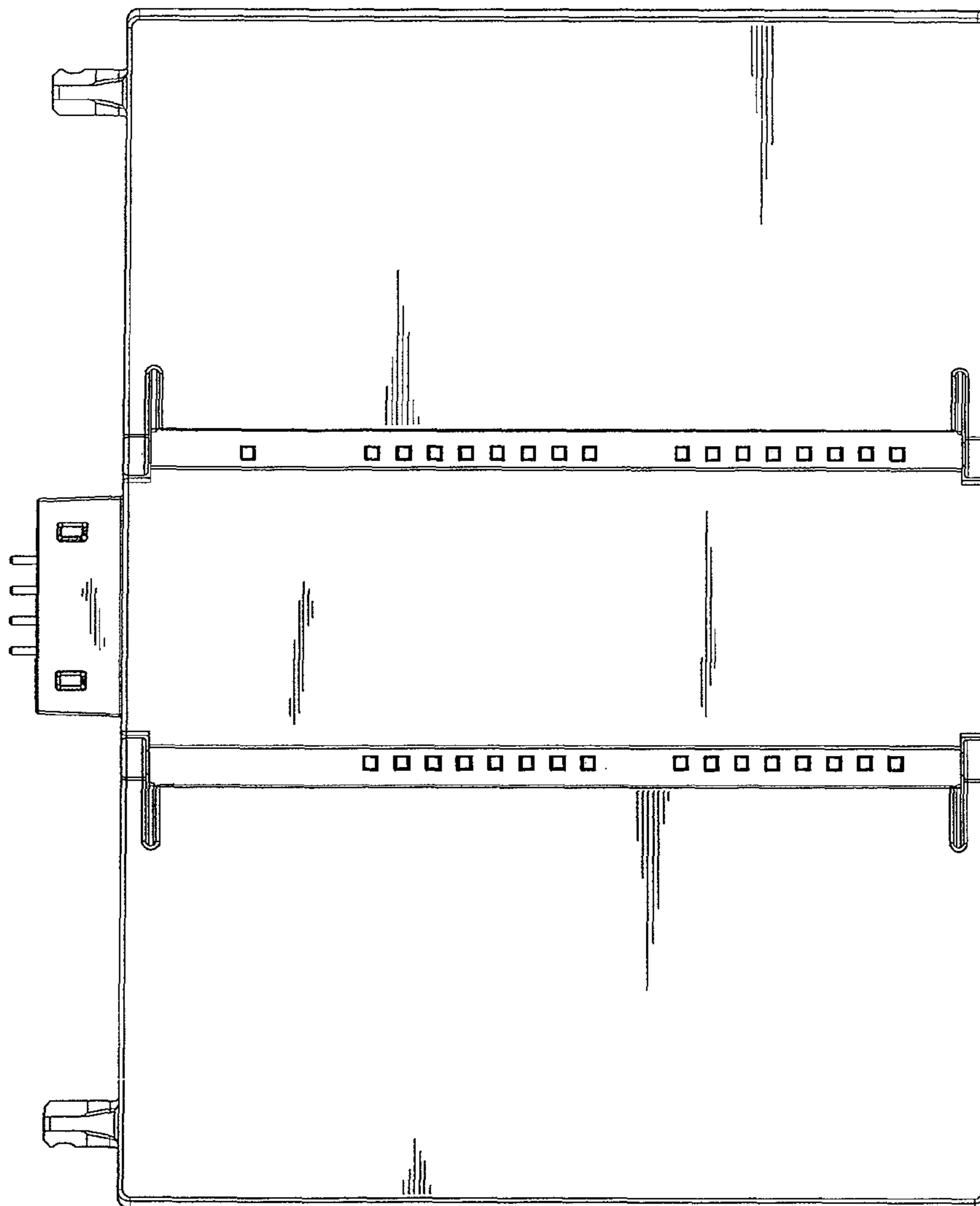

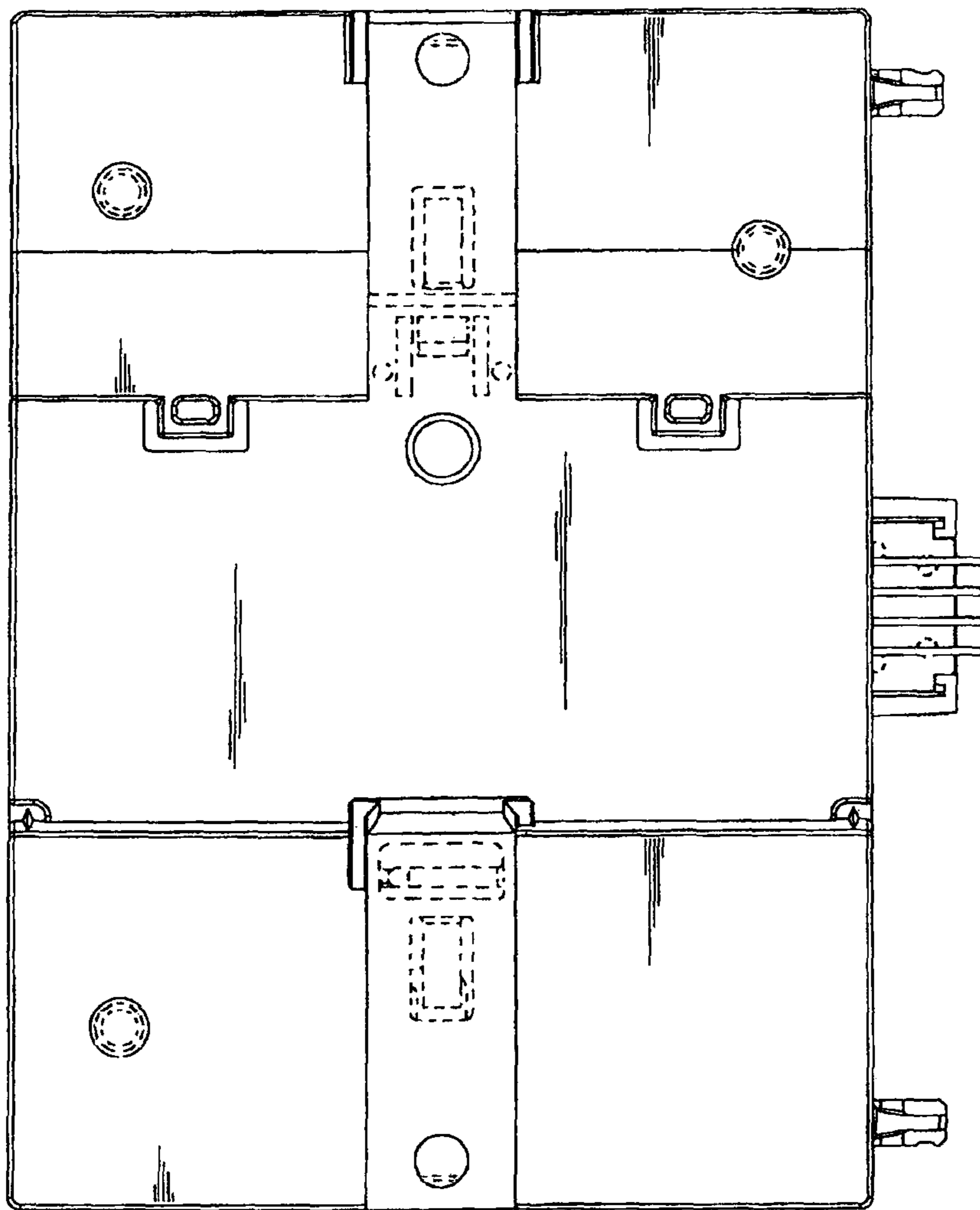

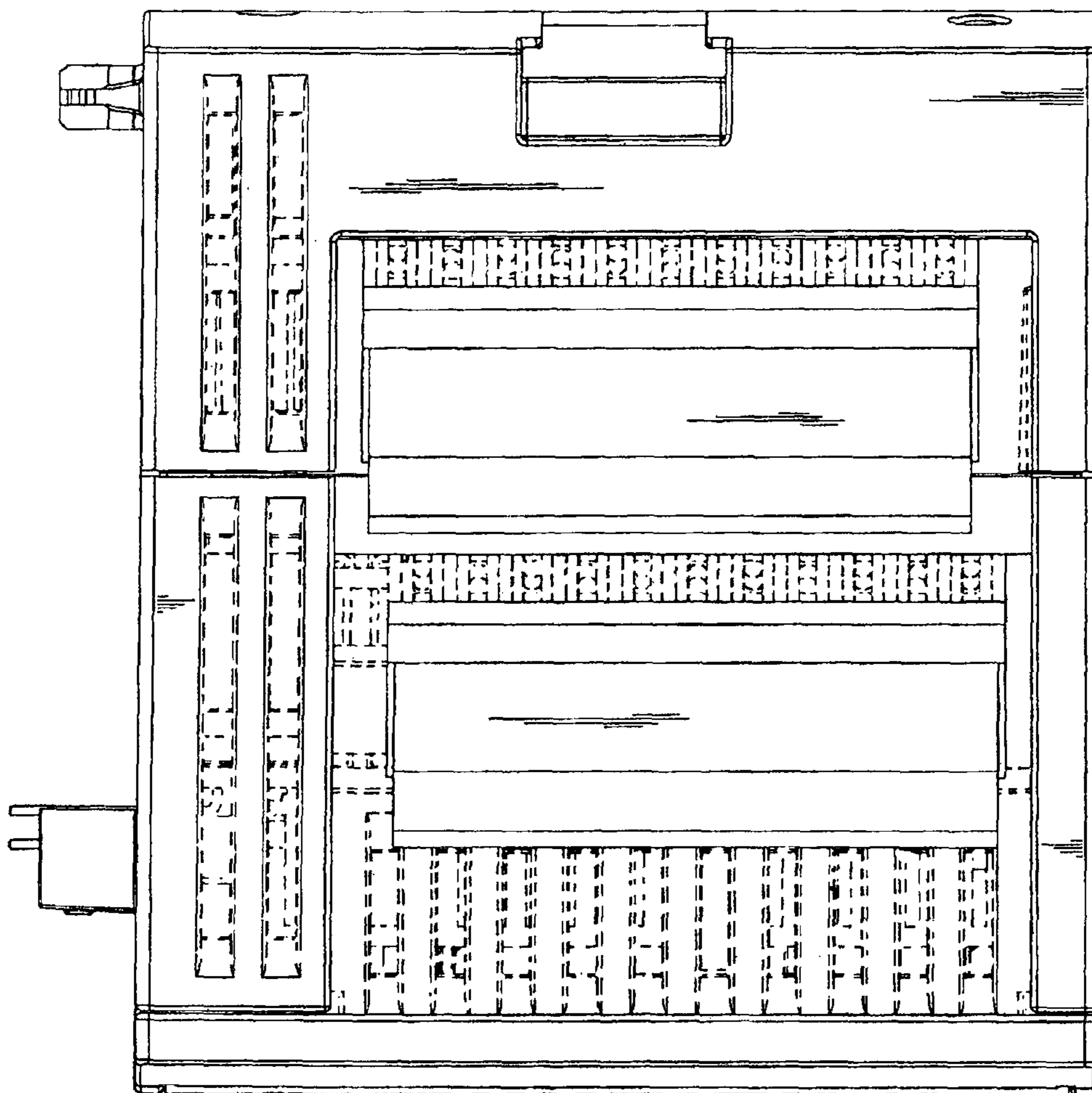

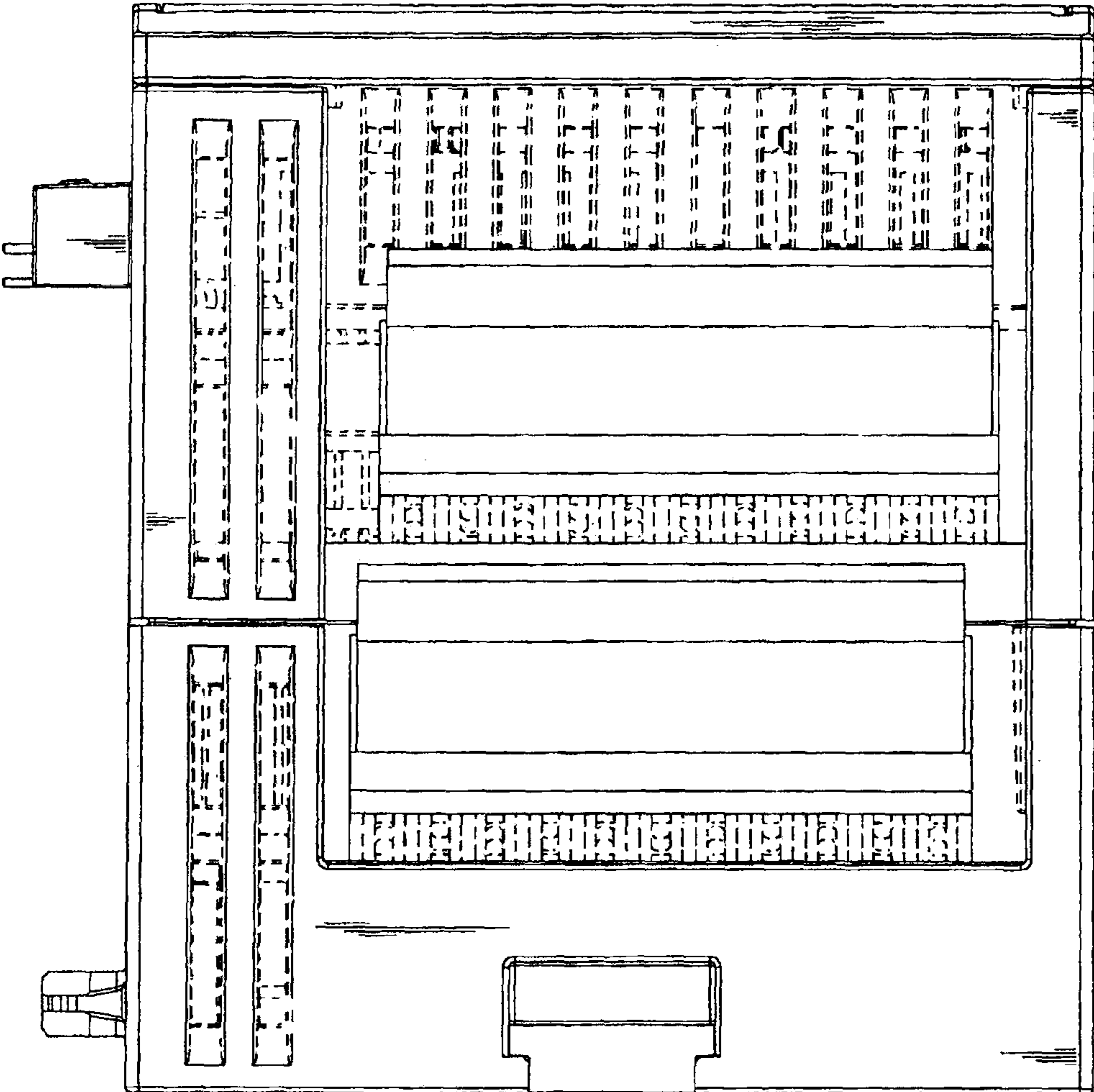

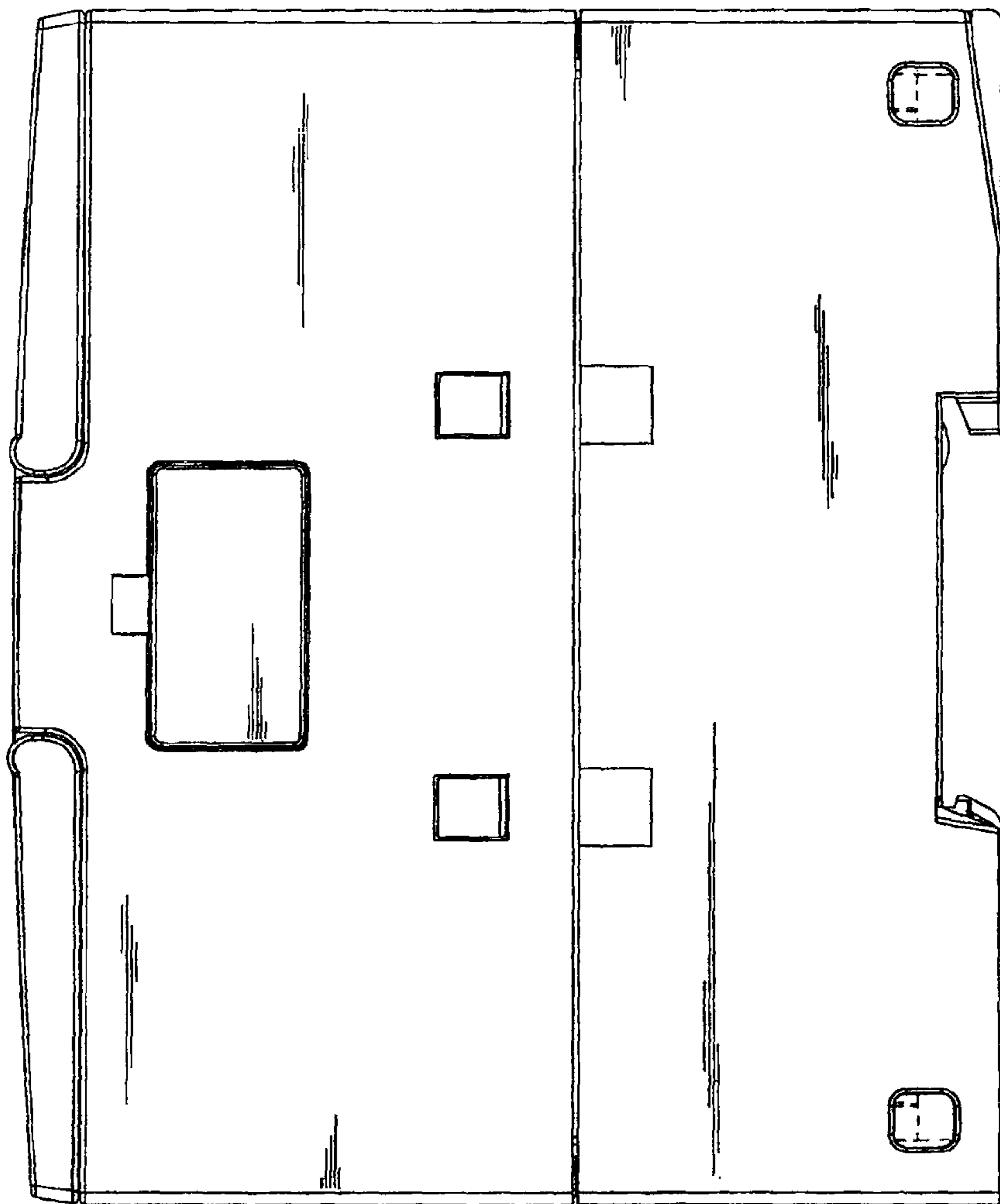

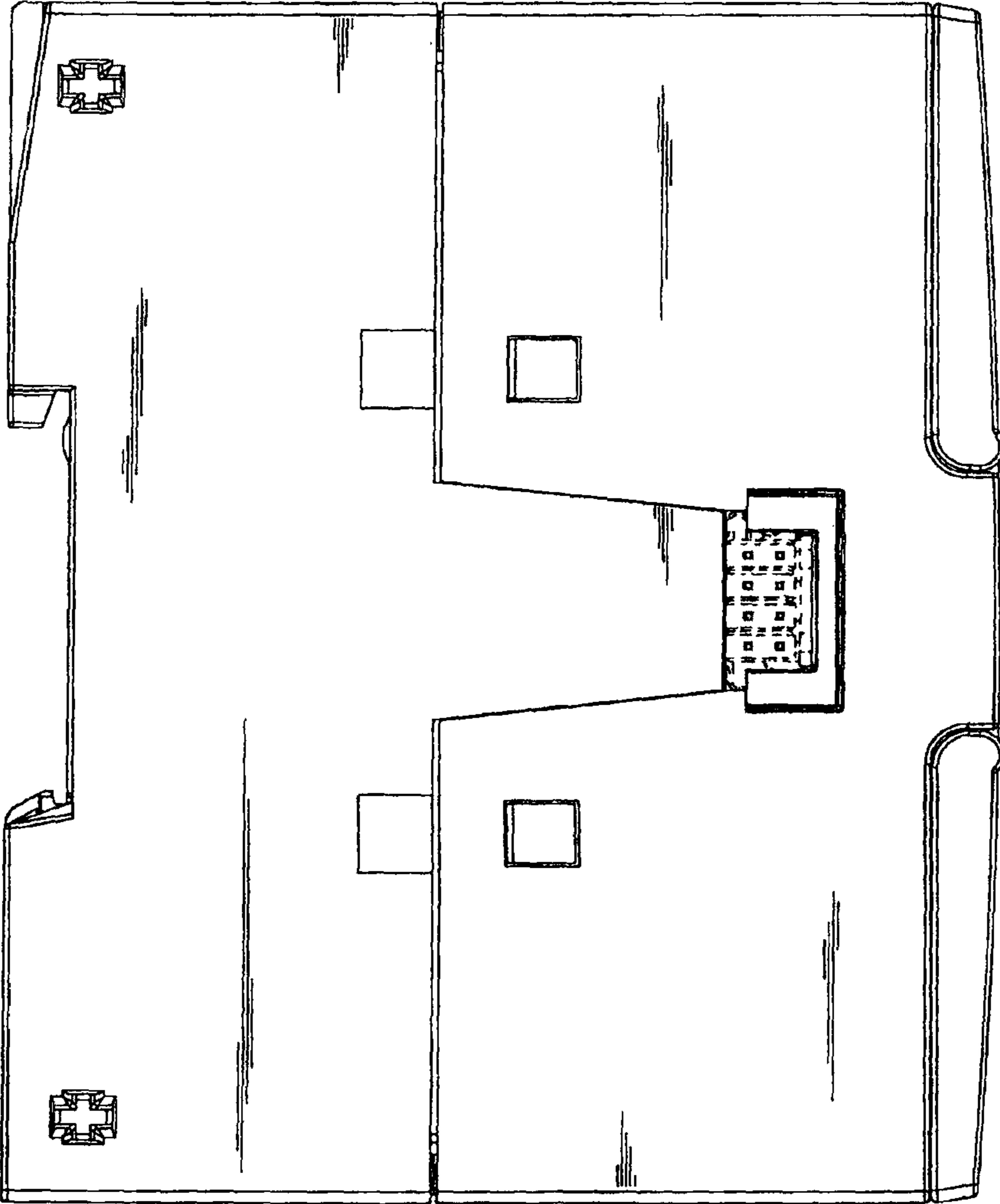

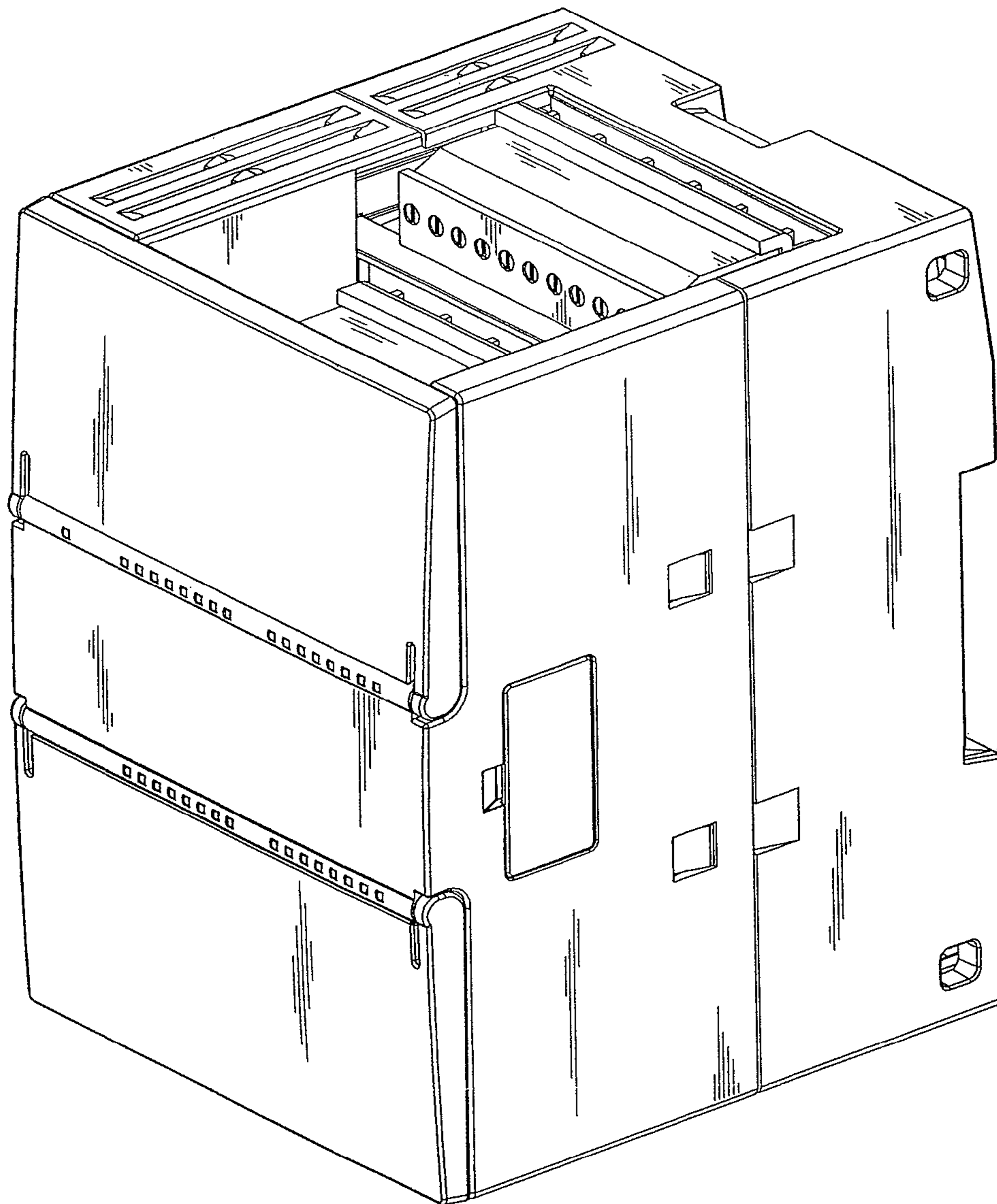
