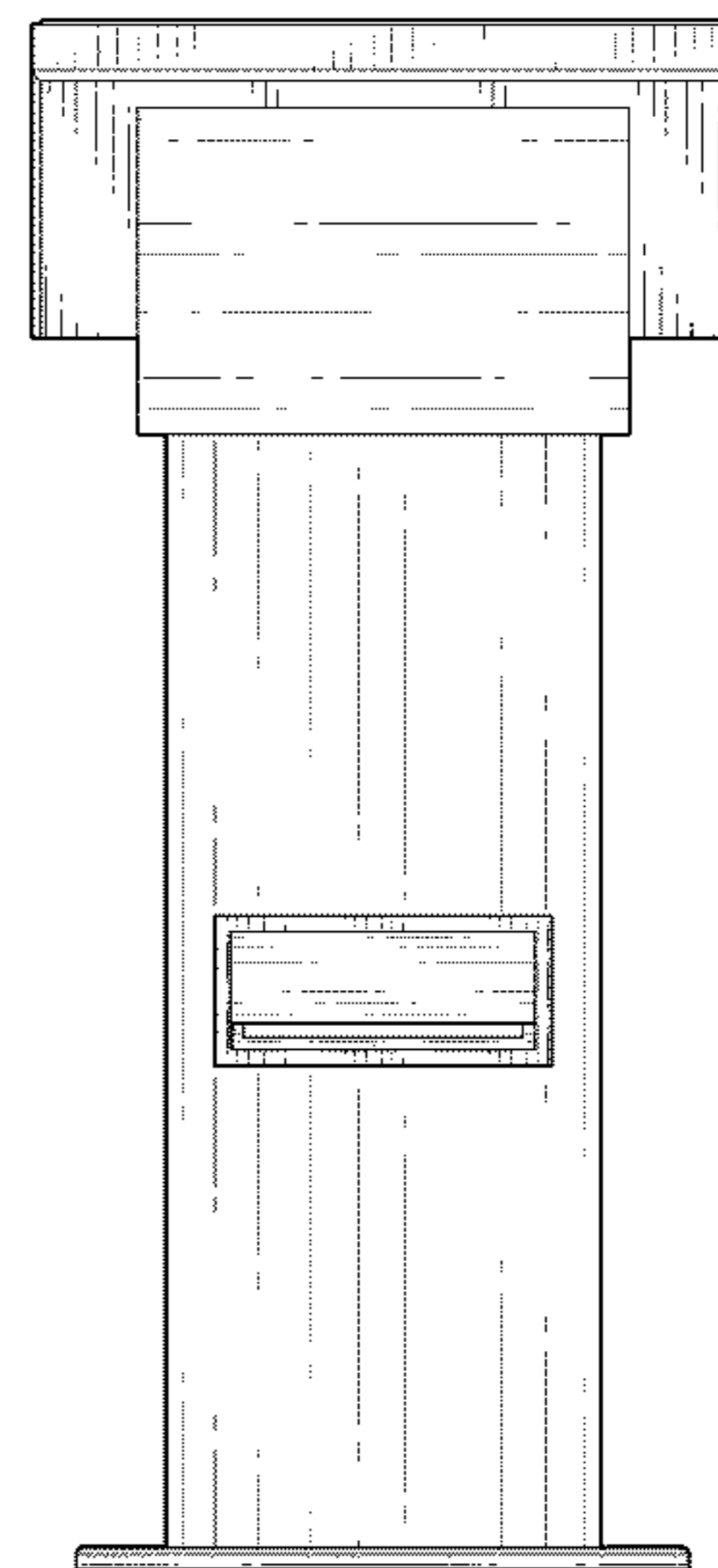
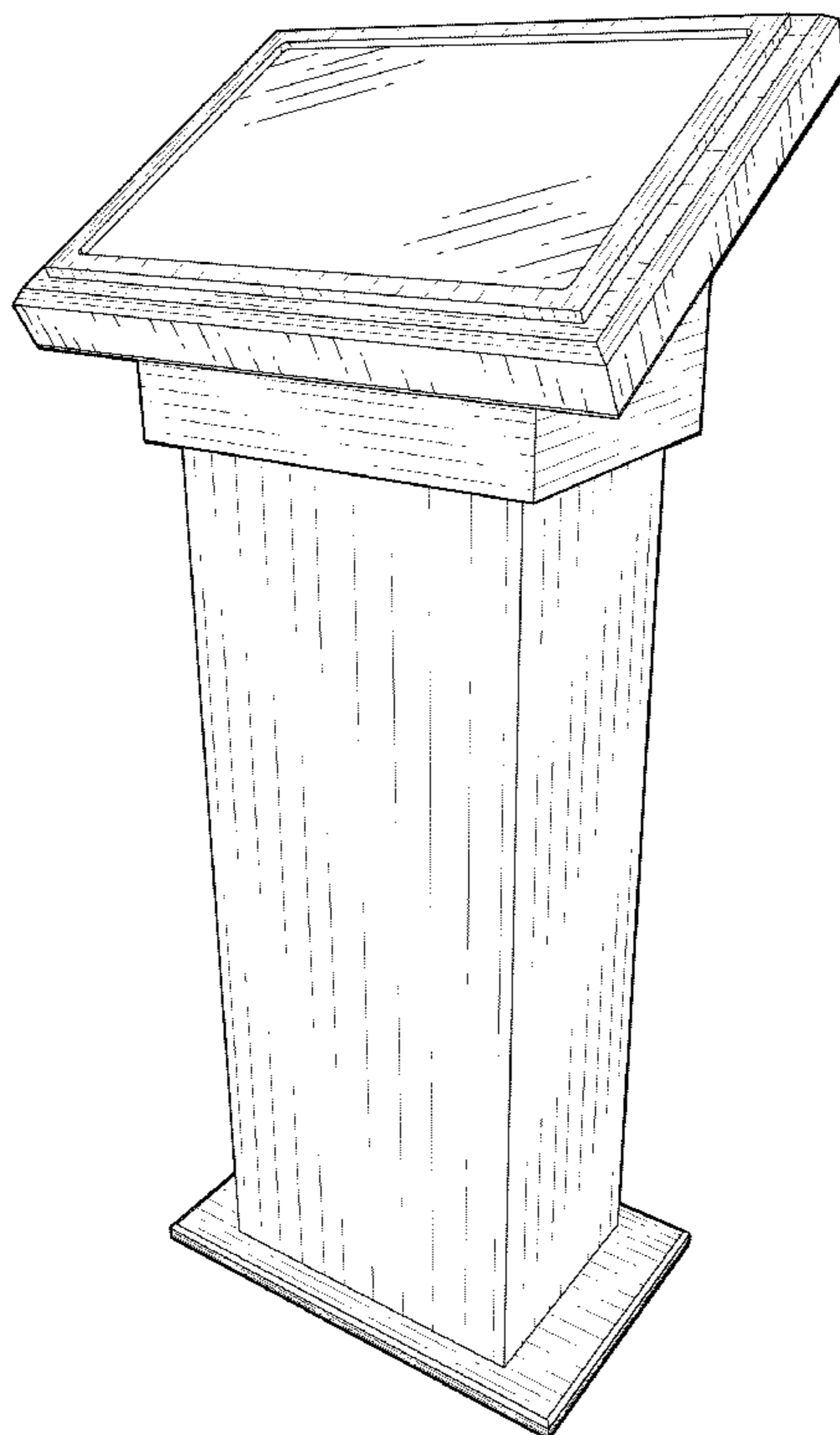

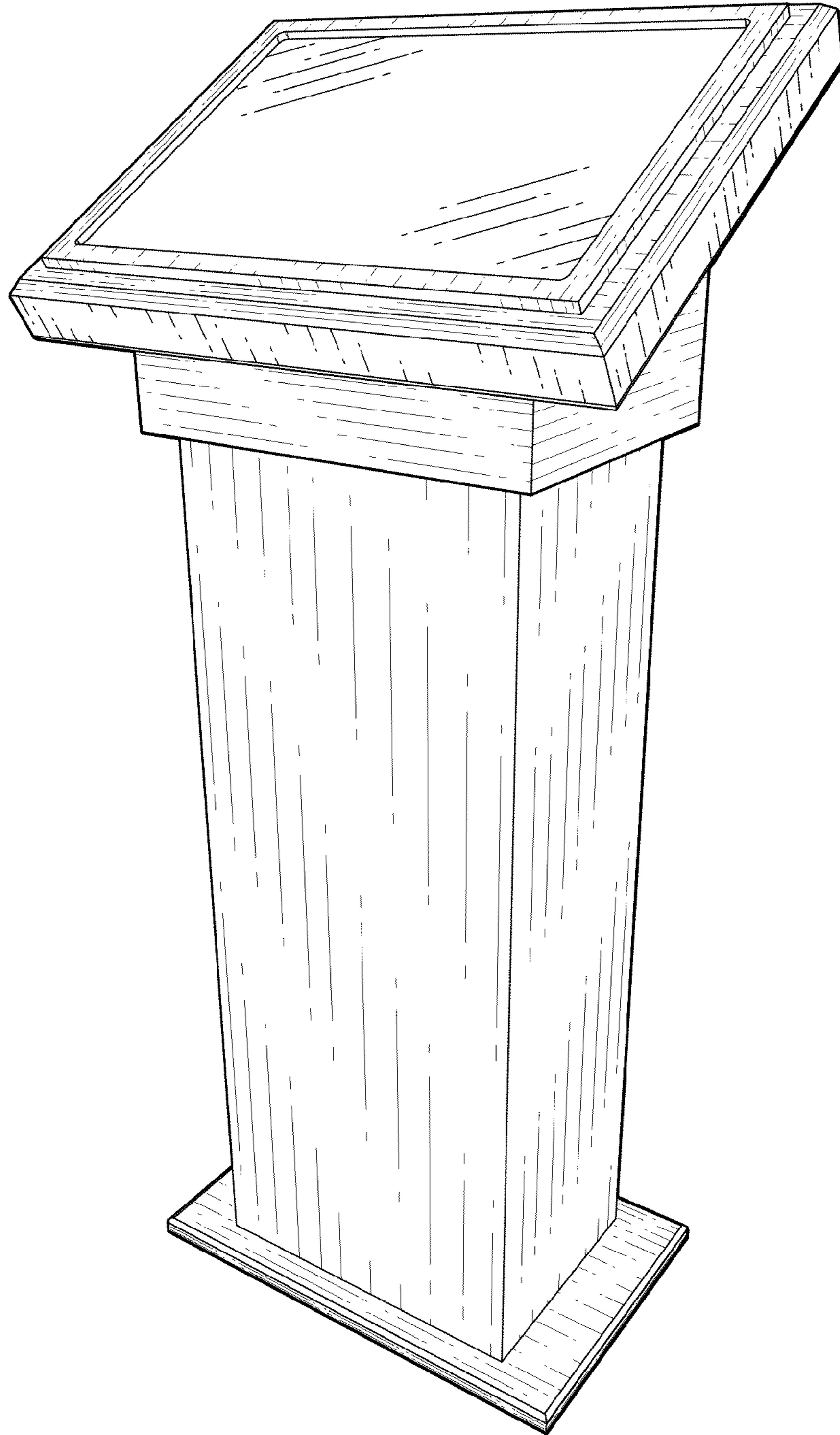
The ornamental design for a digital guestbook registry, as shown and described.

**DESCRIPTION**

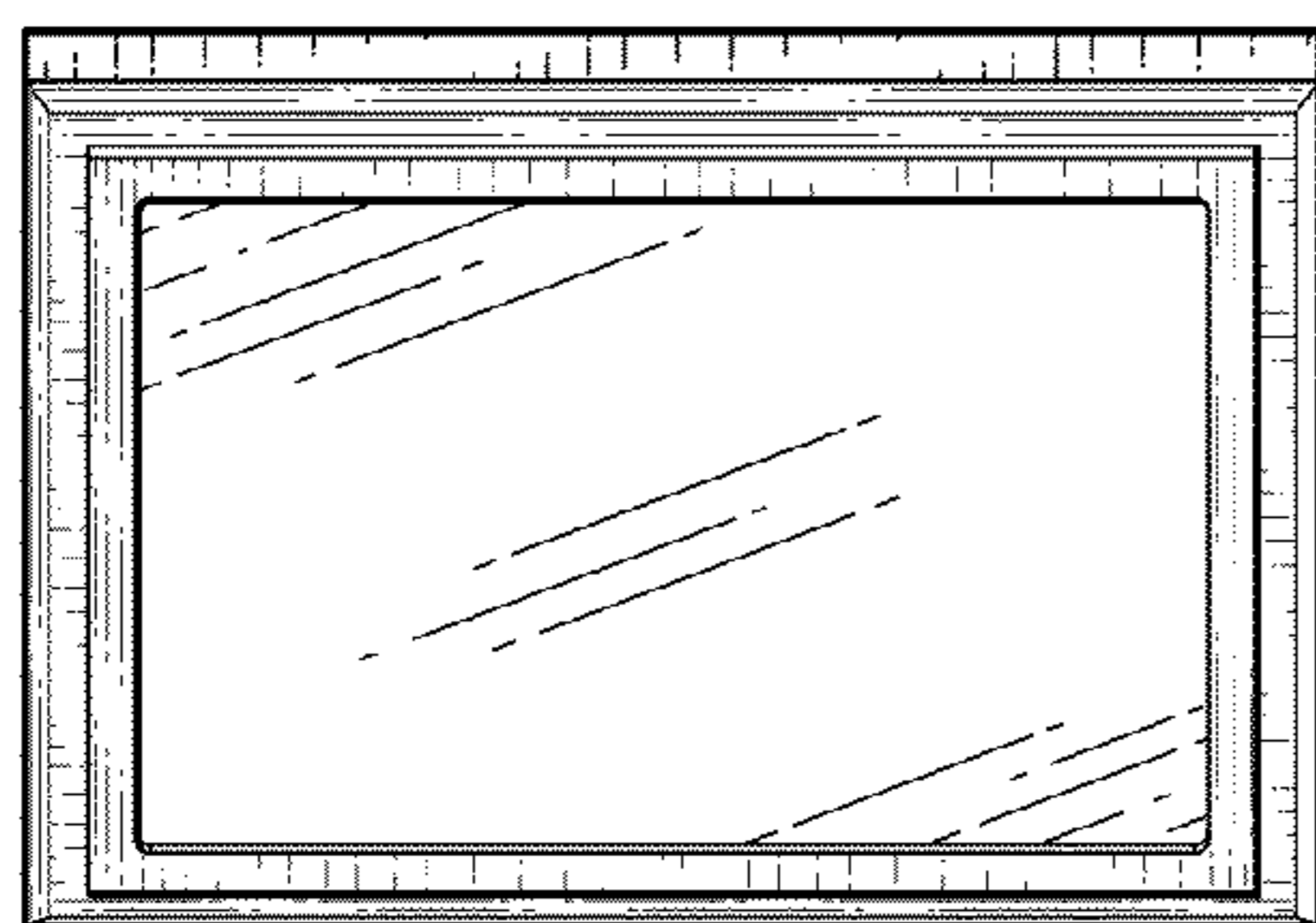
FIG. 1 is a top, right-side perspective view of the digital guestbook registry of the present invention.

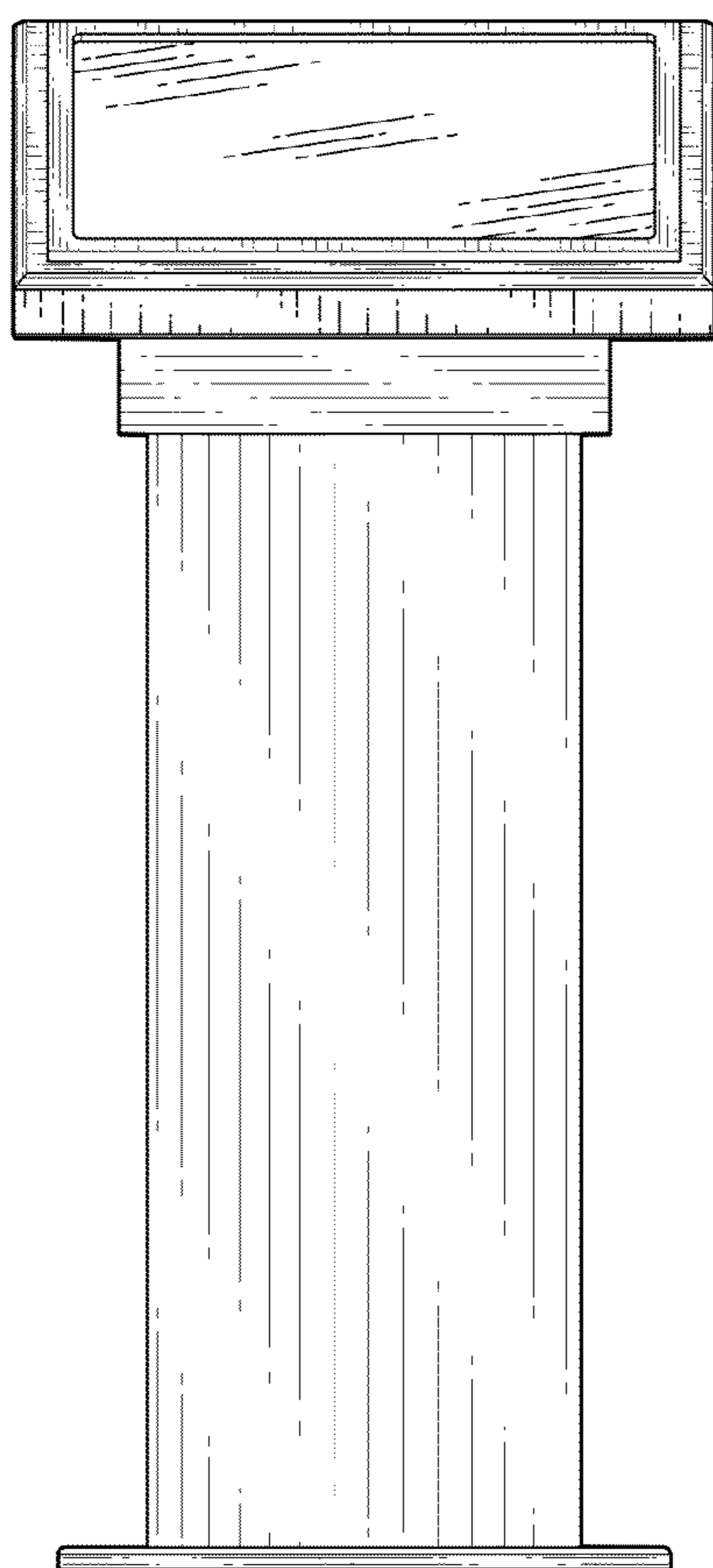




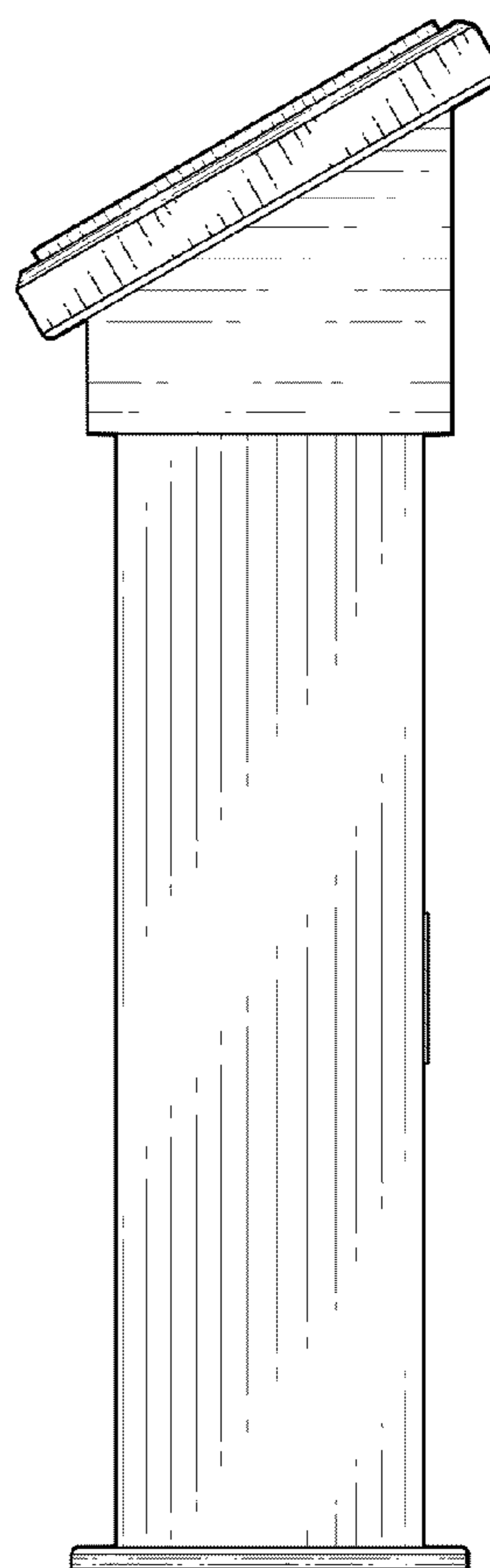

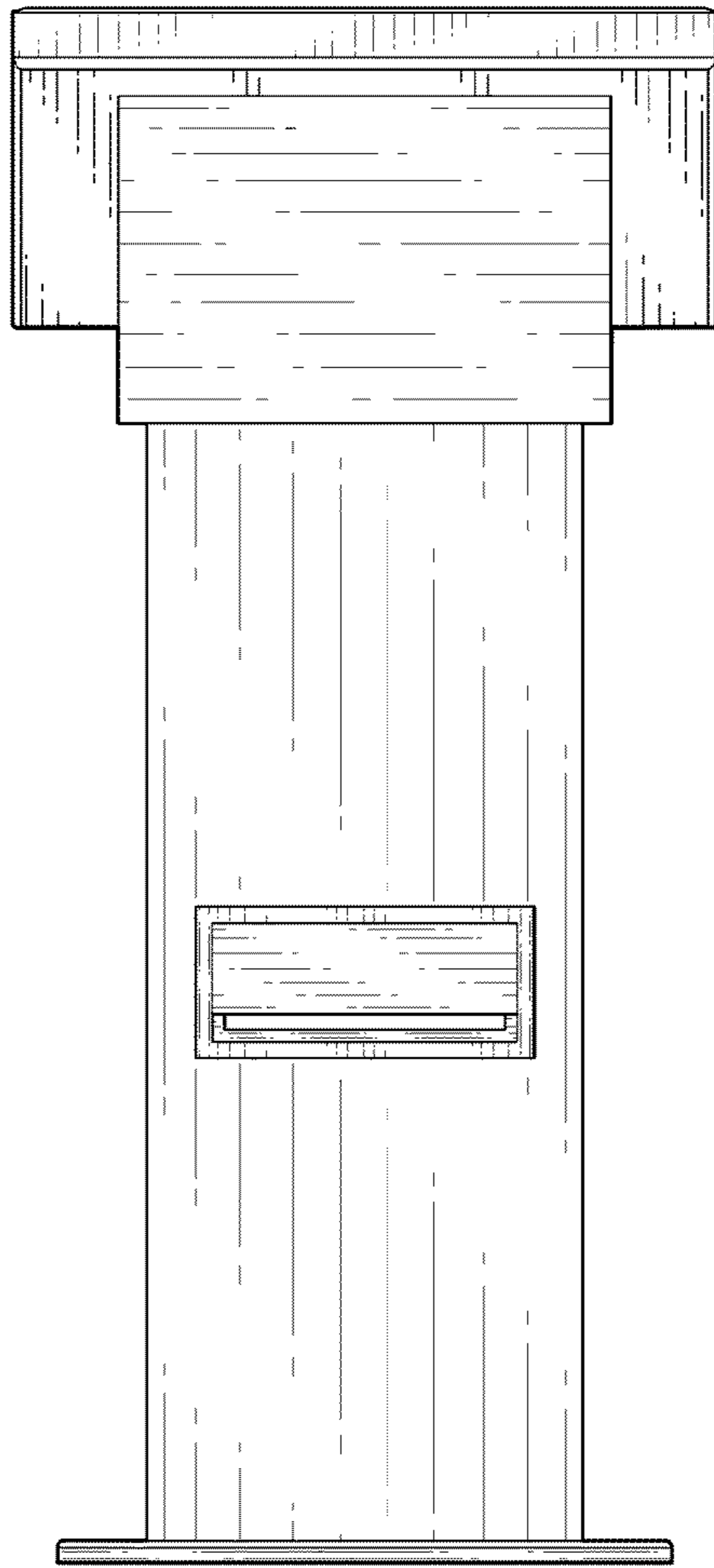

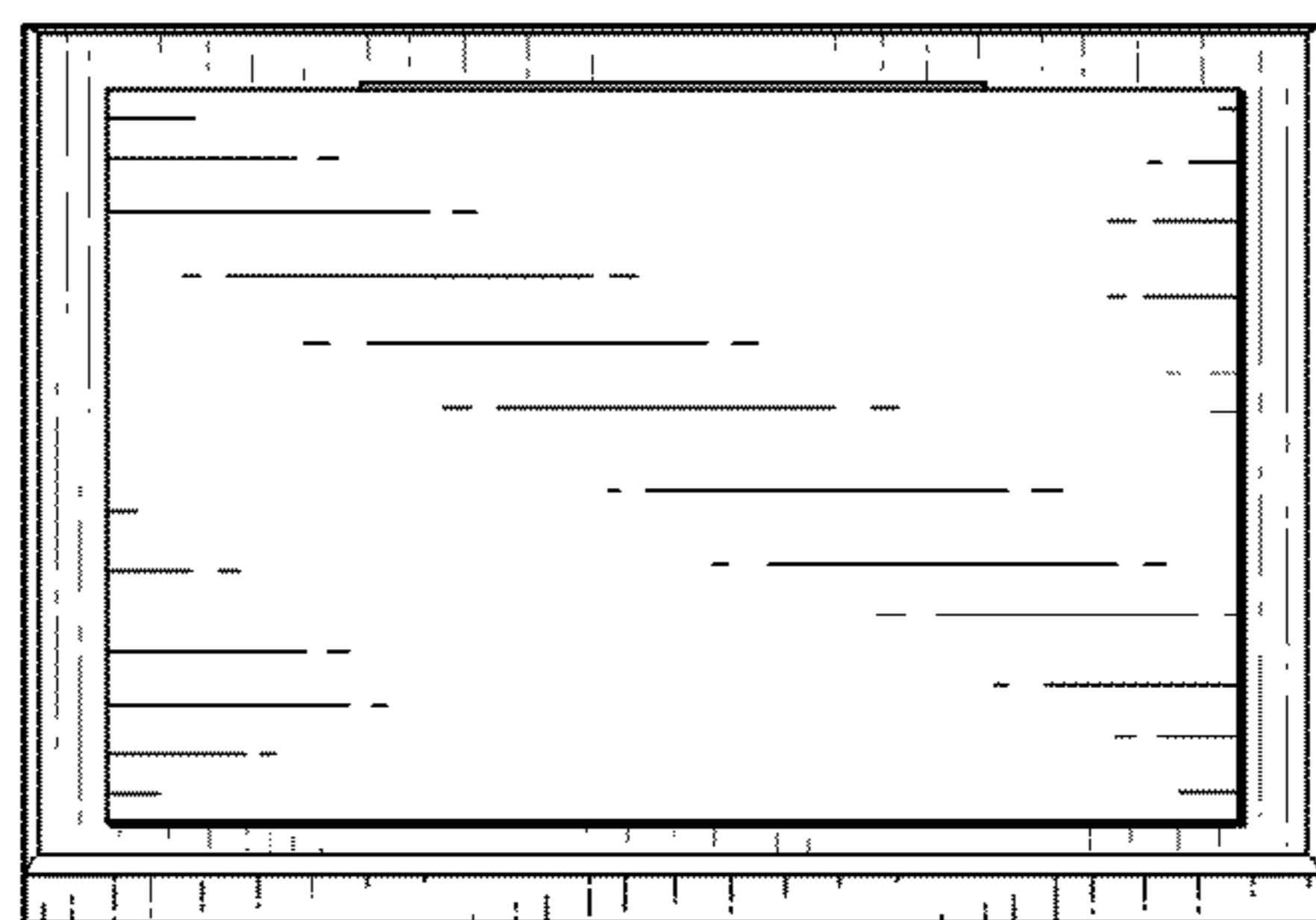
