(57) **CLAIM**
We claim the ornamental design for a mitt for making a snowball, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a mitt for making a snowball, according to the design;
FIG. 2 is a rear elevation view of the mitt;
FIG. 3 is a side elevation view of the mitt;
FIG. 4 is an opposite side elevation view of the mitt;
FIG. 5 is a top plan view of the mitt; and,
FIG. 6 is a bottom plan view of the mitt.
The portions of the mitt shown in phantom form no part of the claimed design.

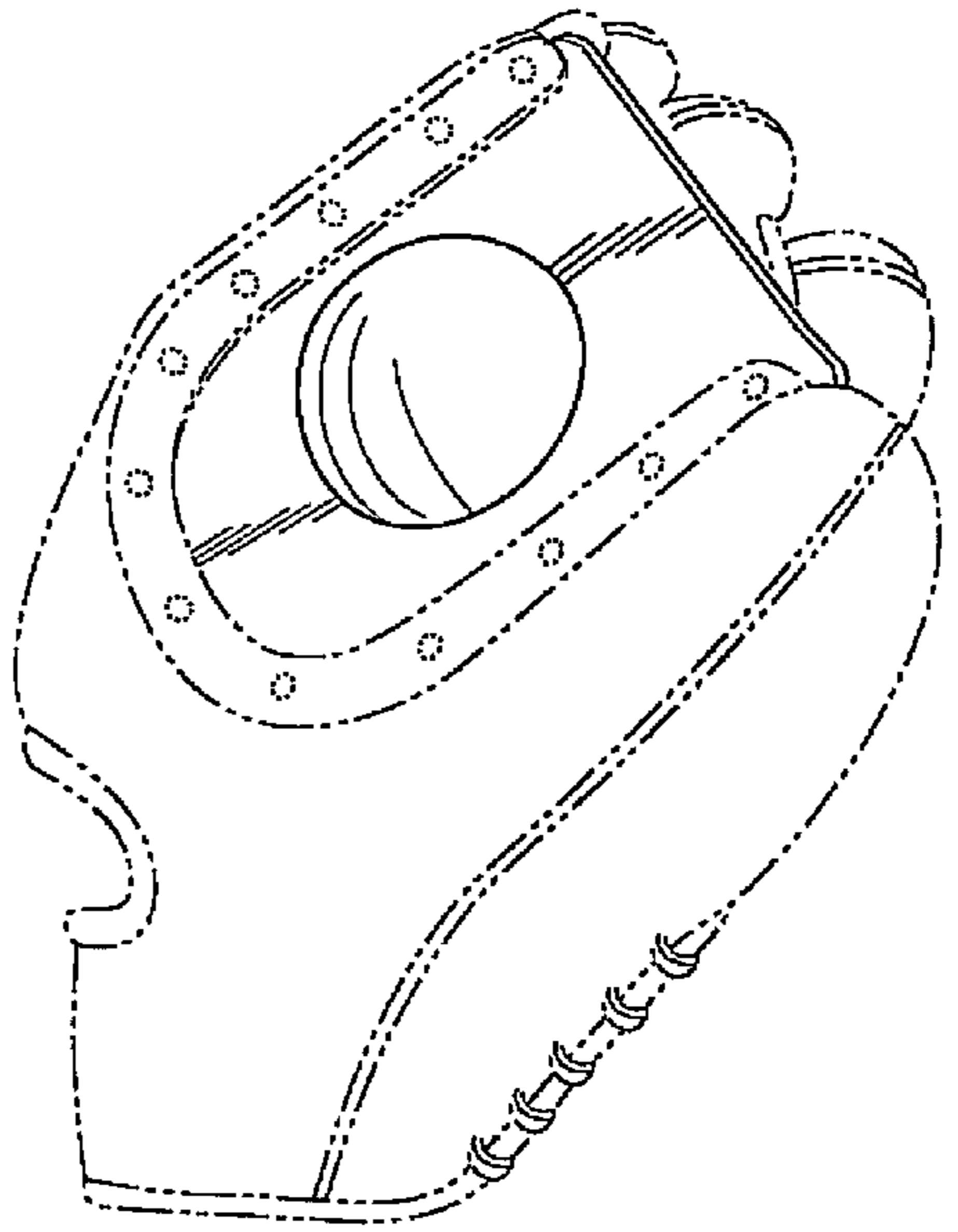
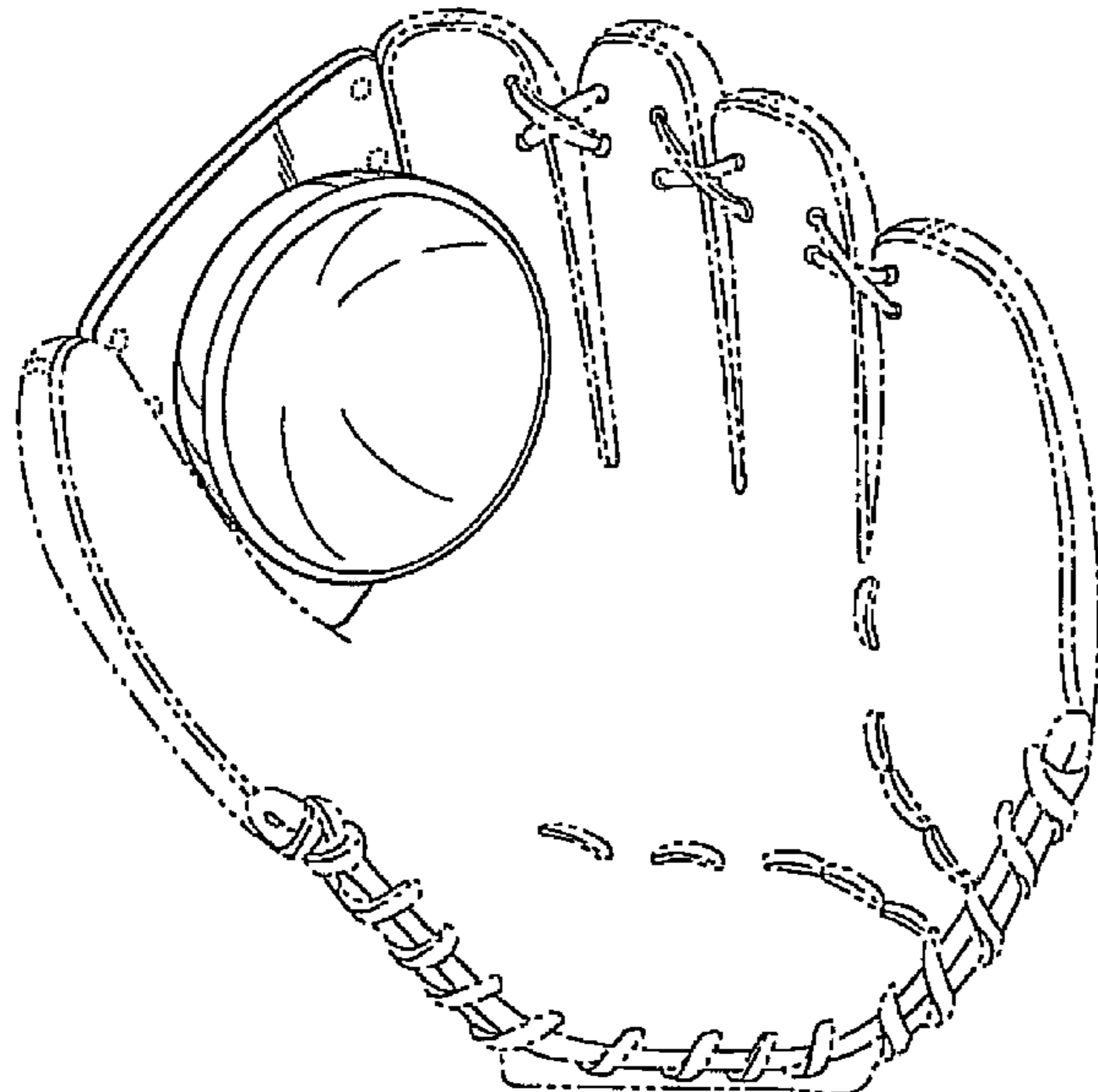

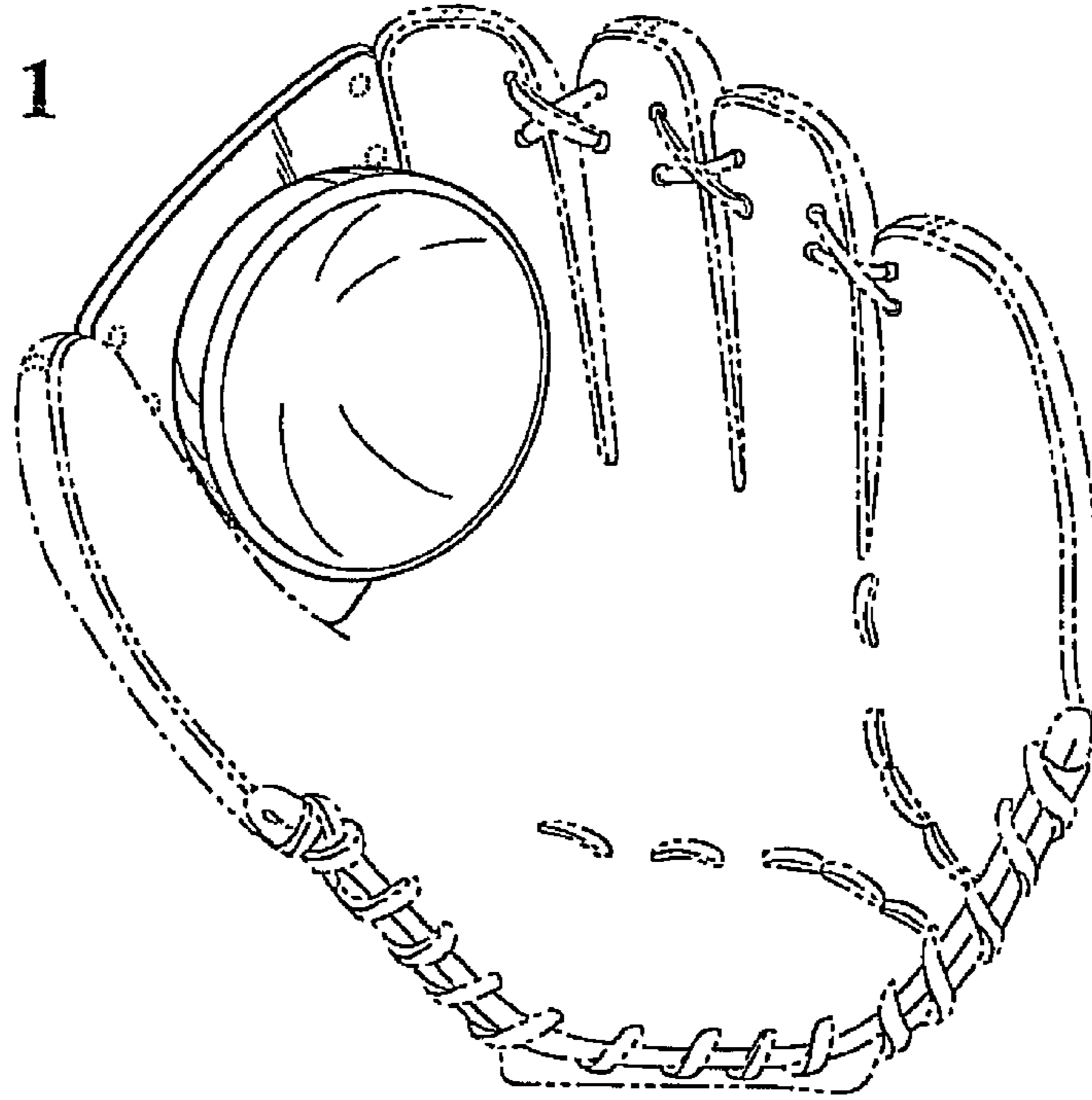

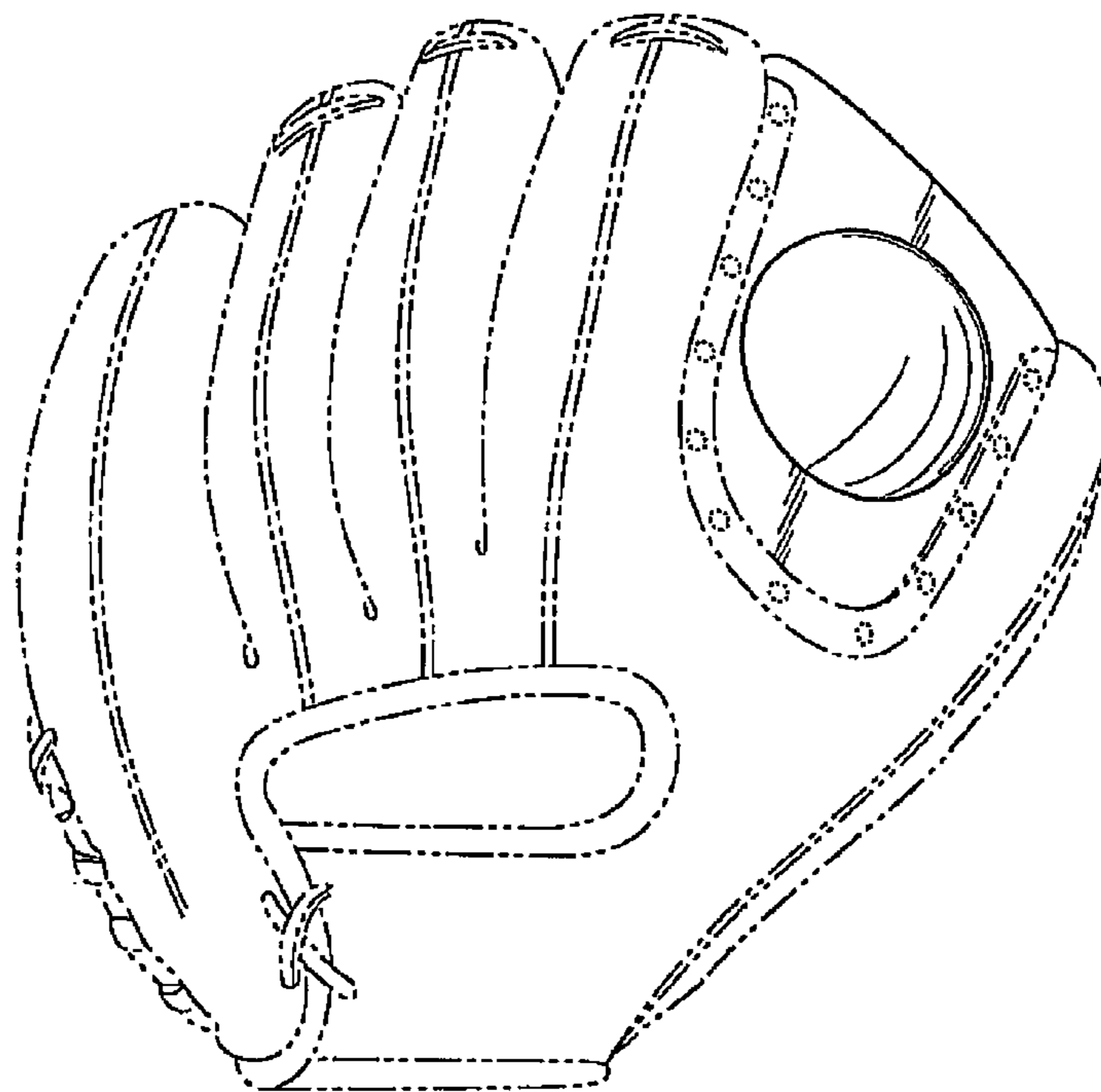

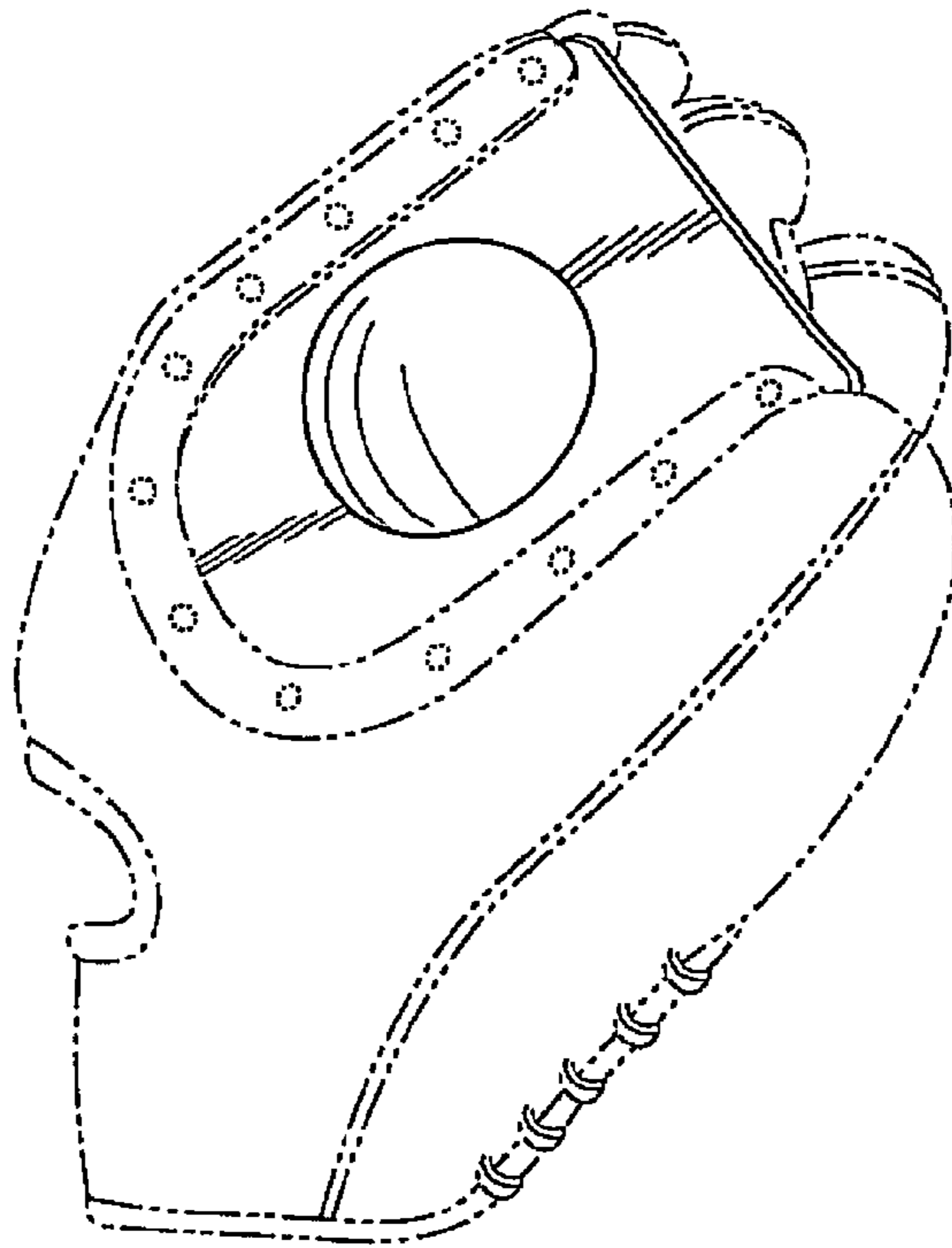
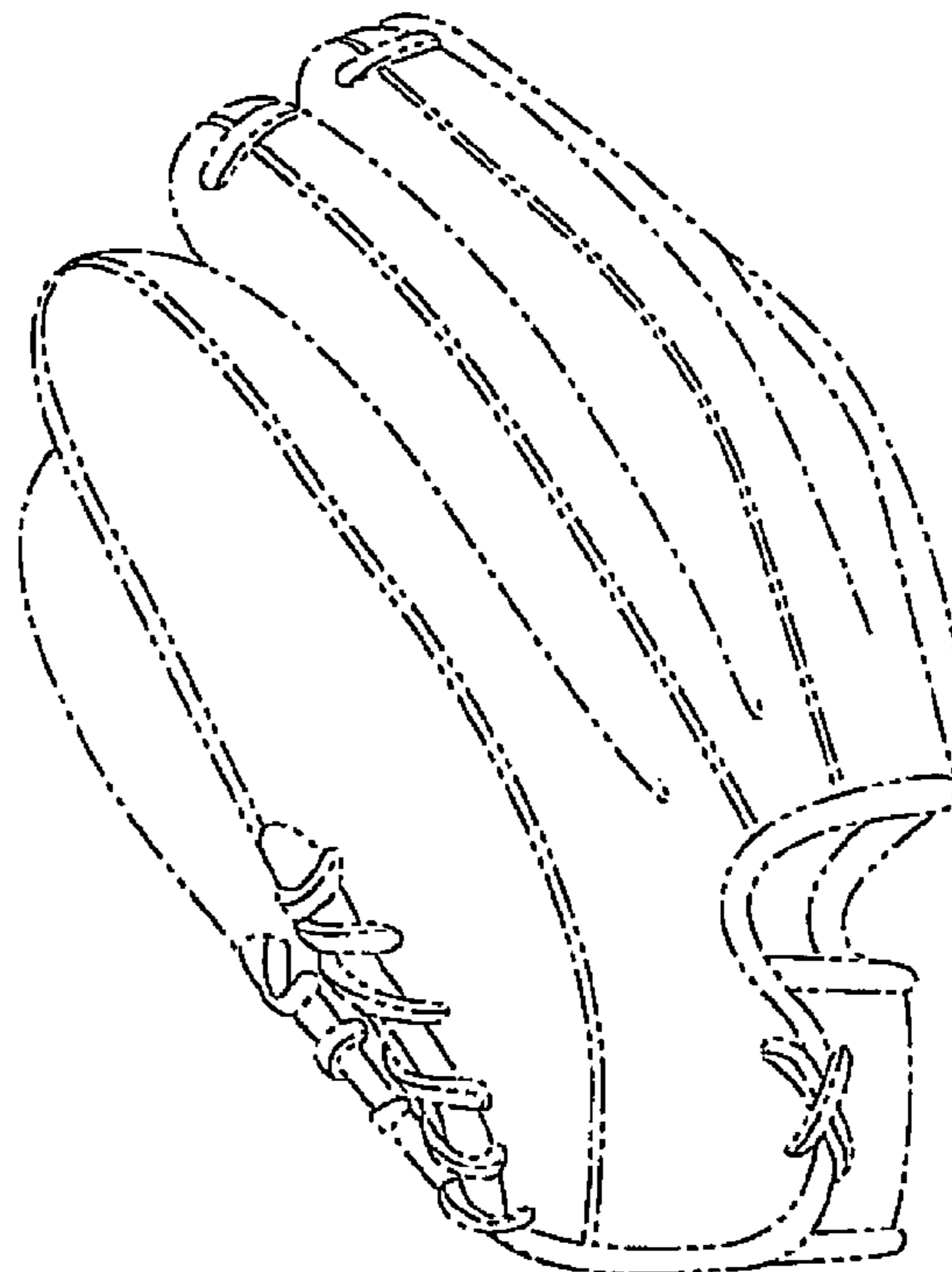

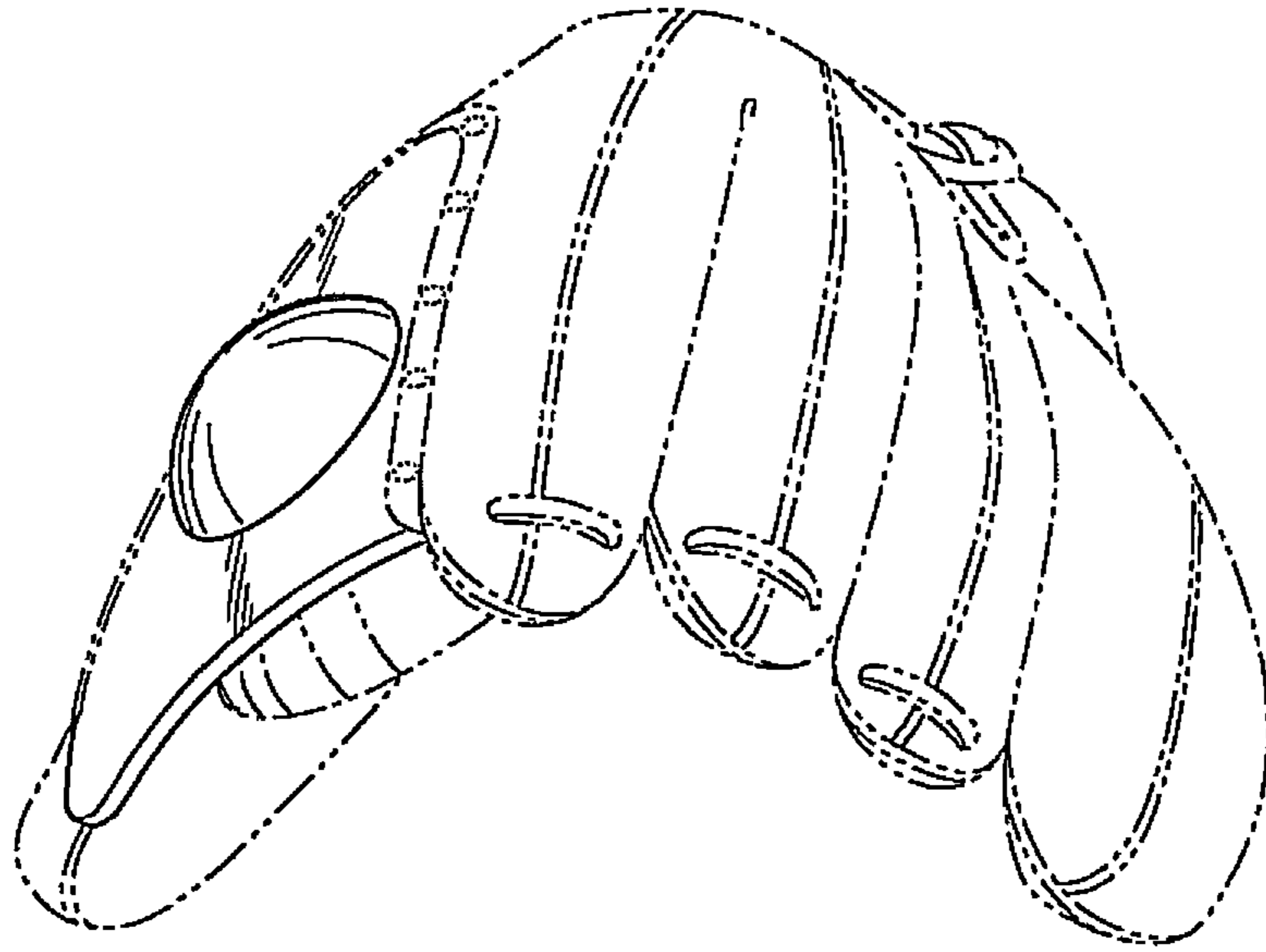

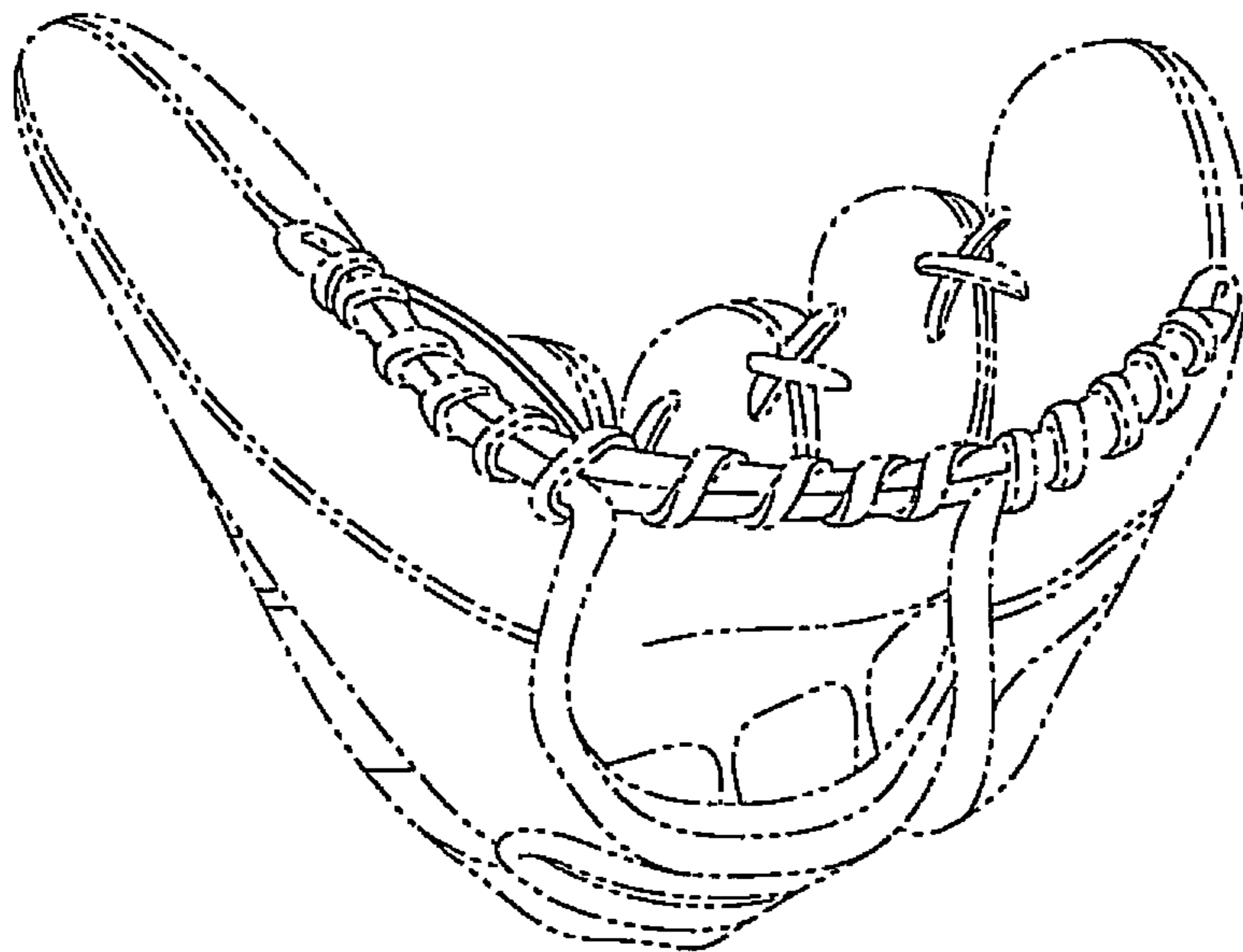
