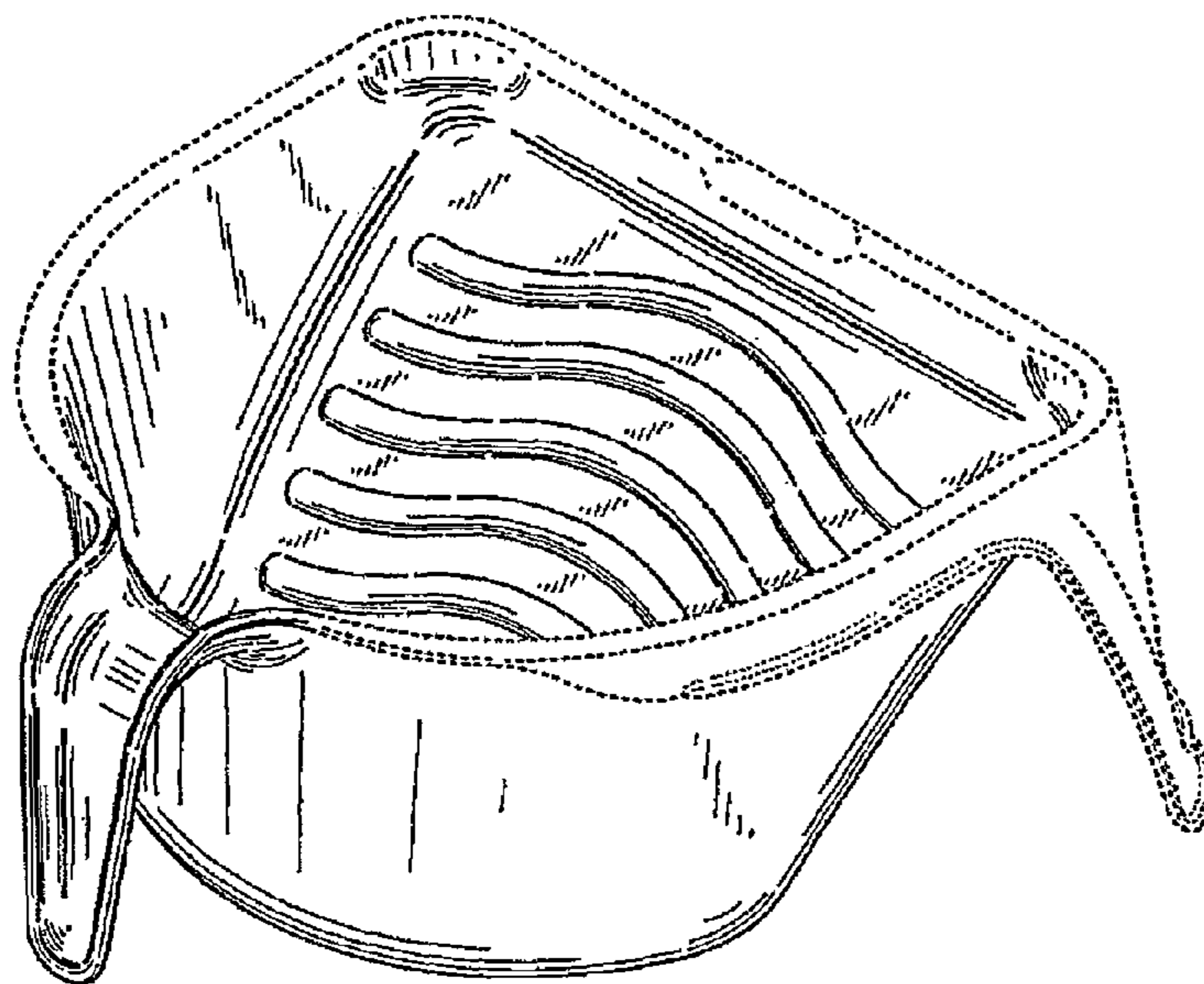
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a paint application container
showing our design;
FIG. 2 is an end view thereof, as taken from the right end of
FIG. 1;
FIG. 3 is an end view thereof, as taken from the left end of
FIG. 1;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof (the side views are mirror
images of one another);
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

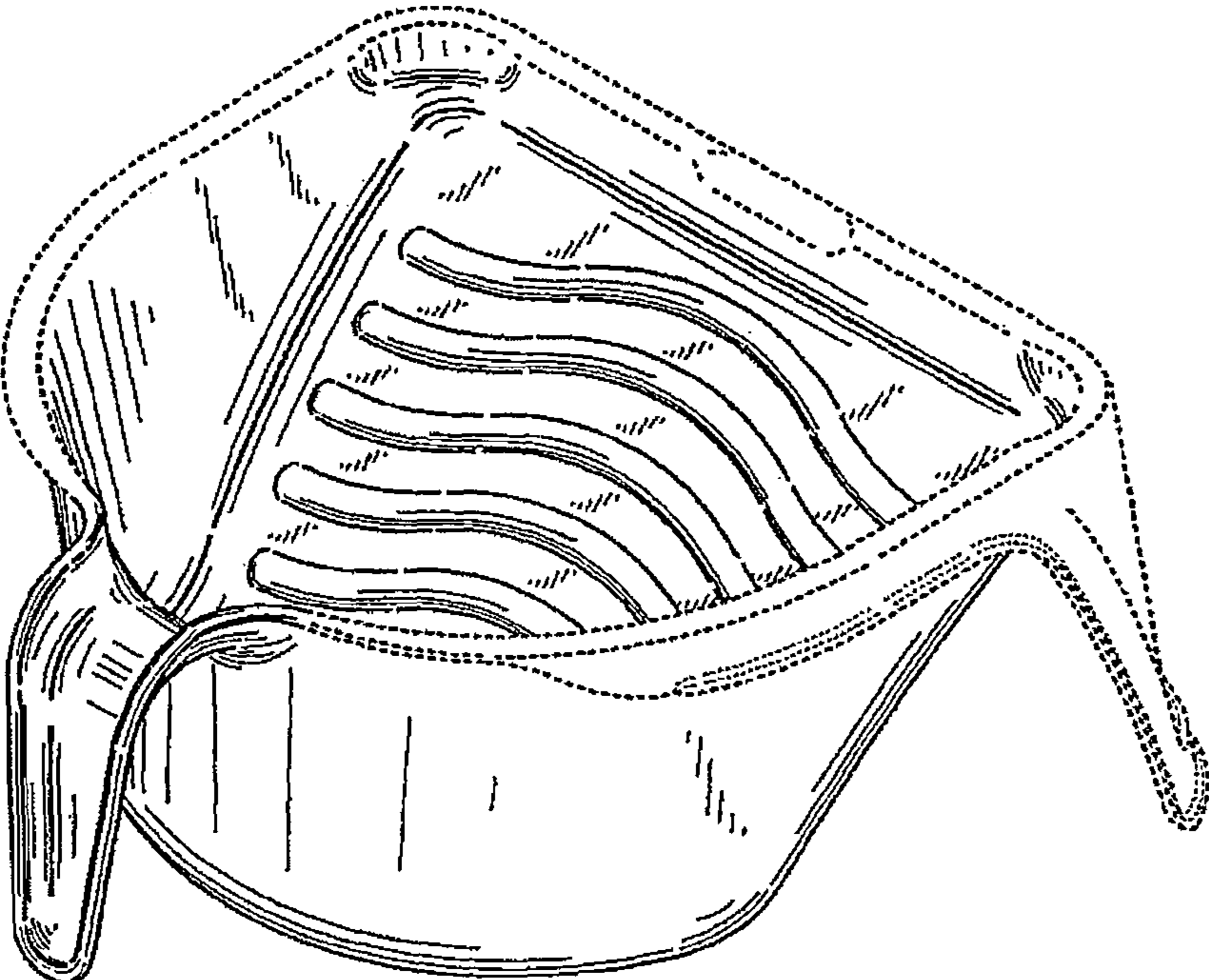

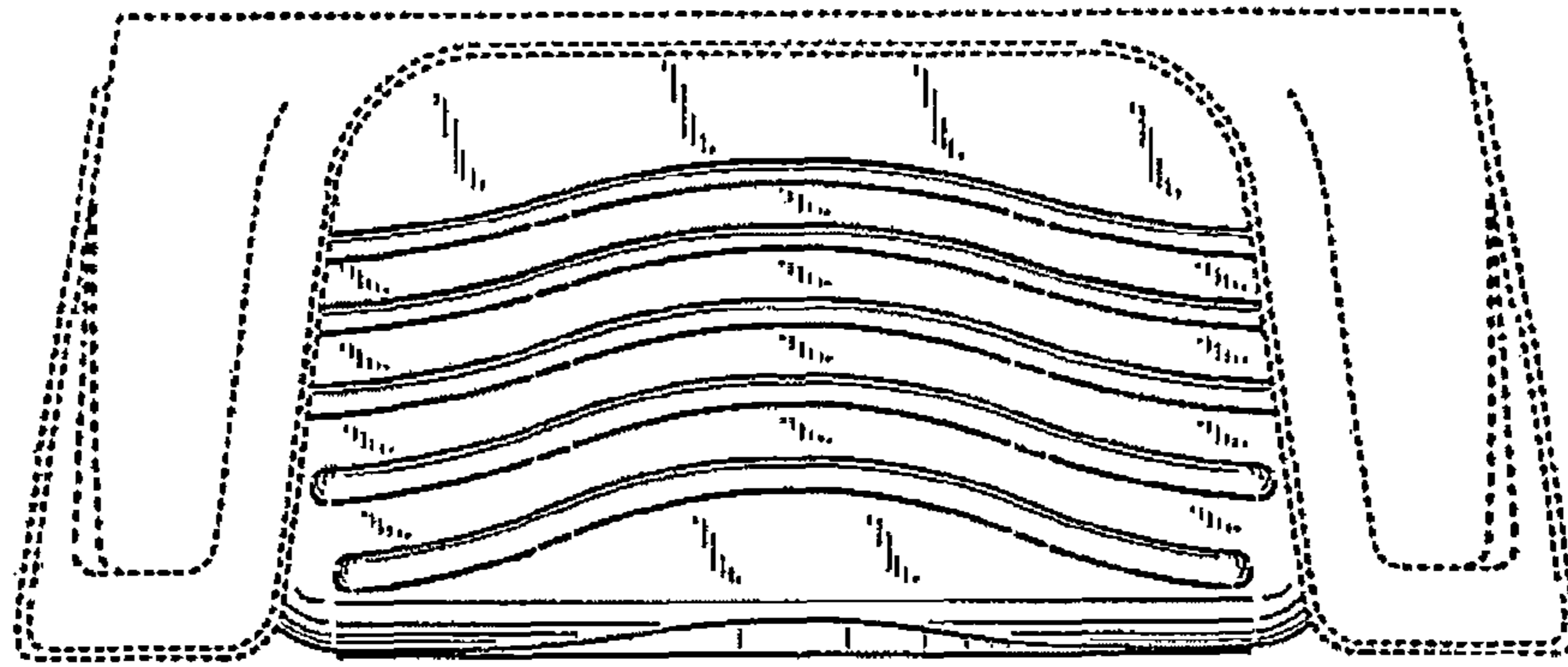

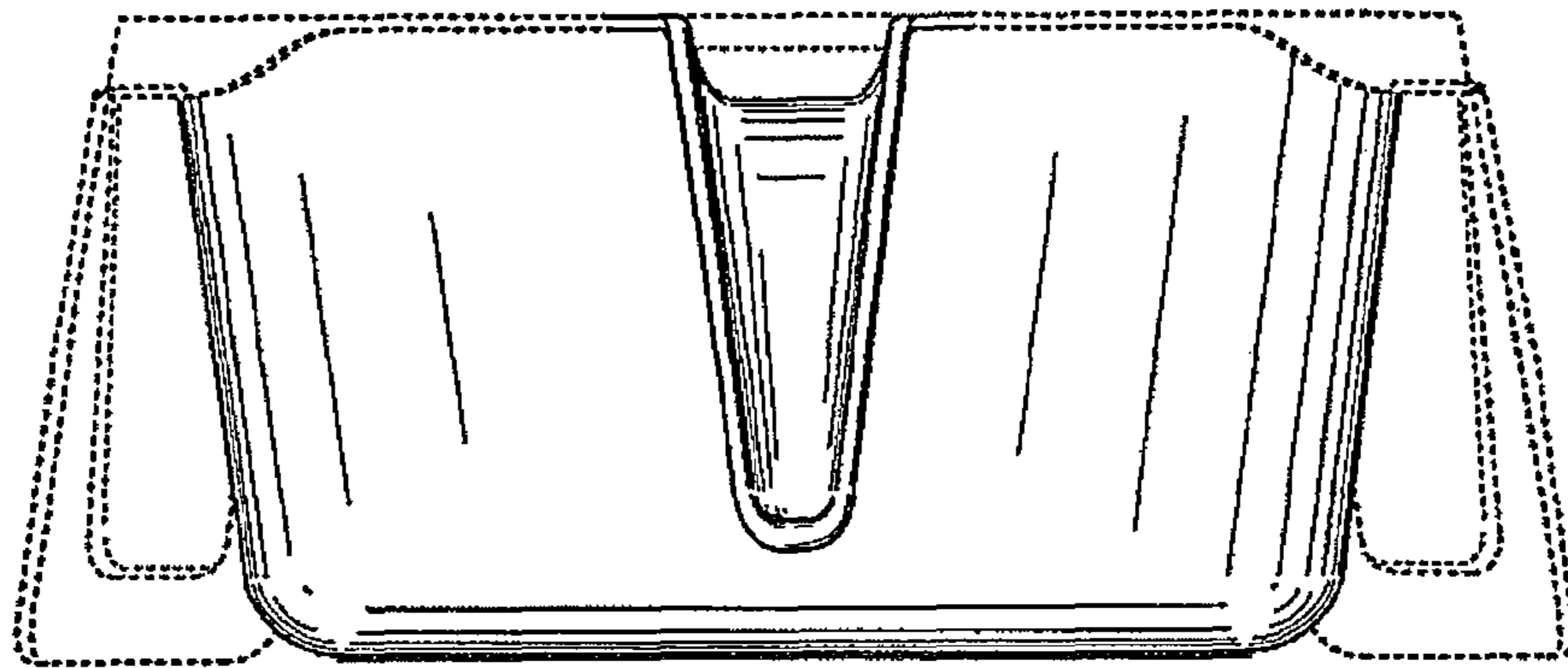

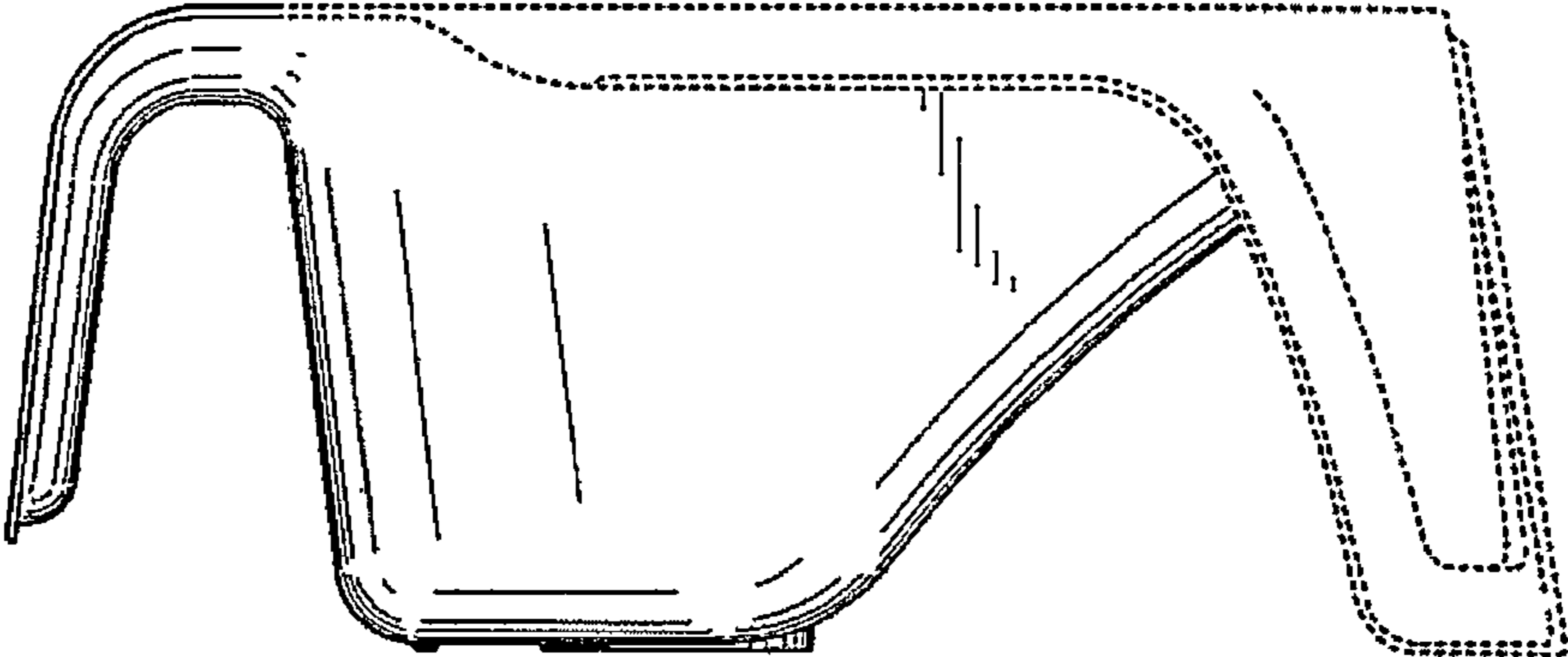

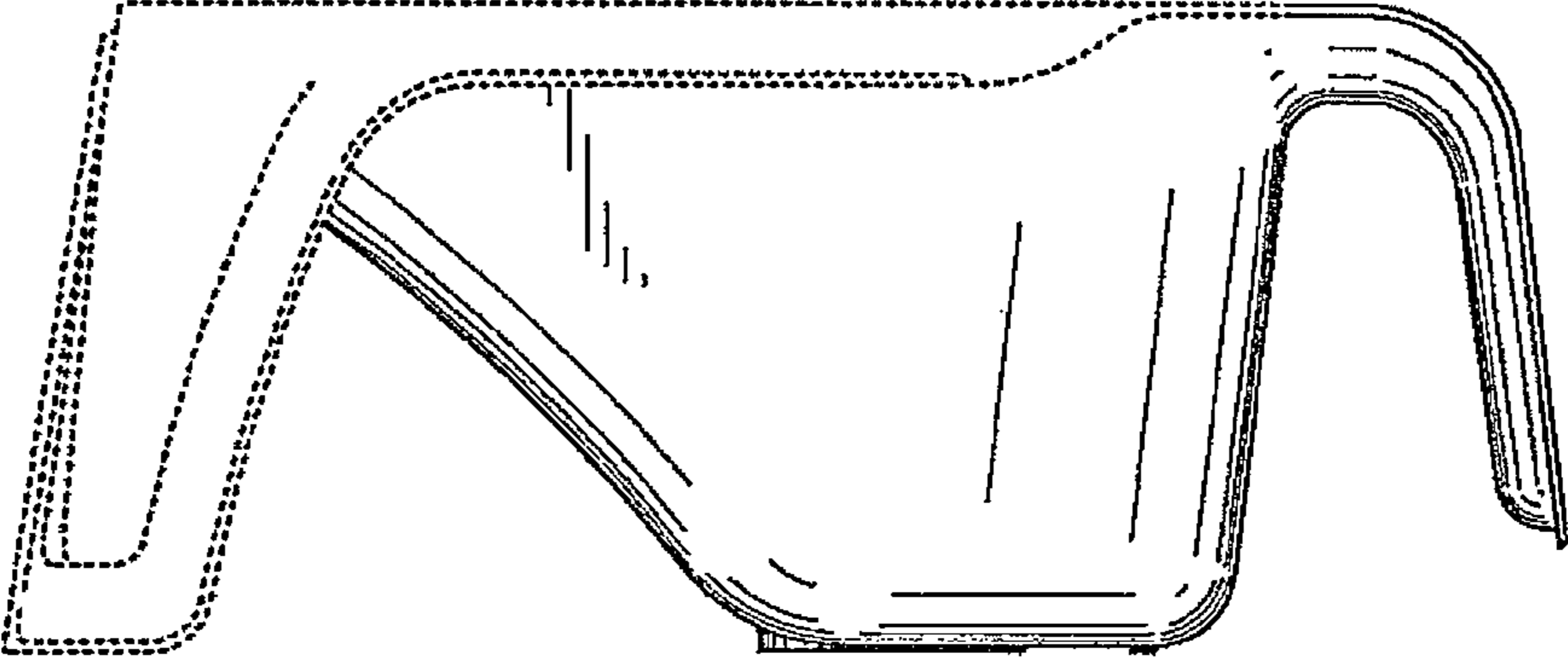

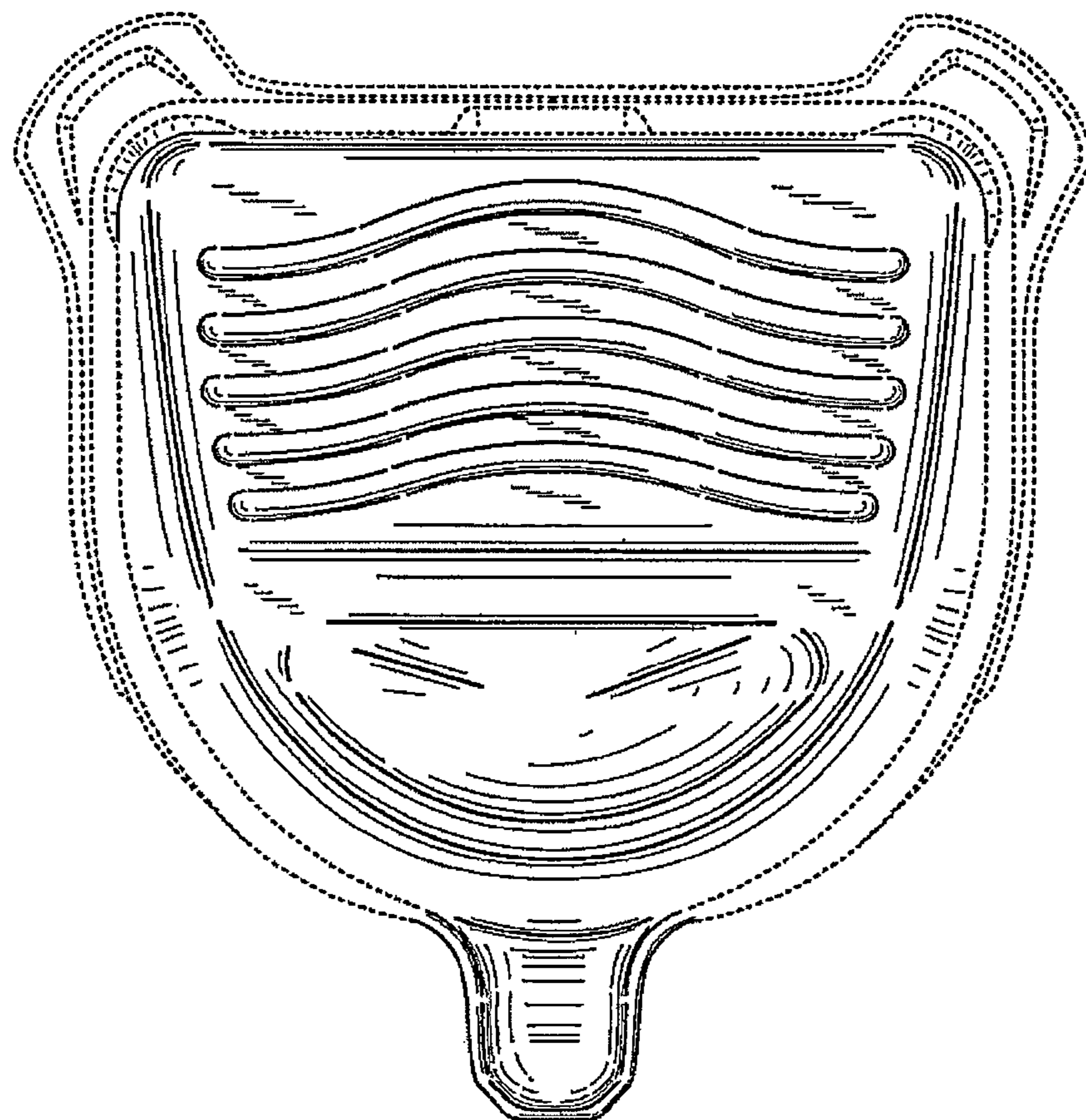

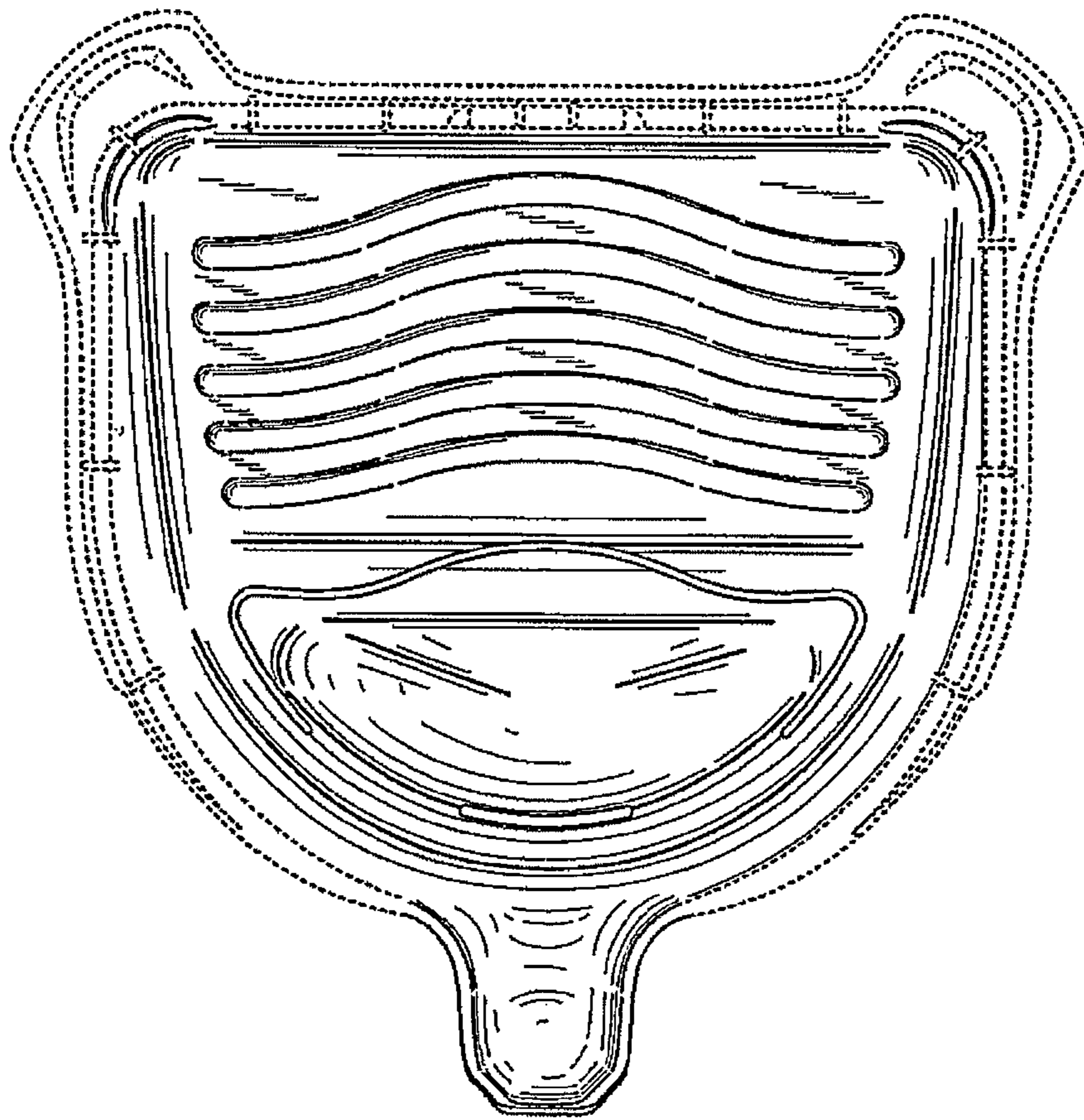
