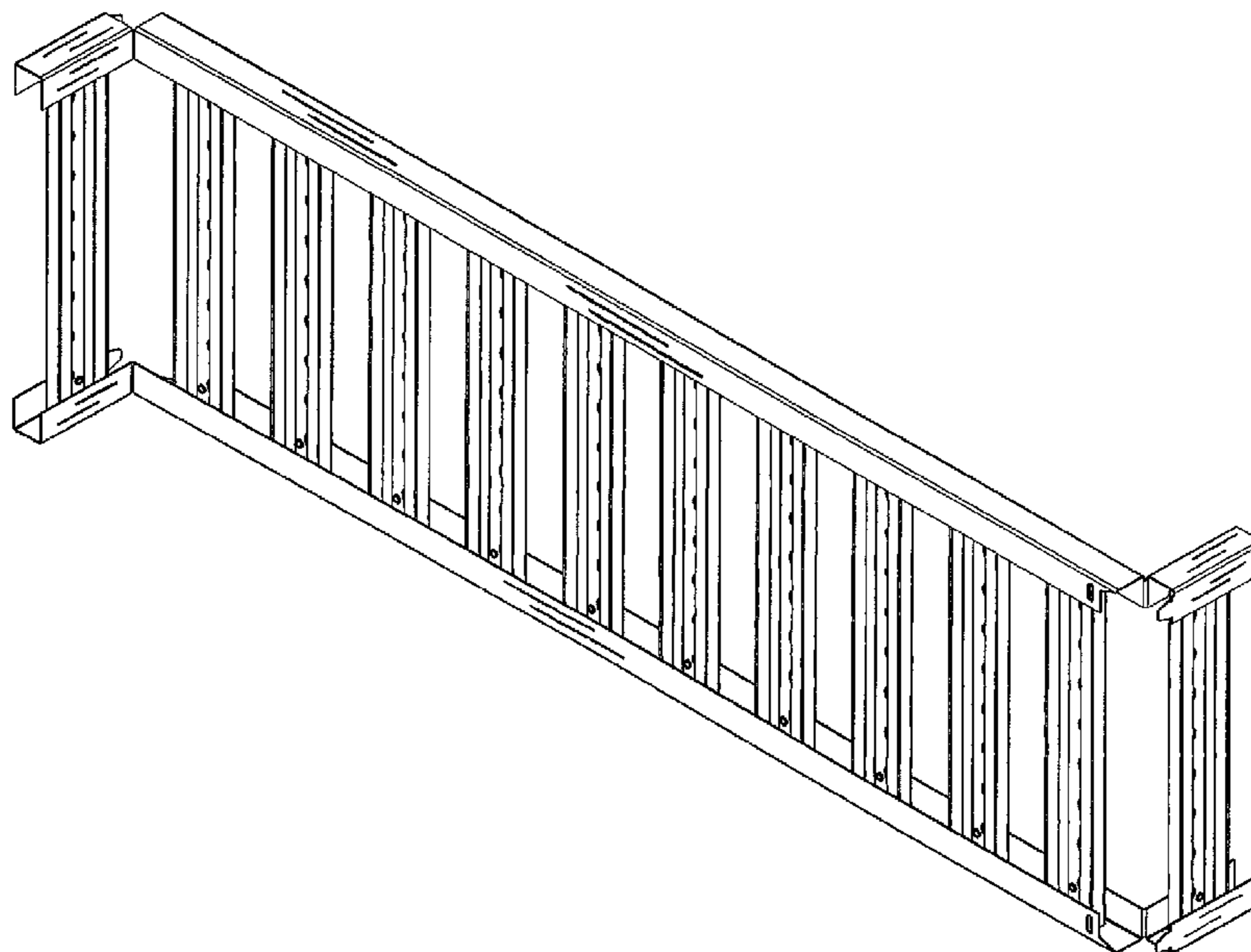
(57) **CLAIM**

The ornamental design for a grain bin floor support member, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view illustrating a front side, a right side and a top side of the grain bin floor support member; FIG. 2 is a perspective view illustrating a rear side, a left side and a bottom side of the grain bin floor support member; FIG. 3 is a front side view of the grain bin floor support member; FIG. 4 is a rear side view of the grain bin floor support member; FIG. 5 is a top side view of the grain bin floor support member in which the opposing bottom side view is a mirror image of the top side view shown; FIG. 6 is a right side view of the grain bin floor support member; FIG. 7 is a left side view of the grain bin floor support member; FIG. 8 is a sectional view along the line 8-8 of FIG. 7; and, FIG. 9 is an enlarged portion of the sectional view according to FIG. 8.

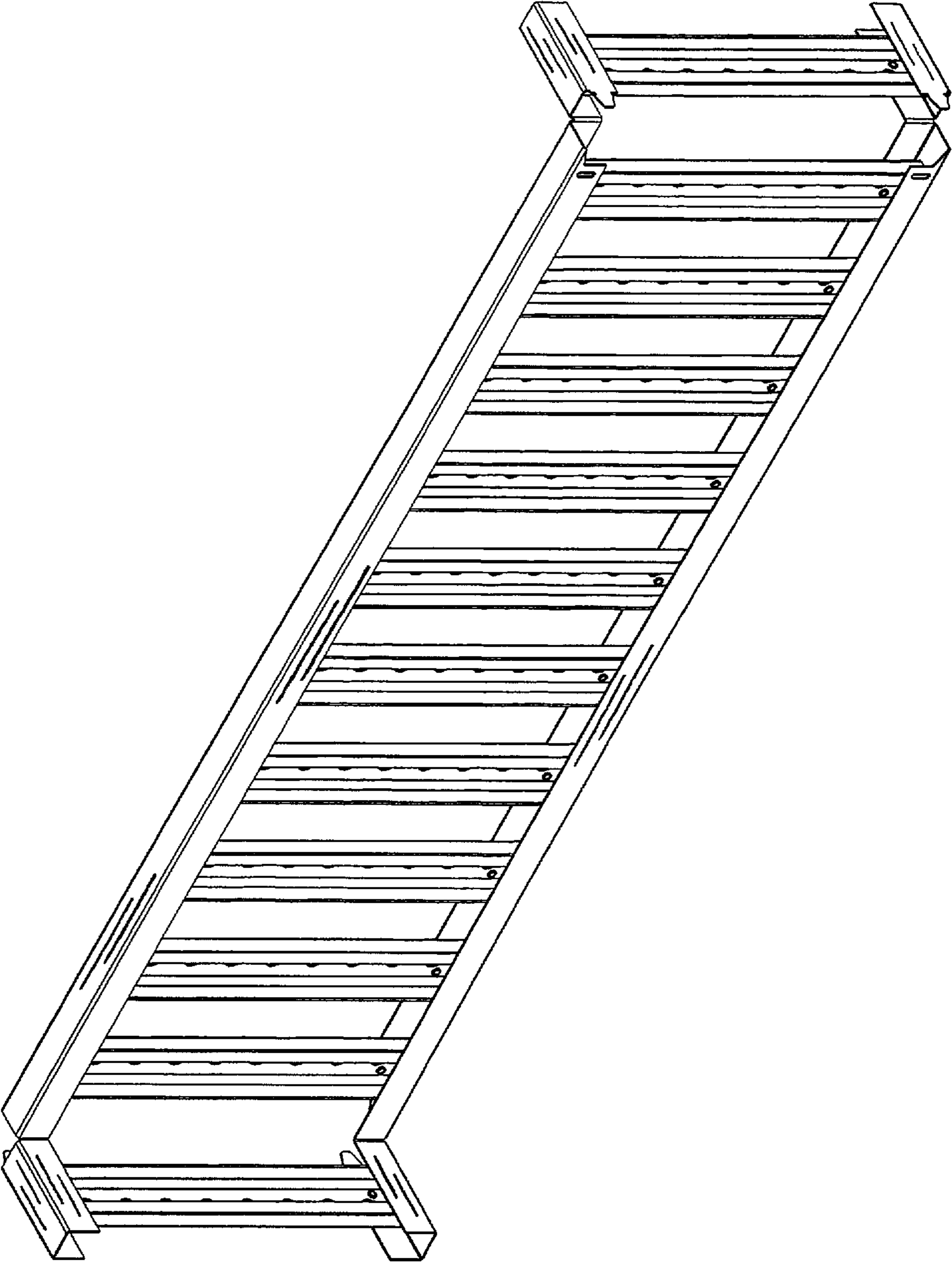

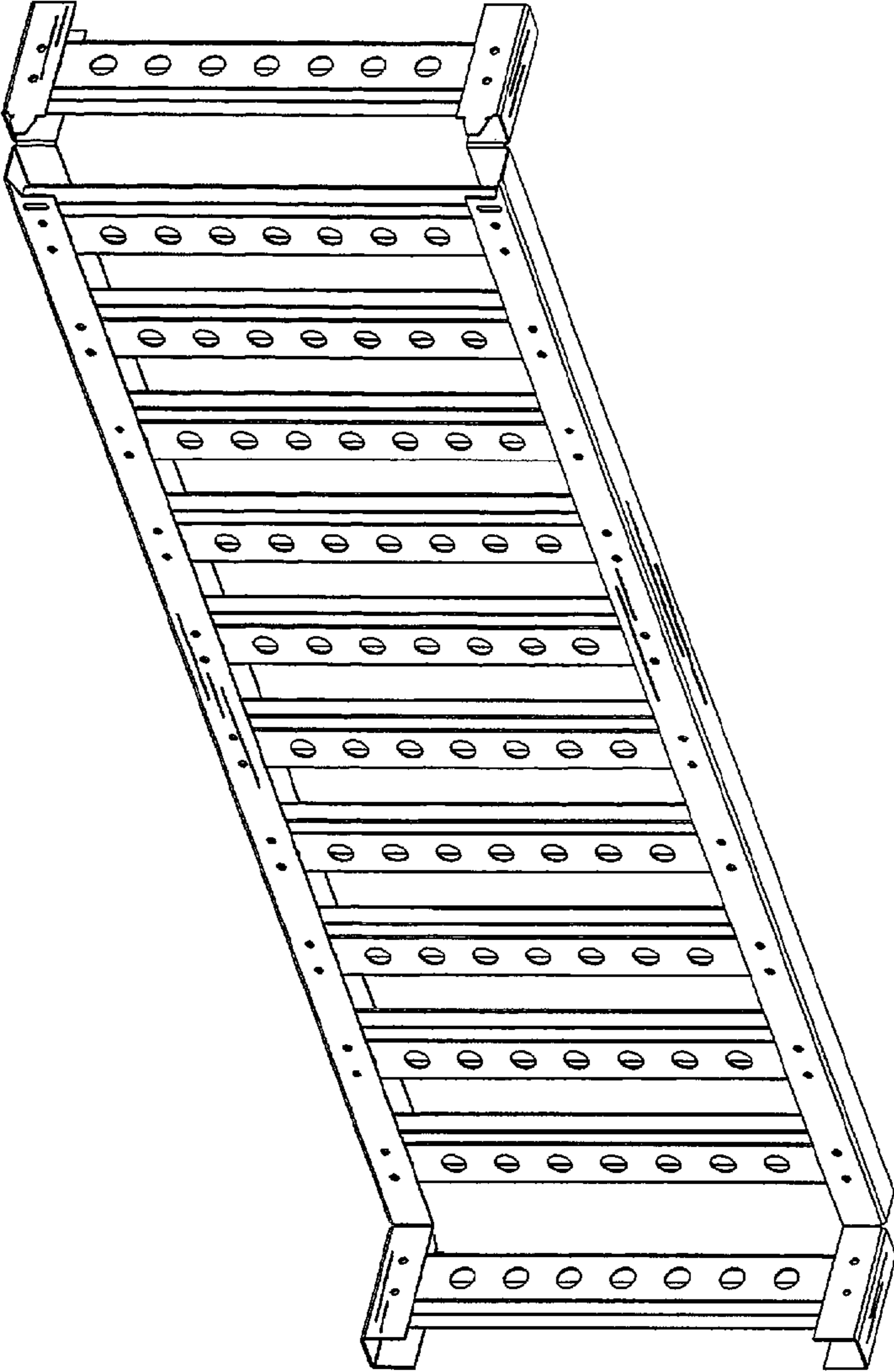

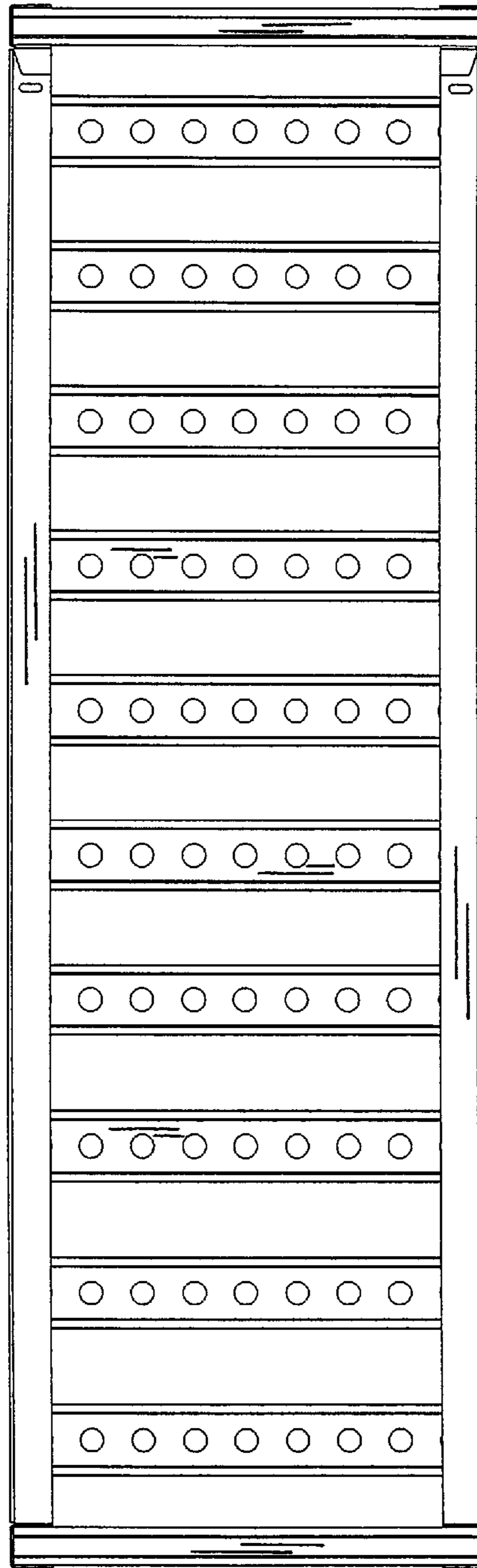

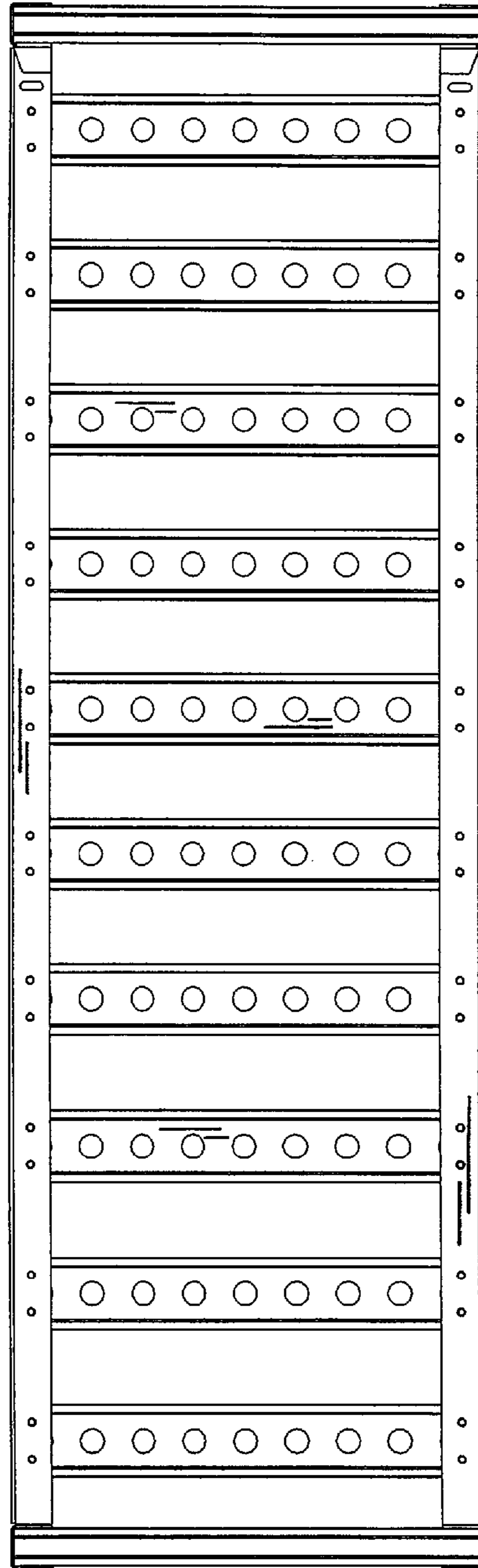

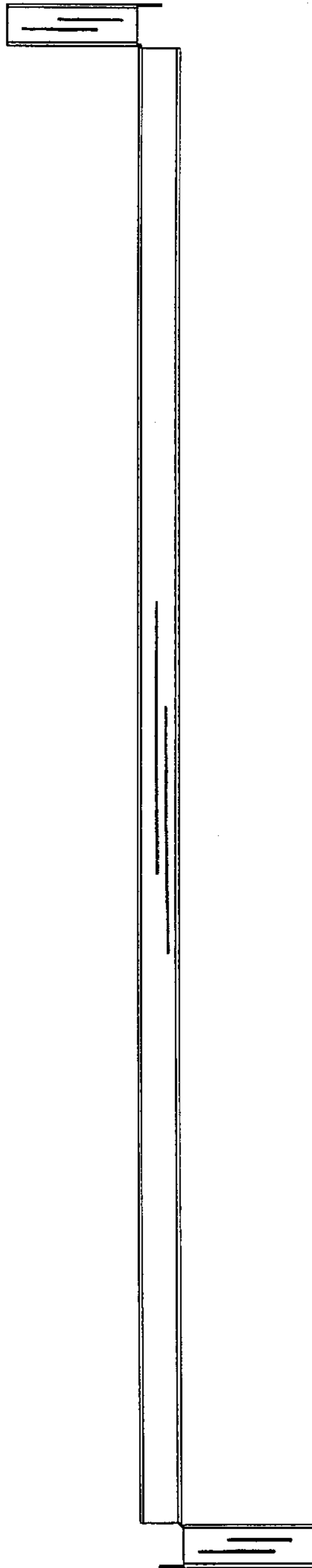

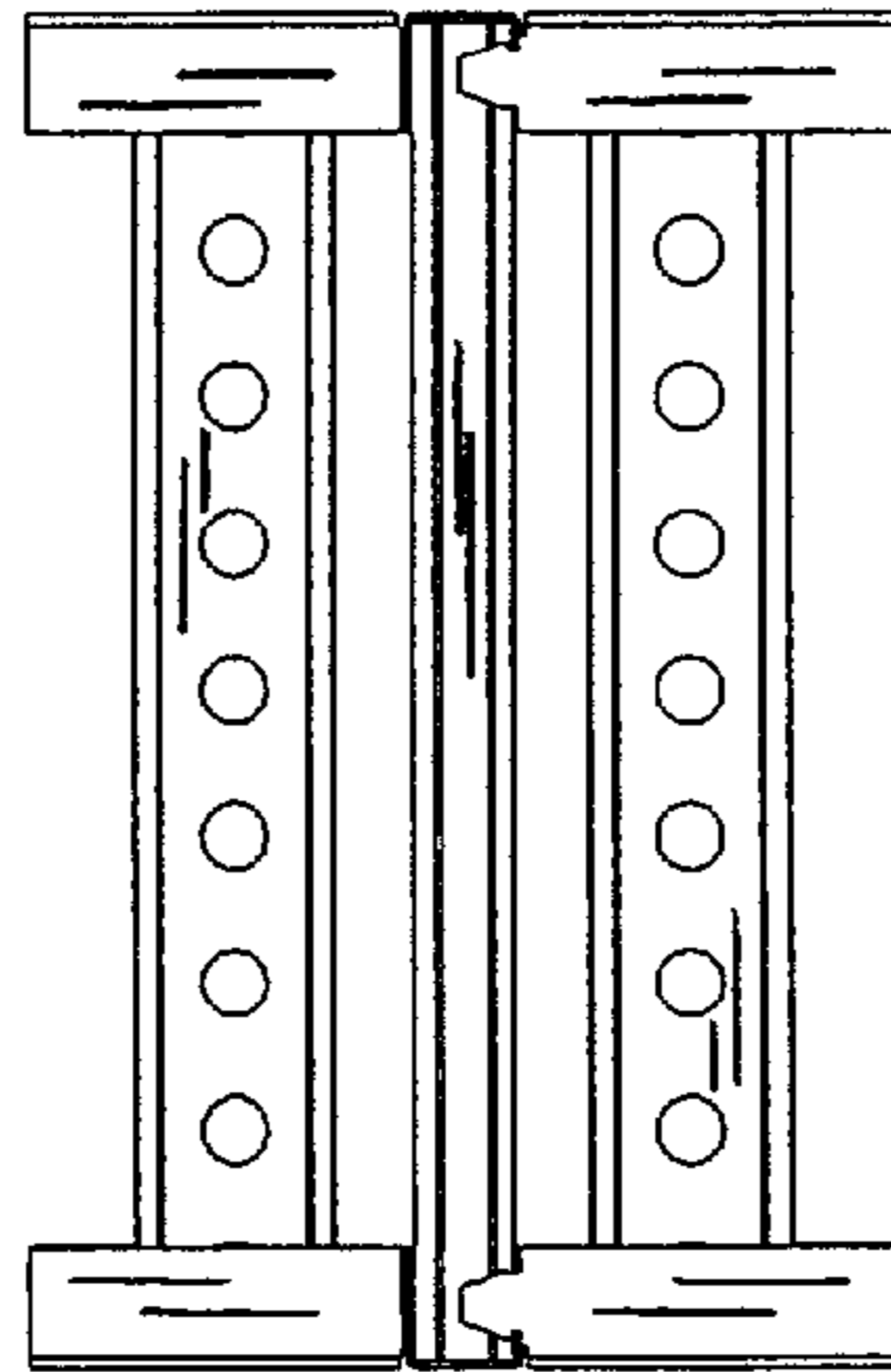

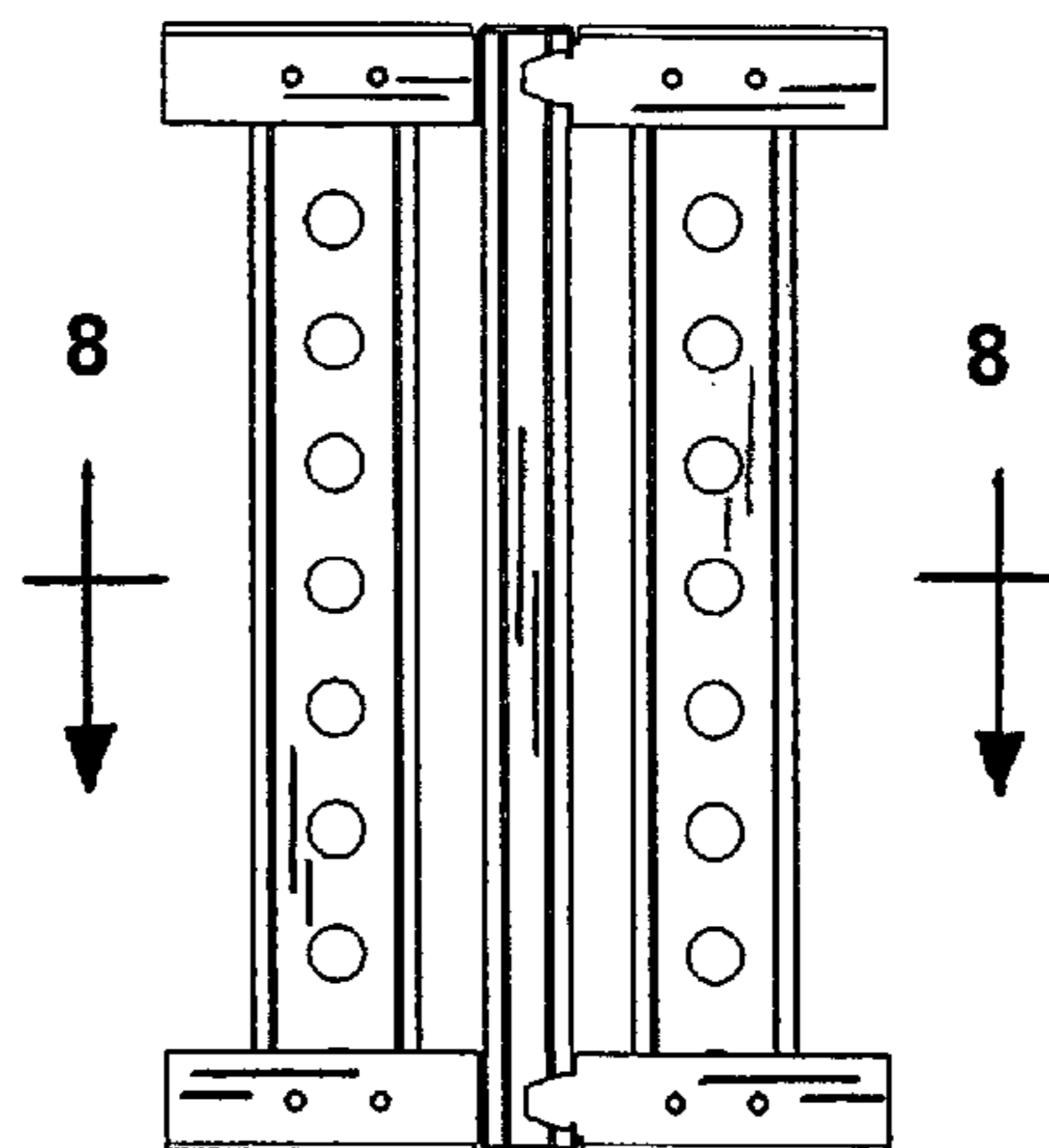

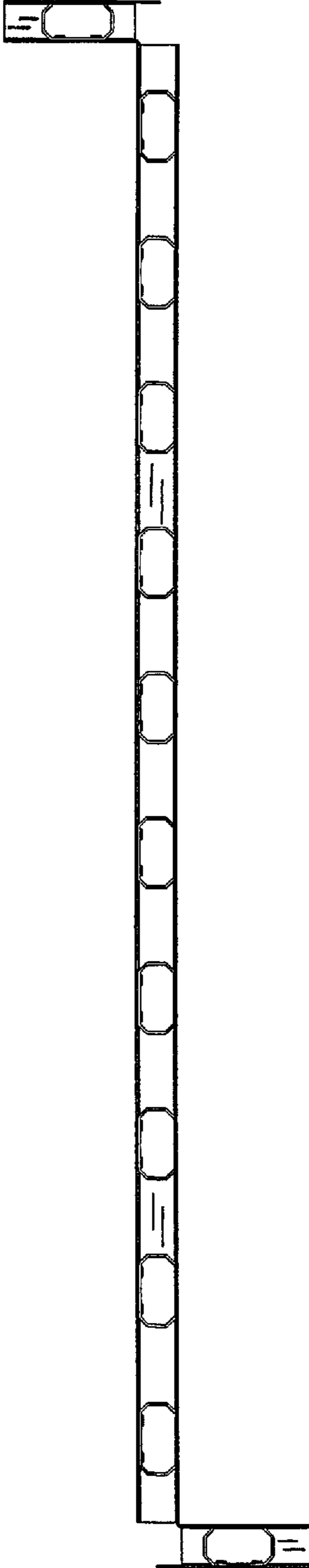

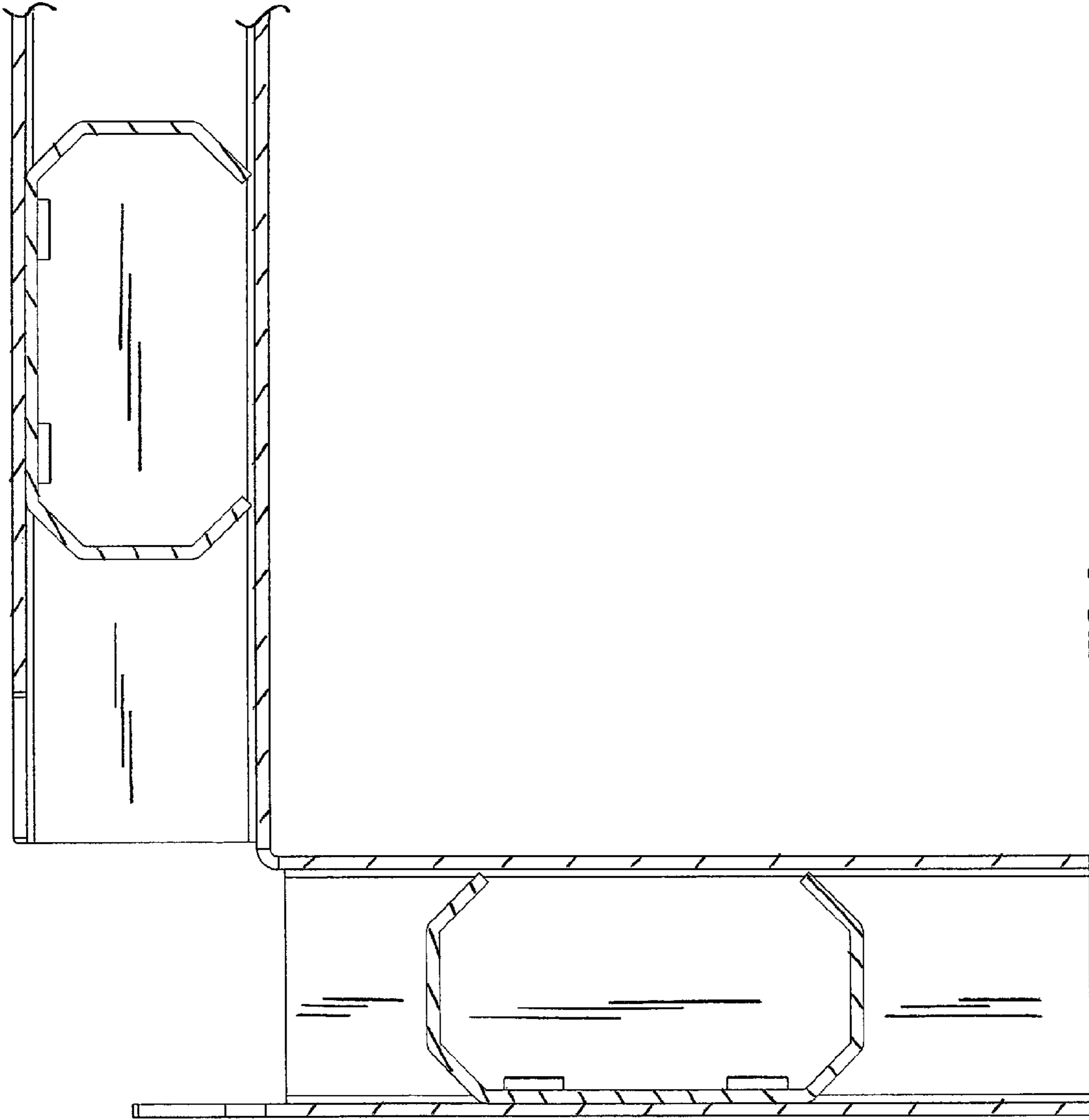
