DESCRIPTION

FIG. 11 is a first side elevation view of the embodiment of FIG. 8;

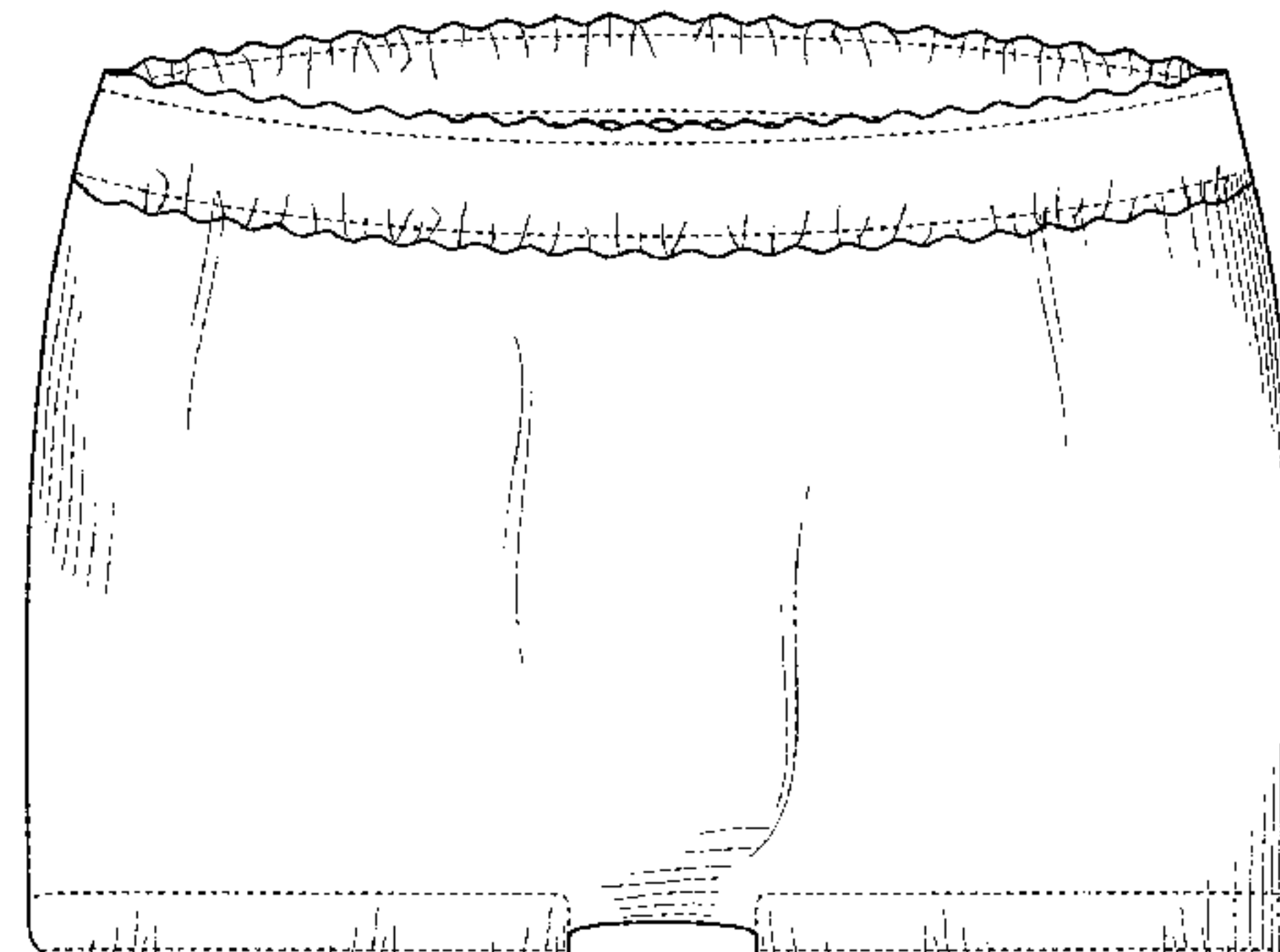
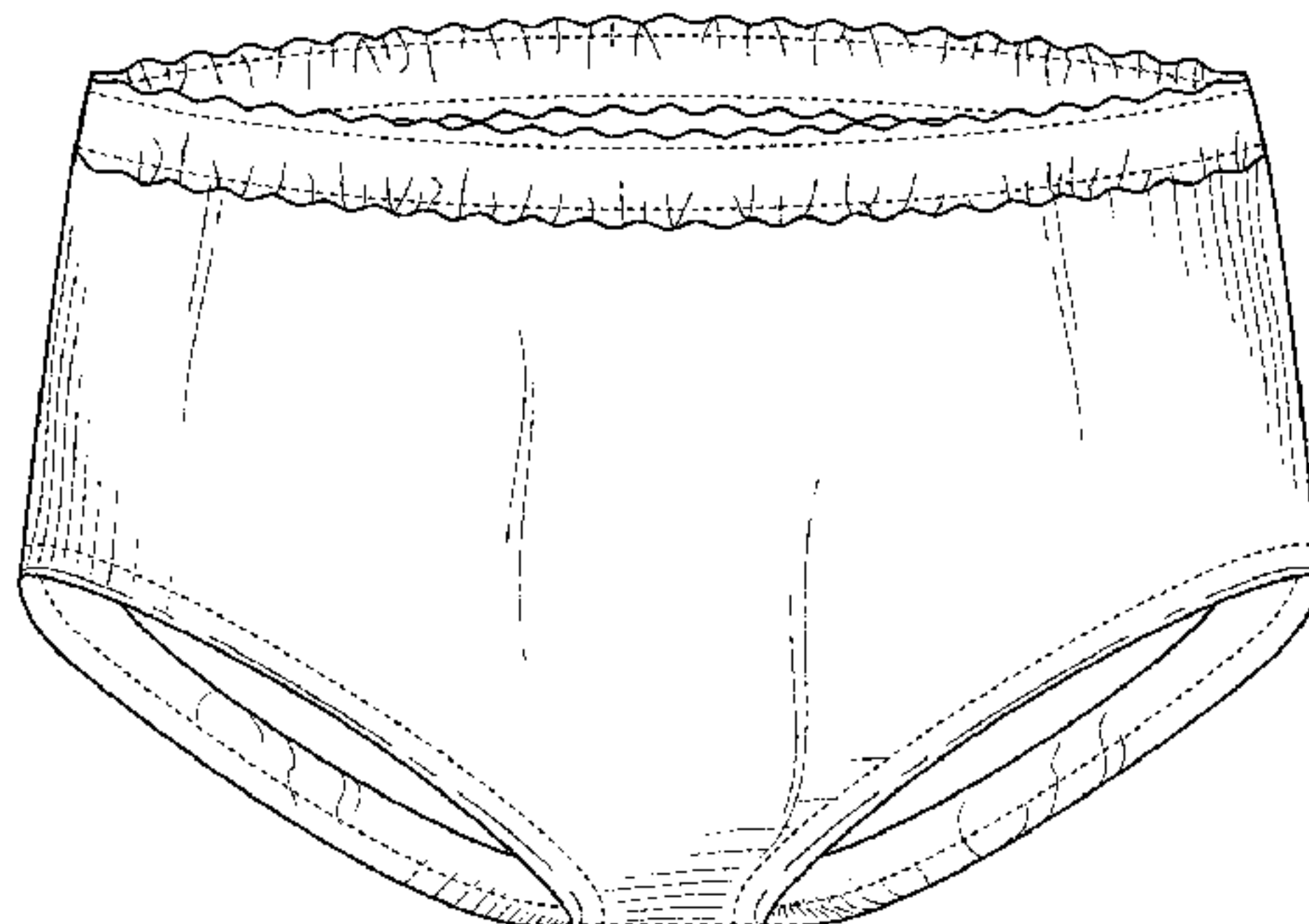
FIG. 12 is a second side elevation view of the embodiment of FIG. 8;

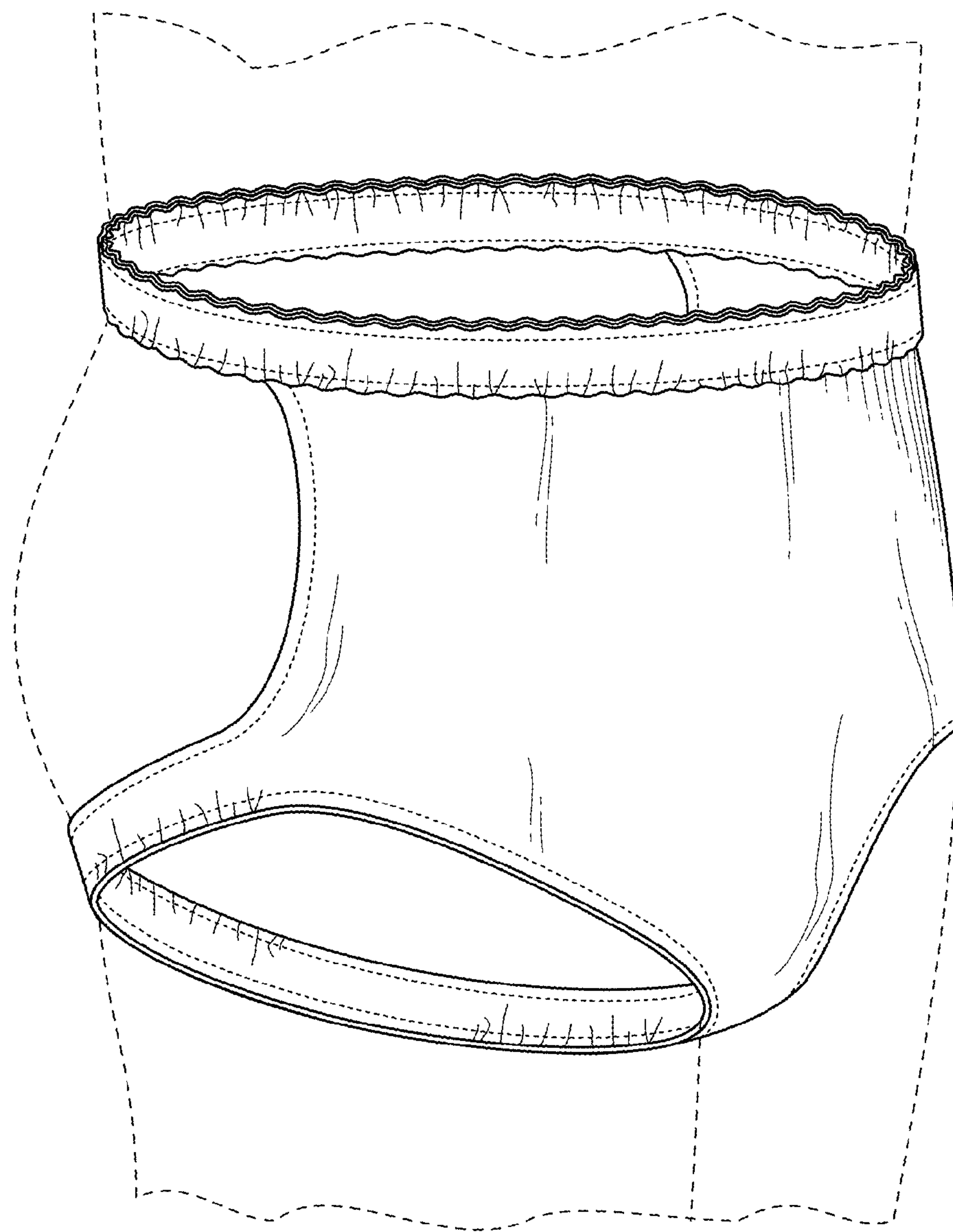

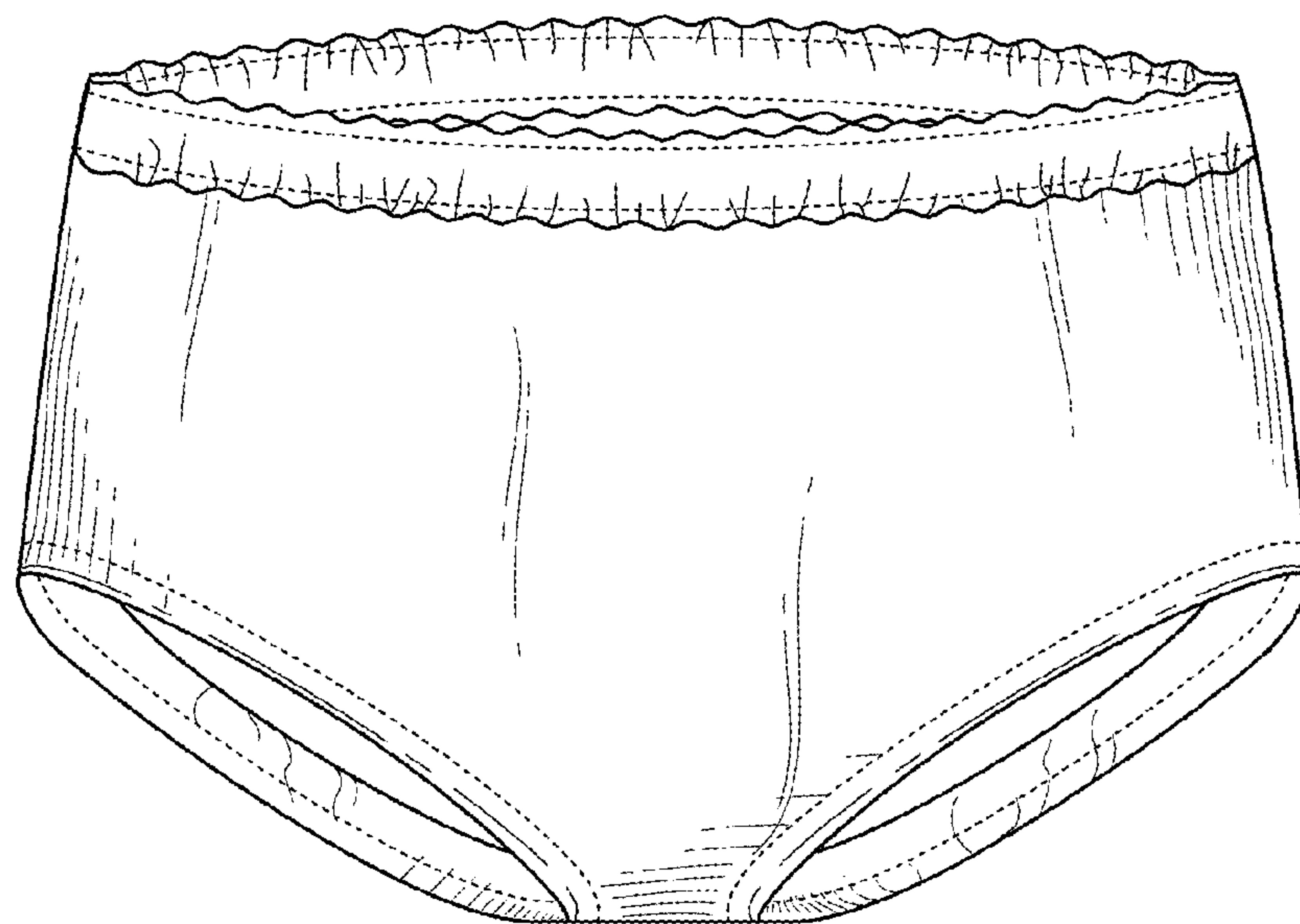

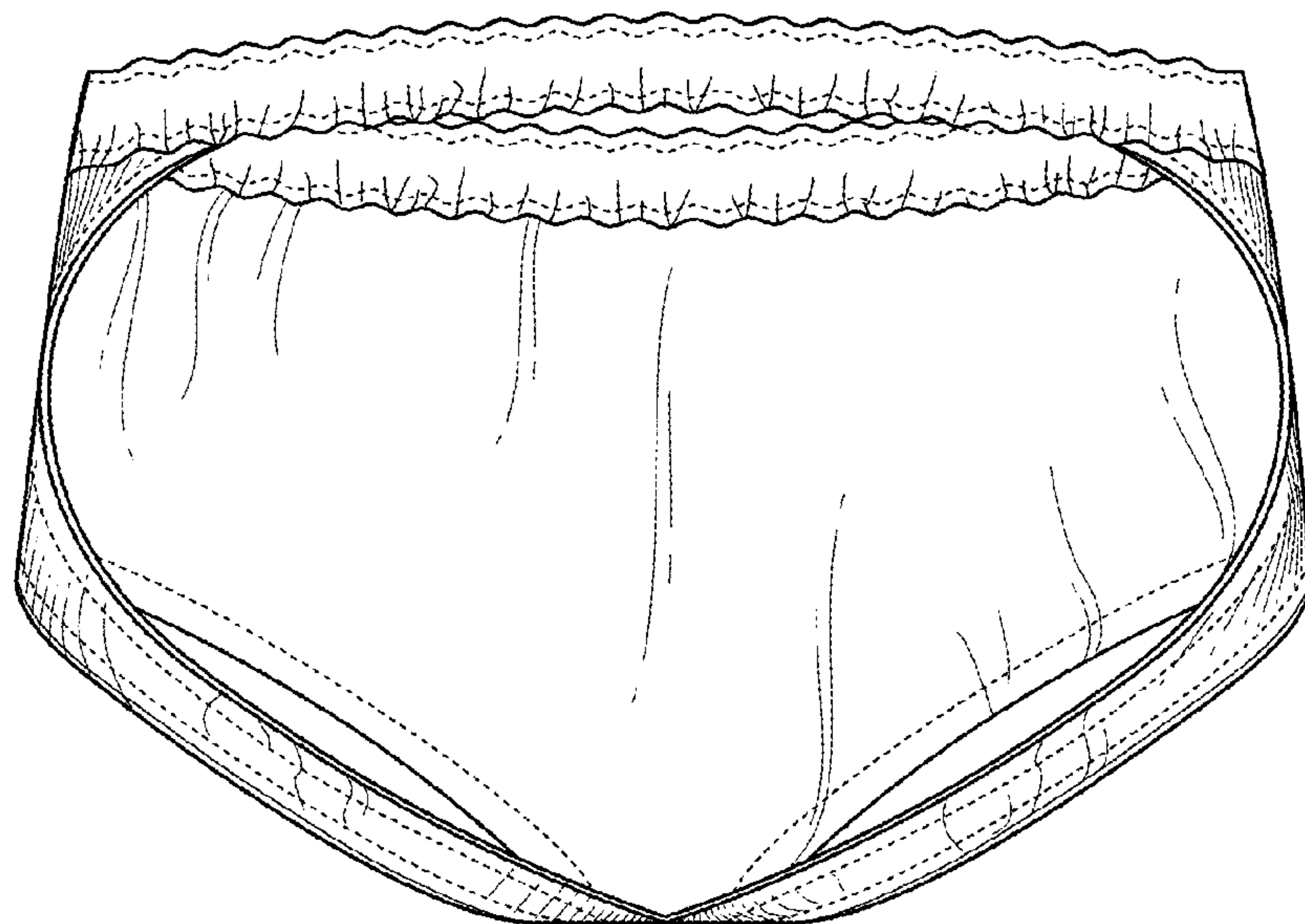

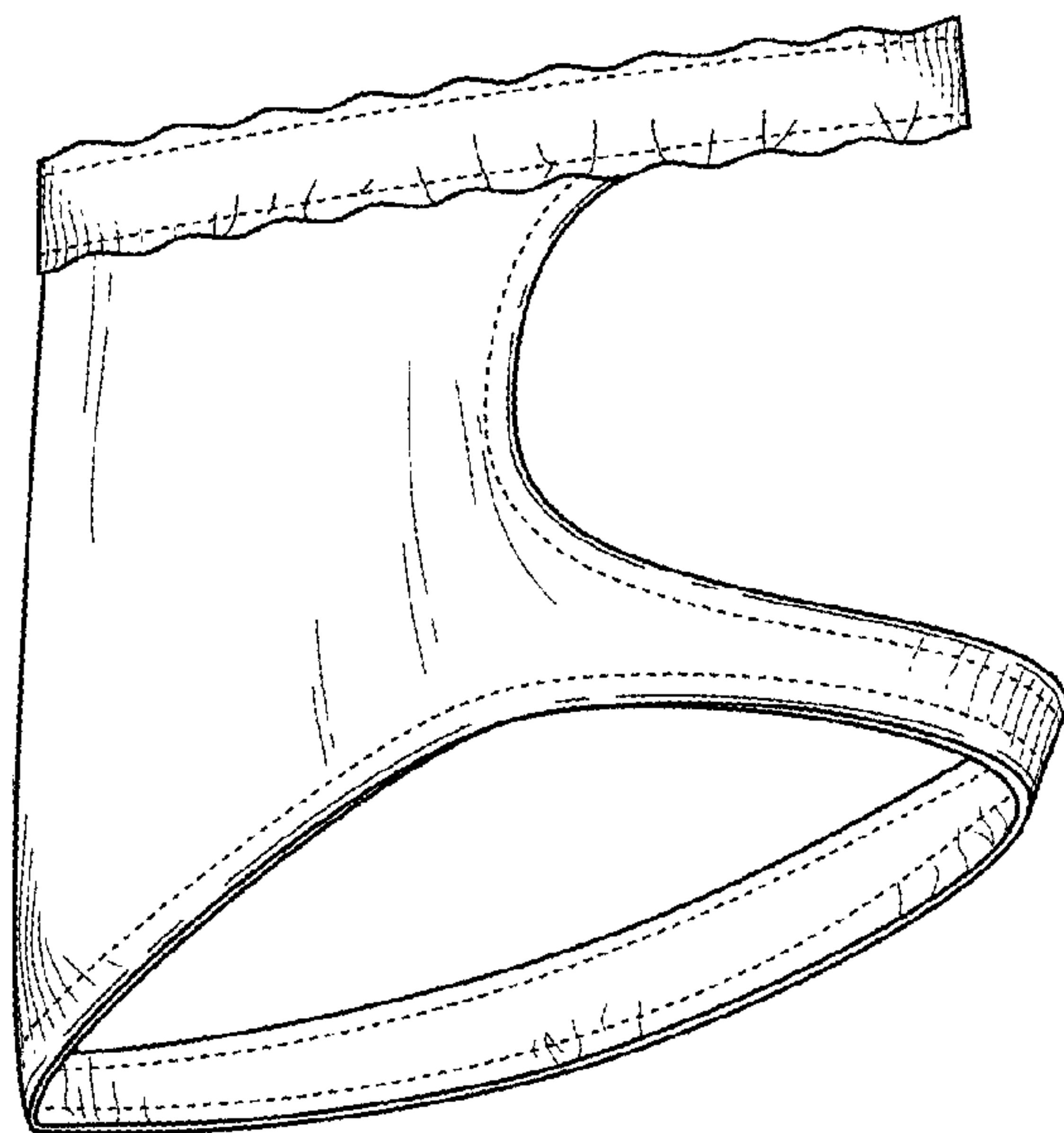

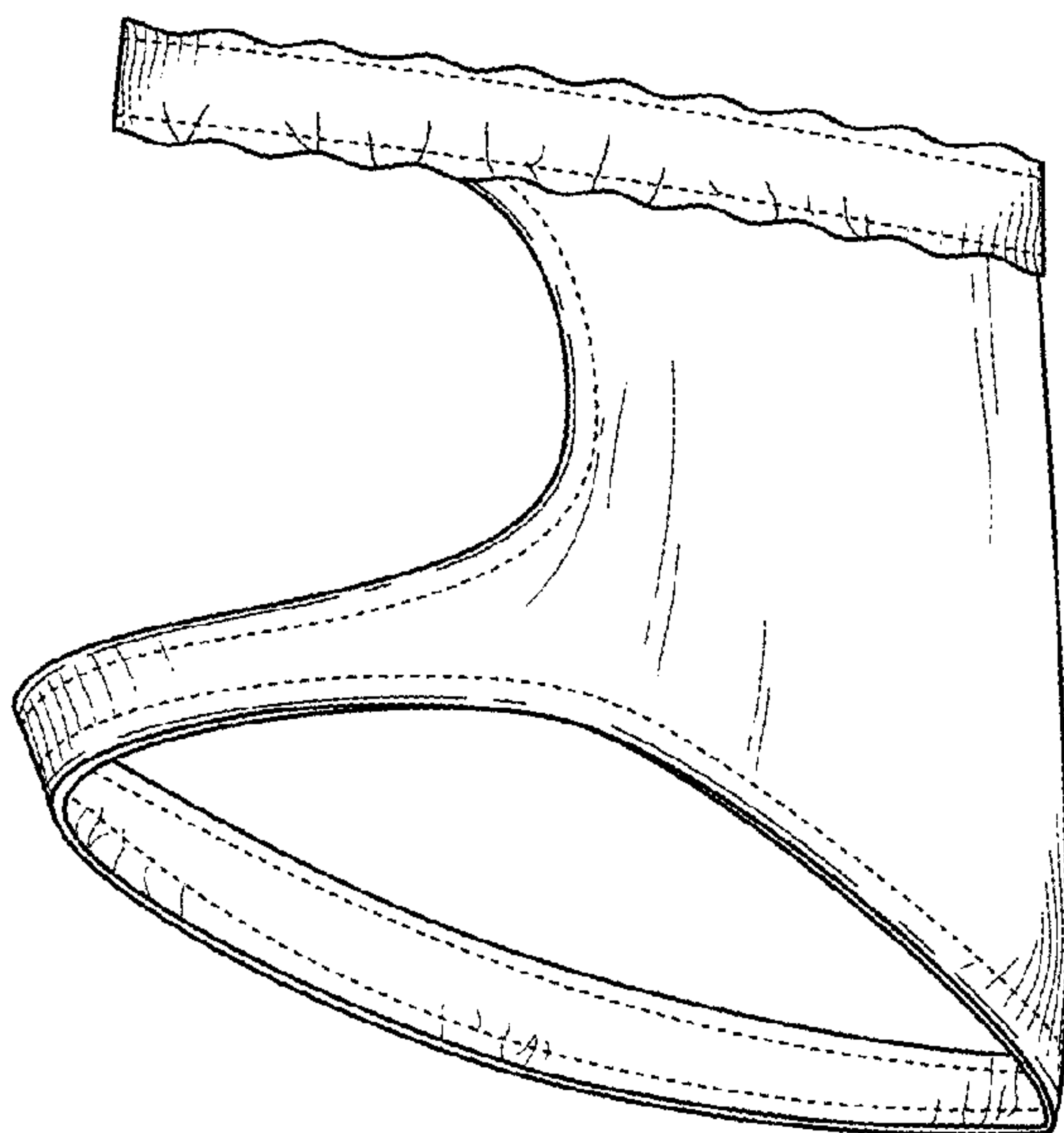

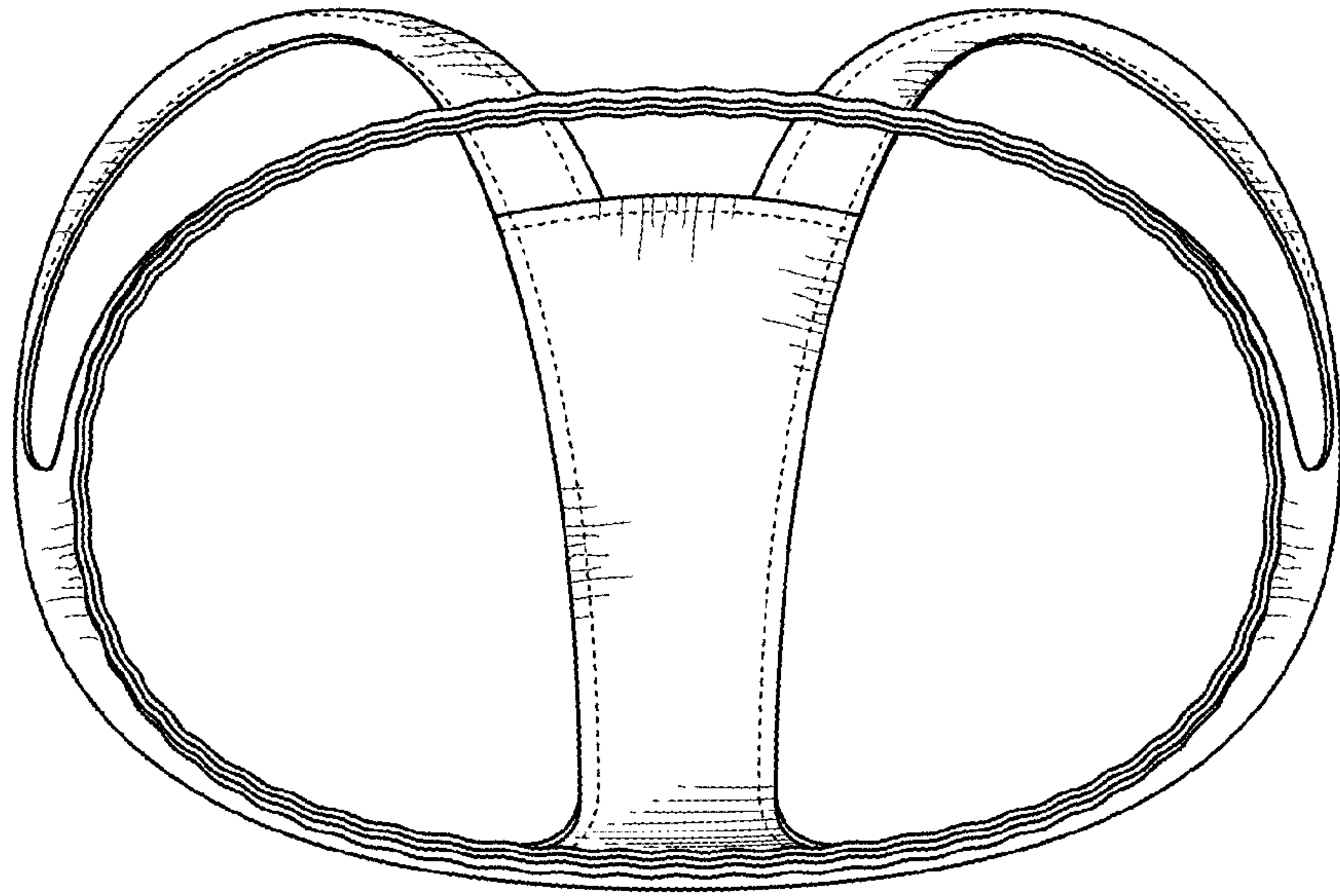

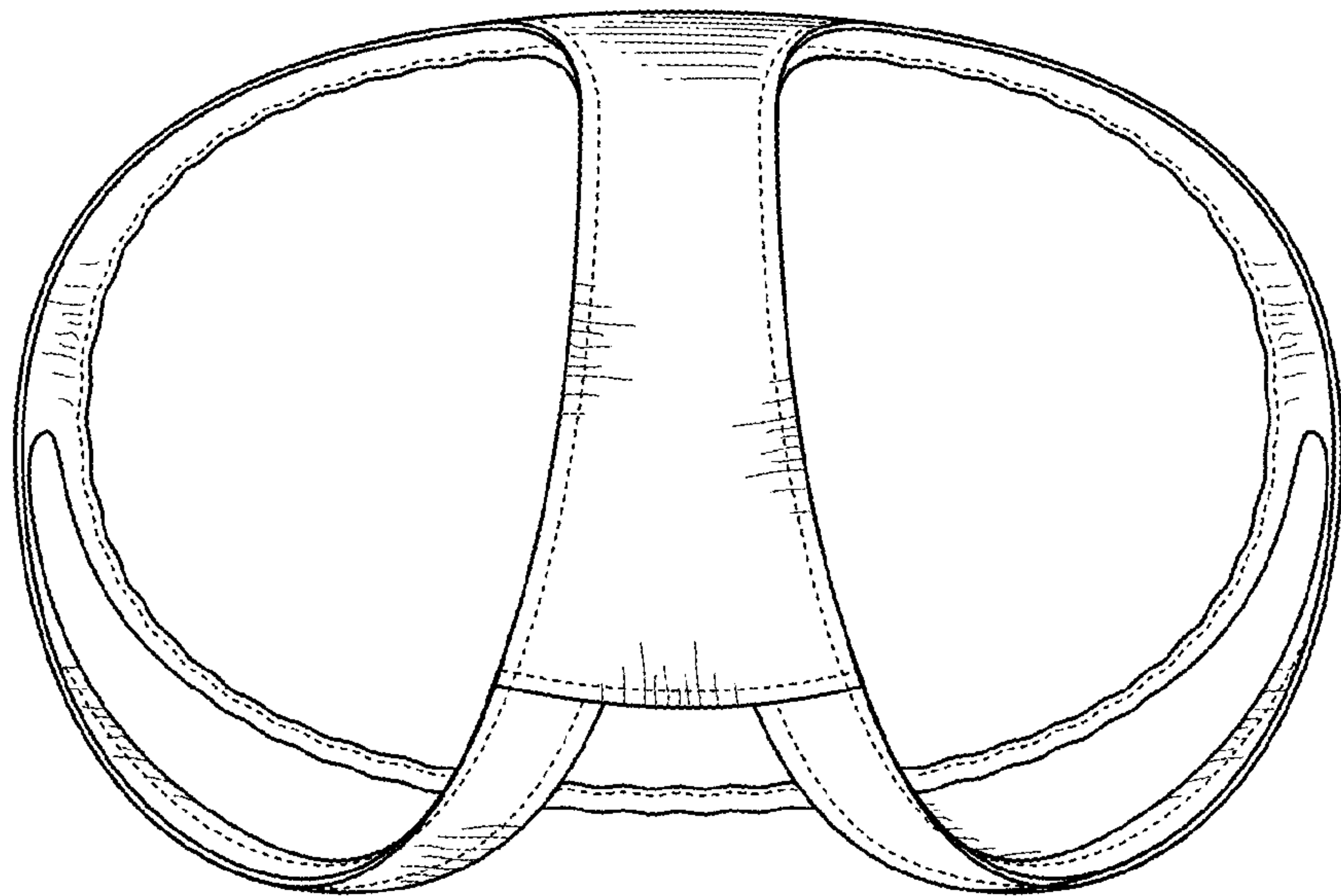

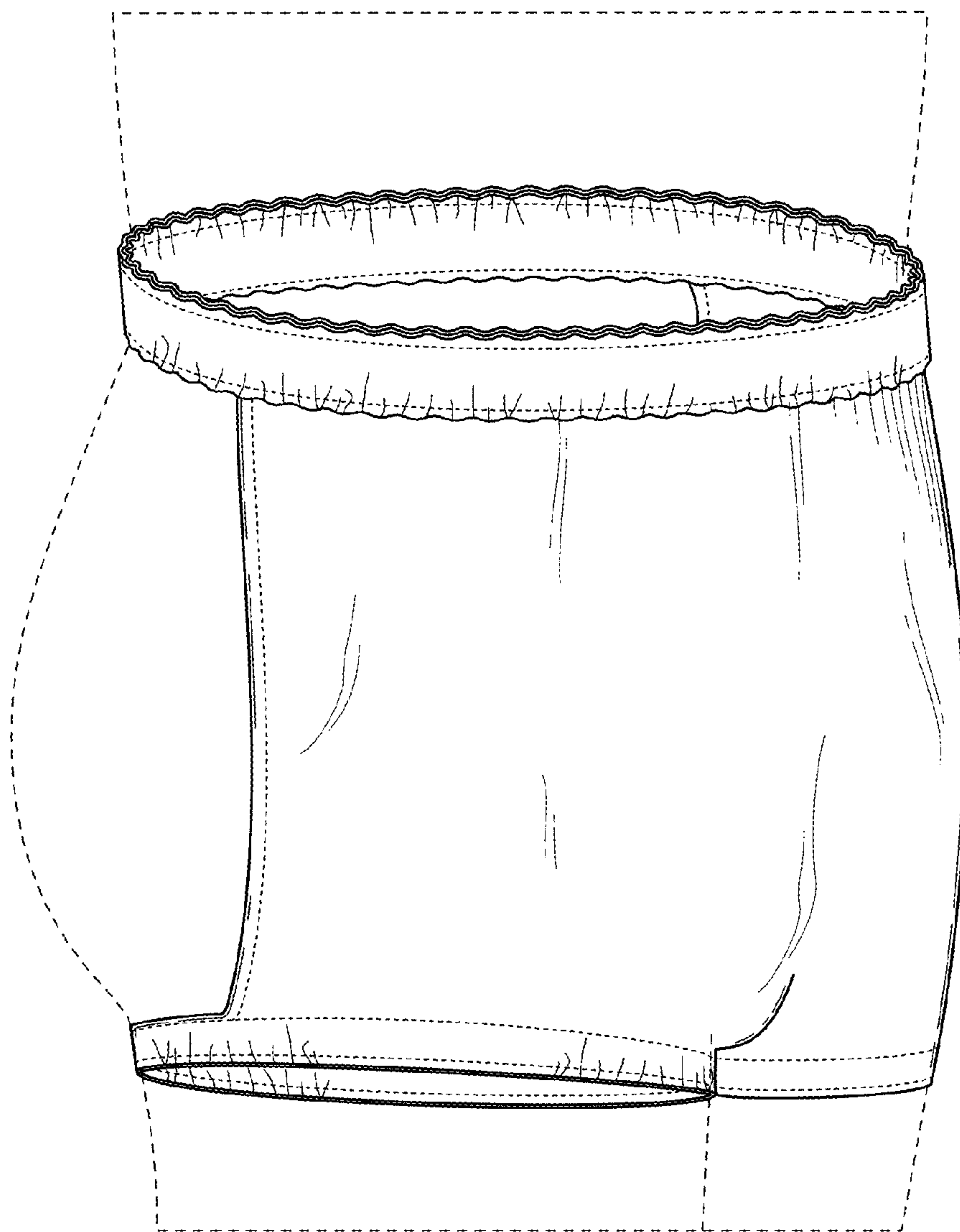

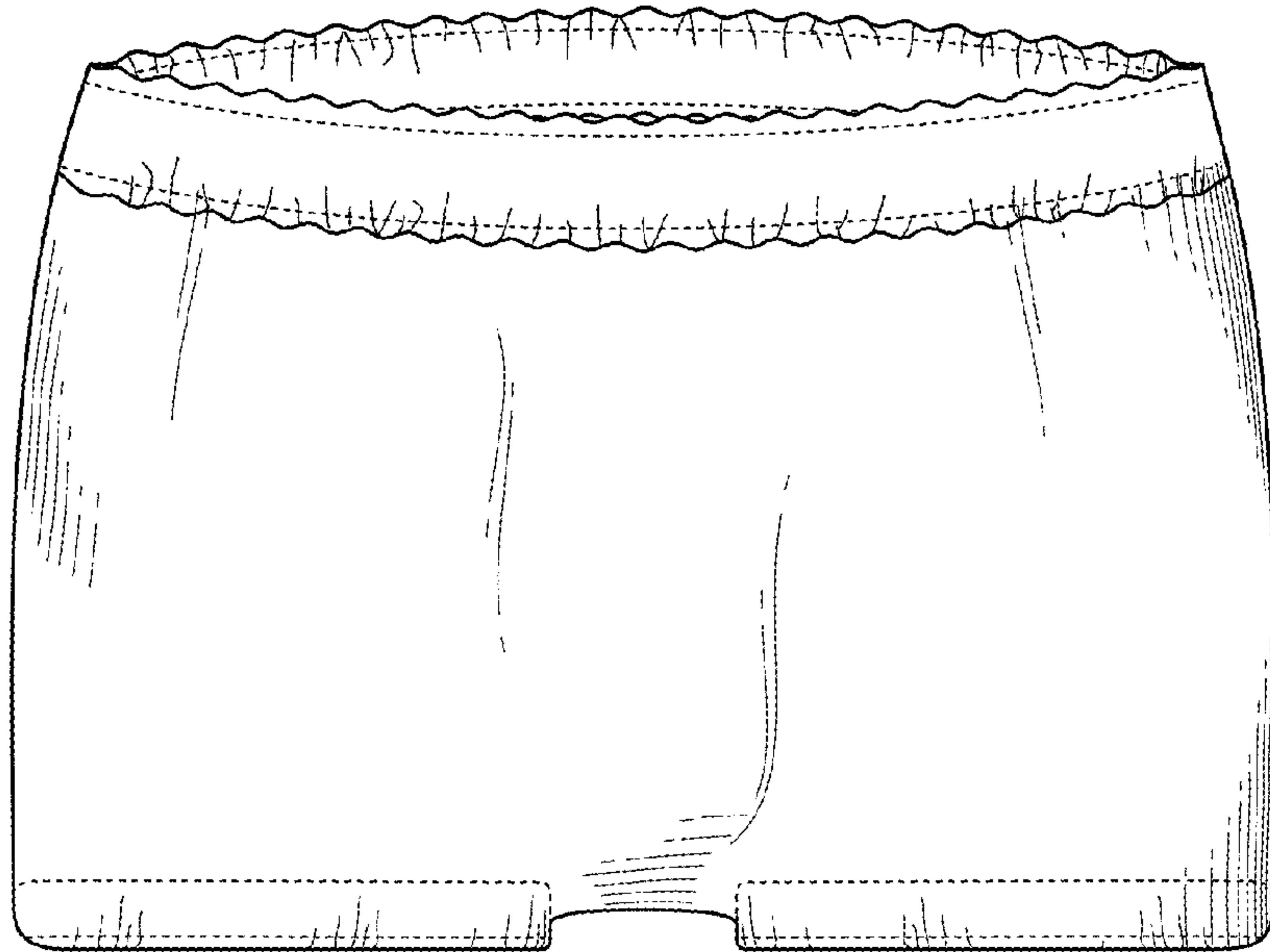

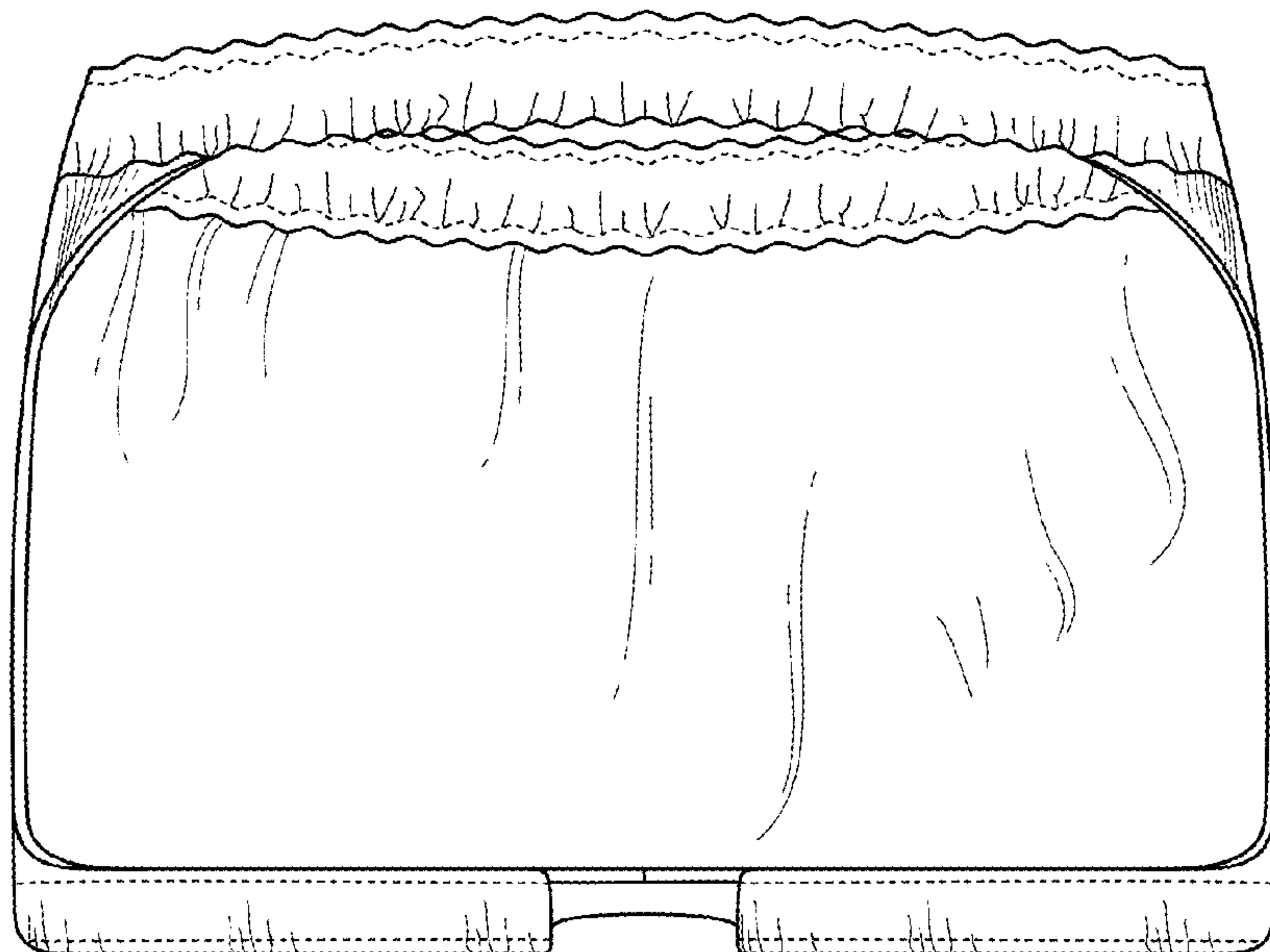

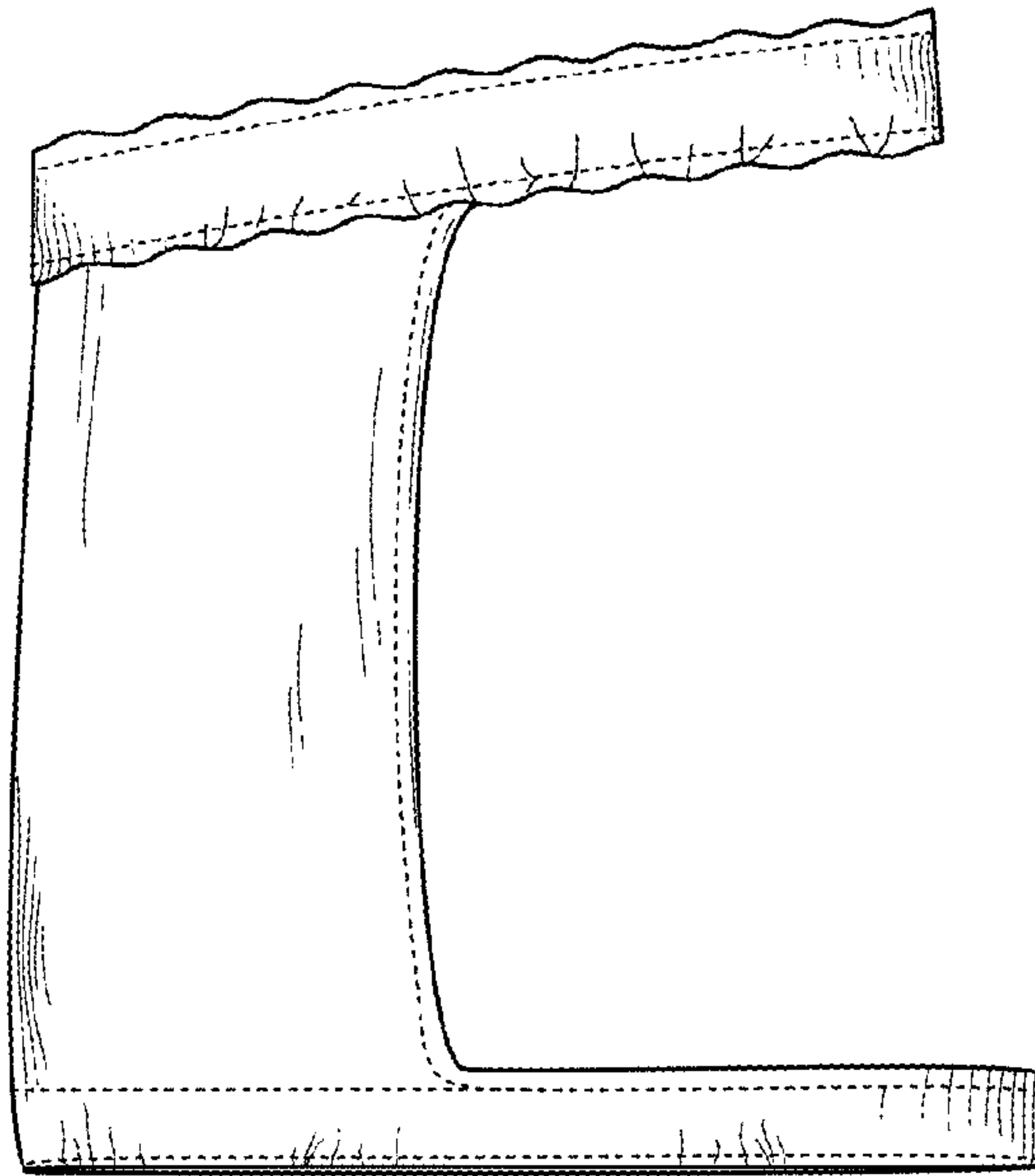

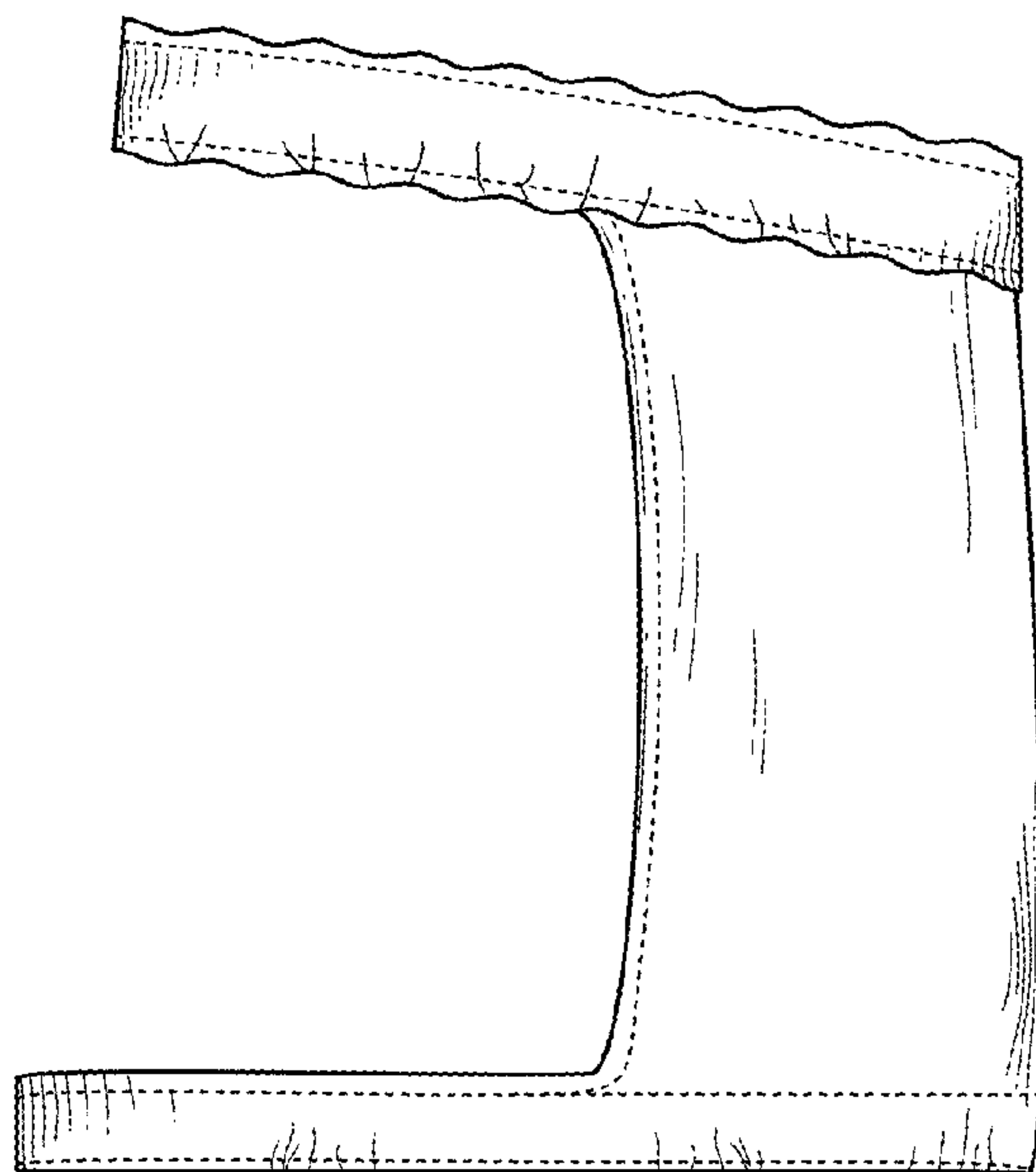

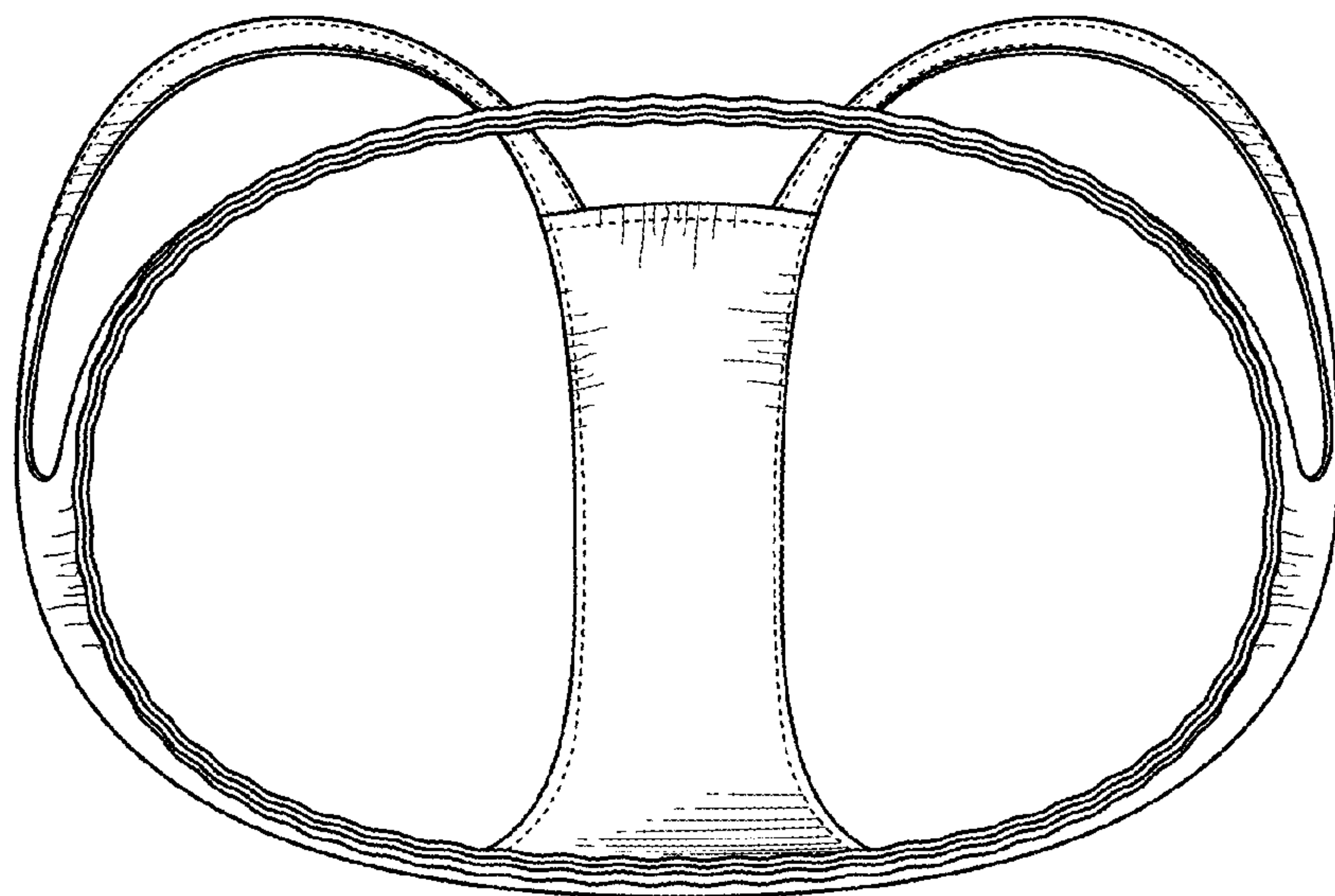

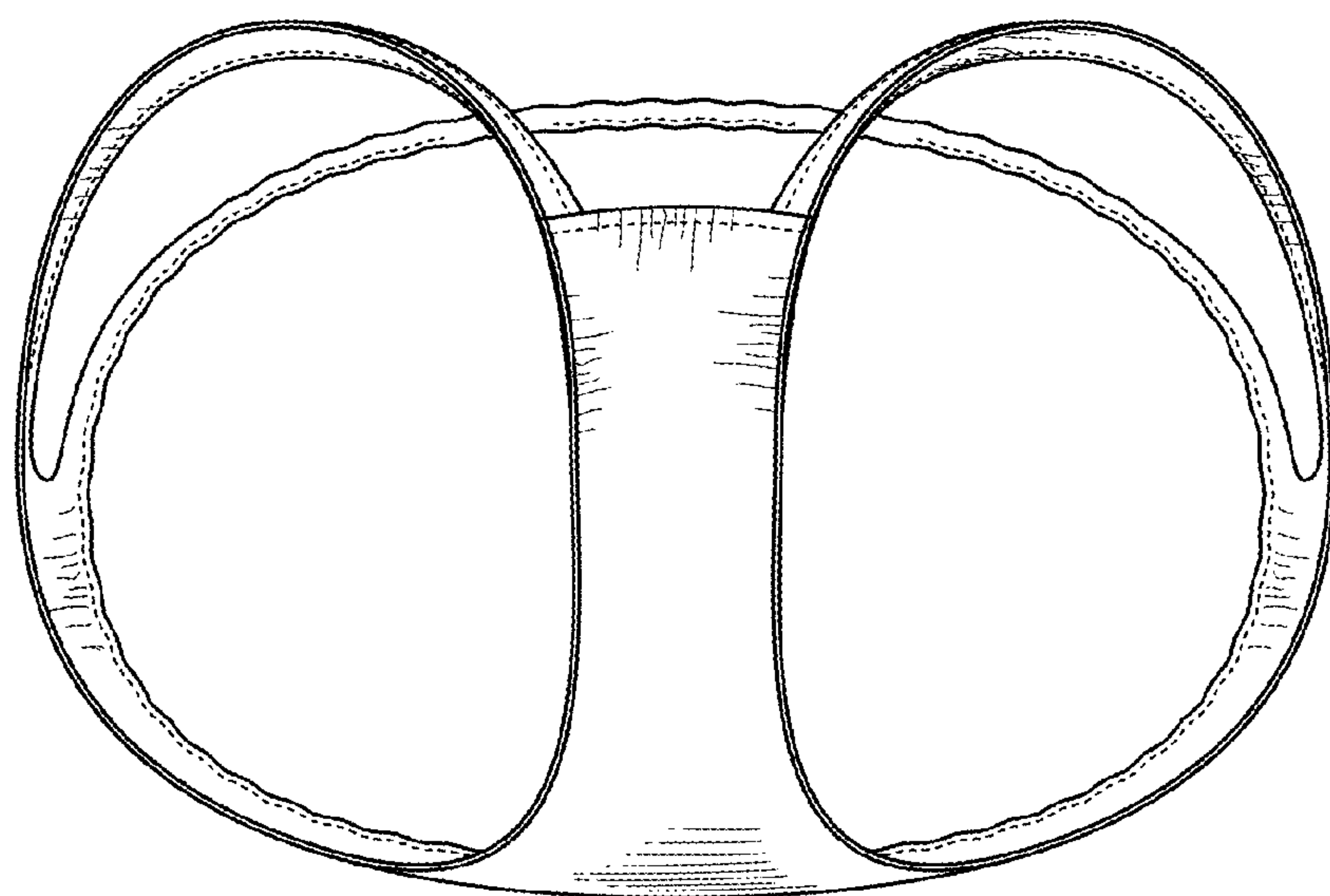
