(57) **CLAIM**

I claim the ornamental design for a baby bib, as shown and described.

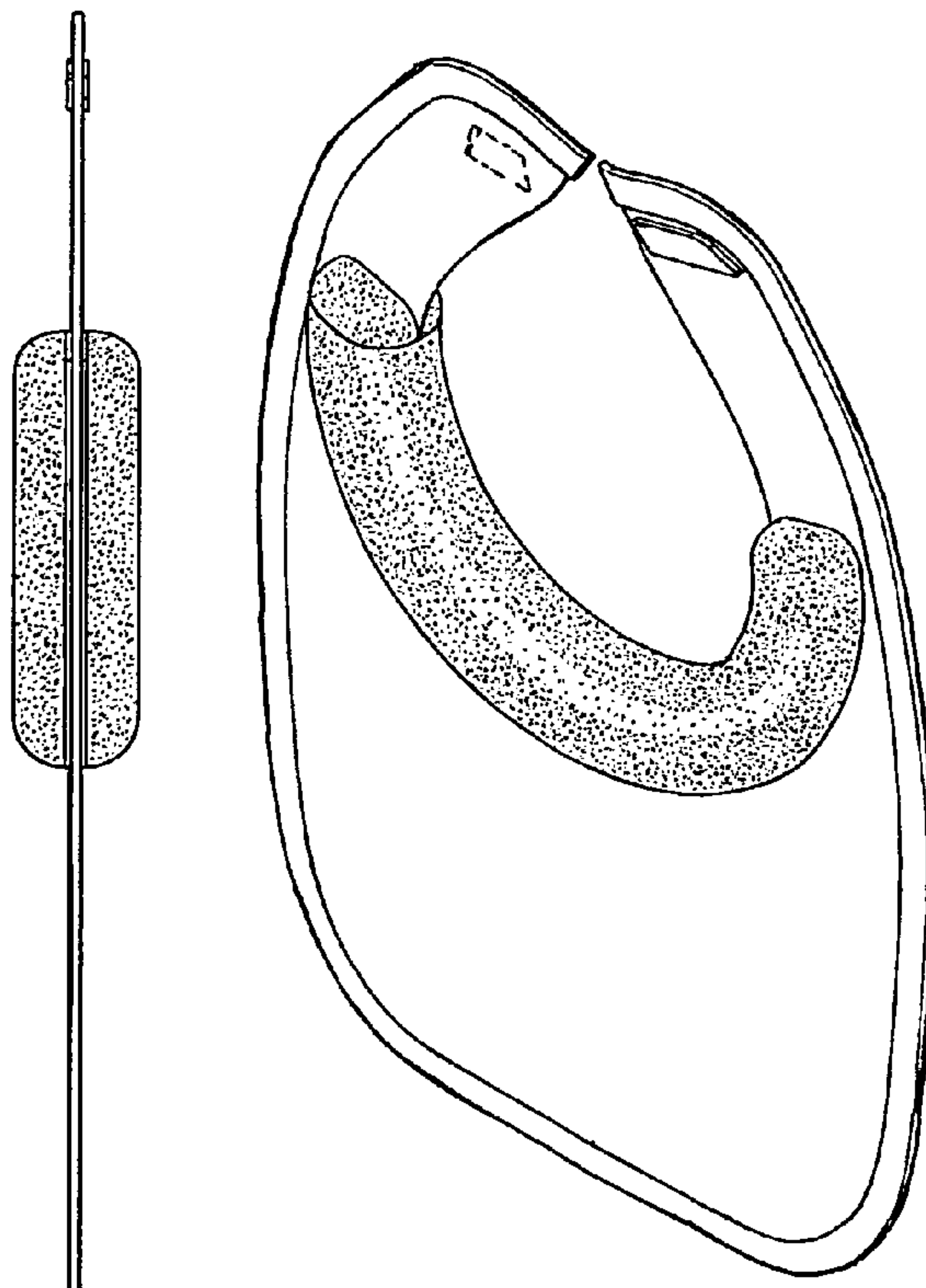
DESCRIPTION

FIG. 1 is a front view of a baby bib showing my new design. FIG. 2 is a back view of a baby bib showing my new design. FIG. 3 is a left side view of a baby bib showing my new design, with a right side view being a mirror image of the left side.

FIG. 4 is a top view of a baby bib showing my new design. FIG. 5 is a bottom view of a baby bib showing my new design; and, FIG. 6 is a perspective view of a baby bib showing my new design.

The broken lines shown on the surface bib in FIGS. 1, 2, 4 & 6 are understood to represent stitching.

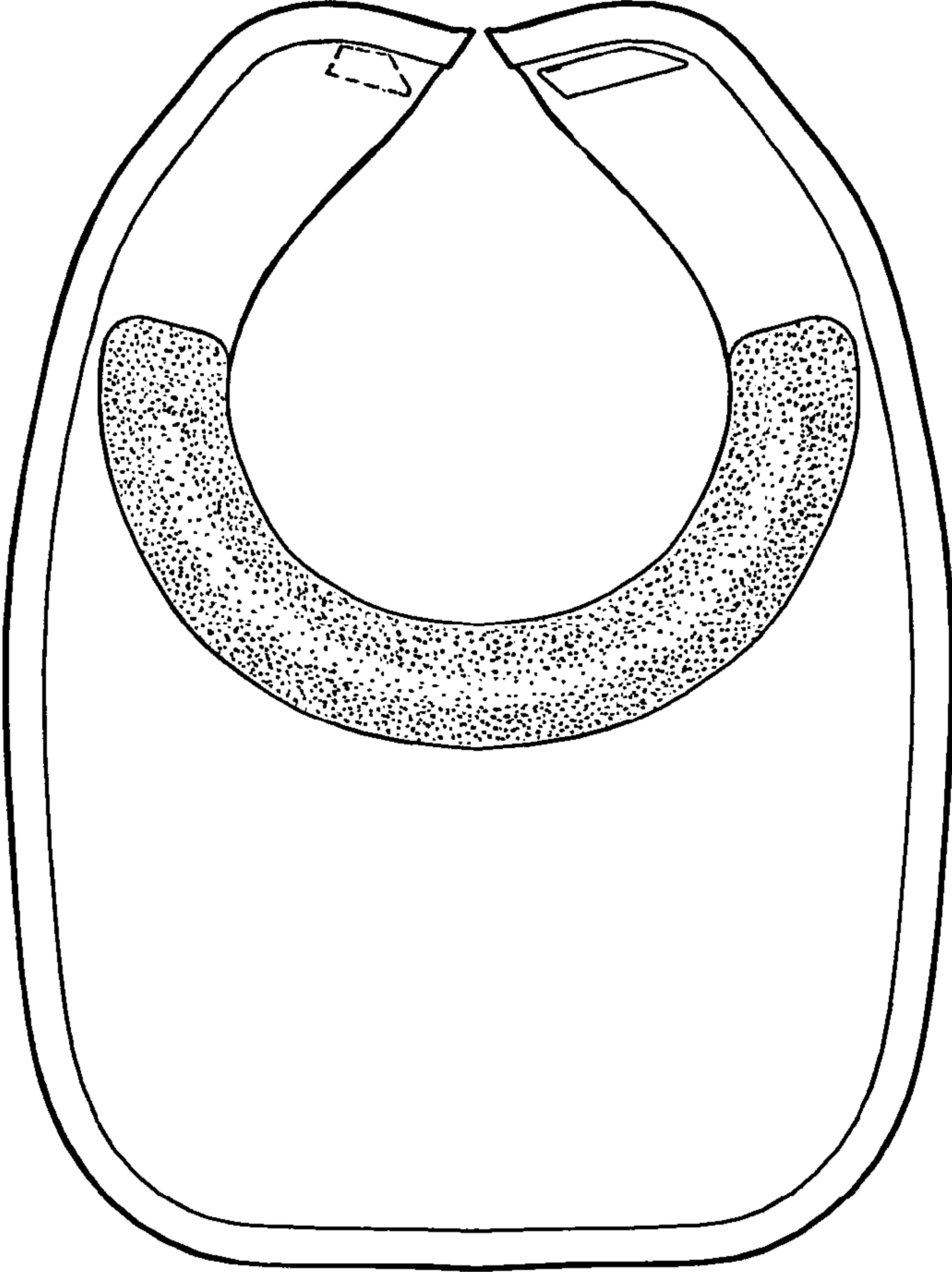

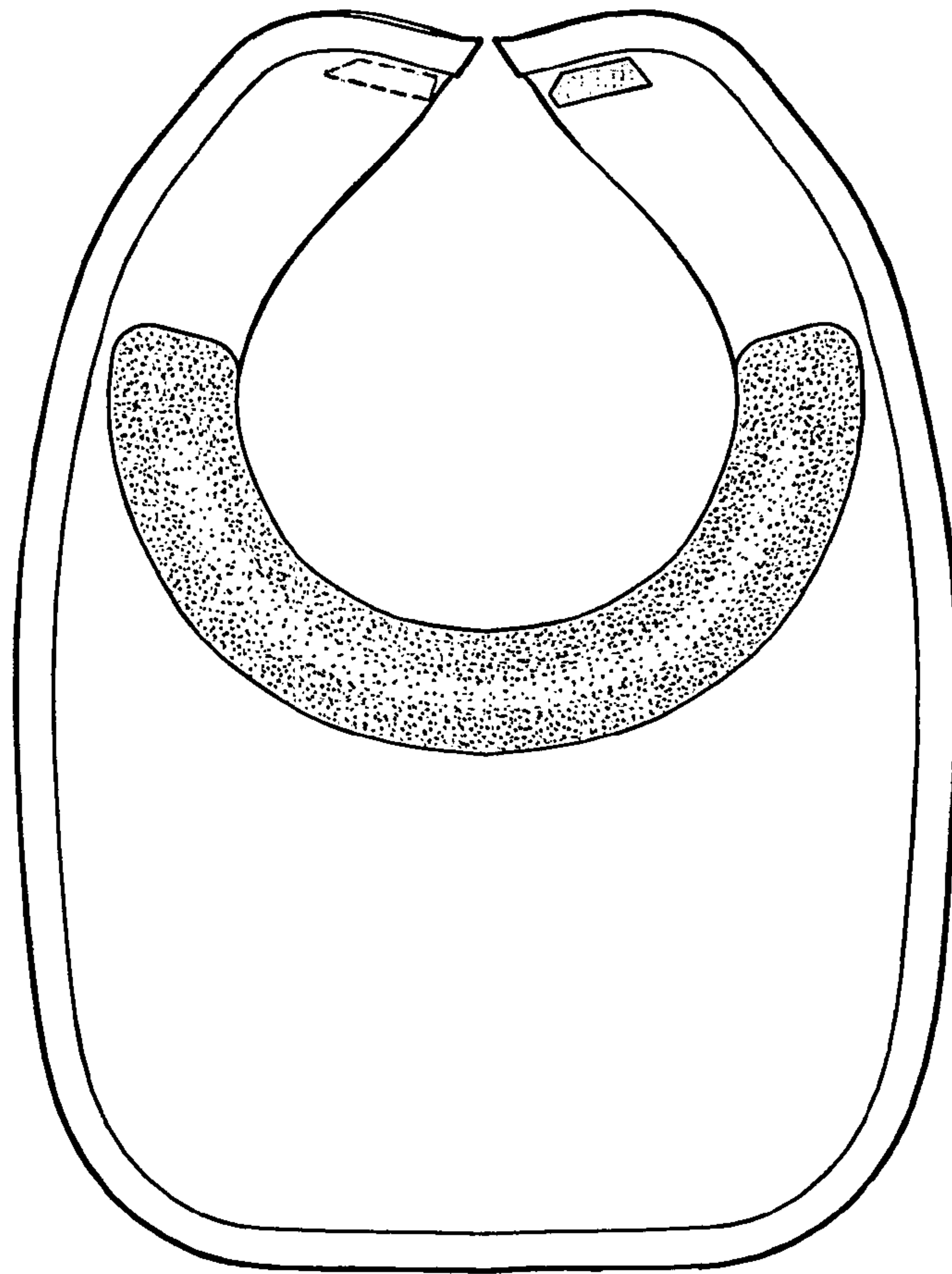

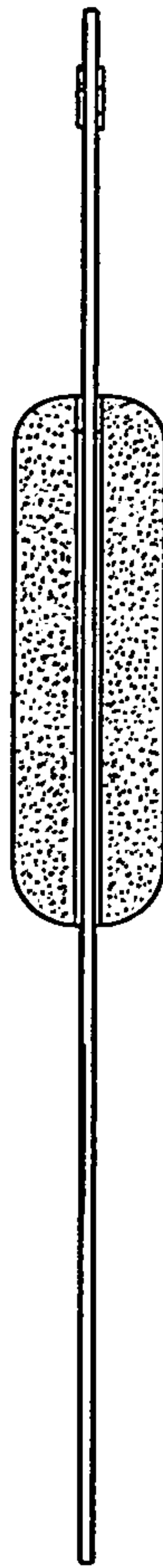

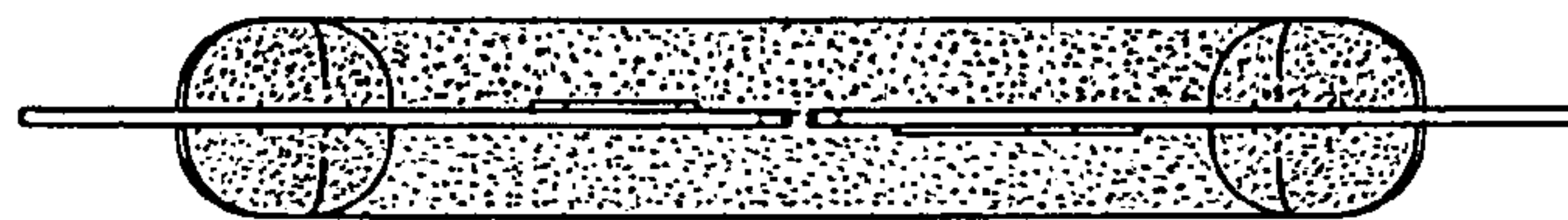

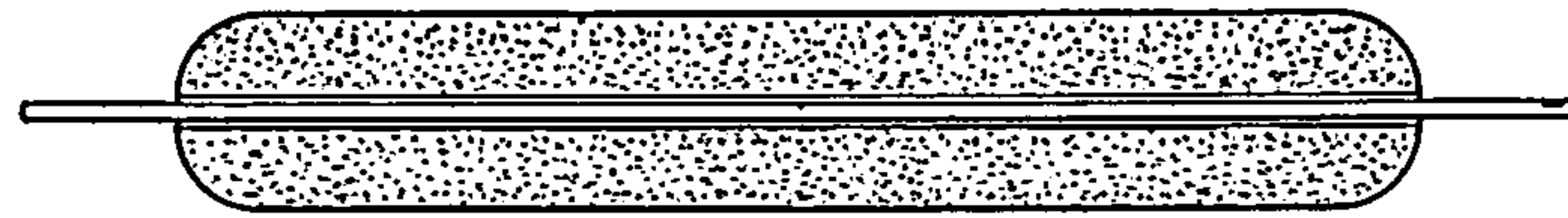

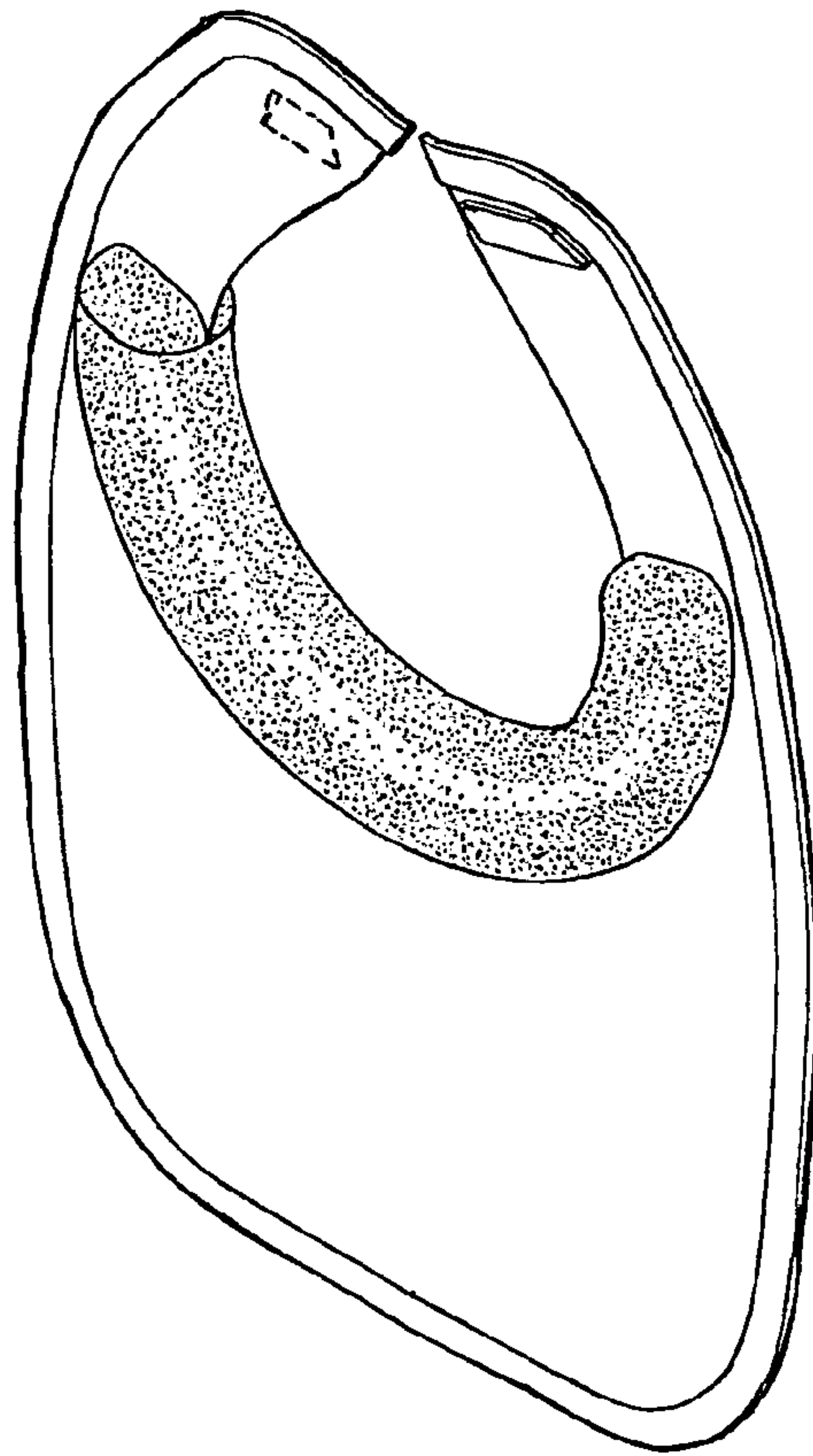
