(57) **CLAIM**

I claim the ornamental design for a hat, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and side perspective view of the hat embodying the design of the present invention, the wearer being shown in dotted lines as the wearer forms no part of the invention.

FIG. 2 is a top plan view thereof.

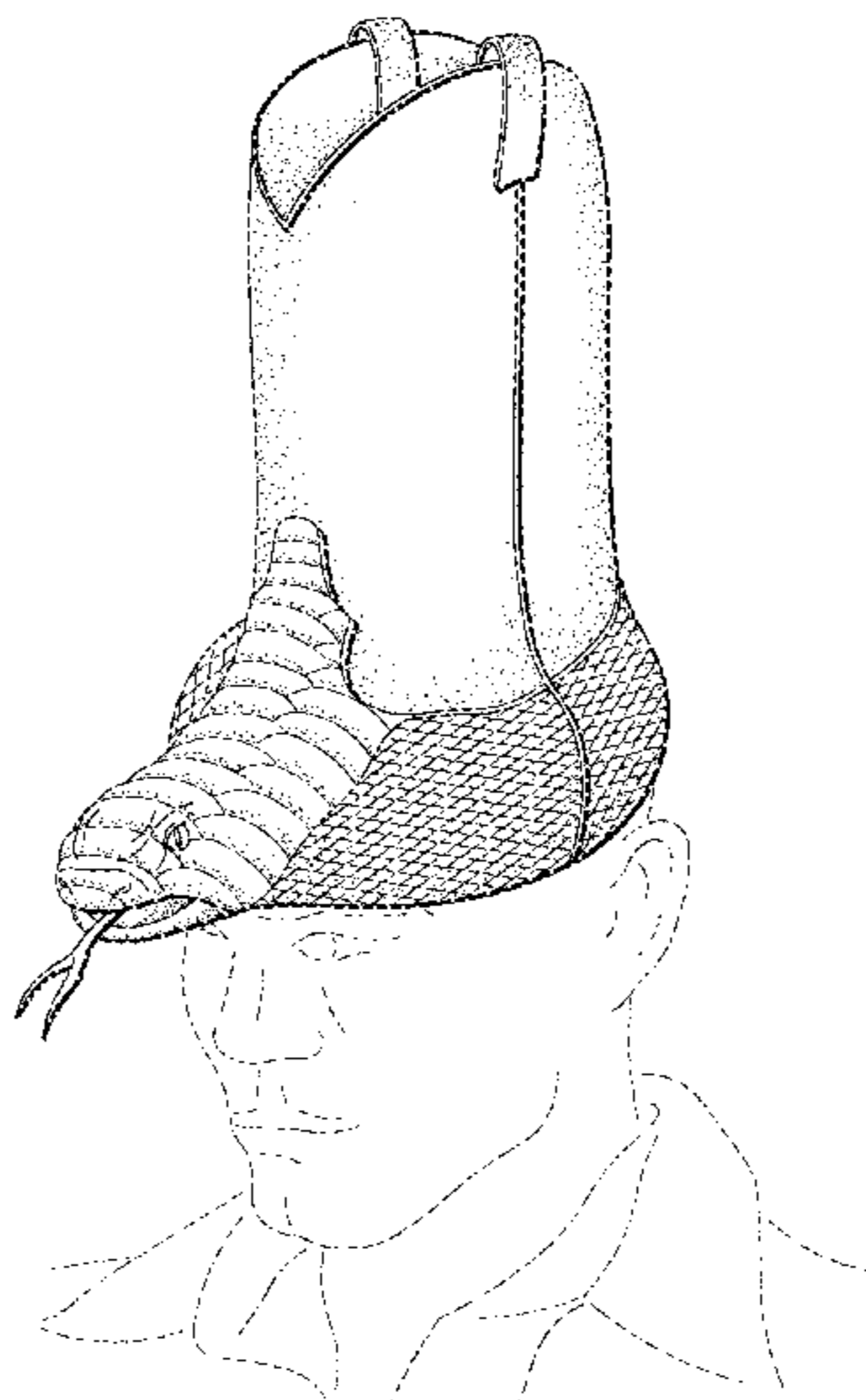
FIG. 3 is a front elevational view thereof.

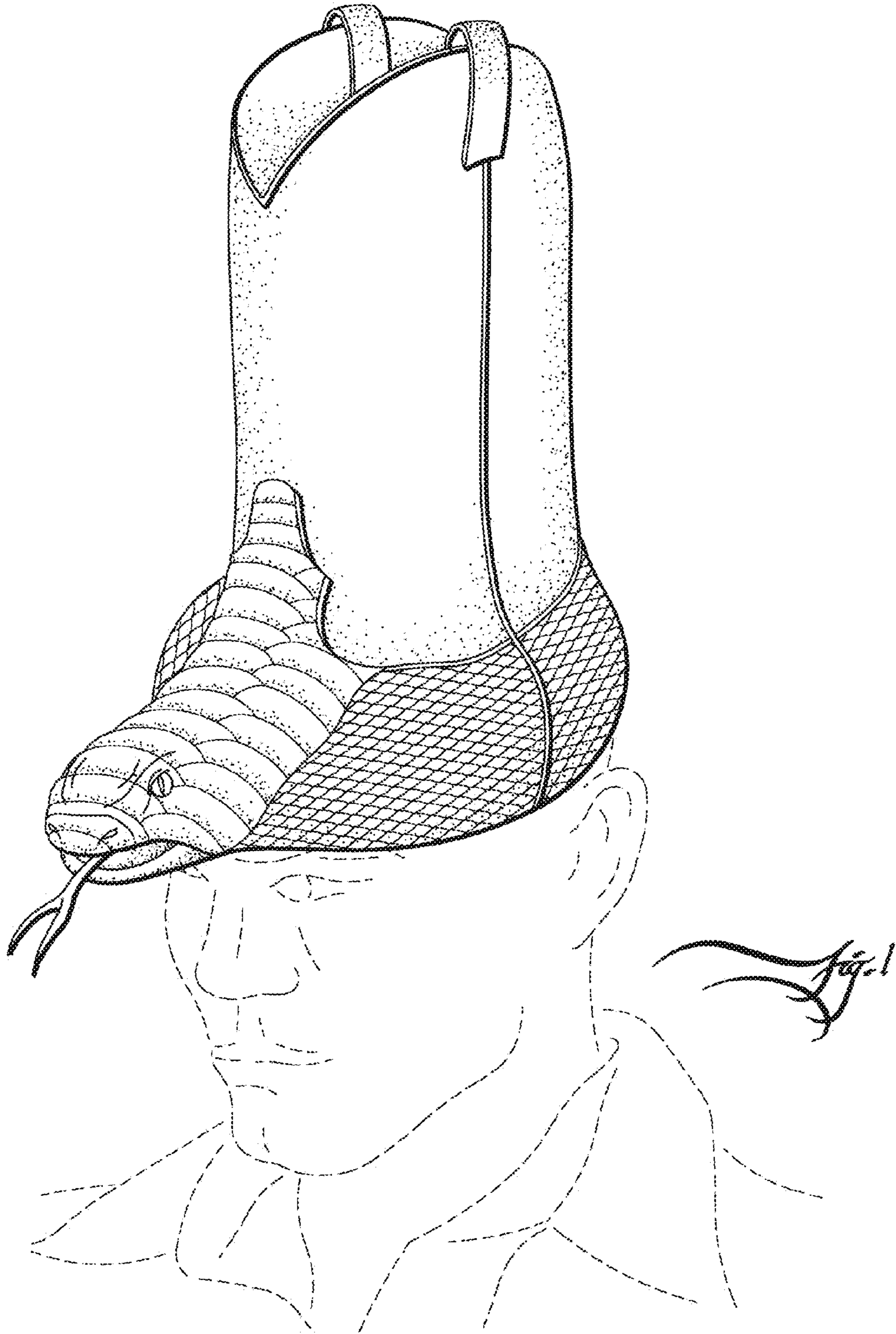
FIG. 4 is a bottom plan view thereof.

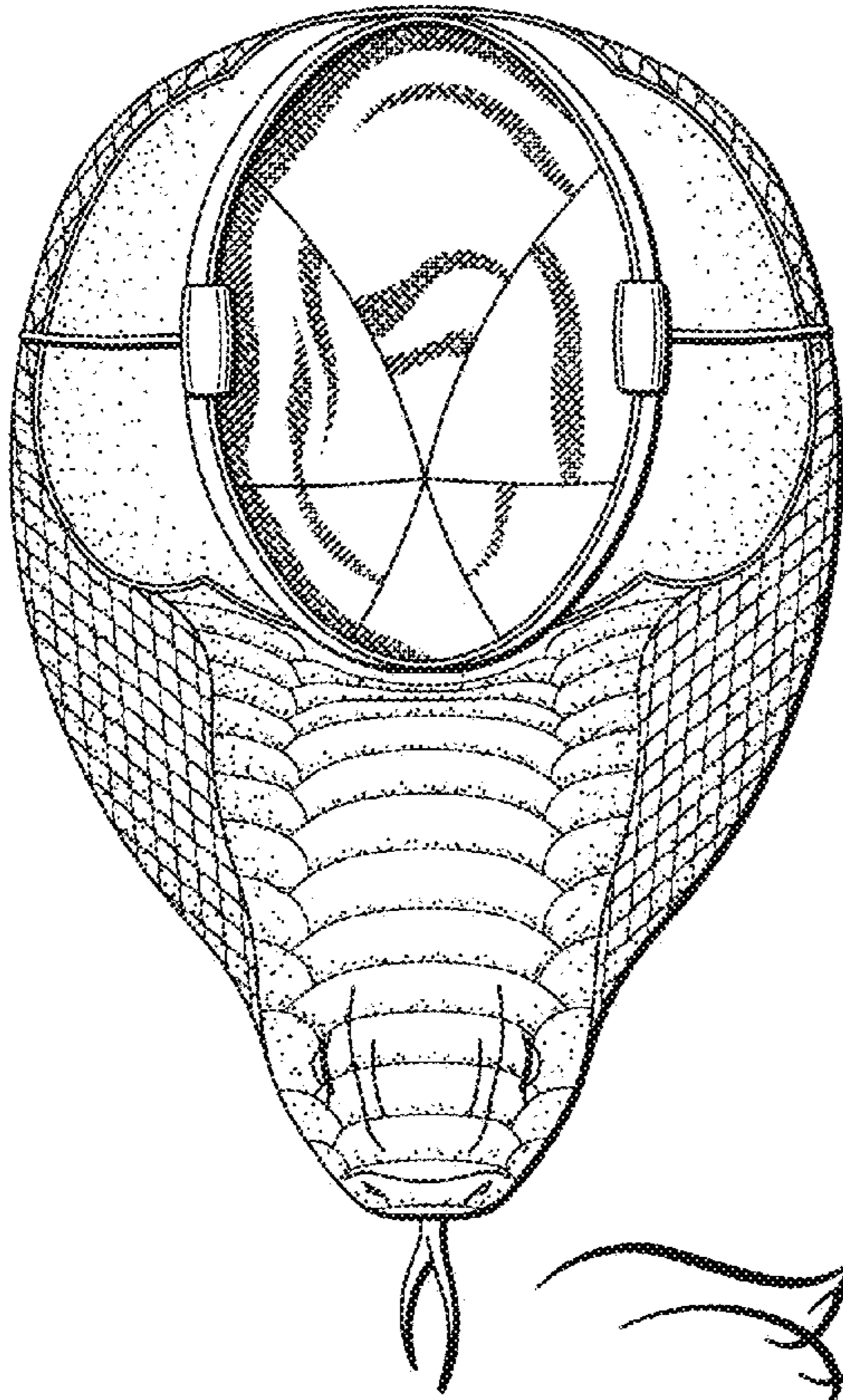

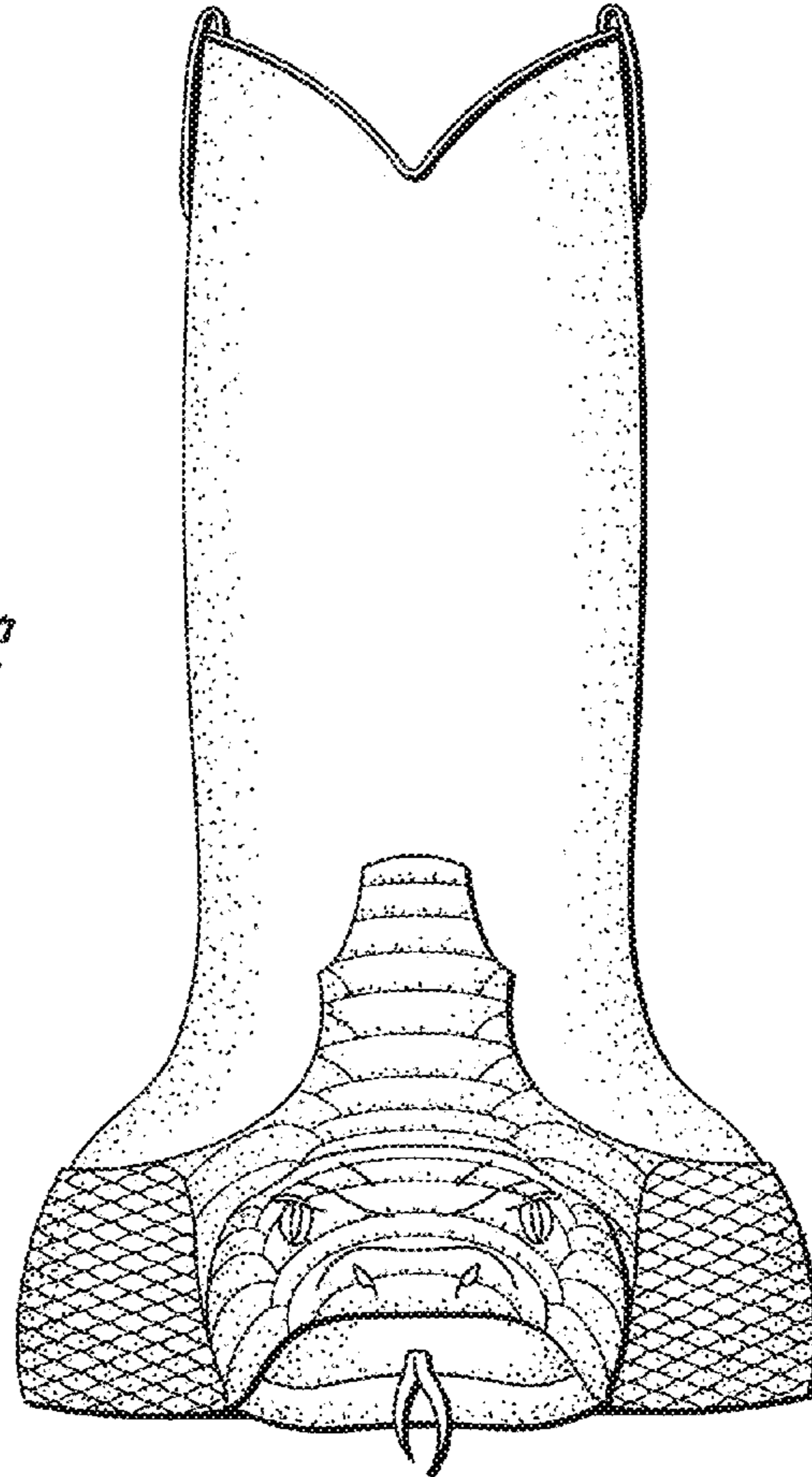

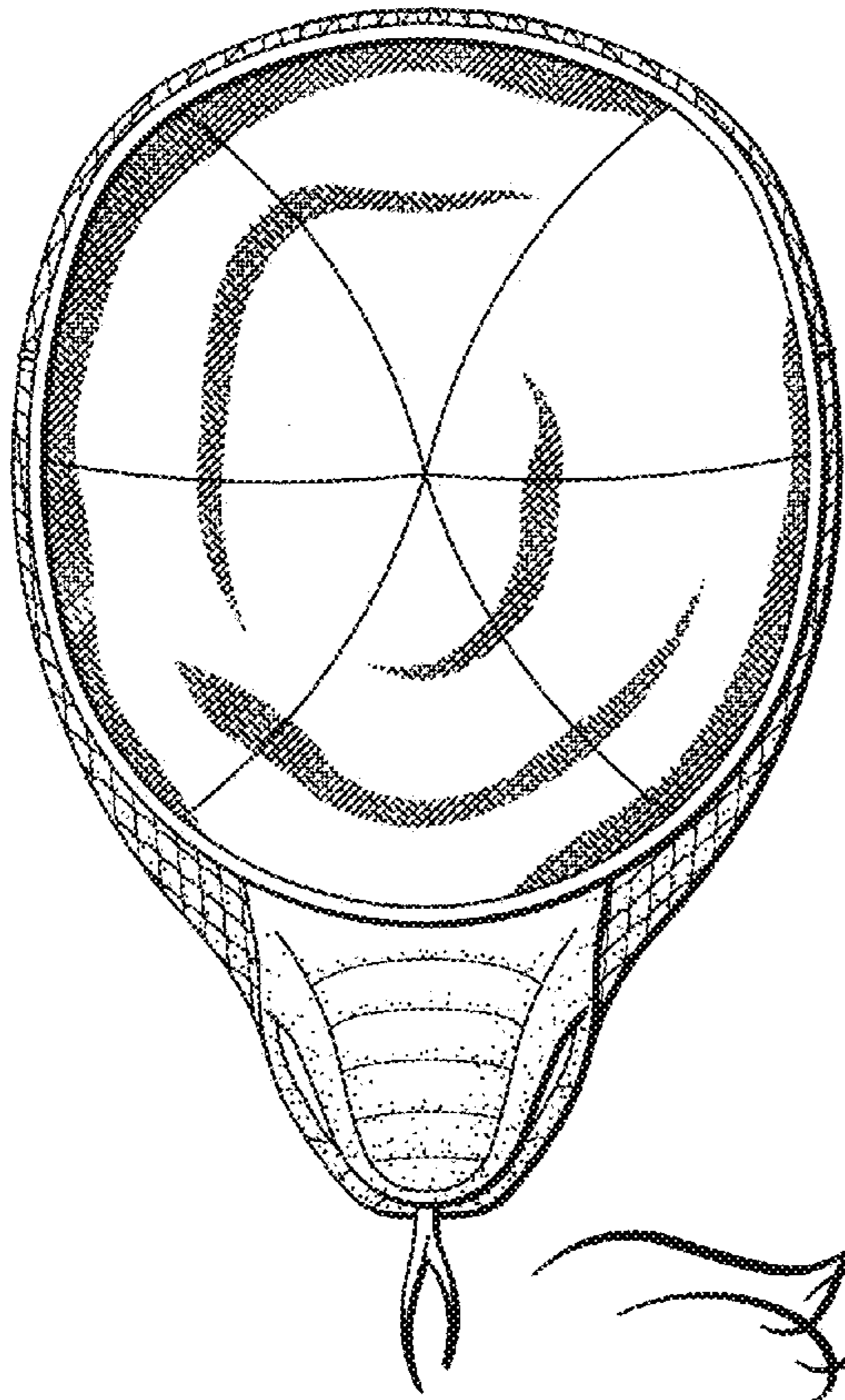

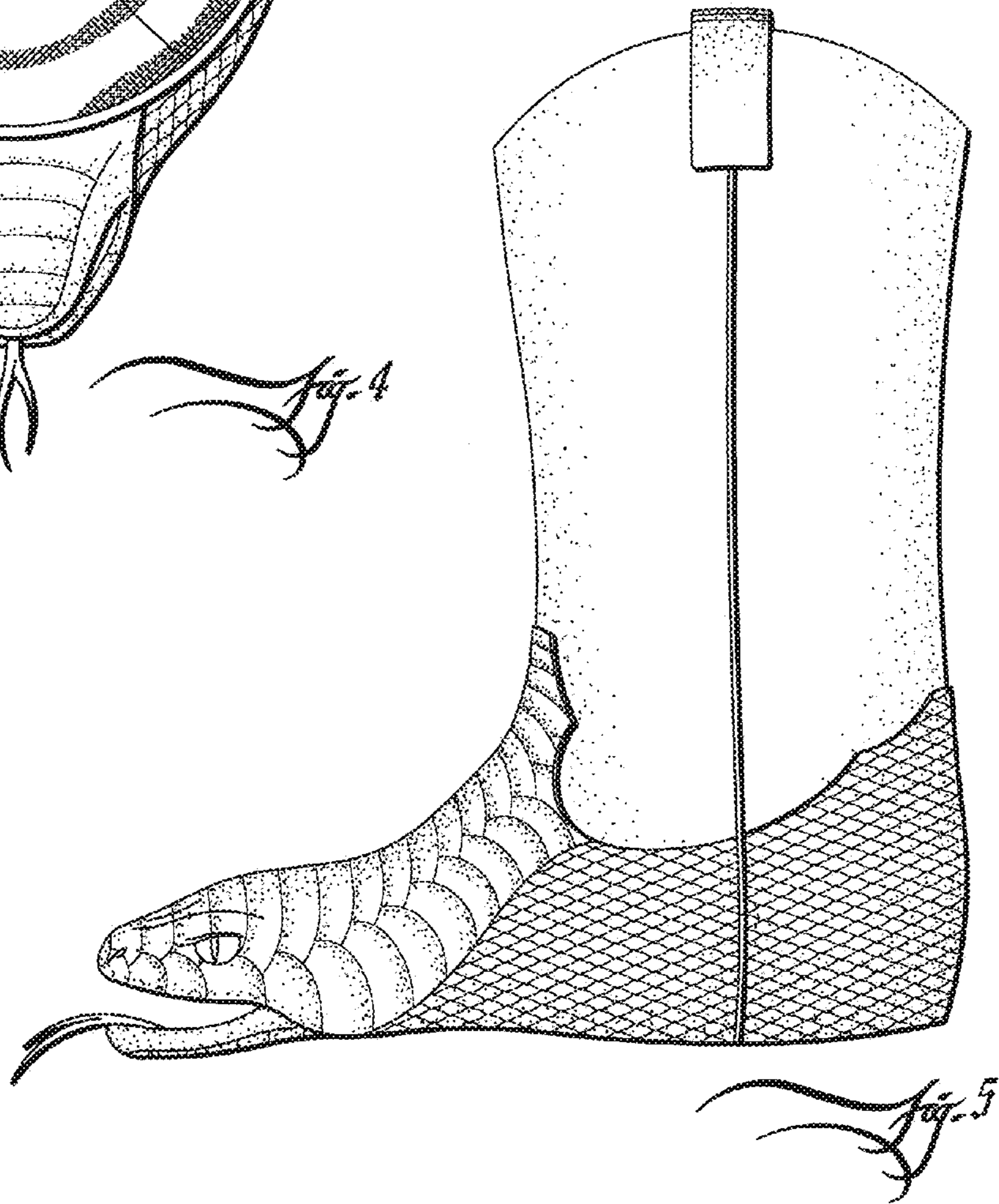

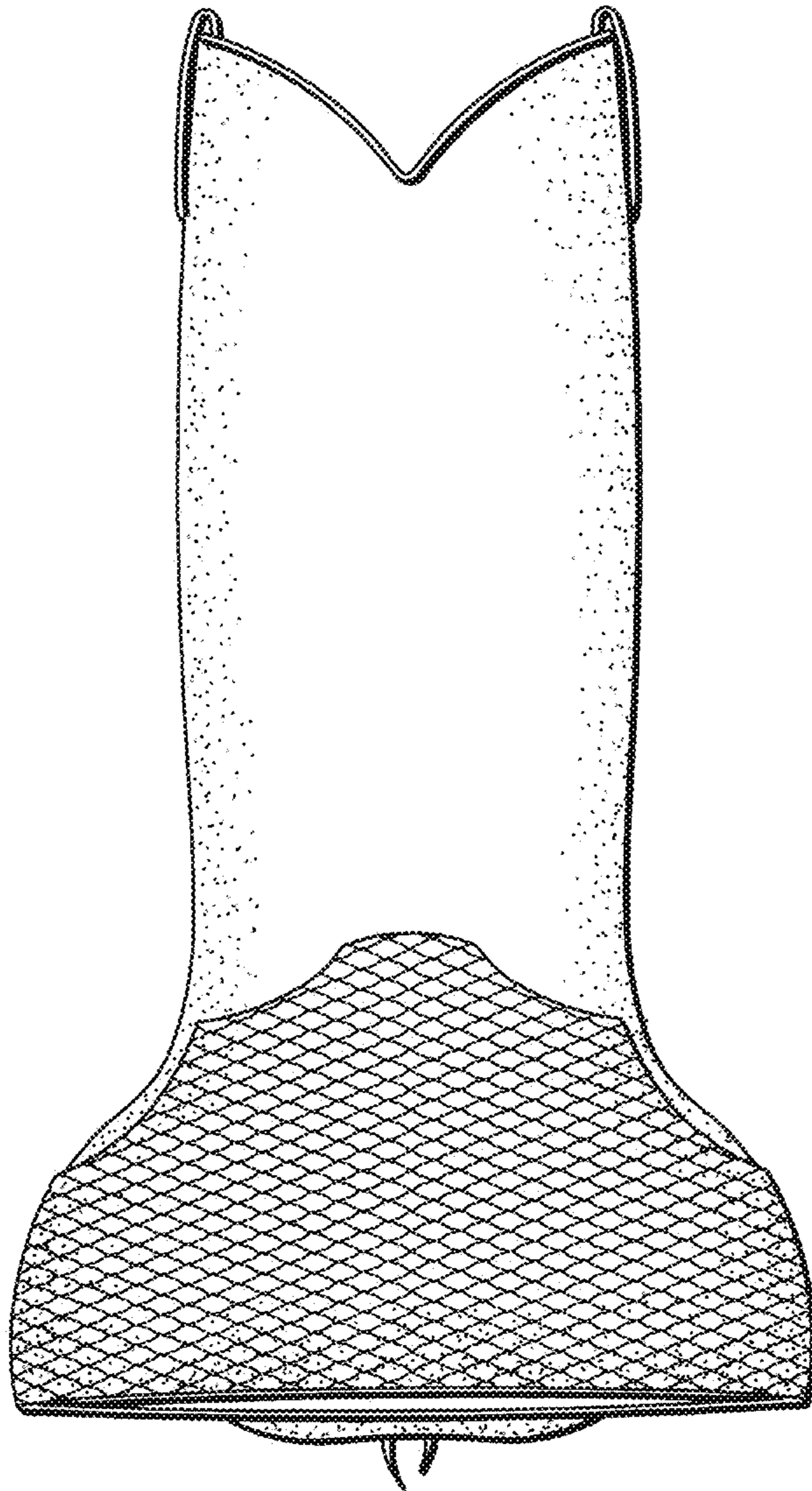
