DESCRIPTION

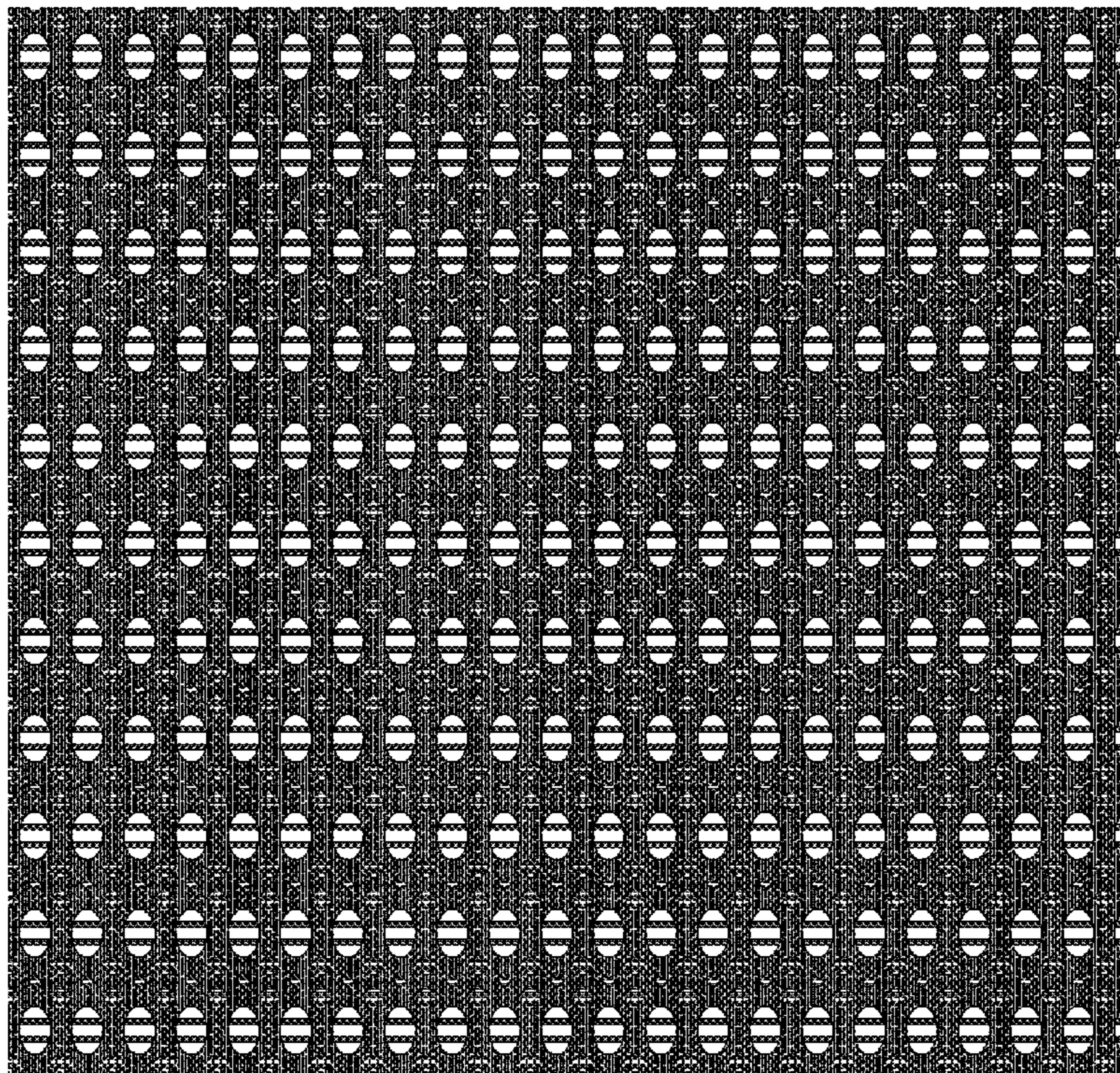
FIG. 1 is a perspective view of the mesh-chair cloth showing my new design;

 FIG. 7 is a bottom plan view thereof.

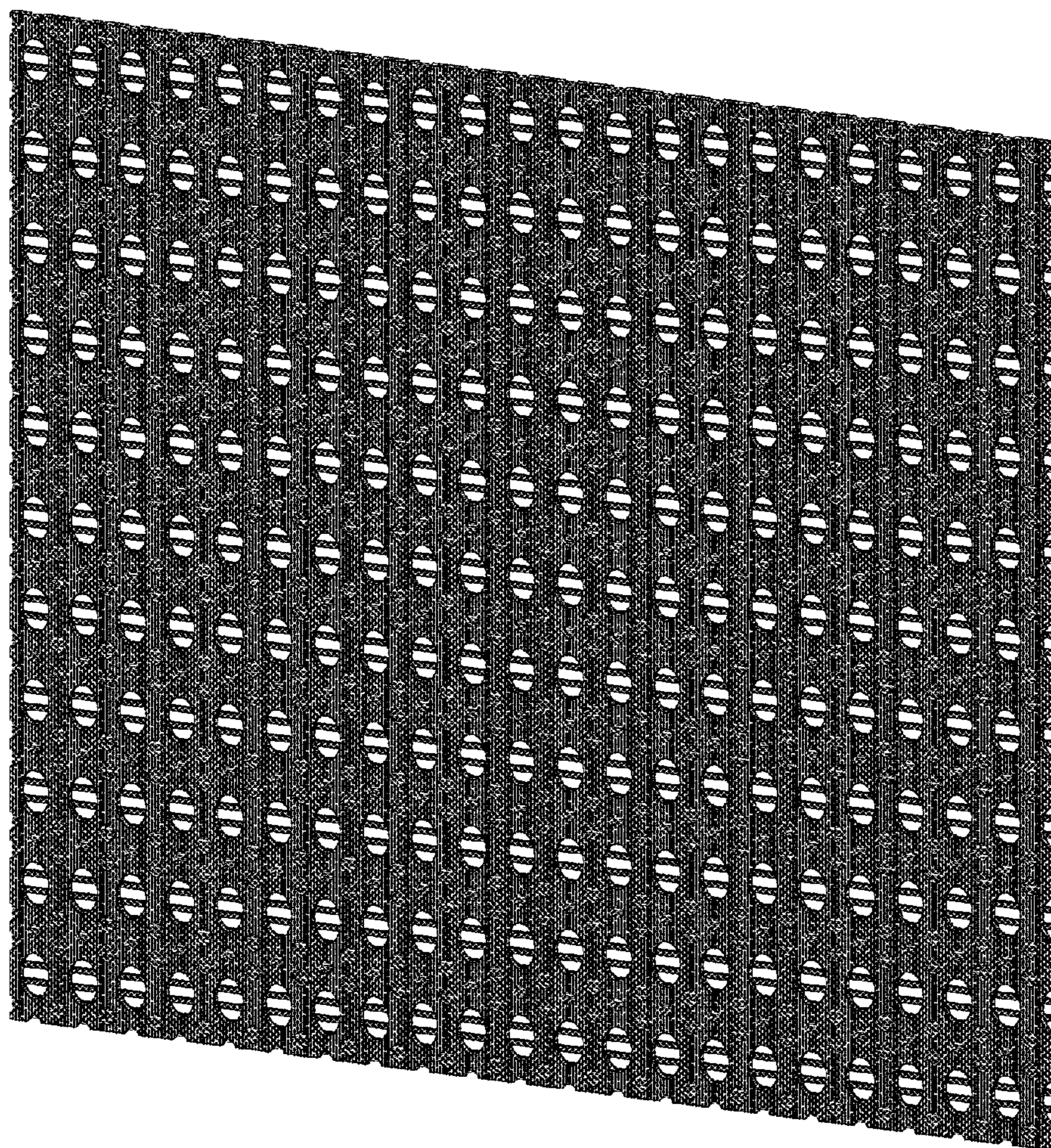

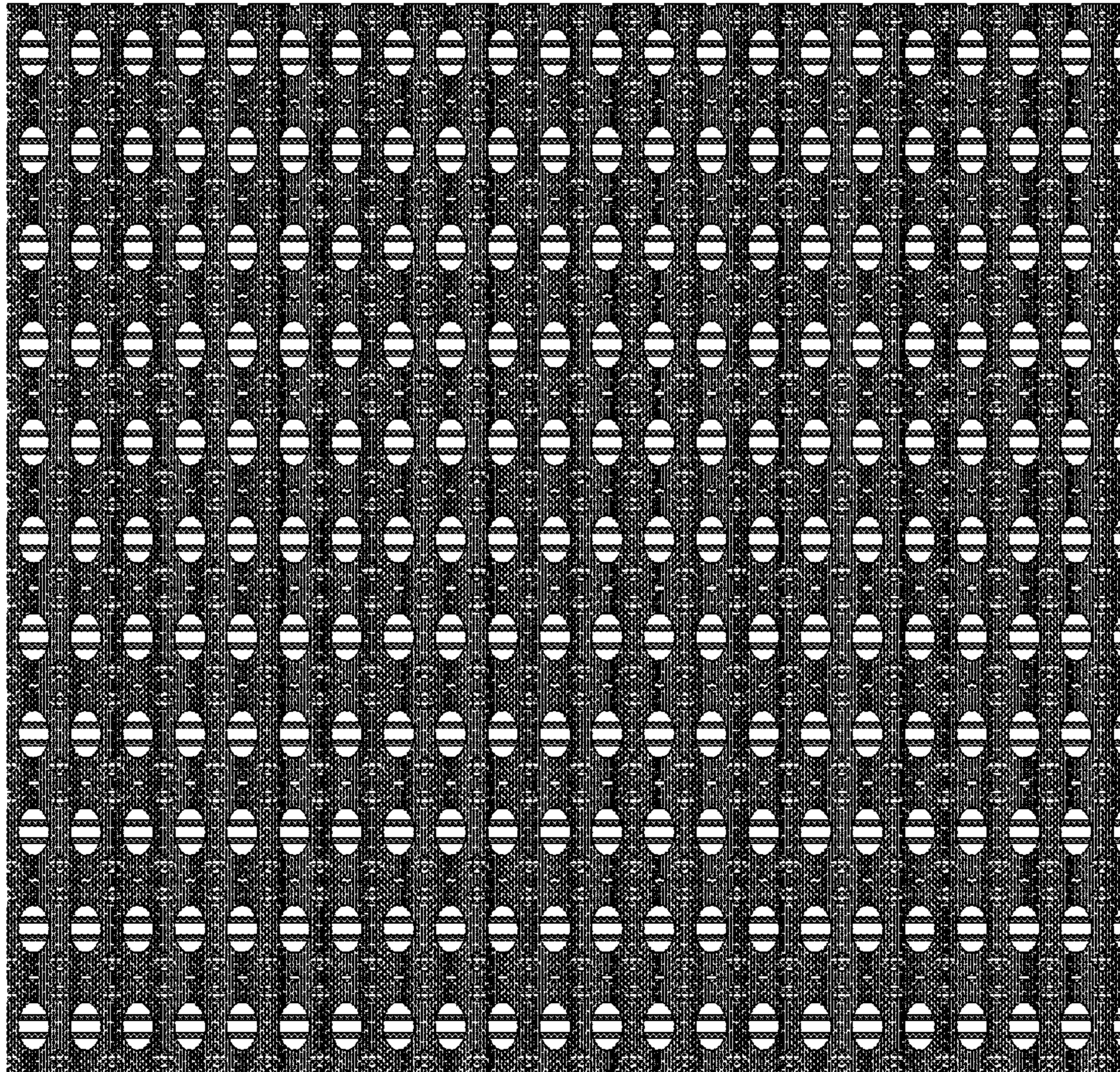

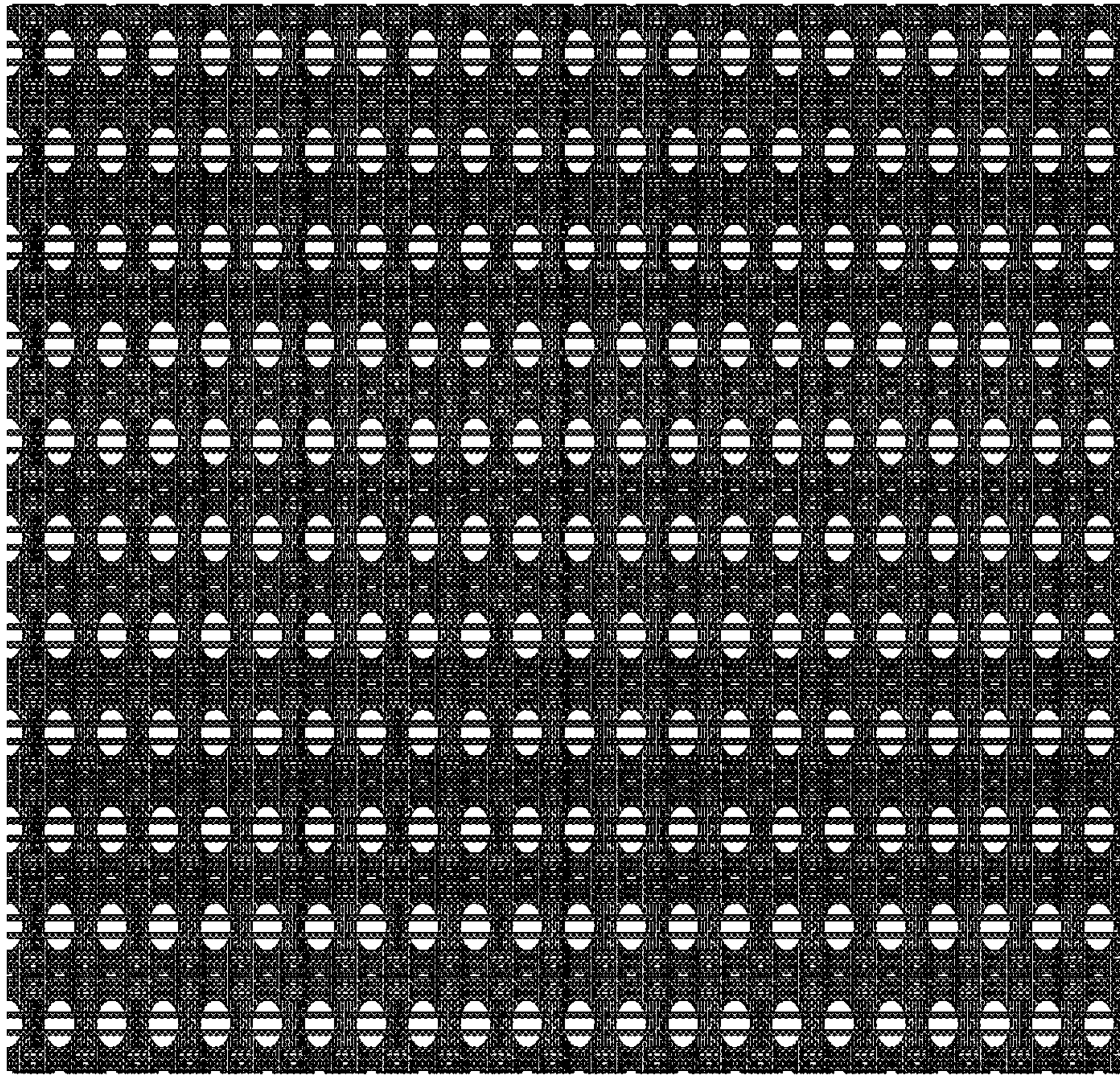

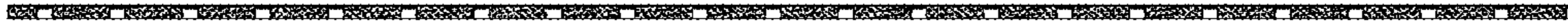
