The ornamental design for a sheet with surface pattern, as shown and described.


**DESCRIPTION**


FIG. 1 is a plan view showing the new design for a sheet with surface pattern;

FIG. 2 is an enlarged plan view of a portion of the sheet with surface pattern of FIG. 1; and,


FIG. 3 is a perspective view of a portion of the sheet with surface pattern of FIG. 1 shown in a position of use on an unclaimed sponge.

The broken line drawing of an unclaimed sponge in FIG. 3 represents unclaimed environmental subject matter and forms no part of the claimed design. The broken lines in FIGS. 1 and 2 circumscribing the area of the detail form no part of the claimed design. The thickness of the sheet with surface pattern forms no part of the claimed design.


