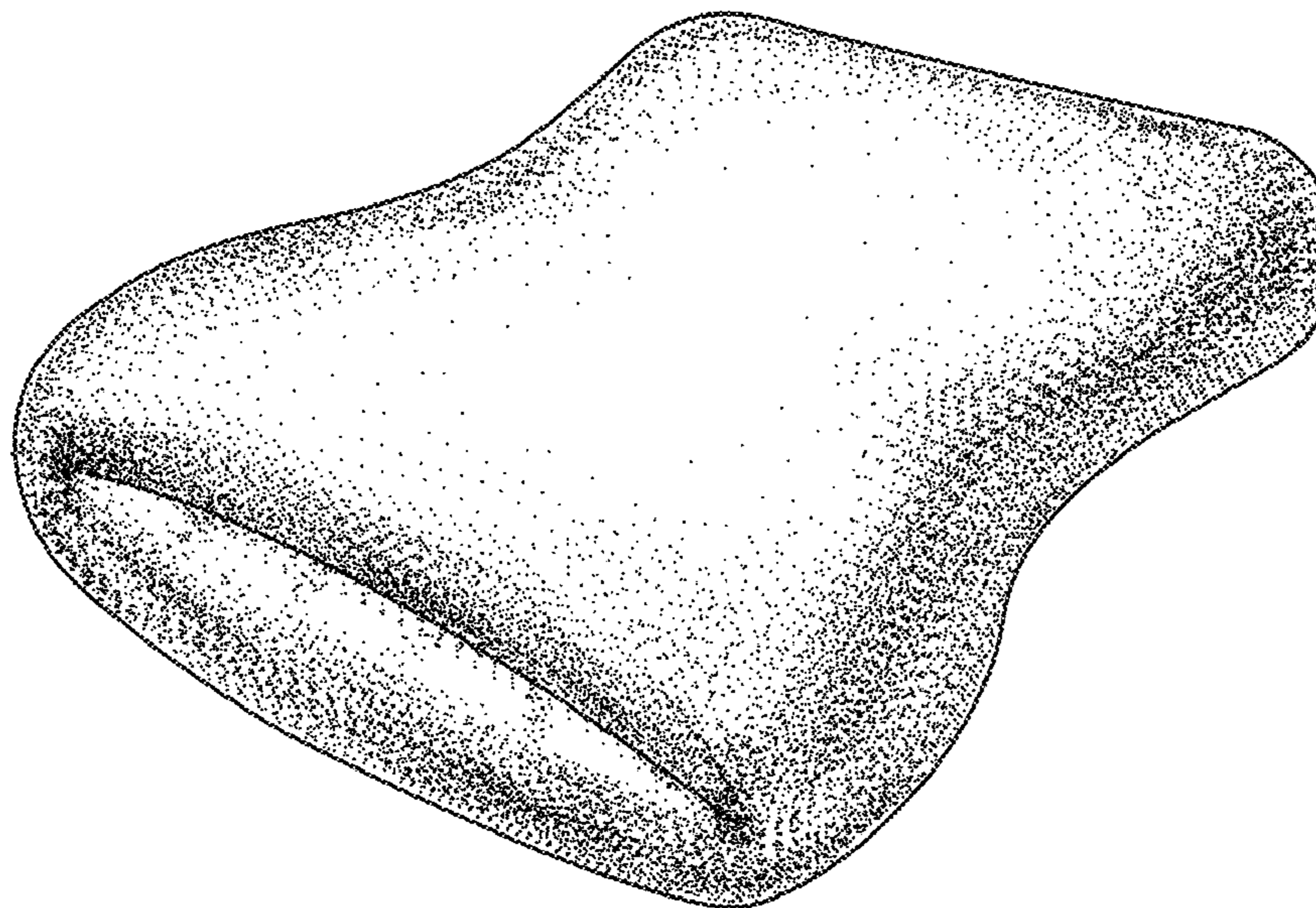
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the pillow;
FIG. 2 is a left-side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

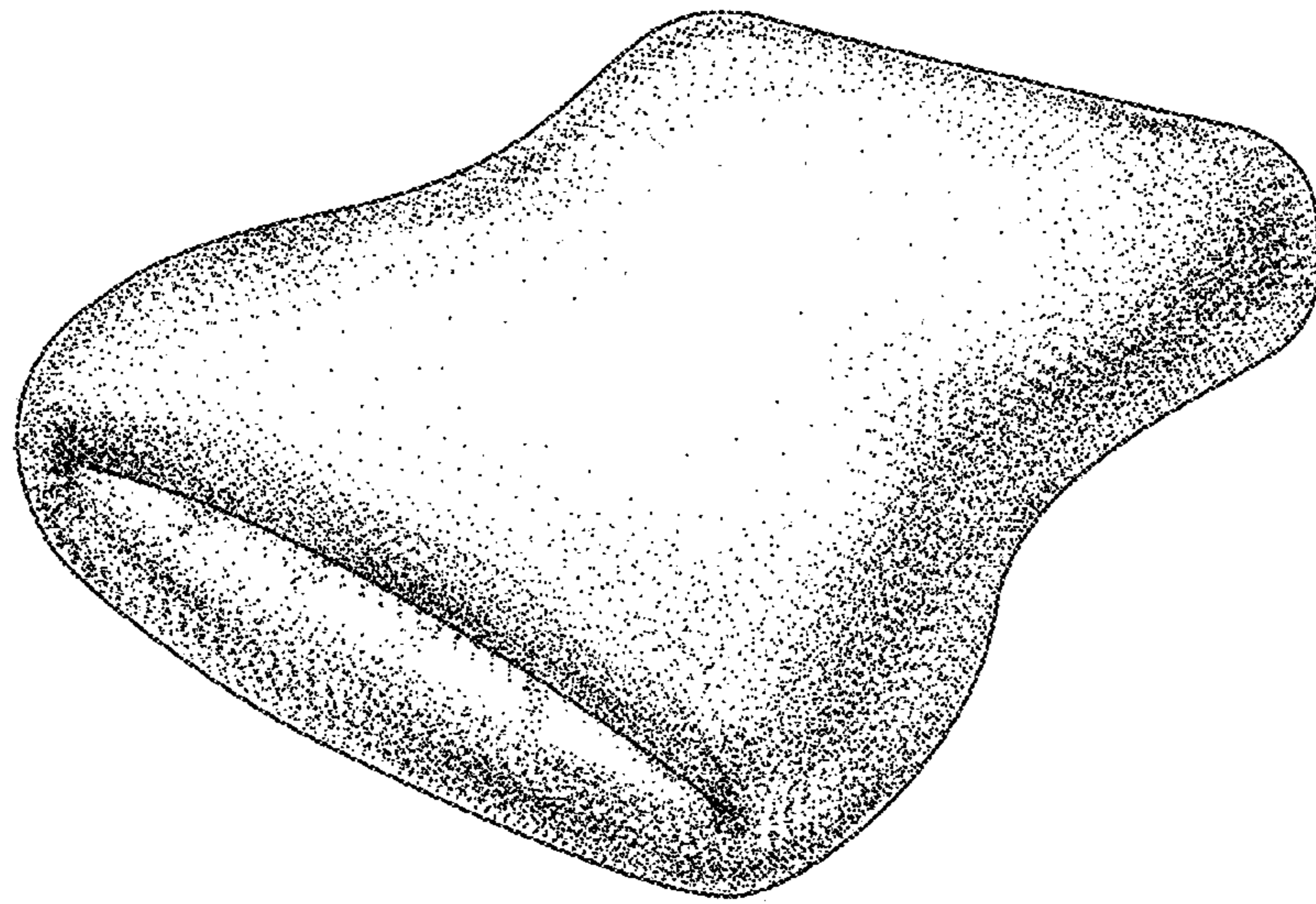

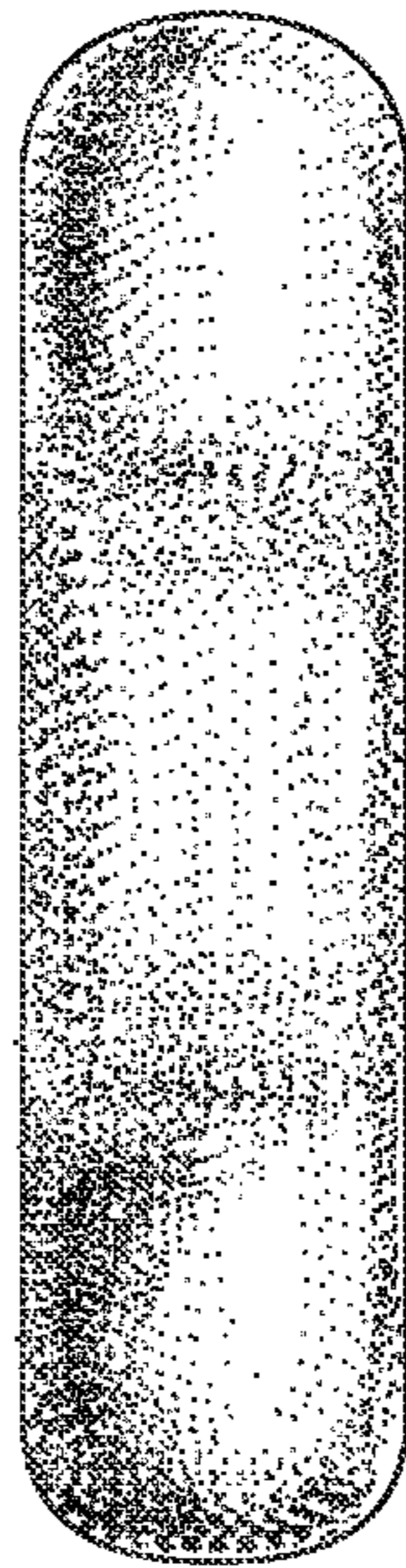

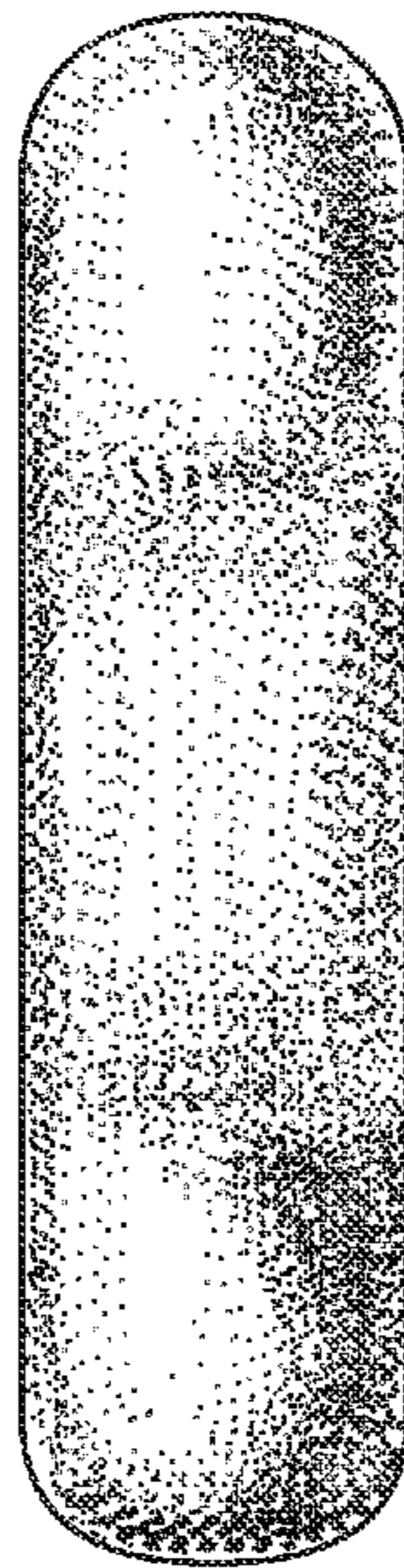

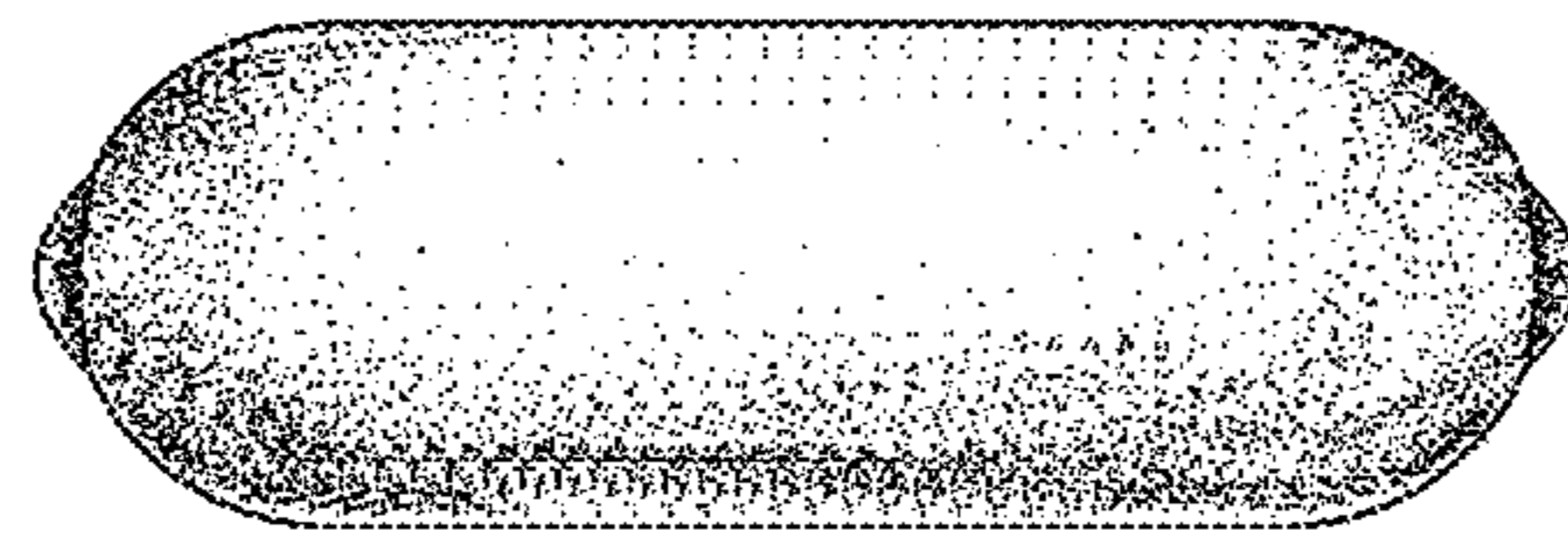

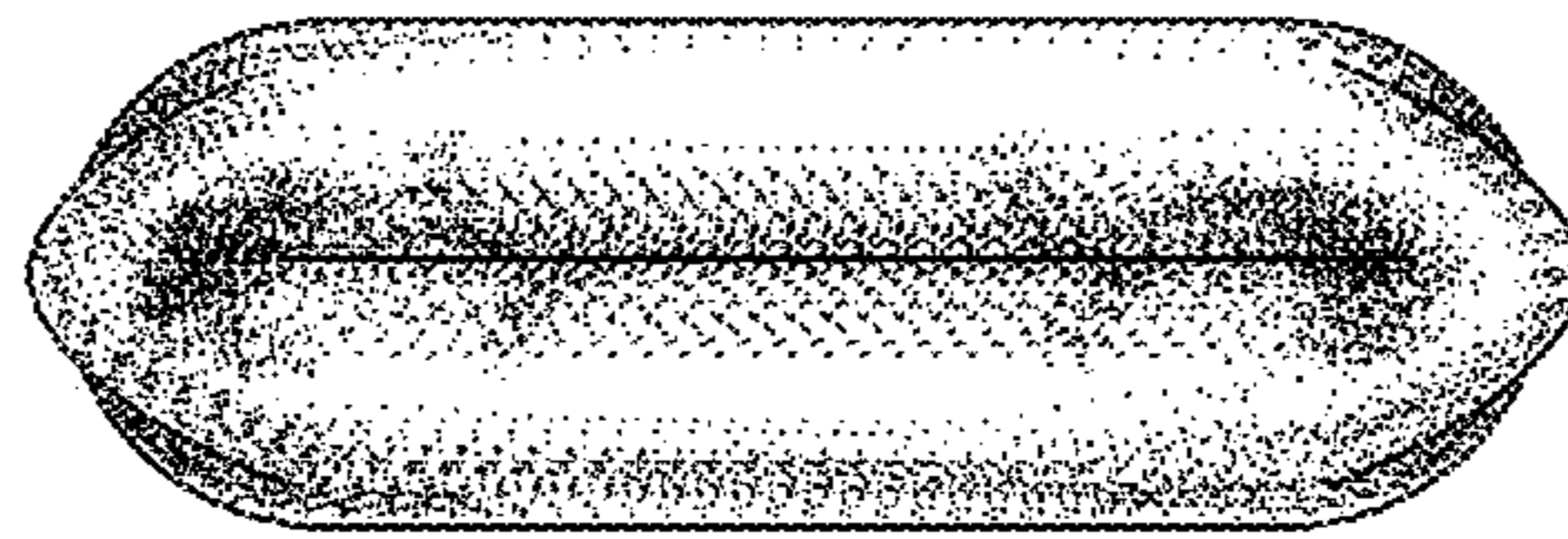

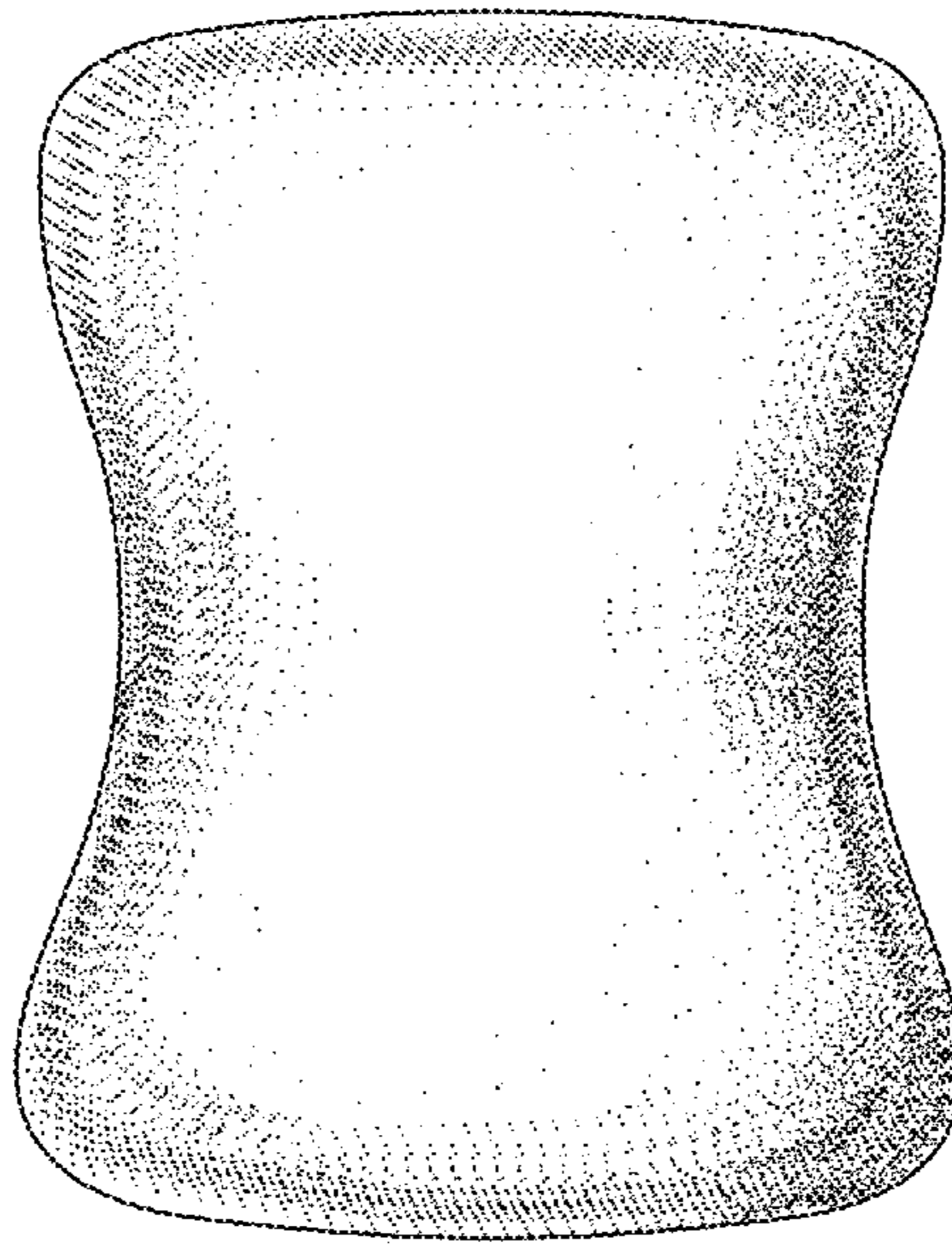

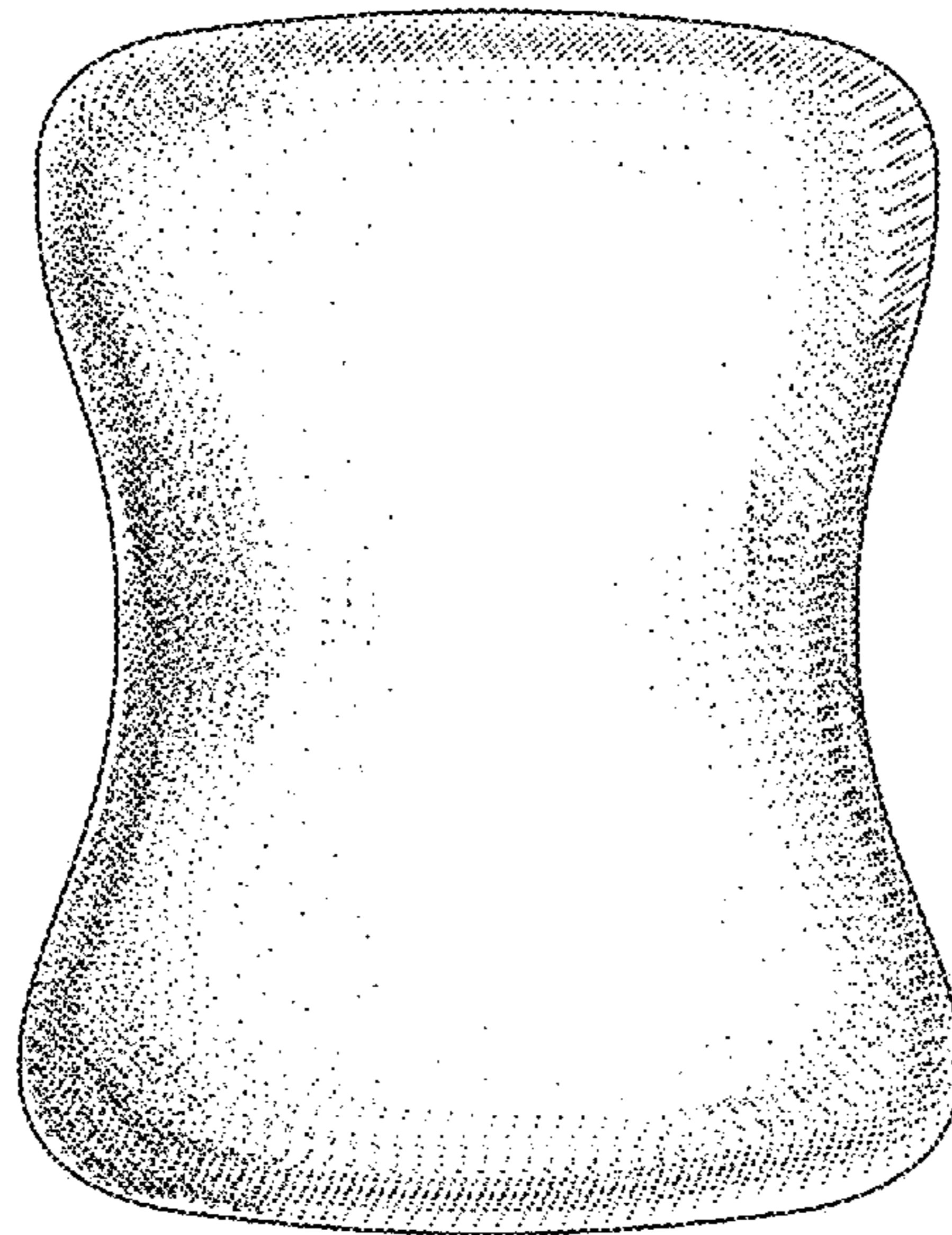

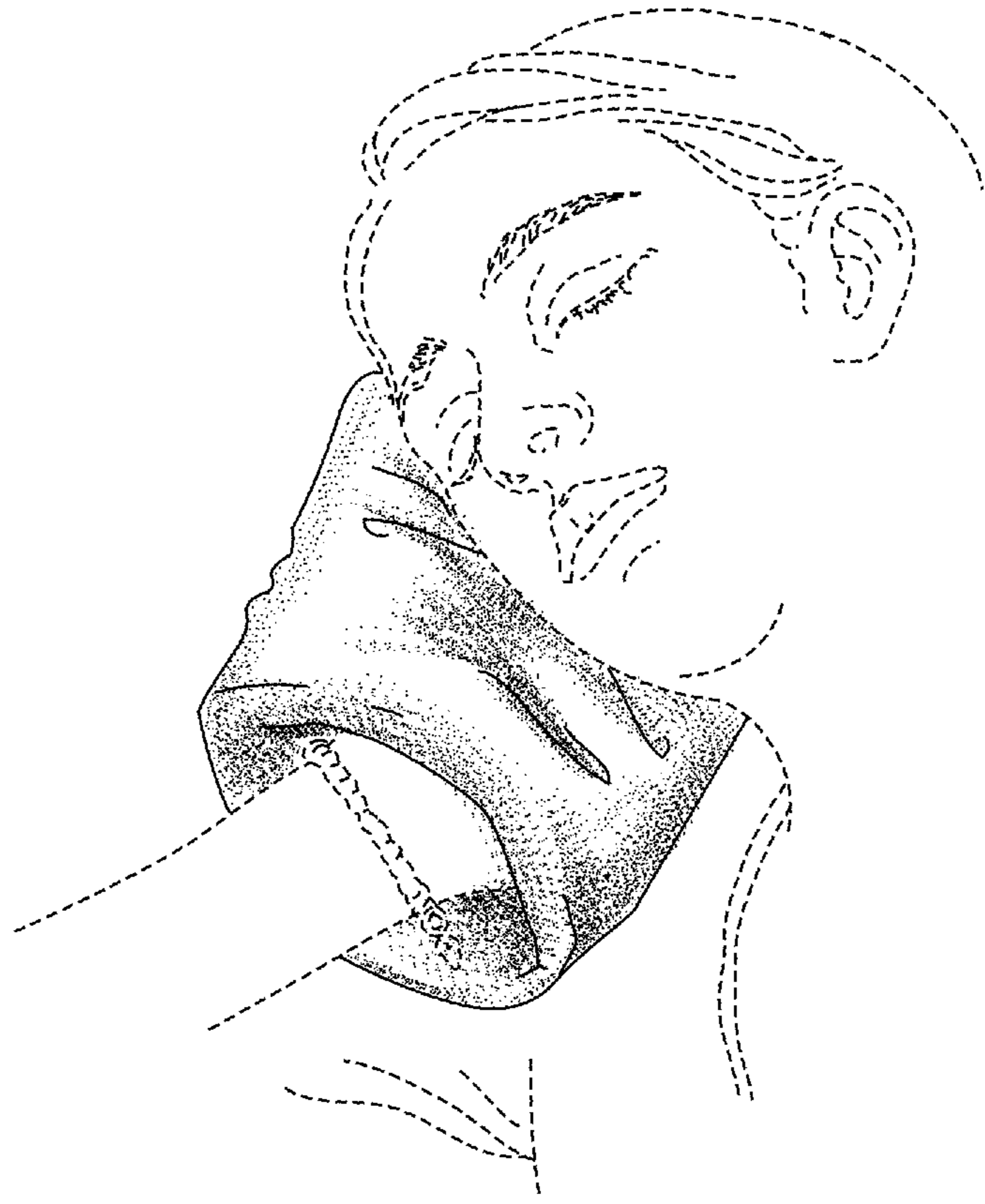

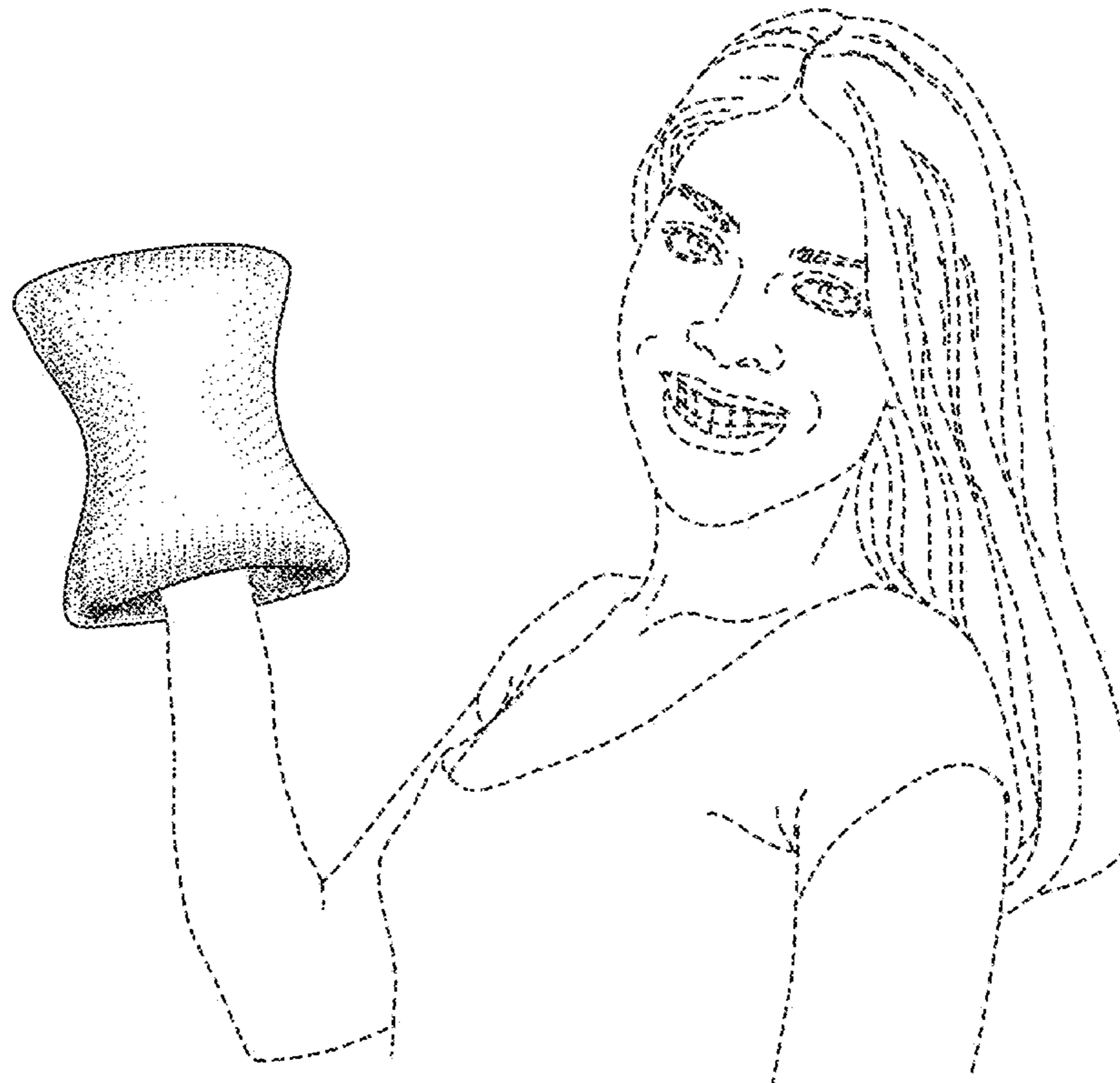
