DESCRIPTION

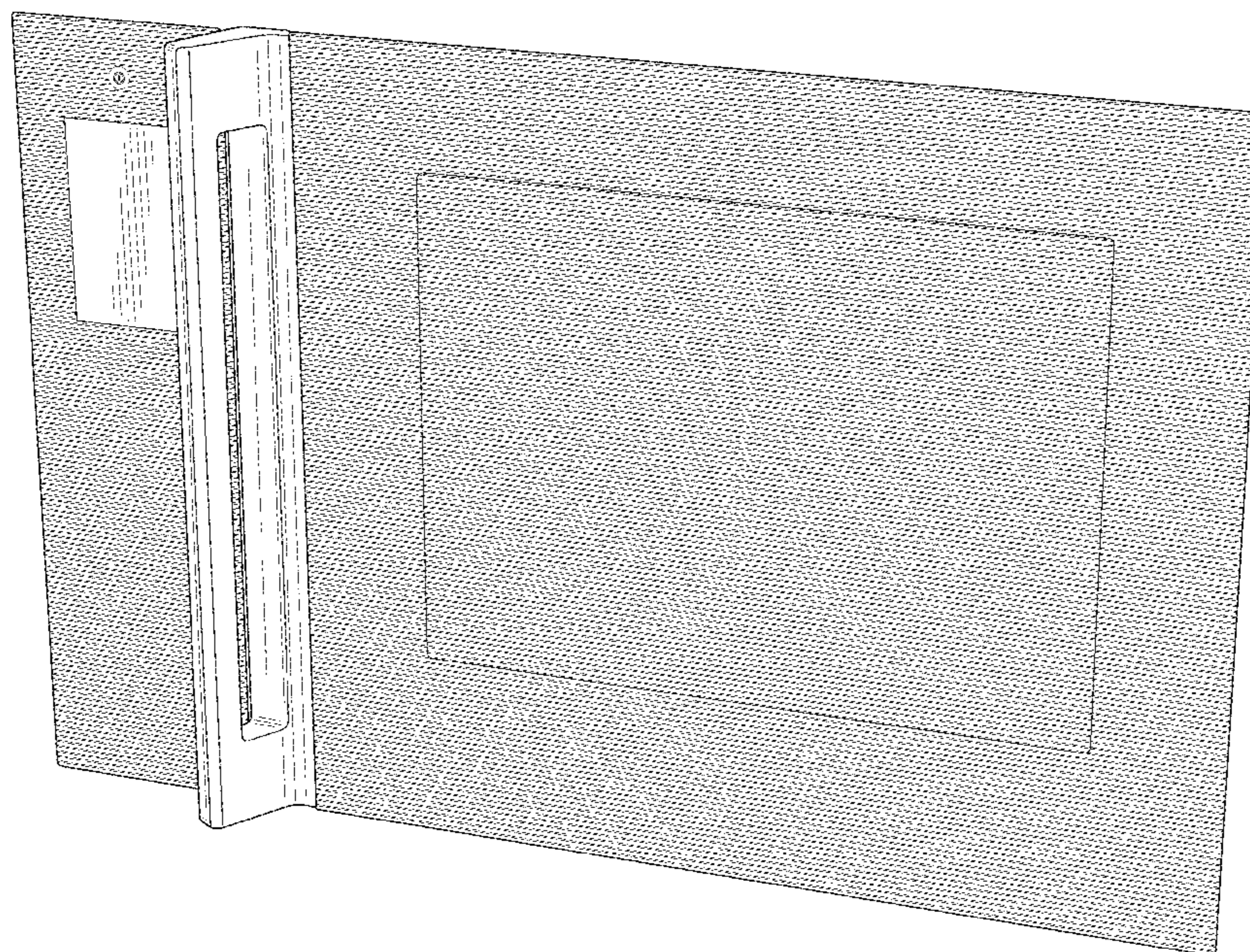
FIG. 1 is a front perspective view of a cooking appliance showing my new design;

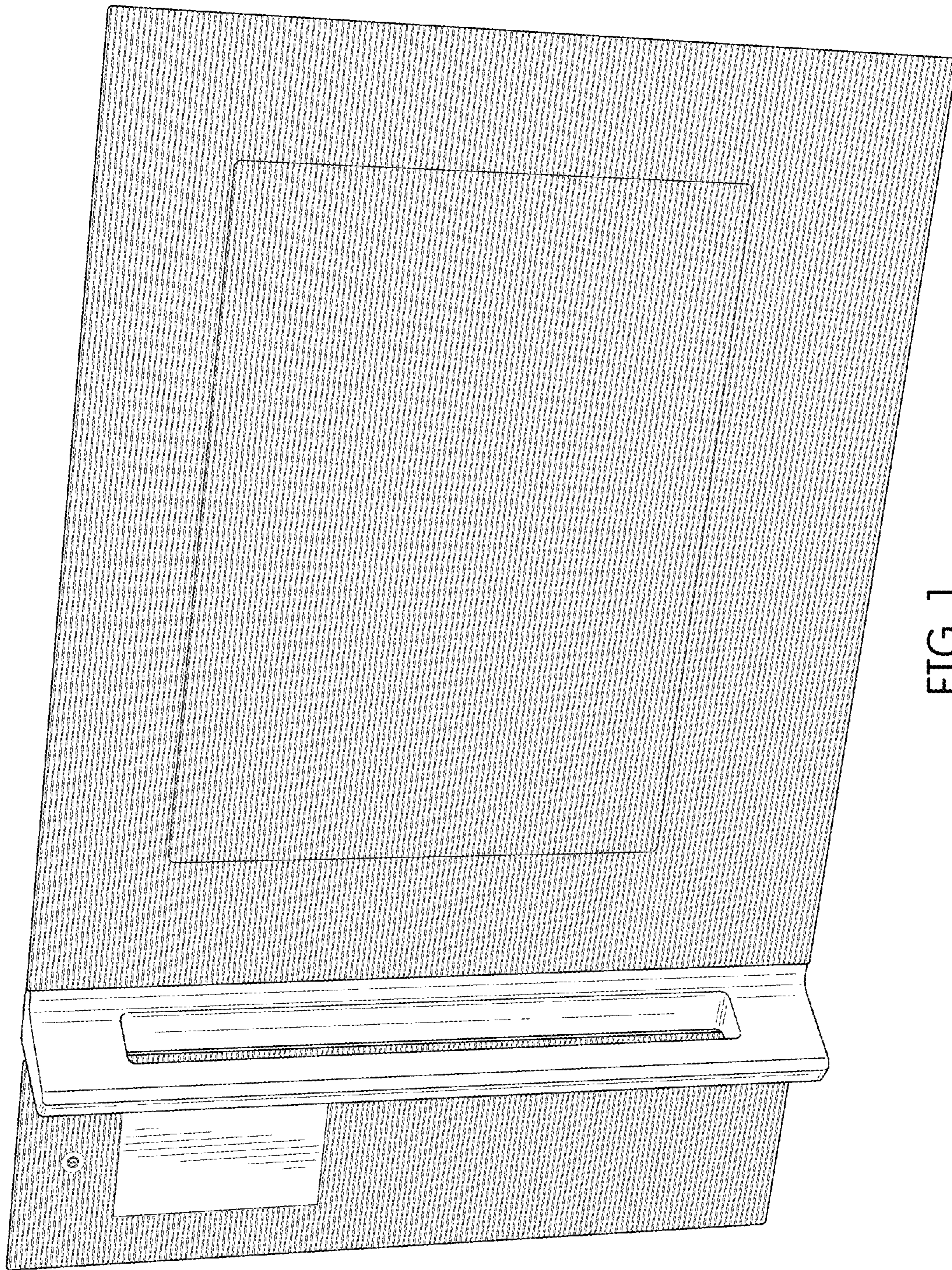

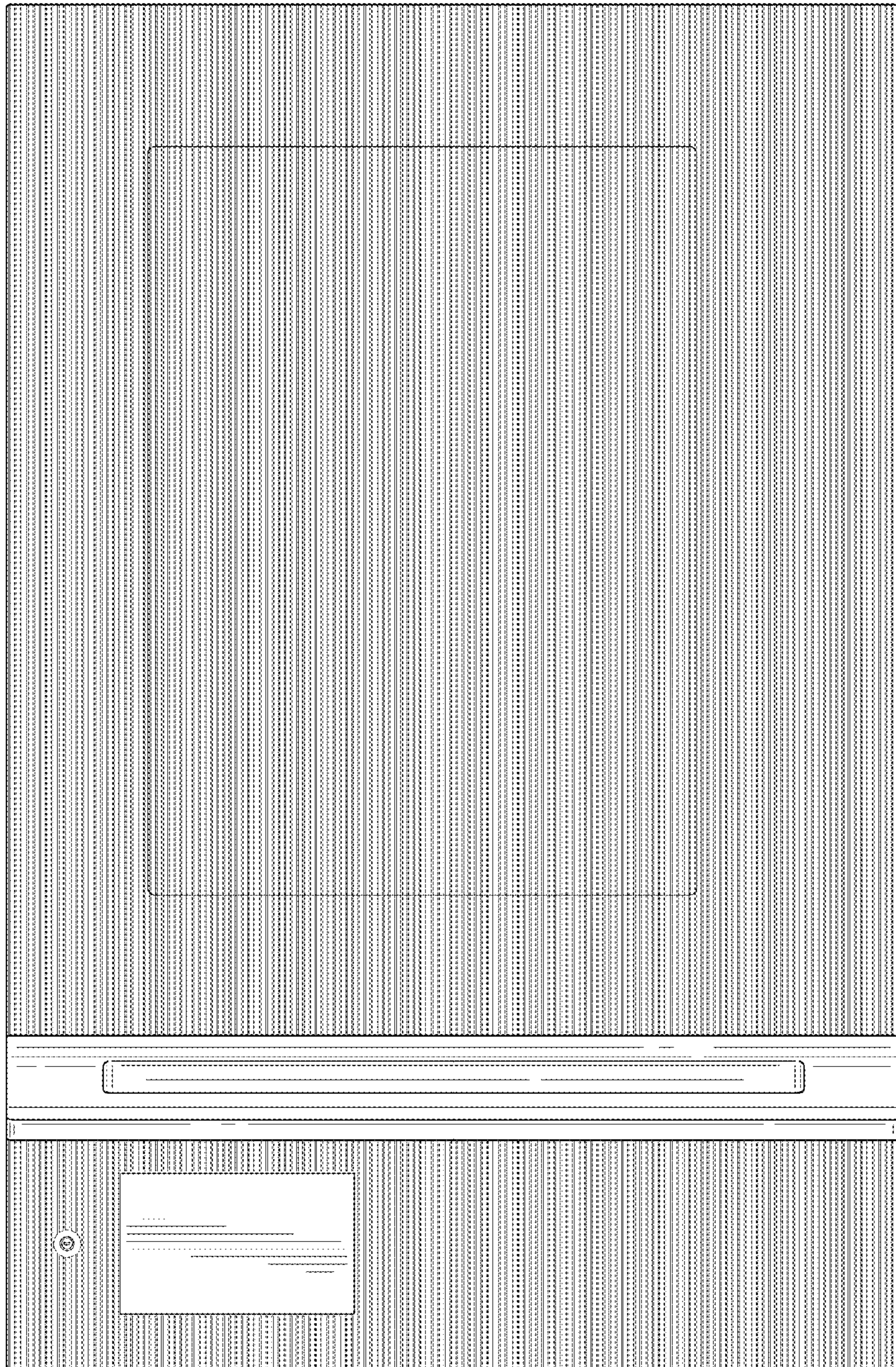

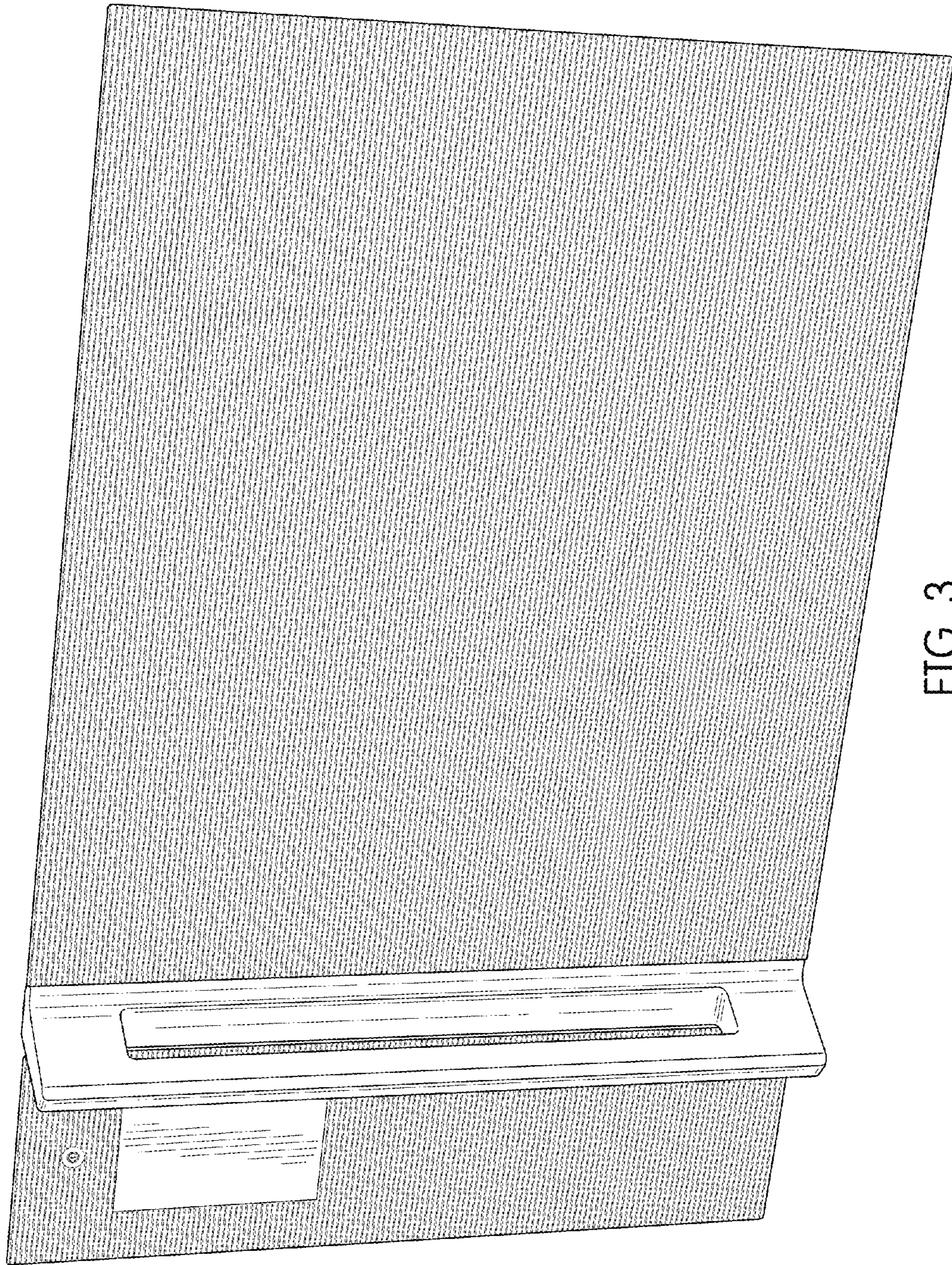

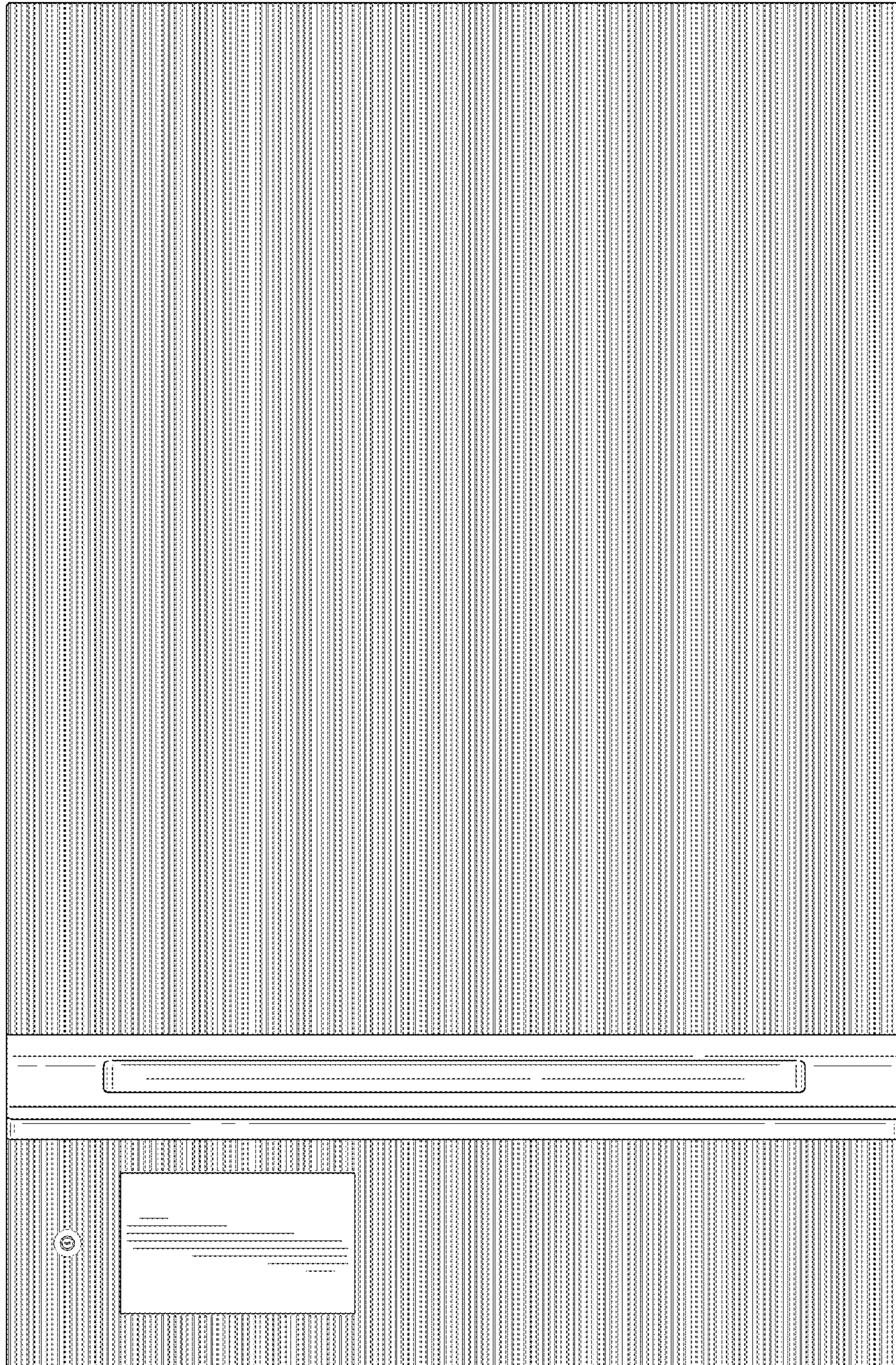
