**CLAIM**

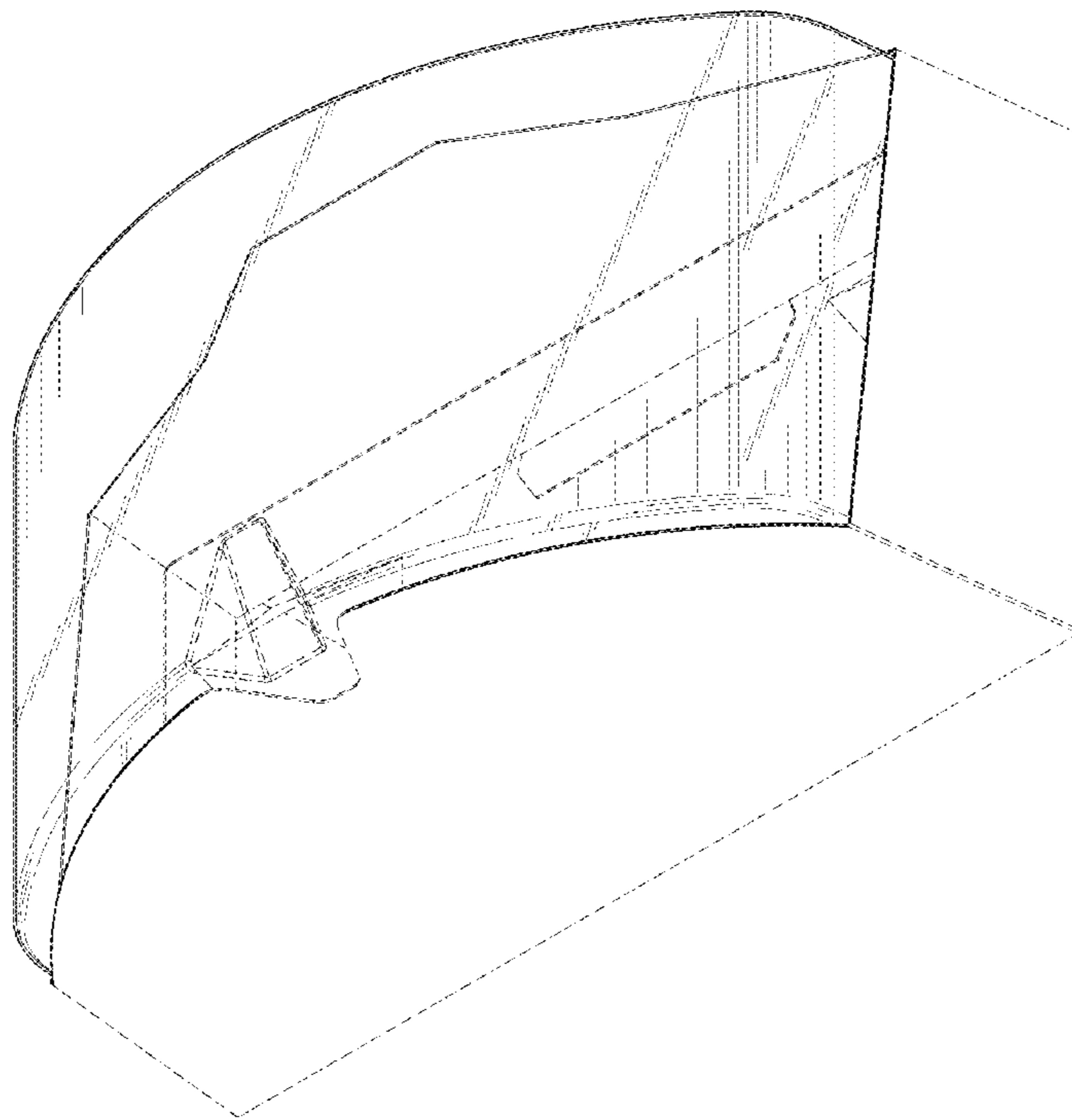
(57) The novel ornamental design for a goggle box, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a goggle box showing our novel design.  
FIG. 2 is a front view of the goggle box shown in FIG. 1  
FIG. 3 is a right side view of the goggle box shown in FIG. 1. The left side view, not shown, is a mirror image.  
FIG. 4 is a rear view of the goggle box shown in FIG. 1.  
FIG. 5 is a top view side view of the goggle box shown in FIG. 1; and,  
FIG. 6 is a bottom view of the goggle box shown in FIG. 1.  
Broken lines showing features of the box are for illustrative purposes only and form no part of the claimed design.

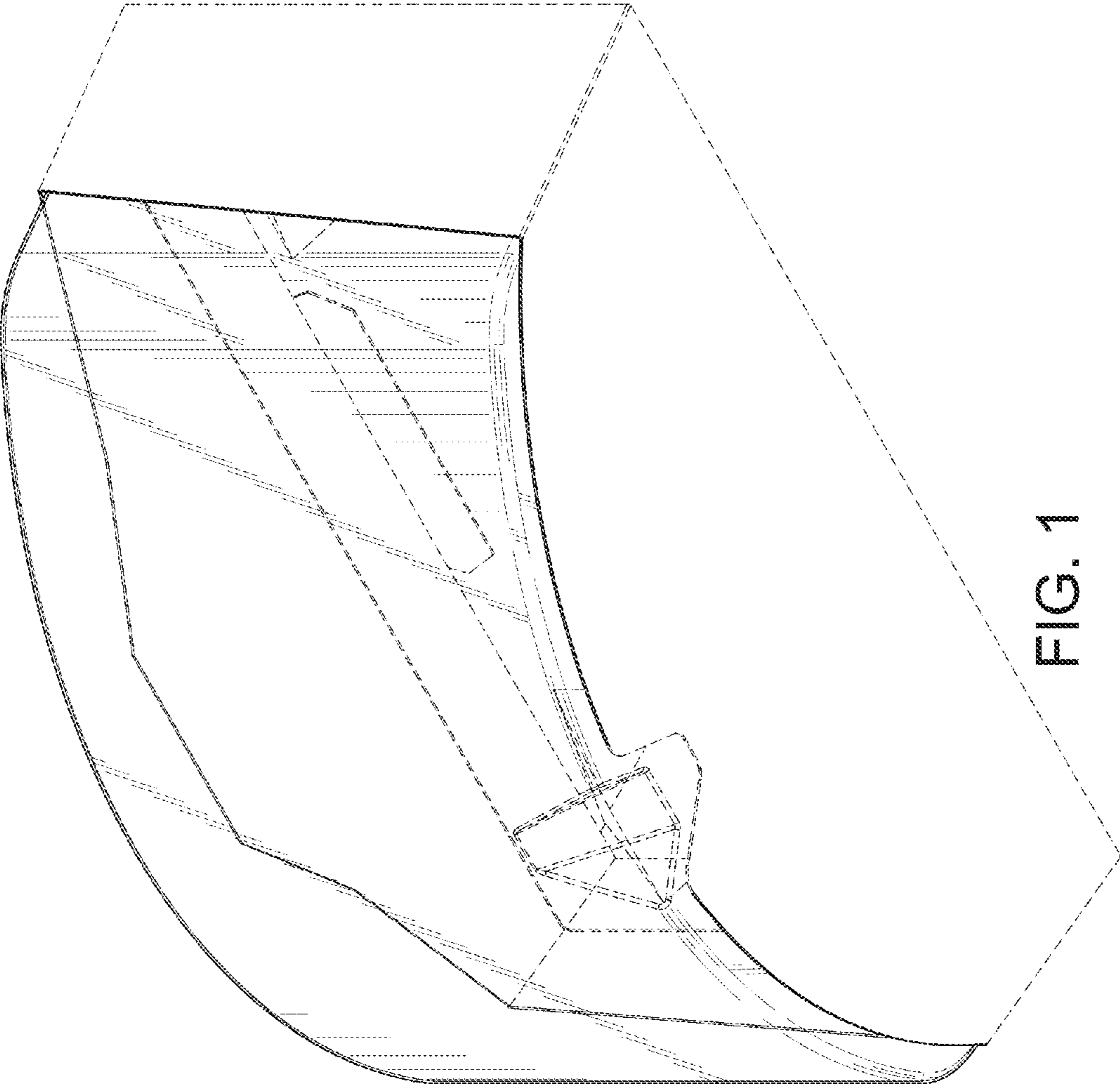

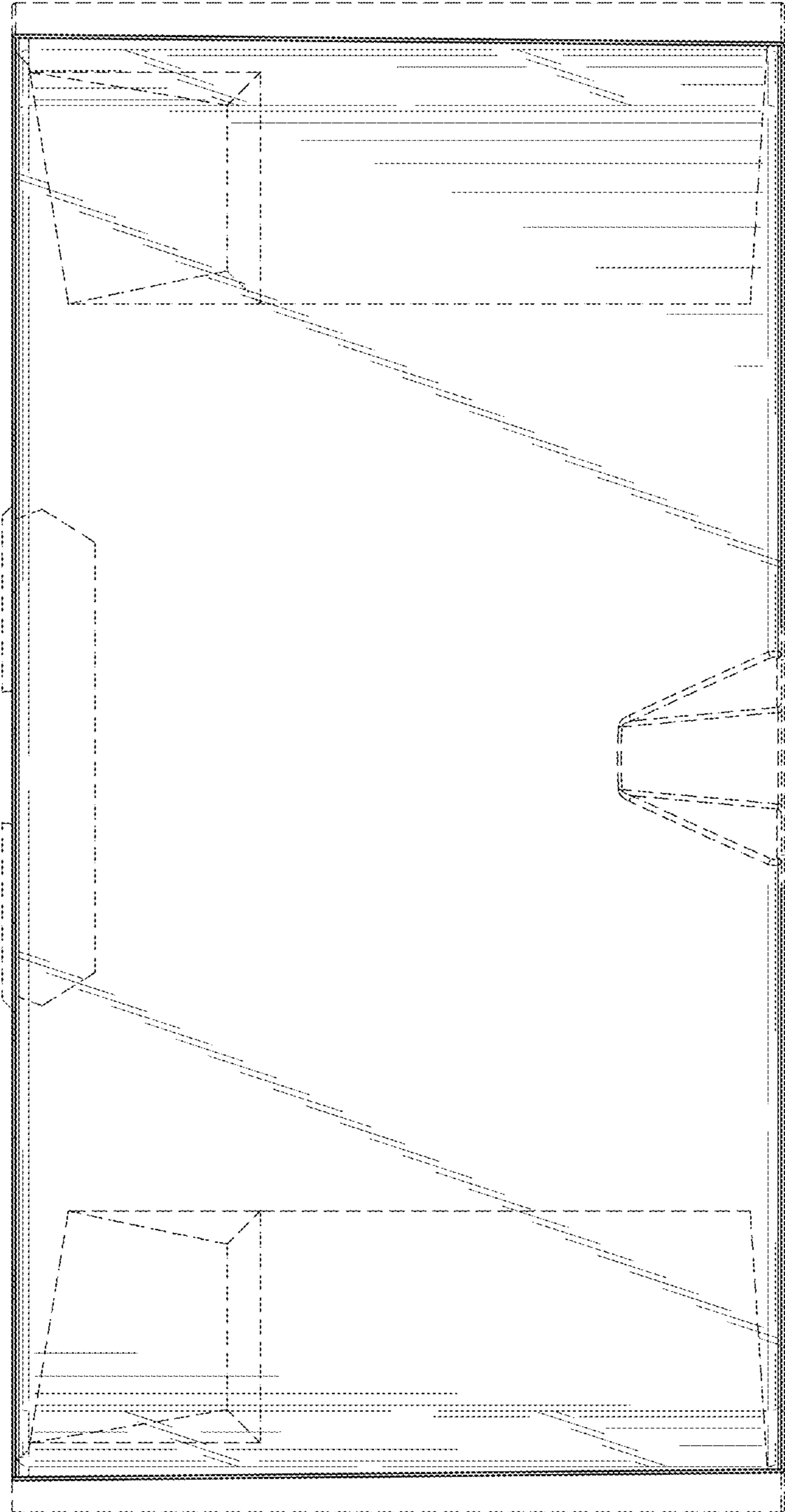

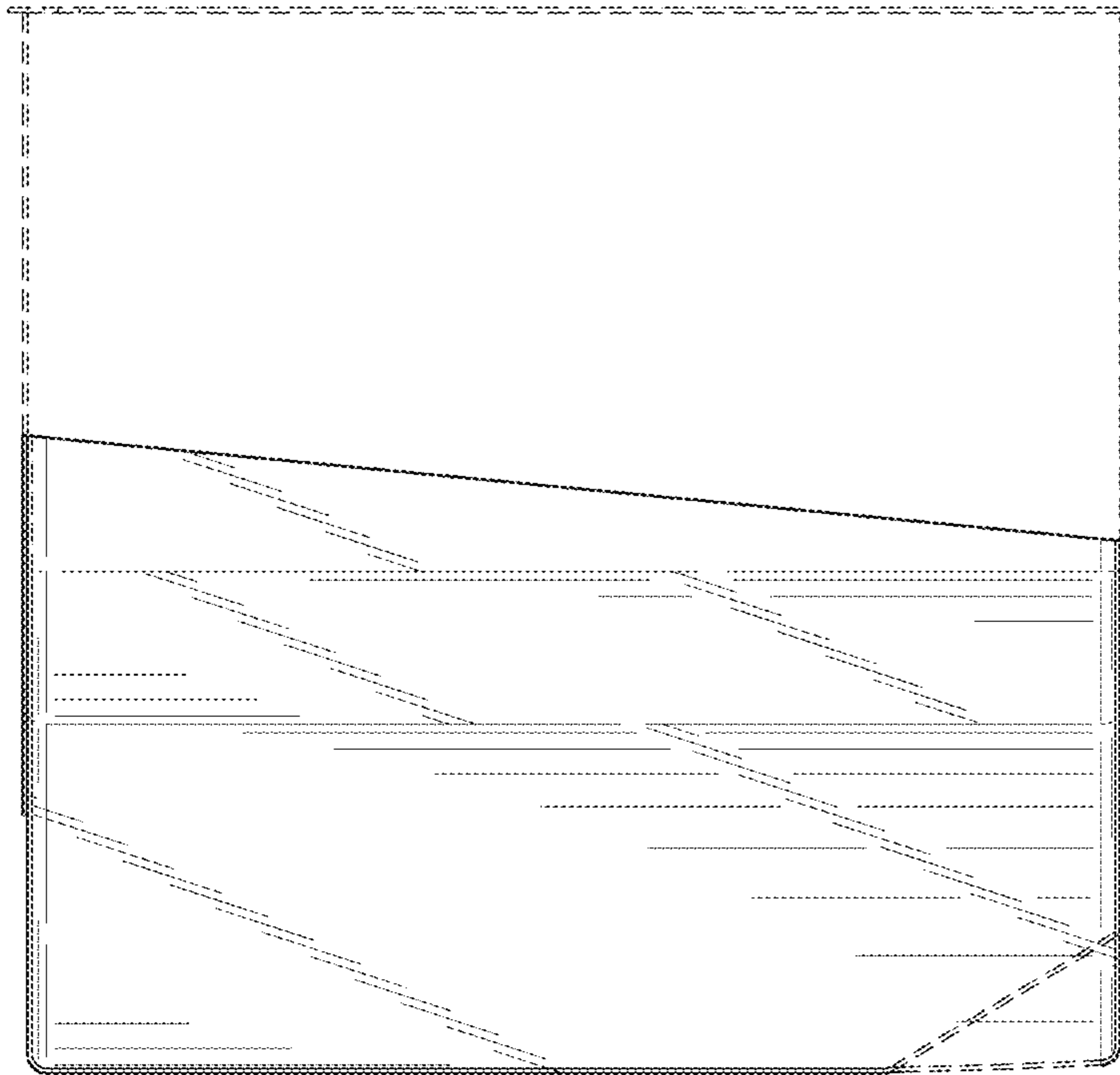

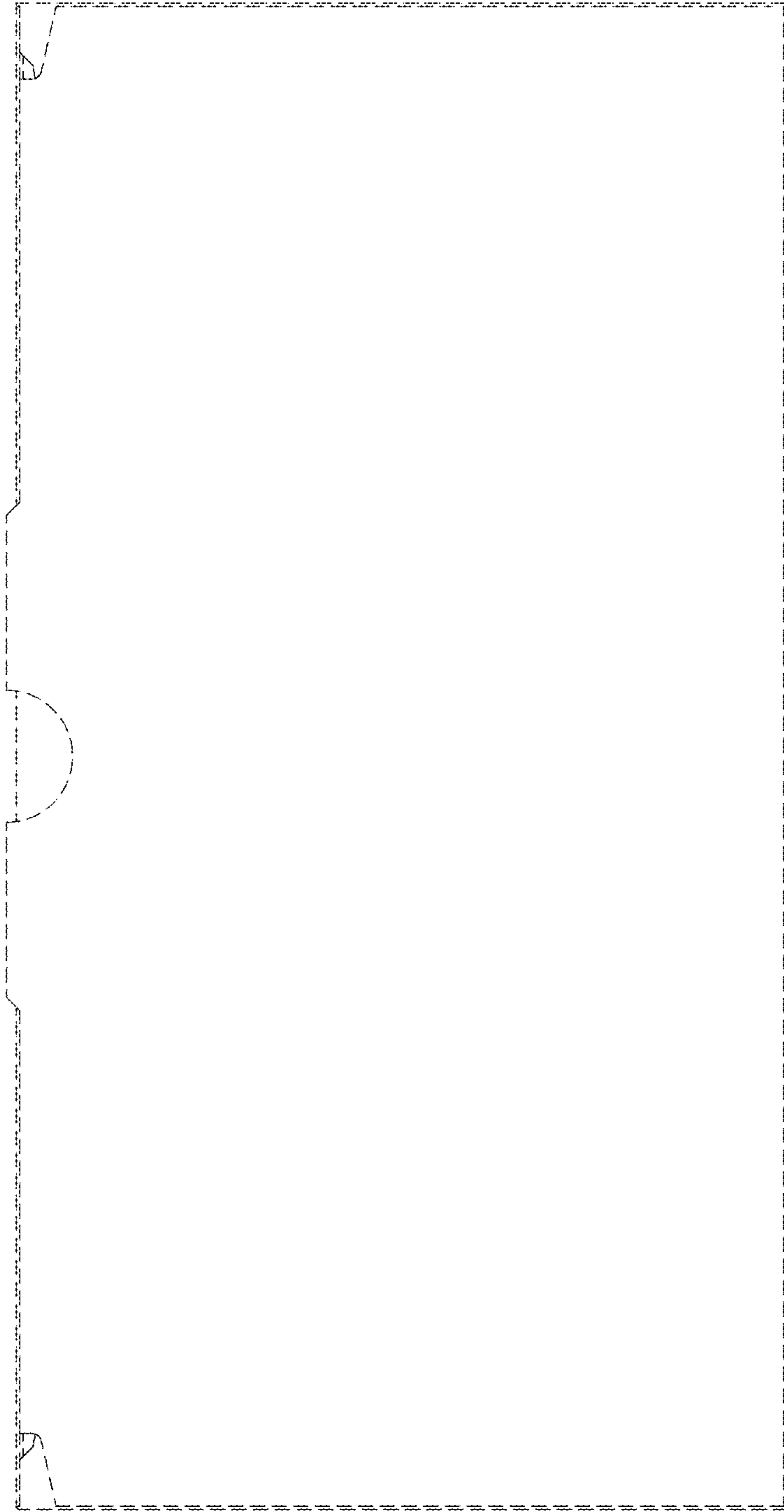

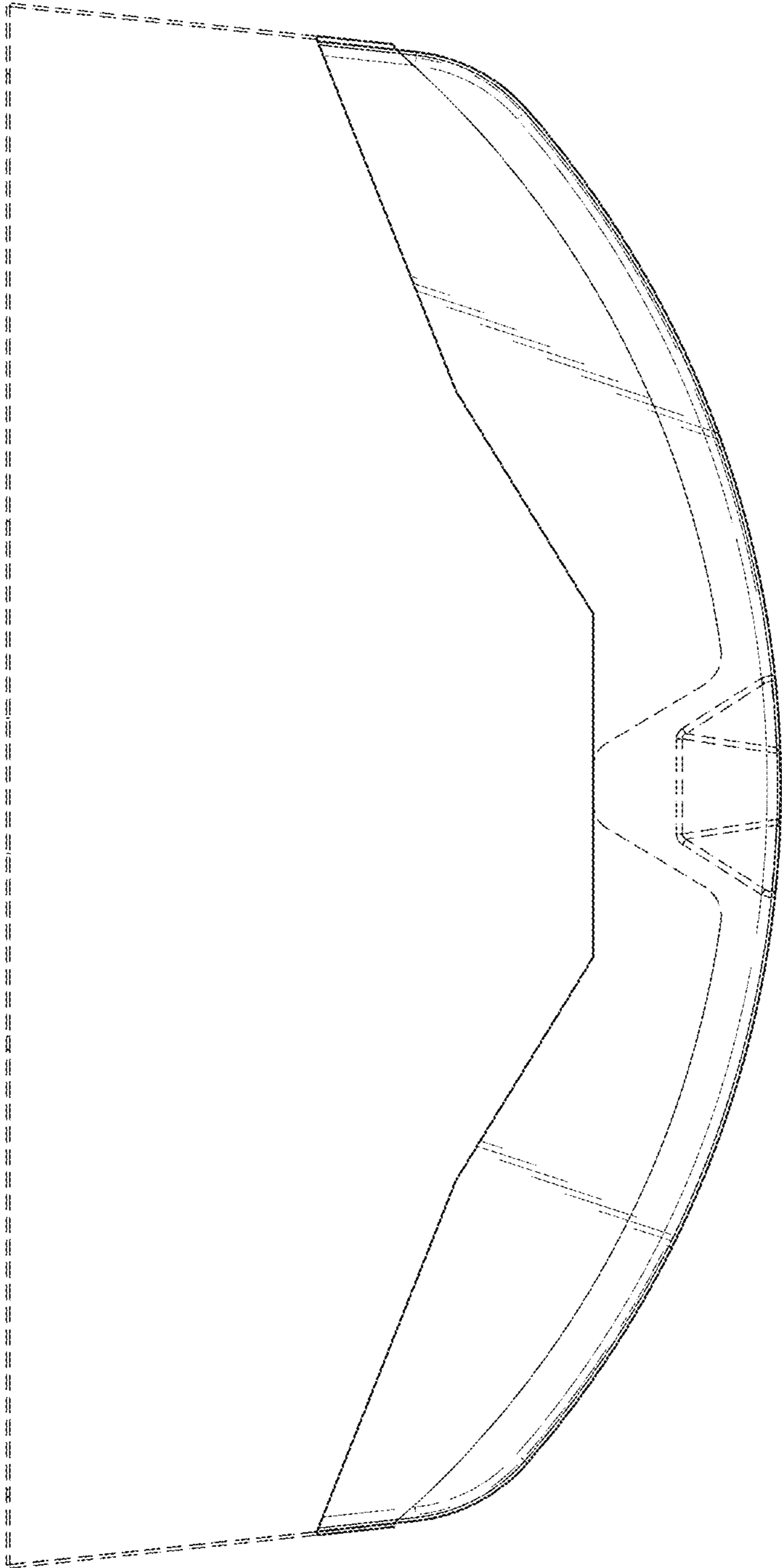

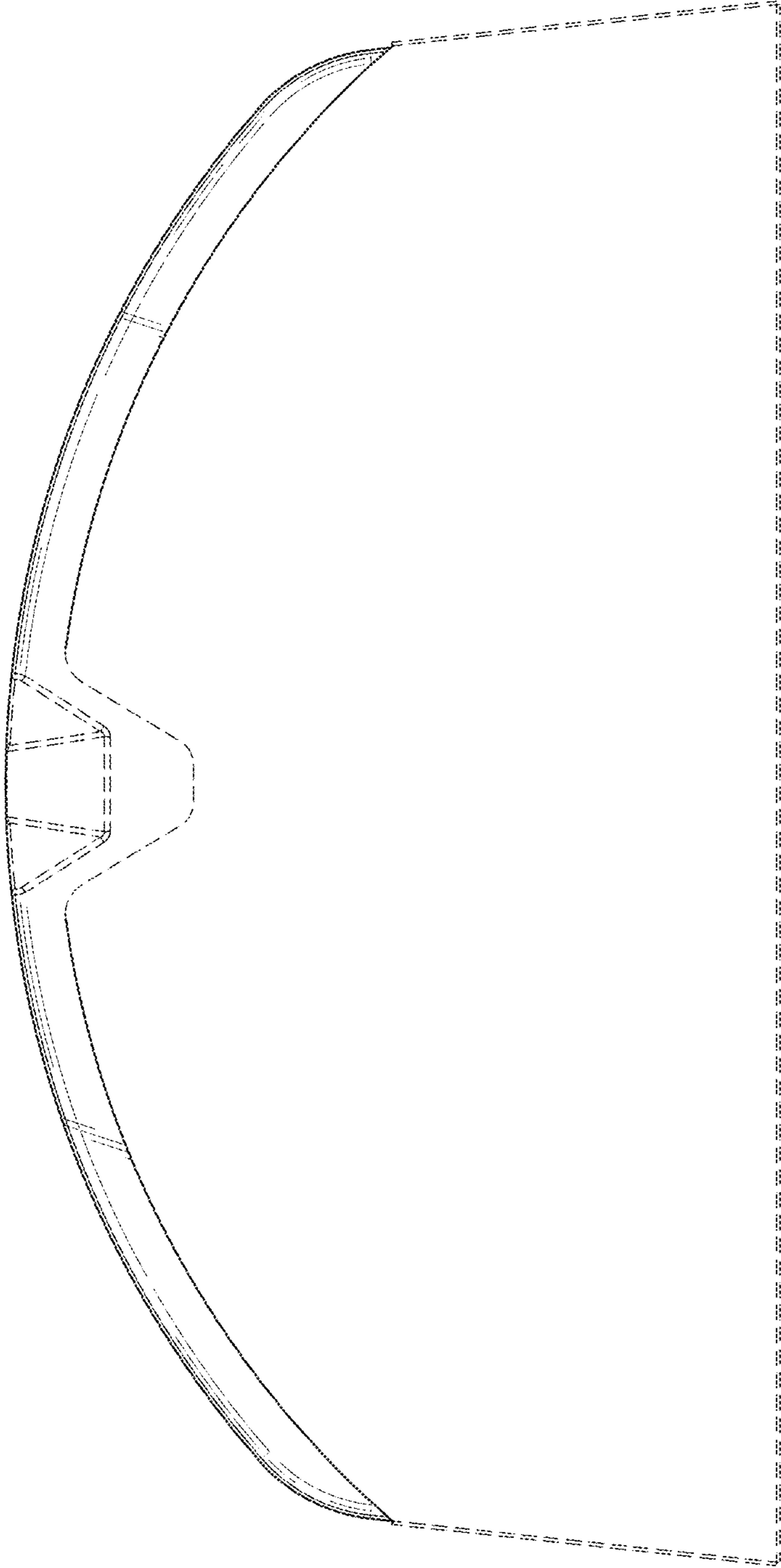
