FIG. 4 is a left-side view of the container for toiletries of FIG. 1.

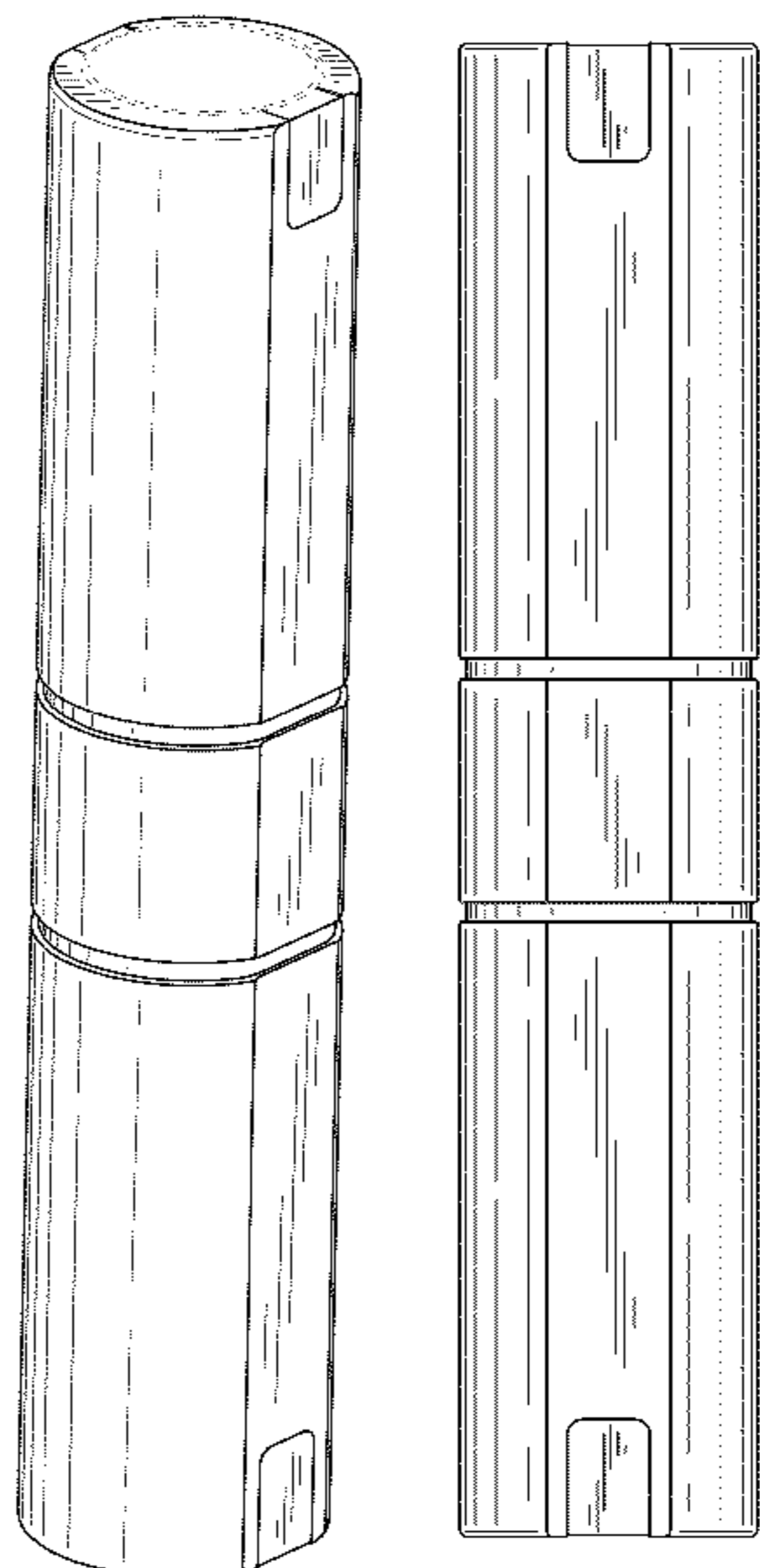
FIG. 5 is a right-side view of the container for toiletries of FIG. 1.

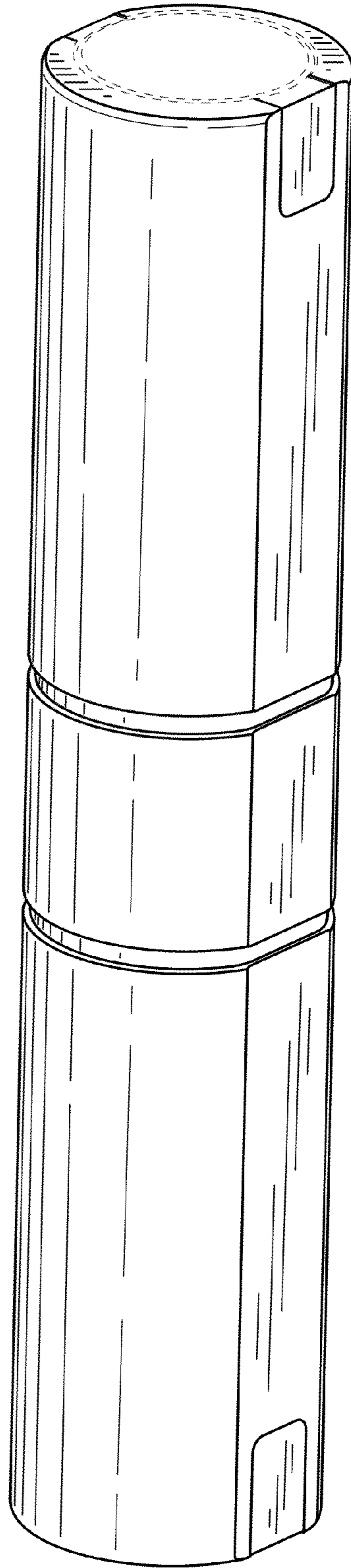

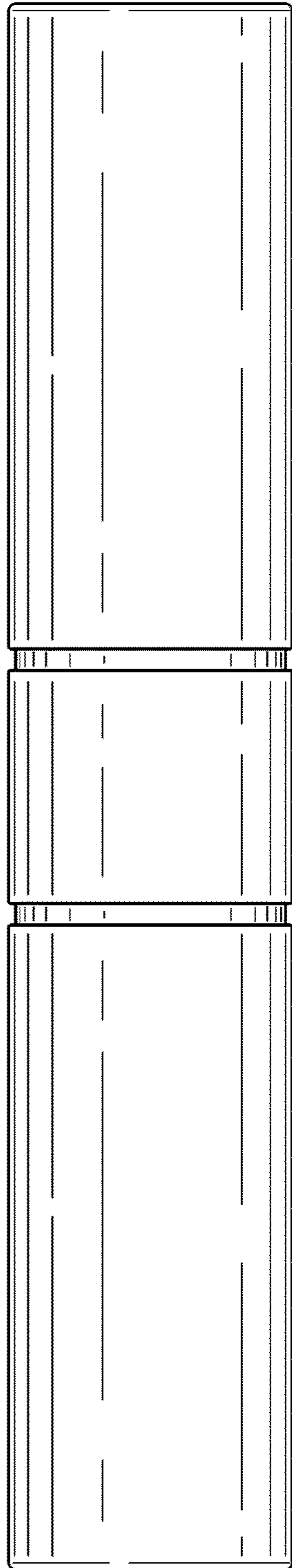

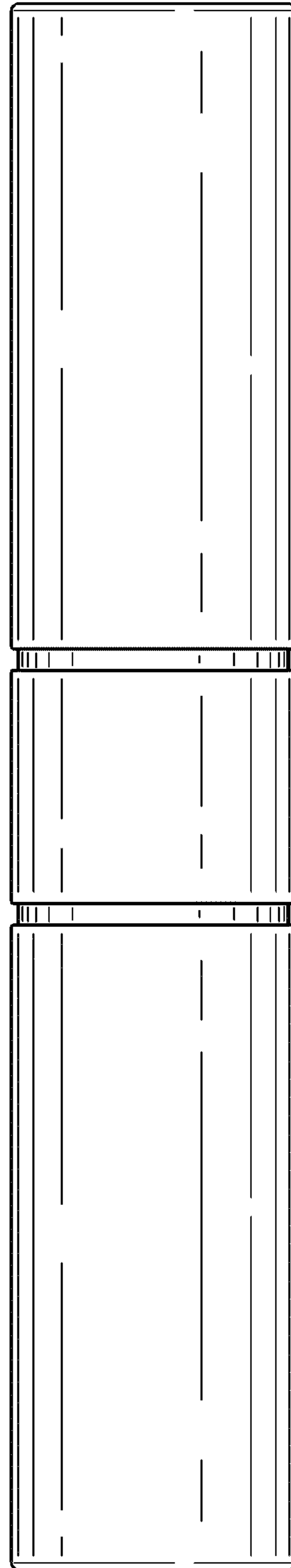

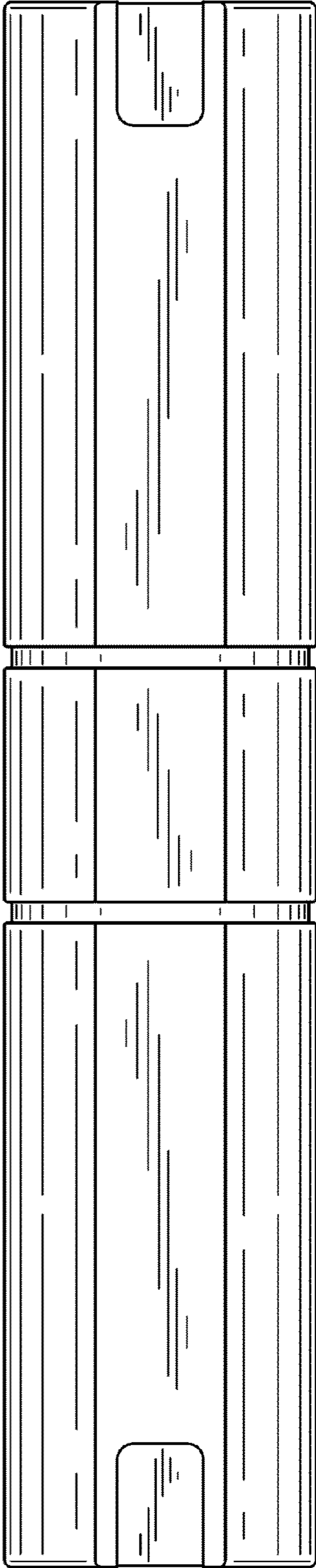

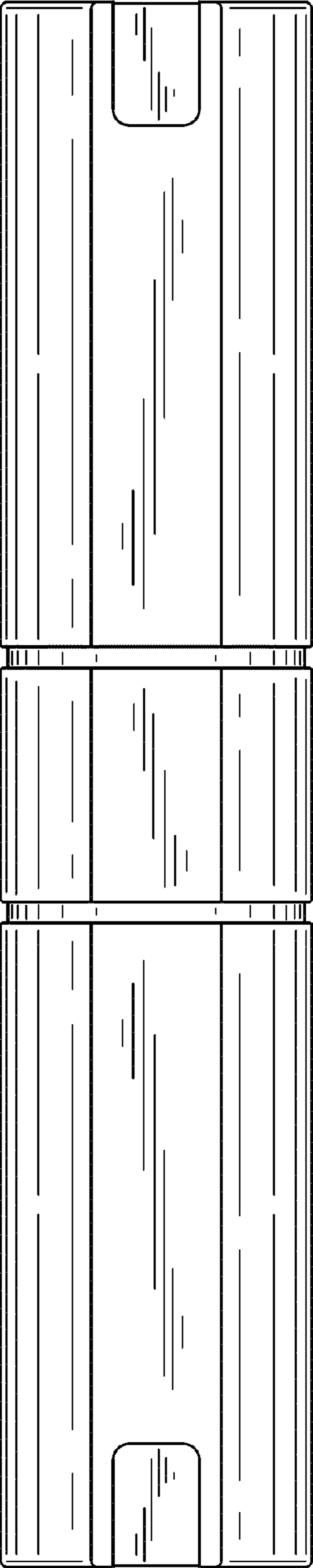

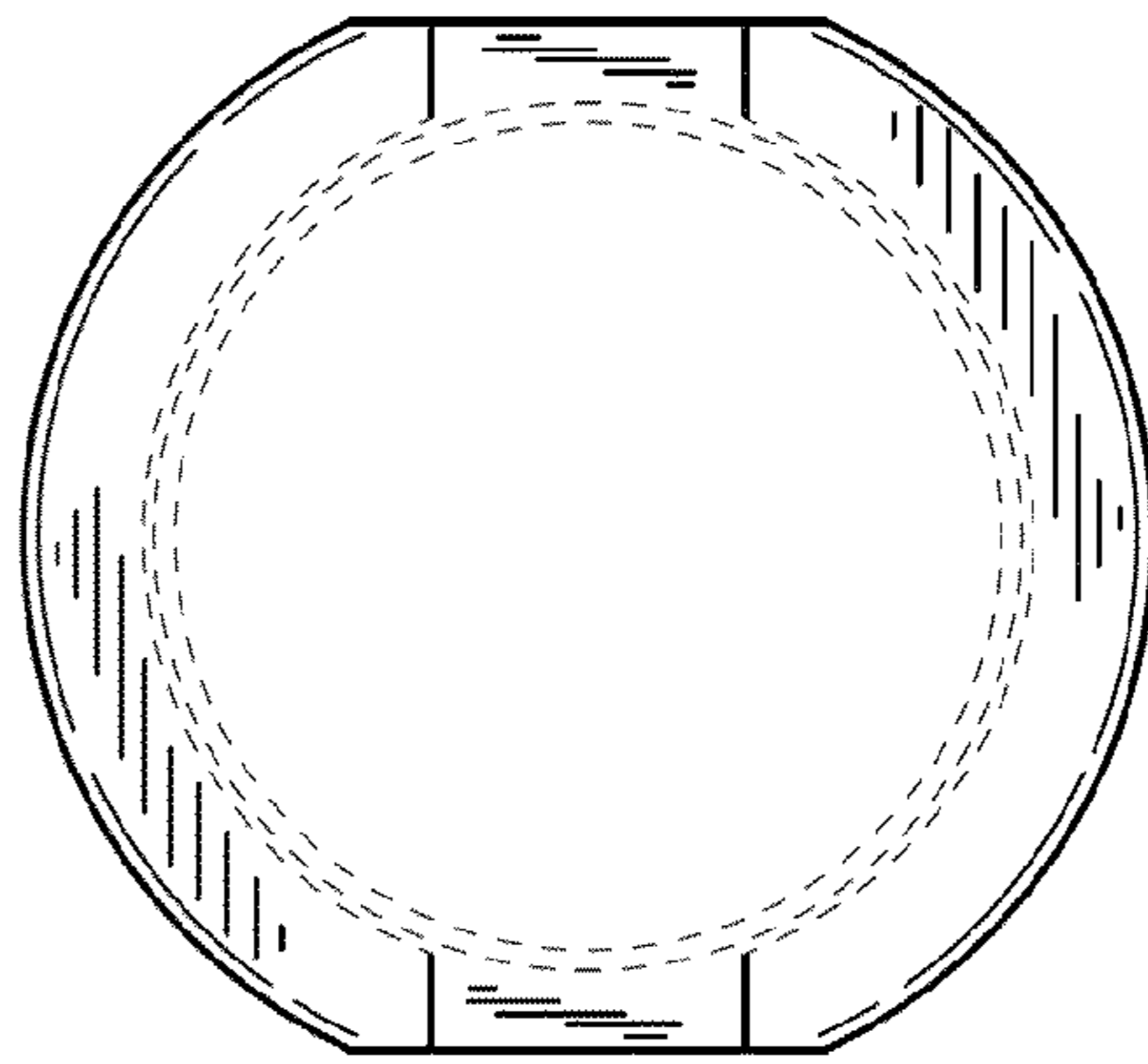

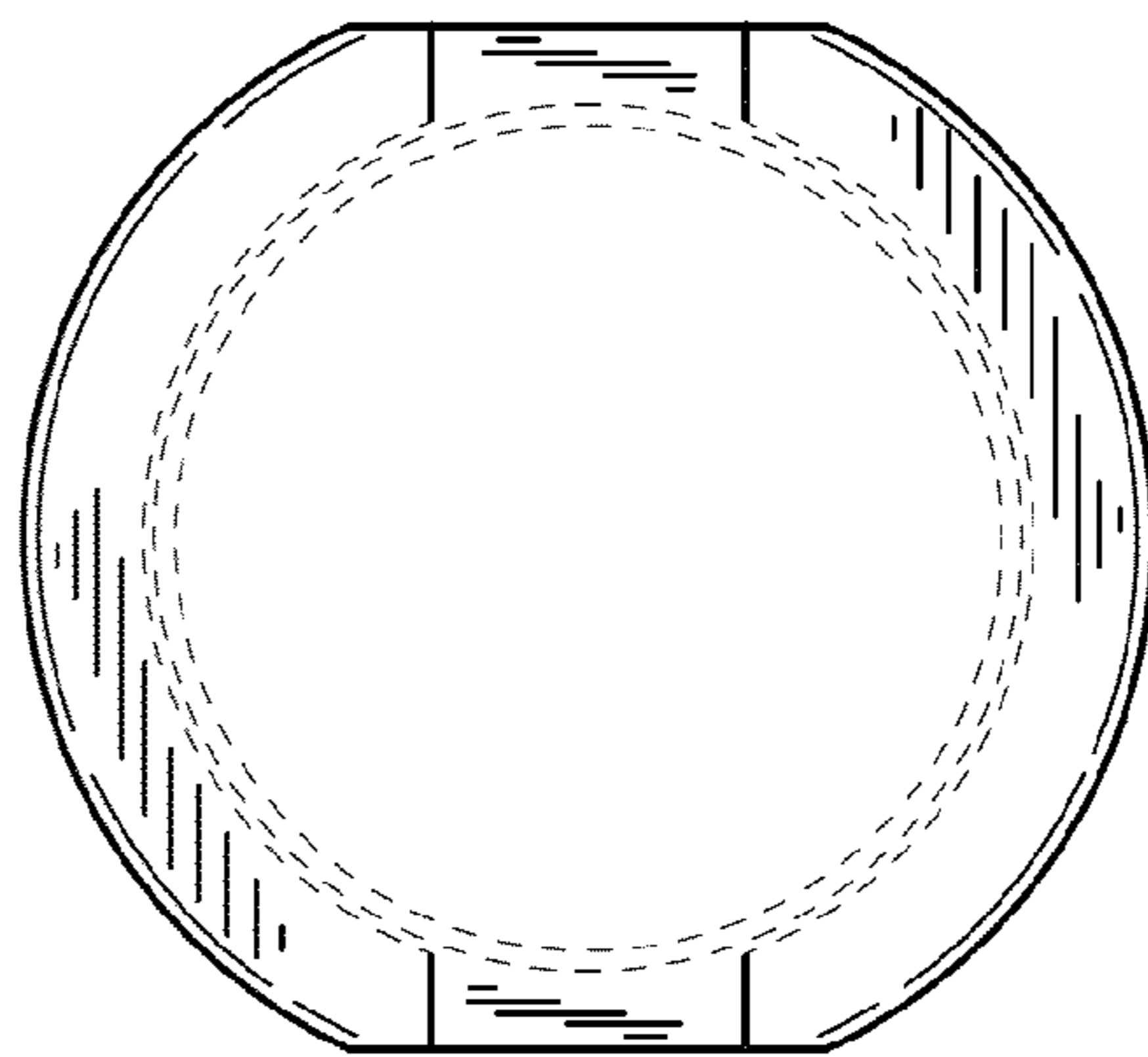
