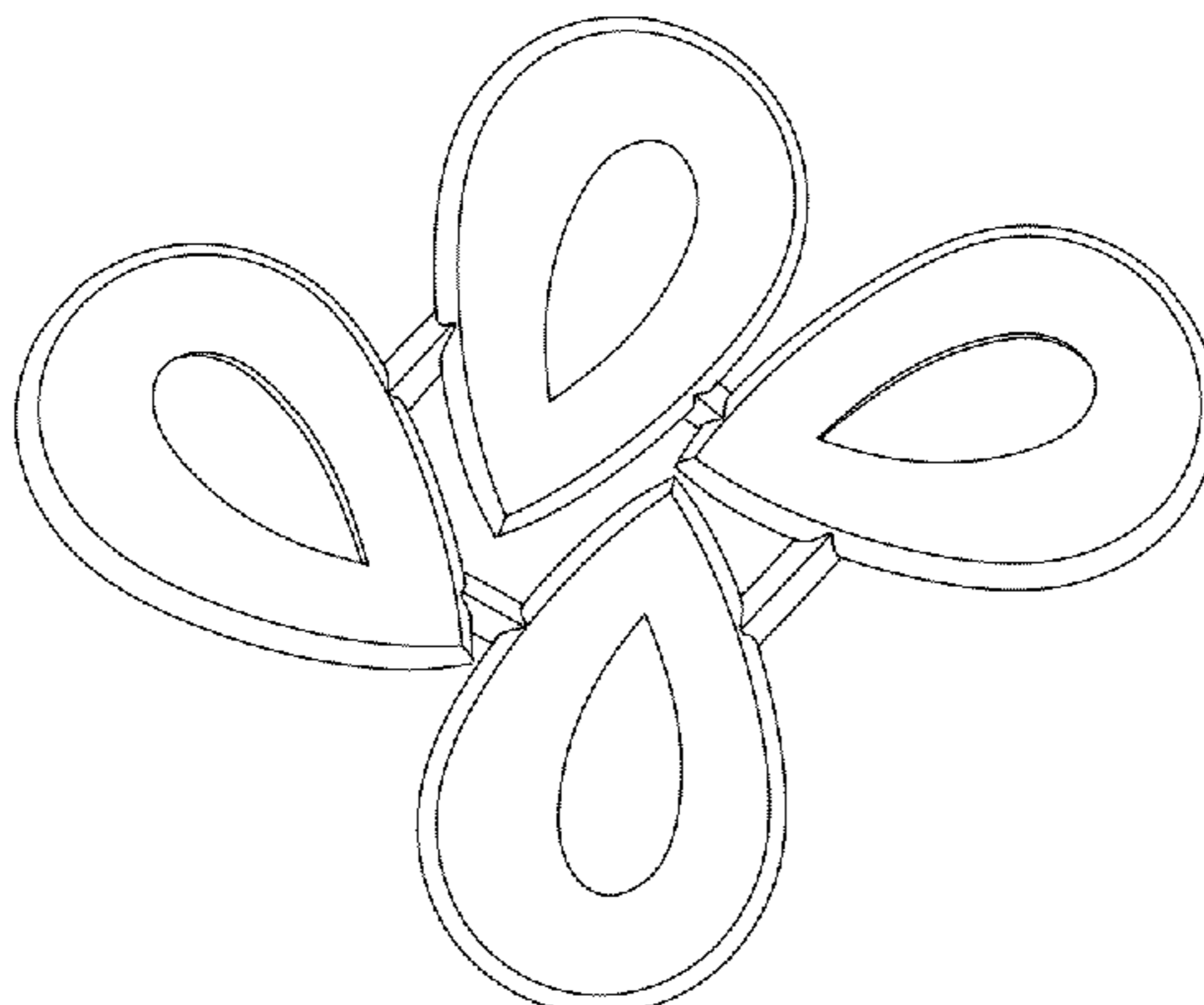
(57) **CLAIM**

The ornamental design for a ring, earring or pendant, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of a ring, earring or pendant showing minor design;  
 FIG. 2 is a bottom view thereof;  
 FIG. 3 is a right-side elevational view thereof;  
 FIG. 4 is a left-side elevational view thereof;  
 FIG. 5 is a front elevational view thereof;

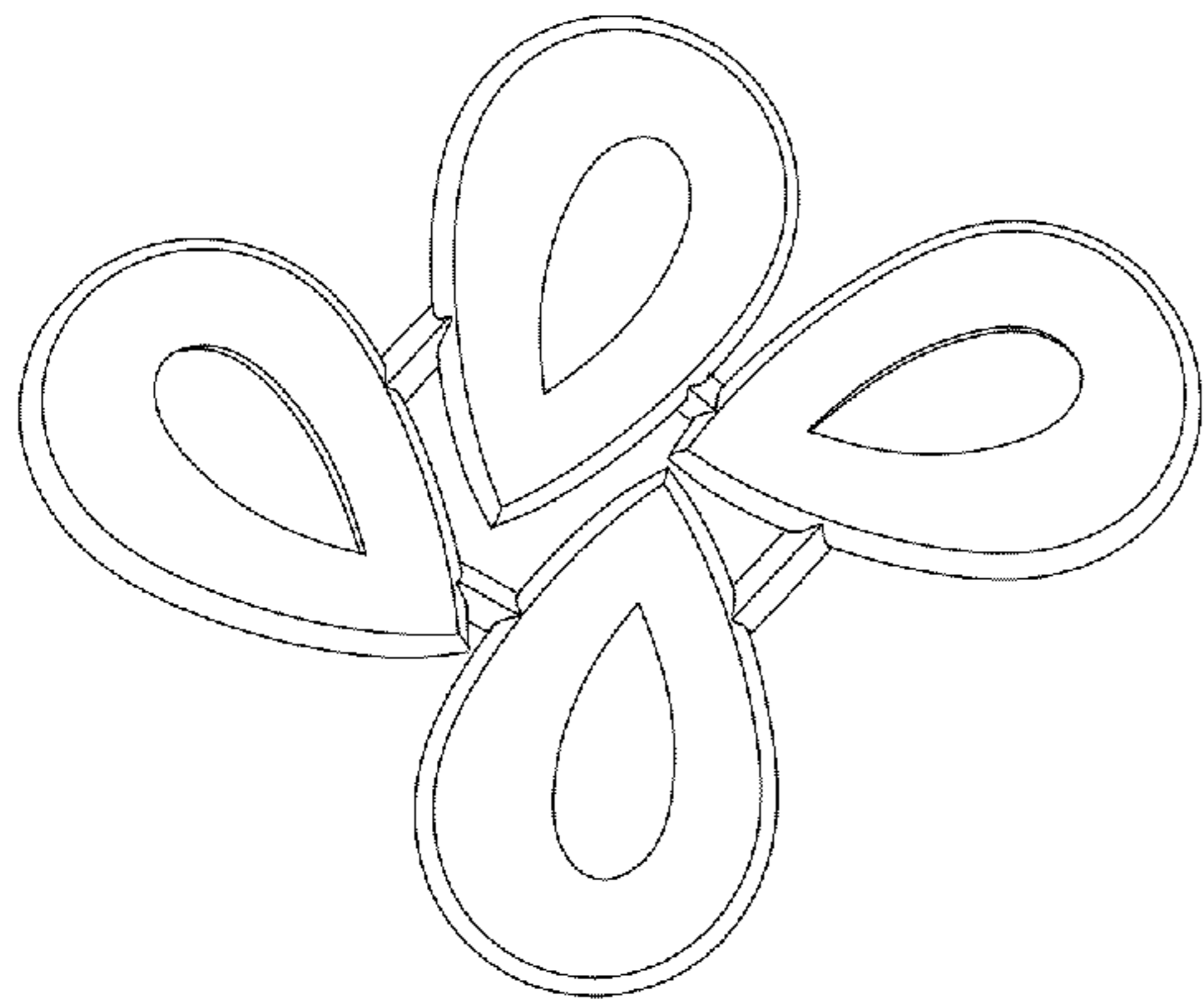

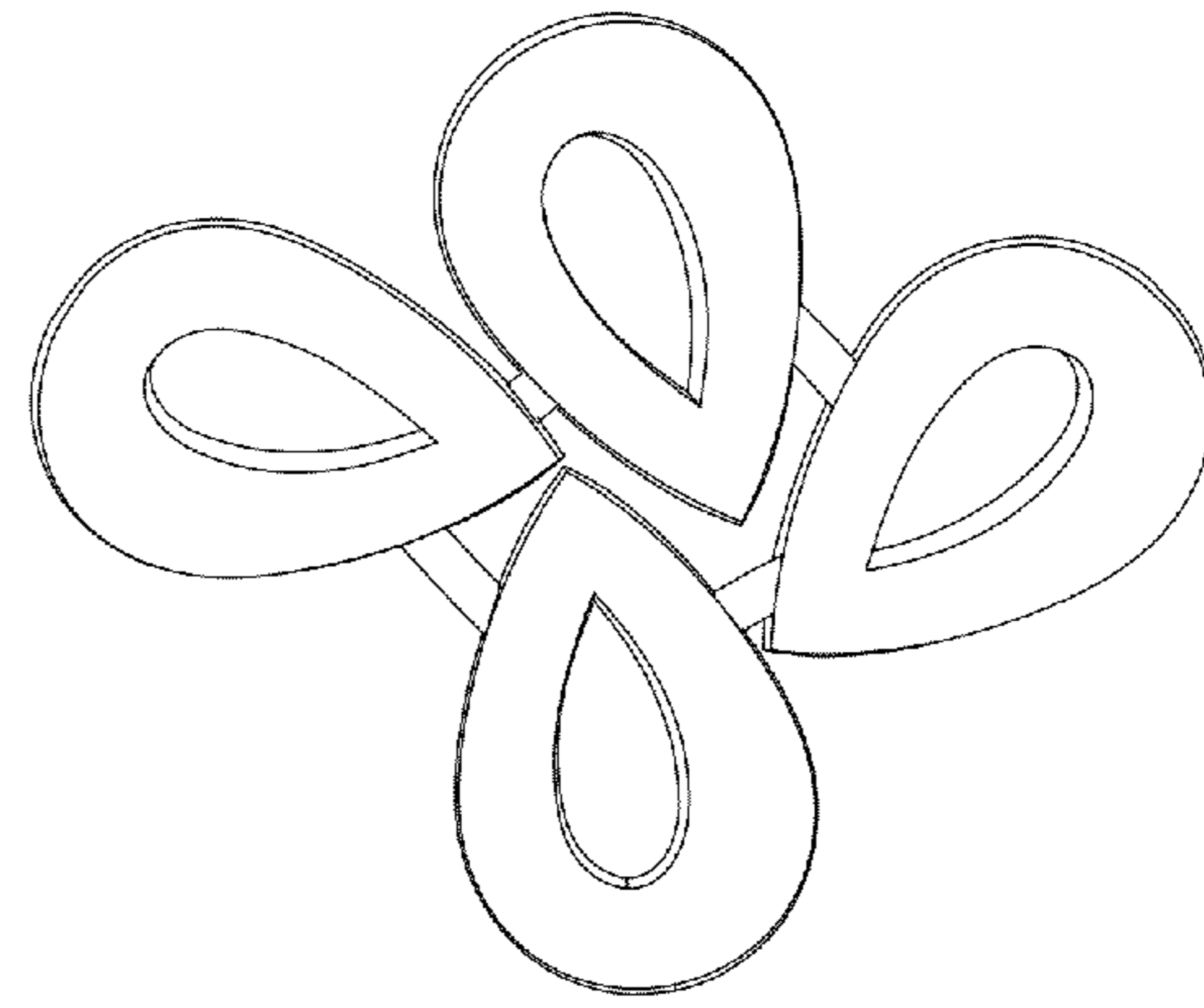

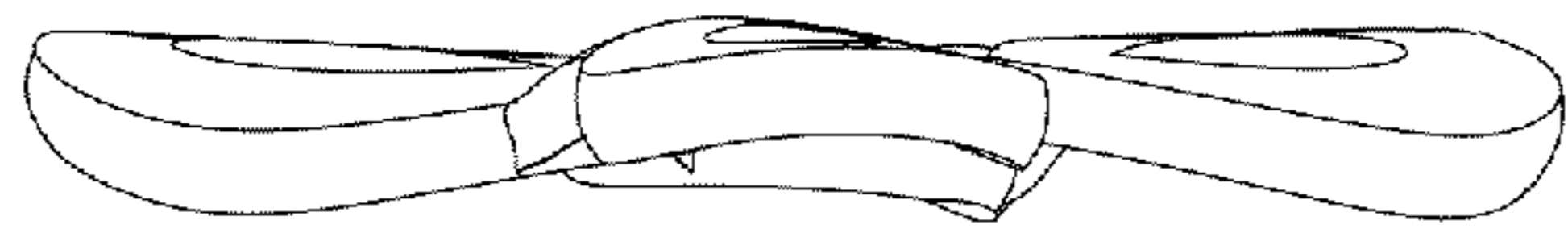

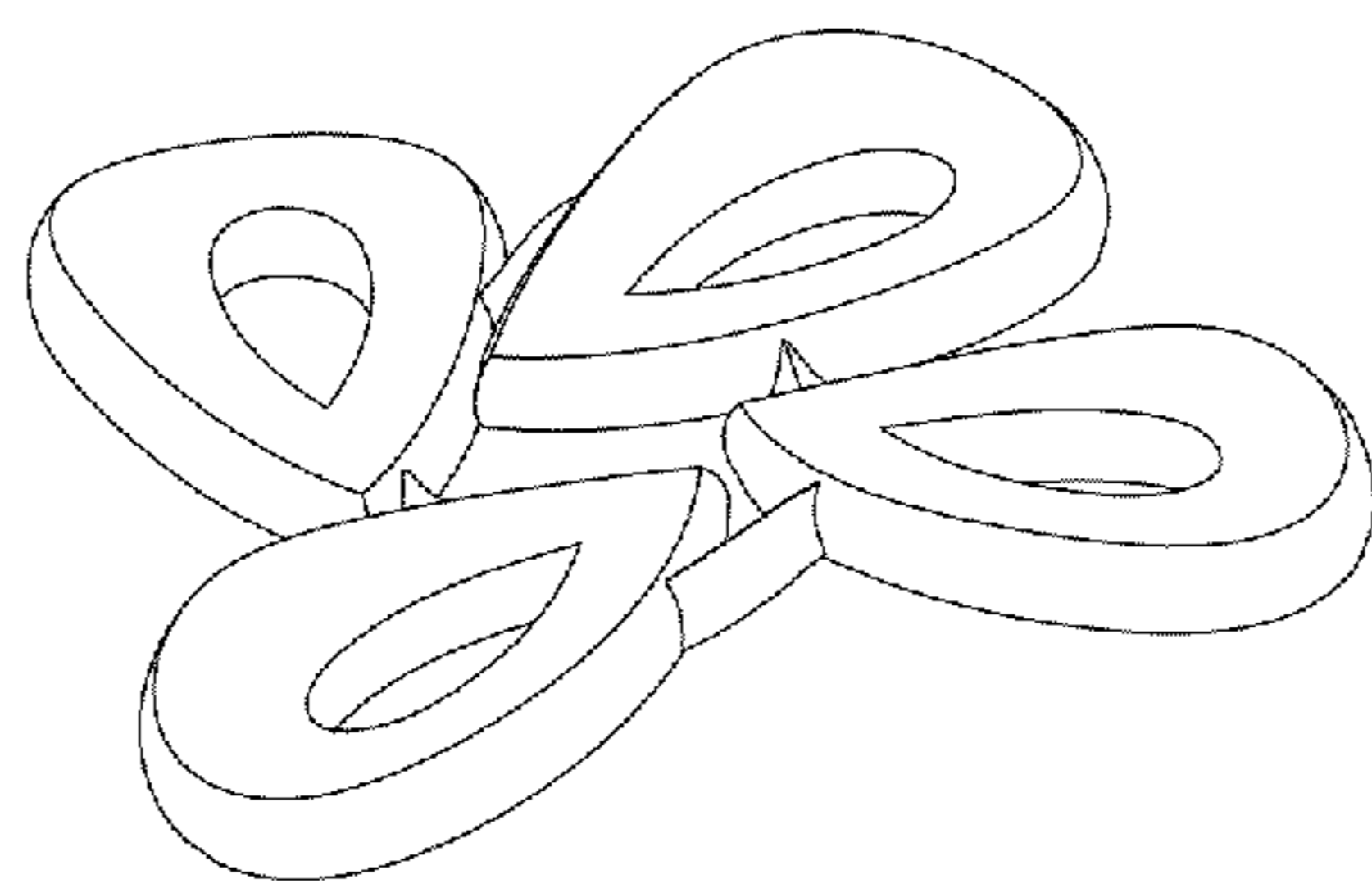
