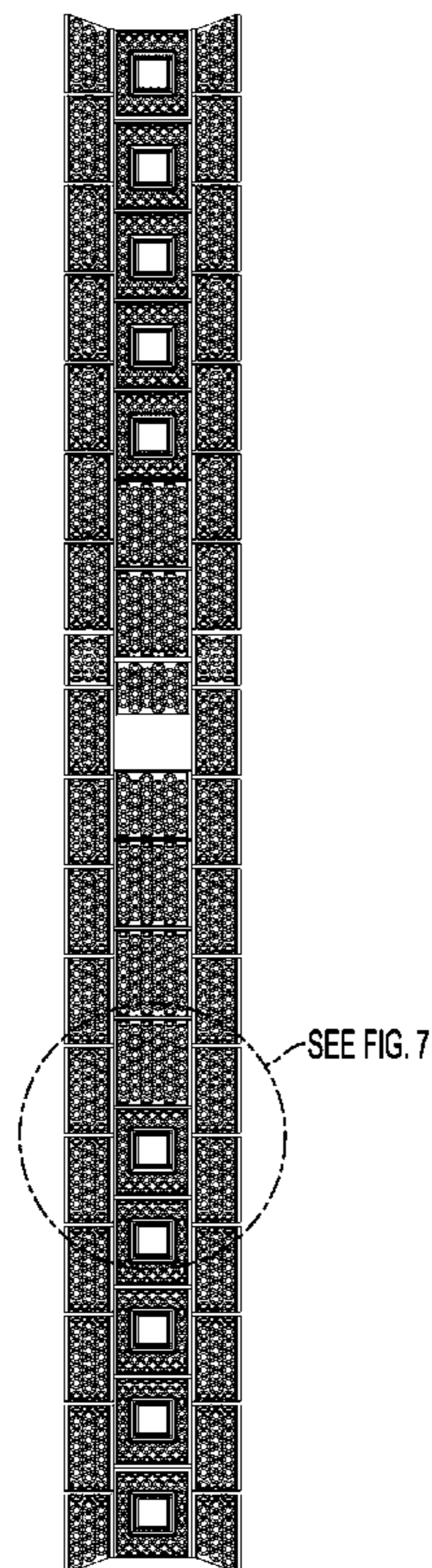
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top view of the bracelet;  
FIG. 2 is a right side view of the bracelet;

FIG. 4 is a front view of the bracelet;  
FIG. 5 is a rear view of the bracelet;  
FIG. 6 is a right-top perspective view of bracelet;

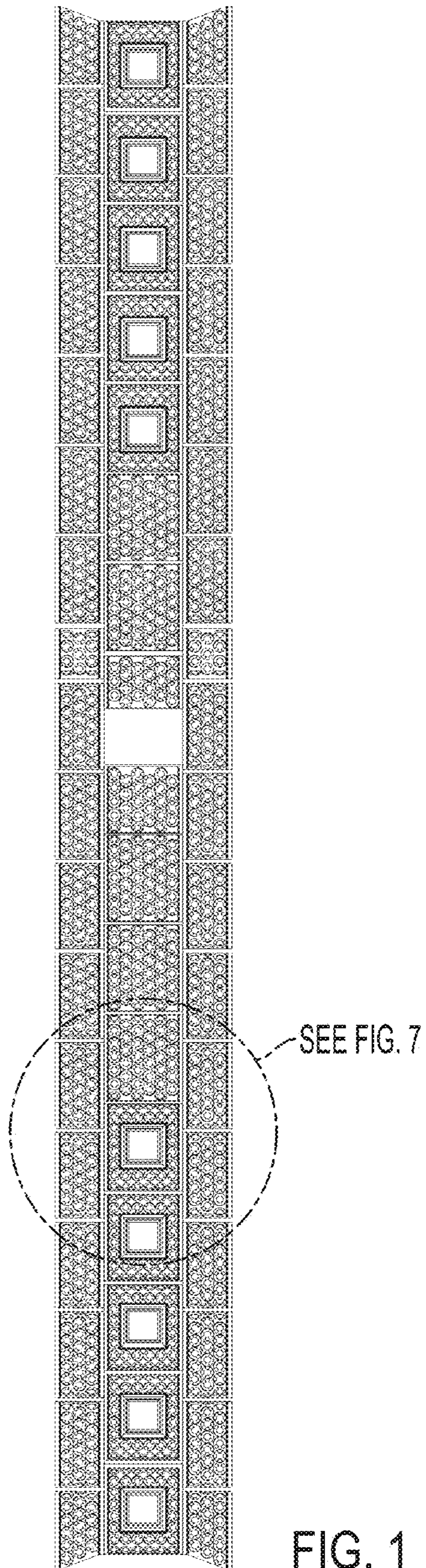

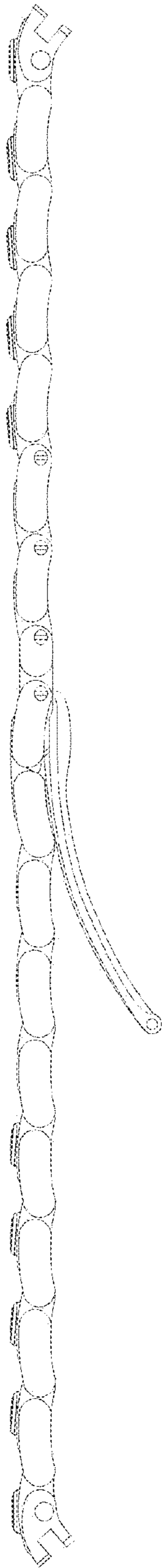

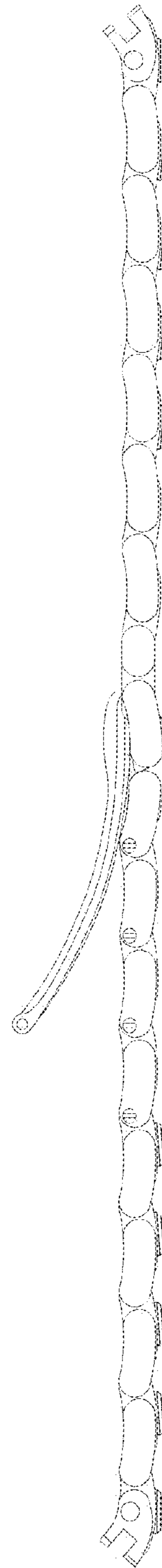

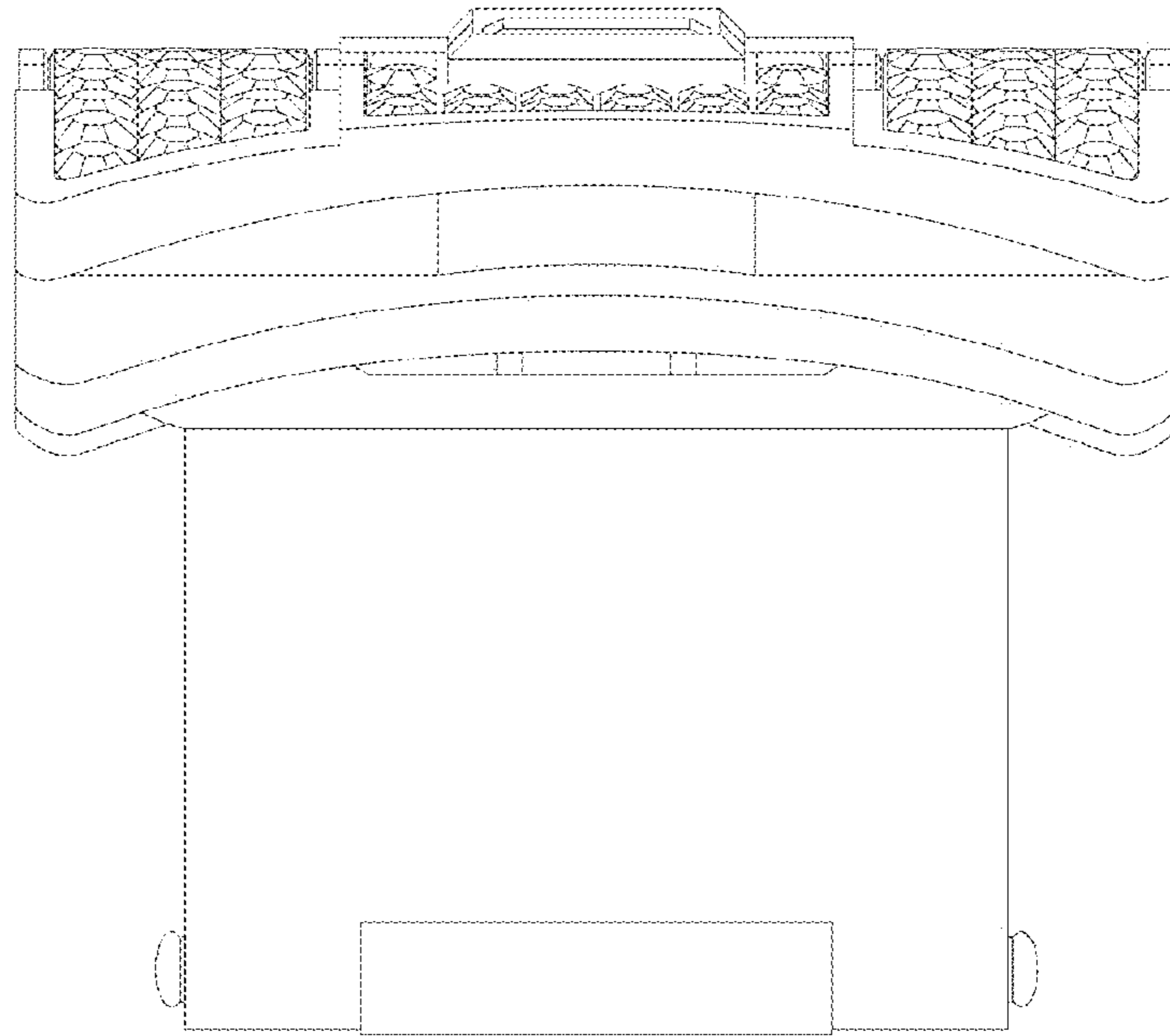

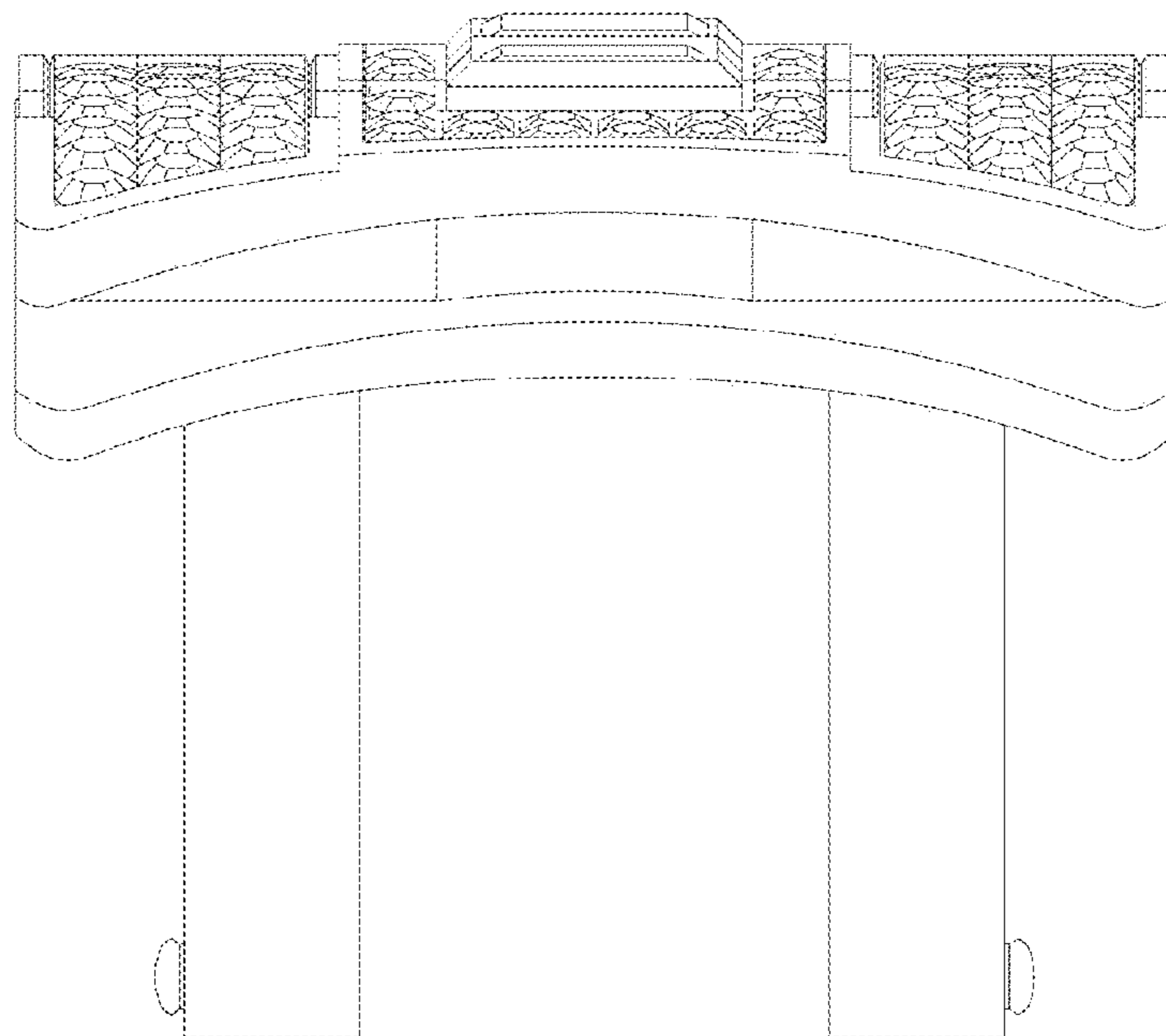

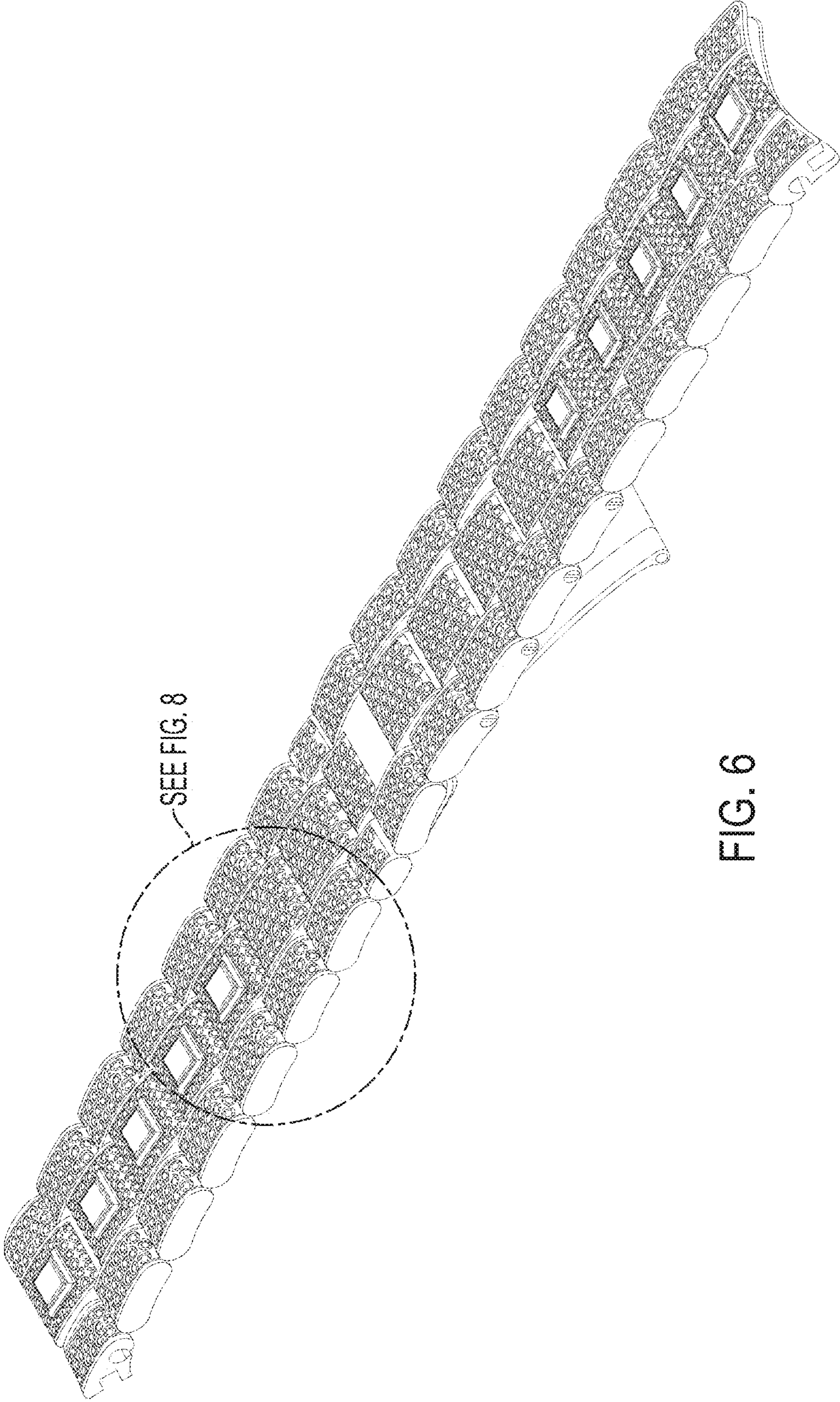

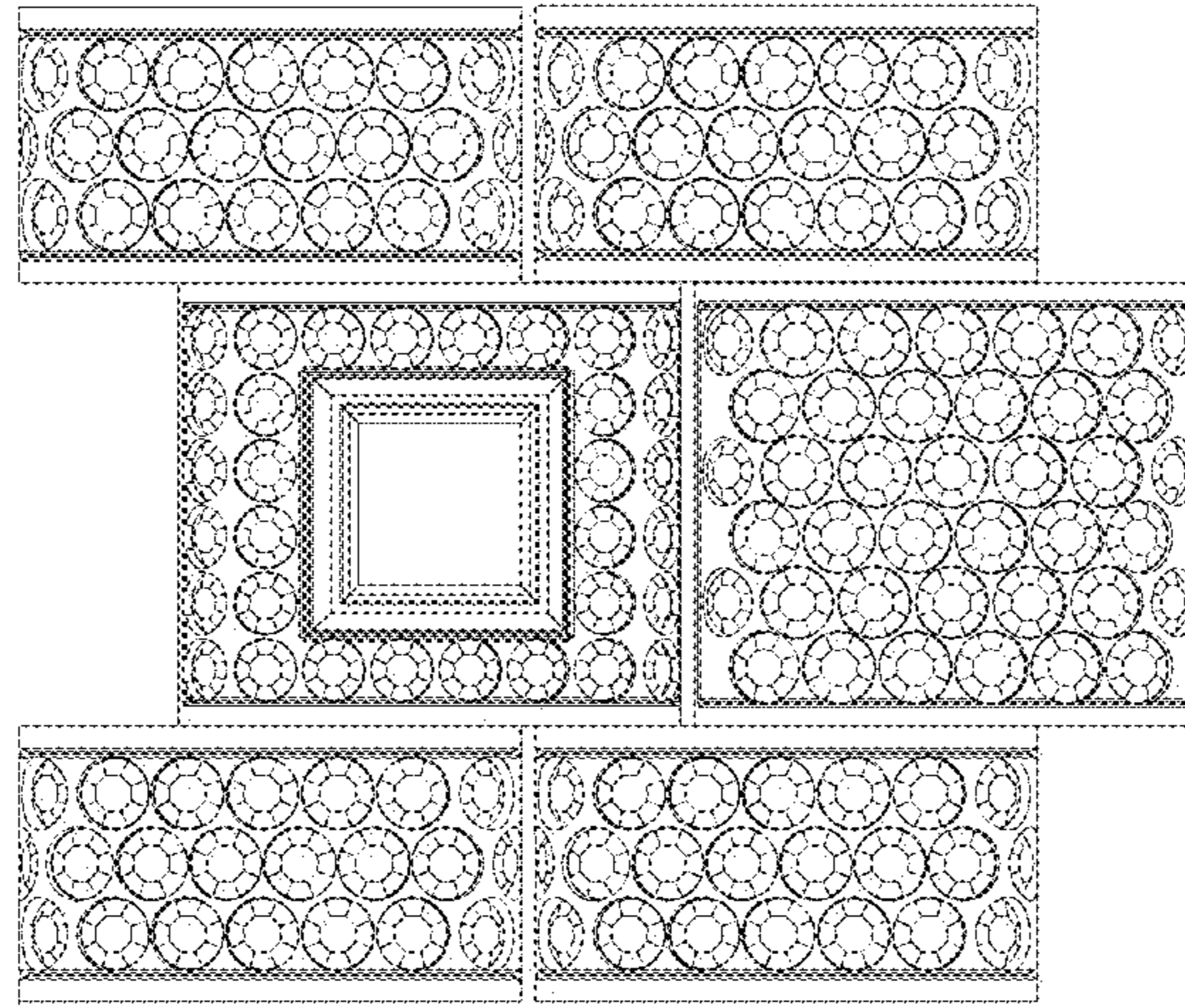

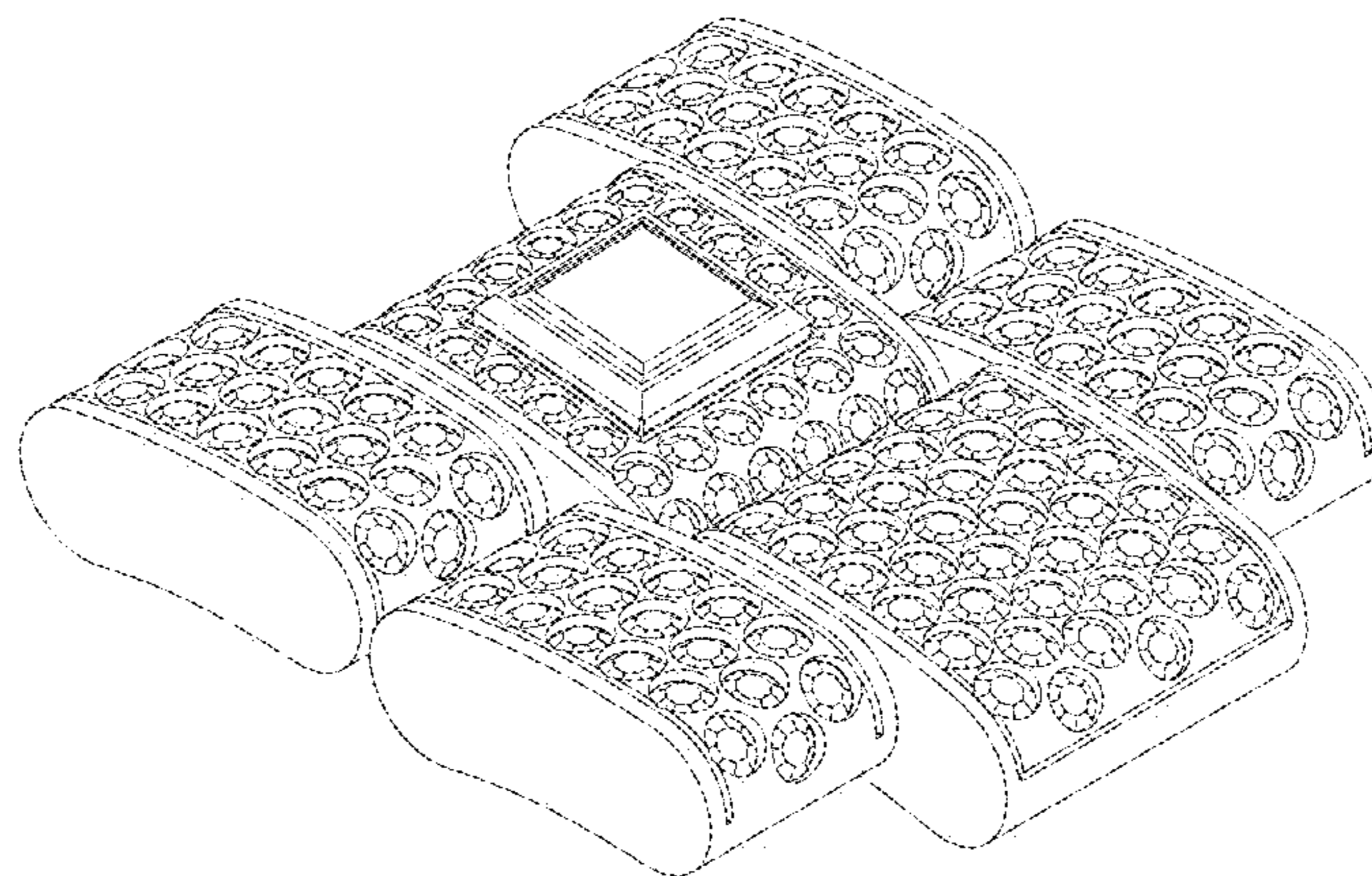

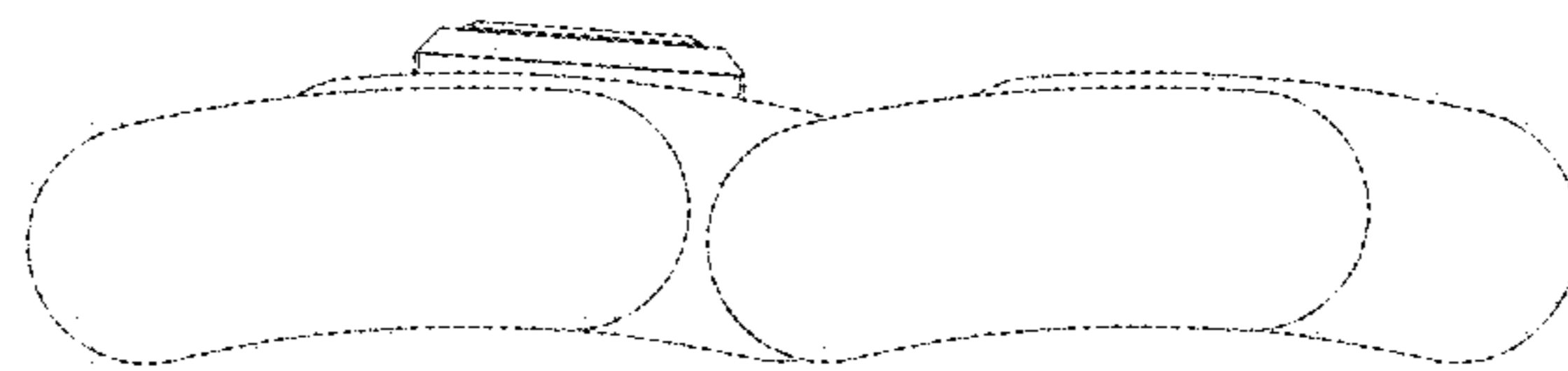
